FIG. 3 is a front view of a fruit arrangement according to the present invention;

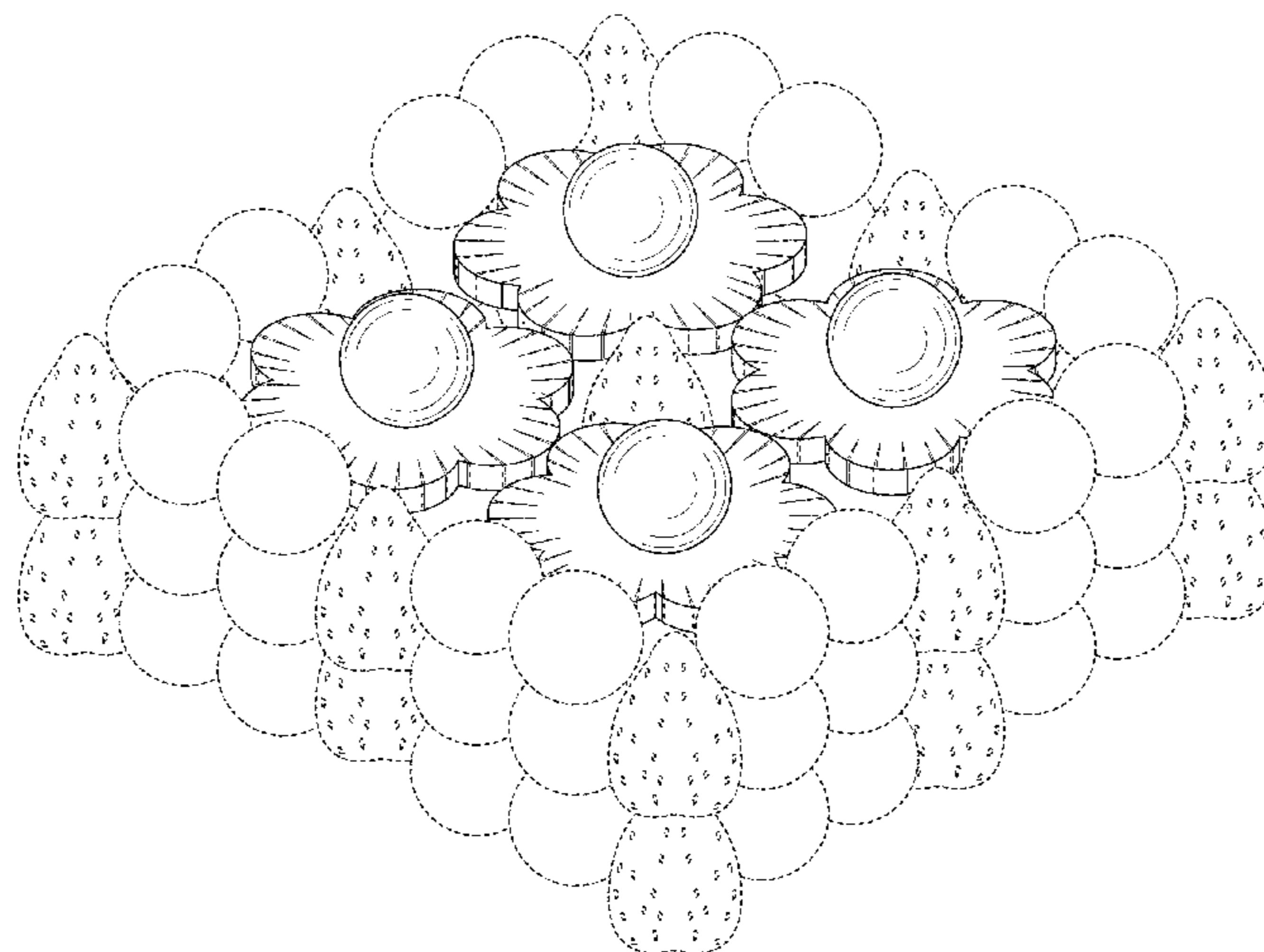
FIG. 4 is a rear view of a fruit arrangement according to the present invention;

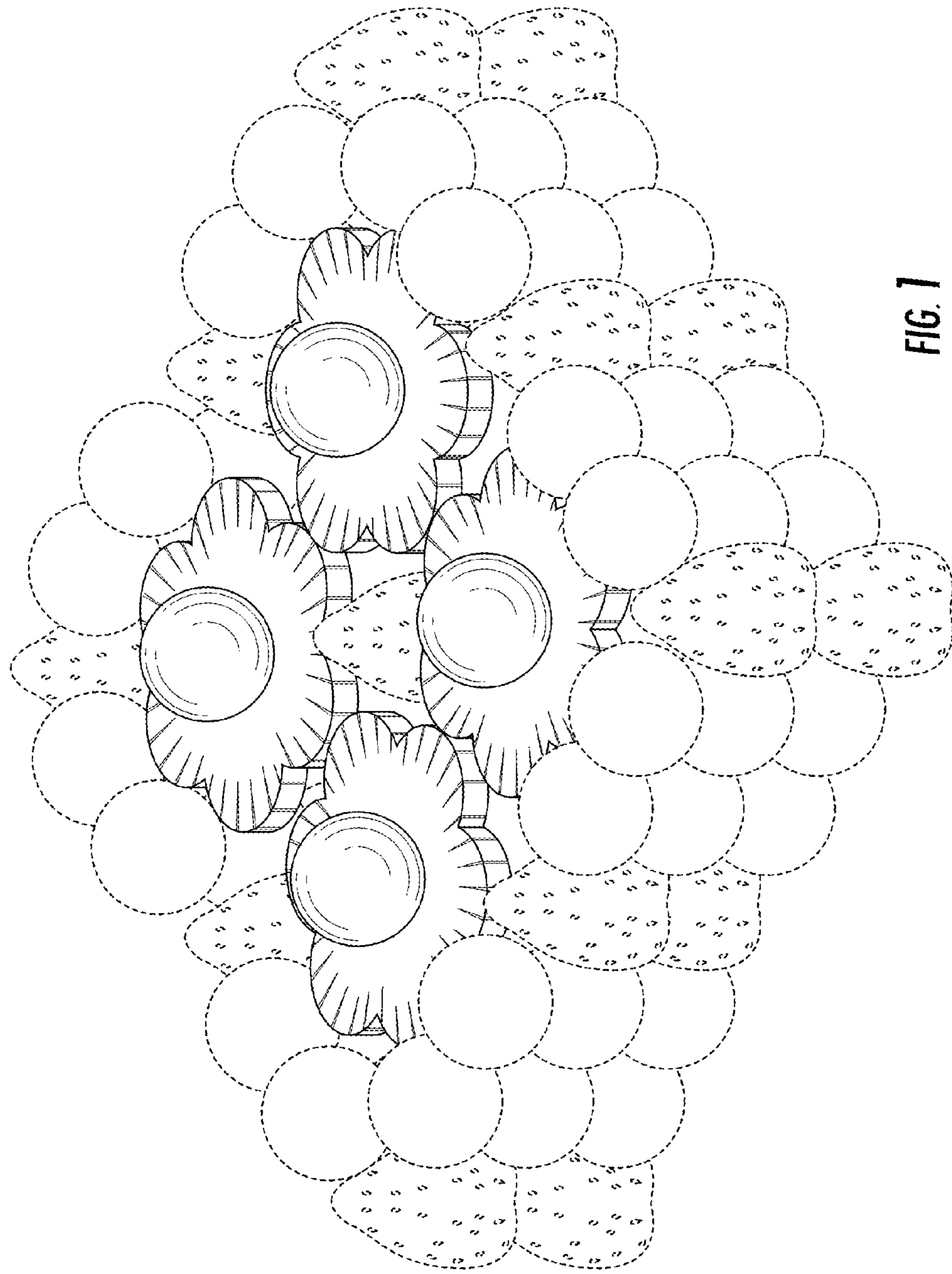

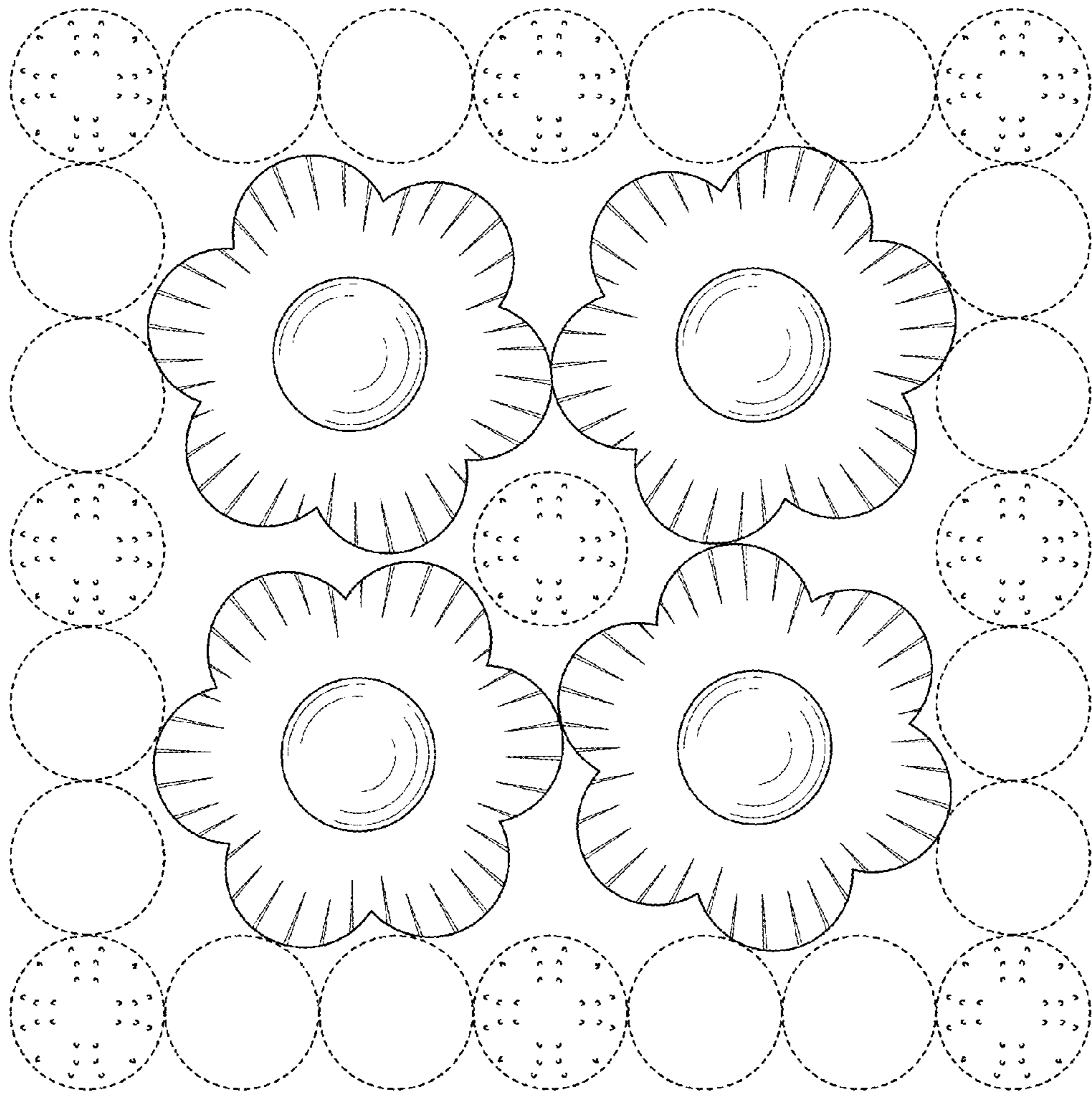
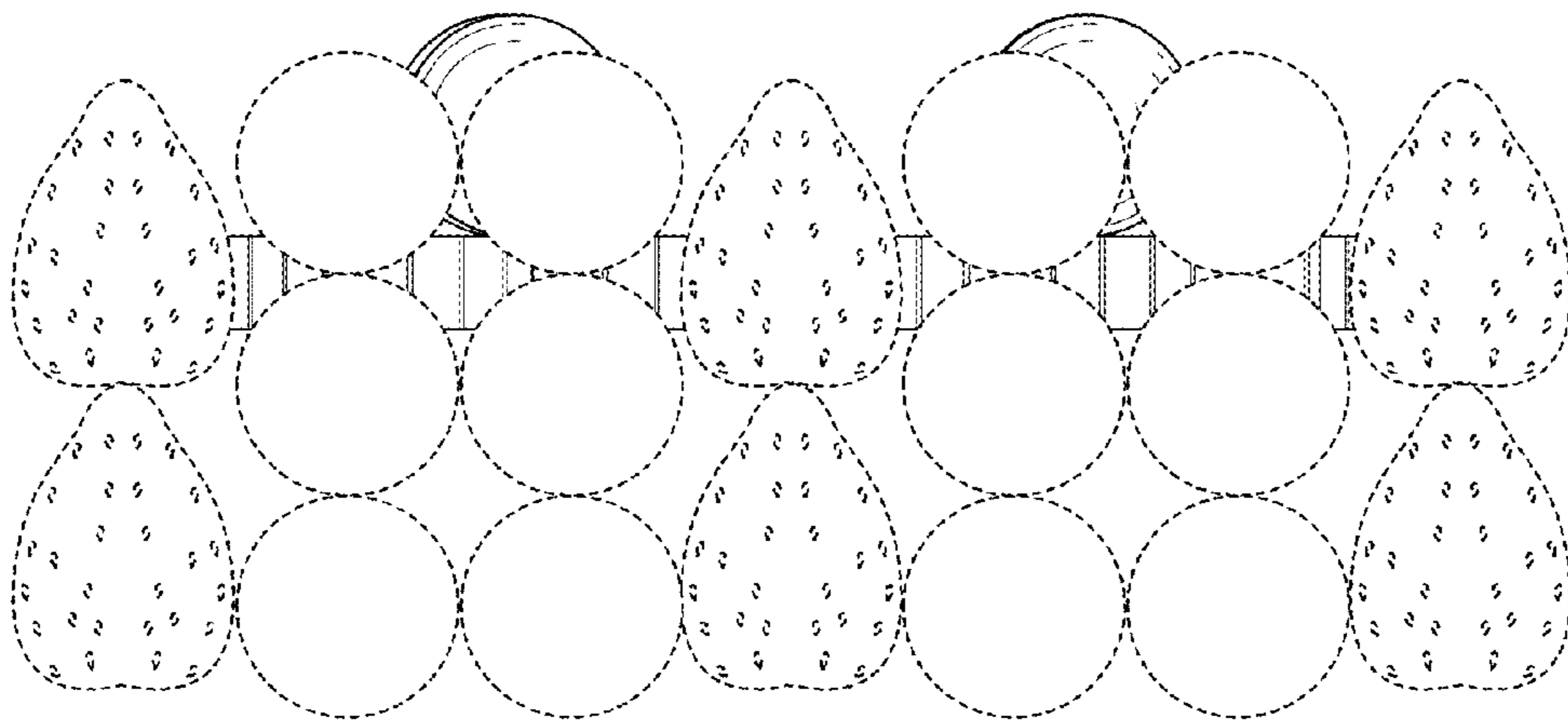
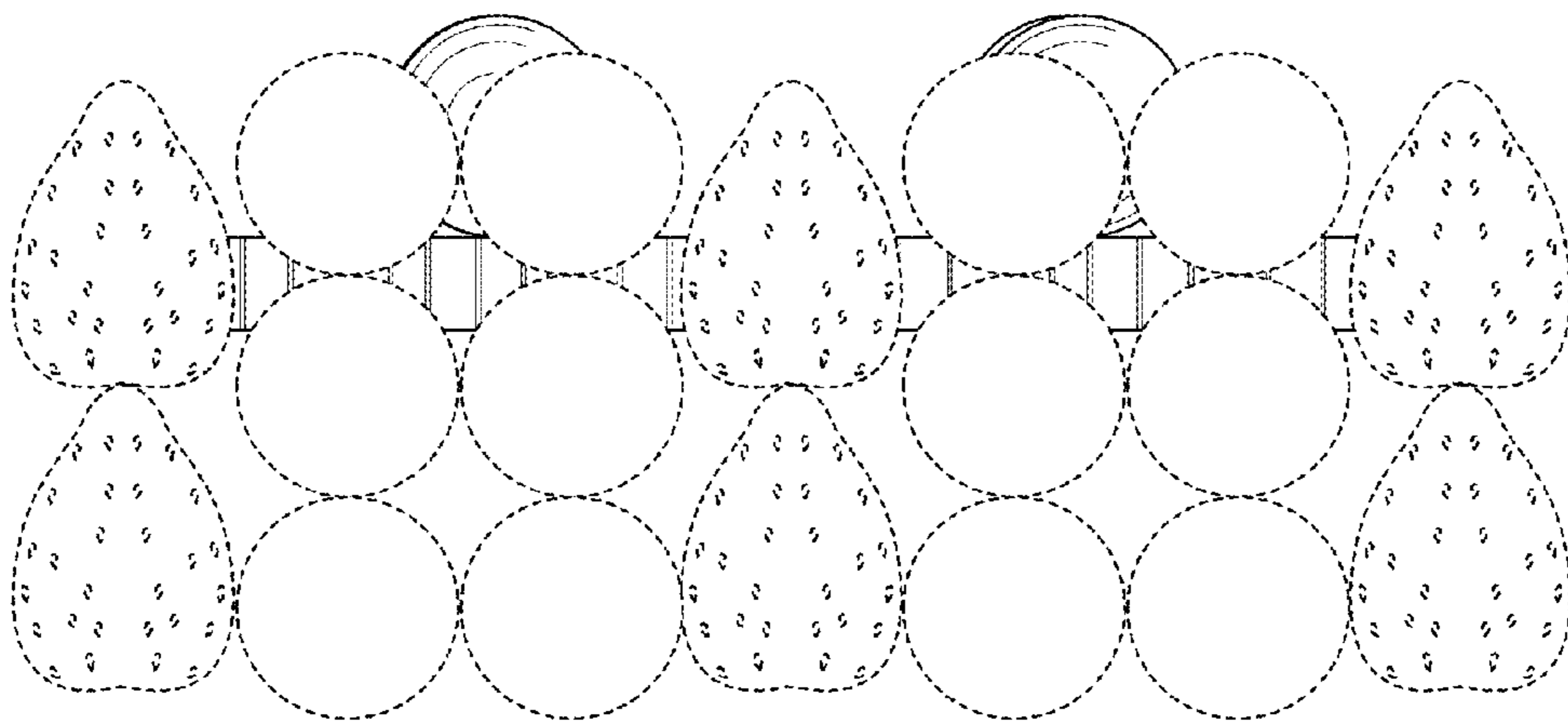

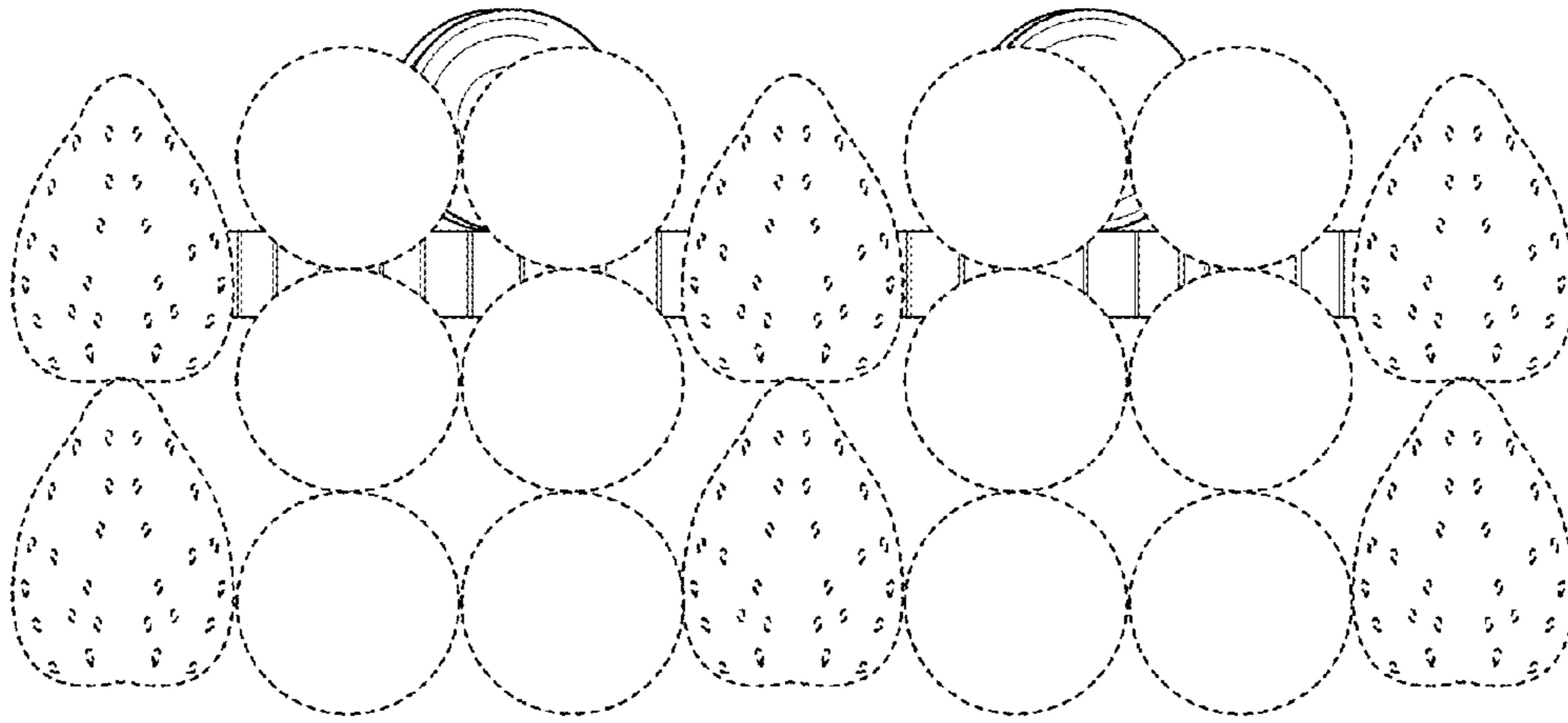




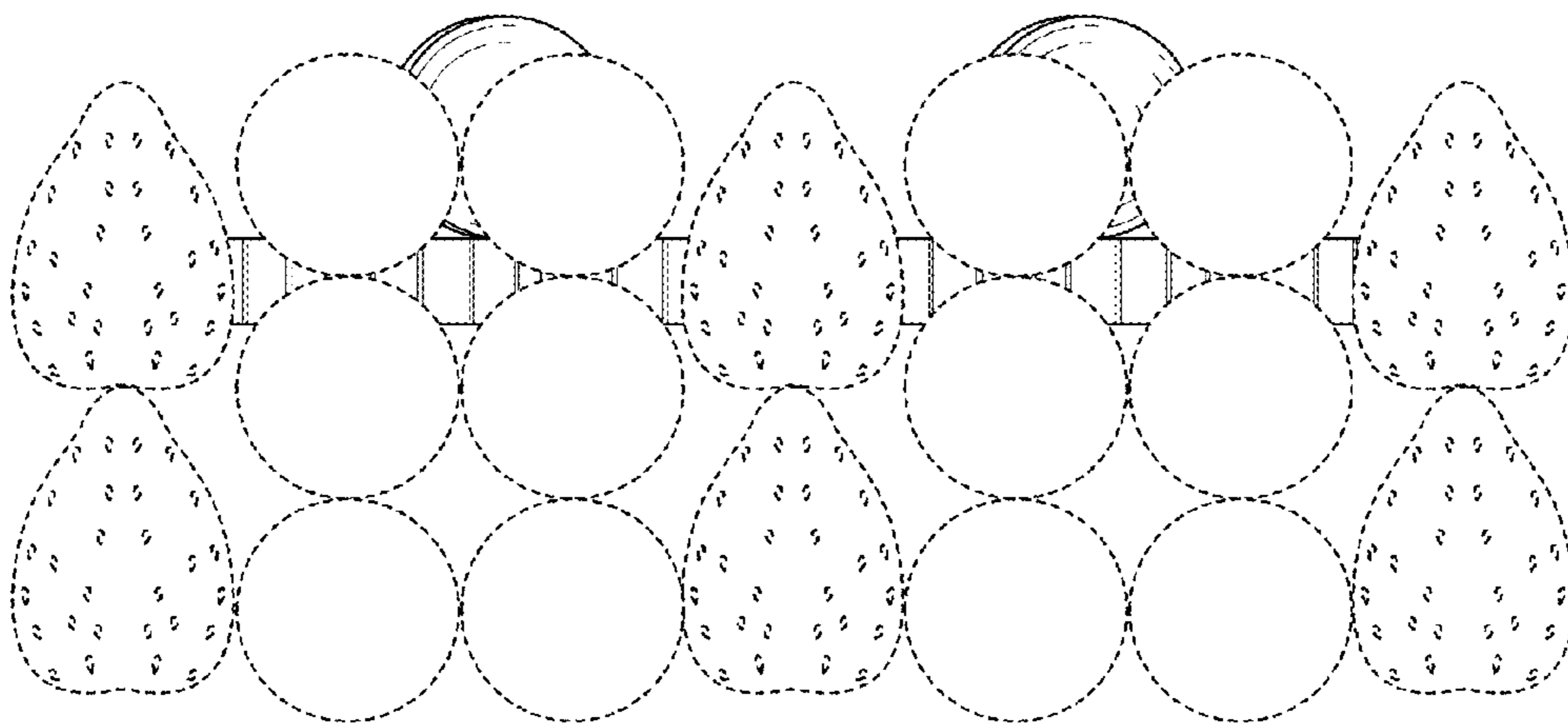
