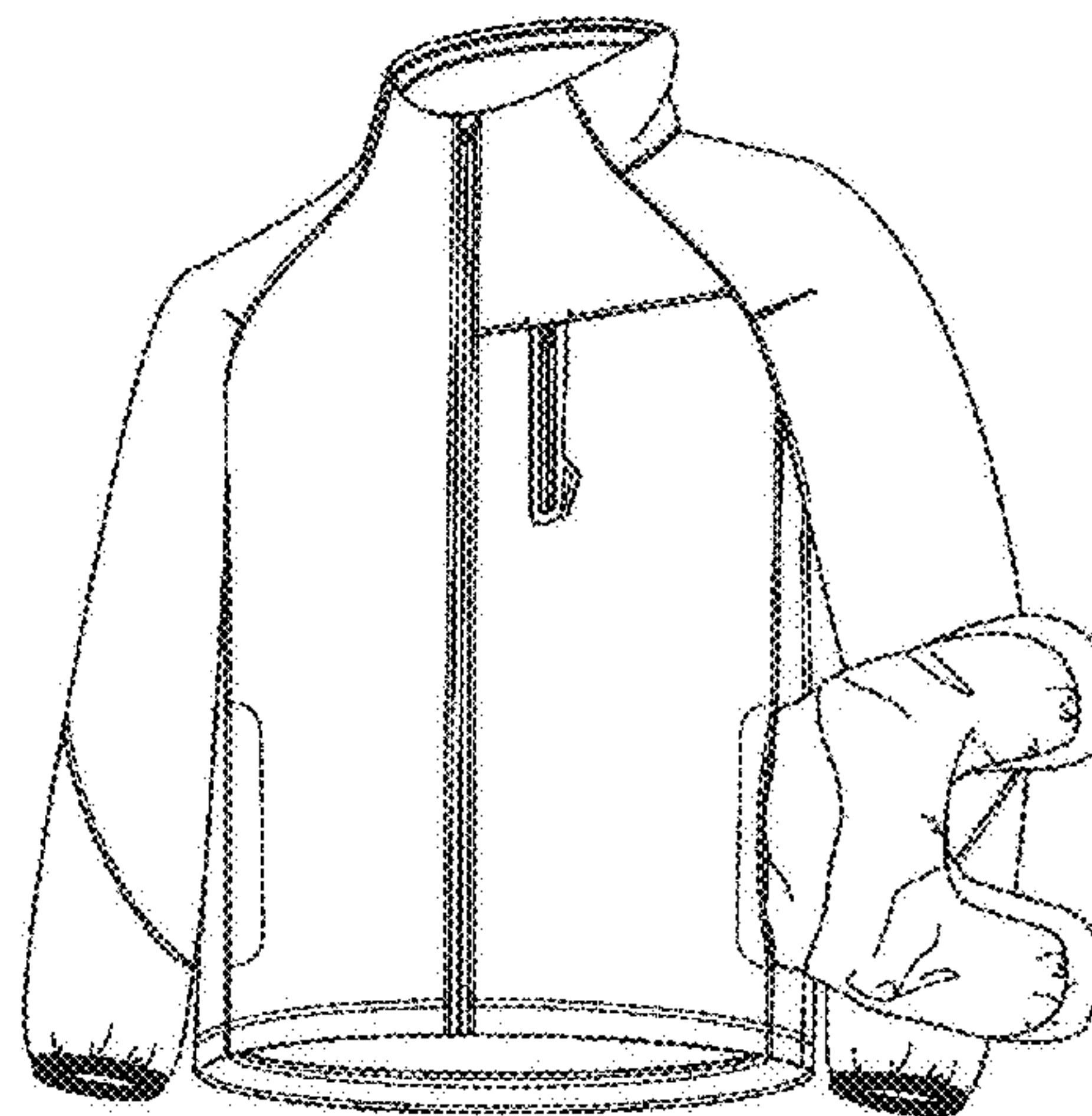
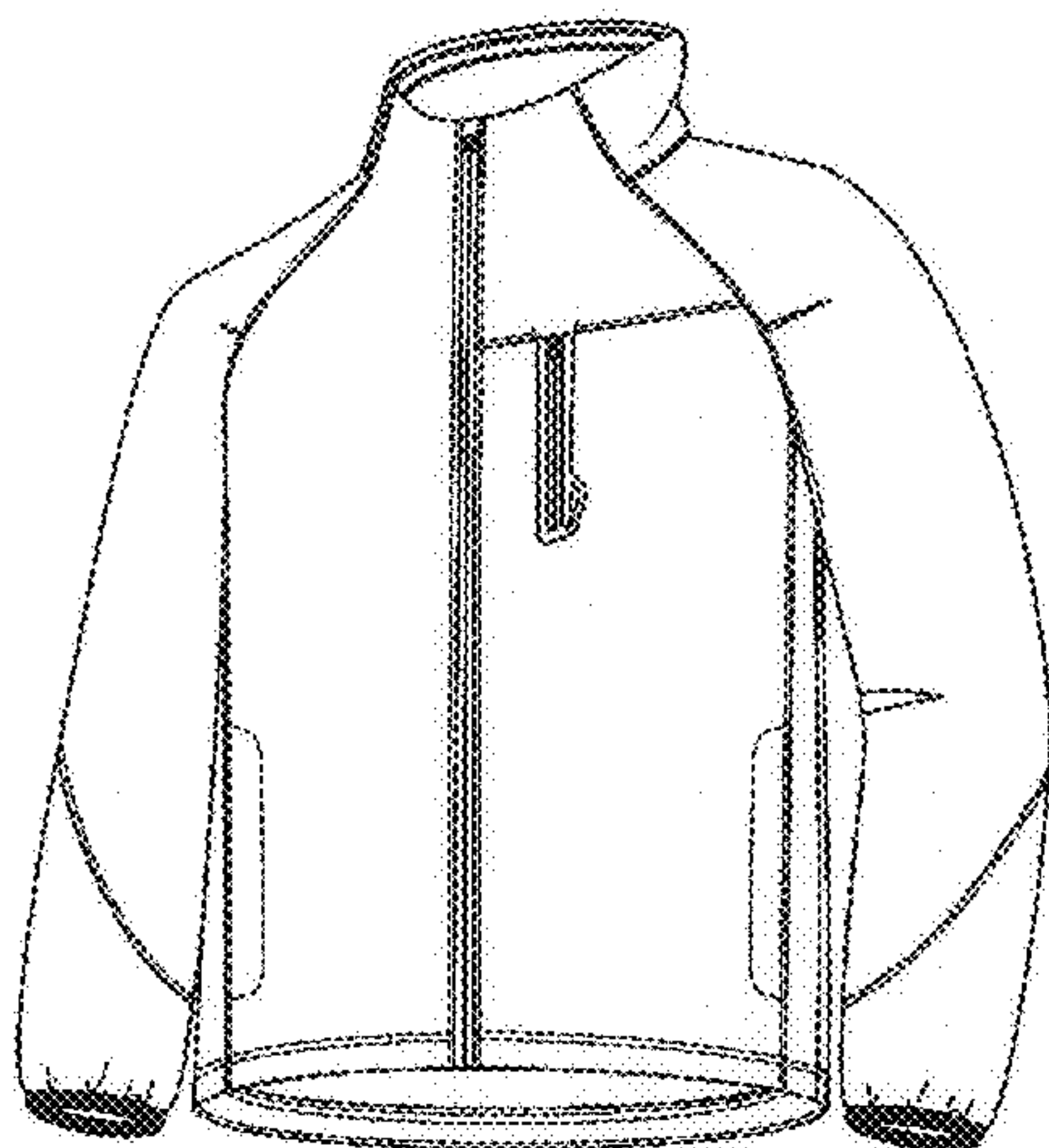

(57) **CLAIM**
The ornamental design for clothing, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of clothing showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a left side elevational view thereof;
FIG. 8 is a front elevational view thereof showing a lining of a storage pocket which is pulled inside out;
FIG. 9 is a perspective view of the clothing stuffed into the lining of the storage pocket; and,
FIG. 10 is a perspective view of the clothing converted into a U-shaped pillow.
The broken lines shown in the views are understood to represent stitching.

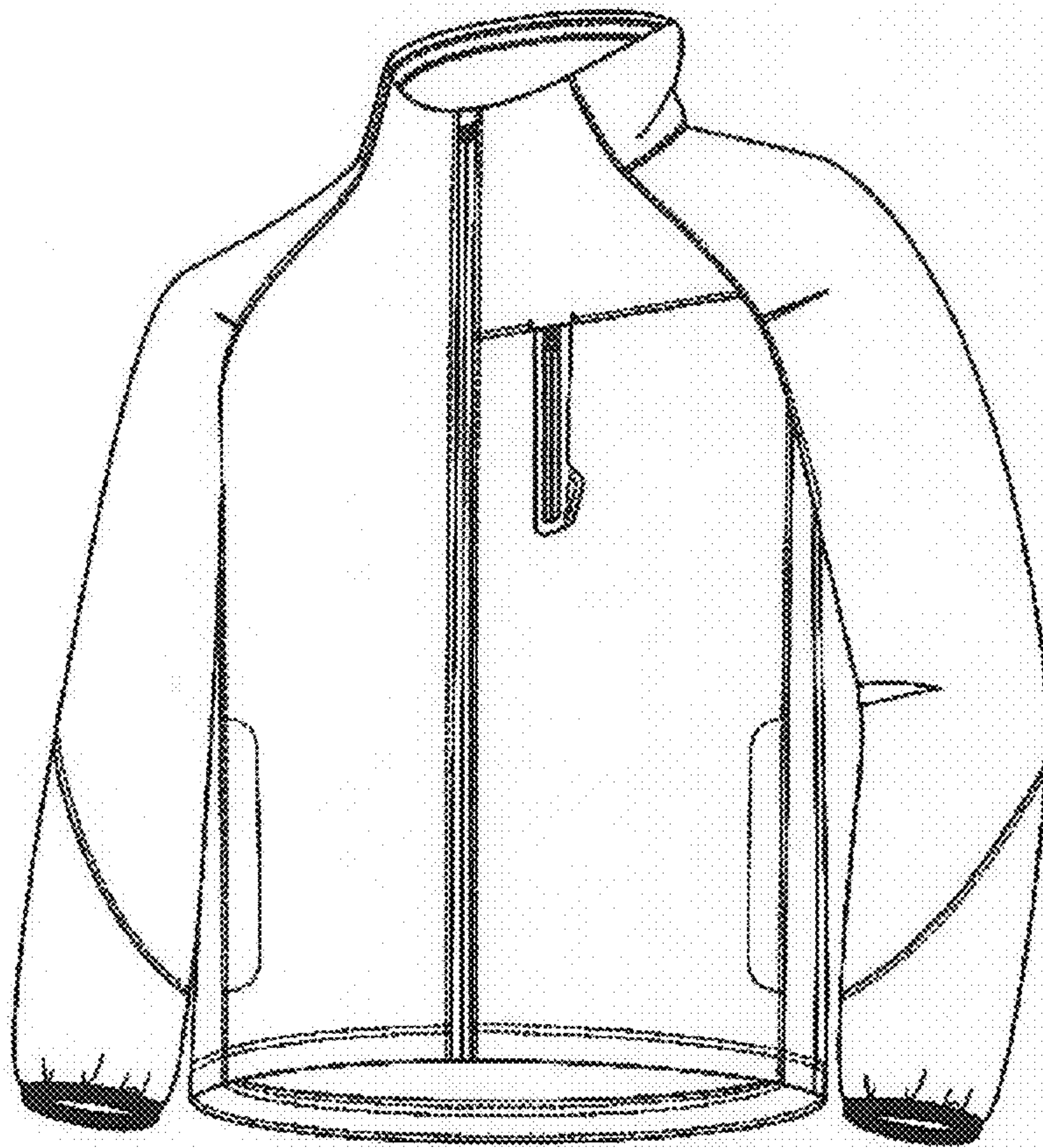

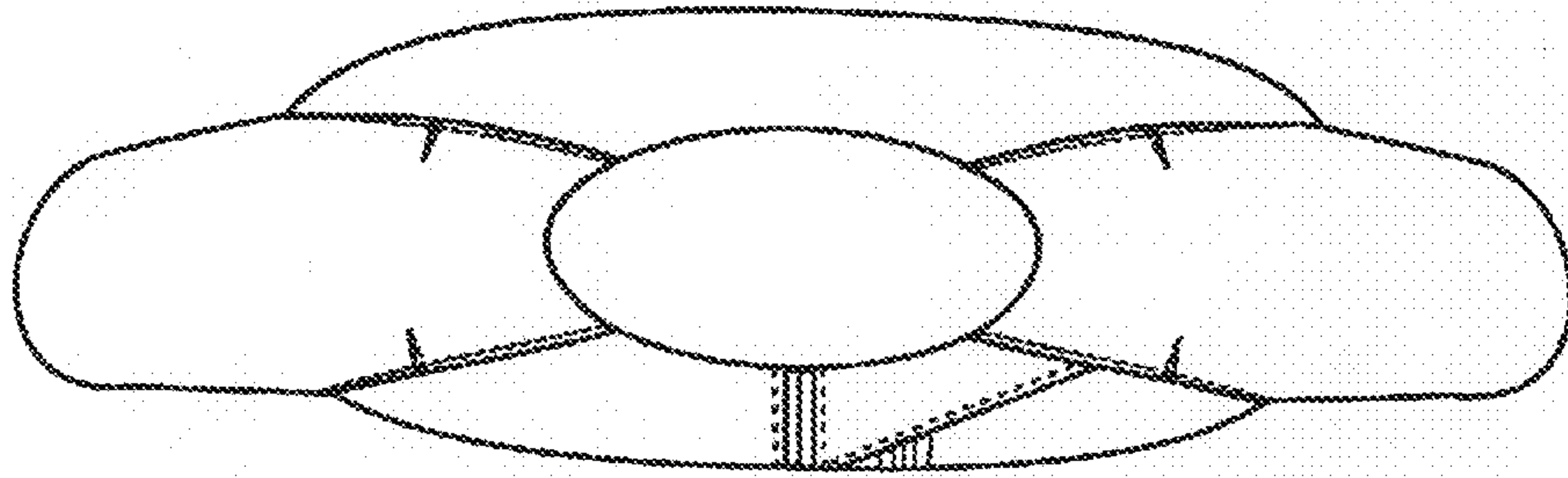

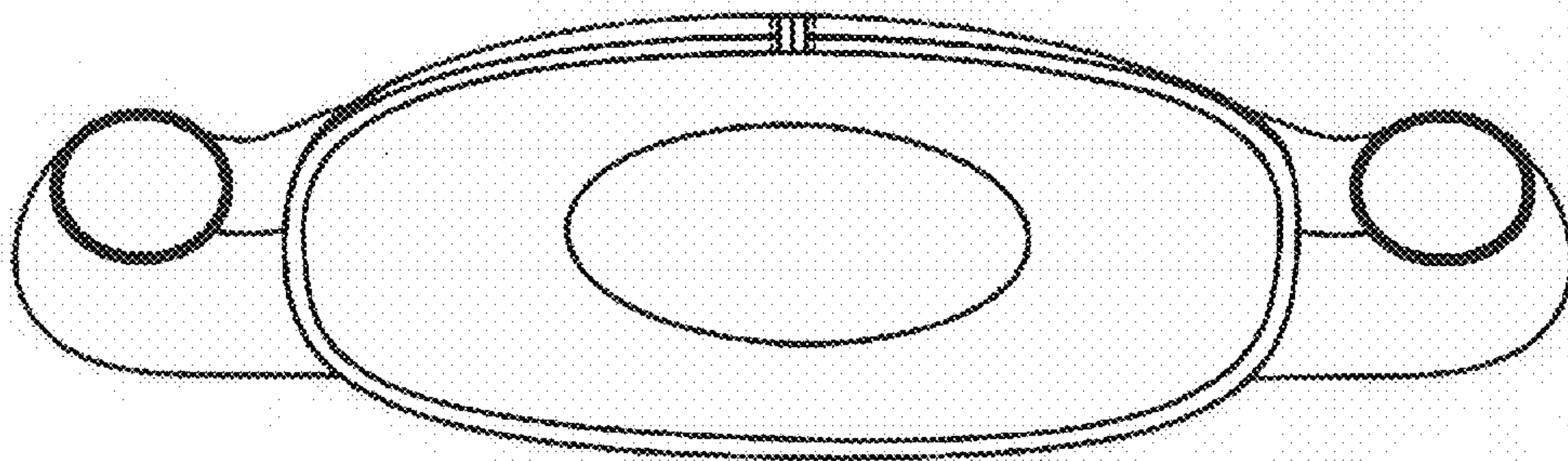

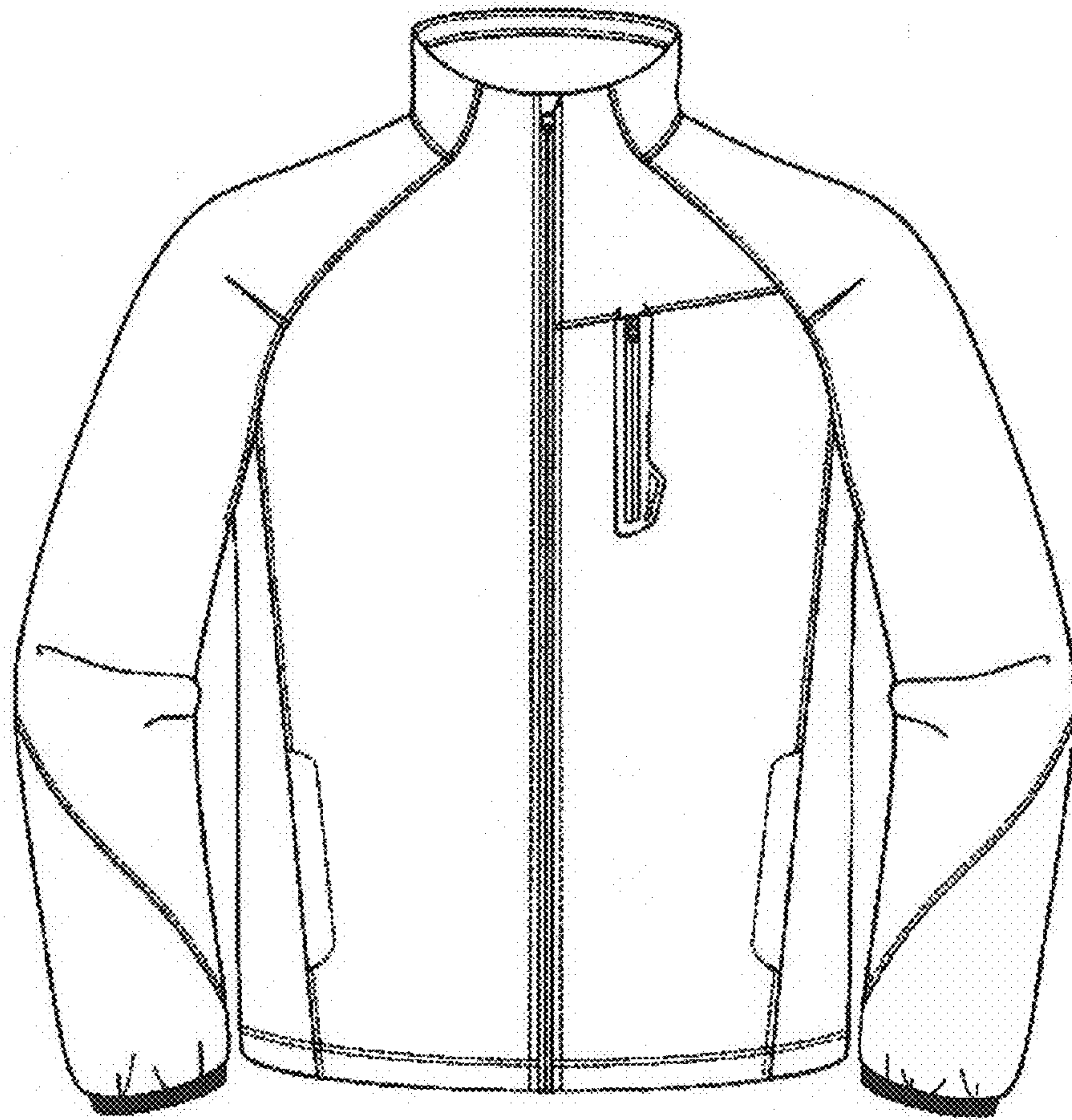

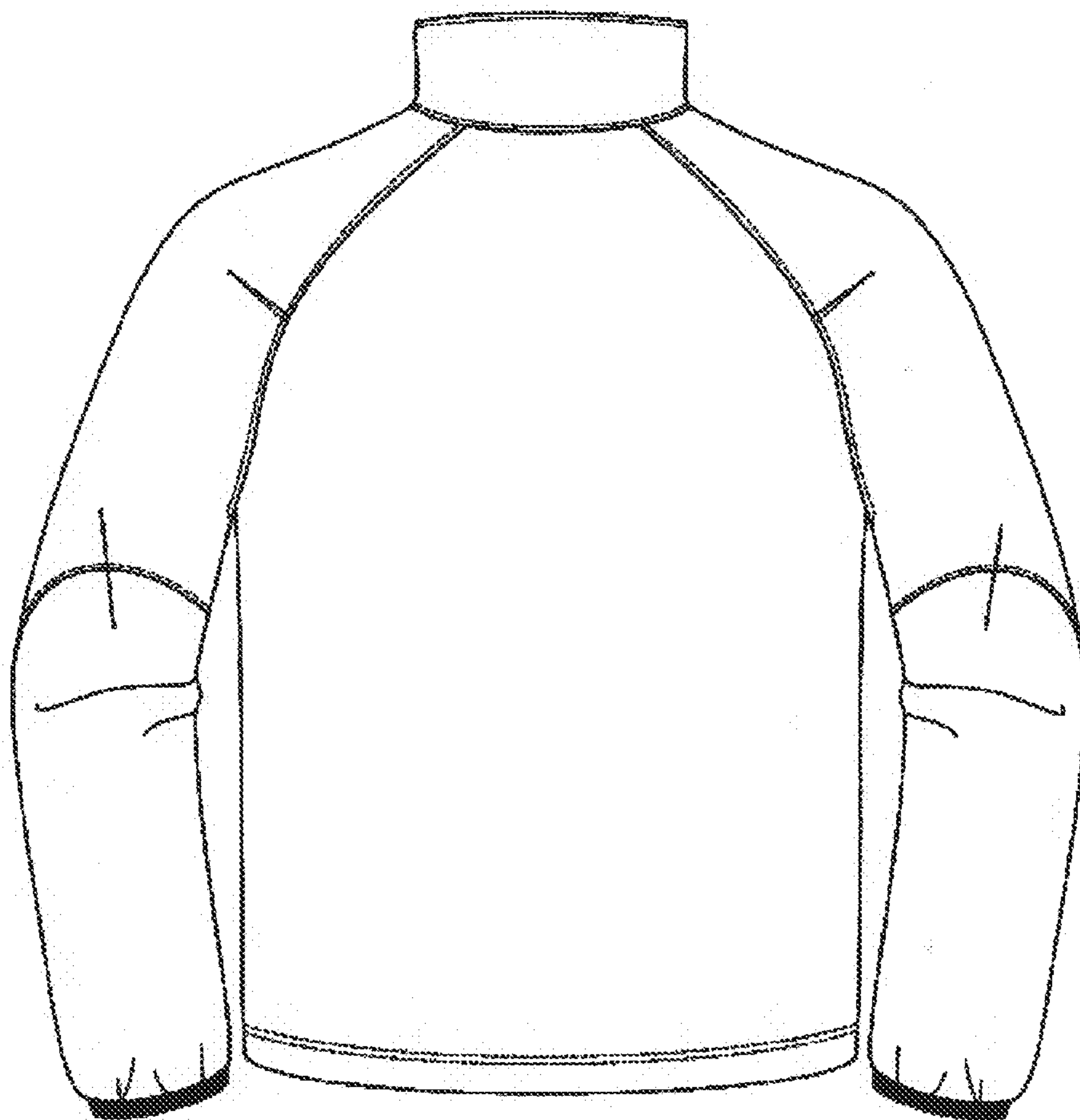

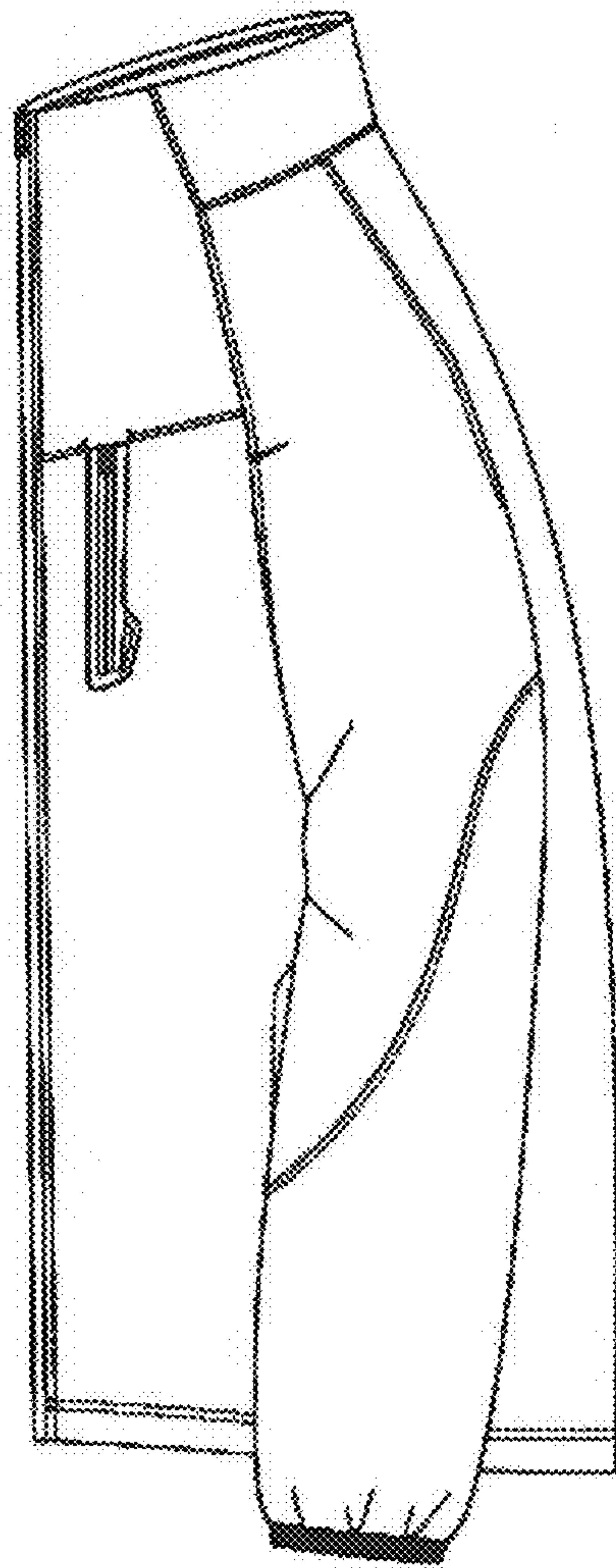

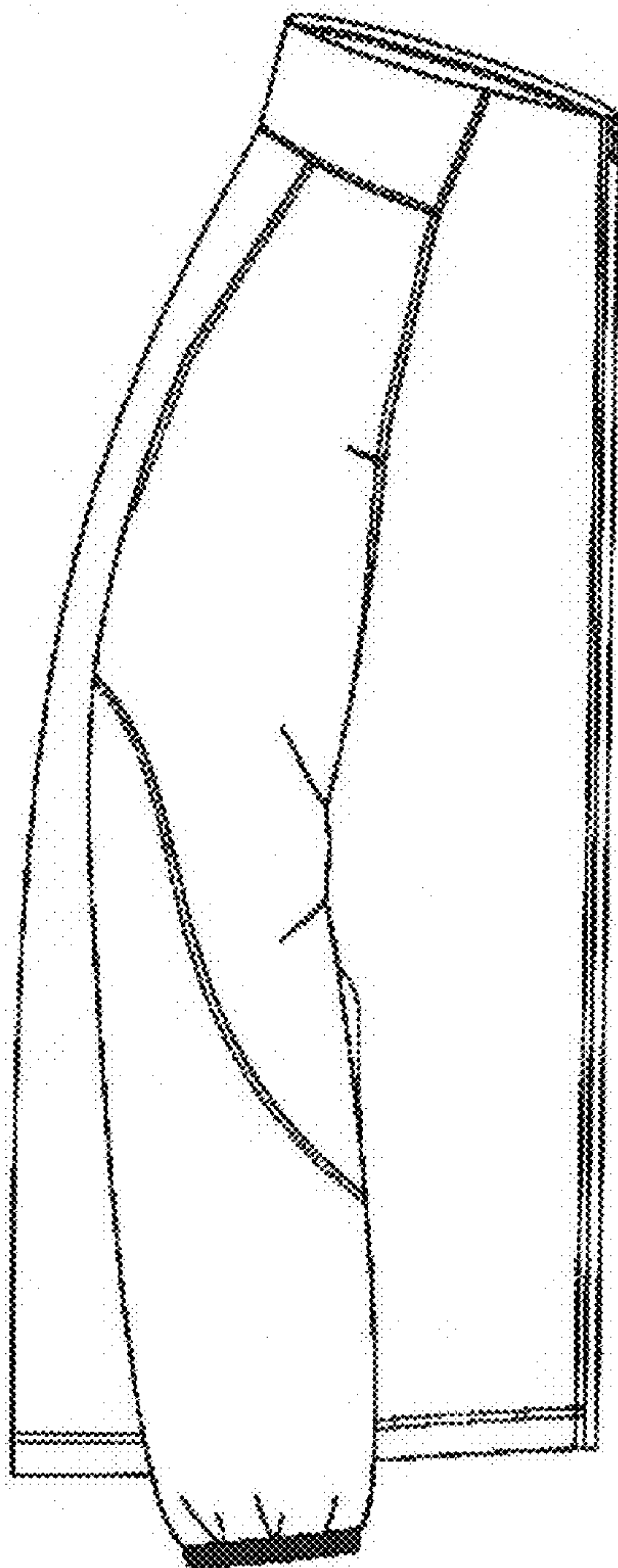

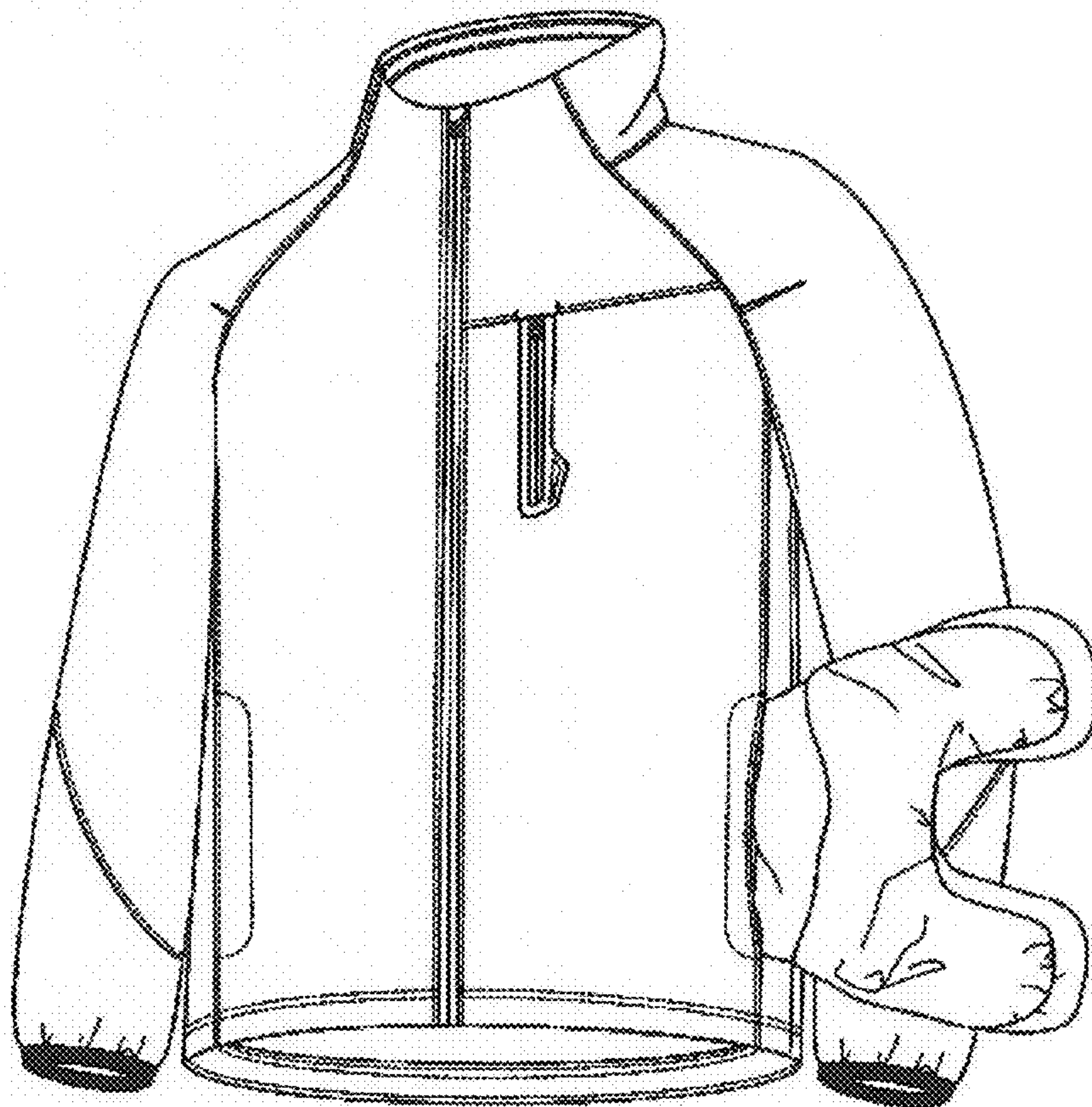

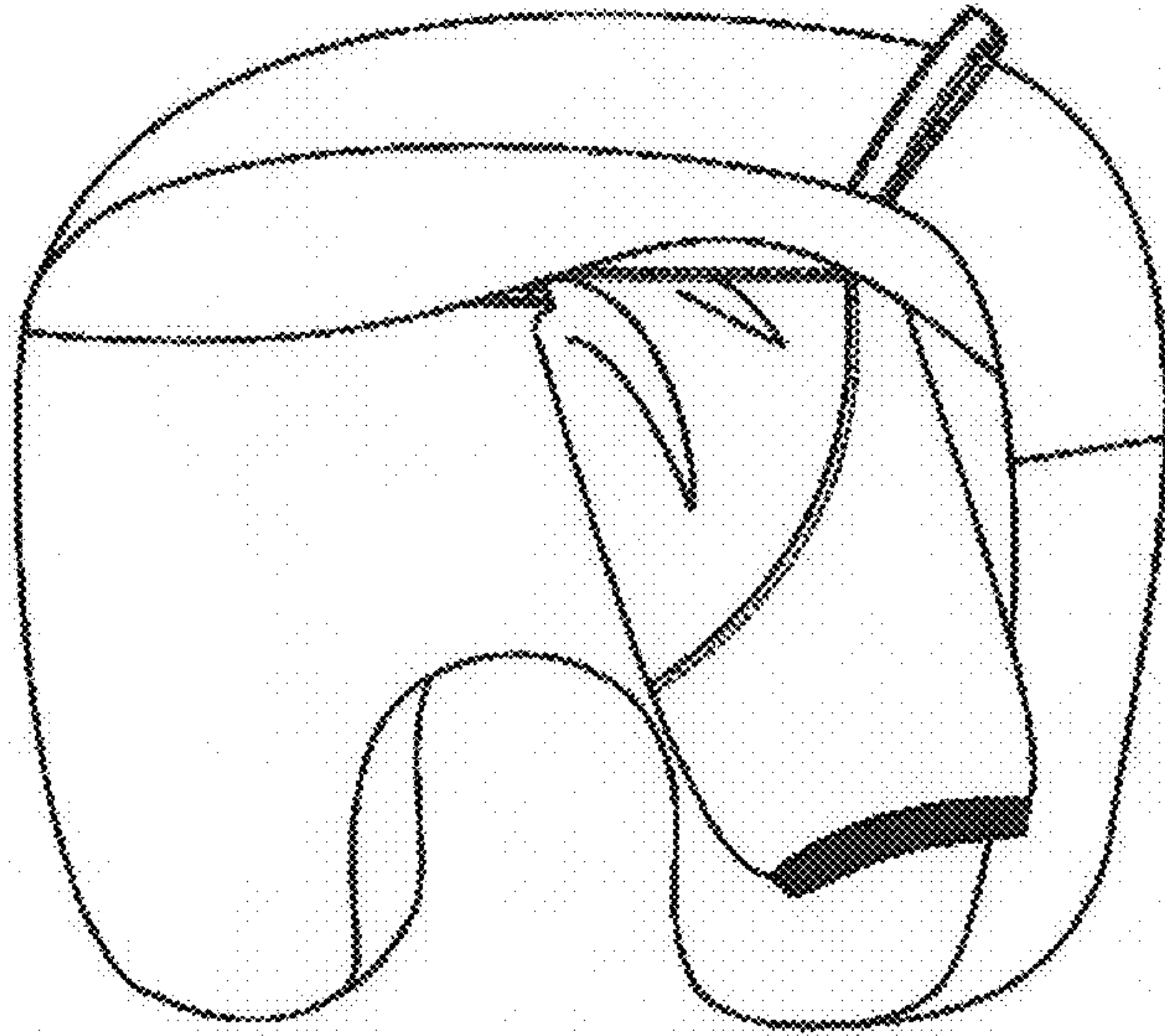

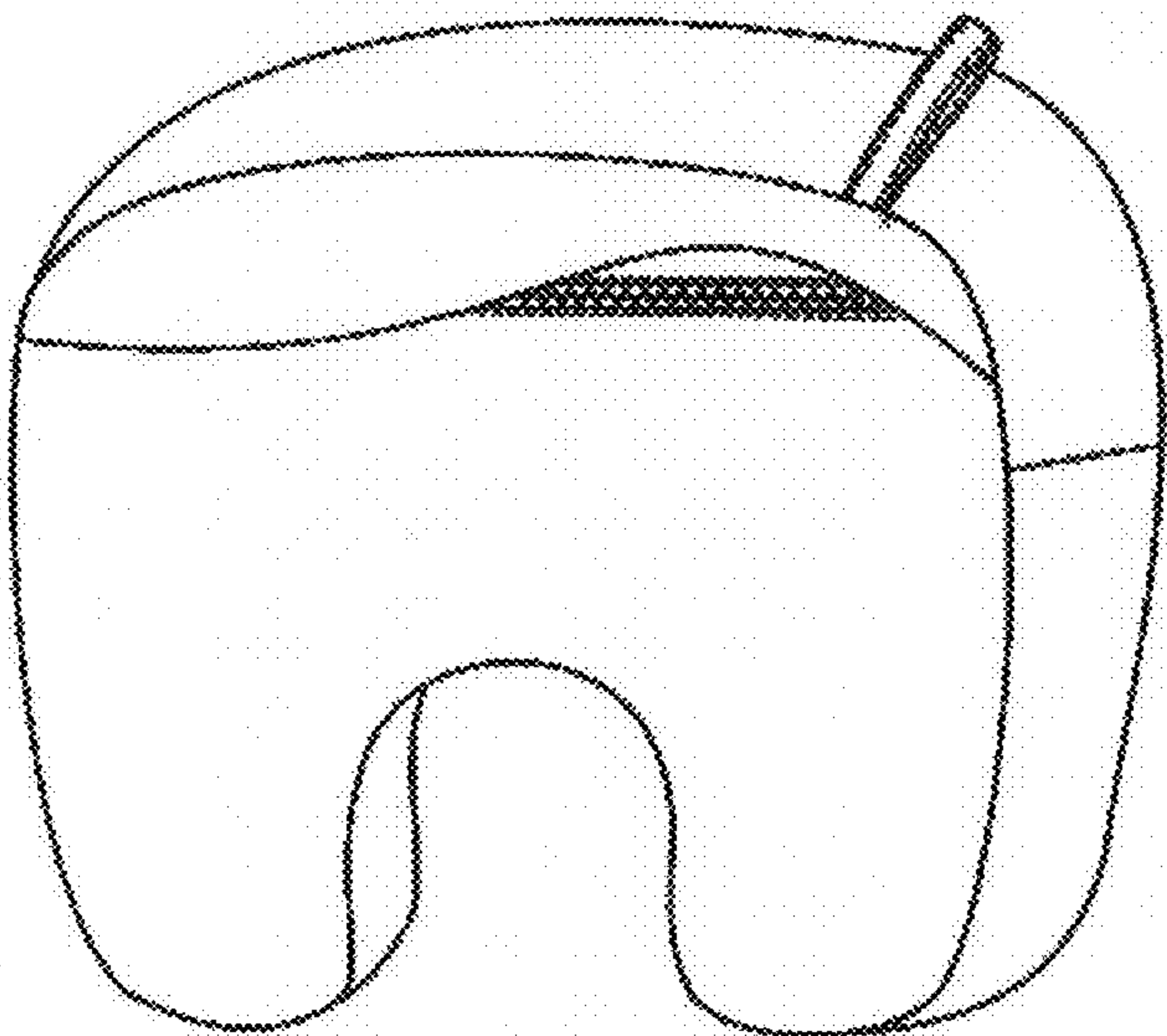
