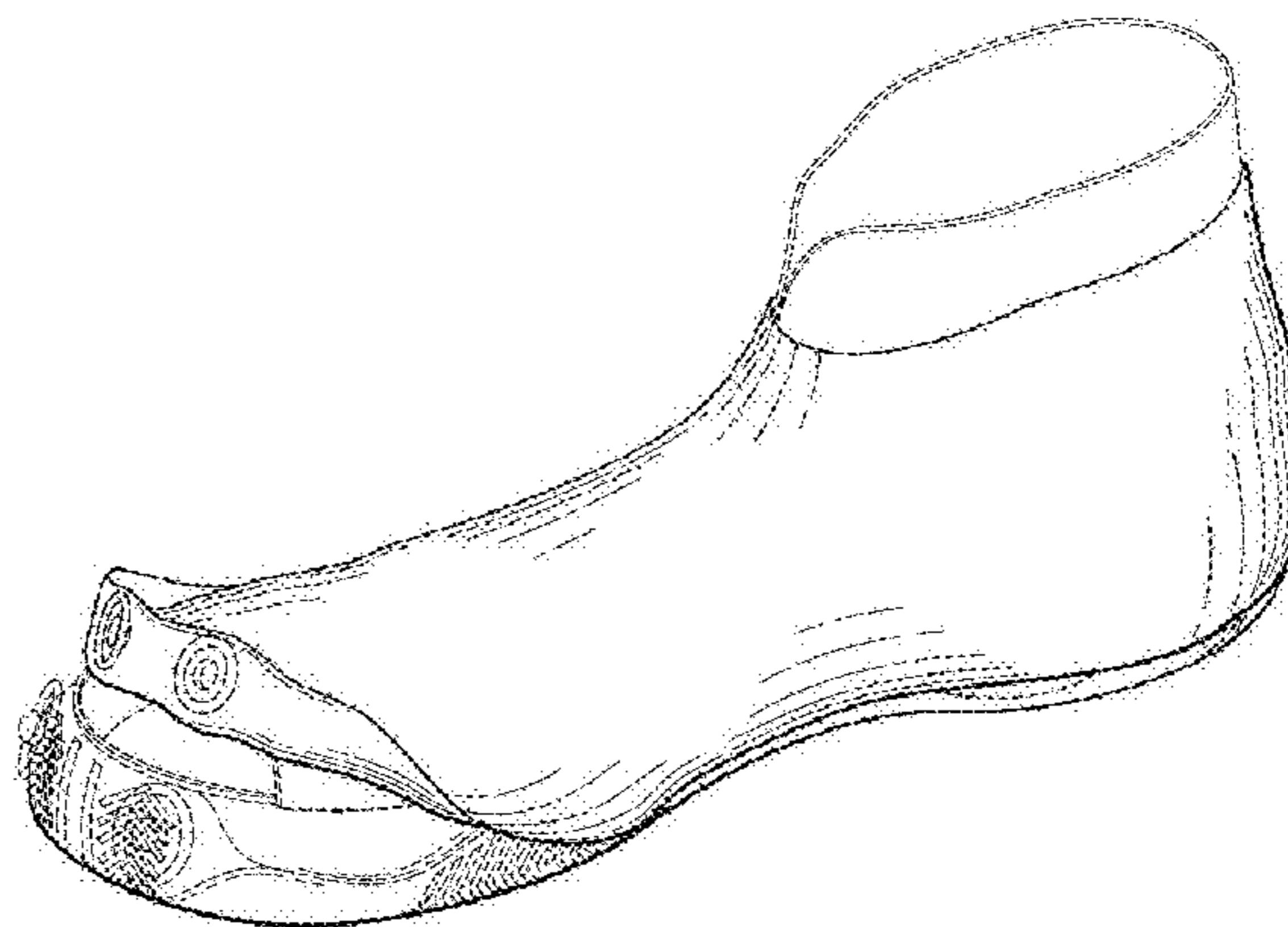
(57) **CLAIM**

The ornamental design for a shoe with shoe cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the shoe with shoe cover showing my design thereof;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a side view thereof;  
FIG. 5 is a perspective view thereof with a shoe cover partially detached from a front portion of the shoe; and,  
FIG. 6 is a bottom view thereof.

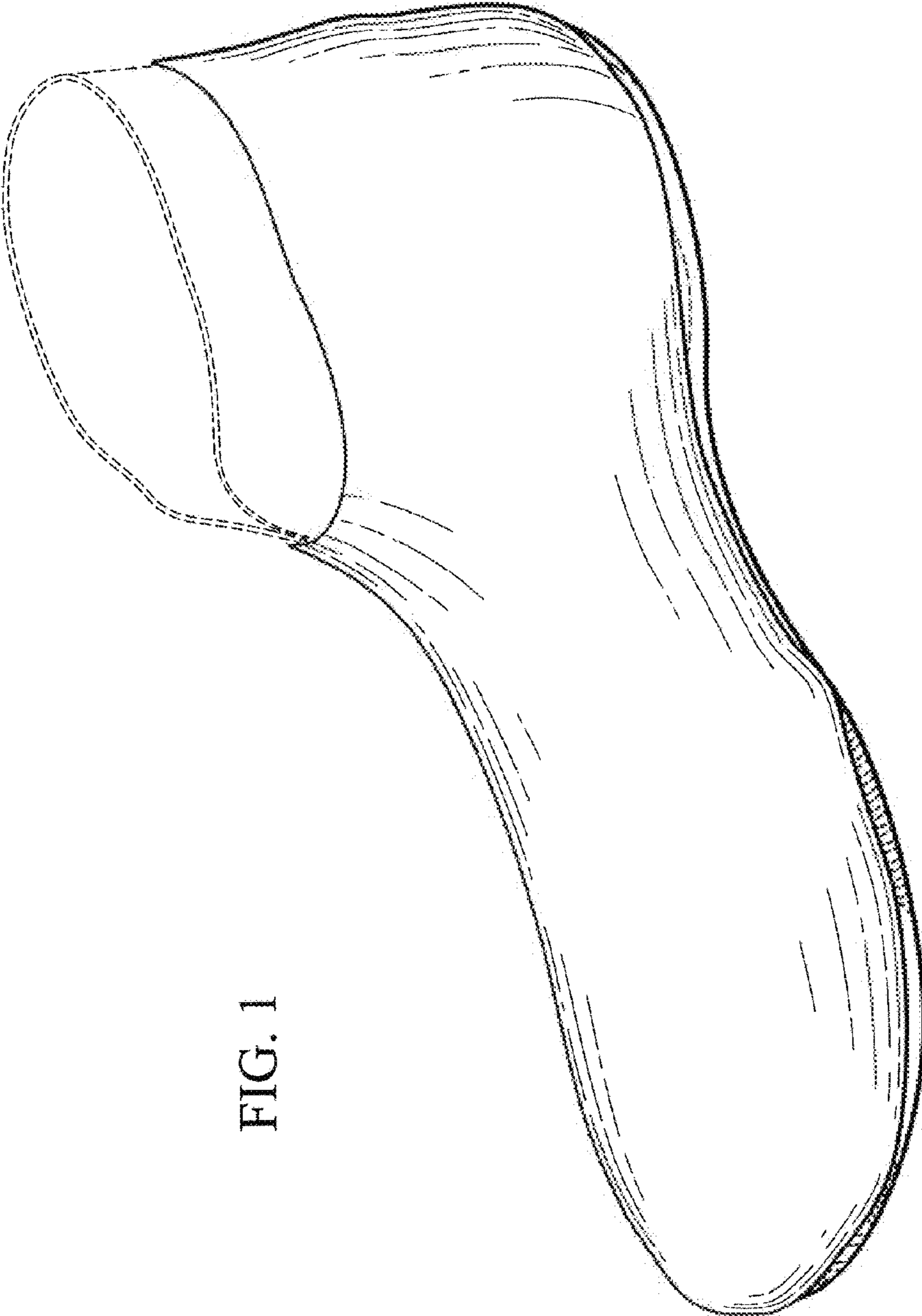

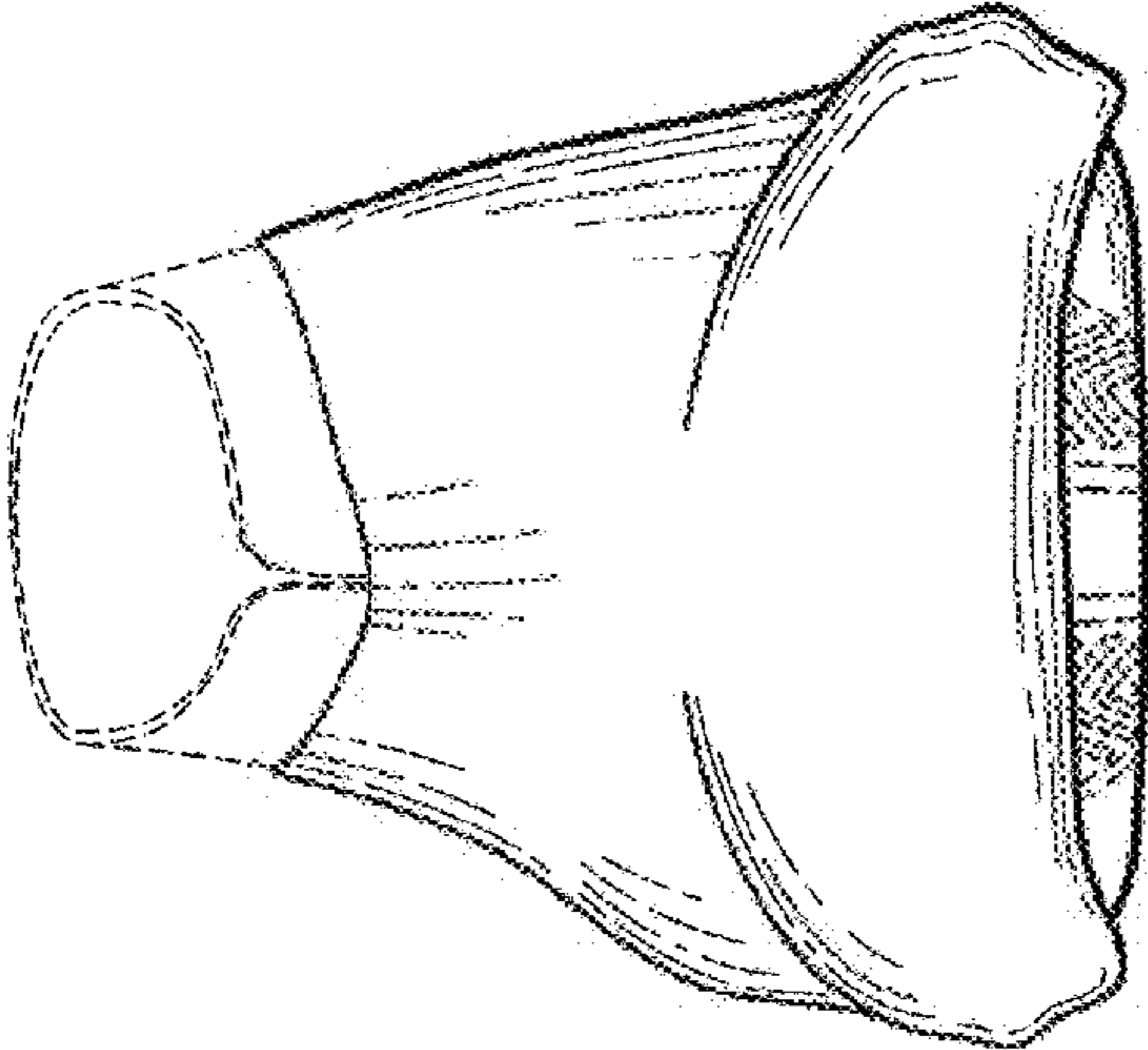
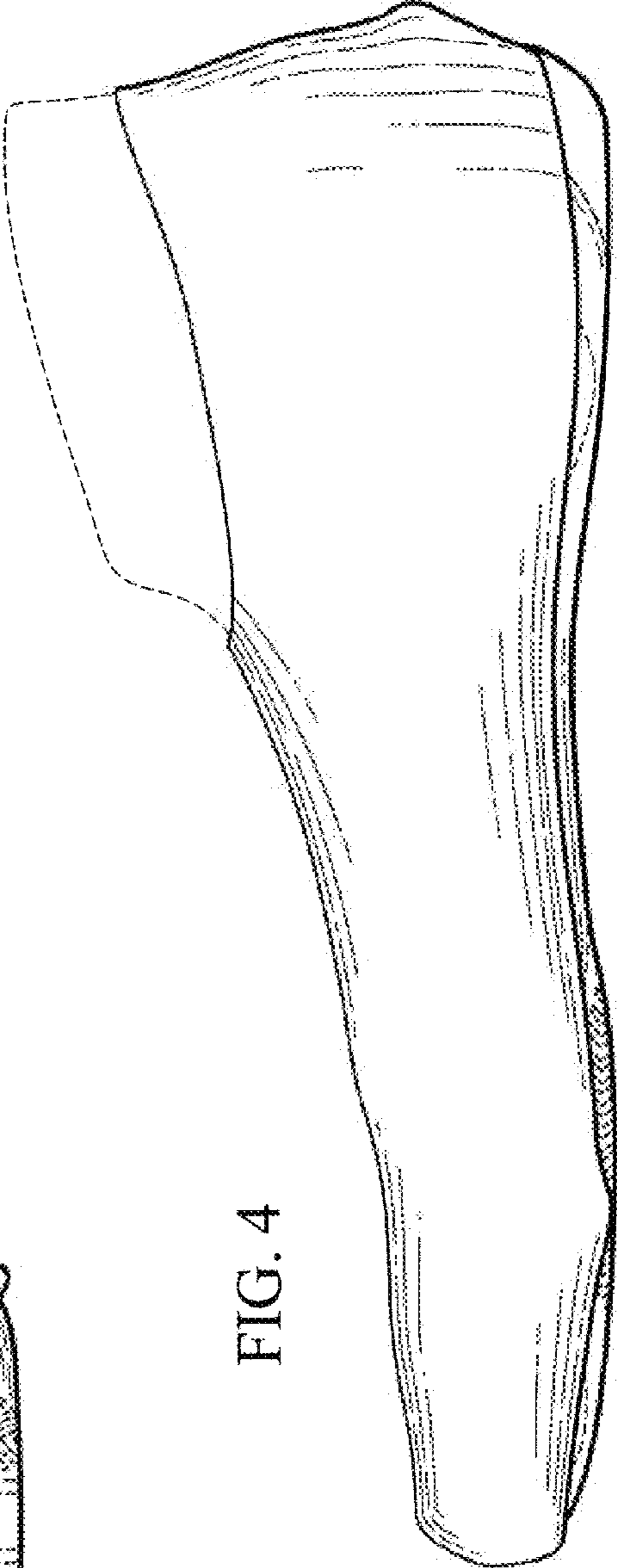

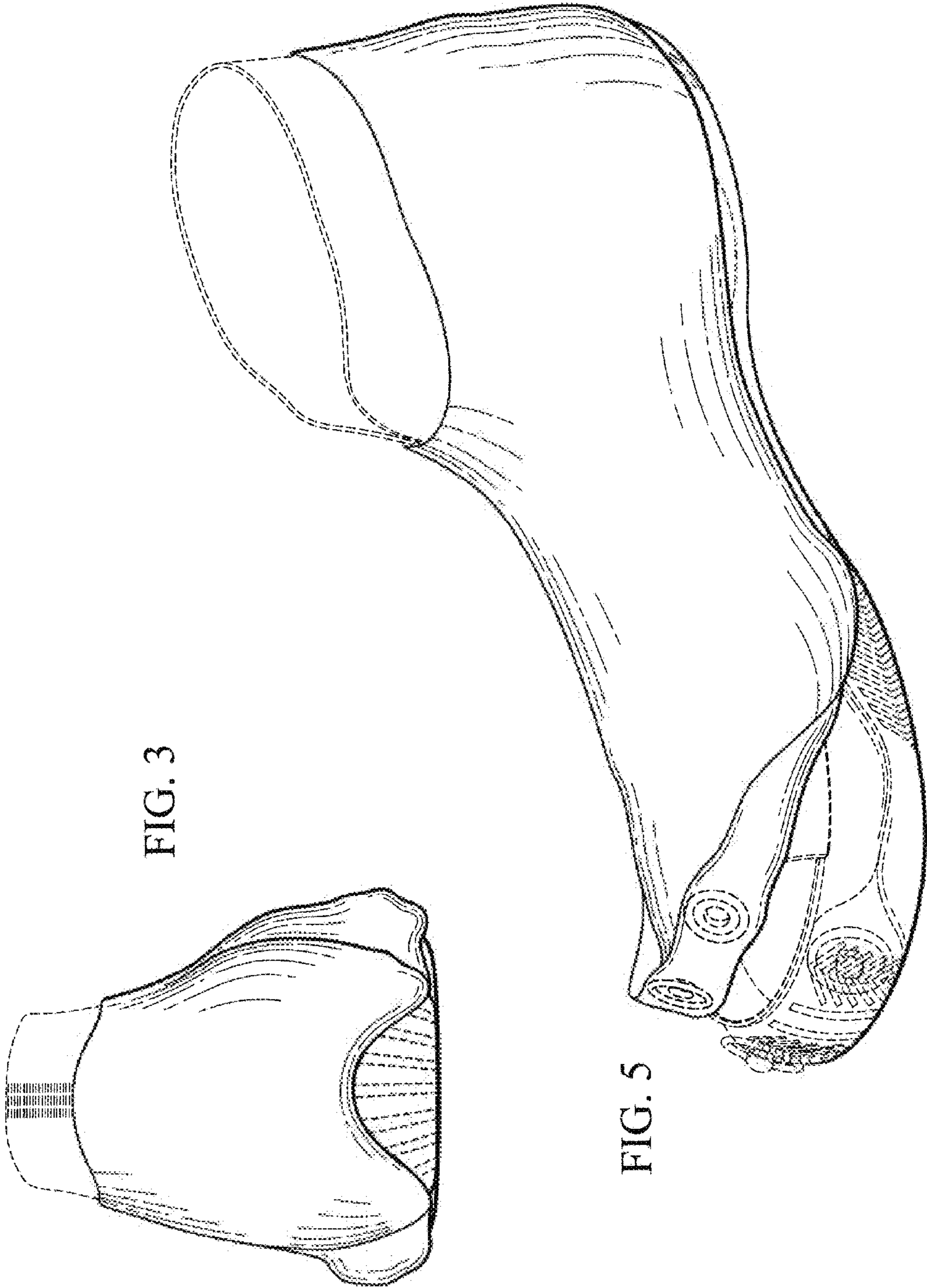

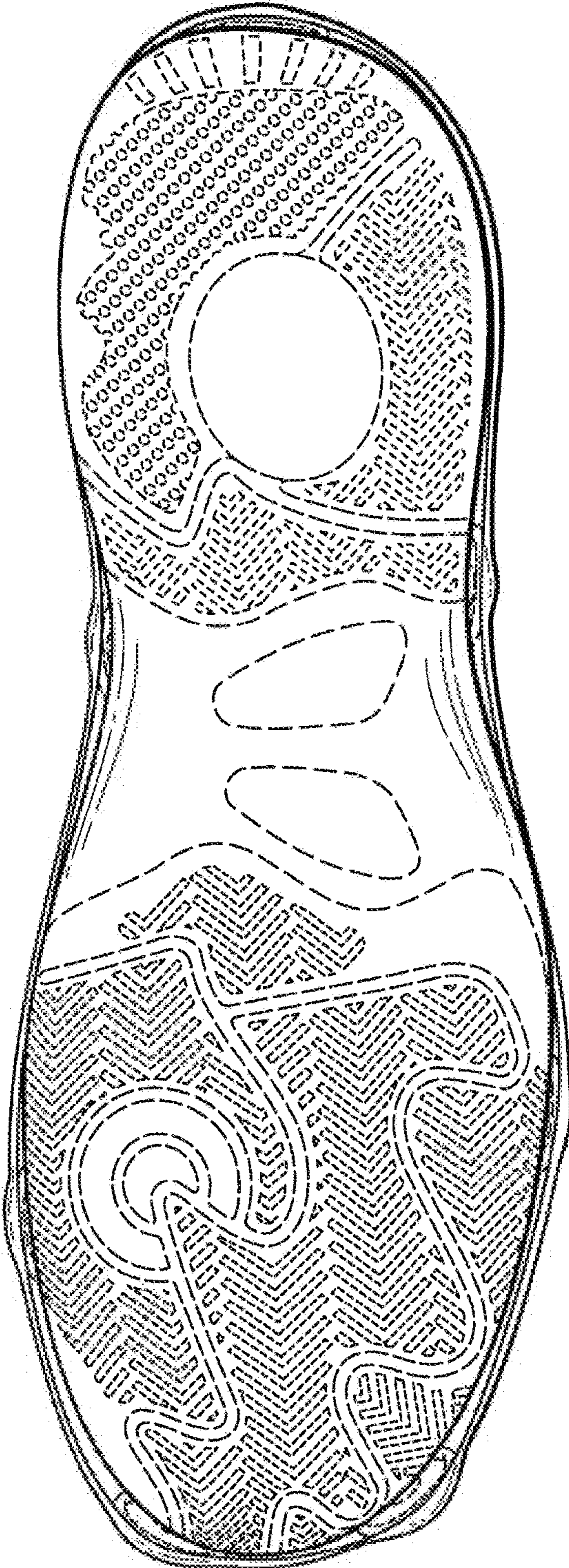
