FIG. 3 is a rear view of a palm makeup brush showing my new design.

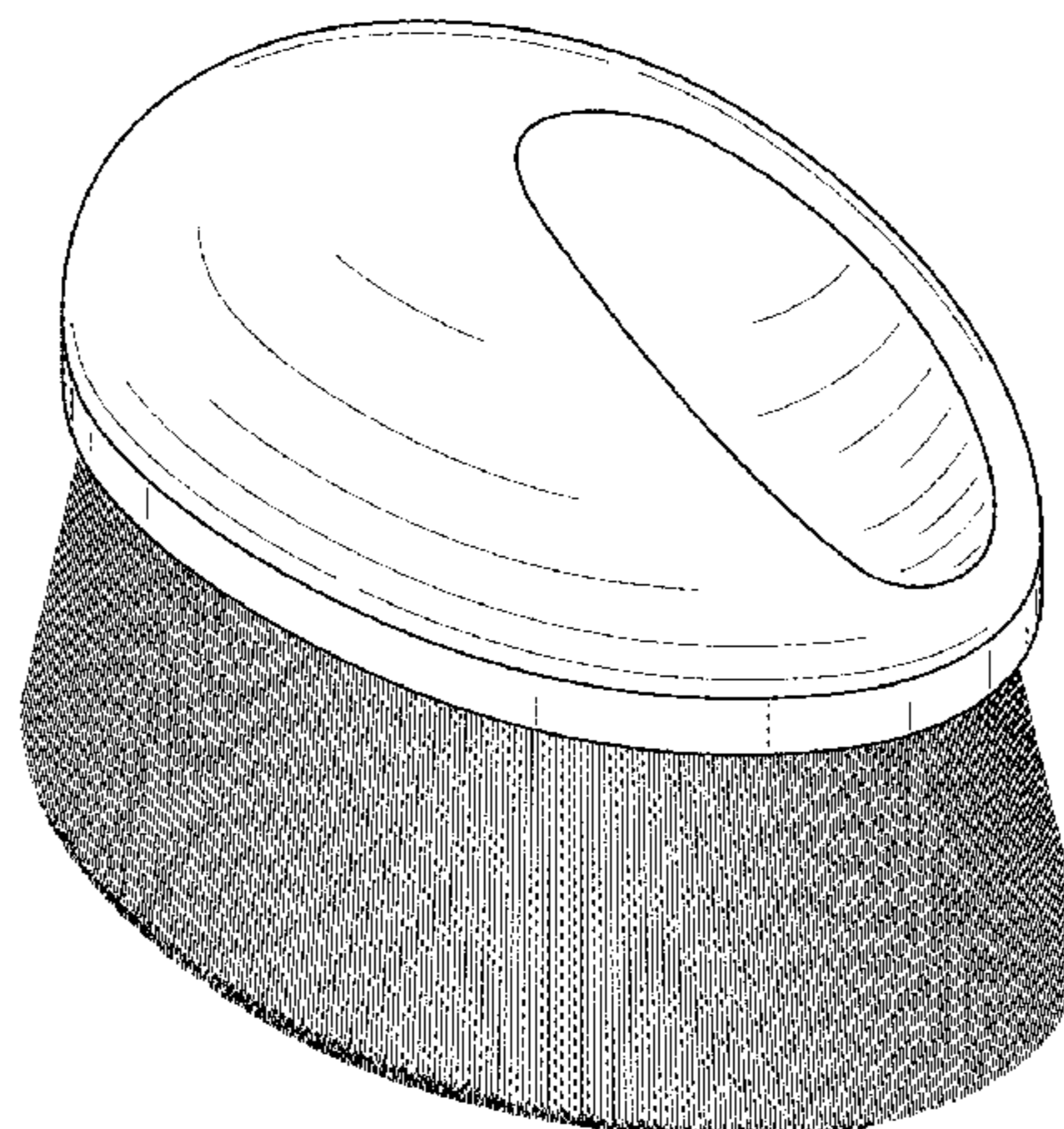
FIG. 4 is an enlarged side view of a palm makeup brush showing my new design.

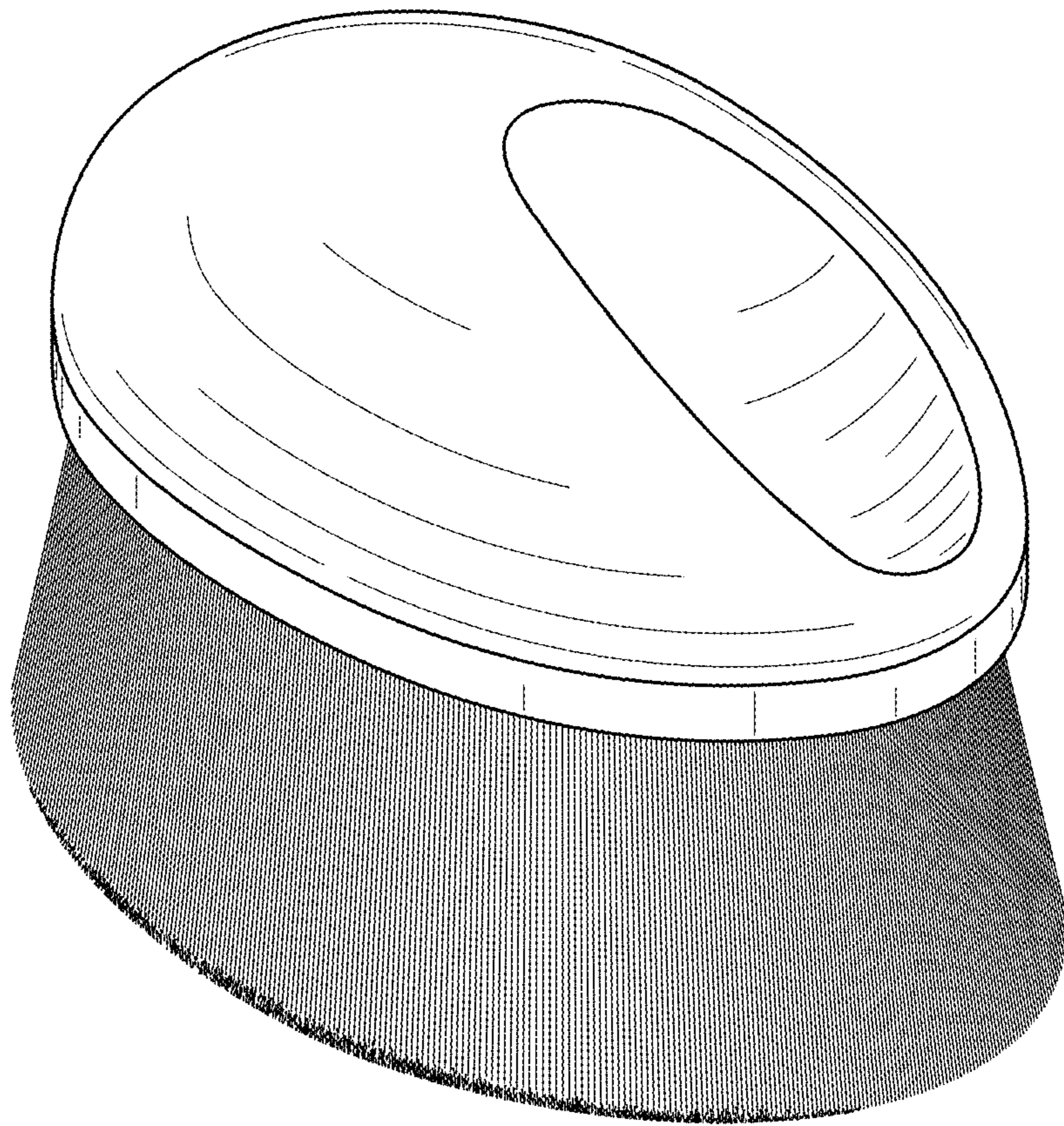

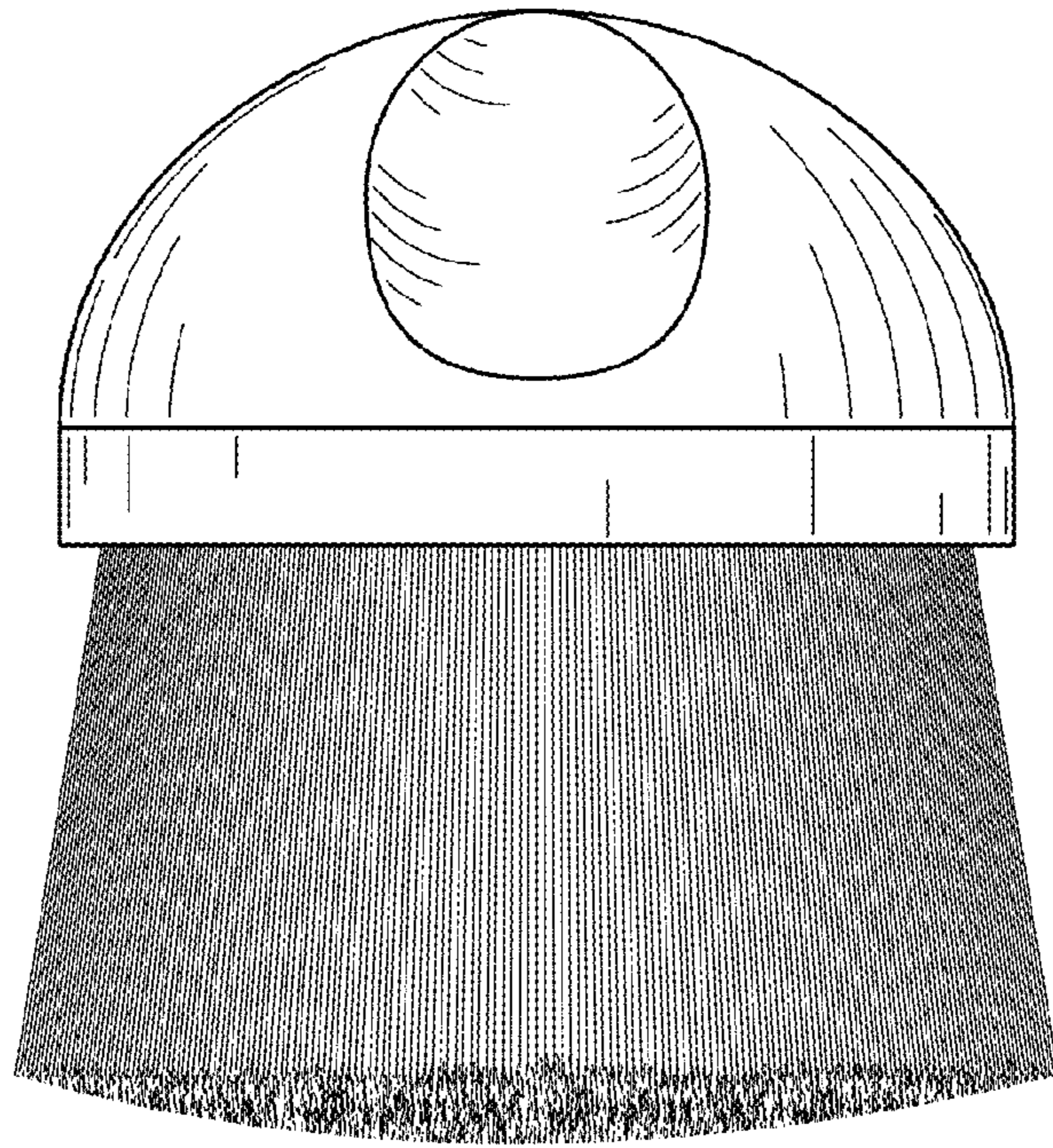

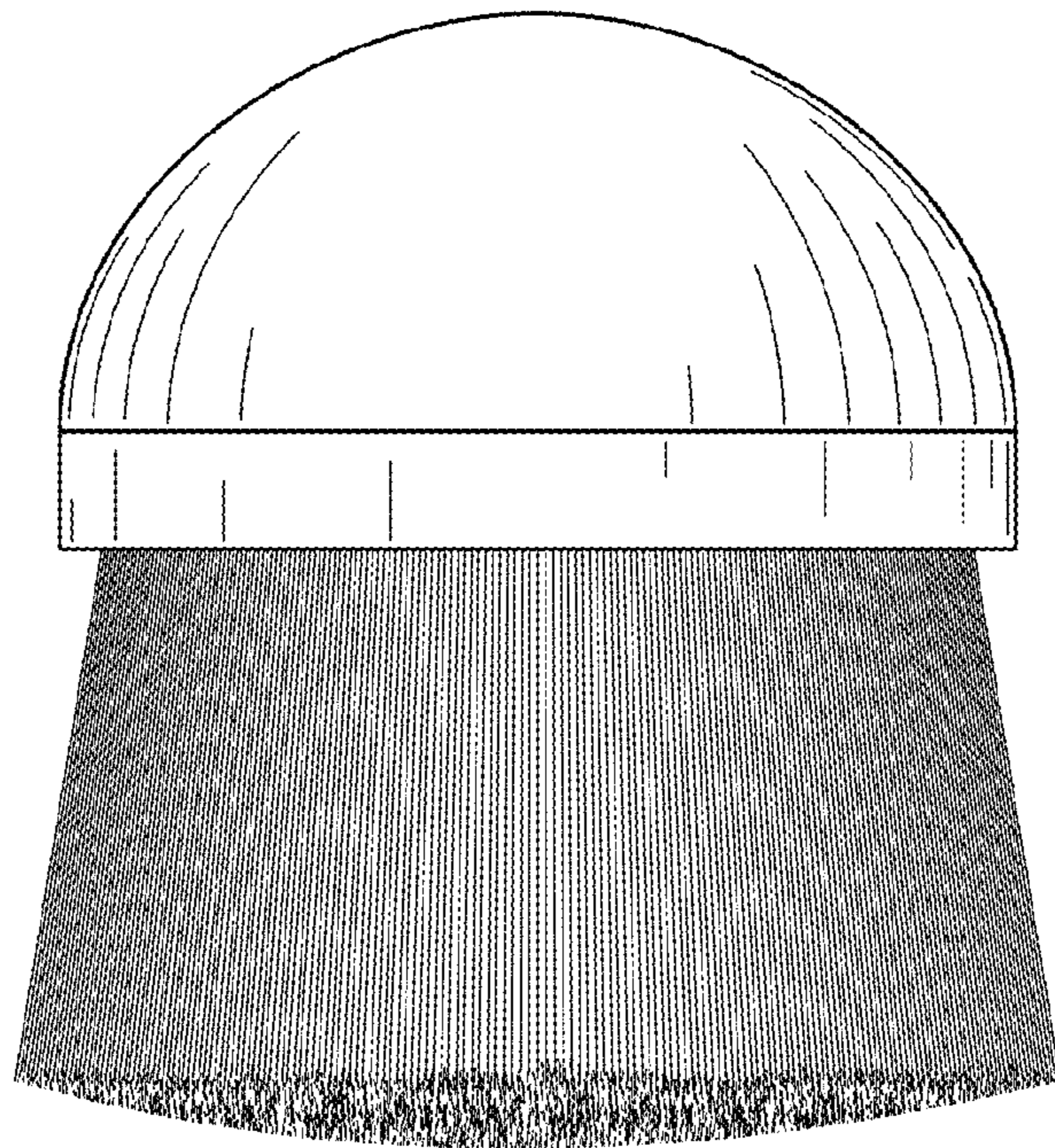

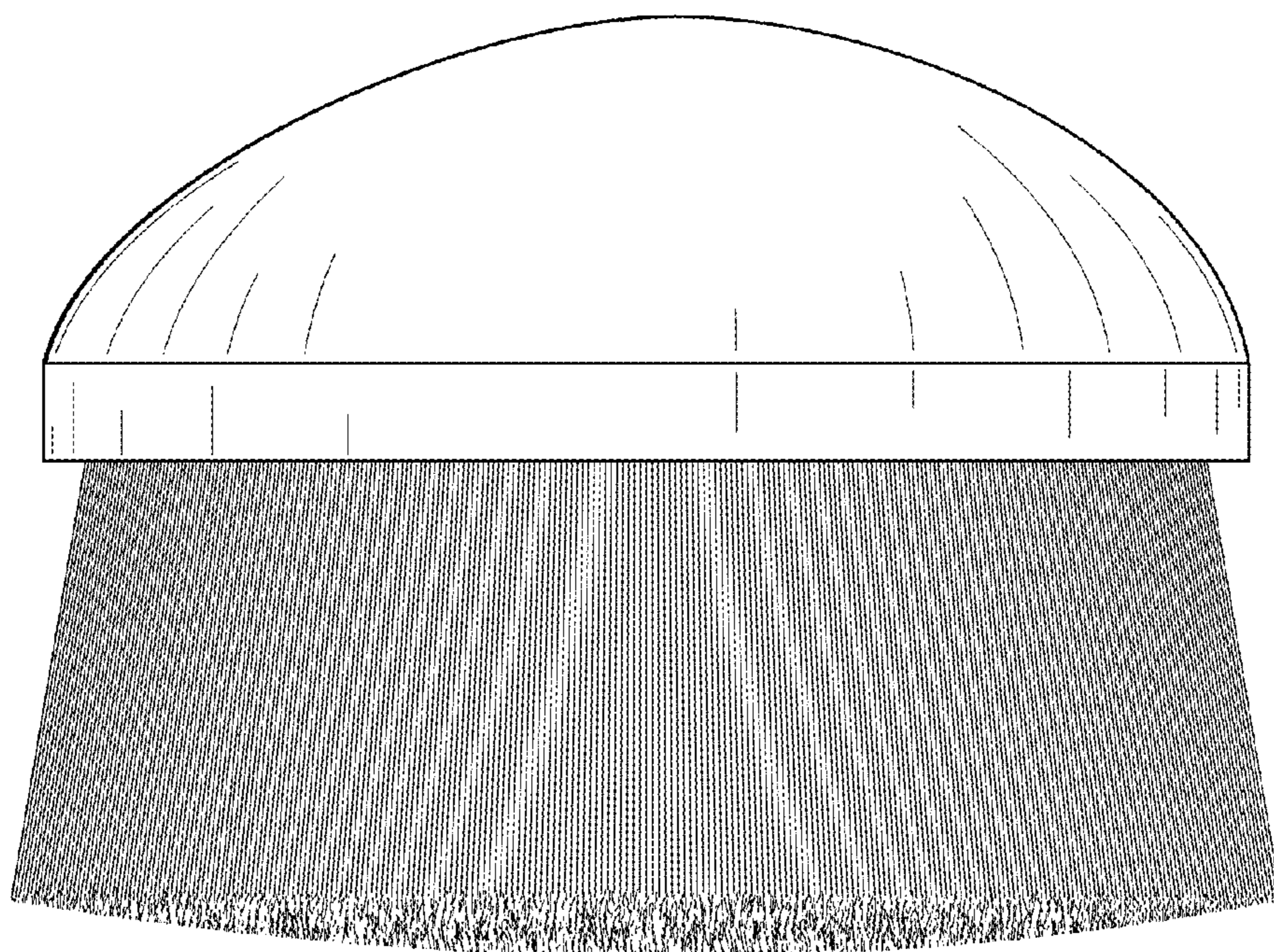

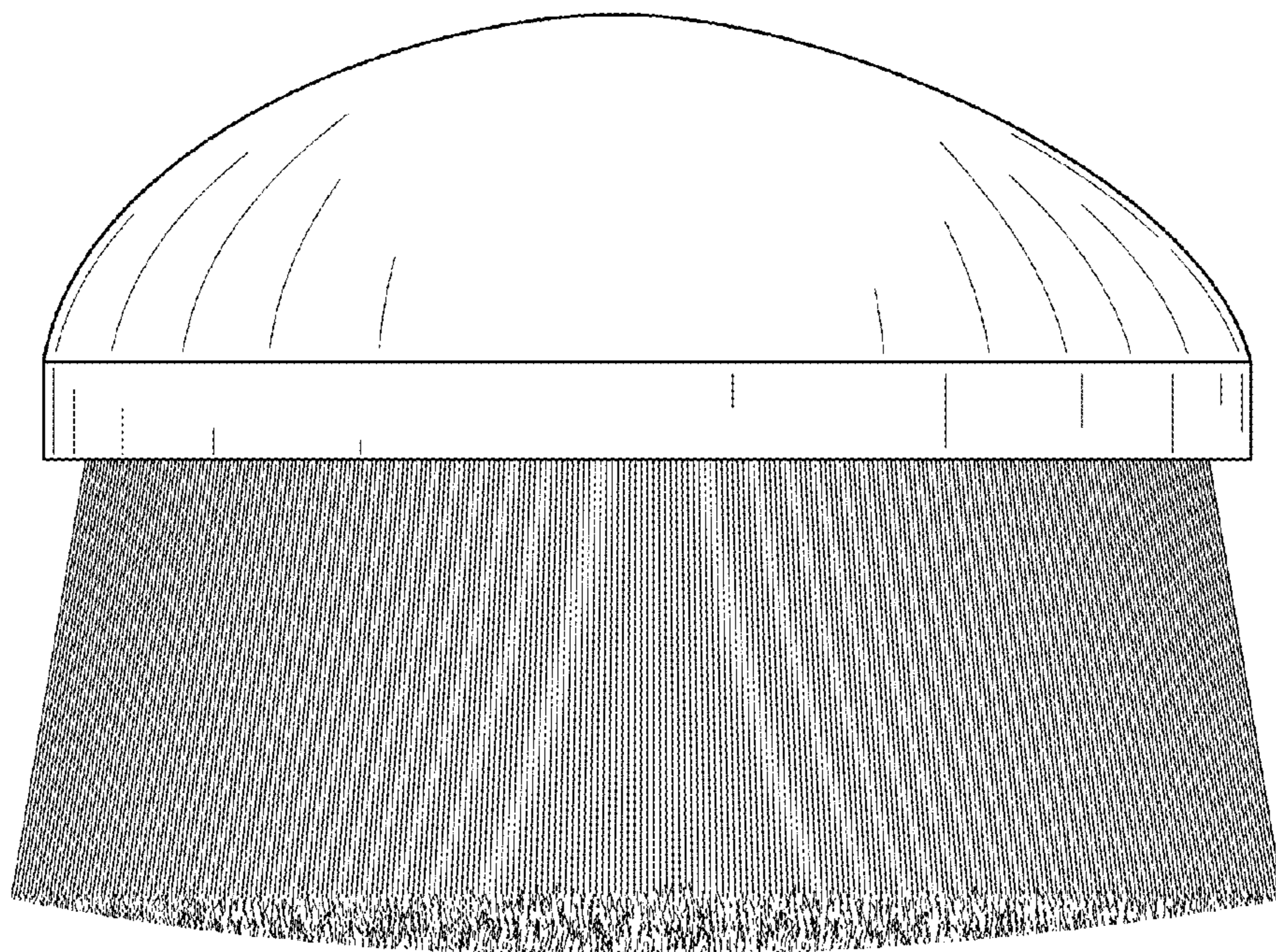

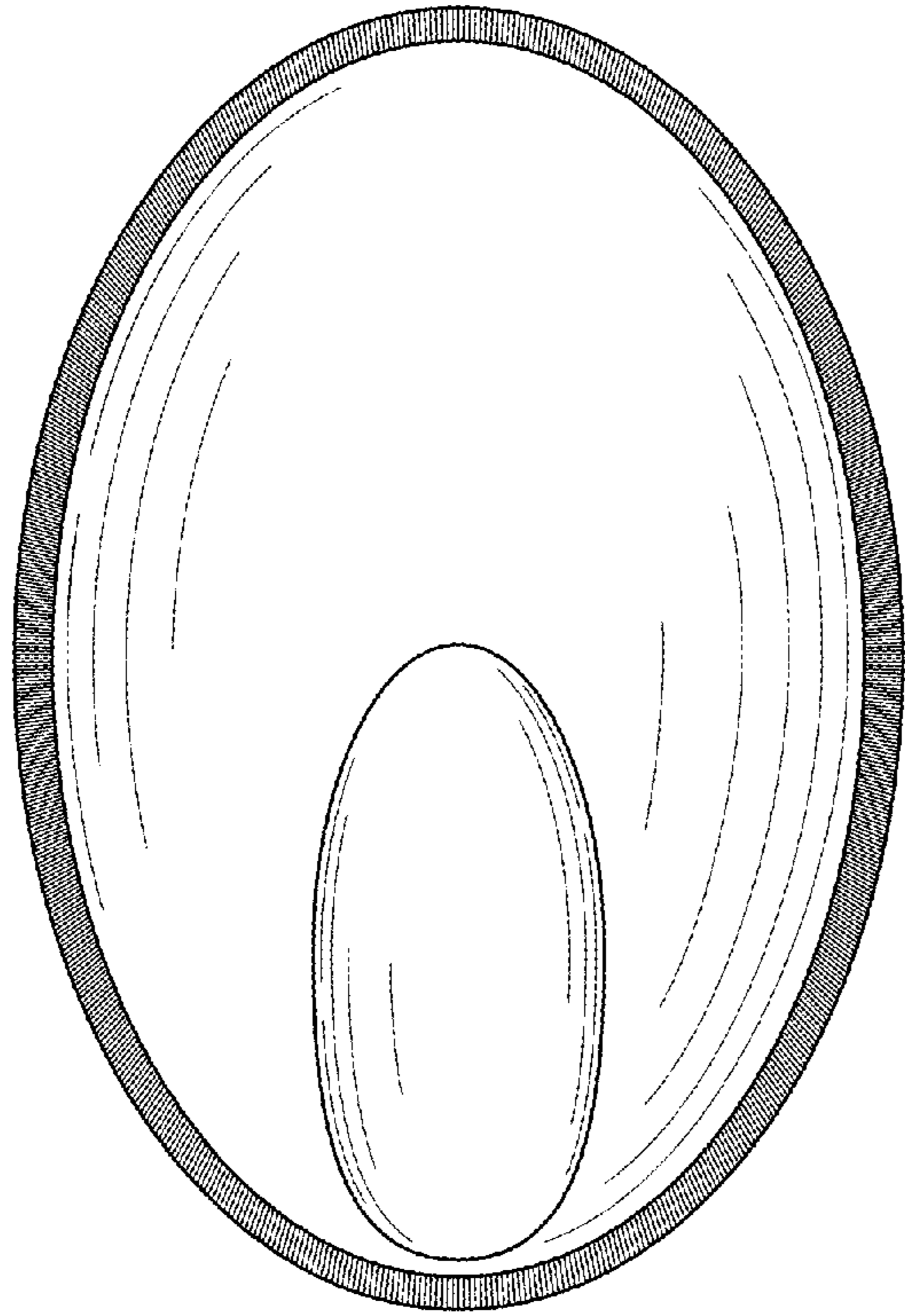

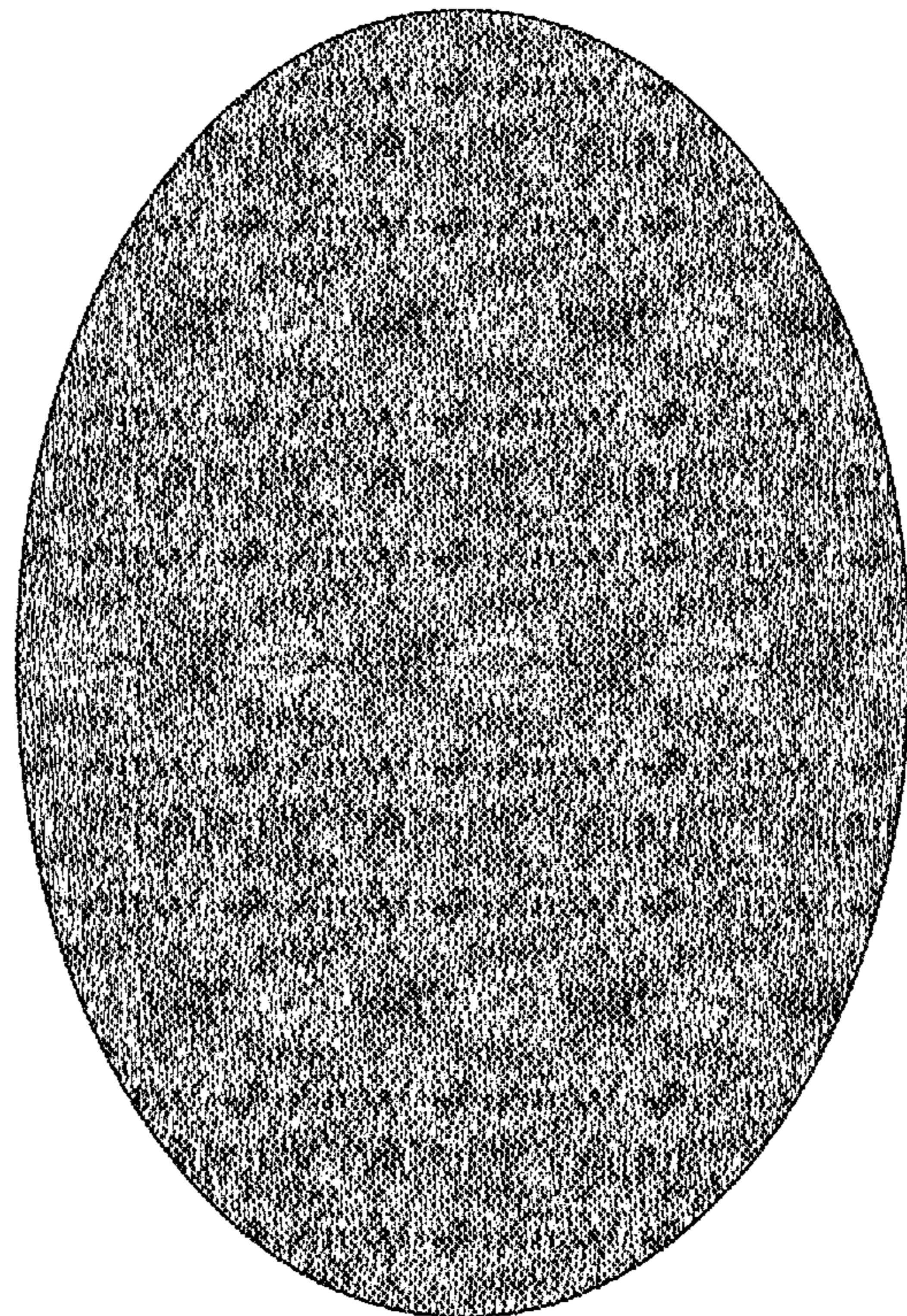
