(57) **CLAIM**

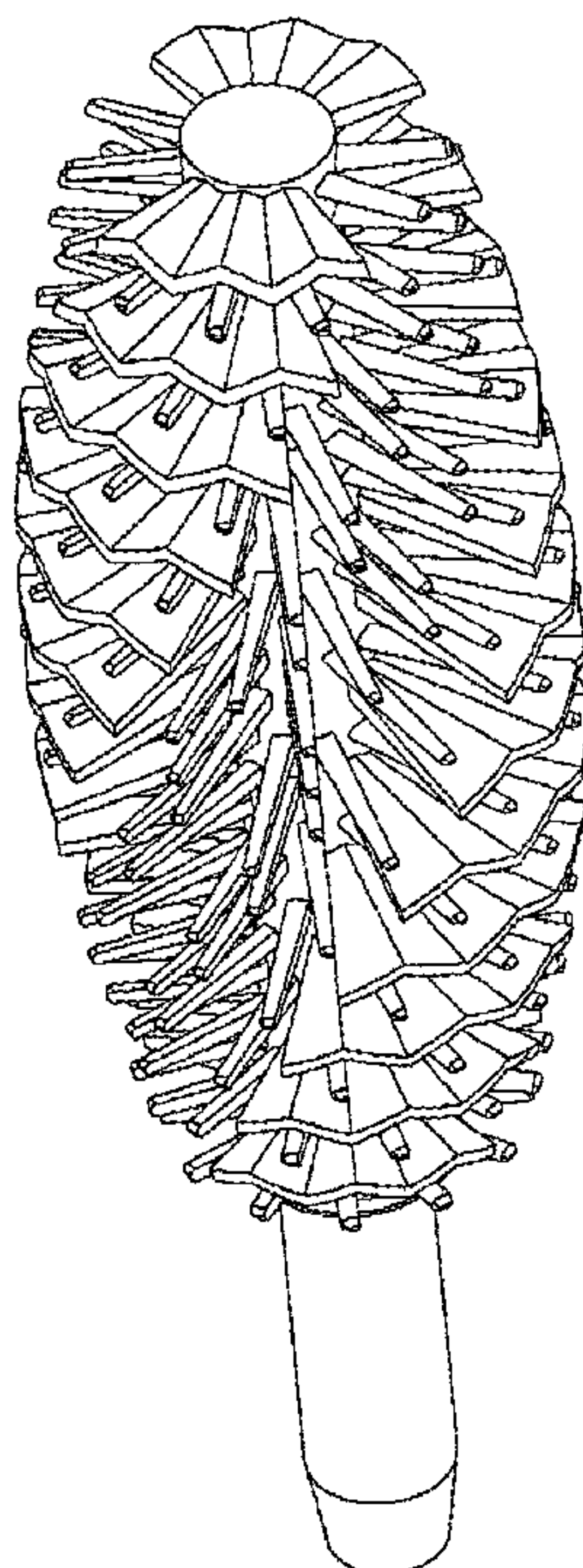
The ornamental design for a mascara brush, as shown and described.

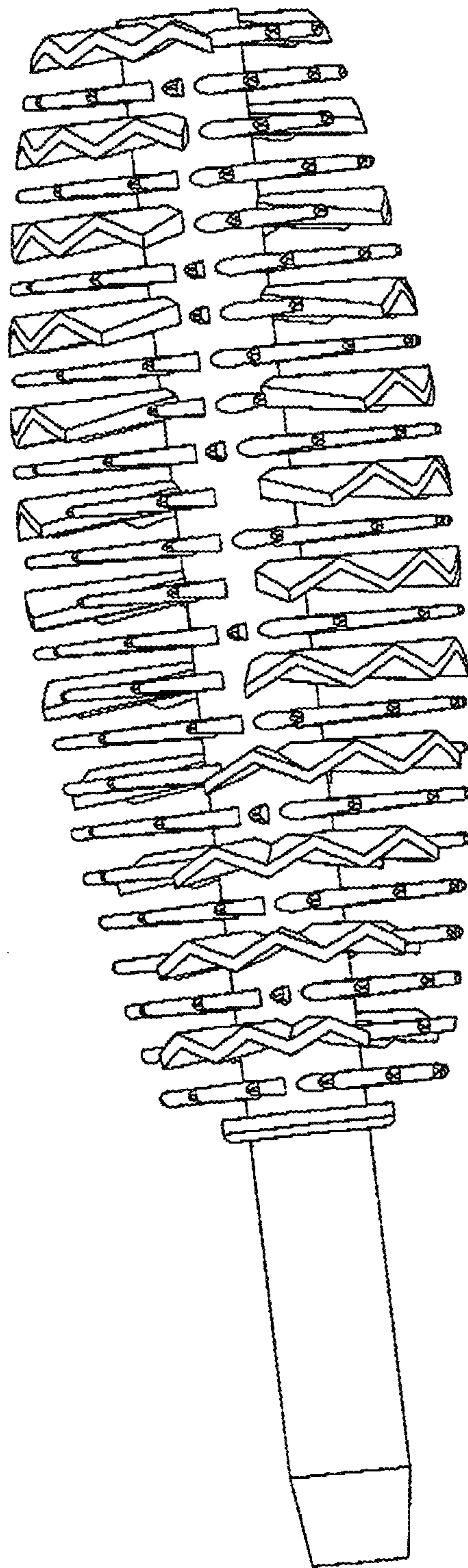

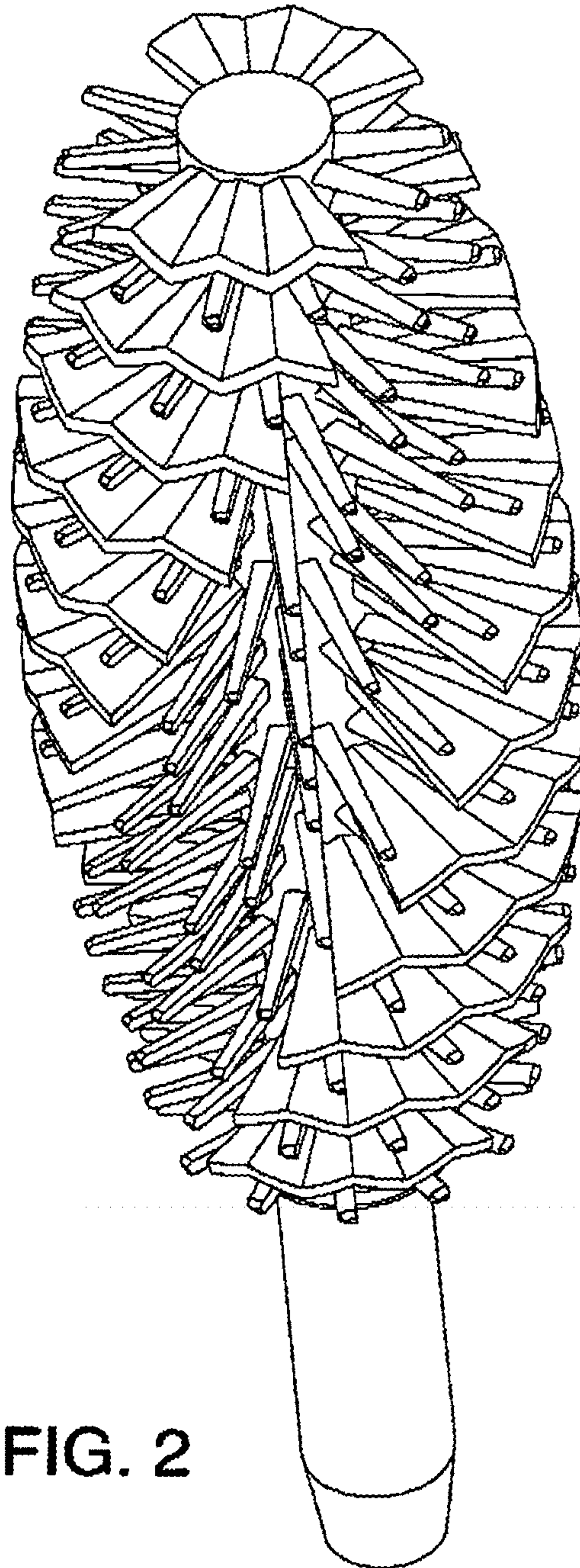
