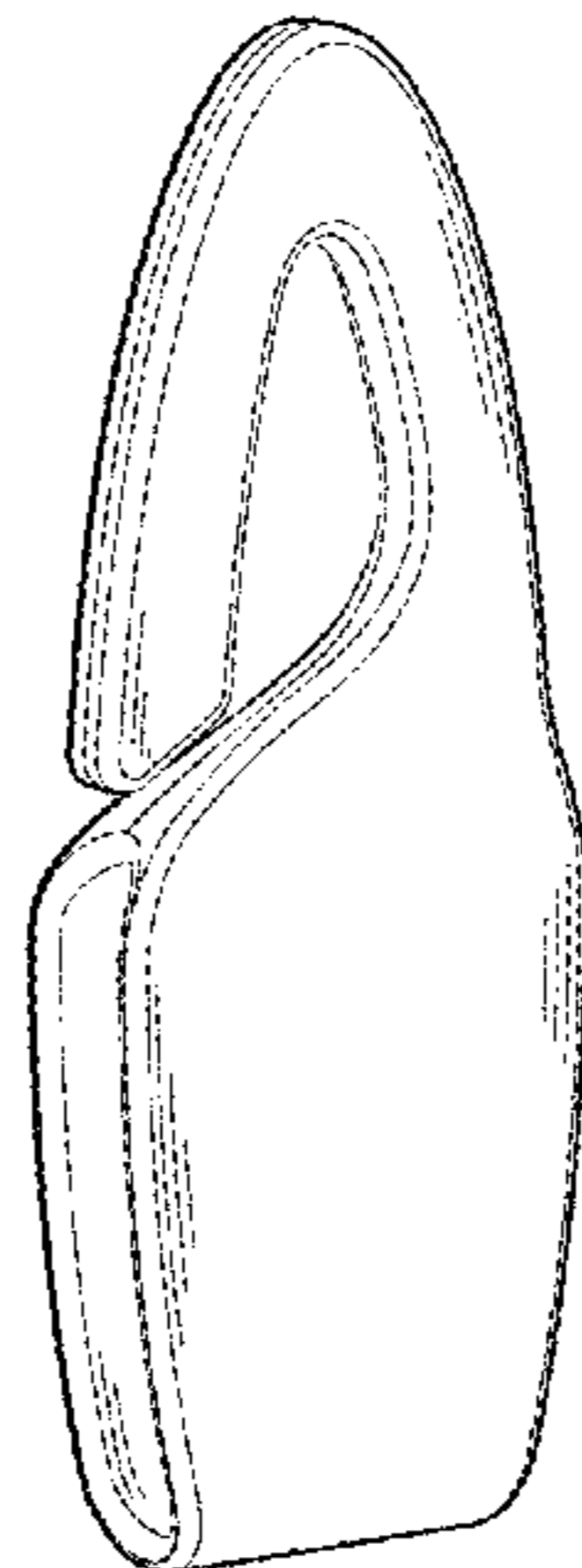
(57) **CLAIM**

The ornamental design for a clothesline hanger support, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of a clothesline hanger support;  
 FIG. 2 is a rear right perspective view of the clothesline hanger support;  
 FIG. 3 is a rear left perspective view of the clothesline hanger support;  
 FIG. 4 is a front right perspective view of the clothesline hanger support;  
 FIG. 5 is a left elevational view view of the clothesline hanger support, the right elevational view being a mirror image thereof;  
 FIG. 6 is a top plan view of the clothesline hanger support;  
 FIG. 7 is a bottom plan view of the clothesline hanger support;  
 FIG. 8 is a front elevational view of the clothesline hanger support;  
 FIG. 9 is a rear elevational view of the clothesline hanger support; and,  
 FIG. 10 is front perspective view illustrating use of the clothesline hanger support shown in environmental use.

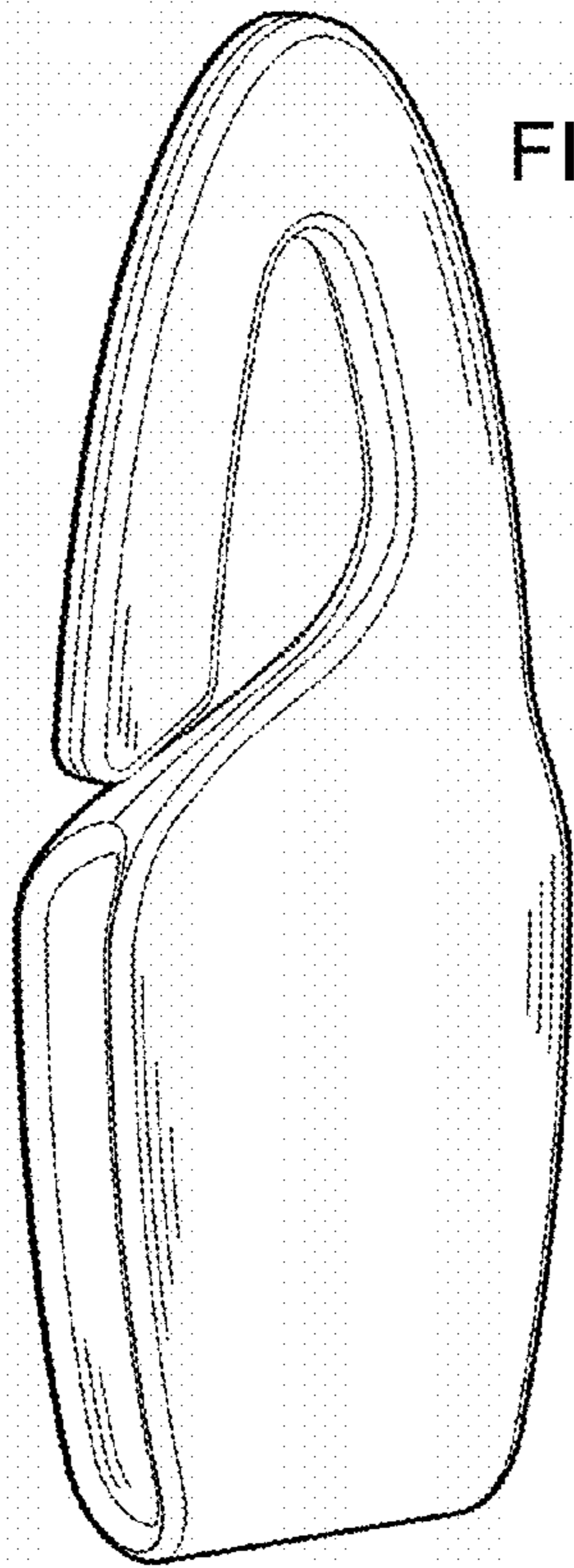

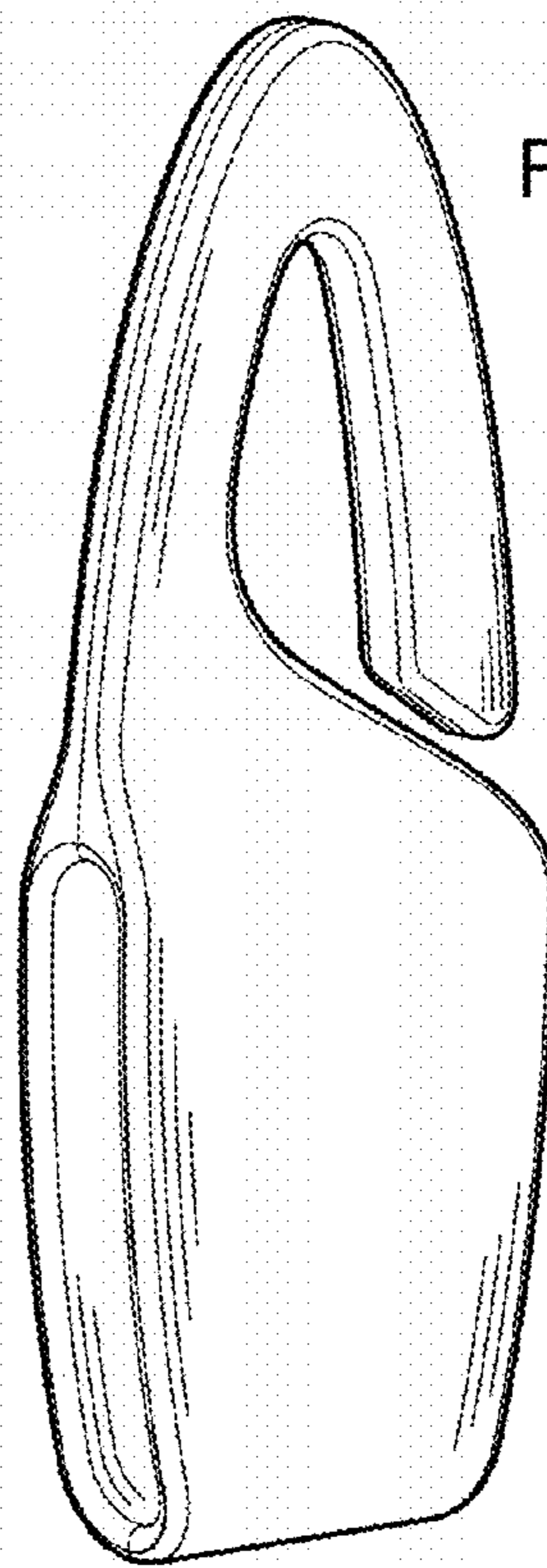

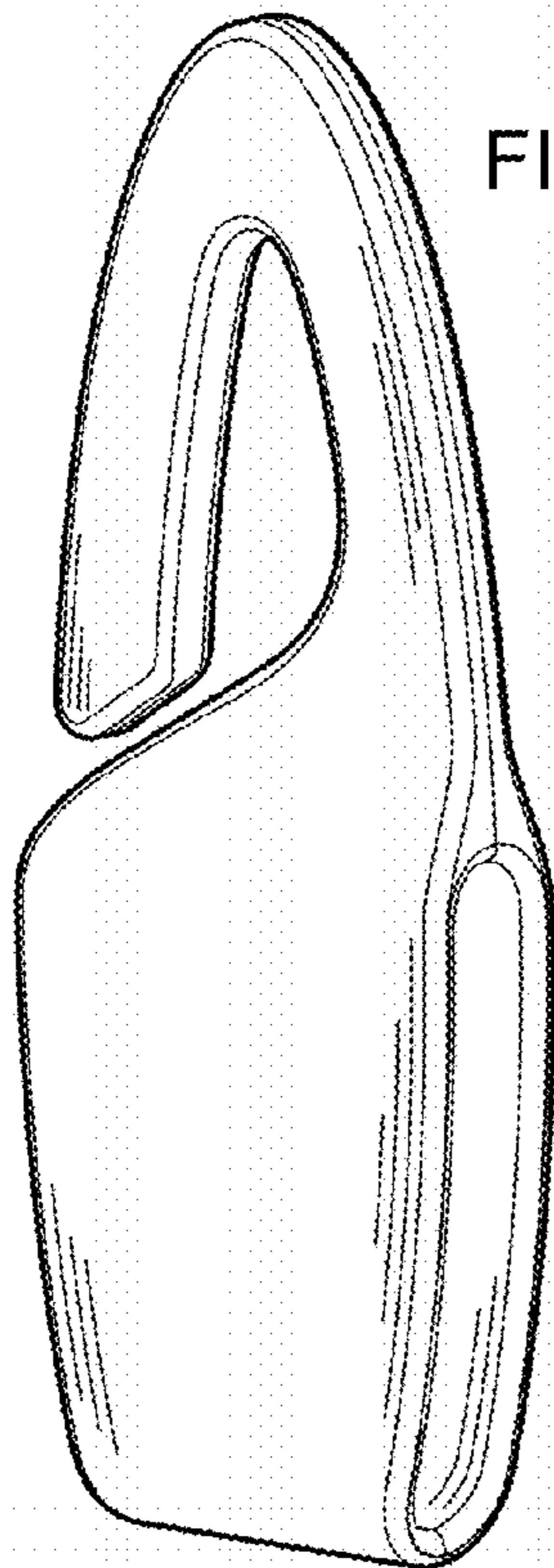

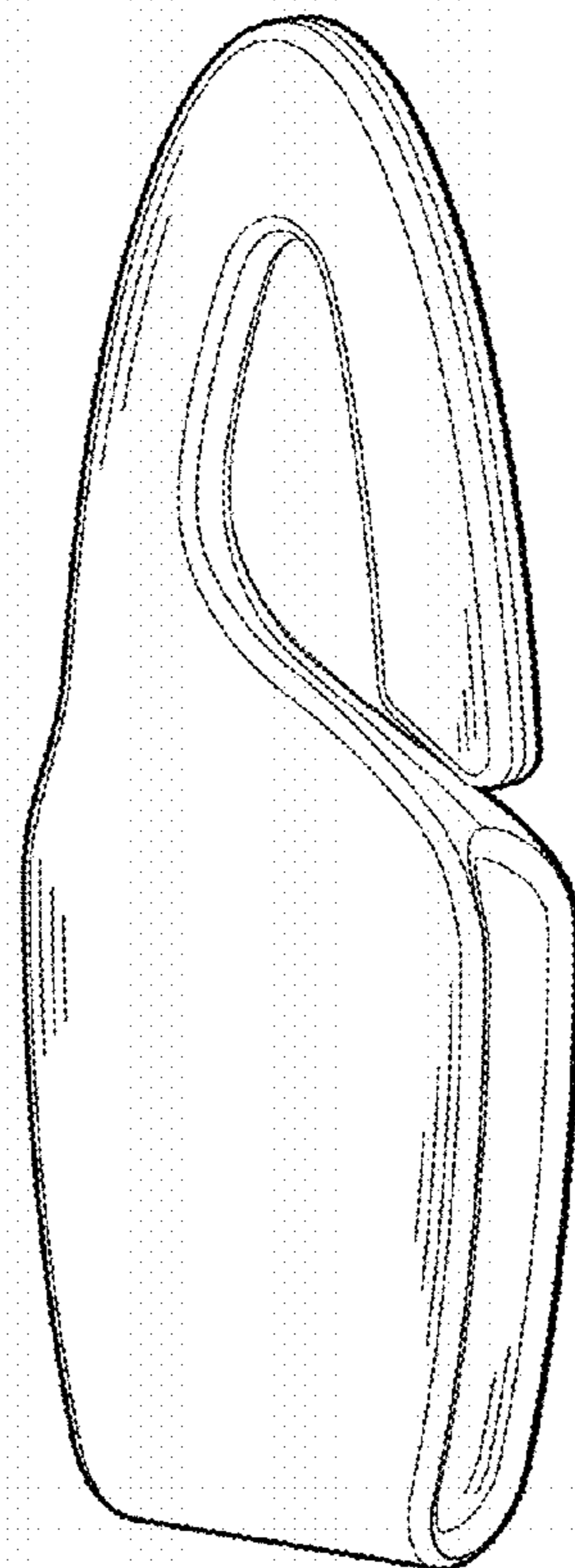

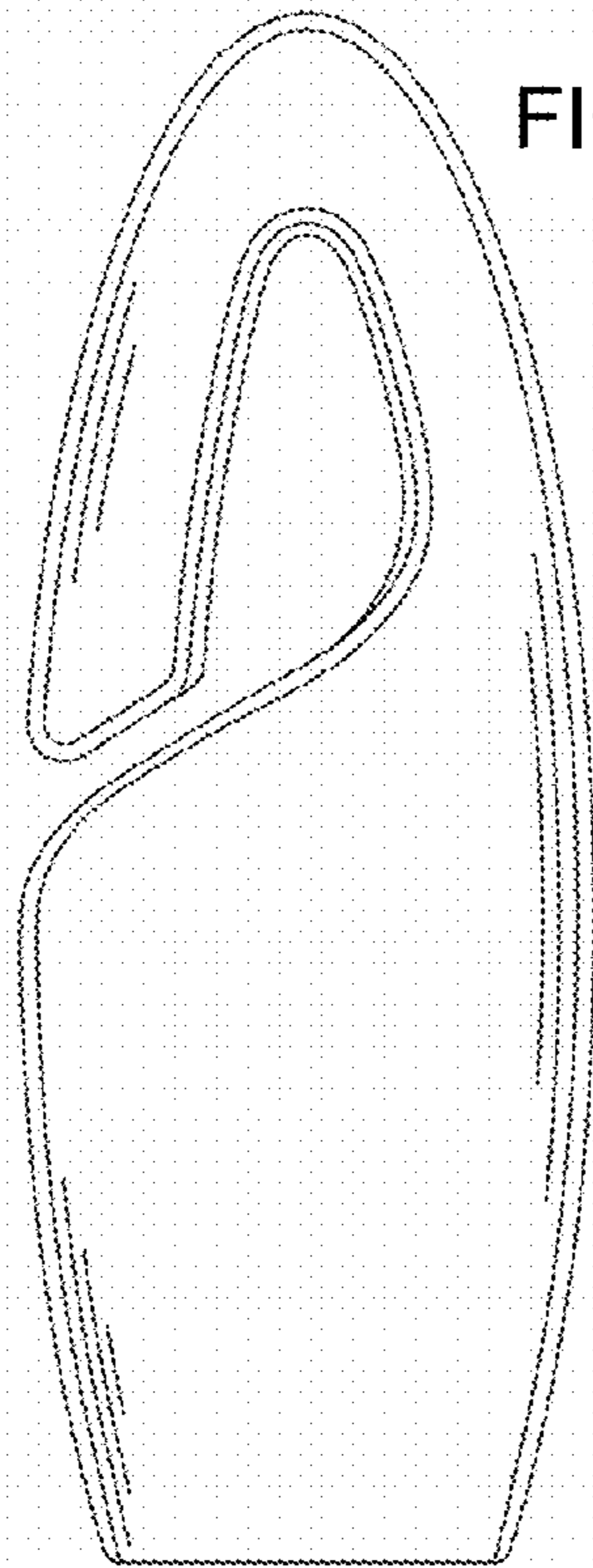

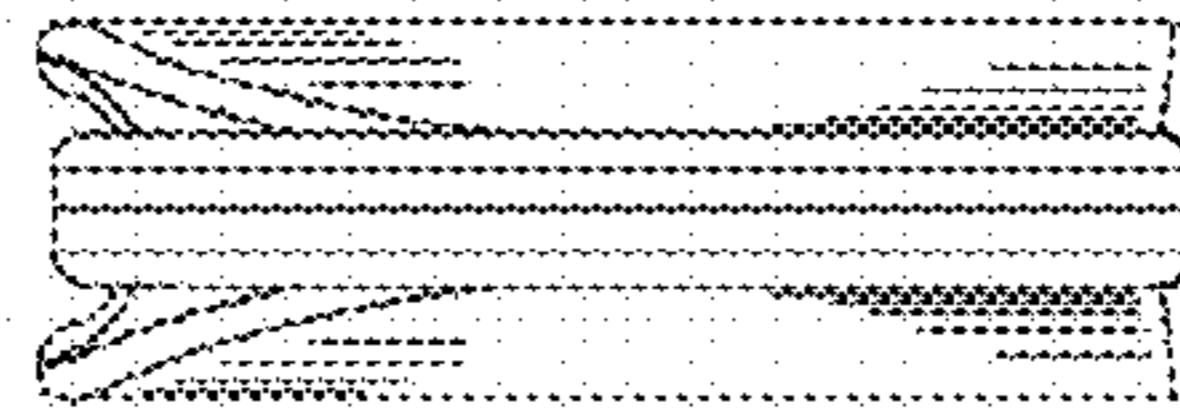

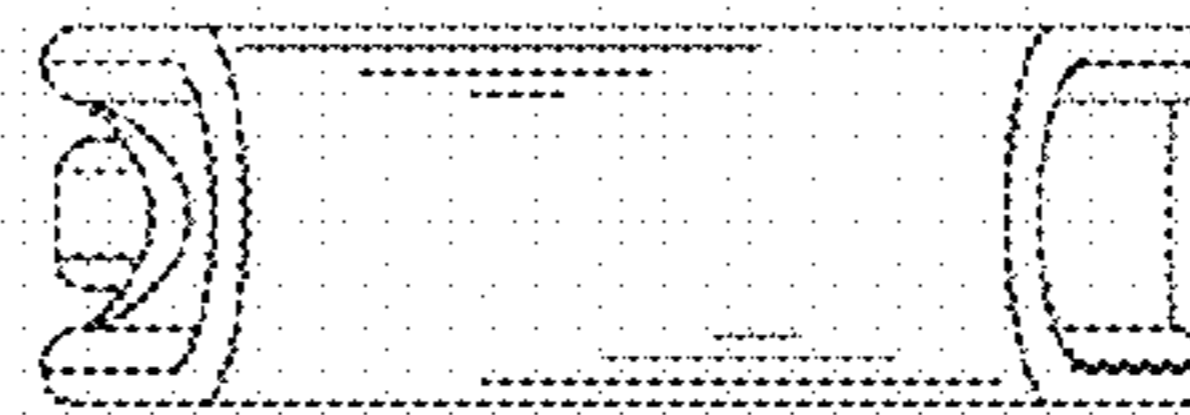

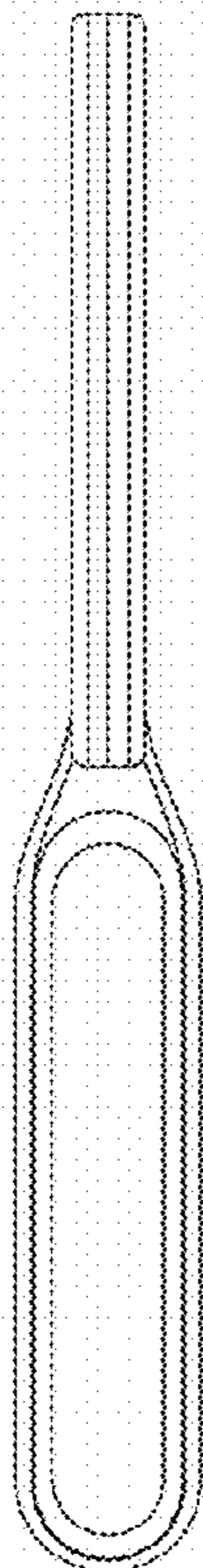

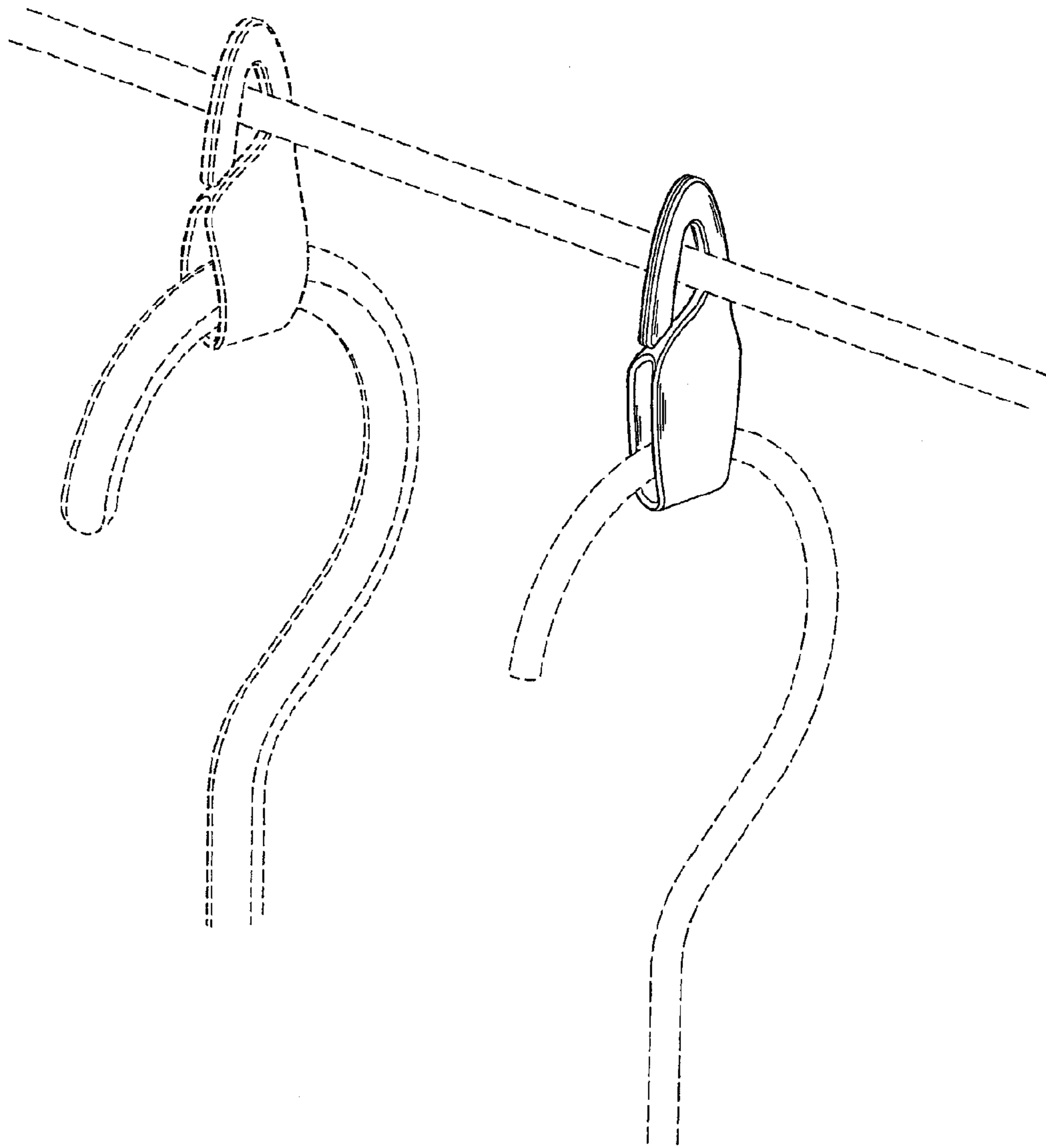
