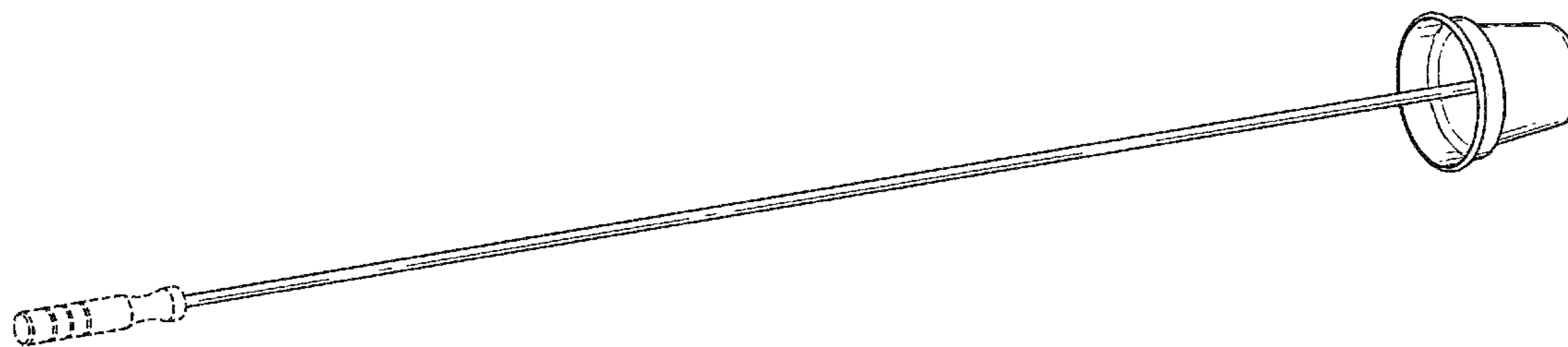

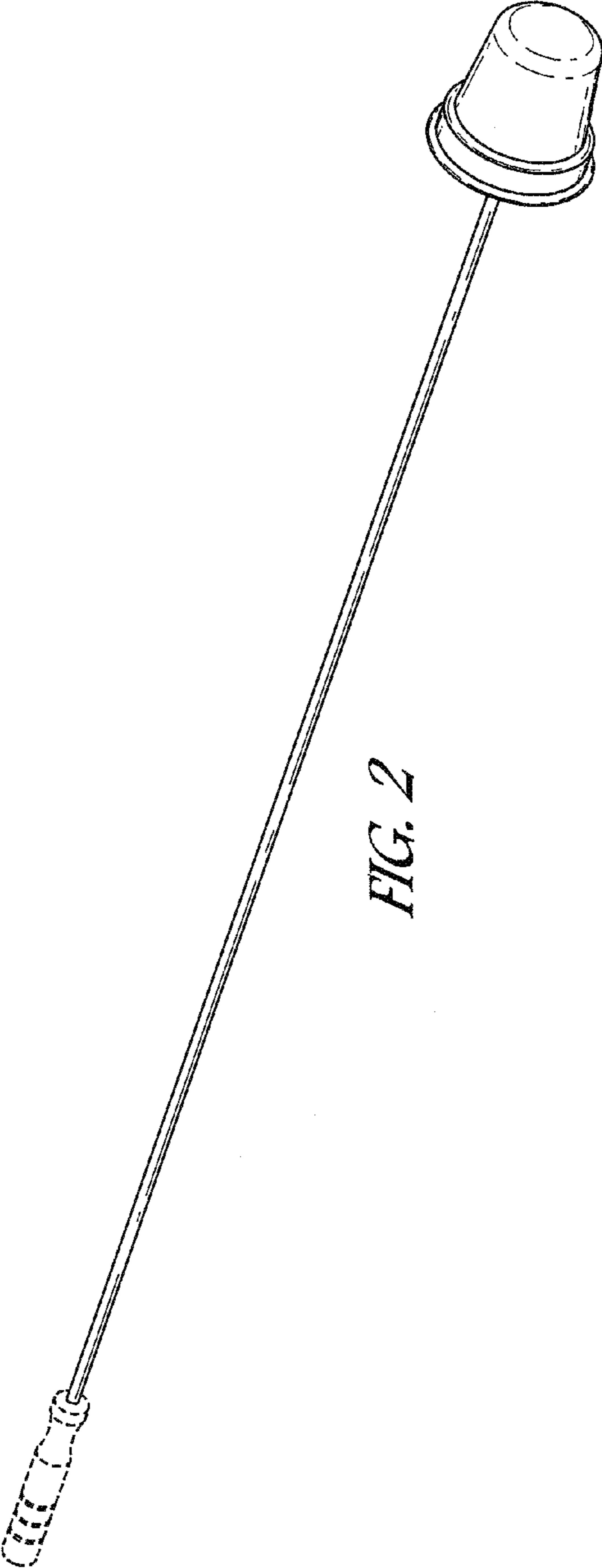
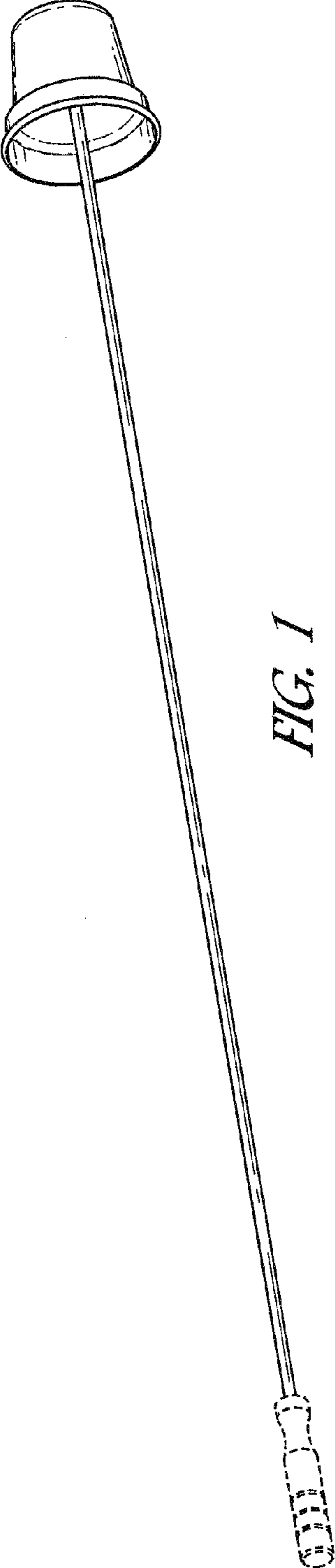
The ornamental design for a roasting stick, as shown and described.

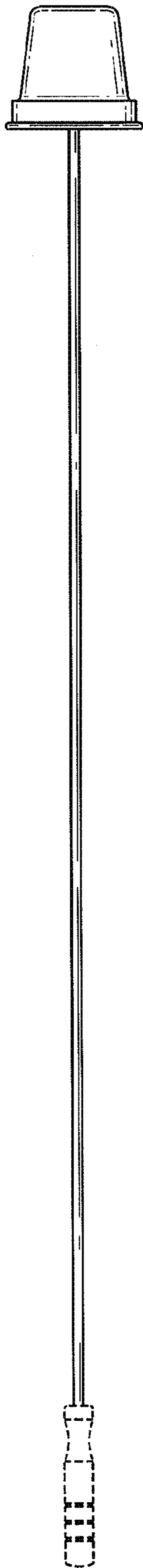
**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a roasting stick in accordance with the present invention. FIG. 2 is another perspective view of the roasting stick of FIG. 1. FIG. 3 is a front view of the roasting stick of FIG. 1. The back view is a mirror image of the left side view. The top view, and the bottom view are the same as the front view. FIG. 4 is a left end view of the roasting stick of FIG. 1; and, FIG. 5 is a right end view of the roasting stick of FIG. 1. Broken lines are used to illustrate features of the roasting stick which form no part of the claimed design.

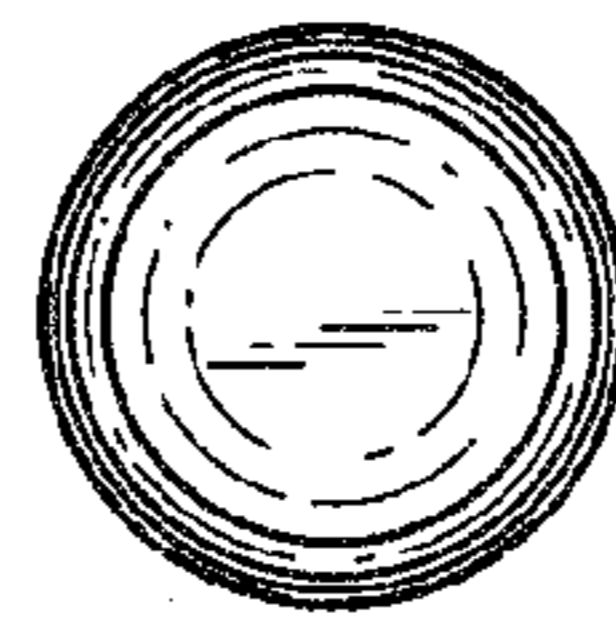

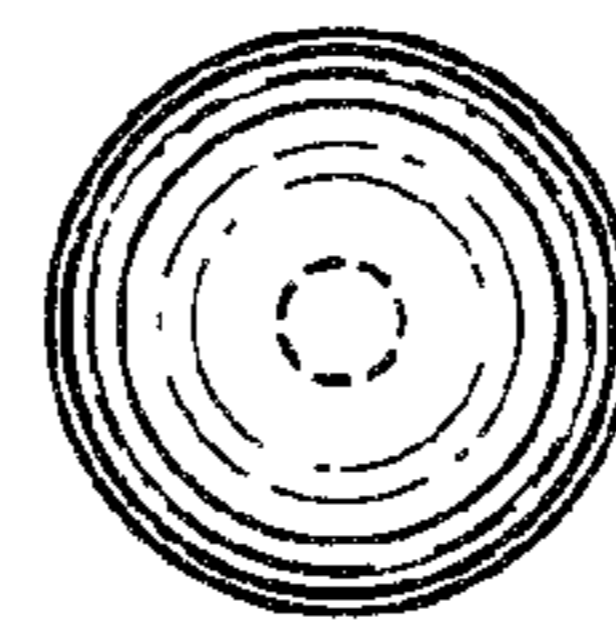
