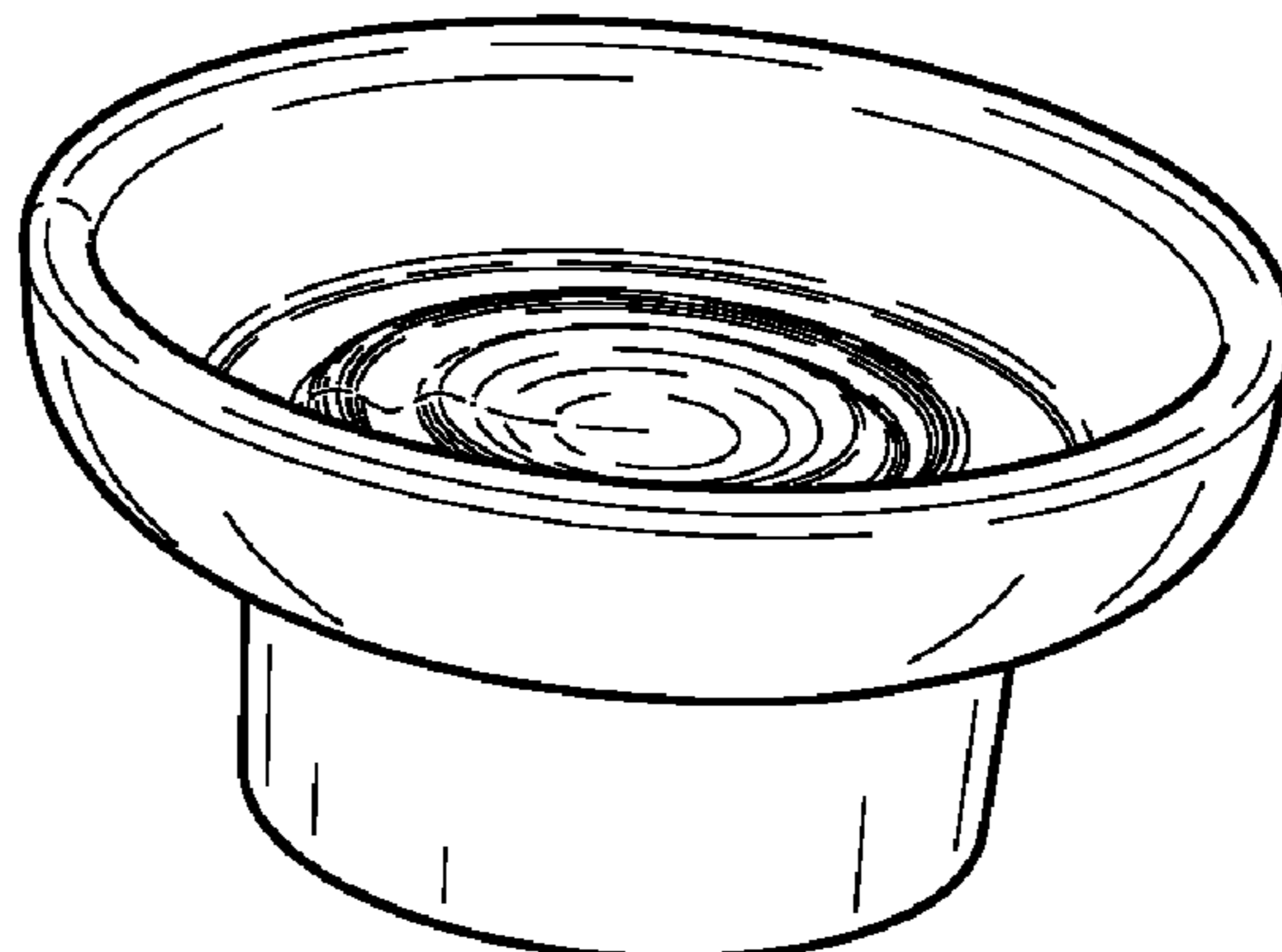

The ornamental design for a “bottle lid,” as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle lid, showing our new design;
FIG. 2 is a front view of the bottle lid;
FIG. 3 is a top view of the bottle lid;
FIG. 4 is a bottom view of the bottle lid;
FIG. 5 is a top view of the bottle lid with a cutting plane;
FIG. 6 is a cross-sectional view of the bottle lid; and,
FIG. 7 is a view of the bottle lid in use.

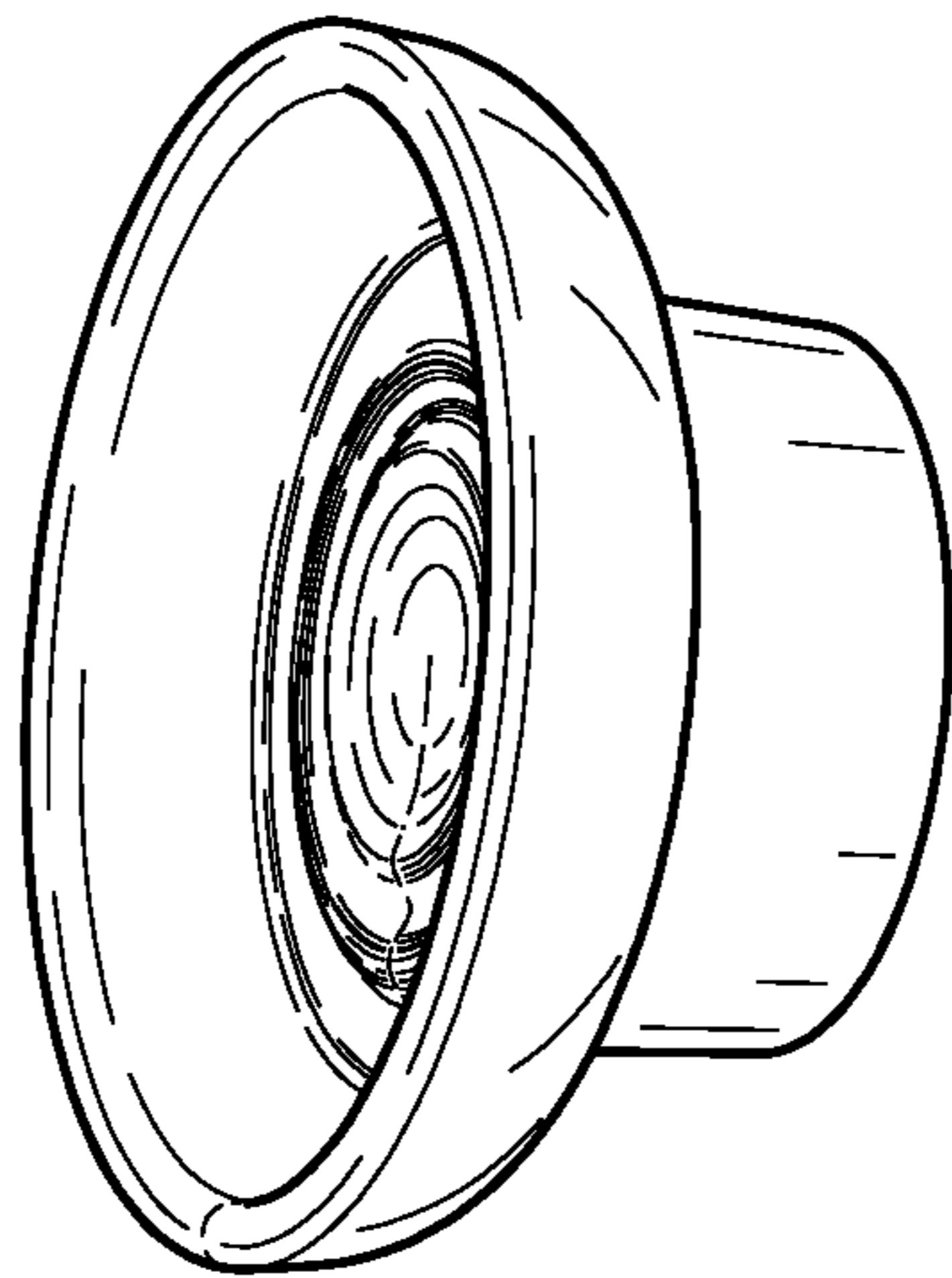

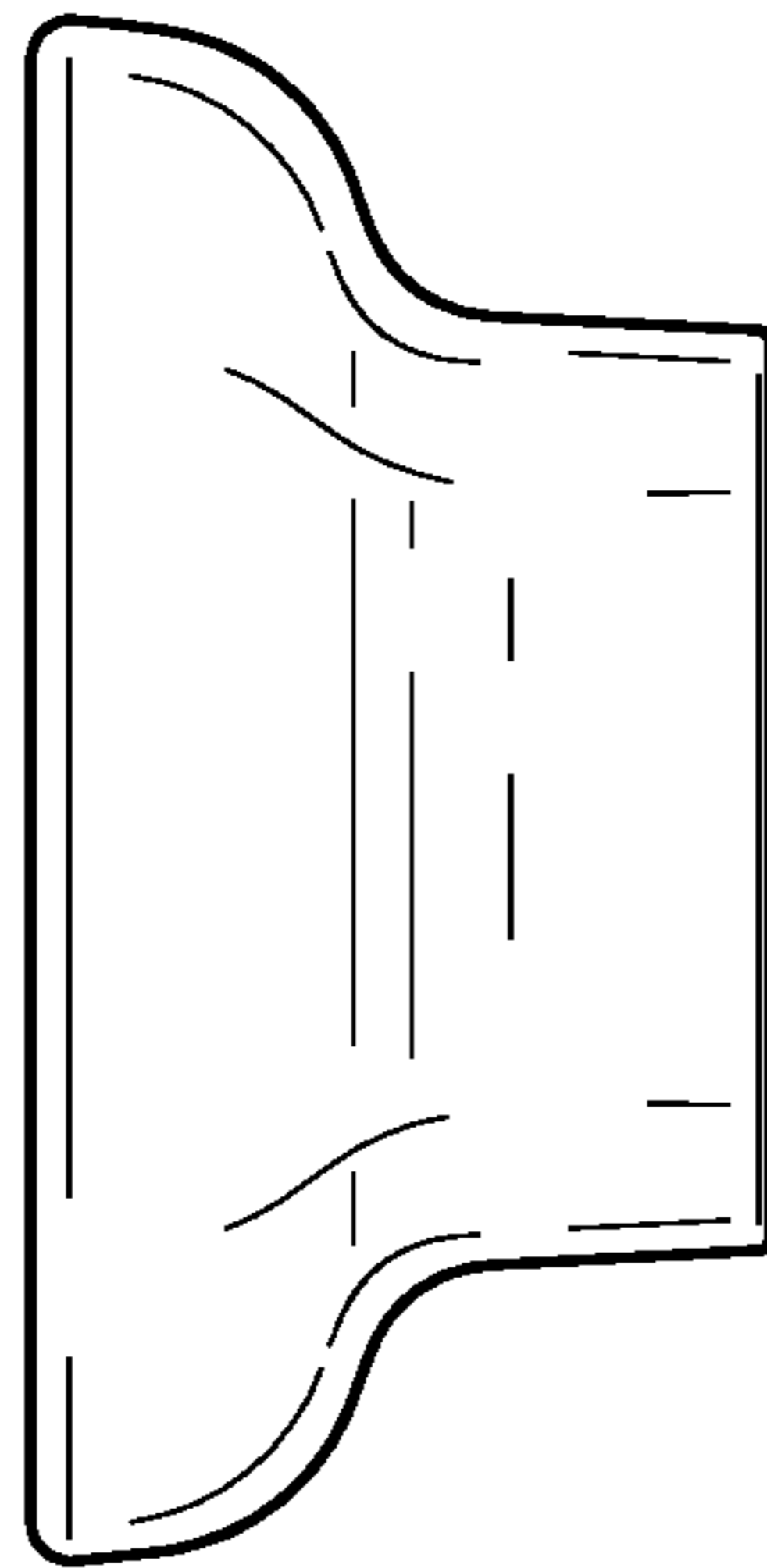

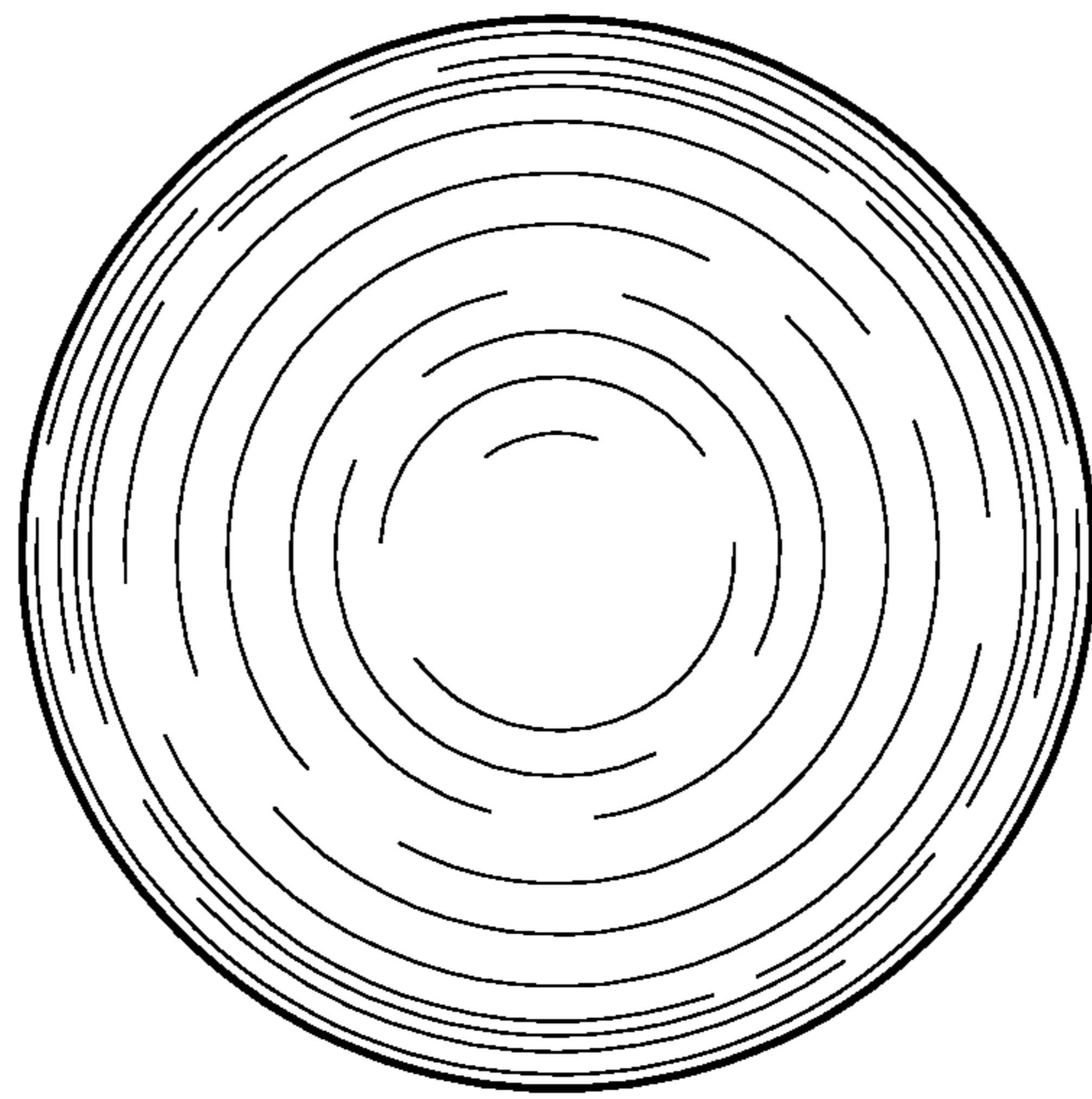

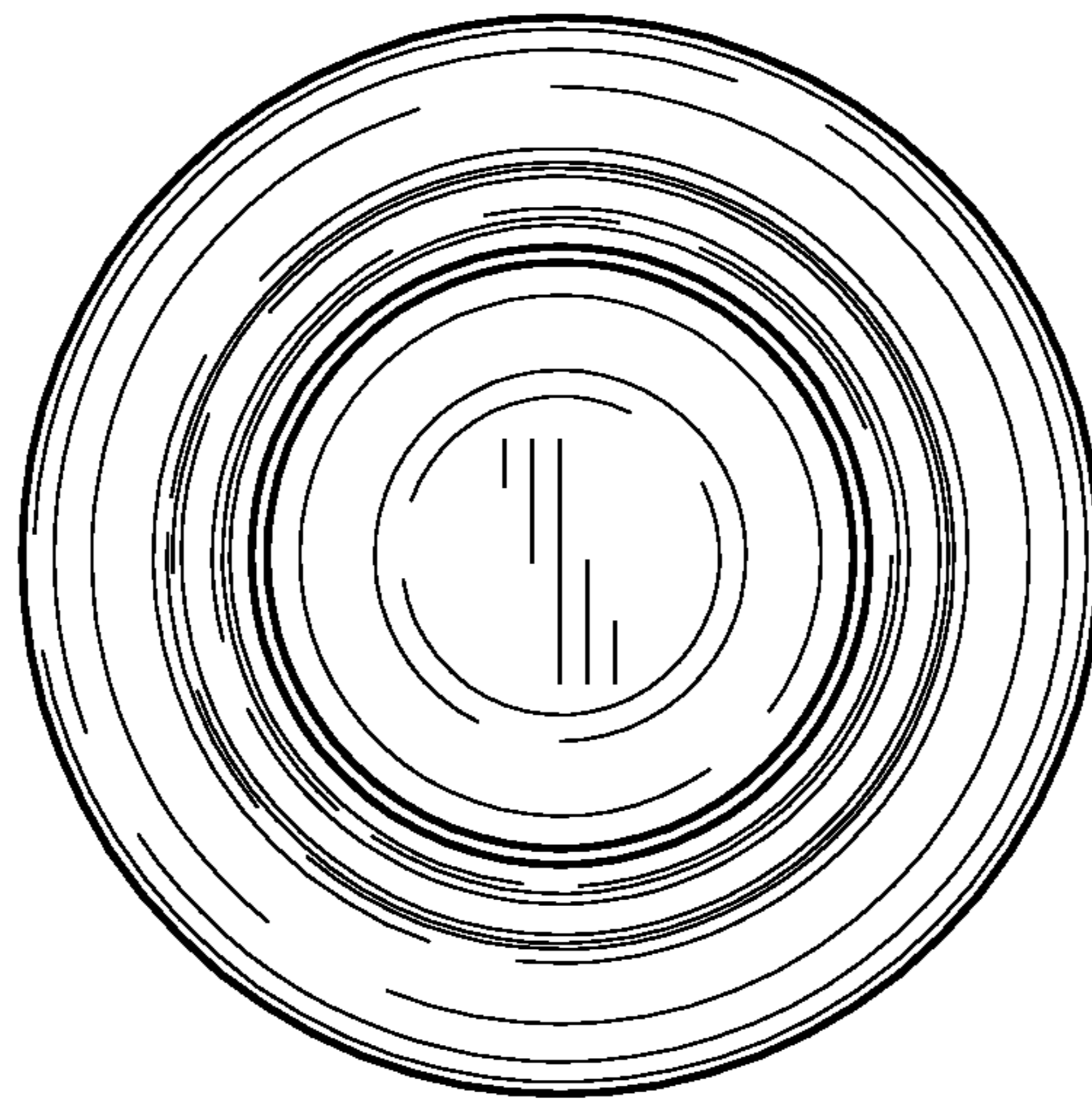

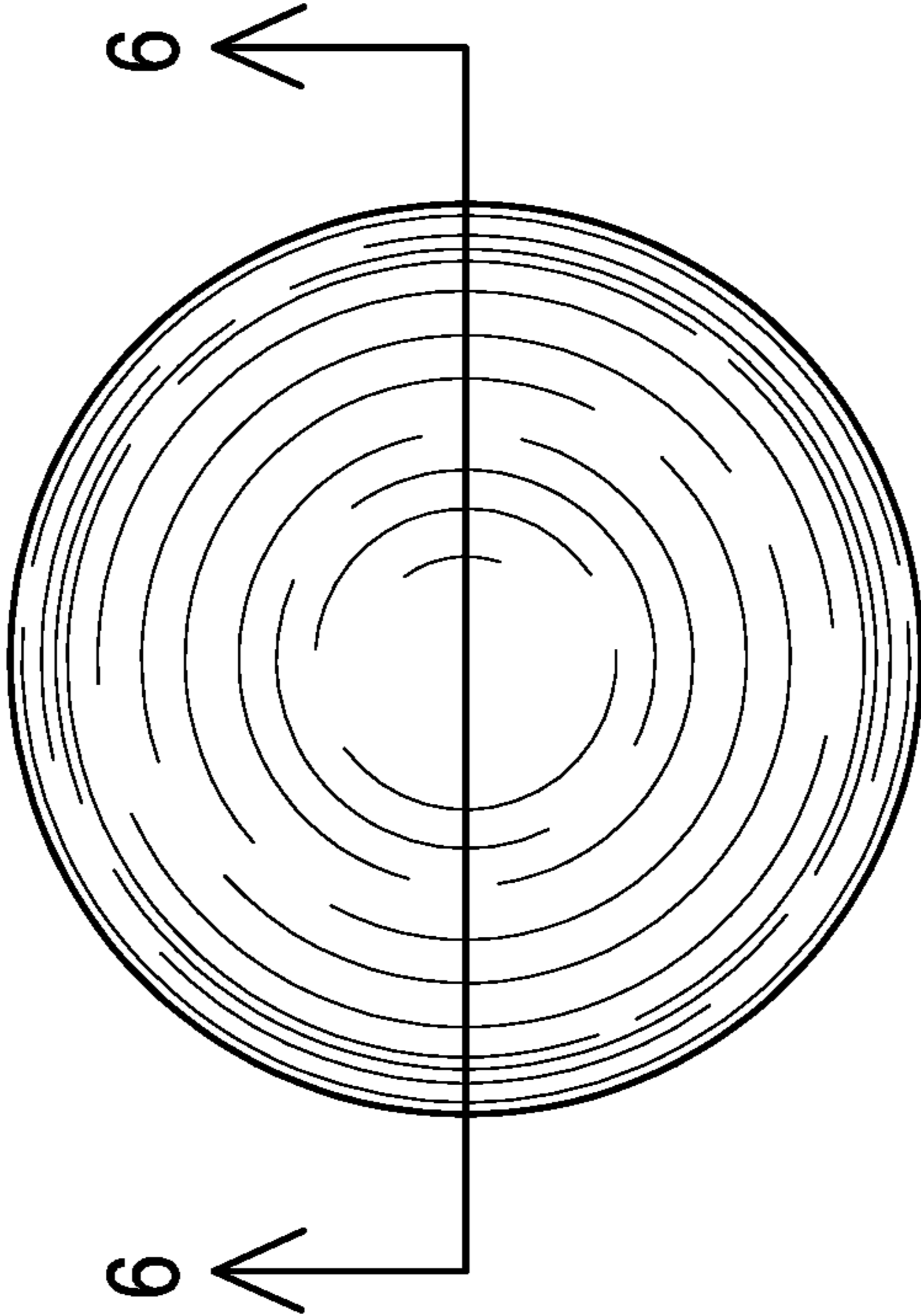

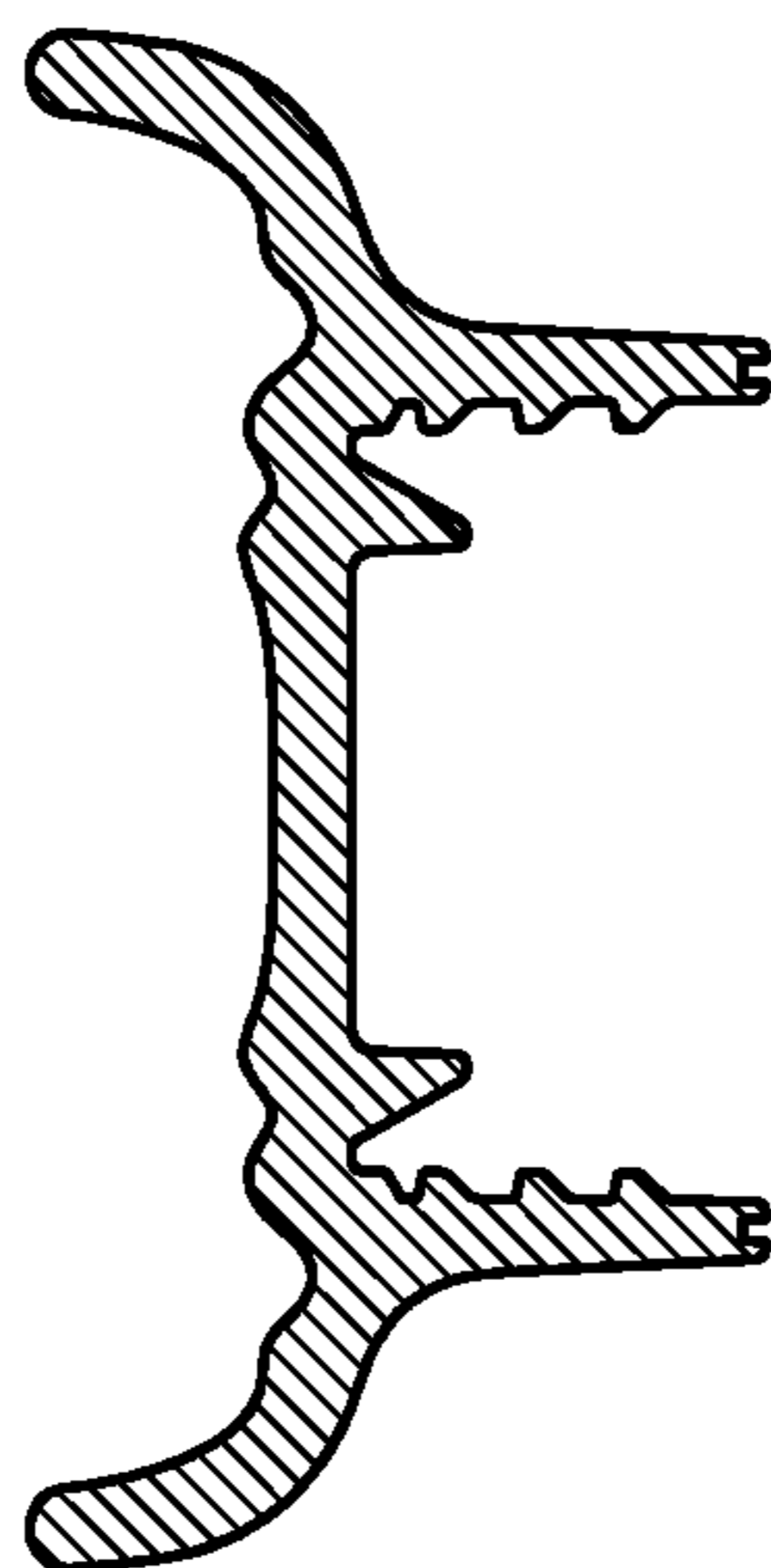

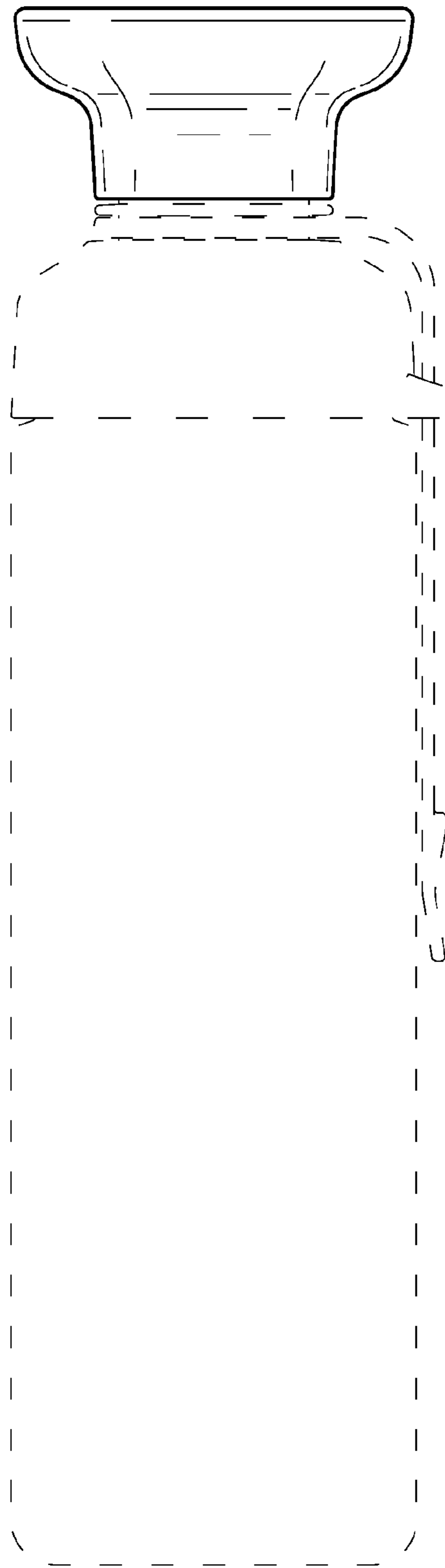
