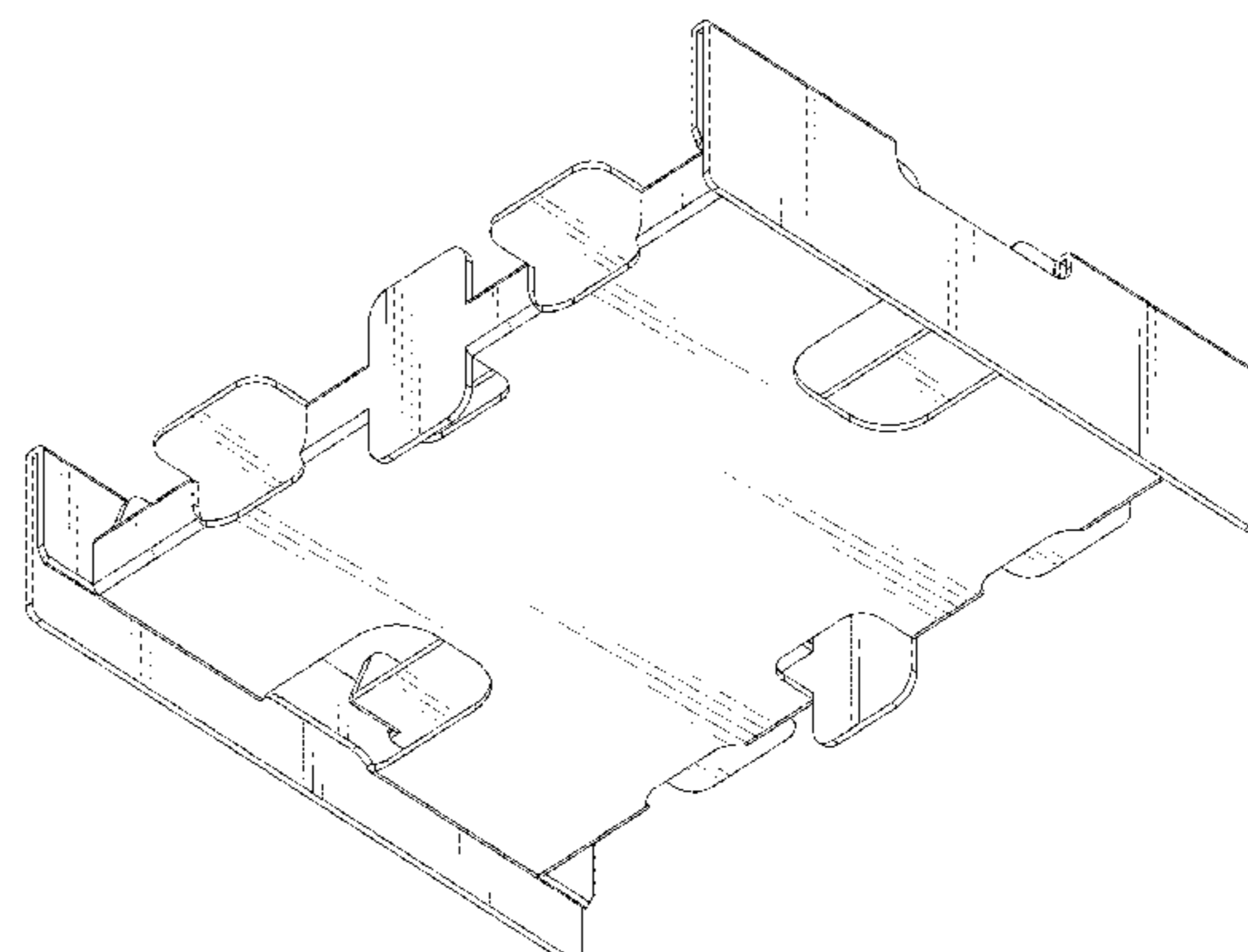
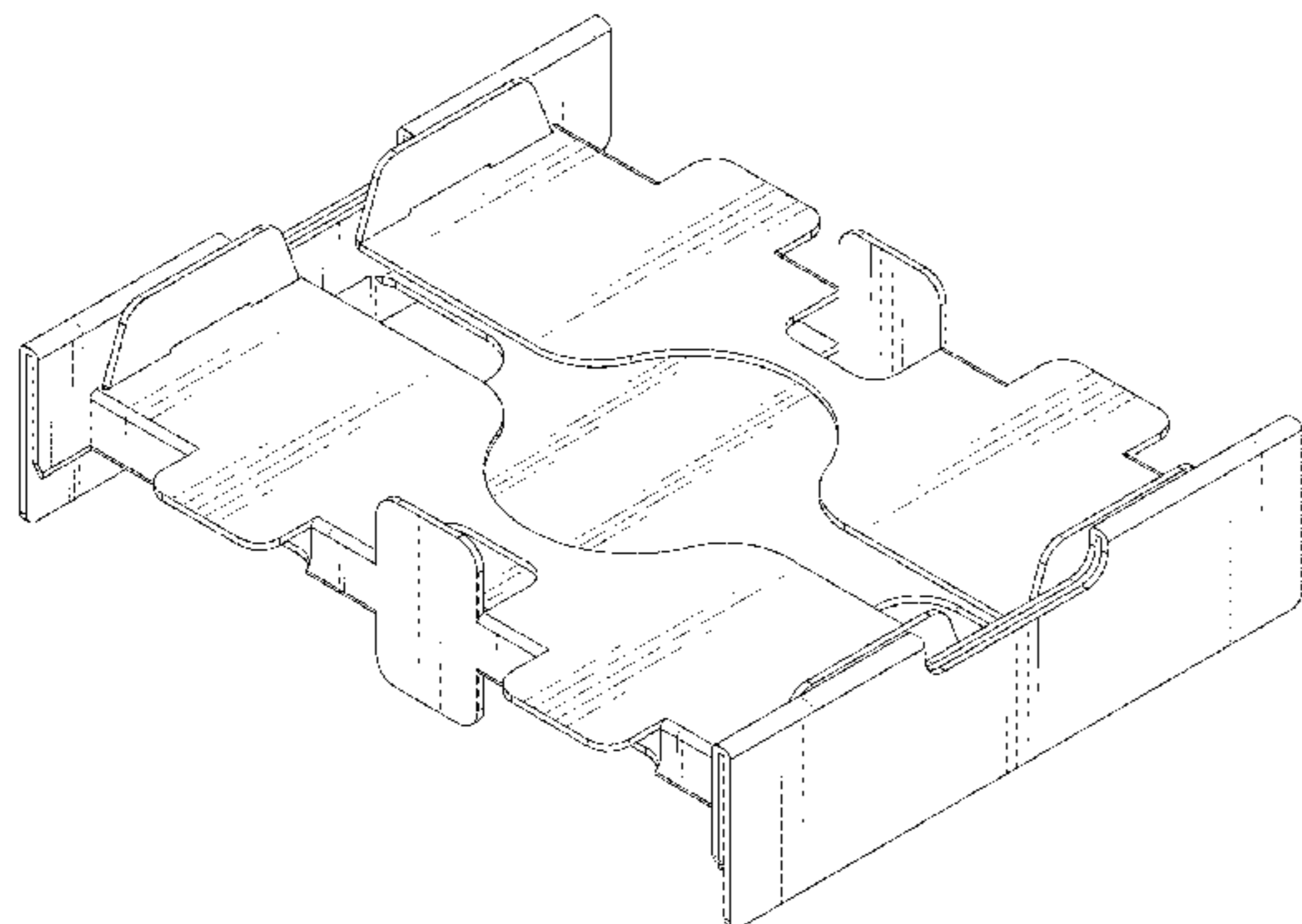
(57) **CLAIM**

FIG. 1 is a perspective view of an inner packing element of box showing our new design;

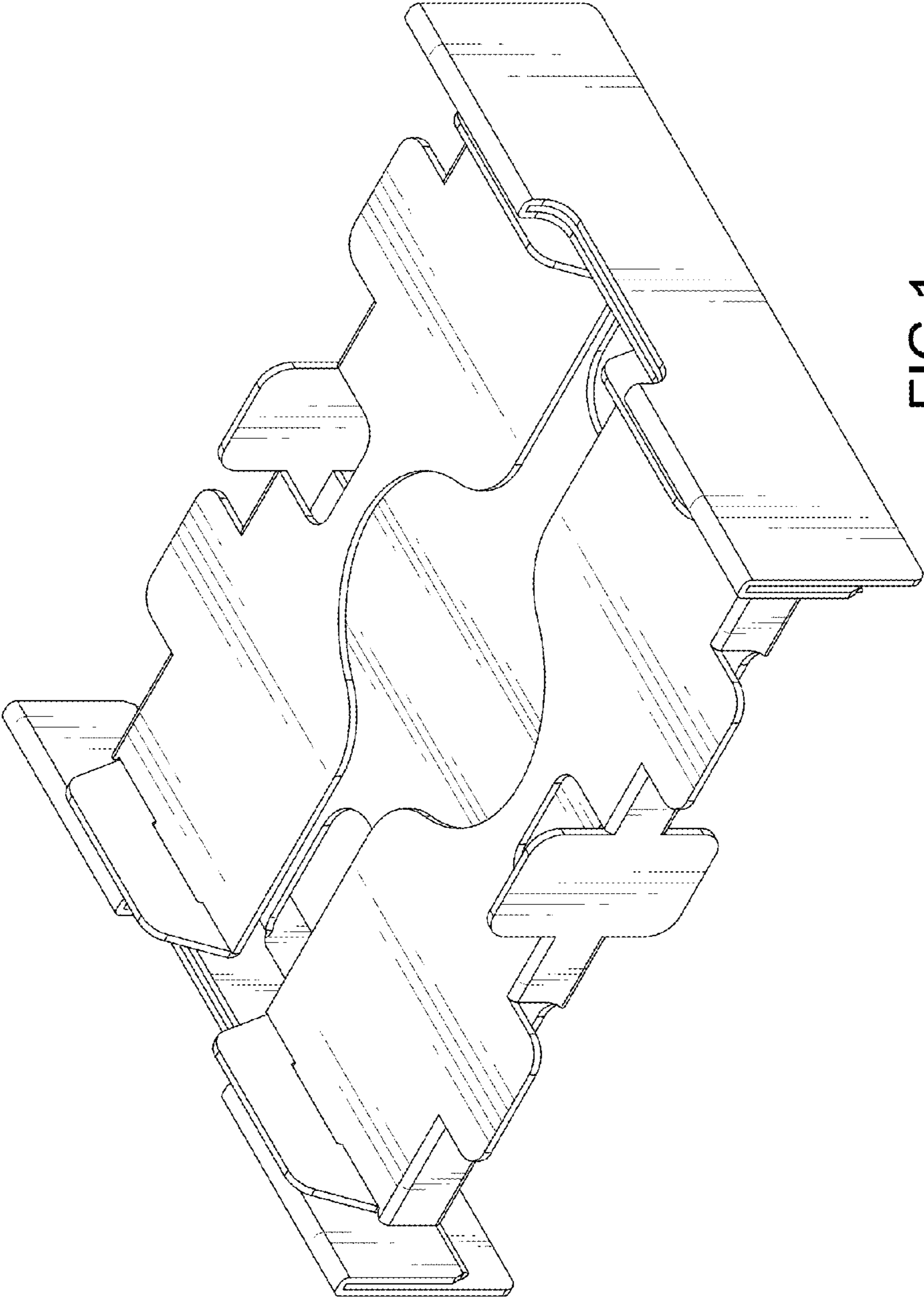

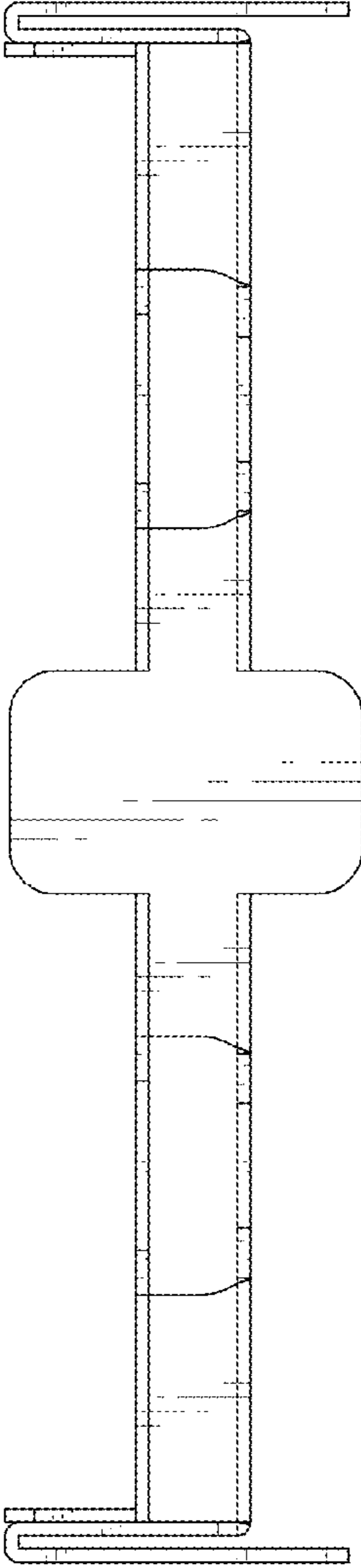

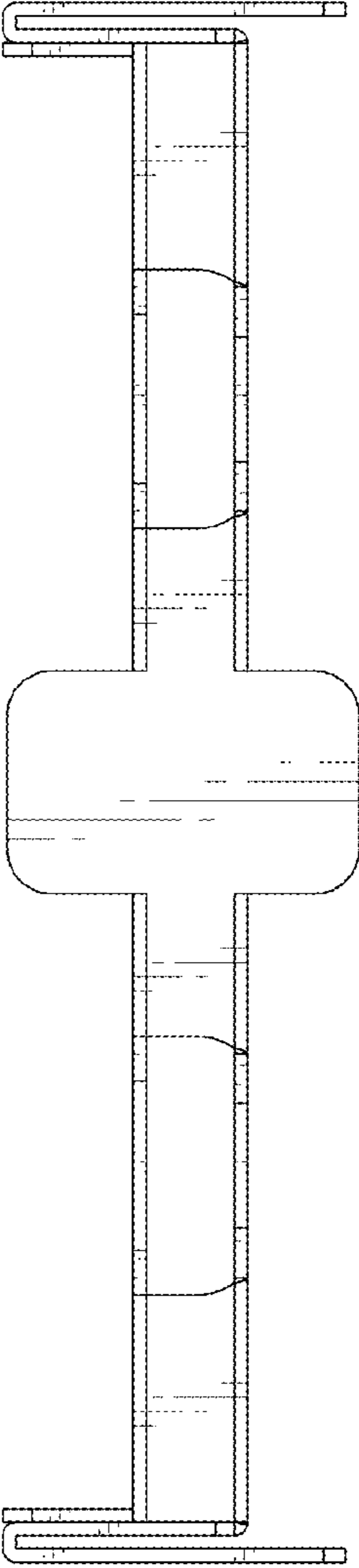

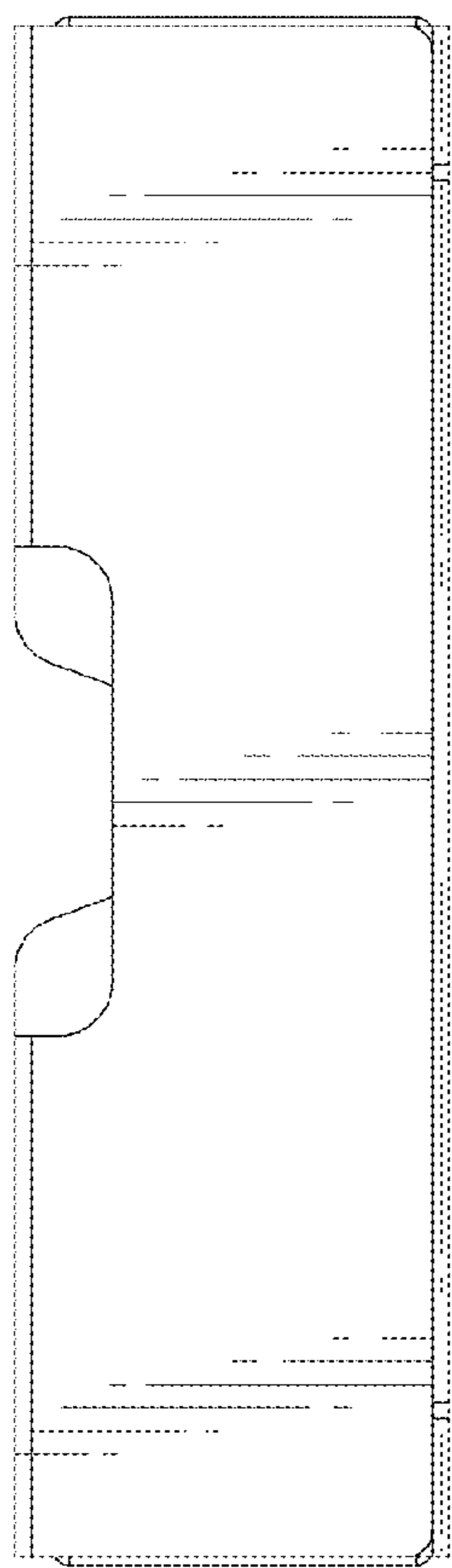

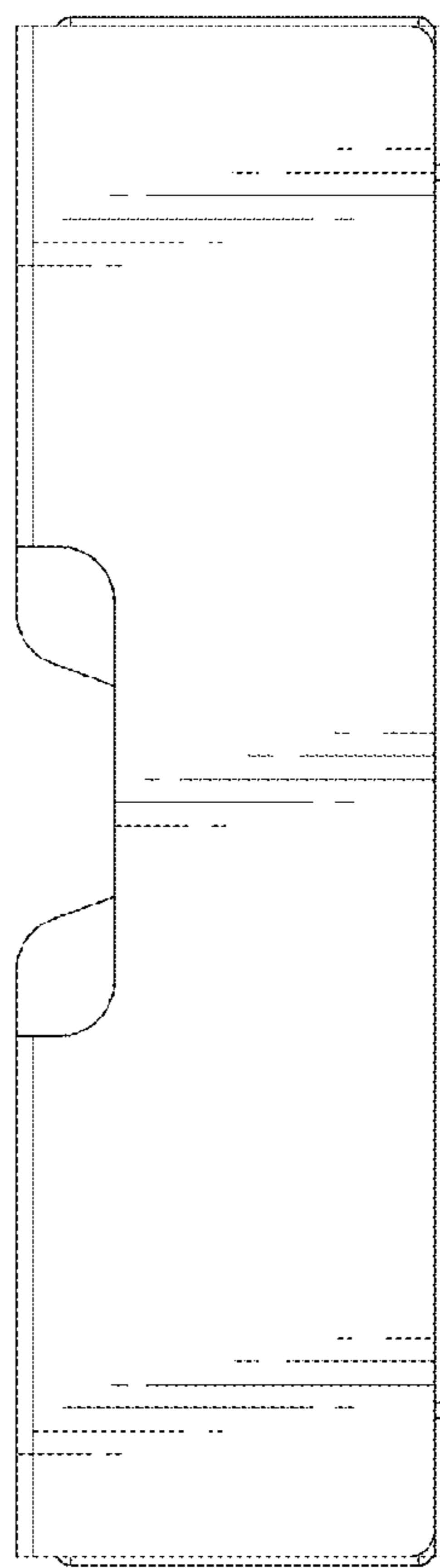

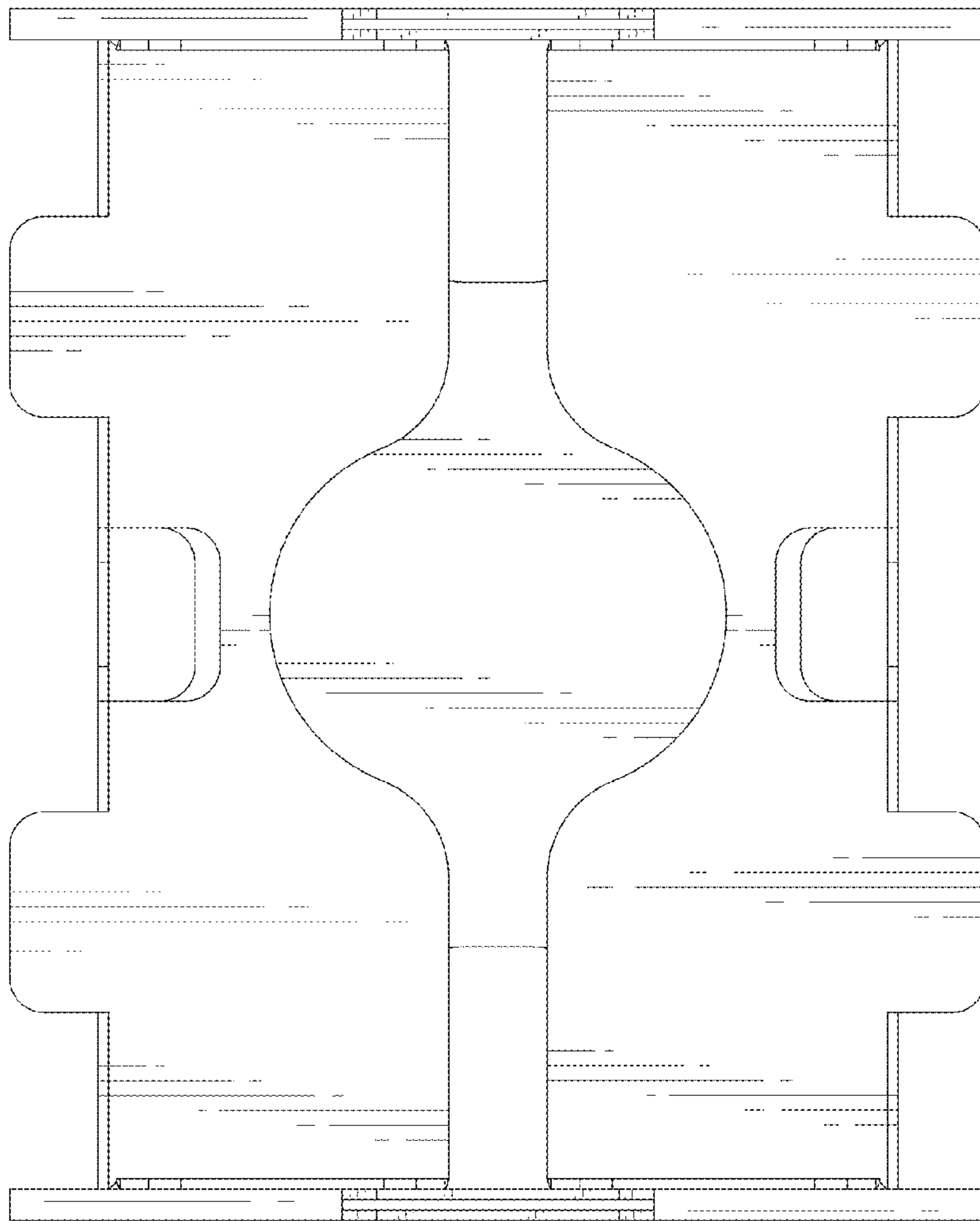

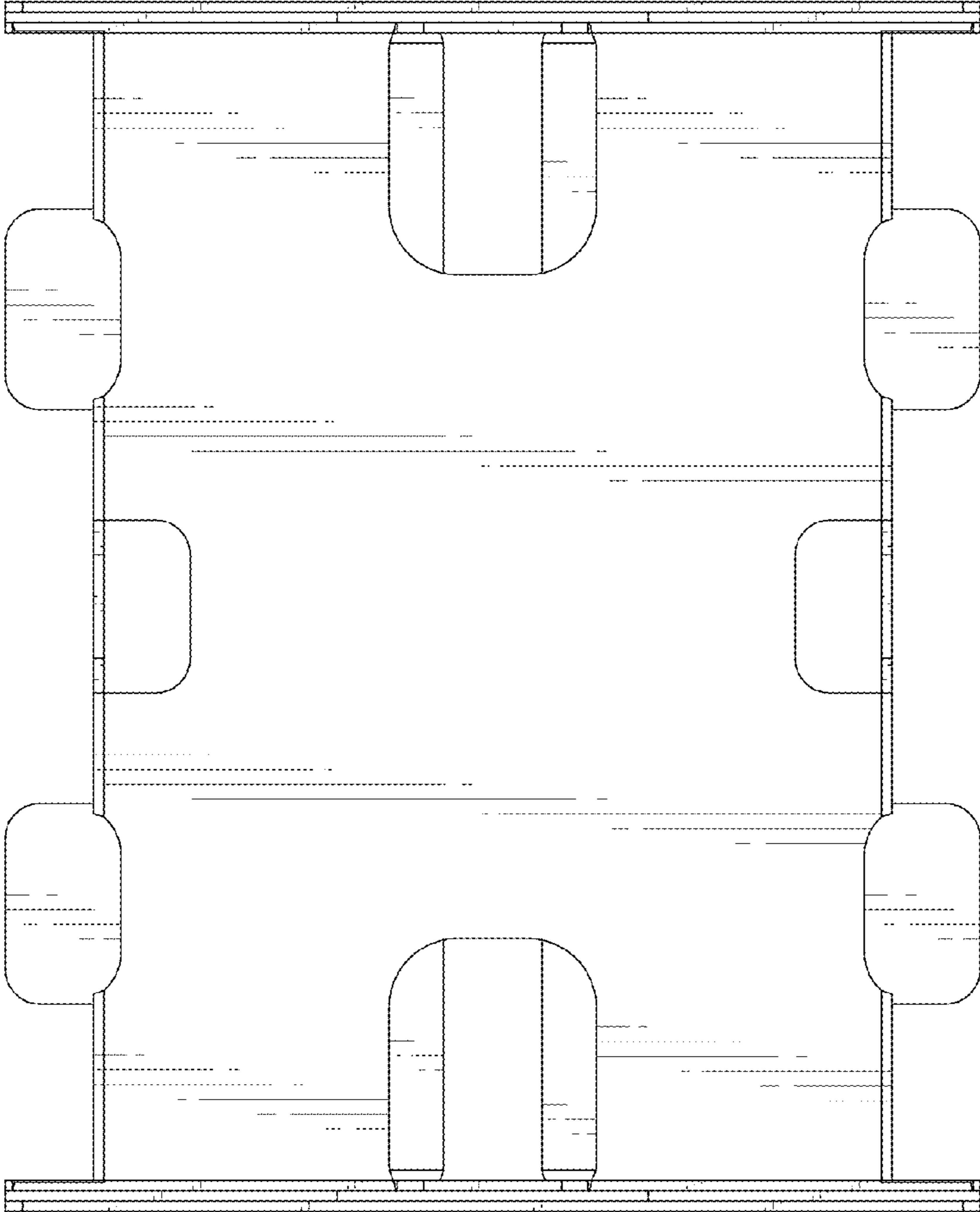

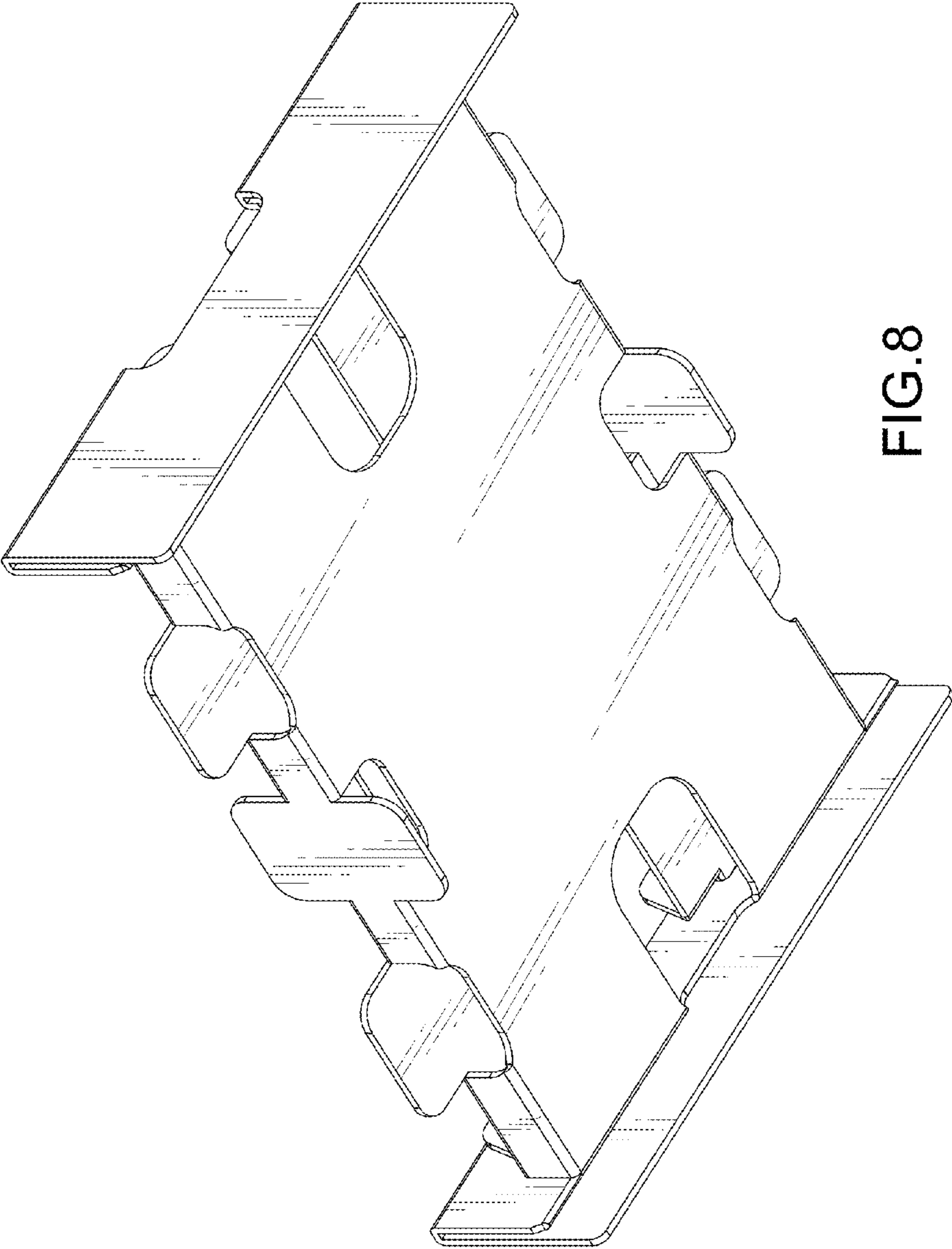

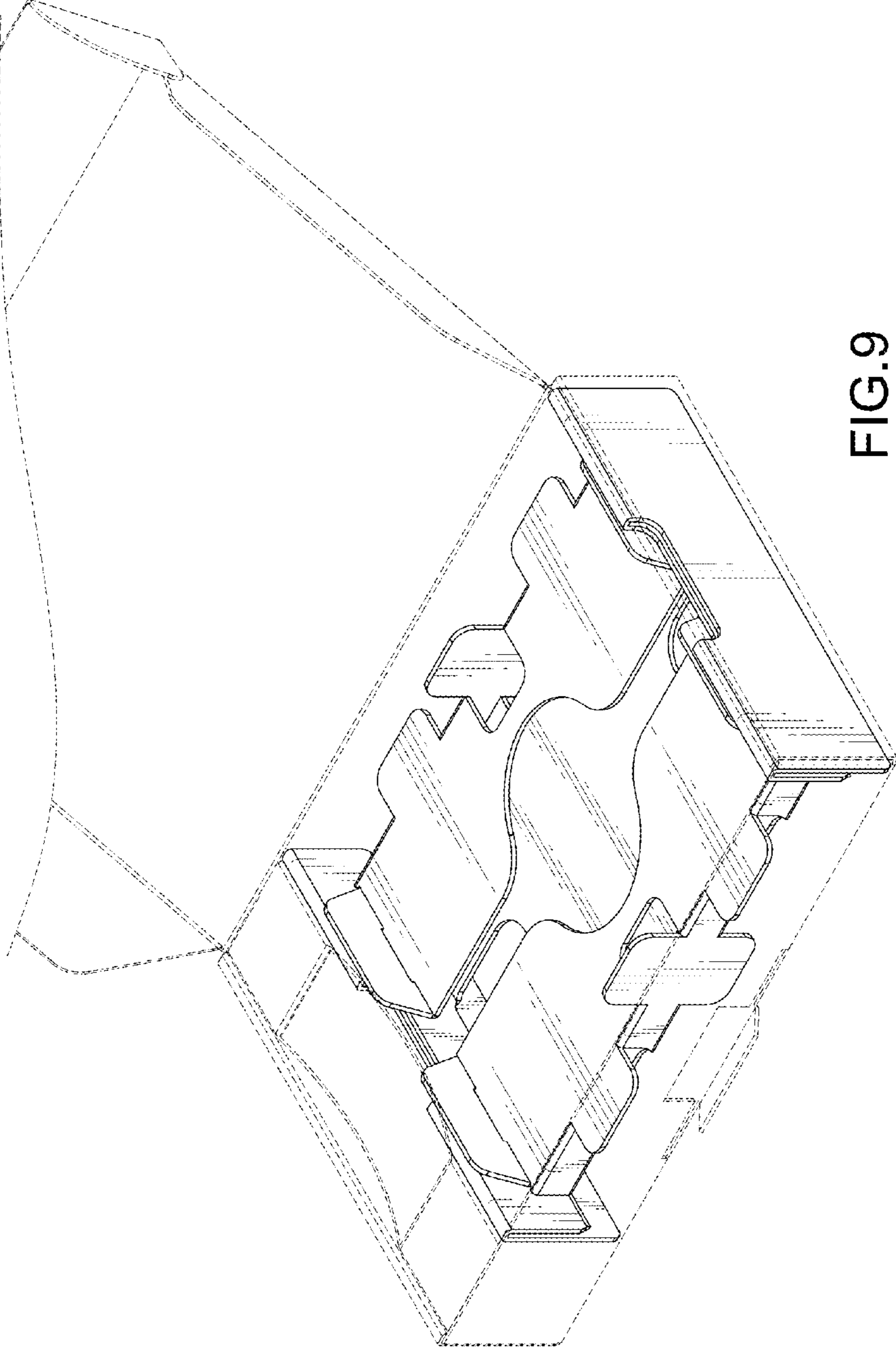
