The design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is front view of a bottle showing my design, the right side view being identical thereto;

FIG. 2 is a rear view thereof;

FIG. 3 is a left side view thereof;

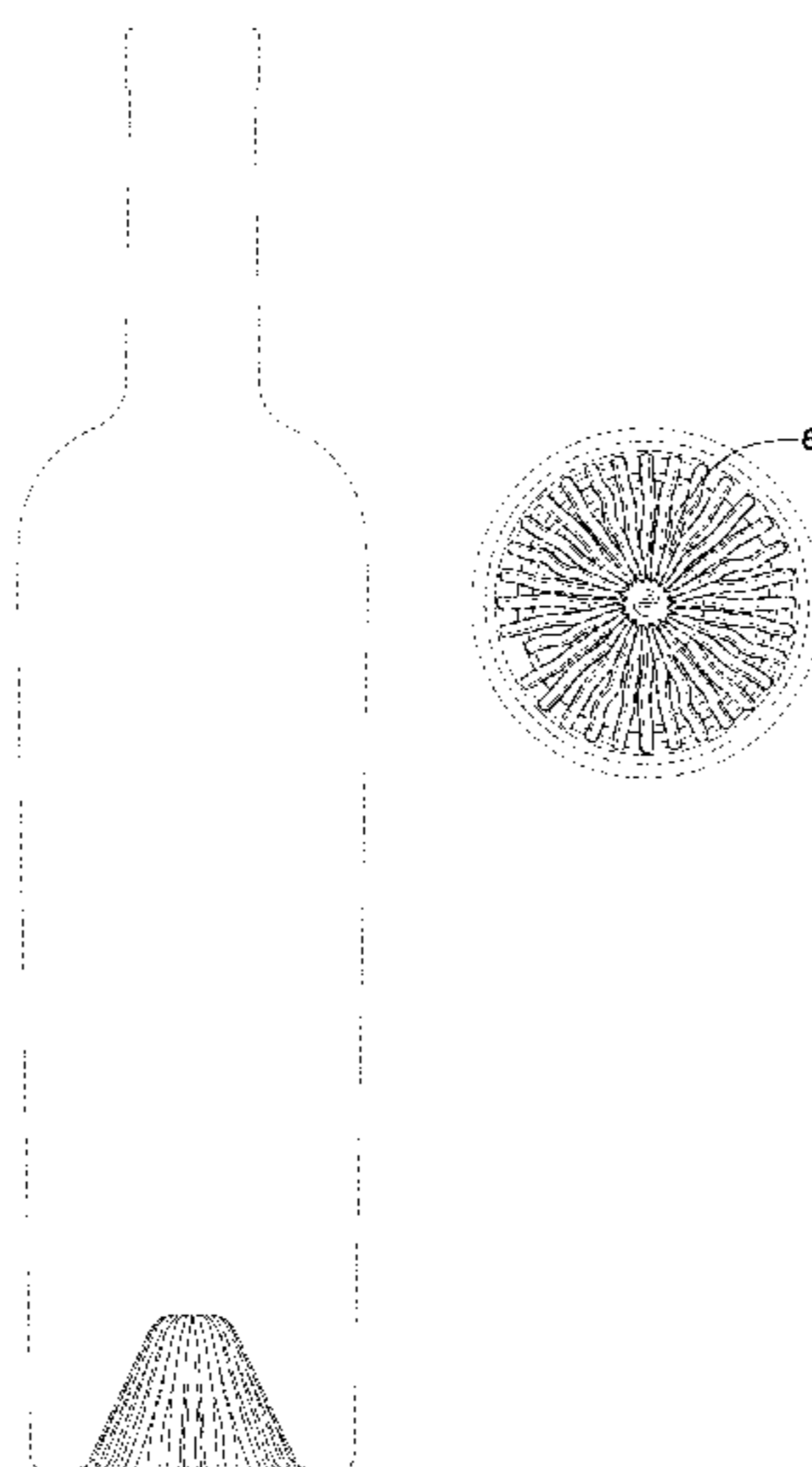
FIG. 4 is a bottom view thereof;

FIG. 5 is a bottom-front perspective view thereof; and,

FIG. 6 is an enlarged partial view of area 6 of FIG. 4.

The broken line showing of a portion of a bottle is for environmental purposes only and forms no part of the claimed design. The dot-dash line in FIGS. 4 and 5 defines the bounds of the claimed design and forms no part thereof. The top view is omitted and forms no part of the claimed design.

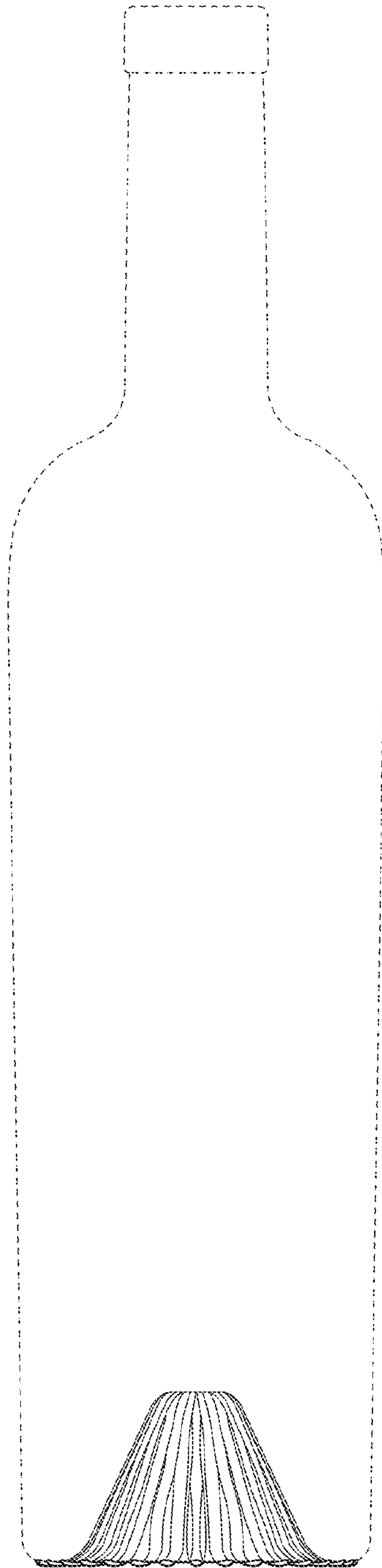

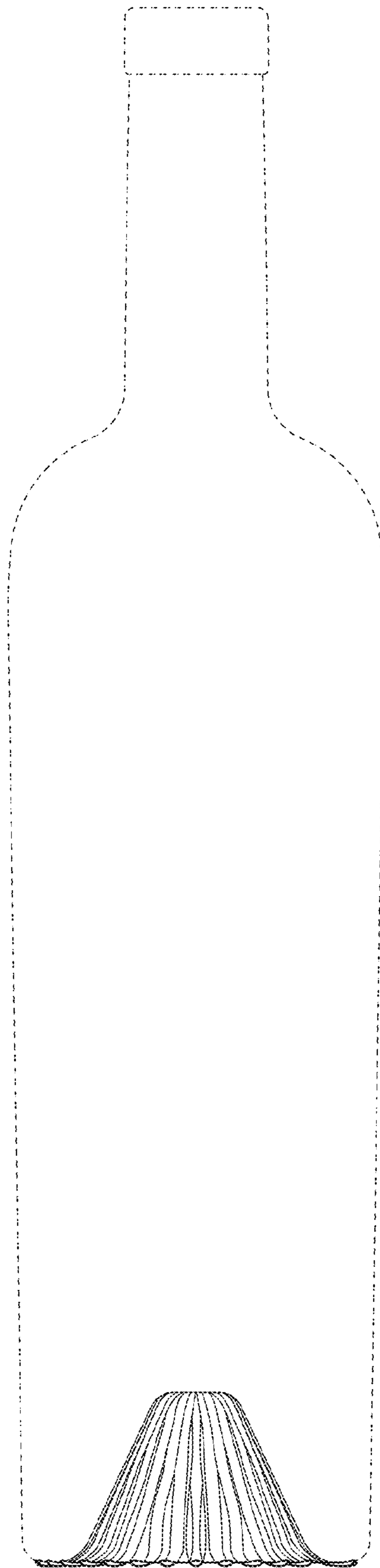

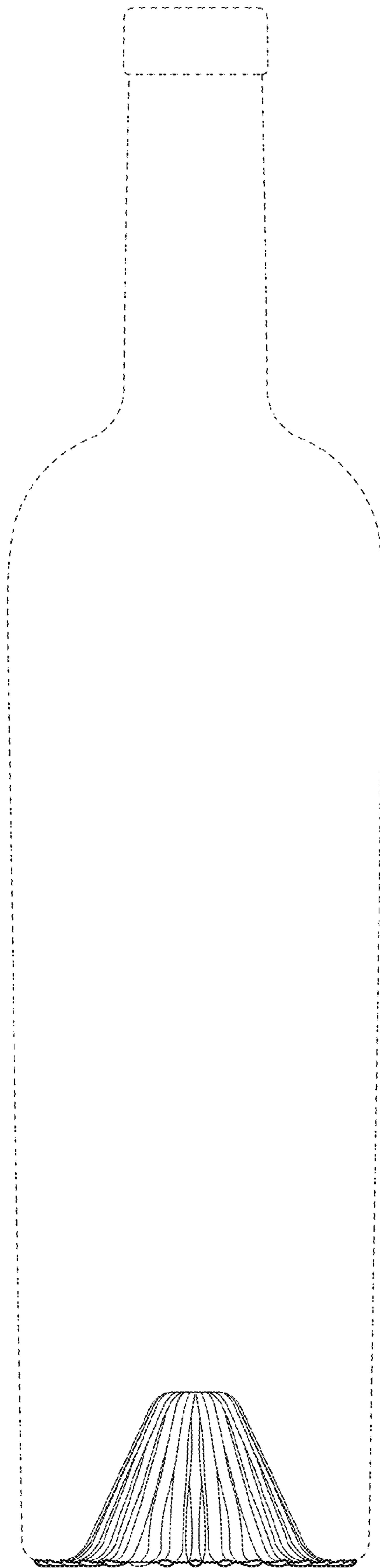

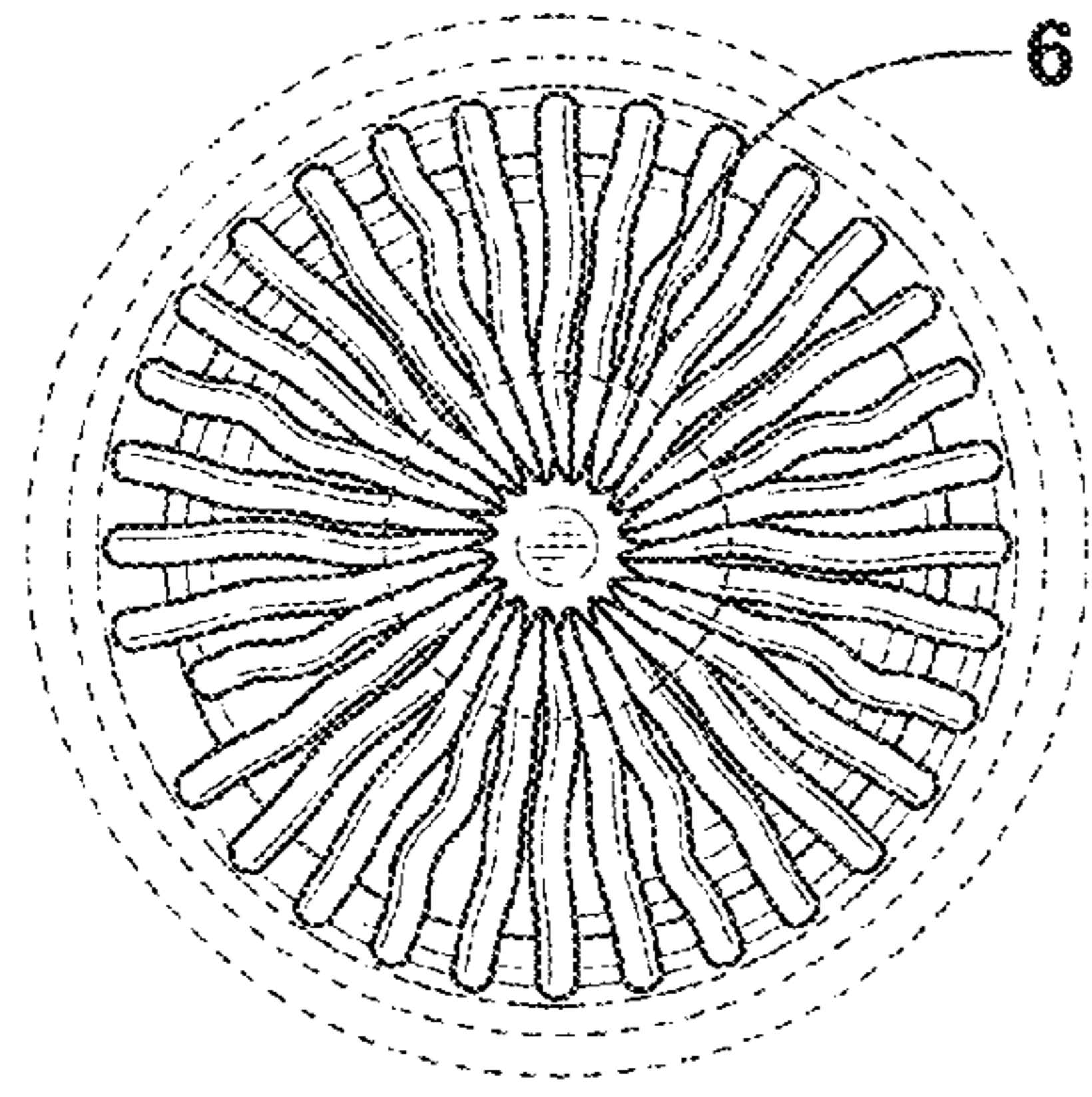

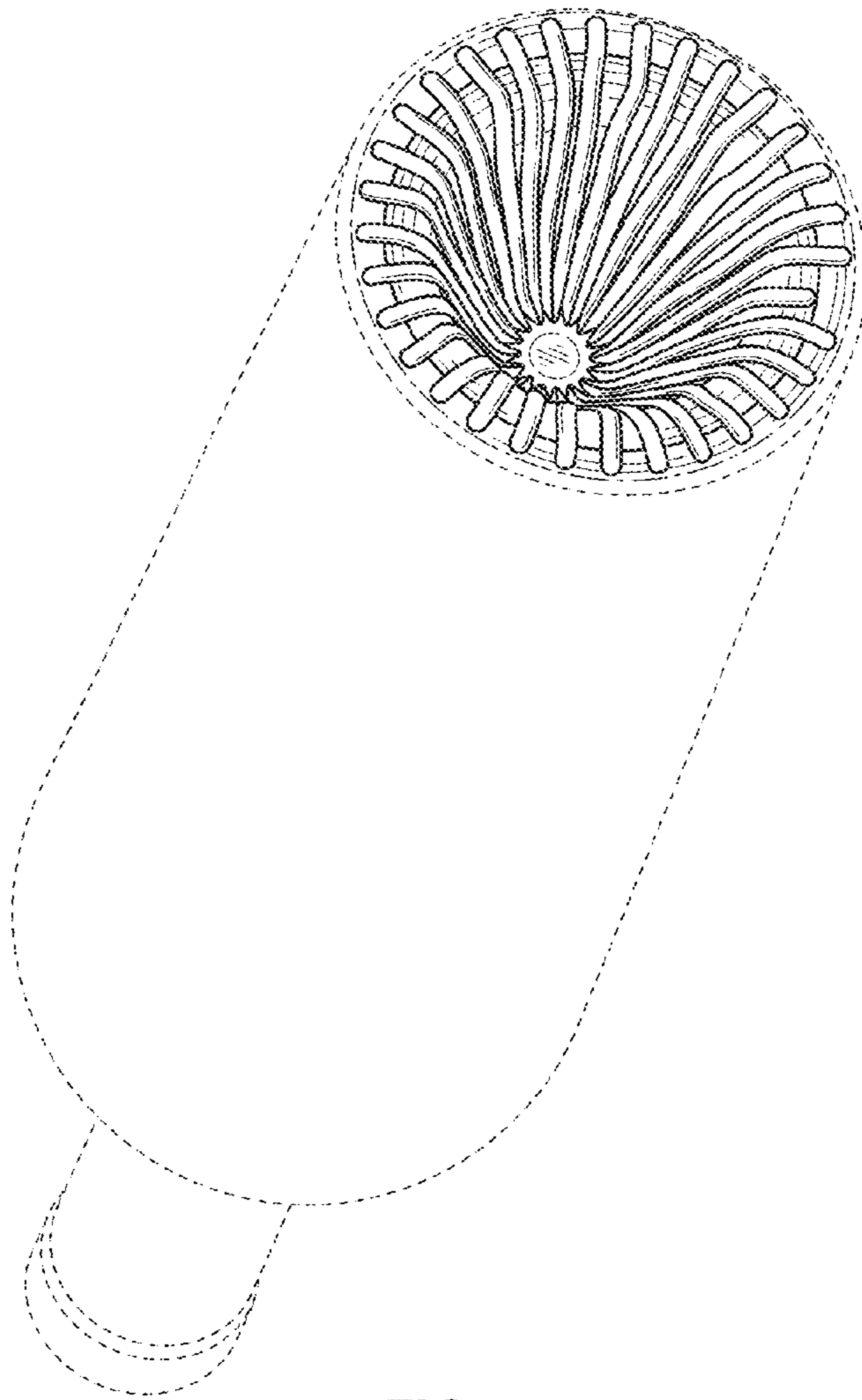

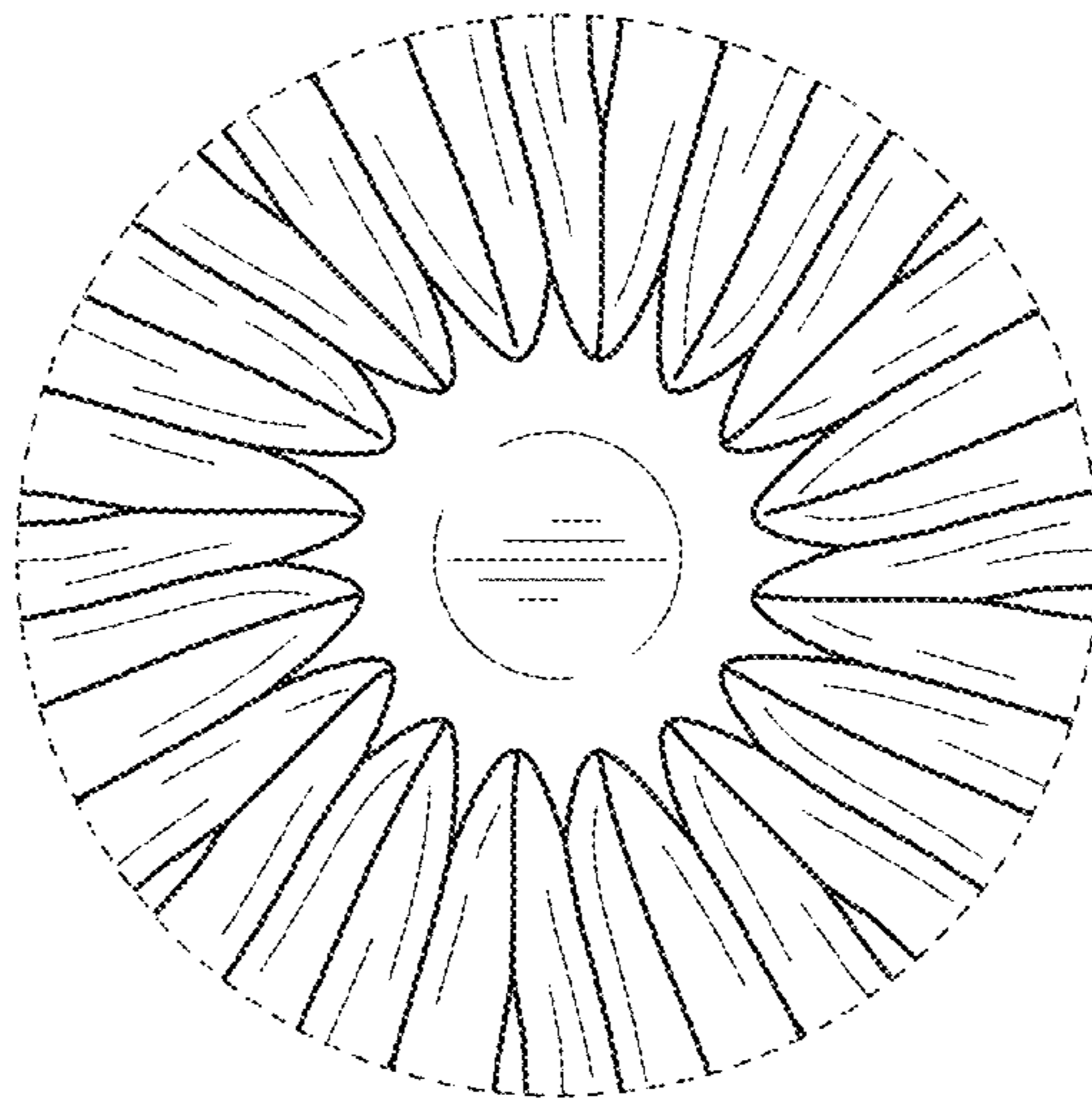
