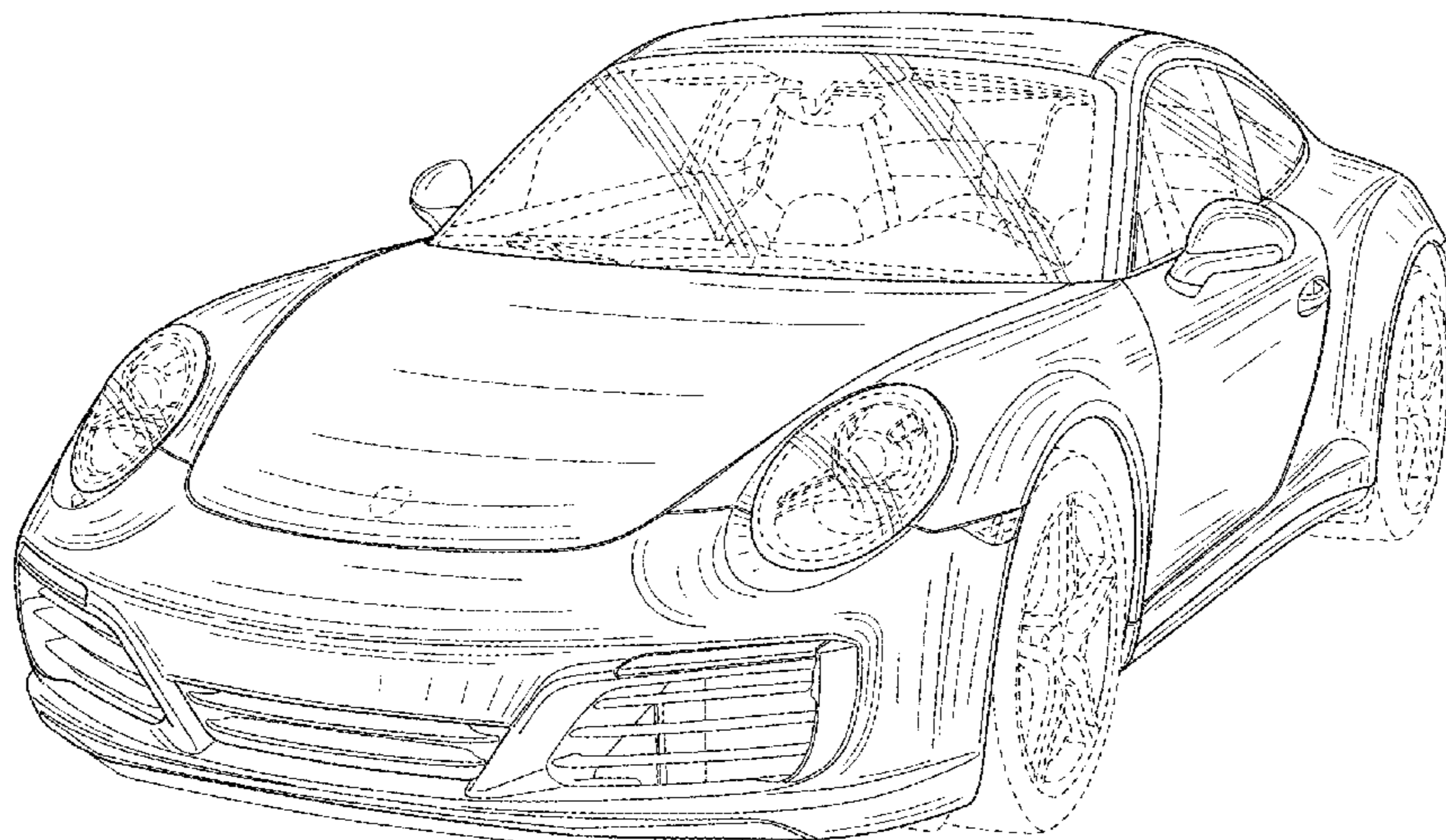
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front and side perspective view of a motor vehicle, toy and/or replica in accordance with my design;
FIG. 2 is a rear and side perspective view of the motor vehicle, toy and/or replica in accordance with my design;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a side elevational view taken from the right side in FIG. 1;

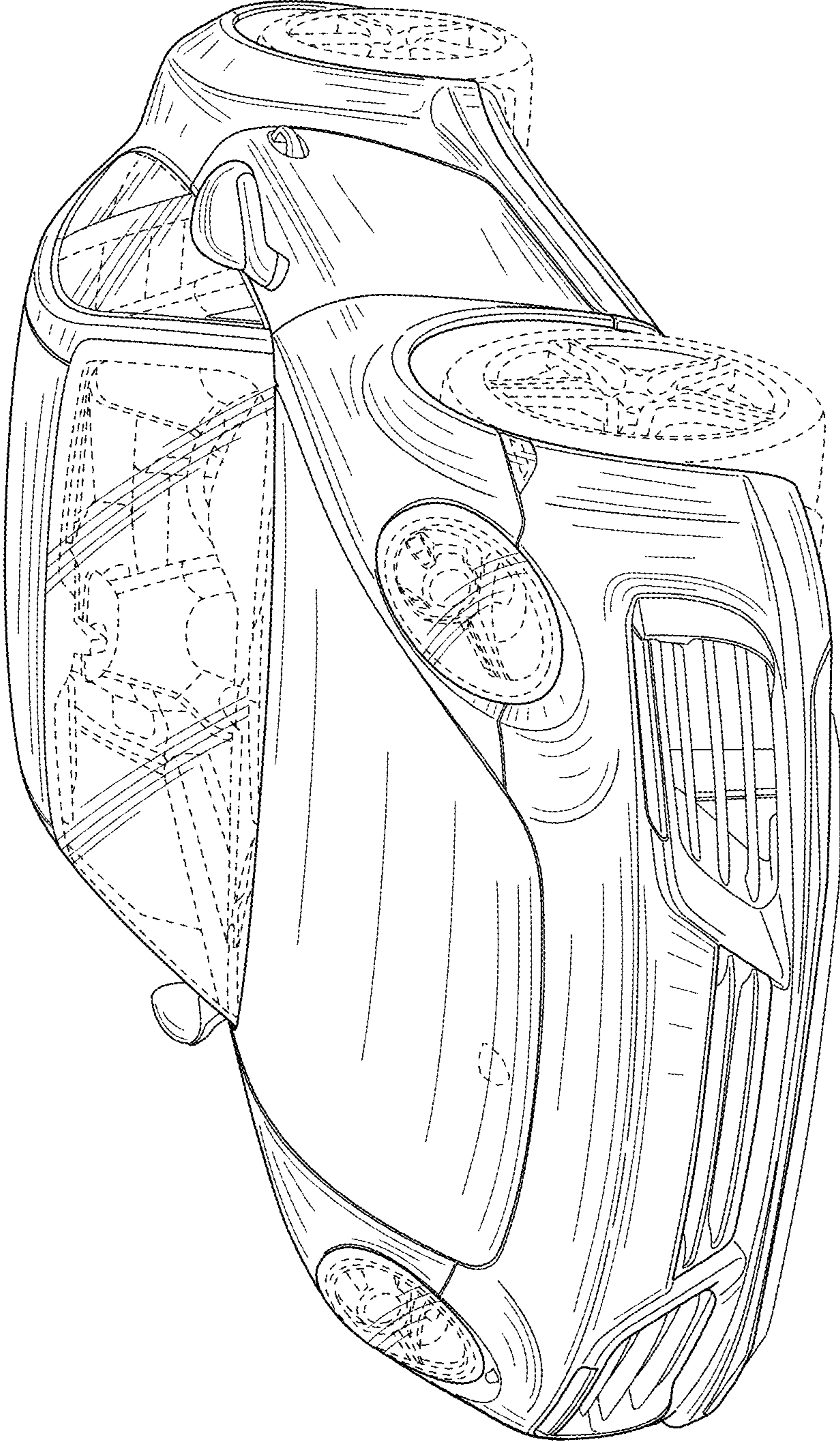

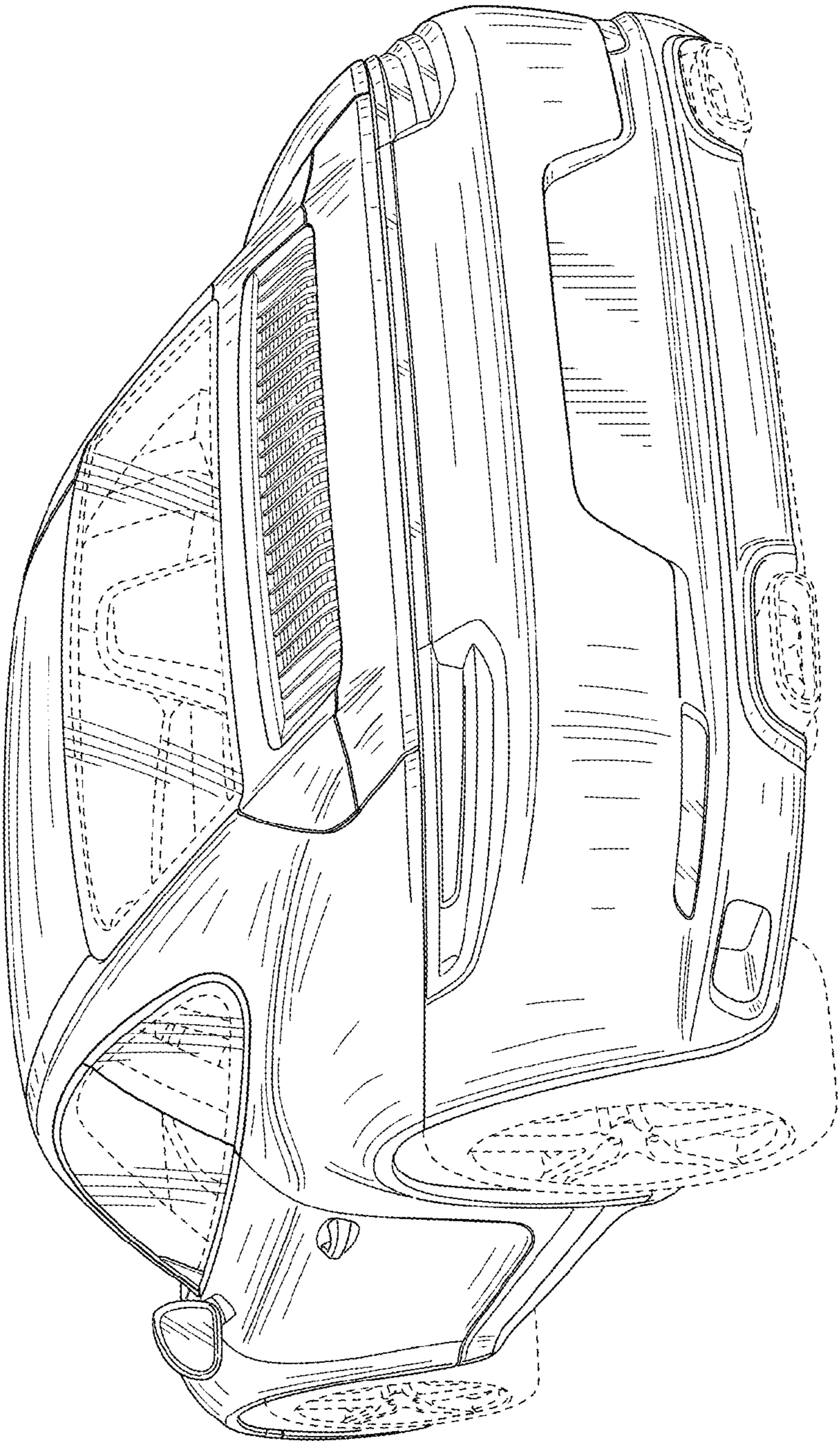

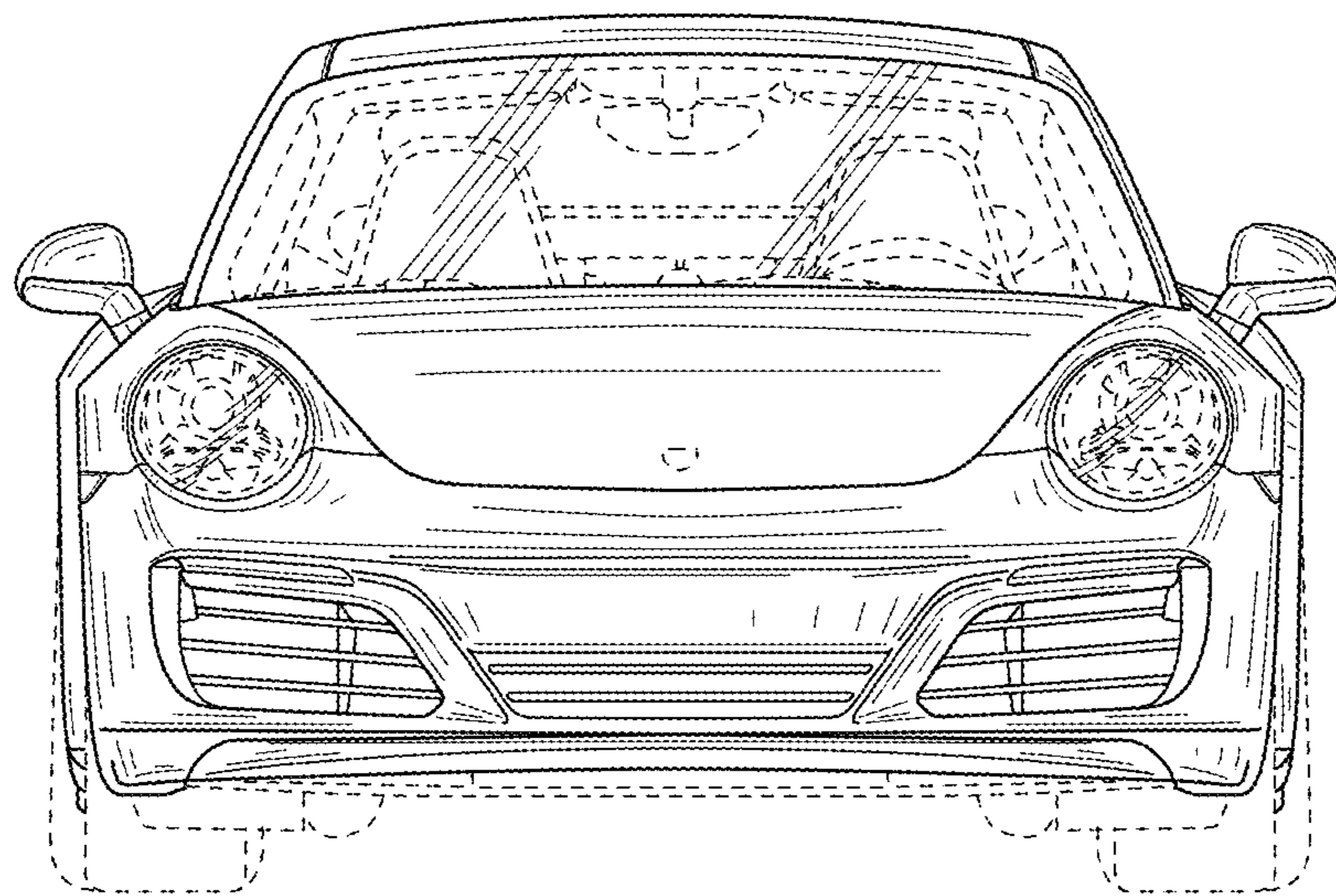

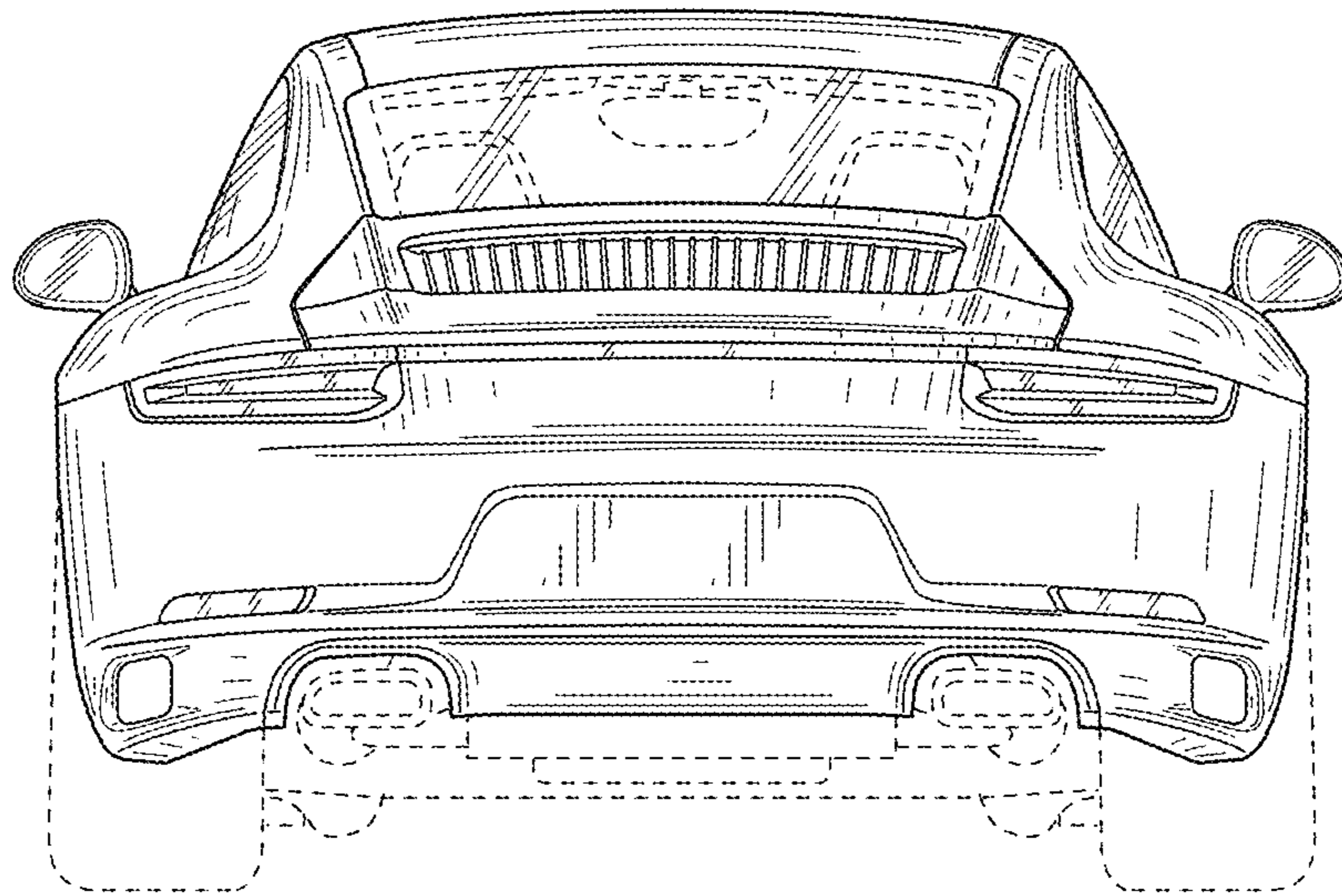

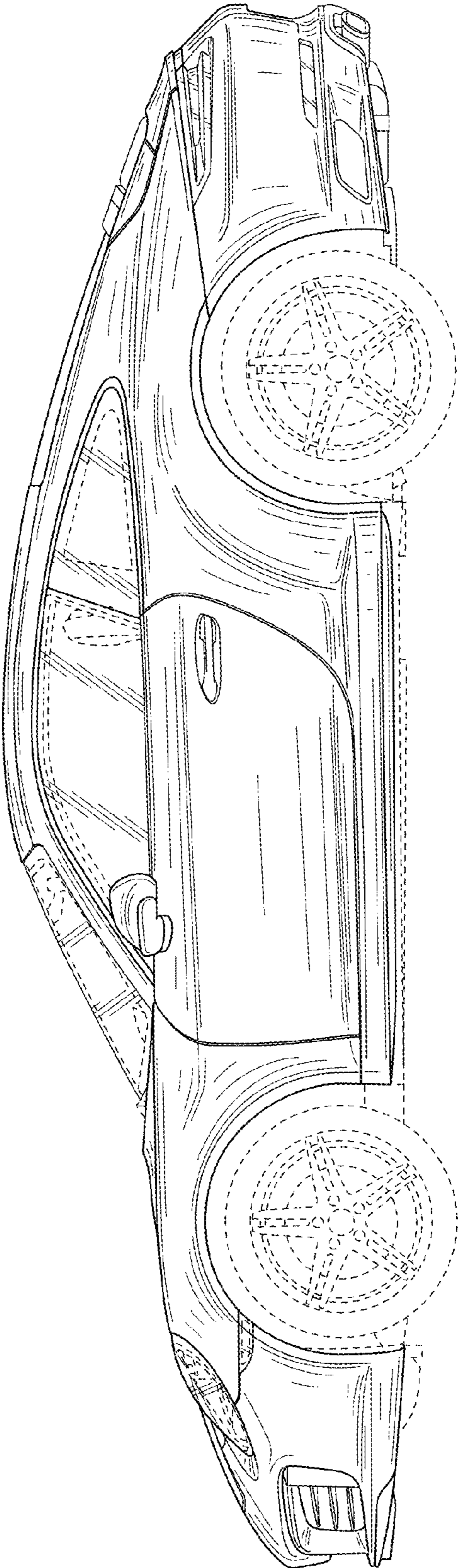

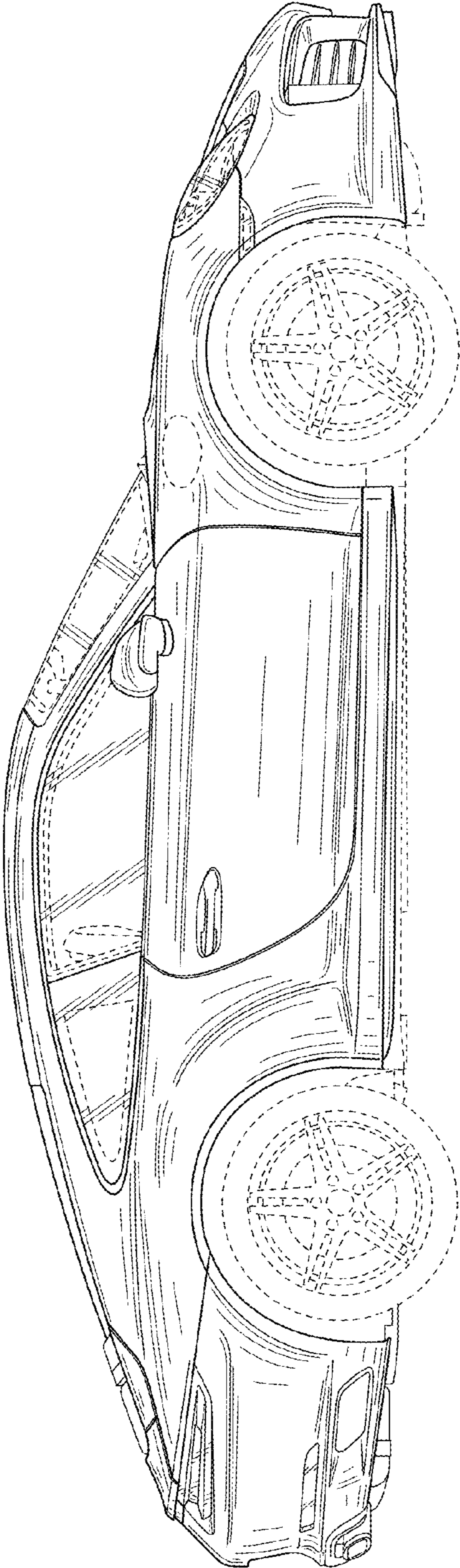

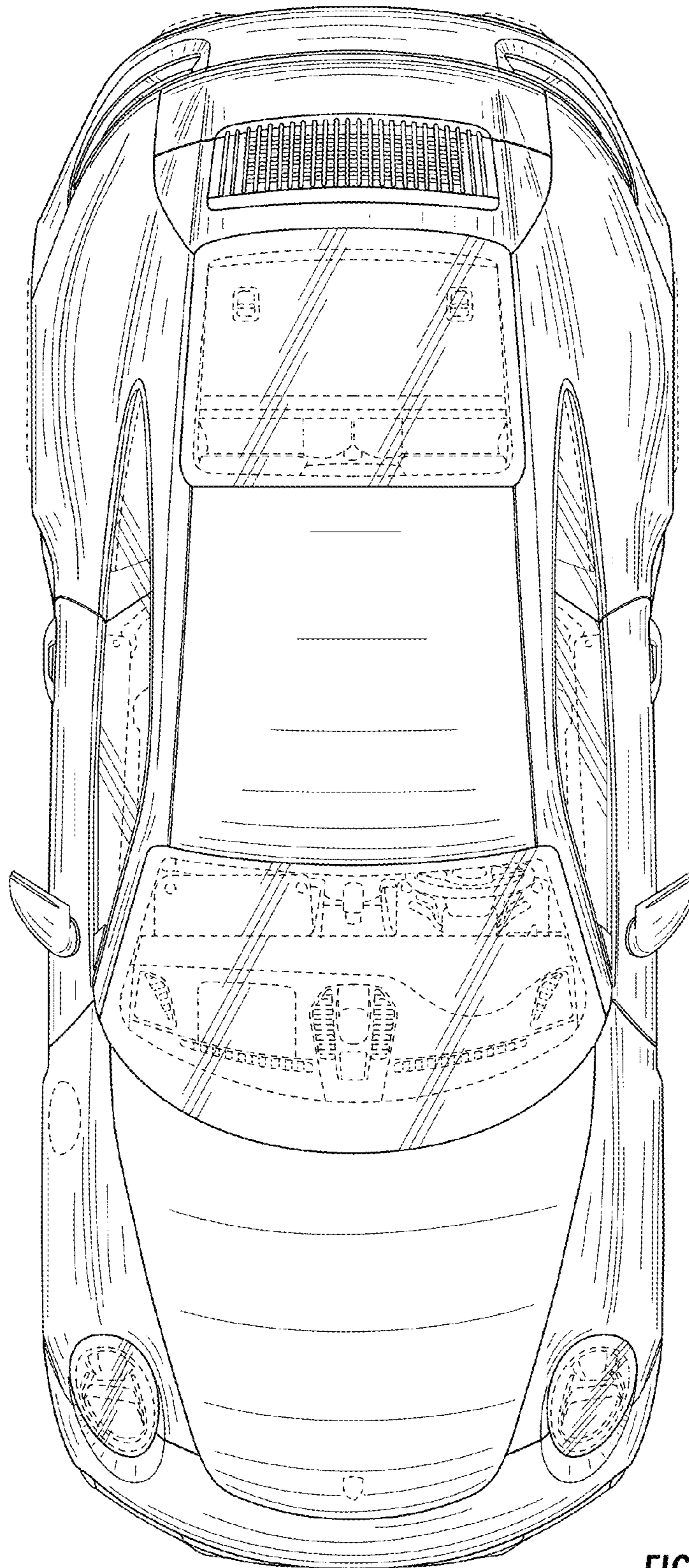

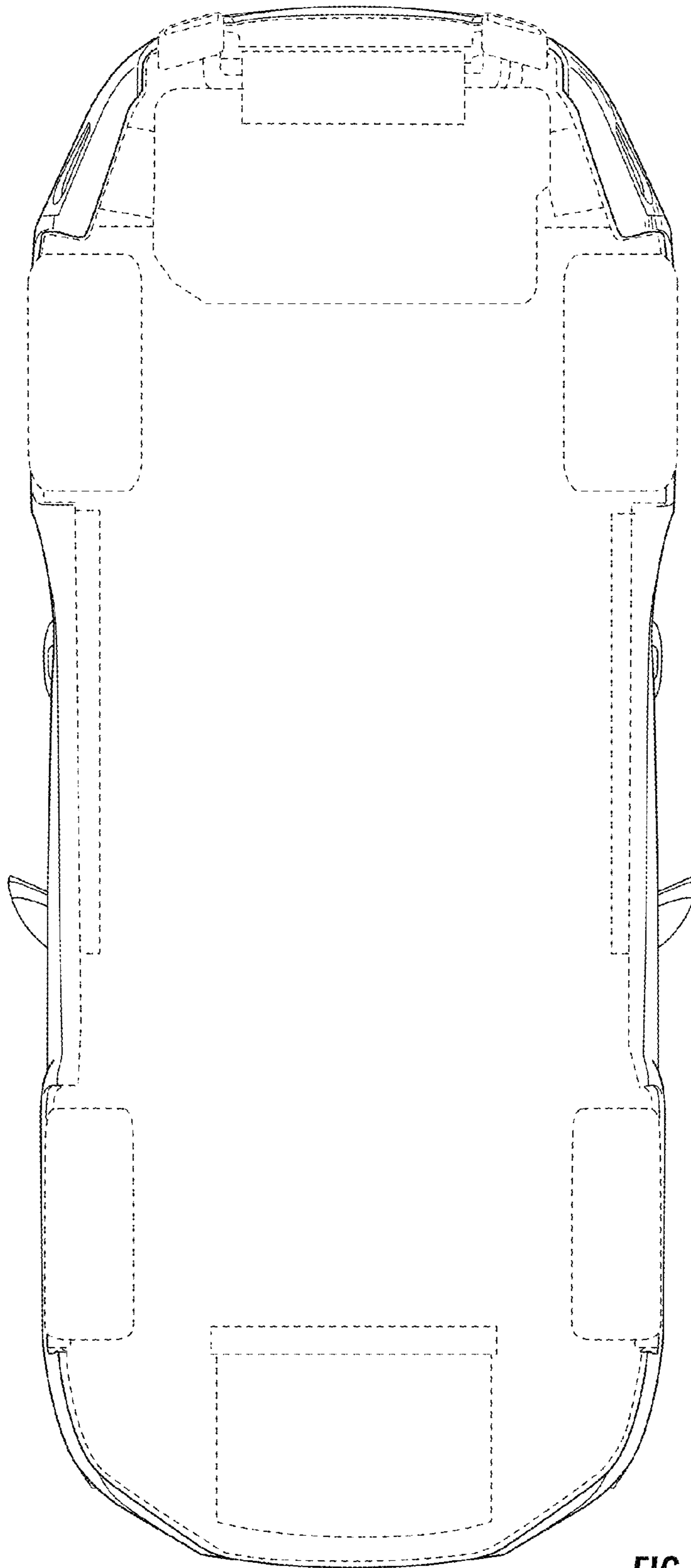
