(57) **CLAIM**

The ornamental design for a speaker sound bar, as shown and described.

DESCRIPTION

FIG. 1 is a front and right side perspective view of a speaker sound bar, shown with a grid overlying a liner array of speakers, LEDs and multiple mounting options, embodying our new design;

FIG. 2 is a left side elevation view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

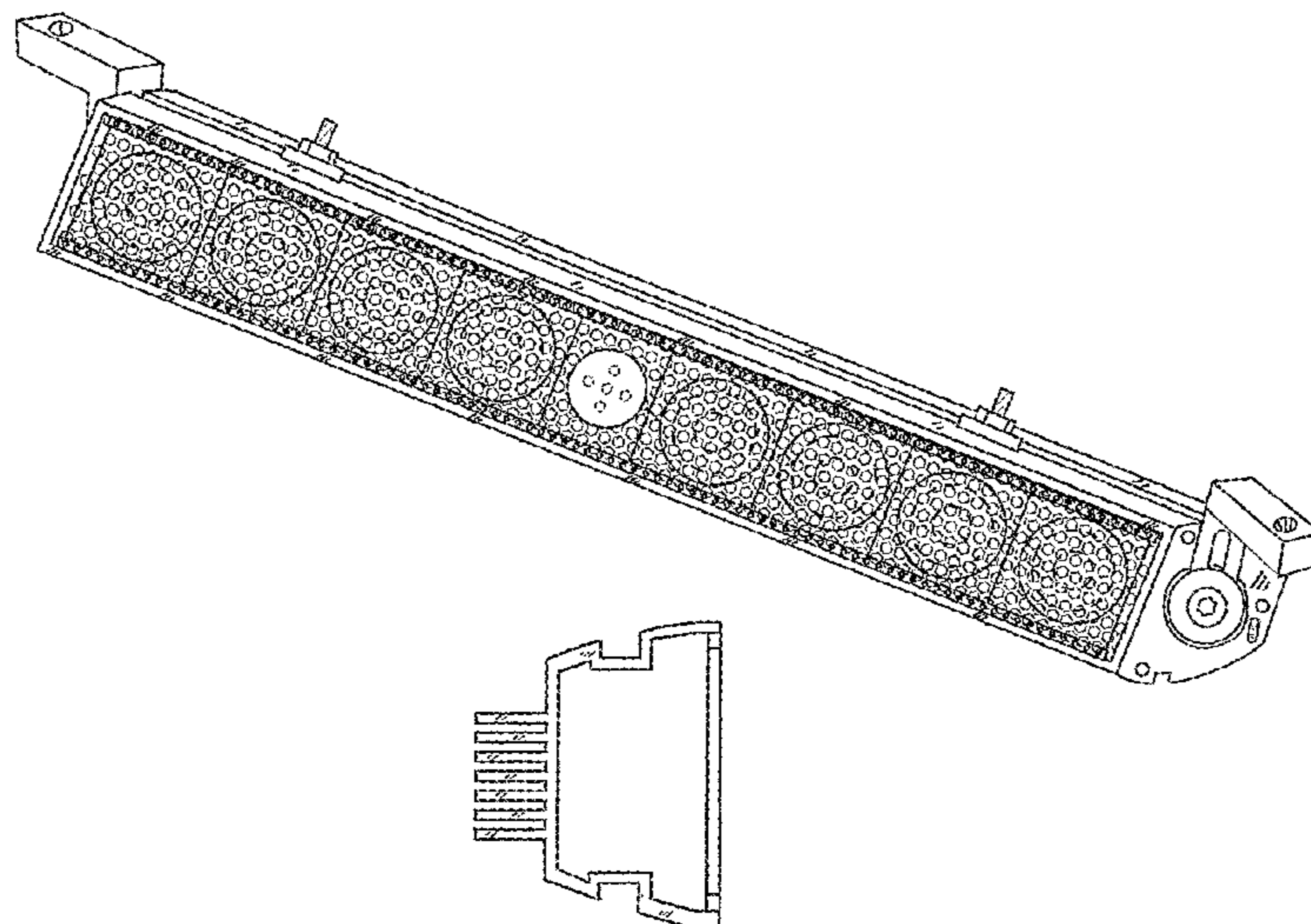
FIG. 6 is a front elevation view thereof;

FIG. 7 is a rear elevation view thereof; and,

FIG. 8 is a cross-sectional view thereof taken between axes A-A and B-B of FIG. 7.

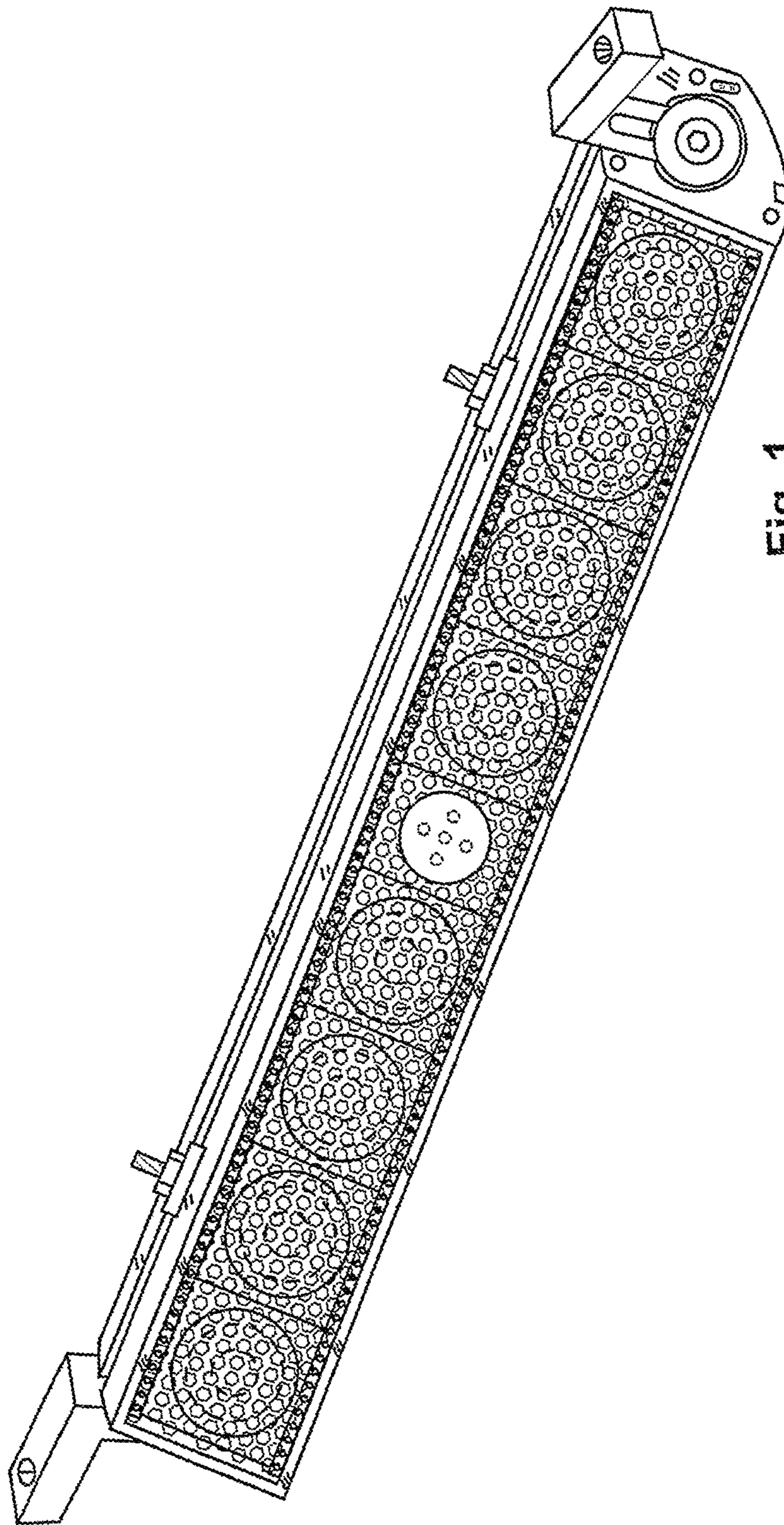

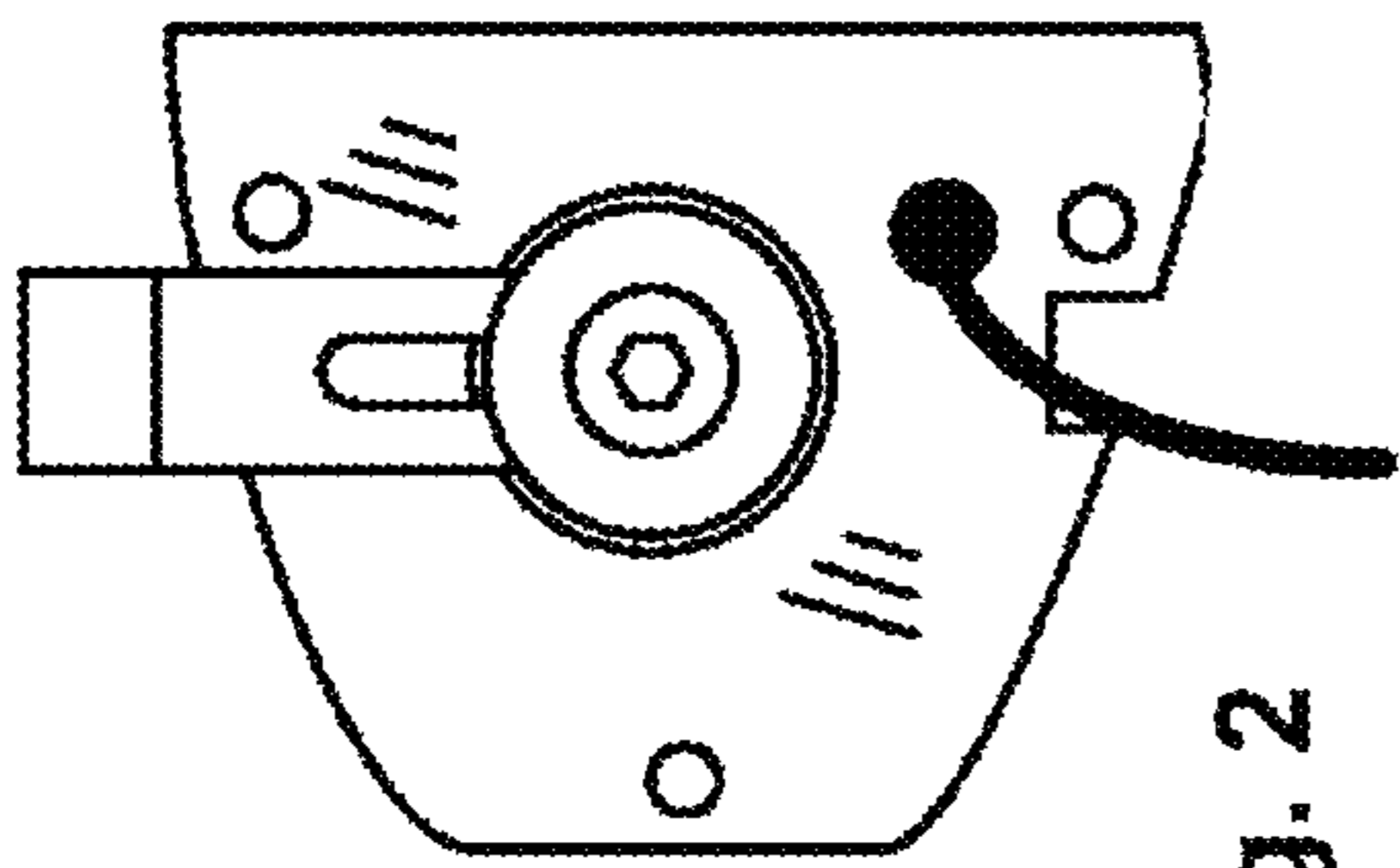

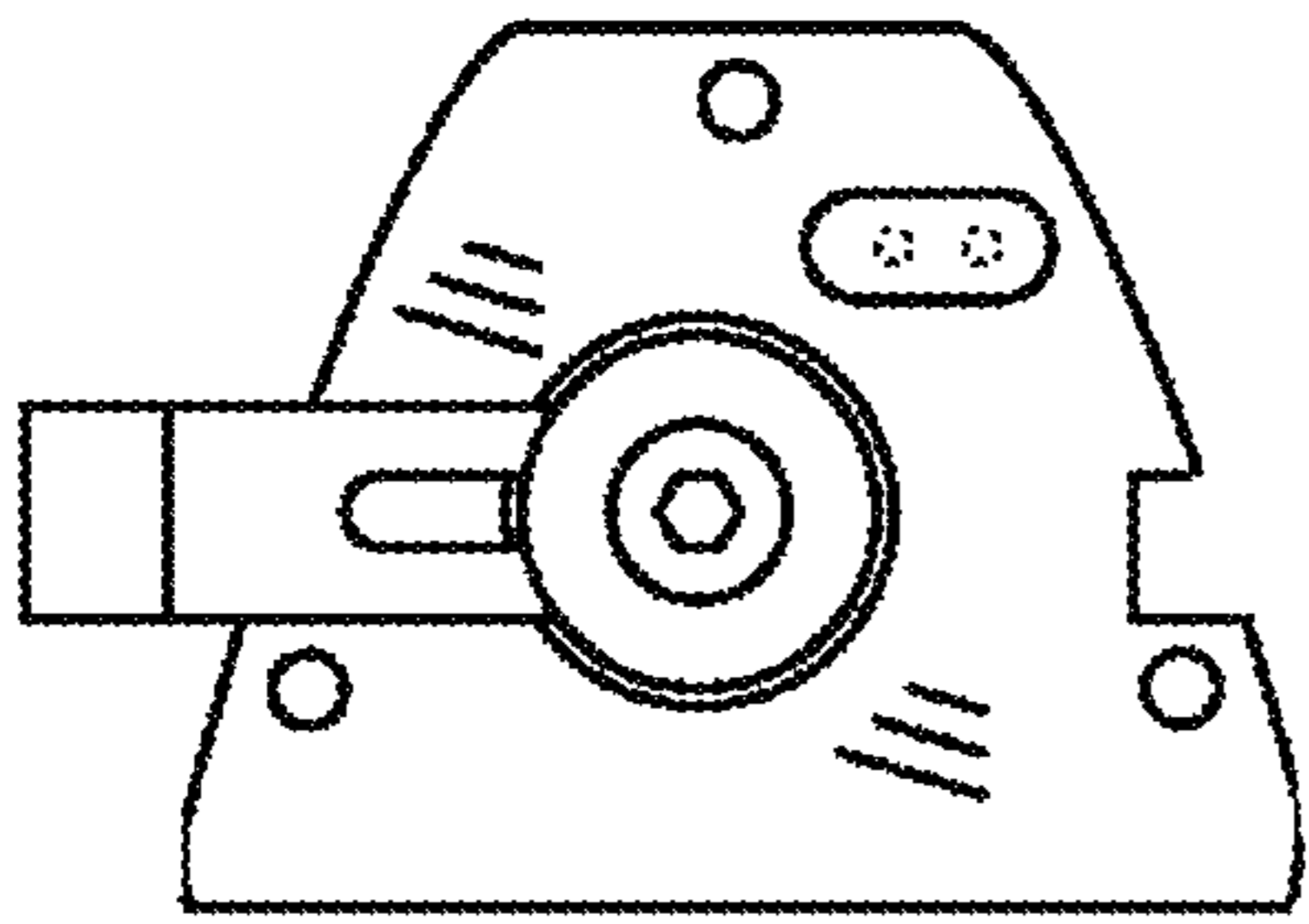

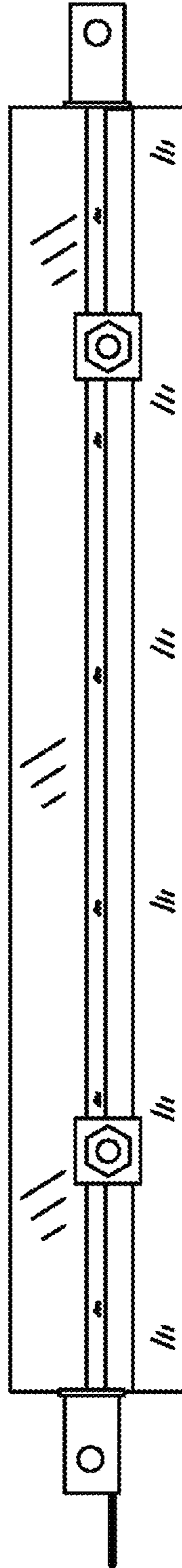

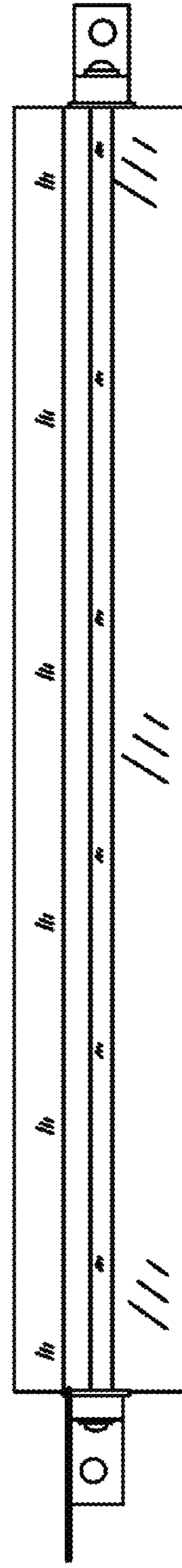

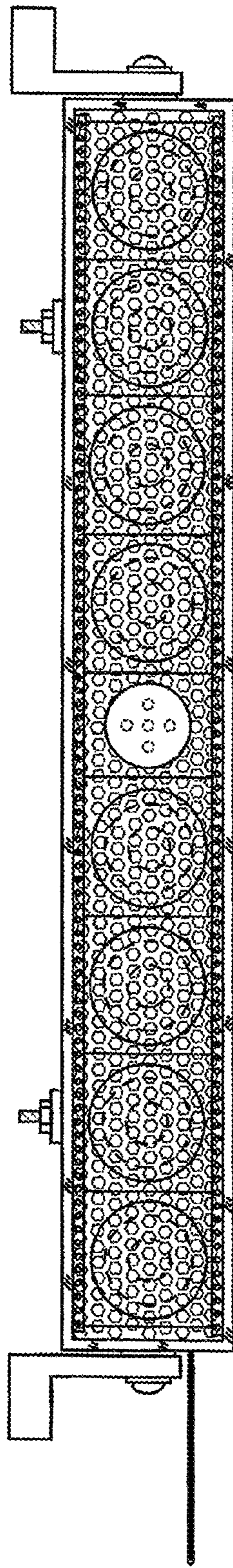

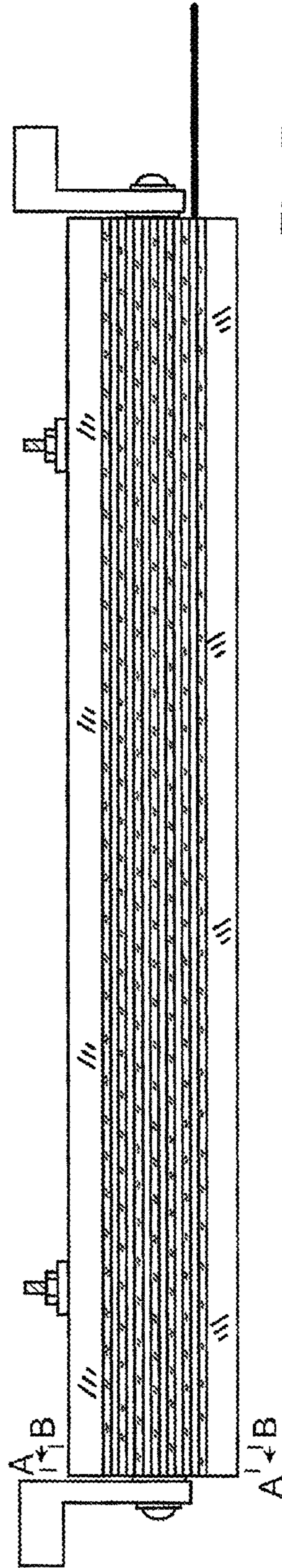

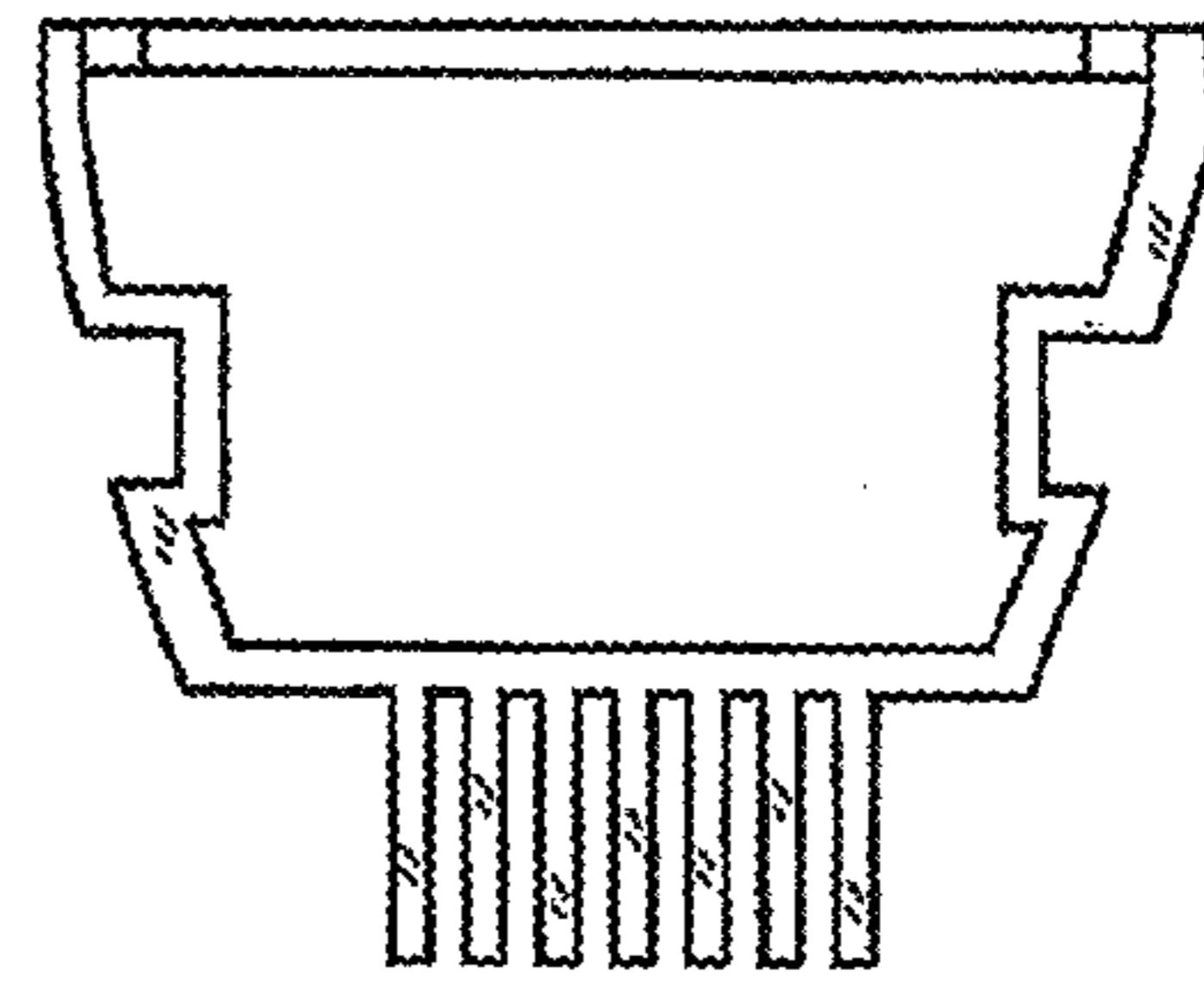
