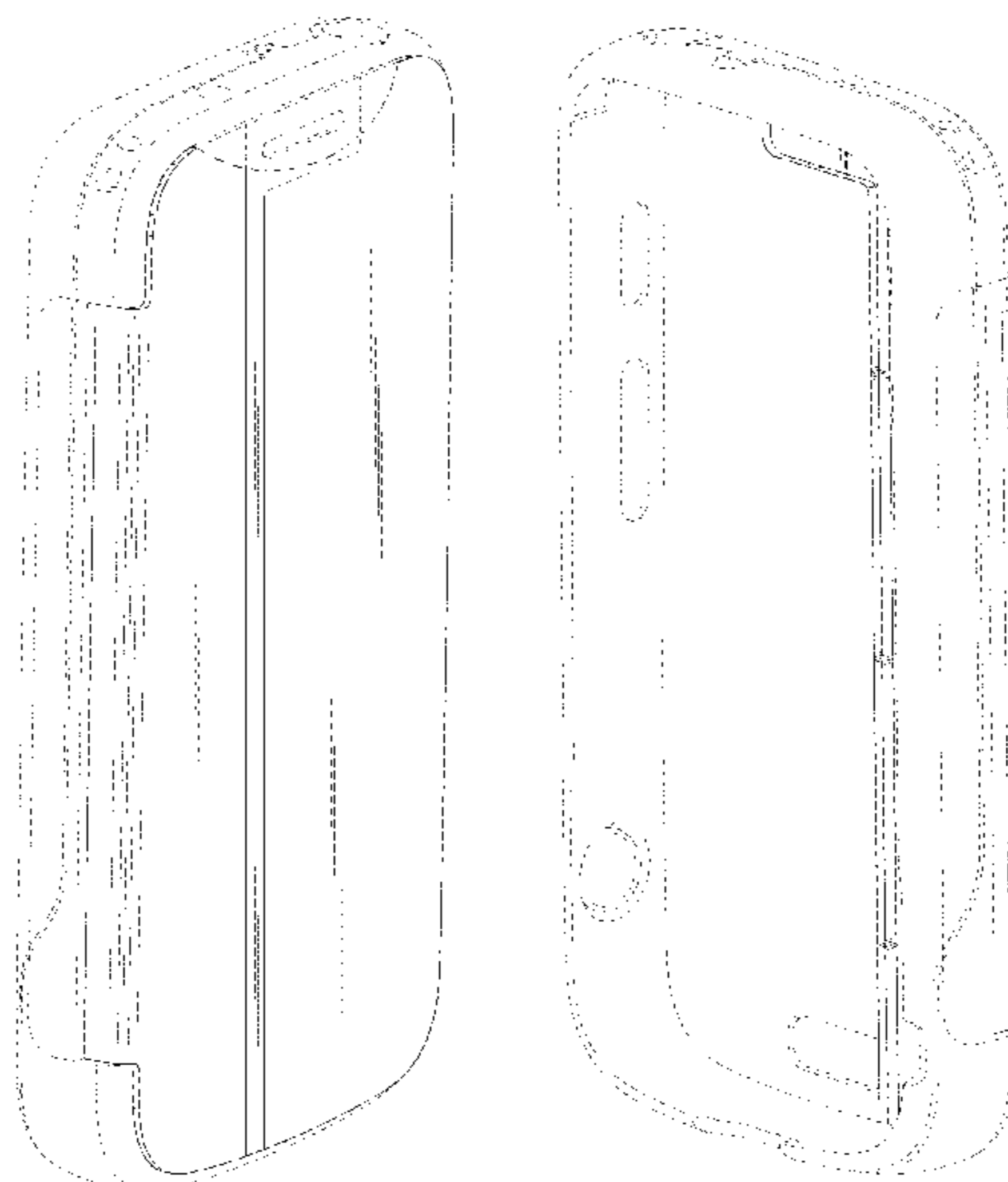
(57) **CLAIM**
The ornamental design for a cover for mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a cover for mobile phone showing our new design;
FIG. 2 is a front view thereof;

FIG. 4 is a left side view thereof;

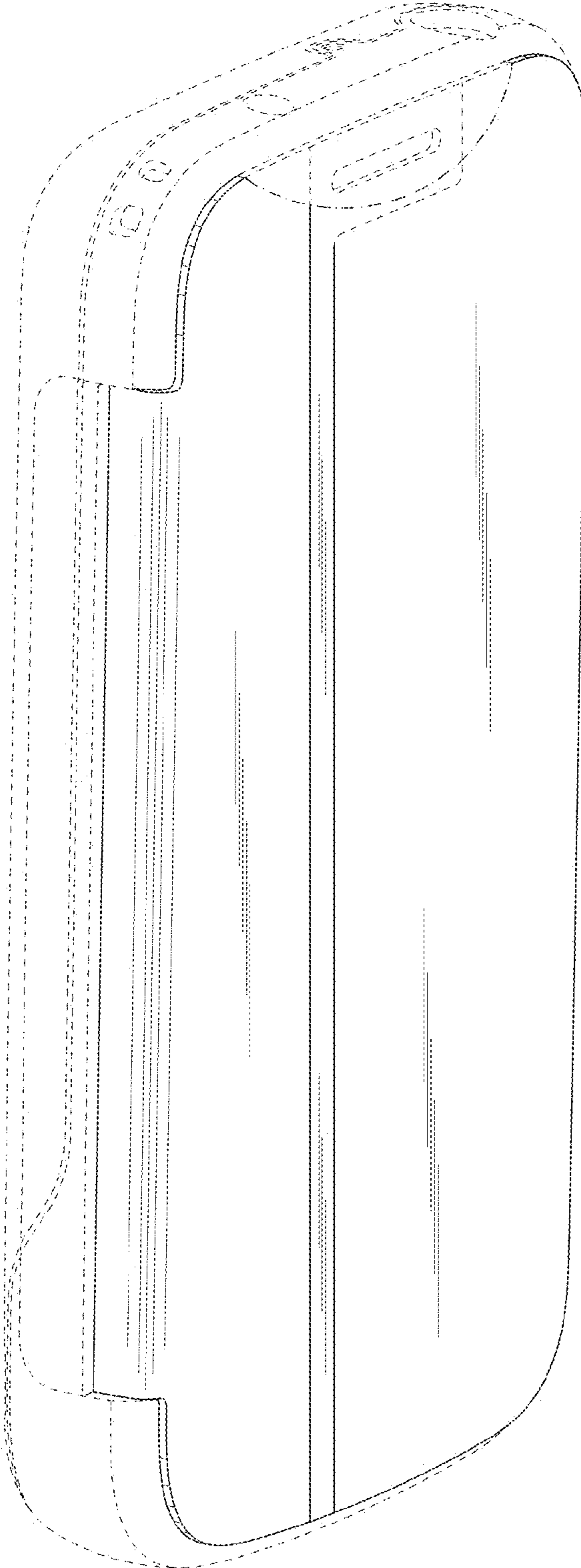

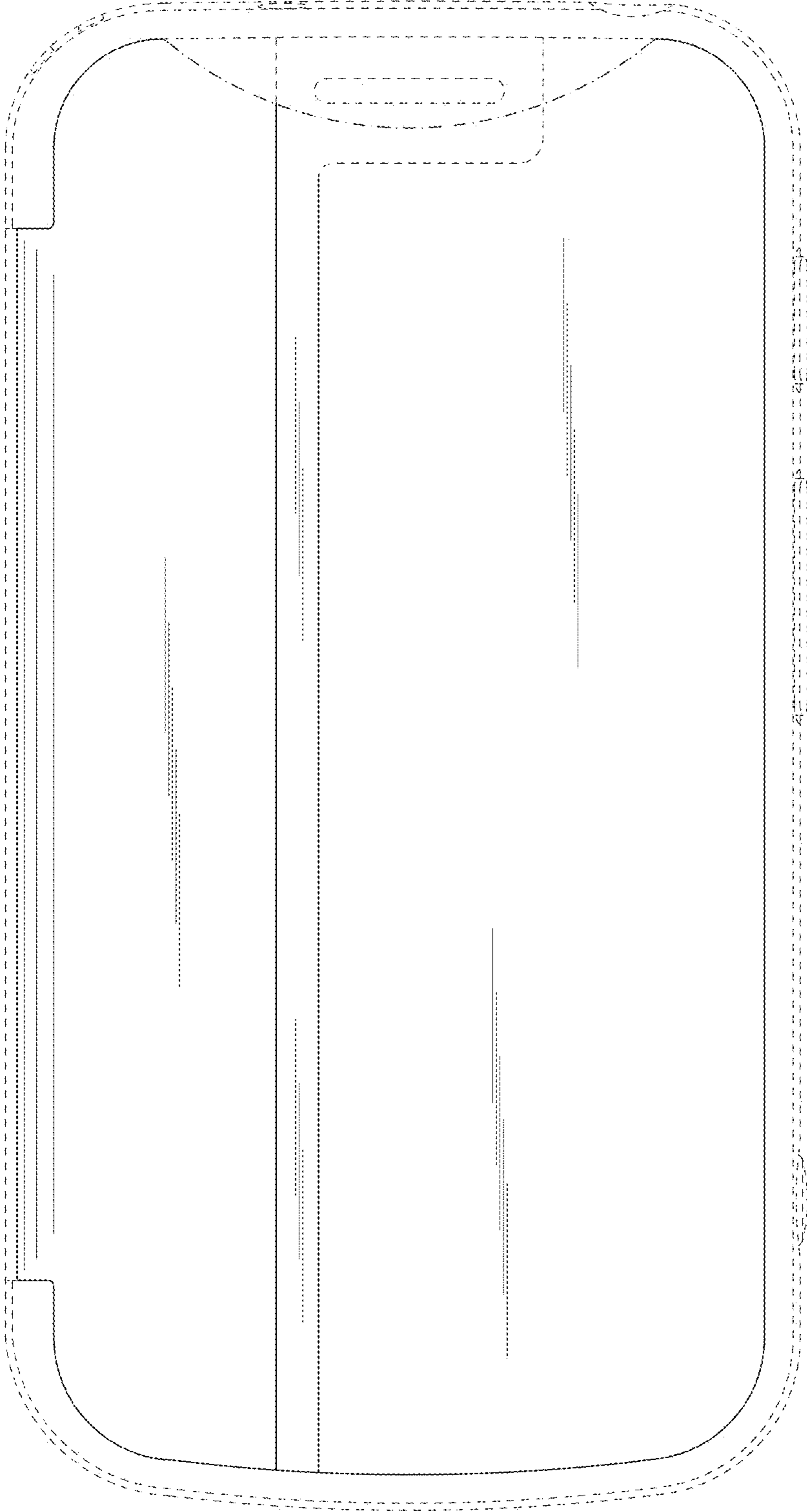

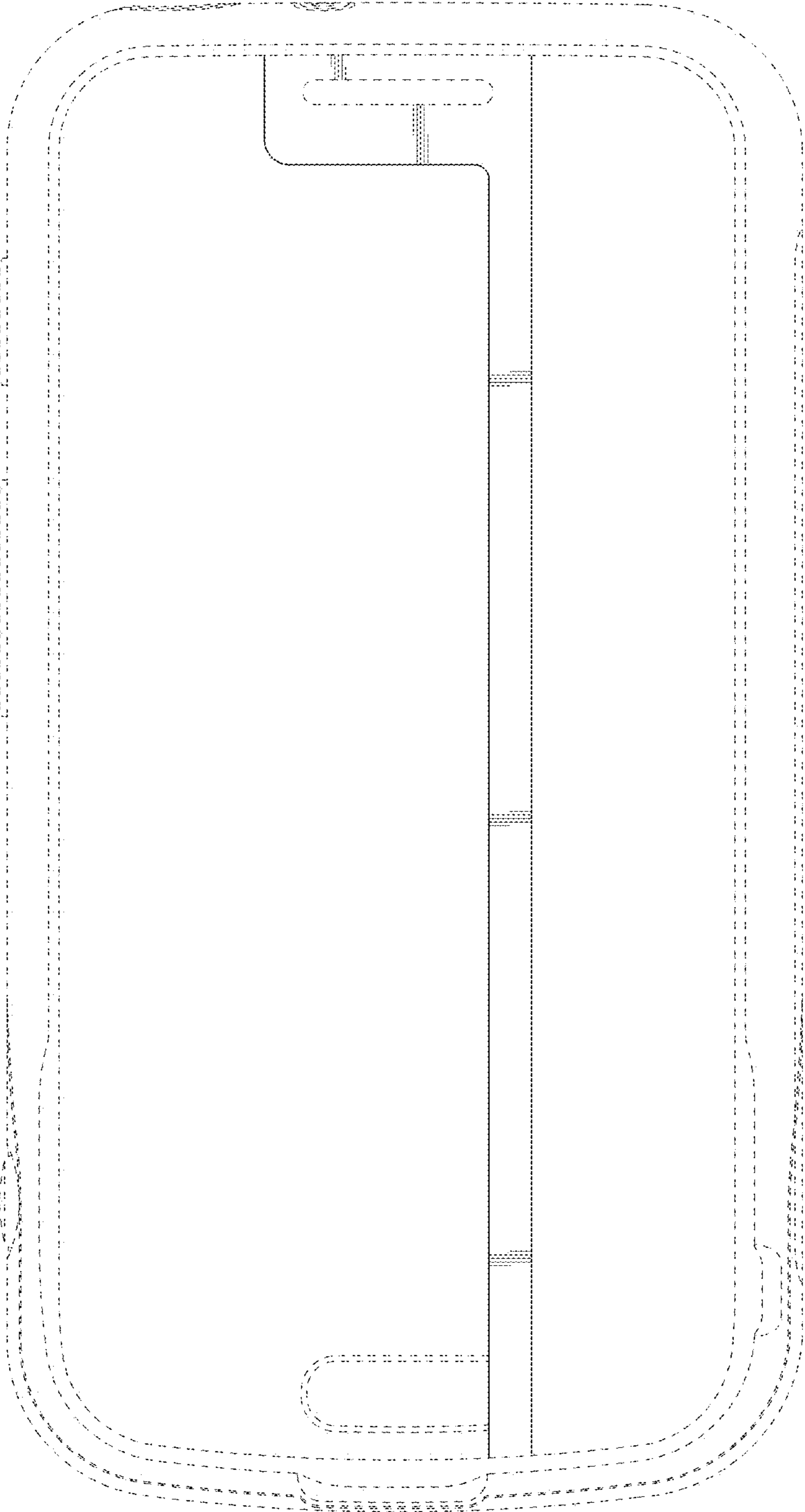

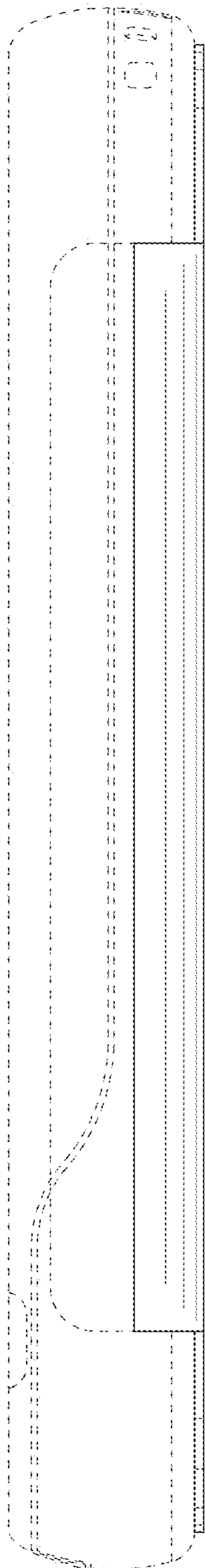

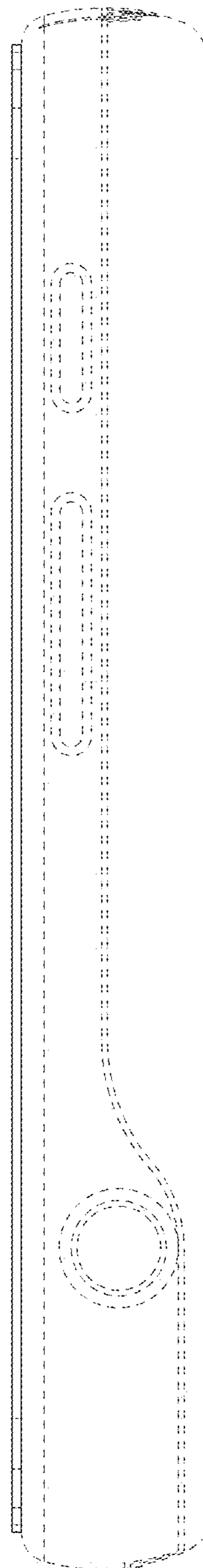

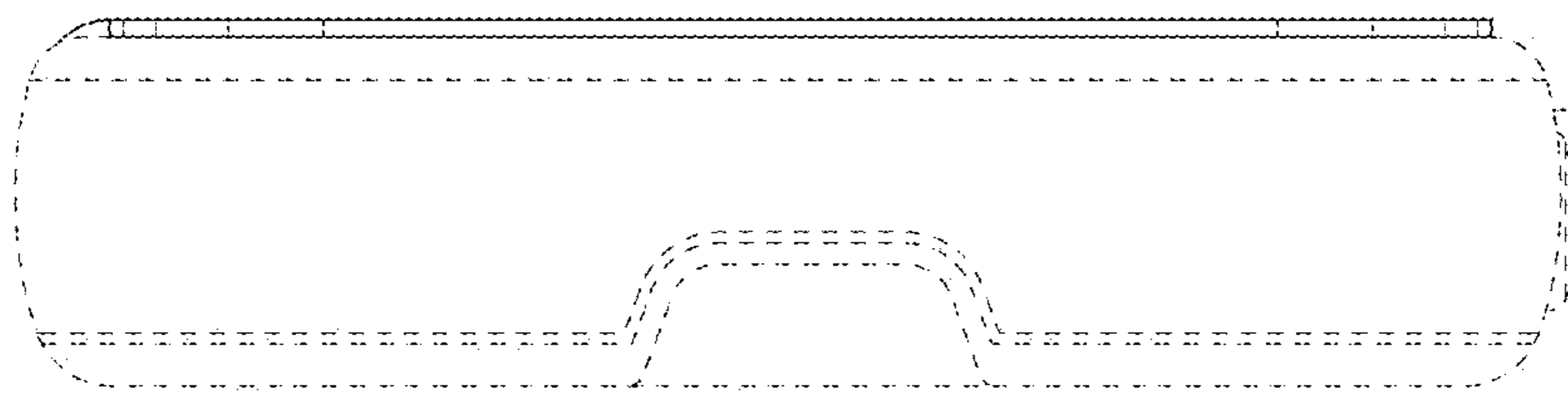
