**DESCRIPTION**

FIG. 1 is the first image in a sequence for a display screen or portion thereof with animated graphical user interface showing my new design;

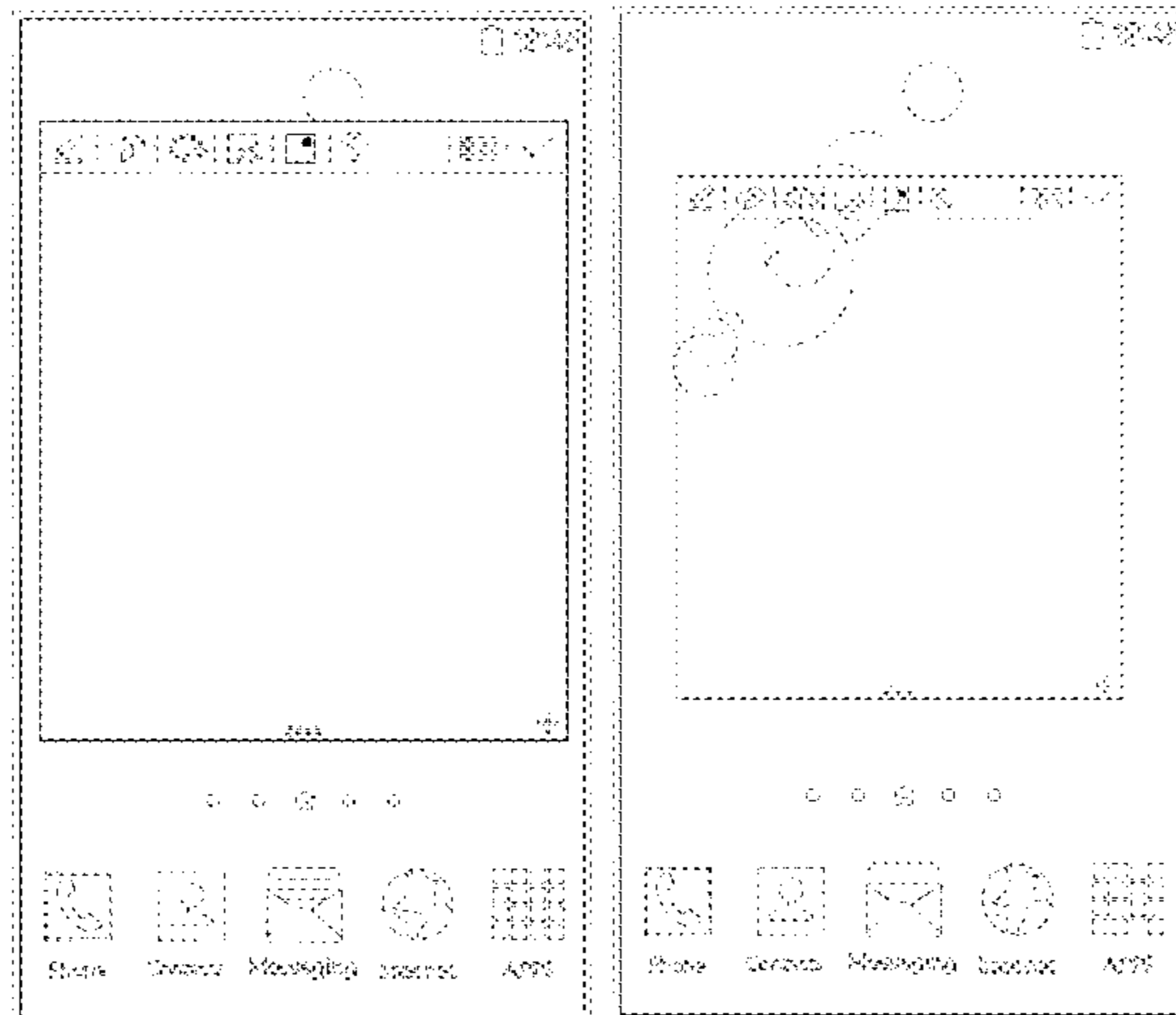
FIG. 2 is the second image thereof;

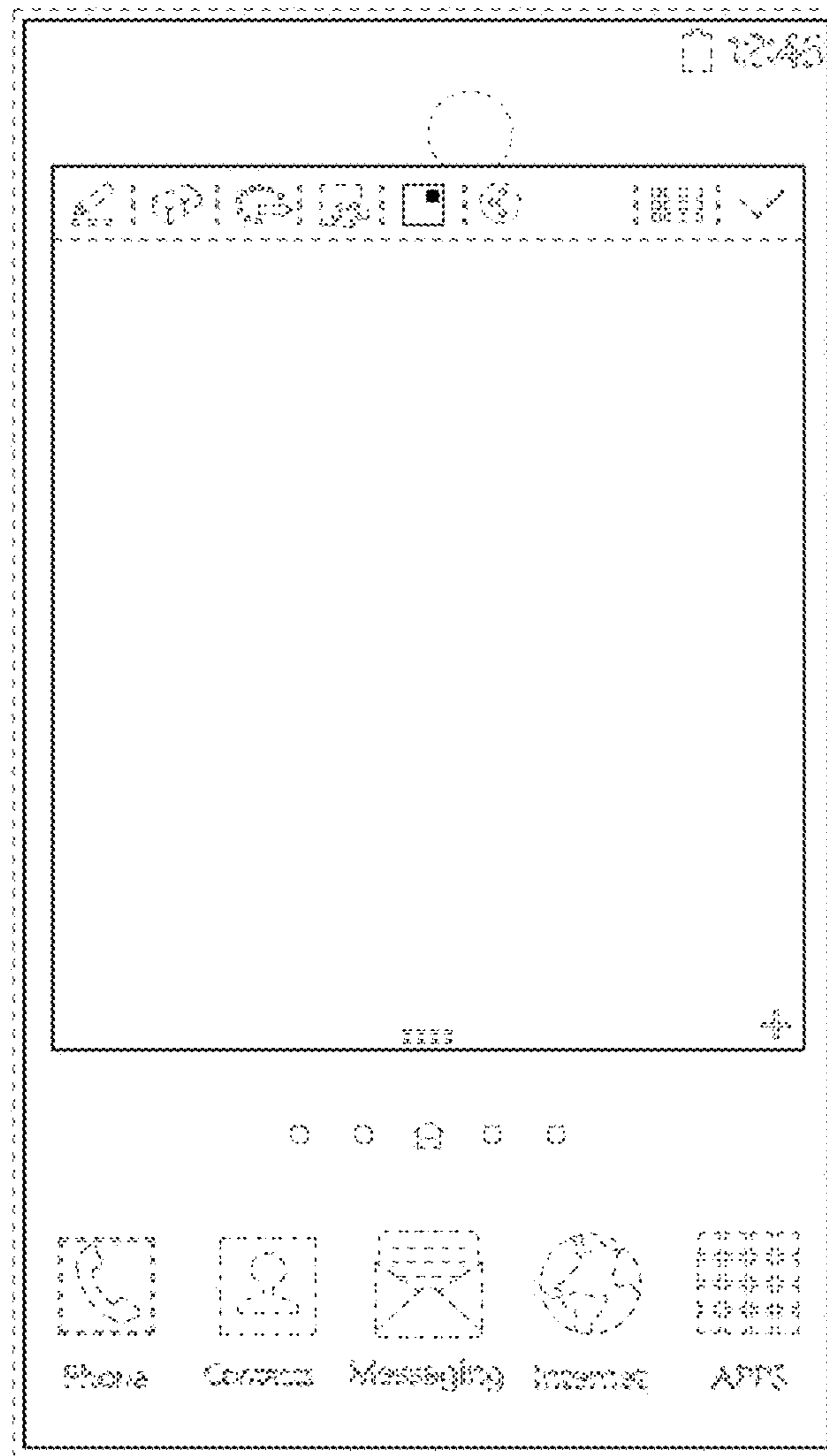

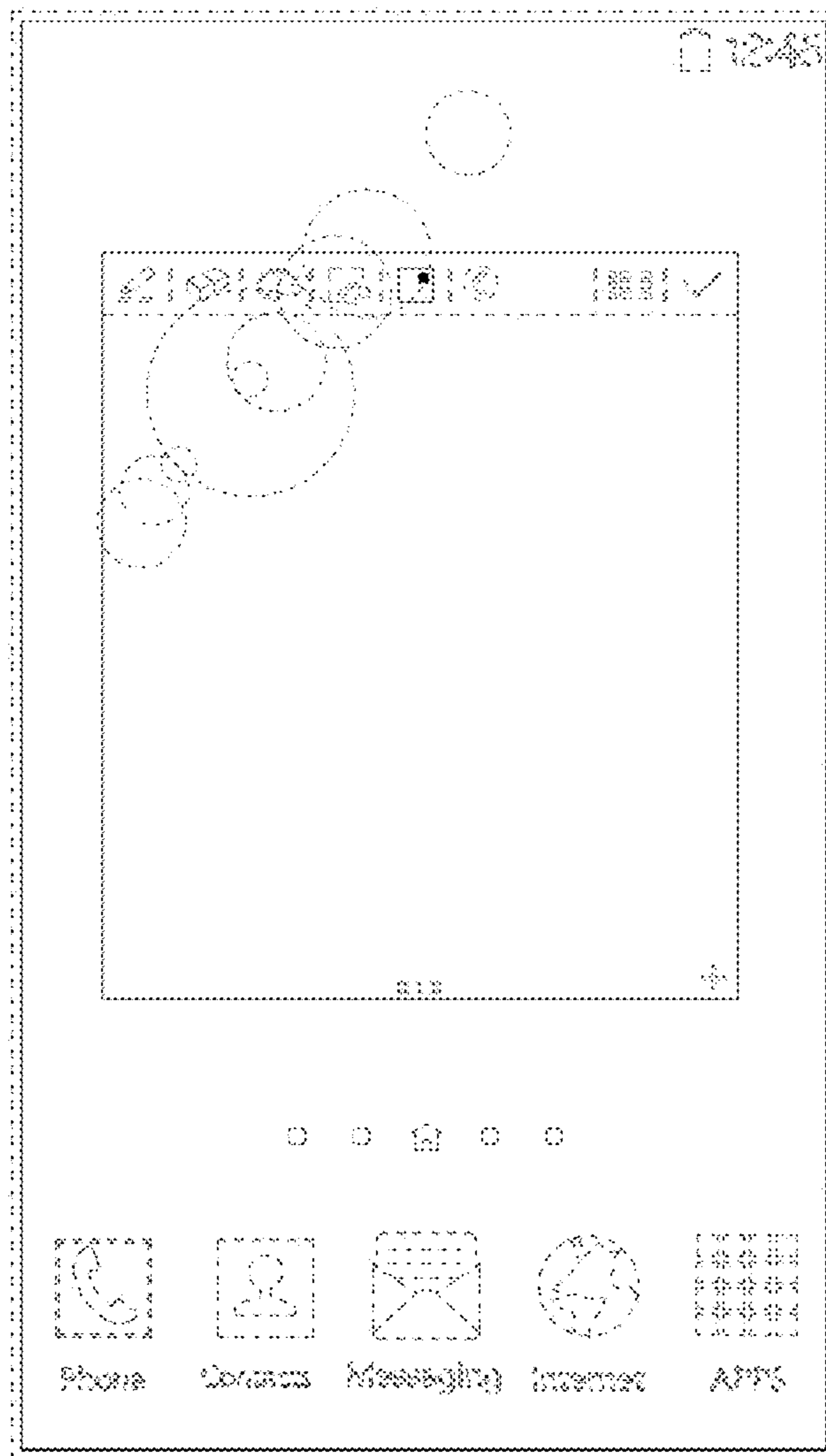

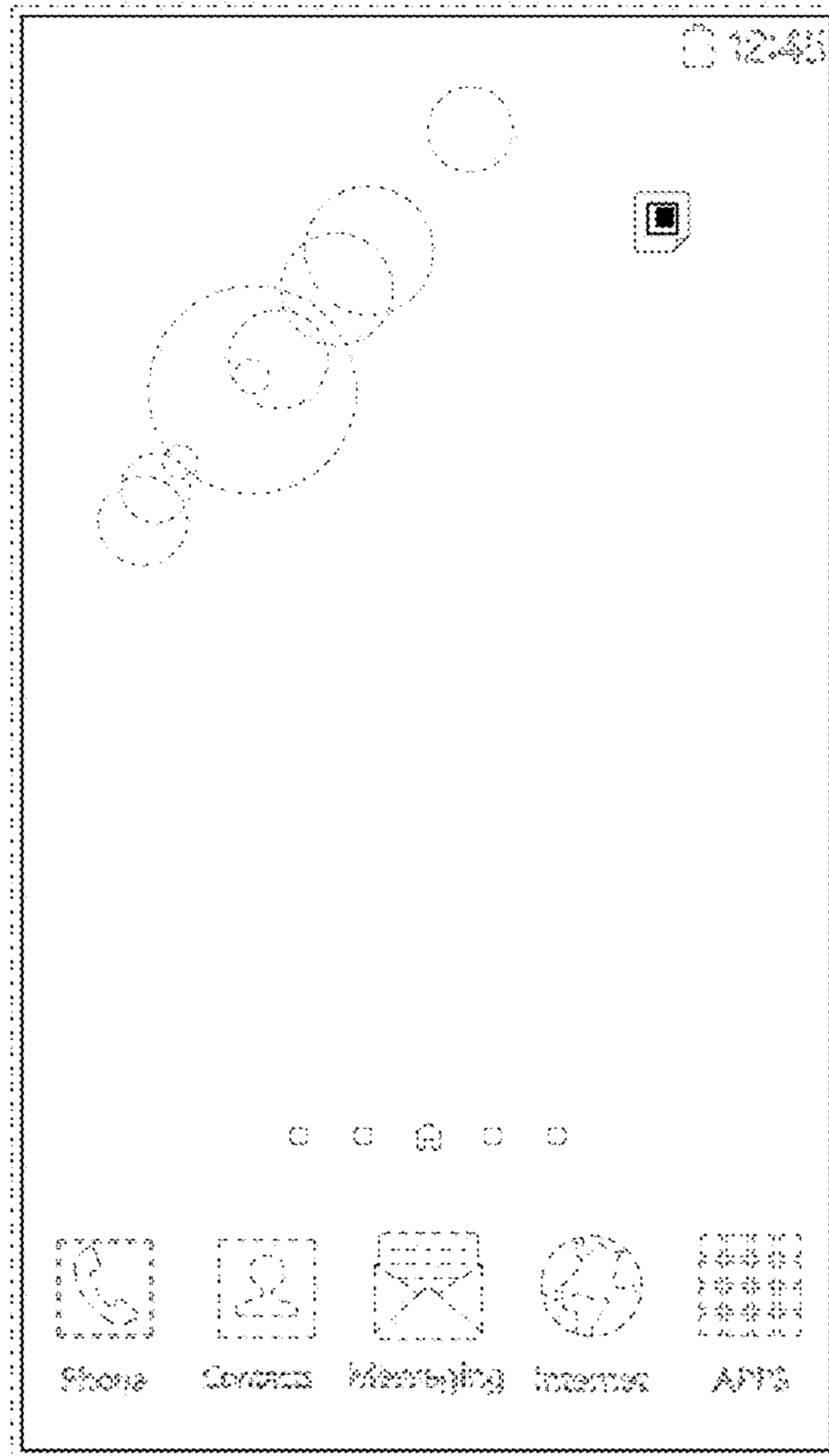

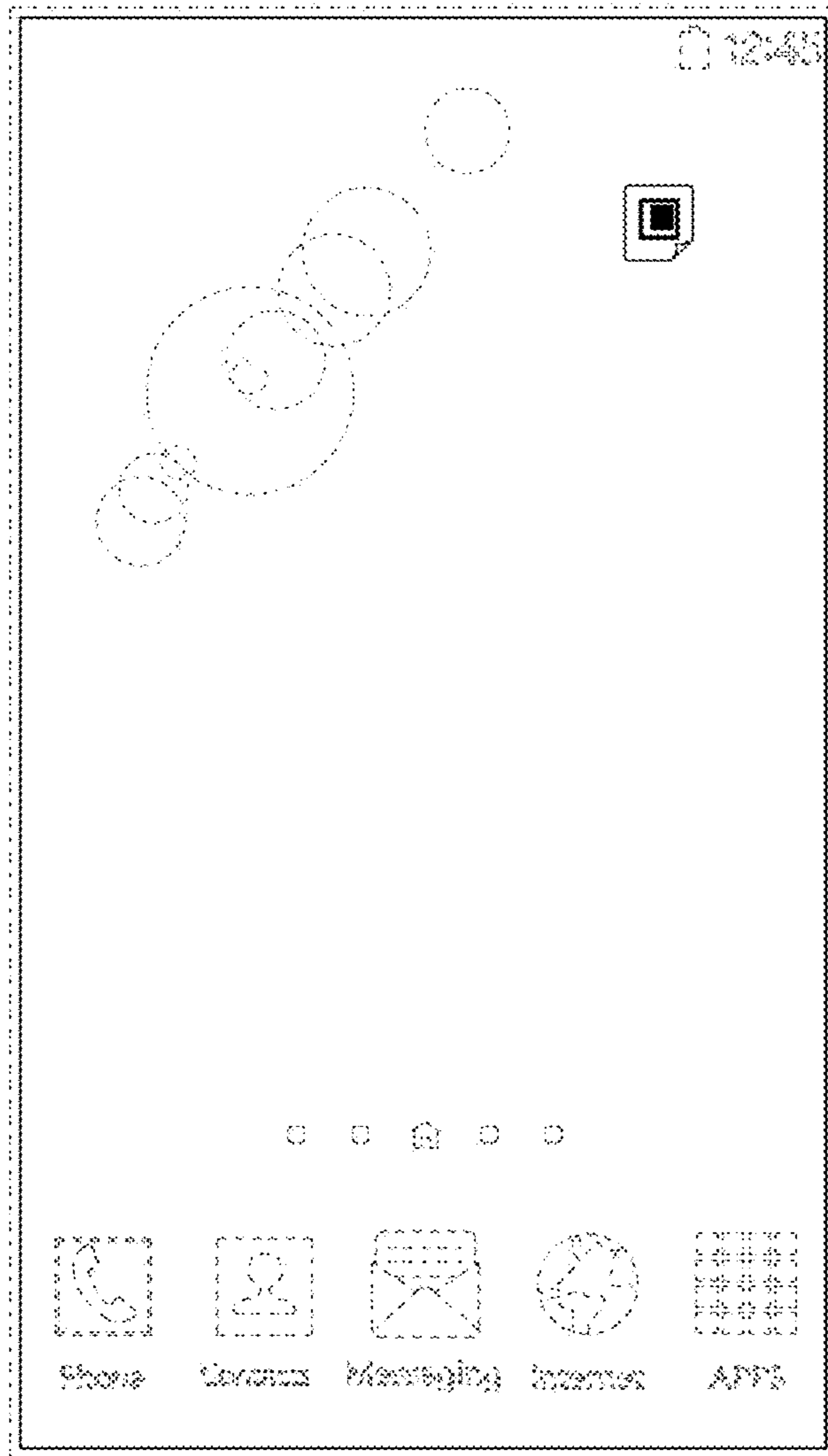
