(57) **CLAIM**

The ornamental design for a display screen or a portion thereof with transitional graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a first image in the sequence of a display screen or a portion thereof with transitional graphical user interface showing my new design;

FIG. 4 is a fourth image thereof;

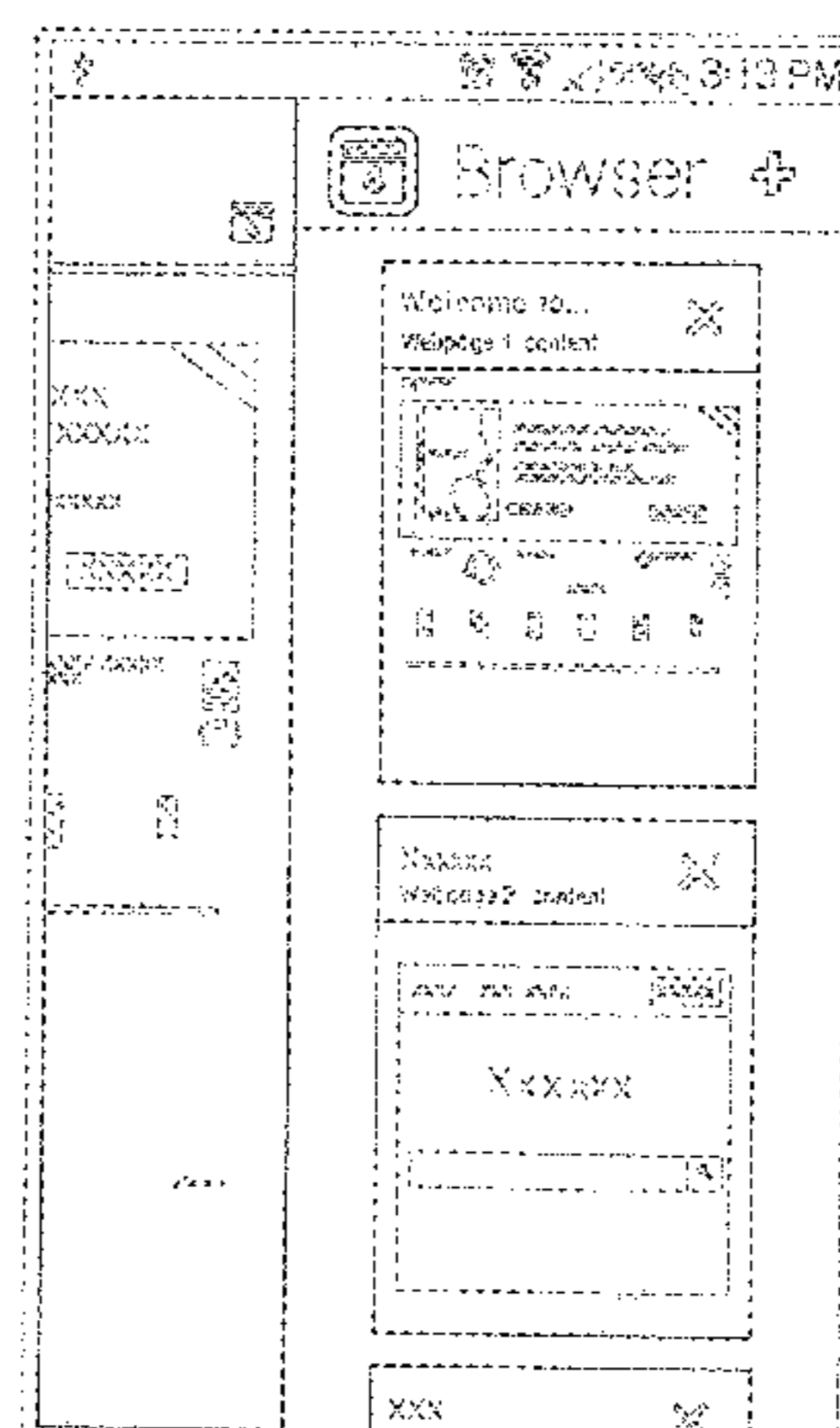
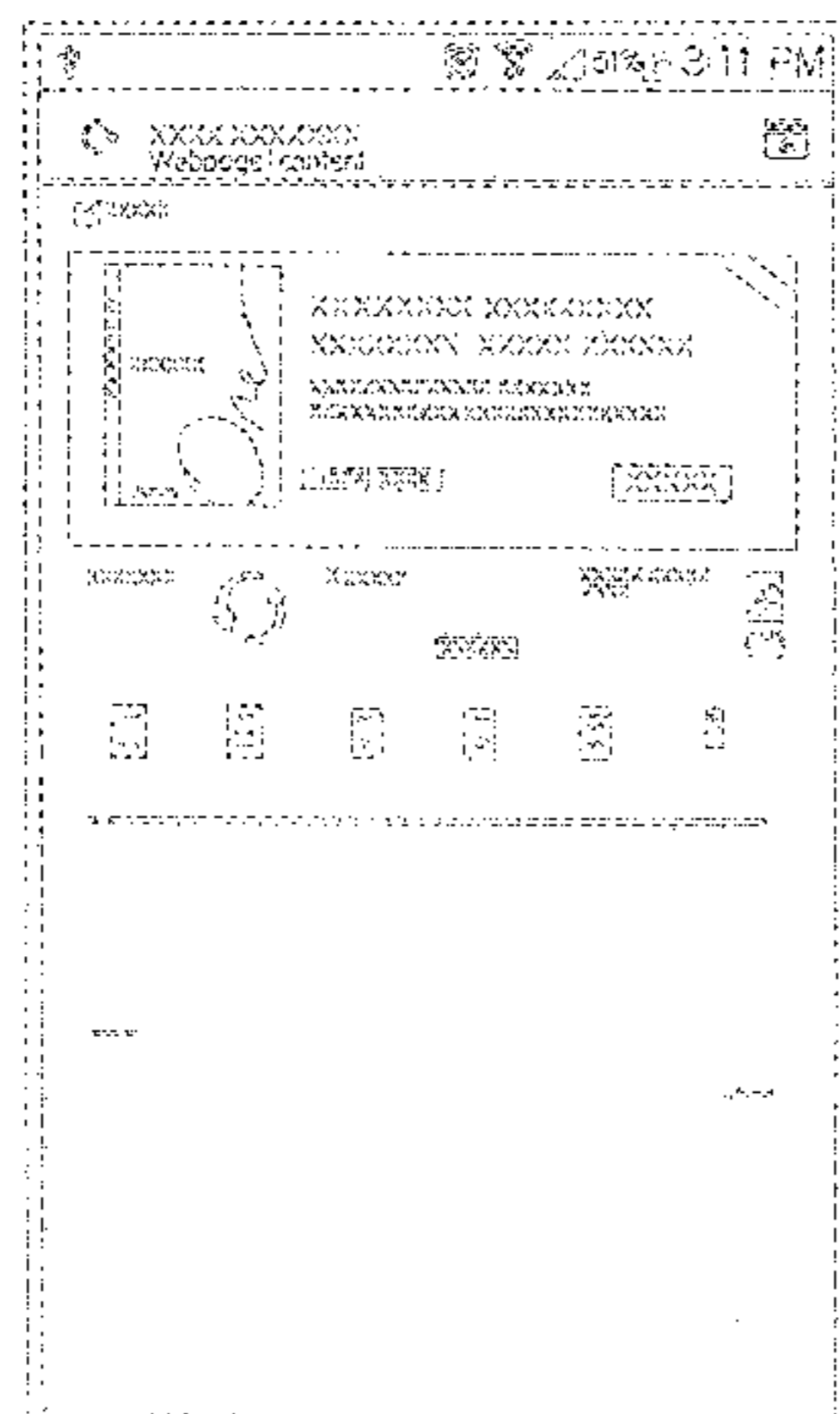


FIG. 5 is a fifth image thereof; and,

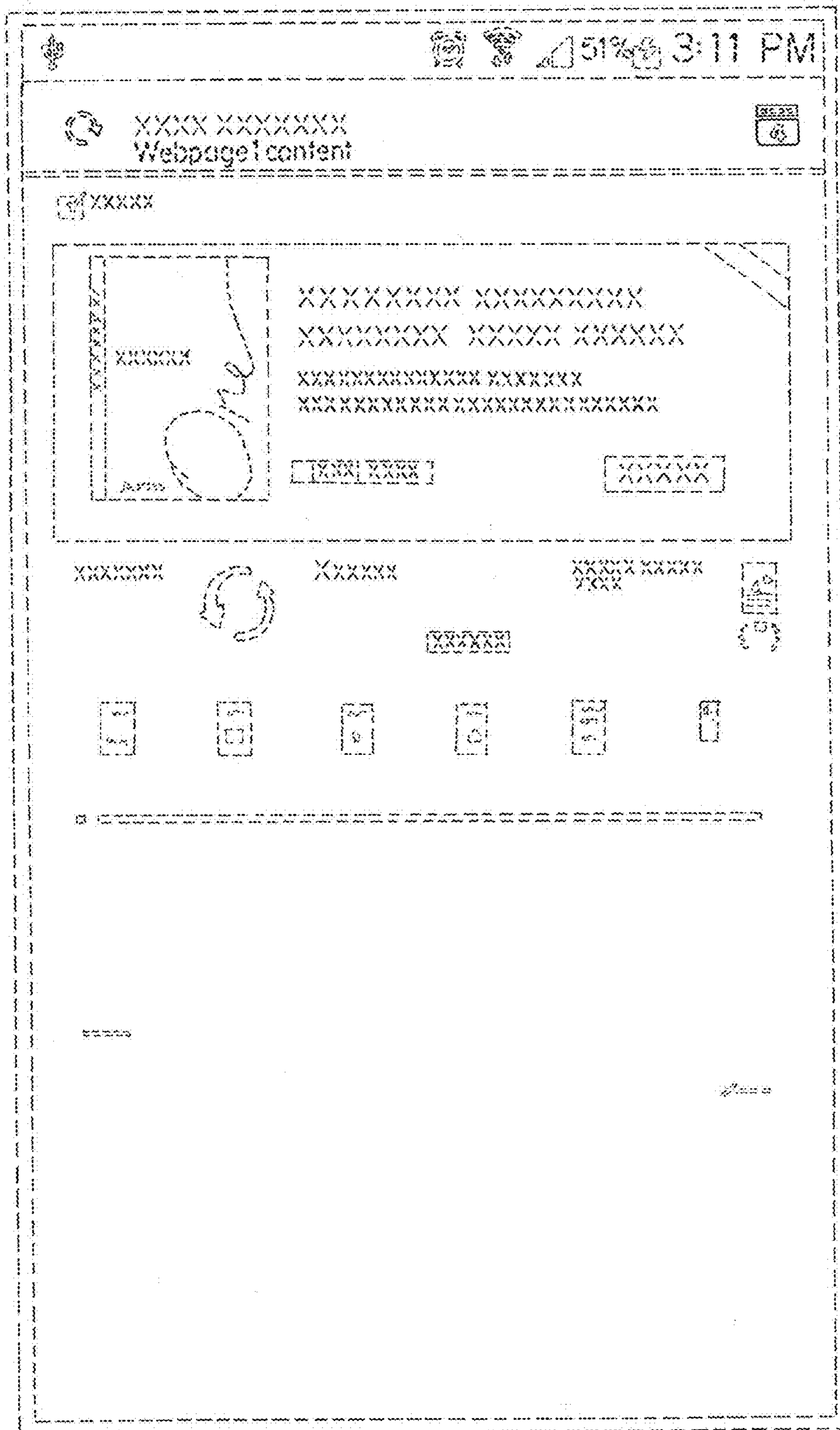

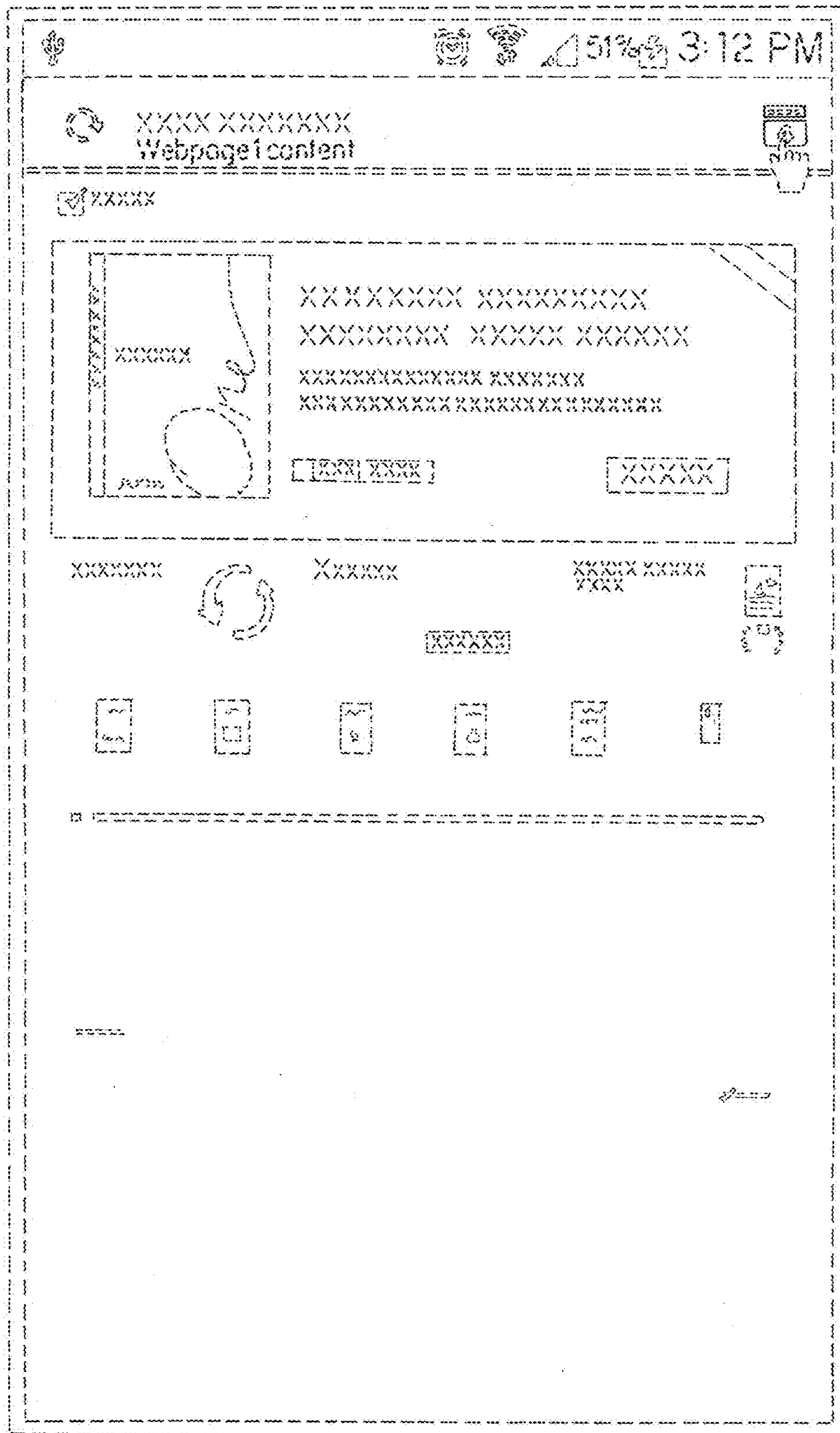

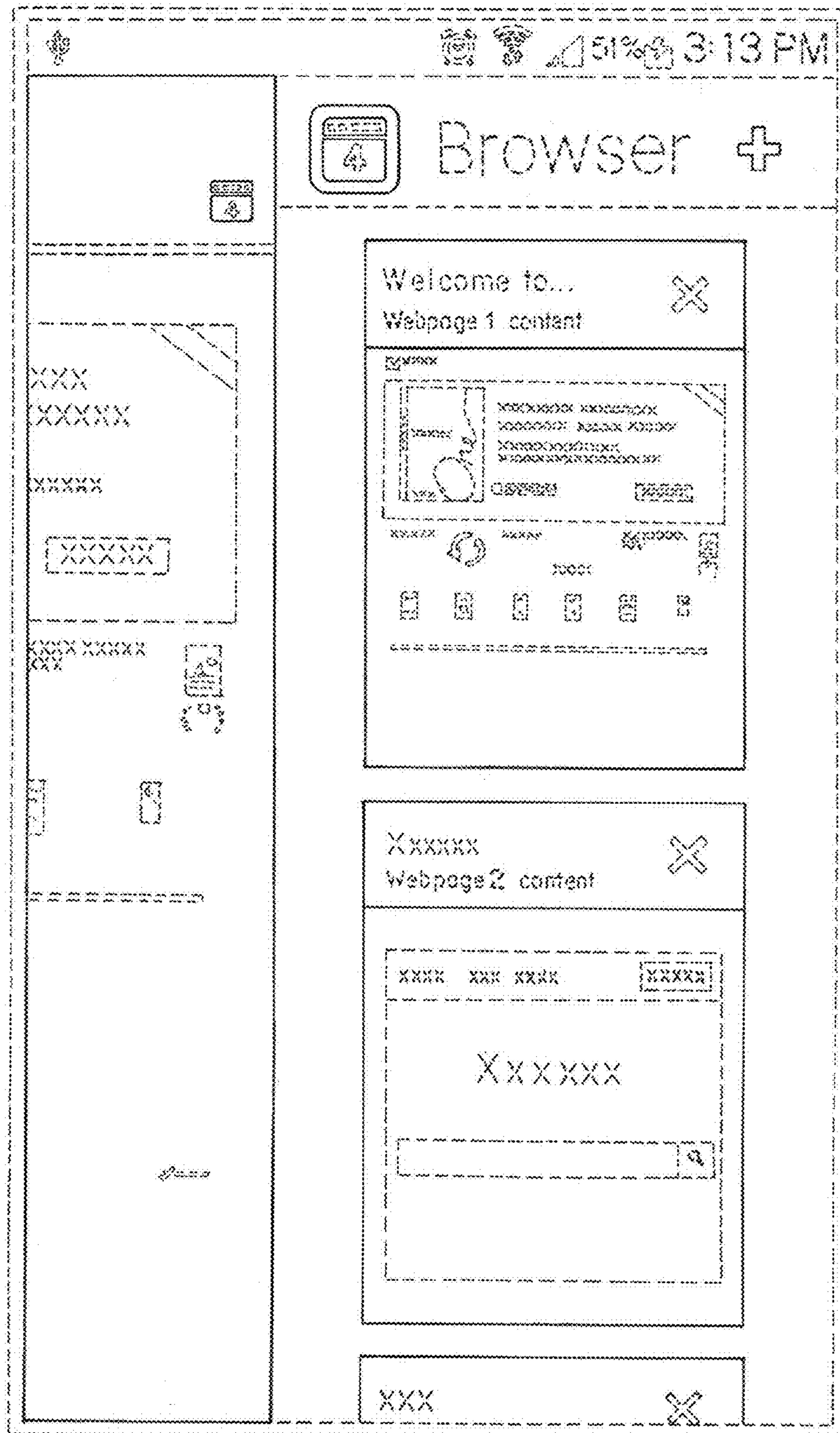

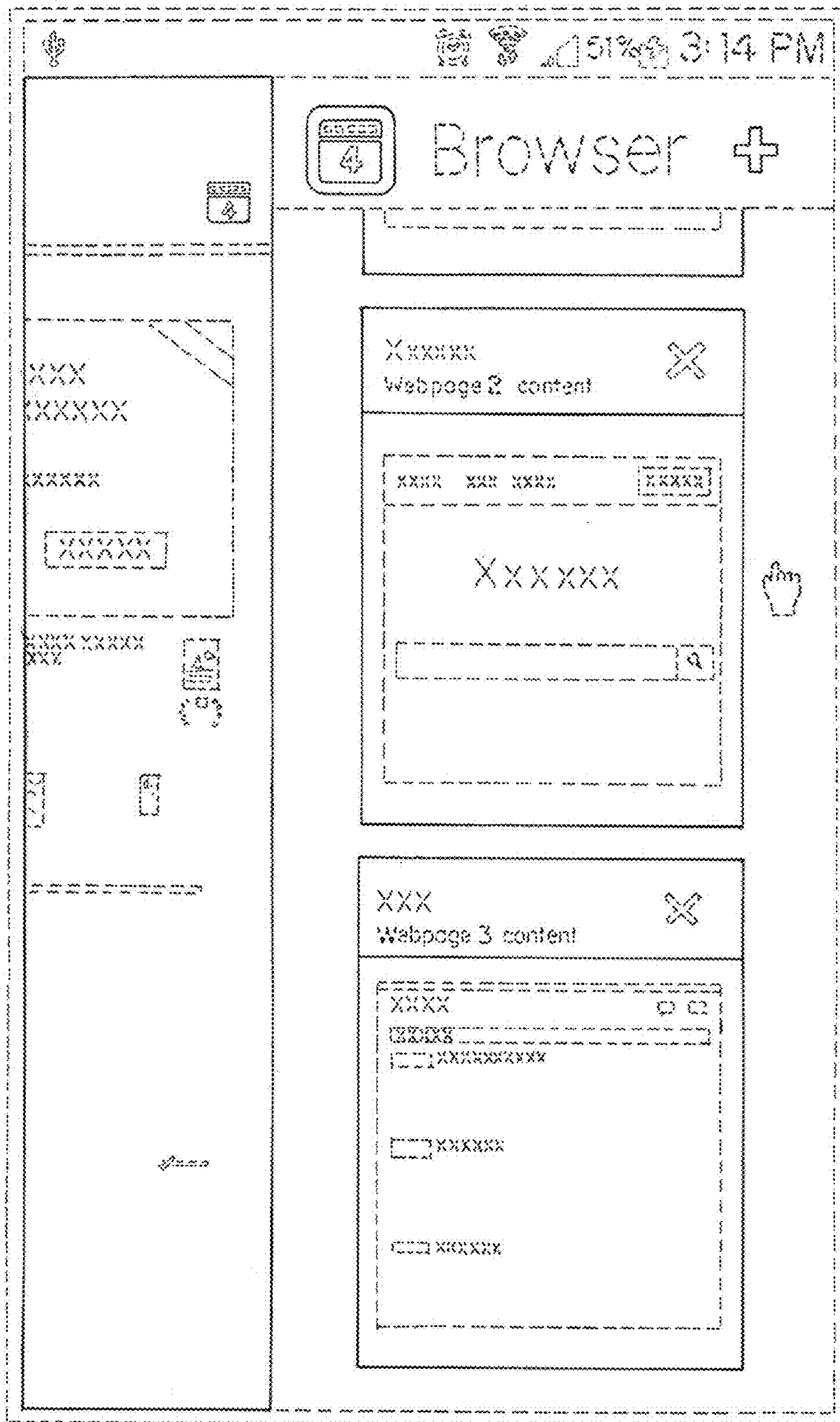

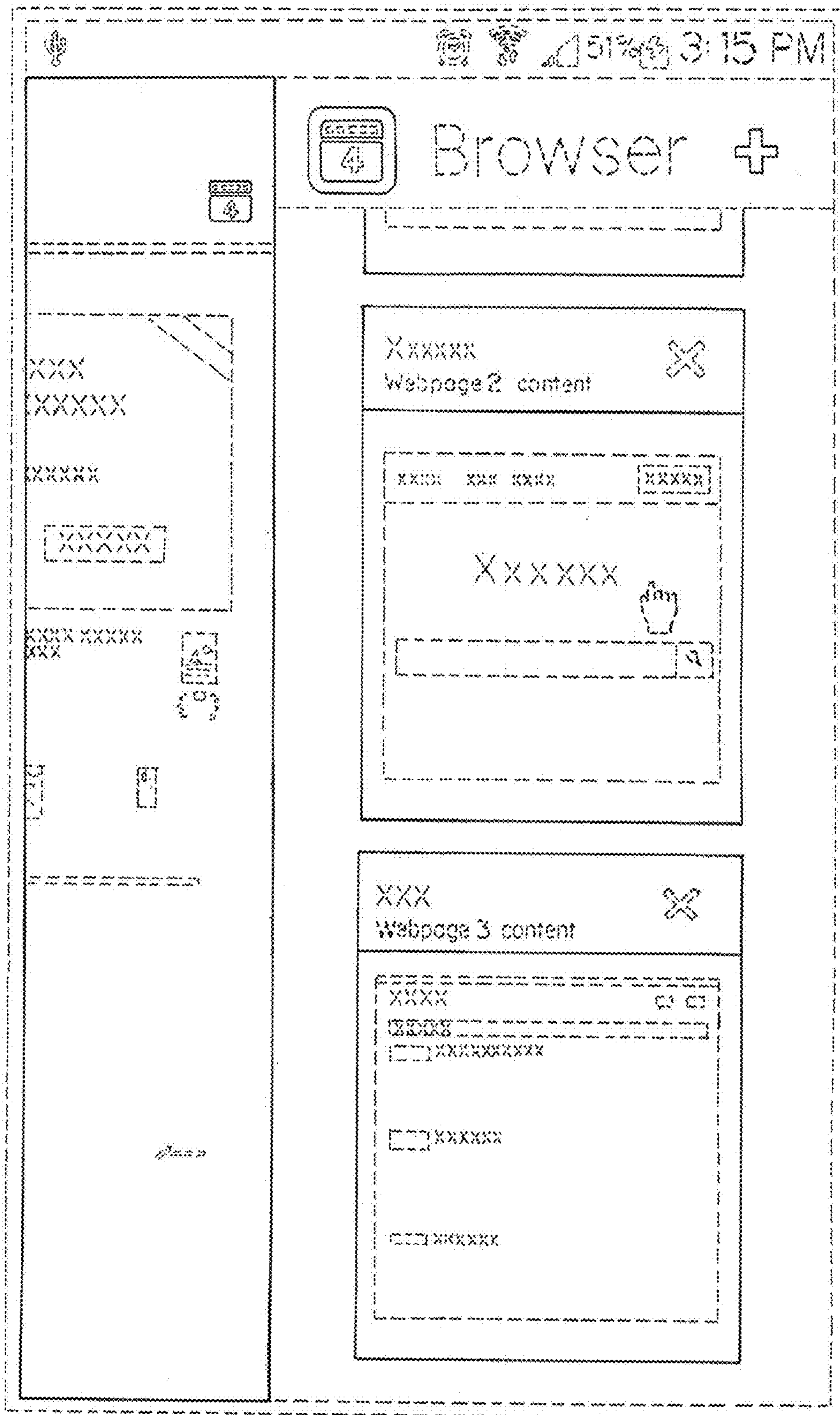

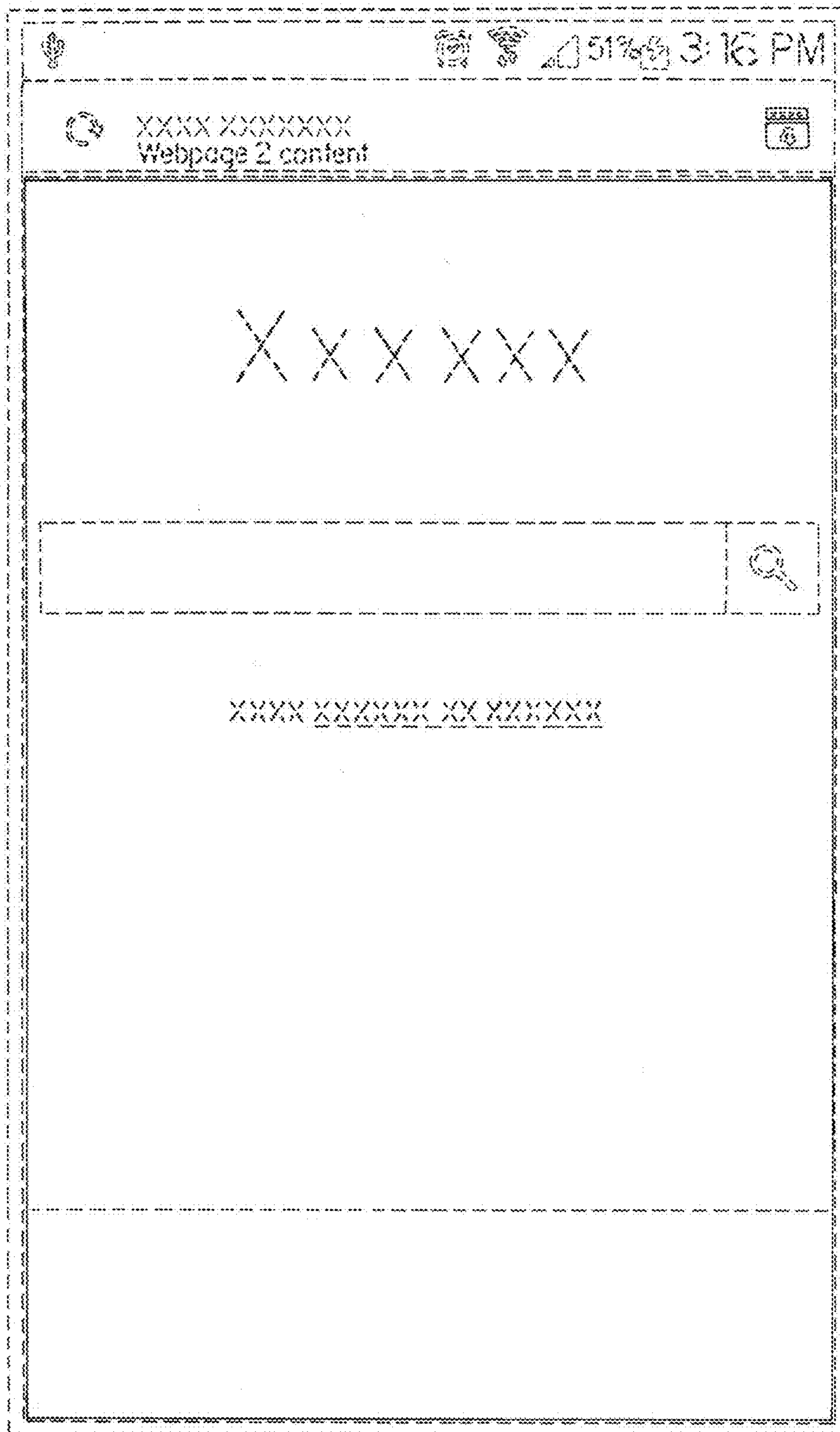
