DESCRIPTION

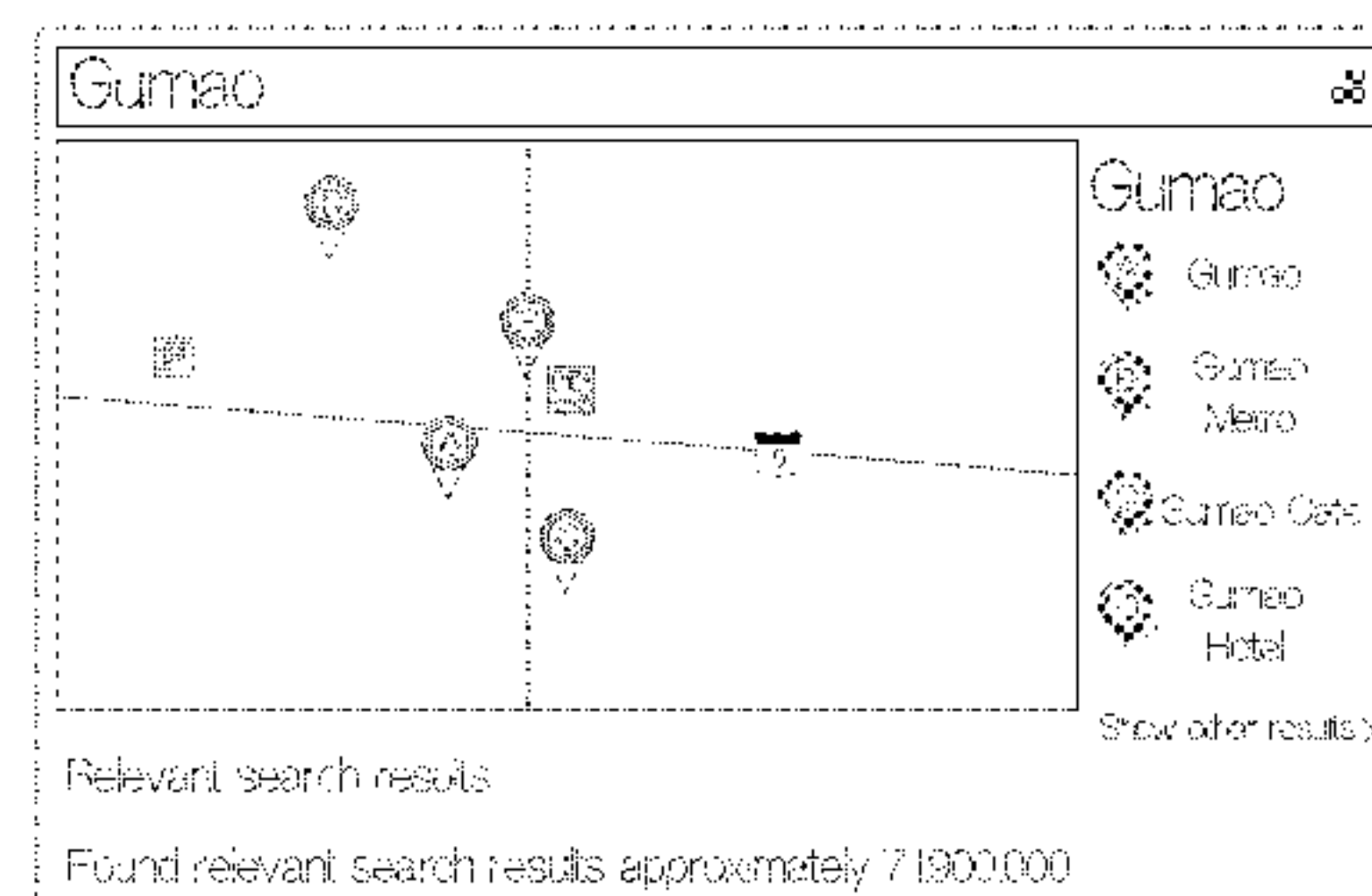
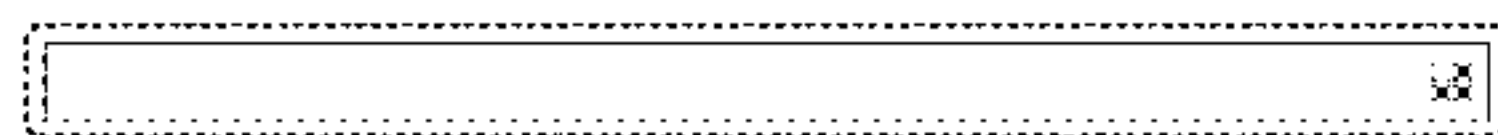
FIG. 1 is a first image in a sequence for a display screen with animated graphical user interface showing our new design; and,

FIG. 2 is a second image thereof.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1 and 2. The process or period in which one image transitions to another image forms no part of the claimed design.

The broken lines shown in FIGS. 1 and 2 represent portions of the display screen with animated graphical user interface that form no part of the claimed design.

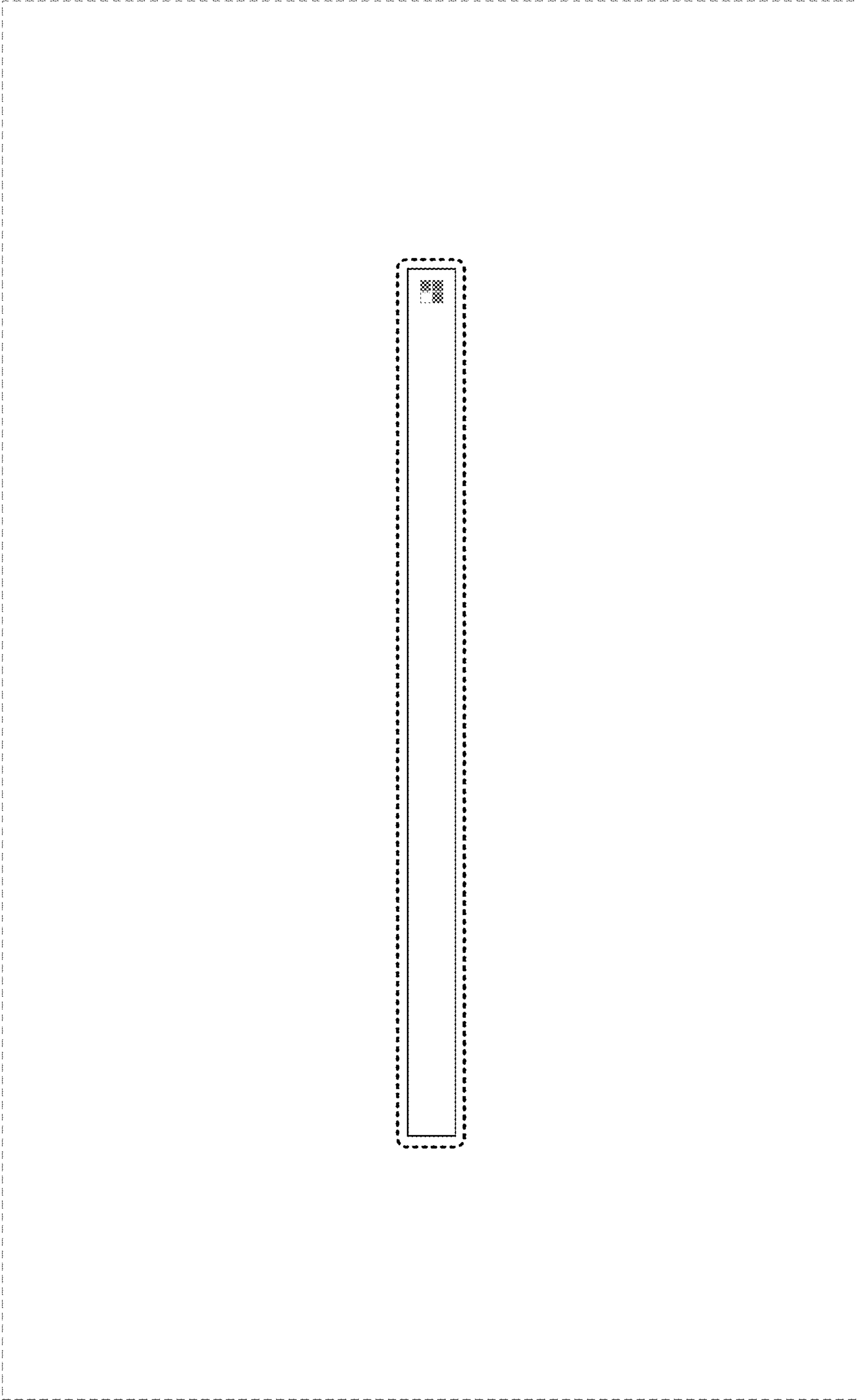

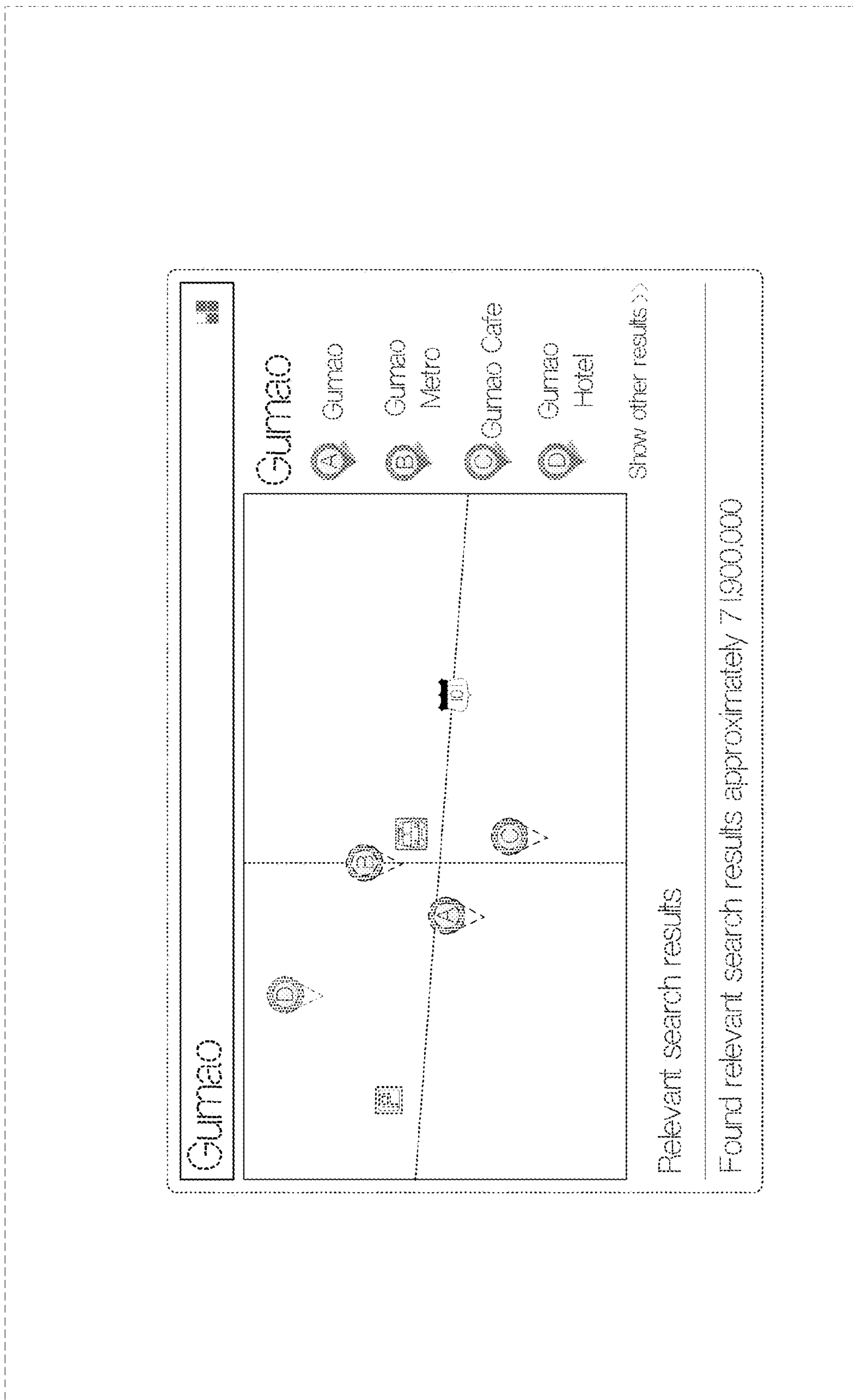
