(57) **CLAIM**

The ornamental design for a bird foam hand character, as shown and described in FIGS. 1-8.

DESCRIPTION

FIG. 1 is a front perspective view of the bird foam hand character according to my new design.

FIG. 2 is a back perspective view of the bird foam hand character of FIG. 1.

FIG. 3 is a front view of the bird foam hand character of FIGS. 1-2.

FIG. 4 is a back view of the bird foam hand character of FIGS. 1-2.

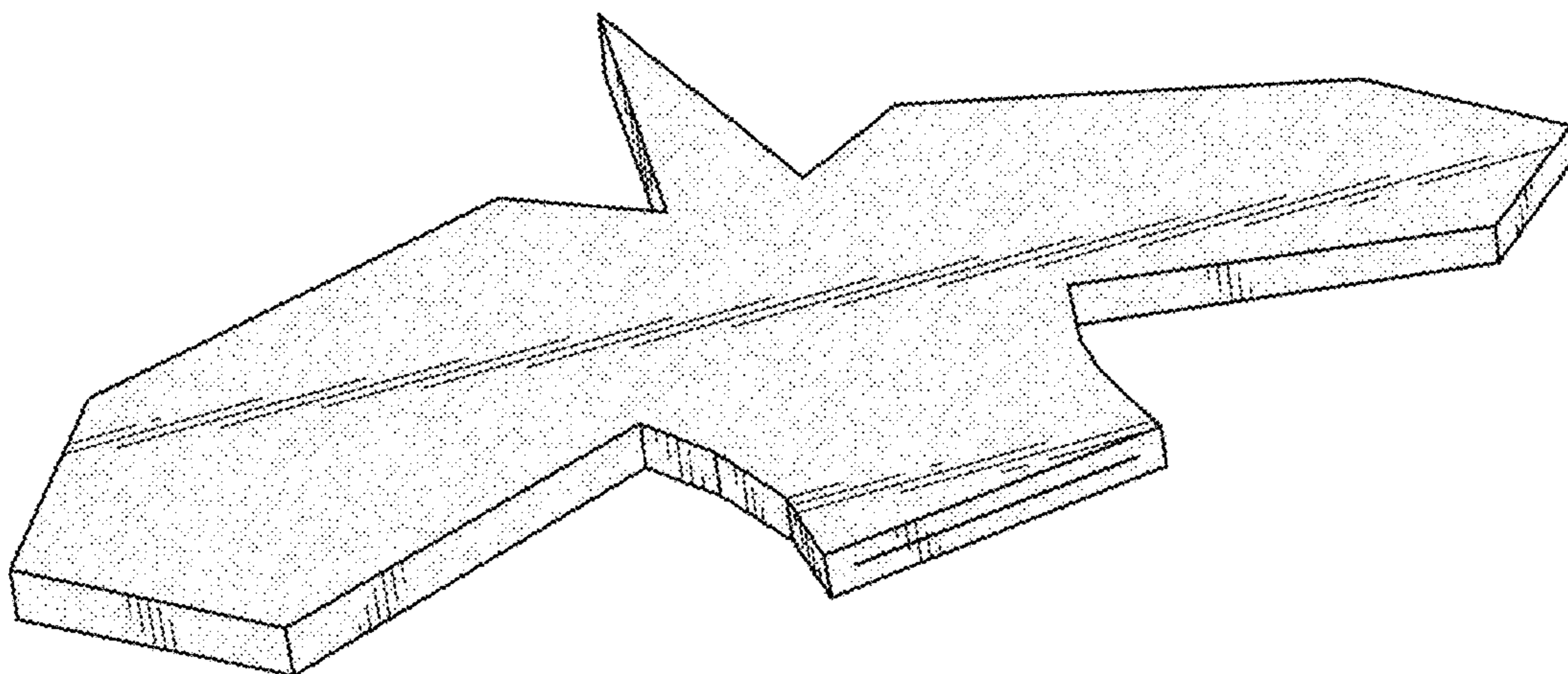
FIG. 5 is an enlarged top end of the bird foam hand character as in FIG. 1.

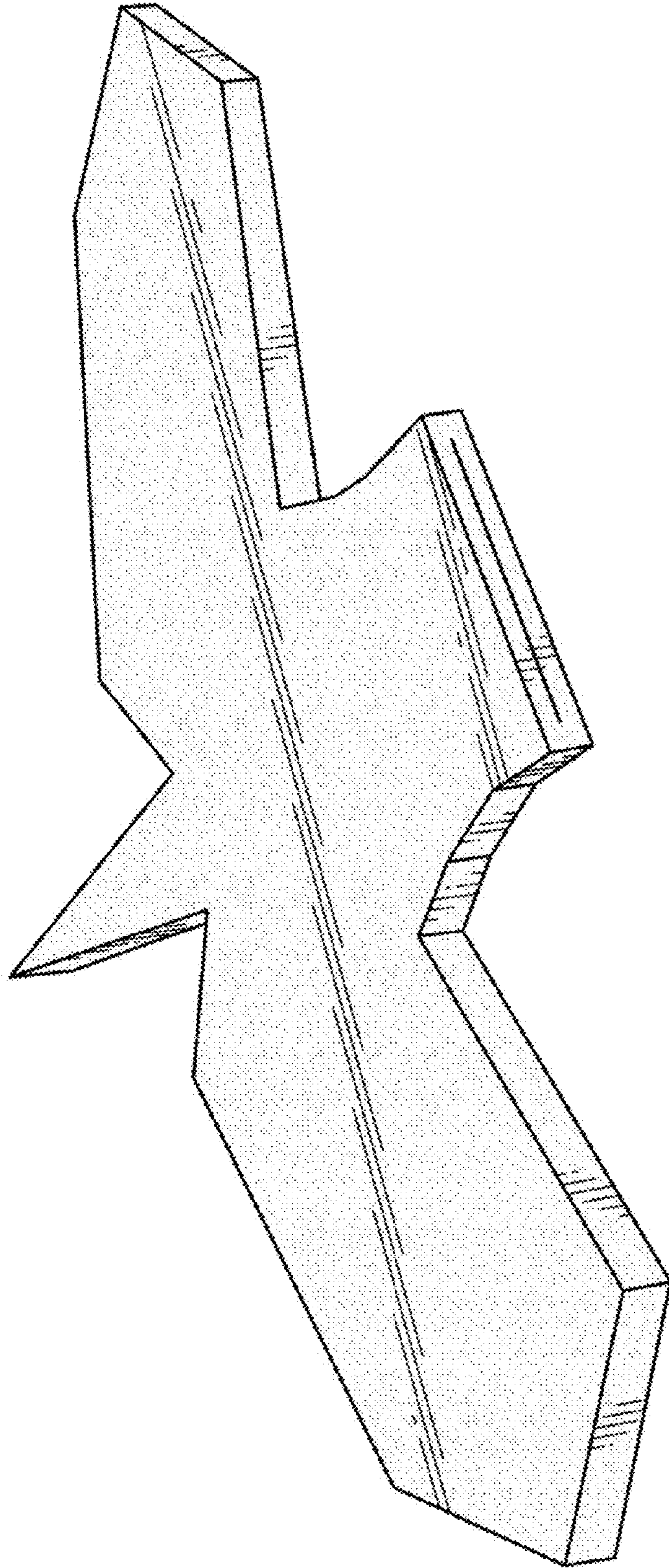

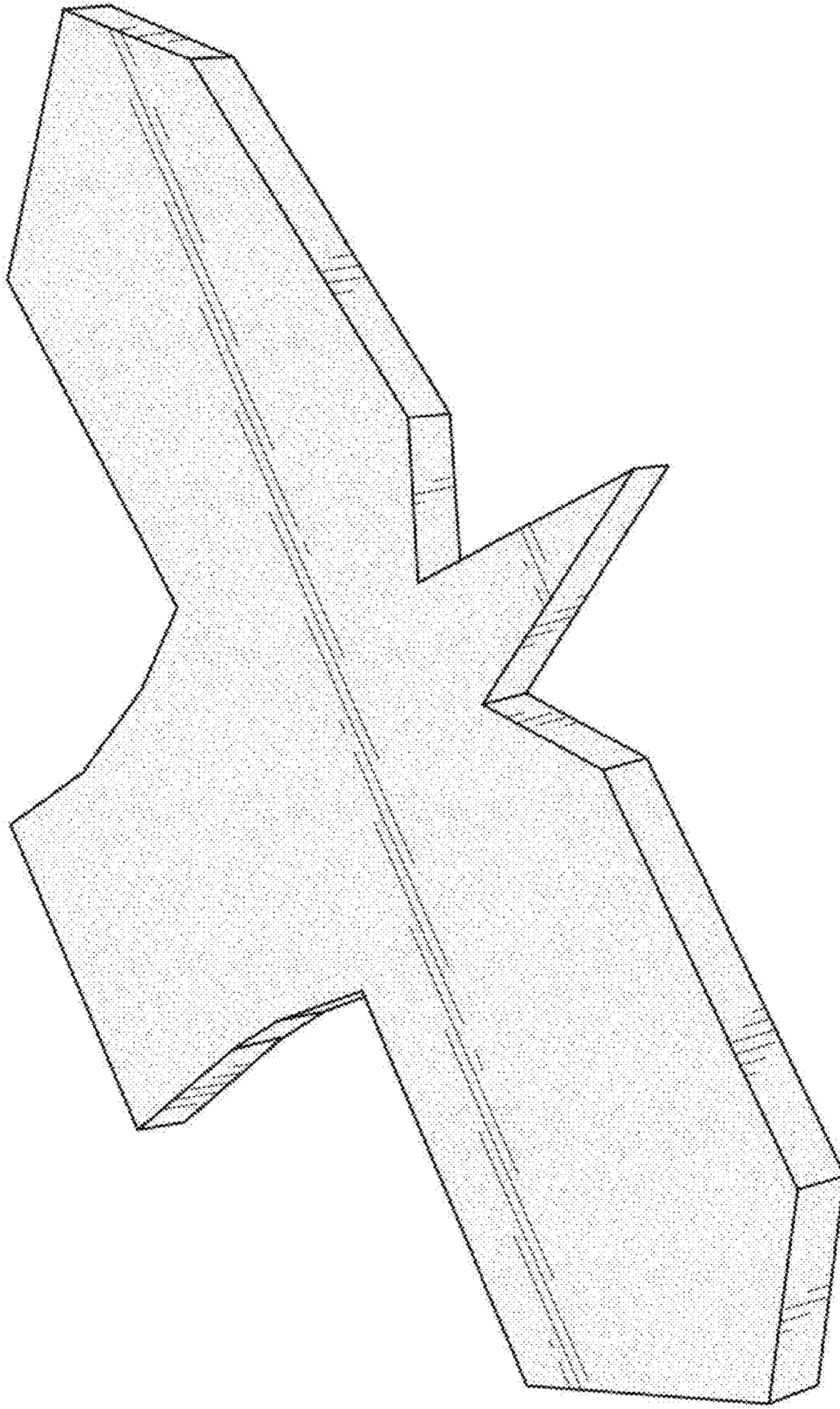
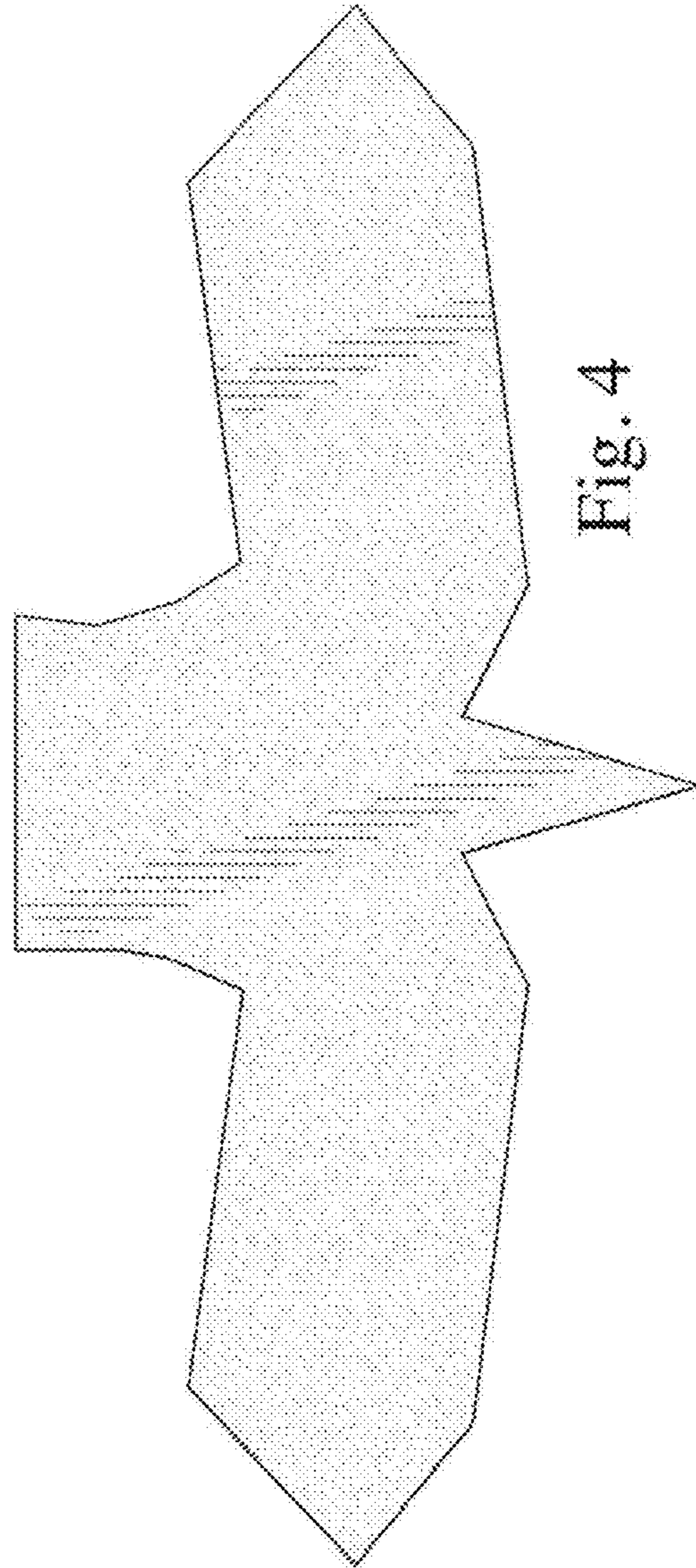
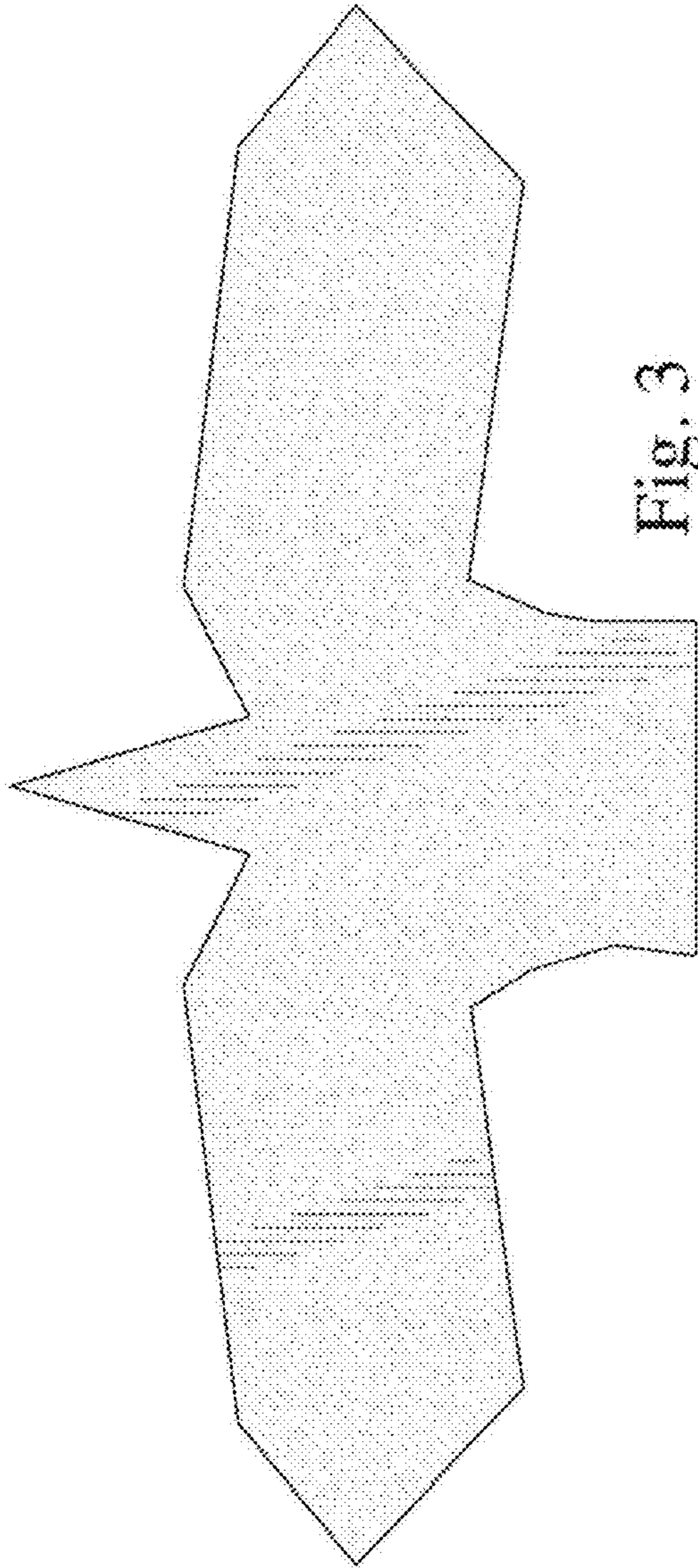

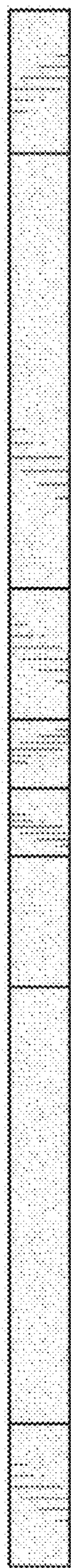

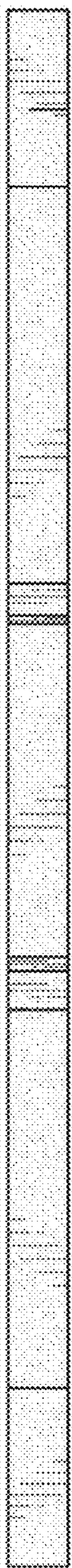
