(57) **CLAIM**

We claim the ornamental design for an golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf club head, as viewed from the toe and front sides, according to an embodiment of the design.

FIG. 2 is a front elevation view of the golf club head of FIG. 1.

FIG. 3 is a rear elevation view of the golf club head of FIG. 1. FIG. 4 is a side elevation view from a toe side of the golf club head of FIG. 1.

FIG. 5 is a side elevation view from an opposite heel side of the golf club head of FIG. 1.

FIG. 6 is a top plan view of the golf club head of FIG. 1.

FIG. 7 is a bottom plan view of the golf club head of FIG. 1.

FIG. 8 is a front elevation view of a golf club head, according to a second embodiment of the design; and,

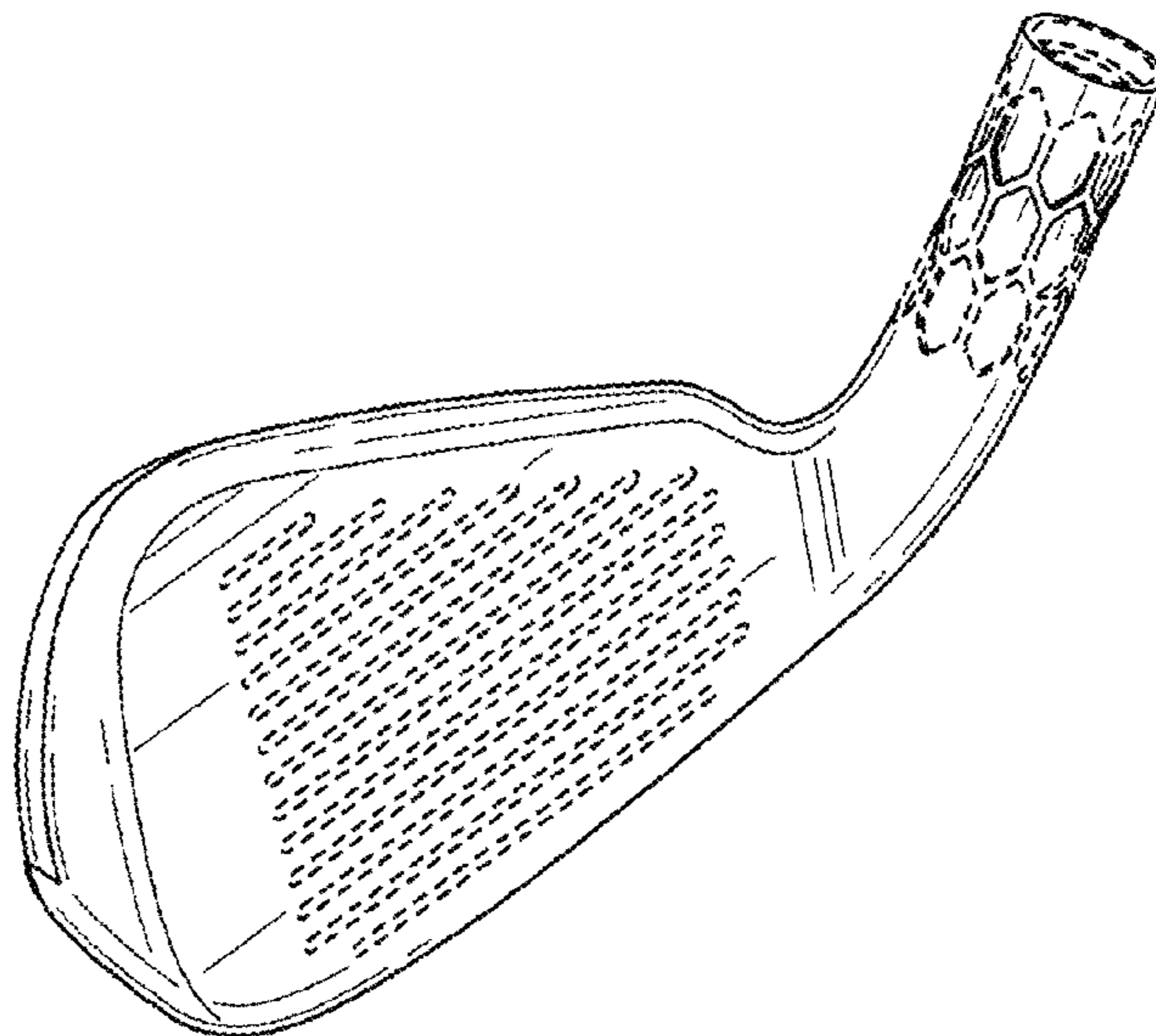
FIG. 9 is a front elevation view of a golf club head, according to a third embodiment of the design.

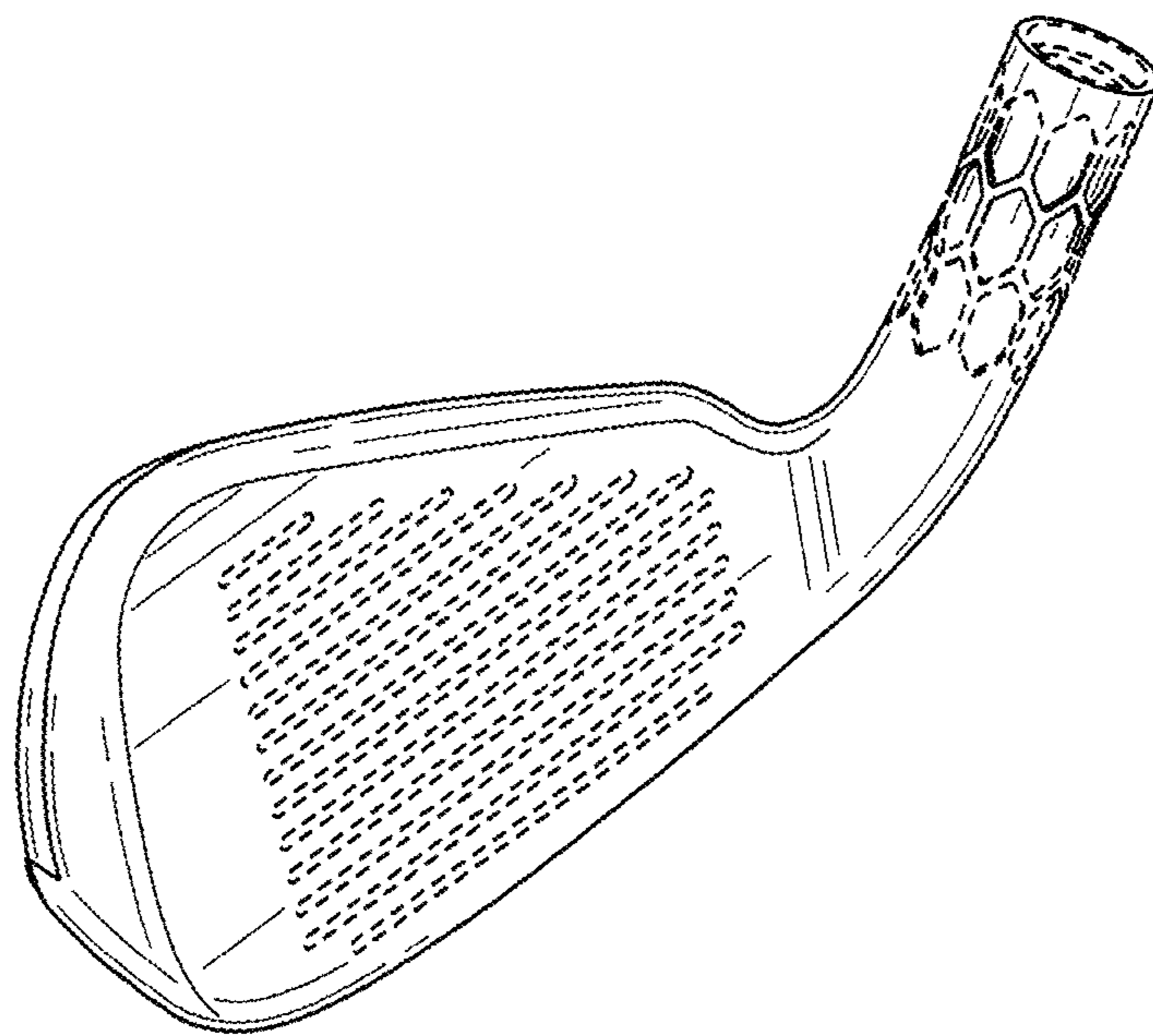

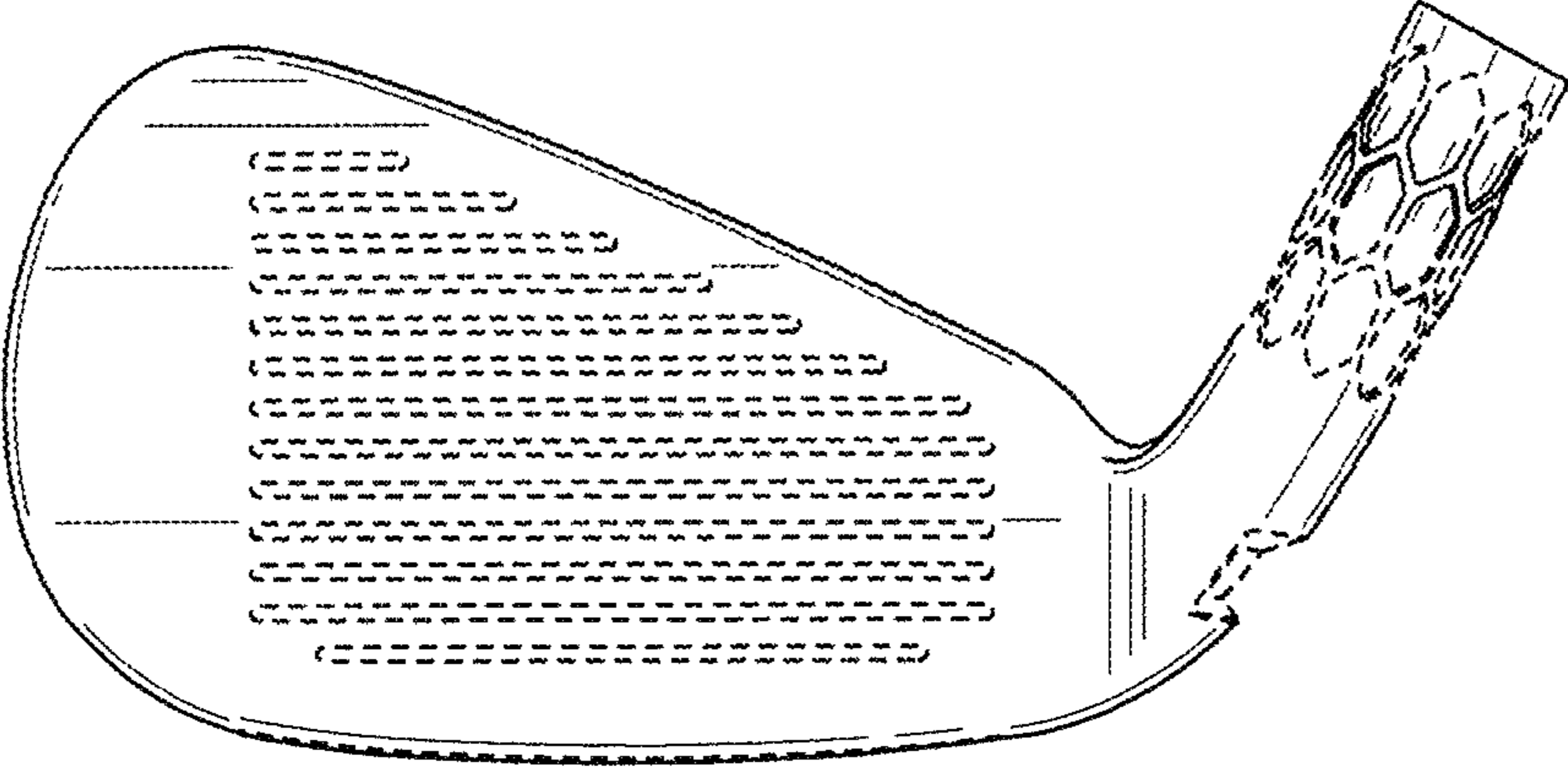

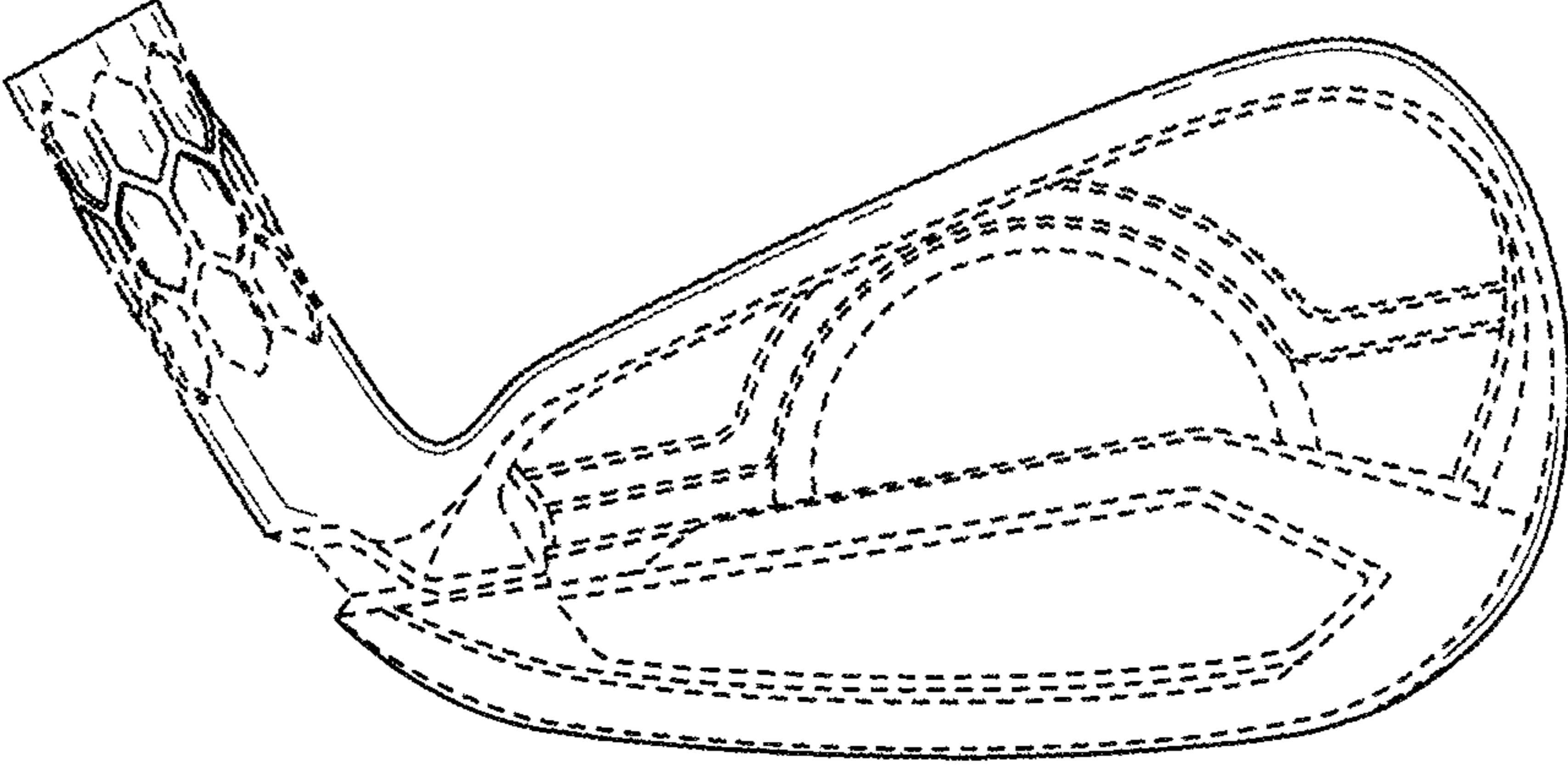

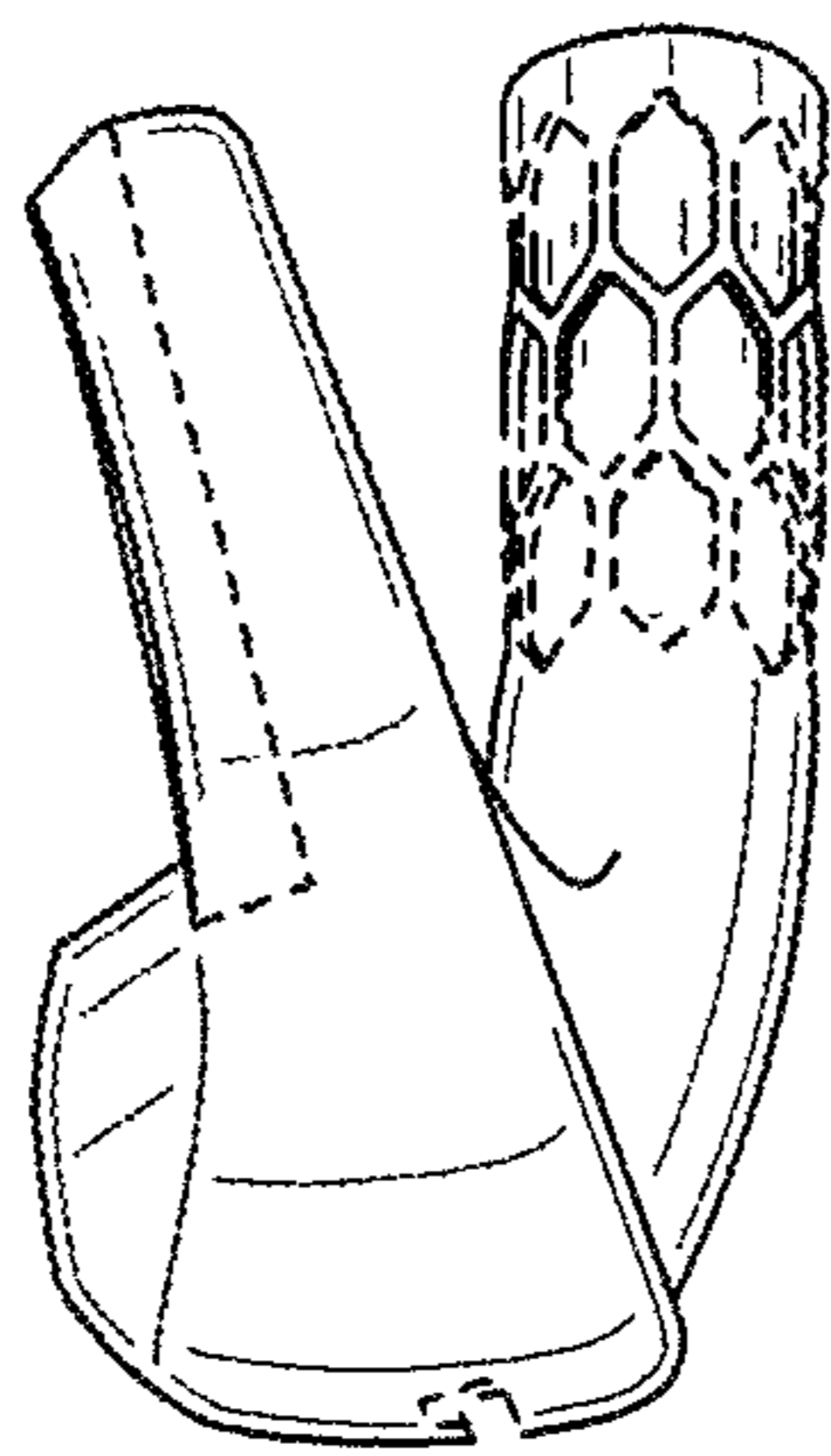

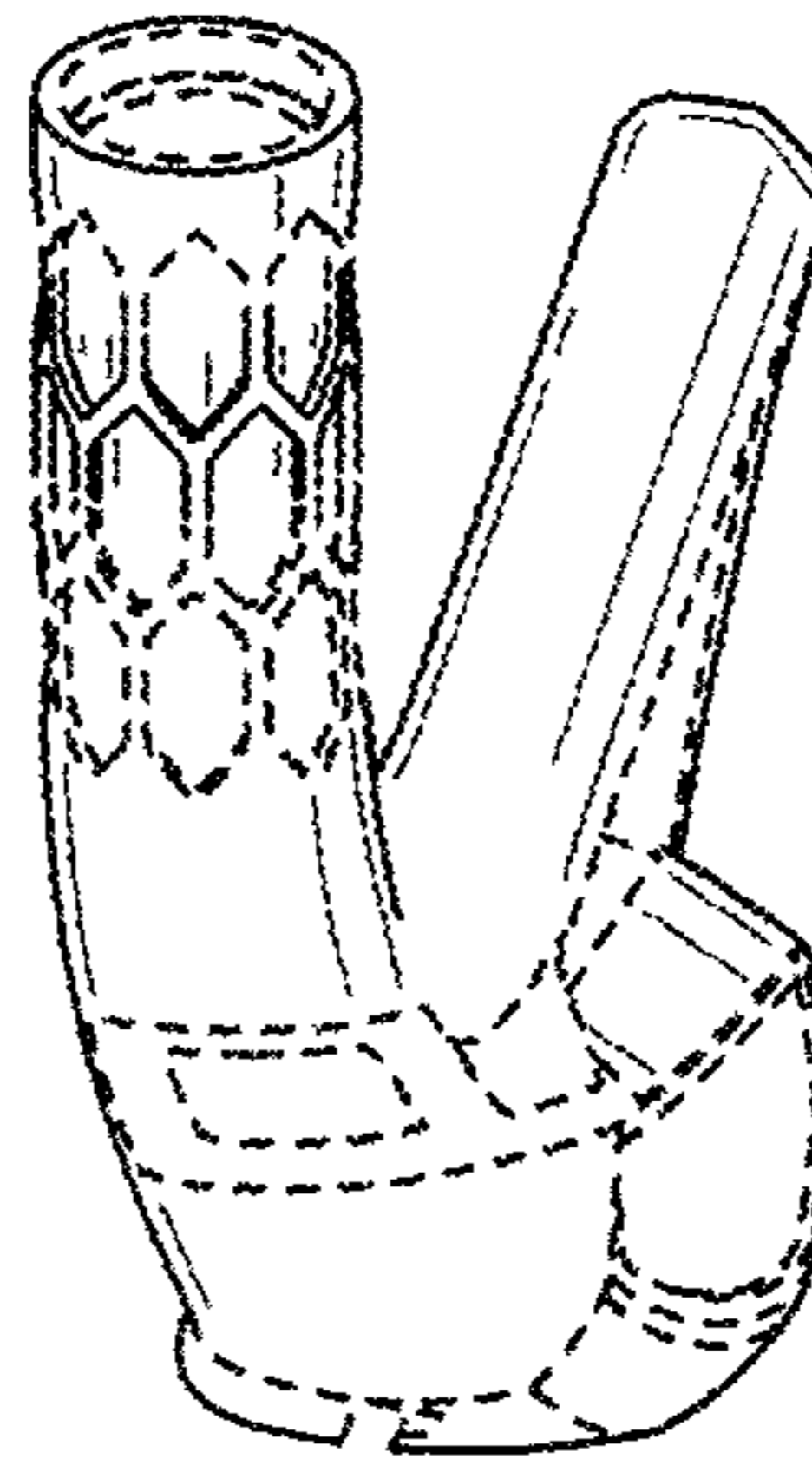

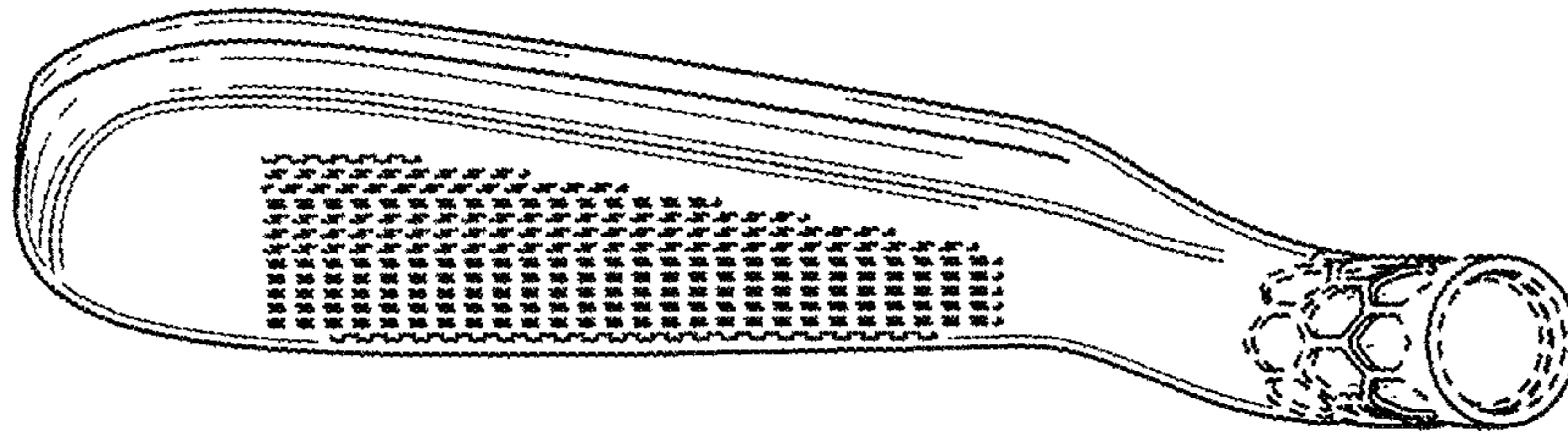

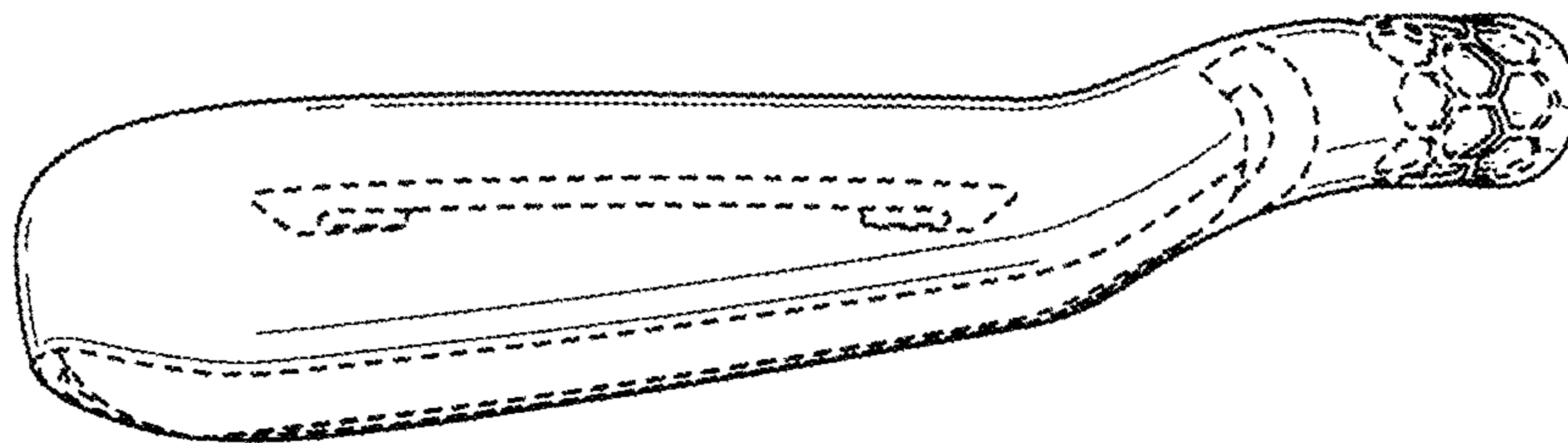

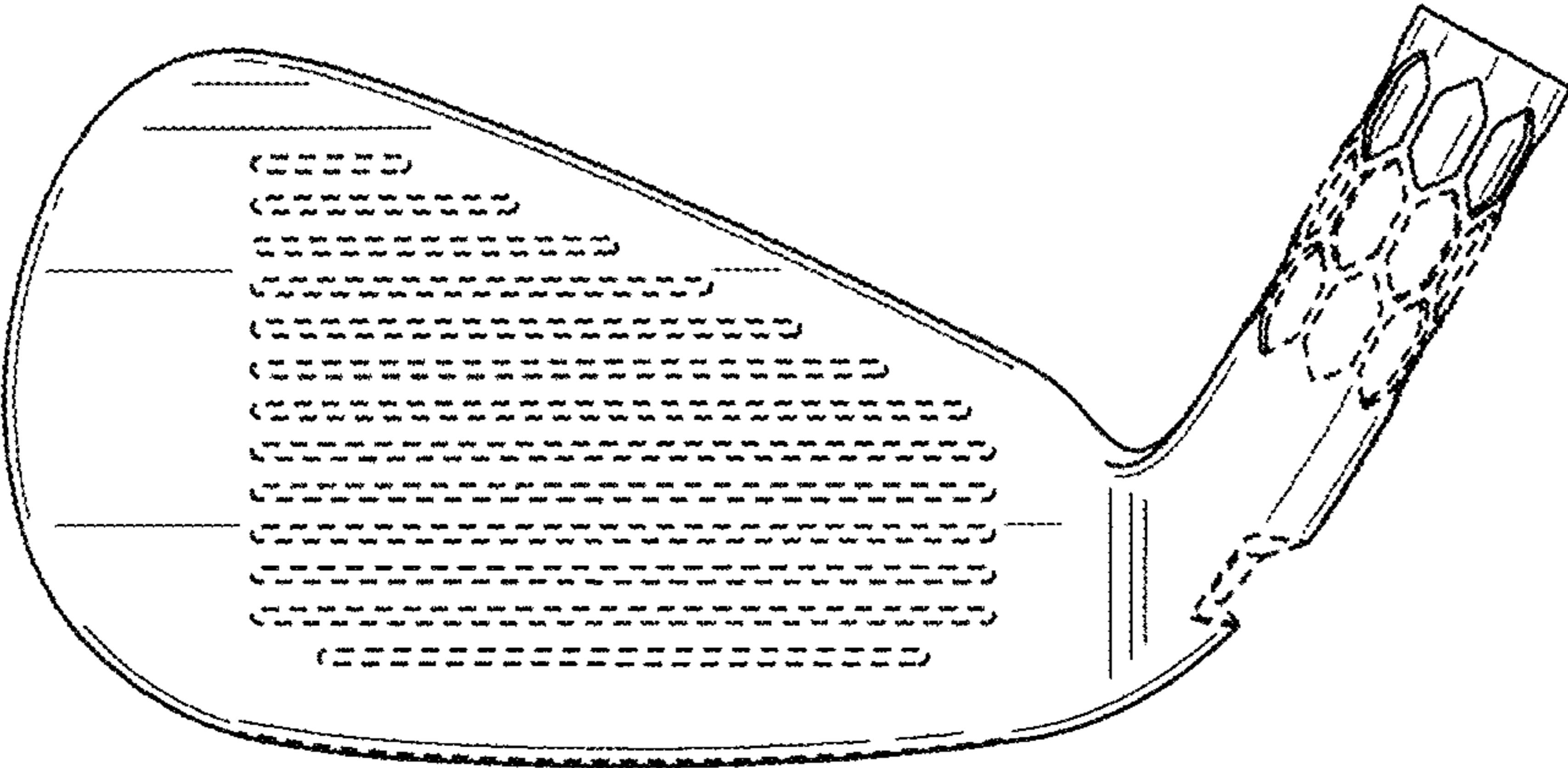

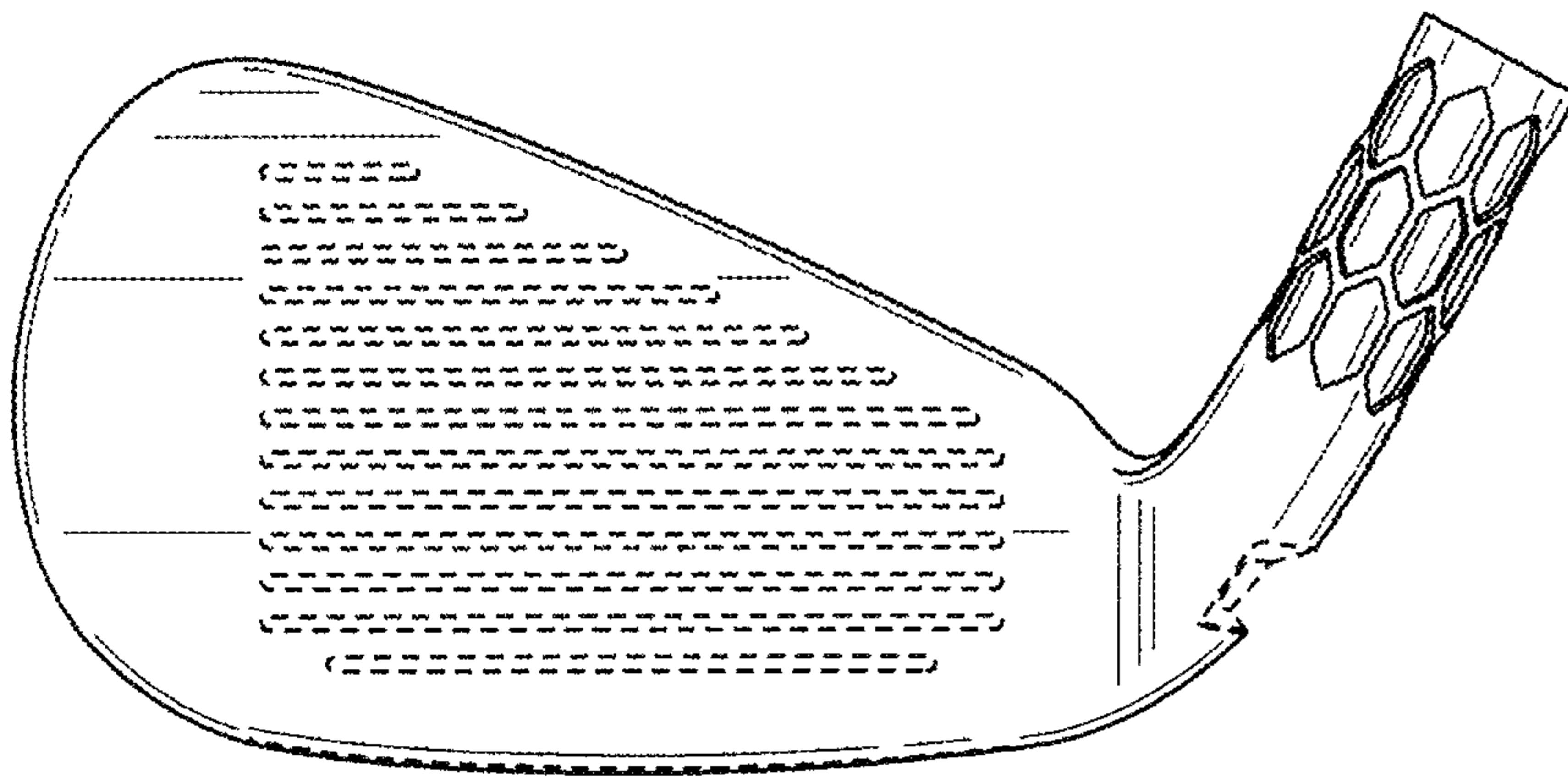
