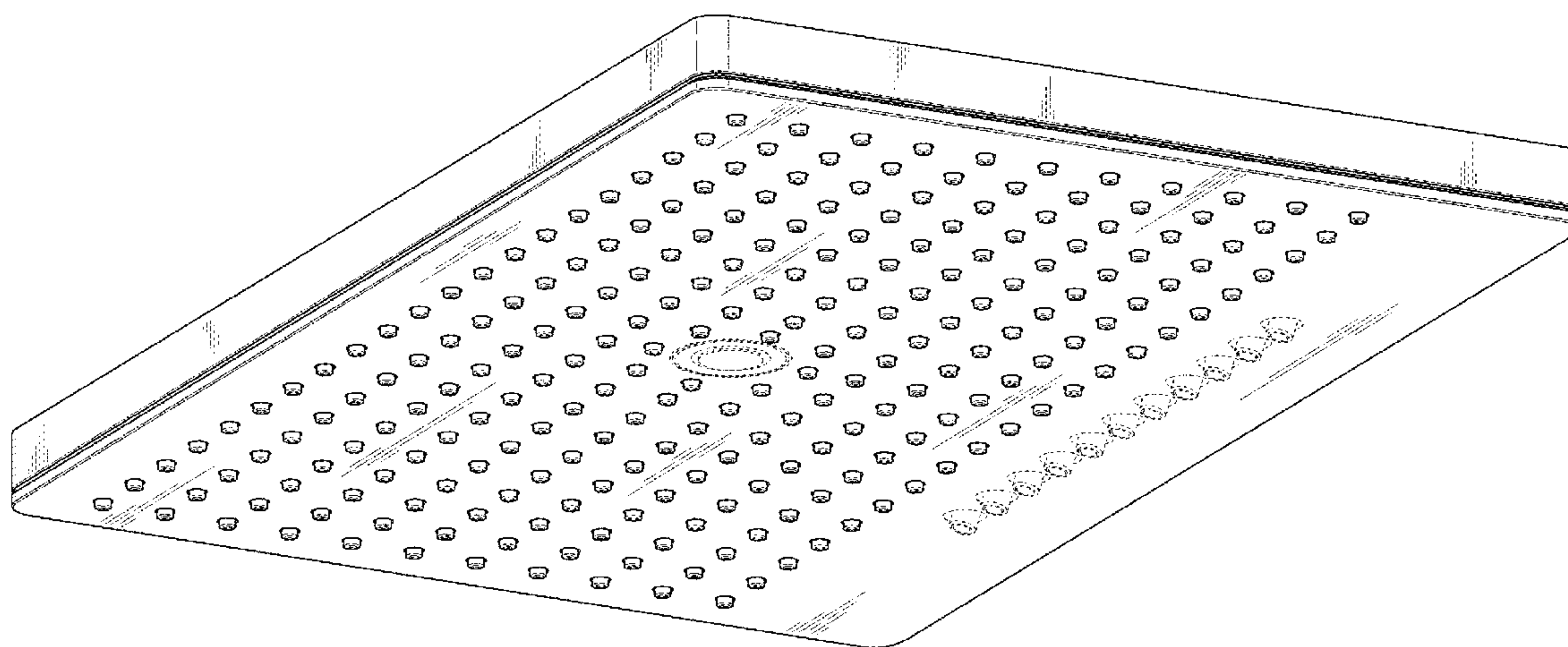
The ornamental design for an overhead shower, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an overhead shower showing our design;
FIG. 2 is a front elevation view;

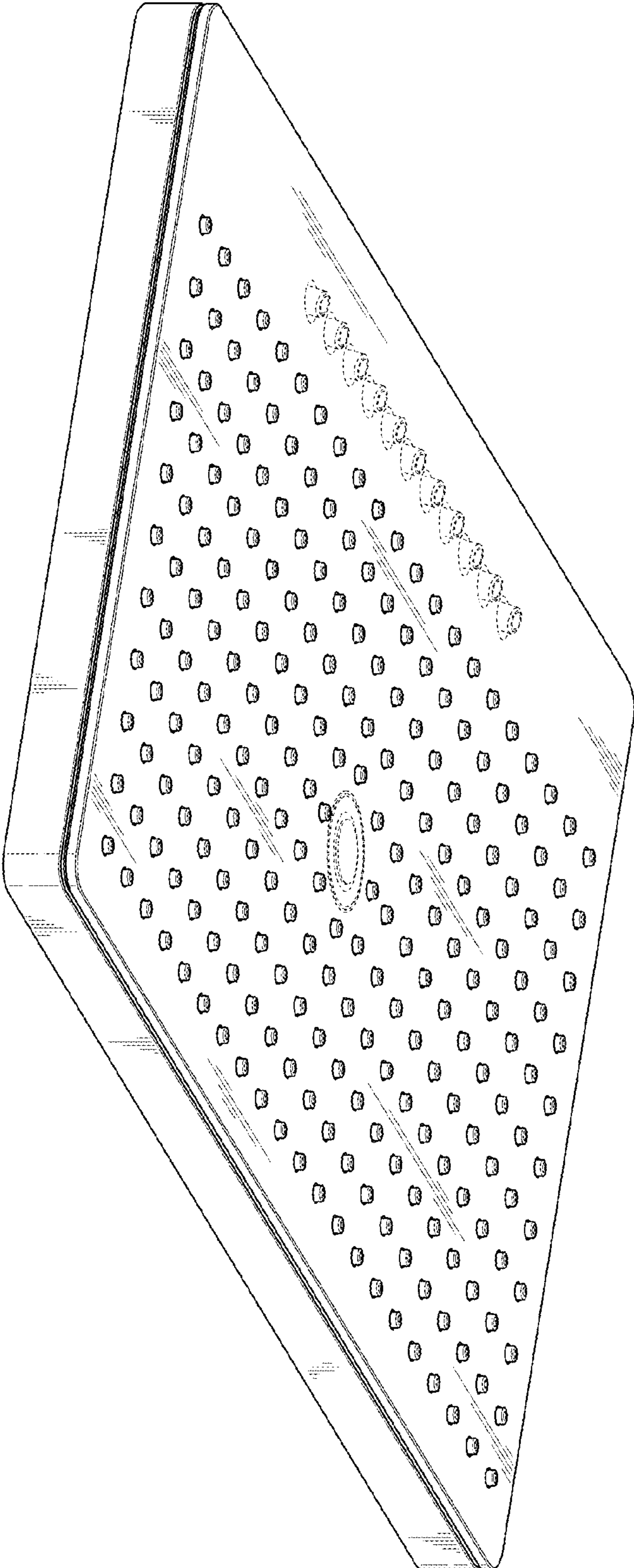

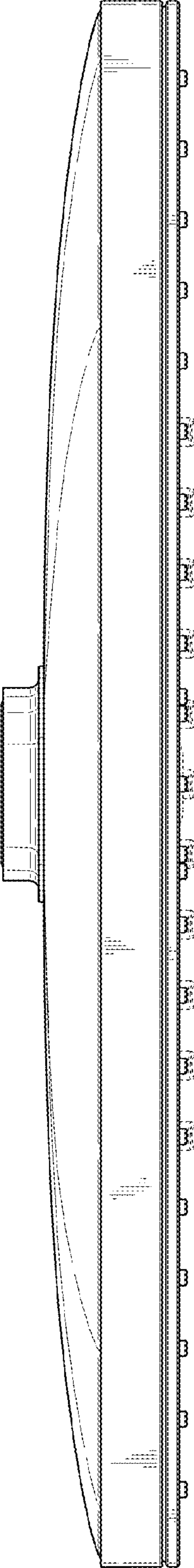
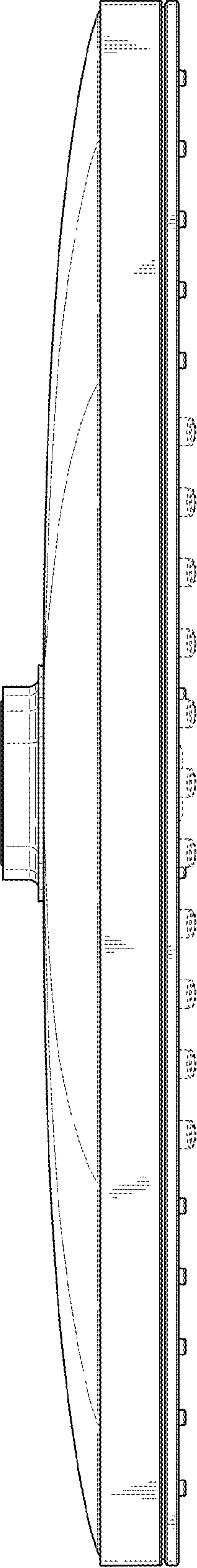

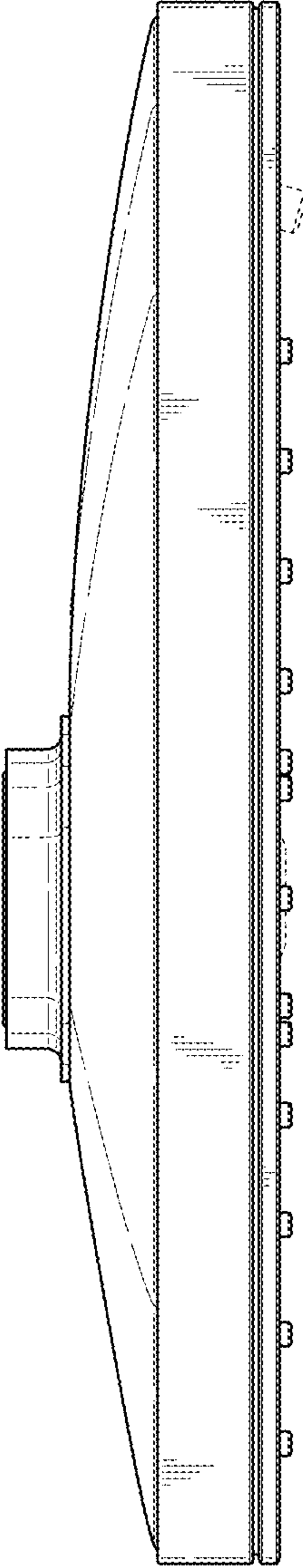
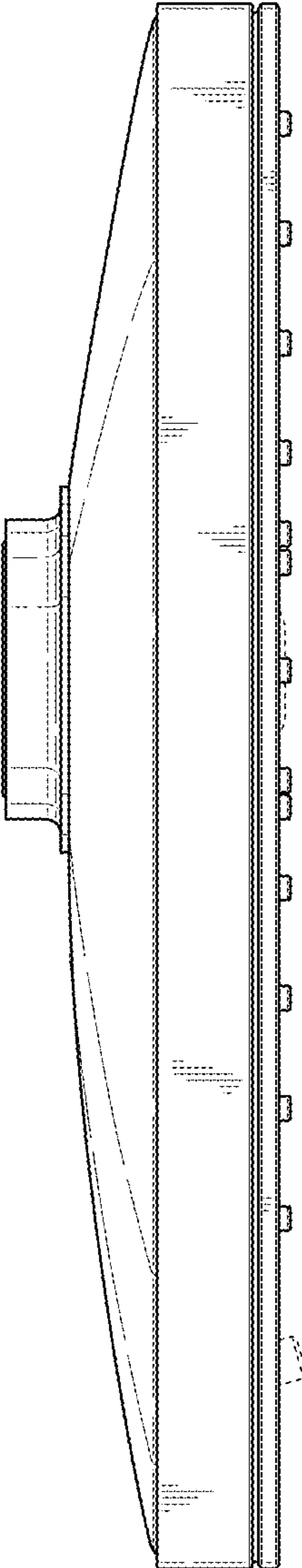

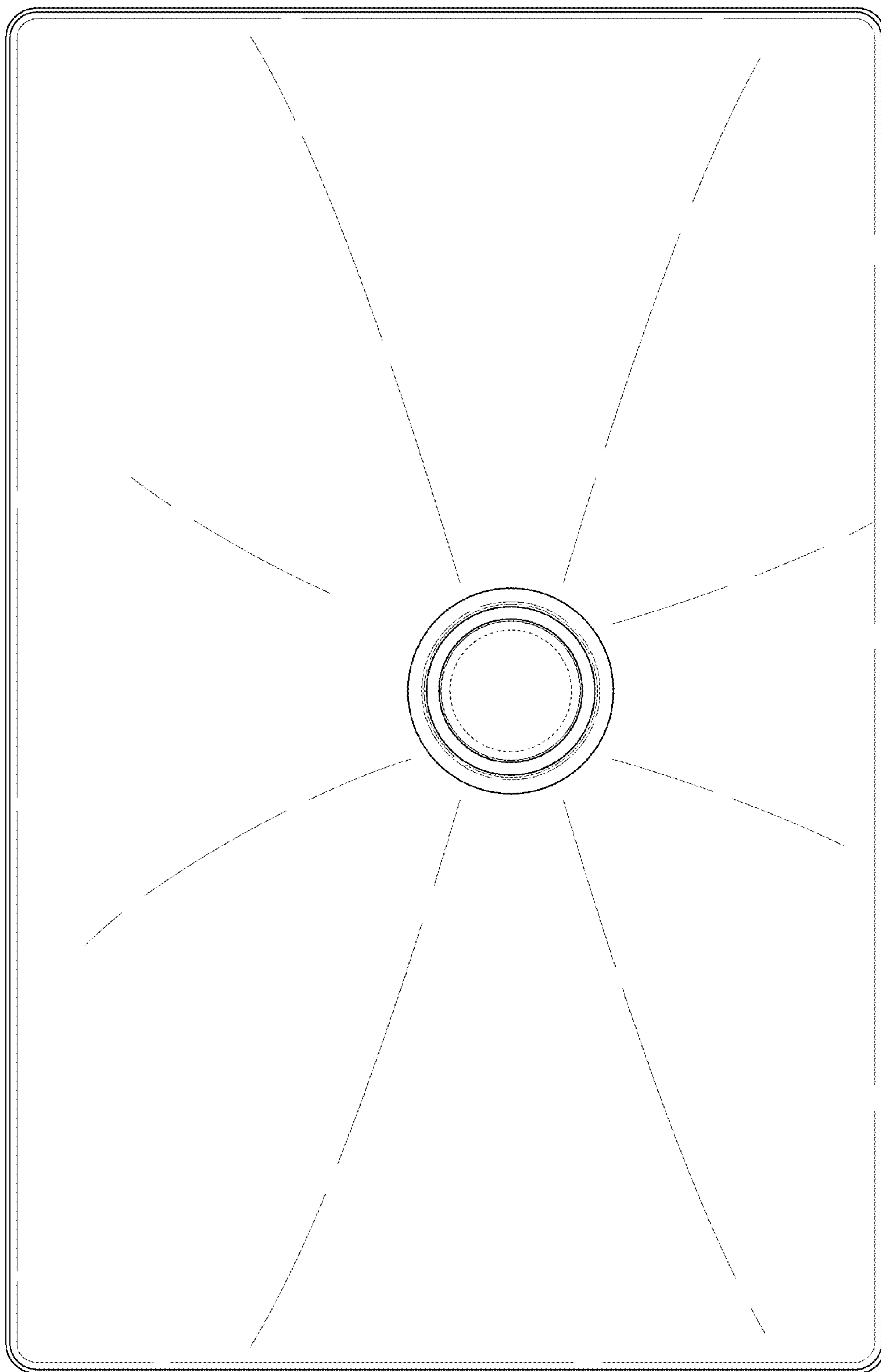

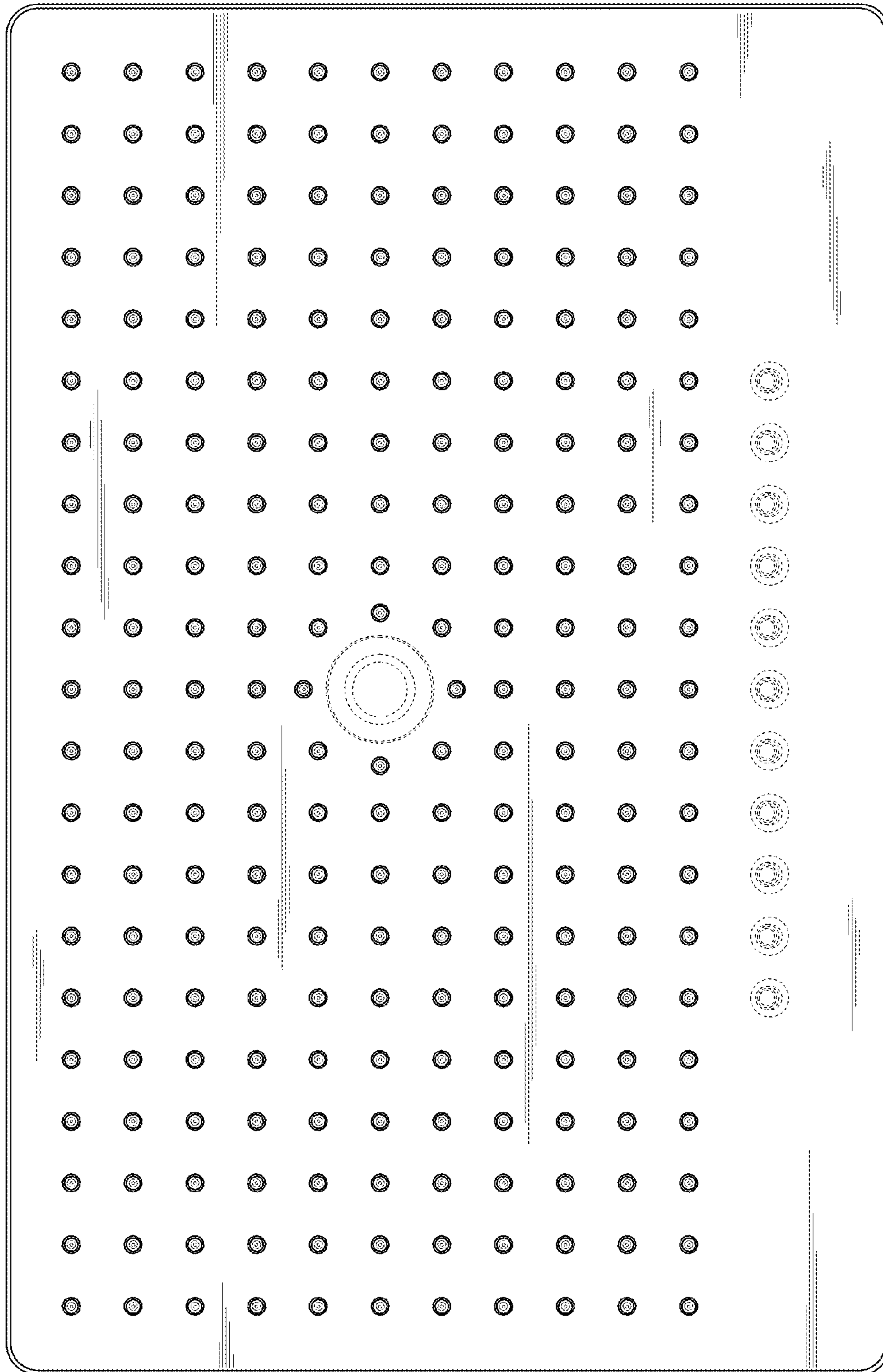
