DESCRIPTION

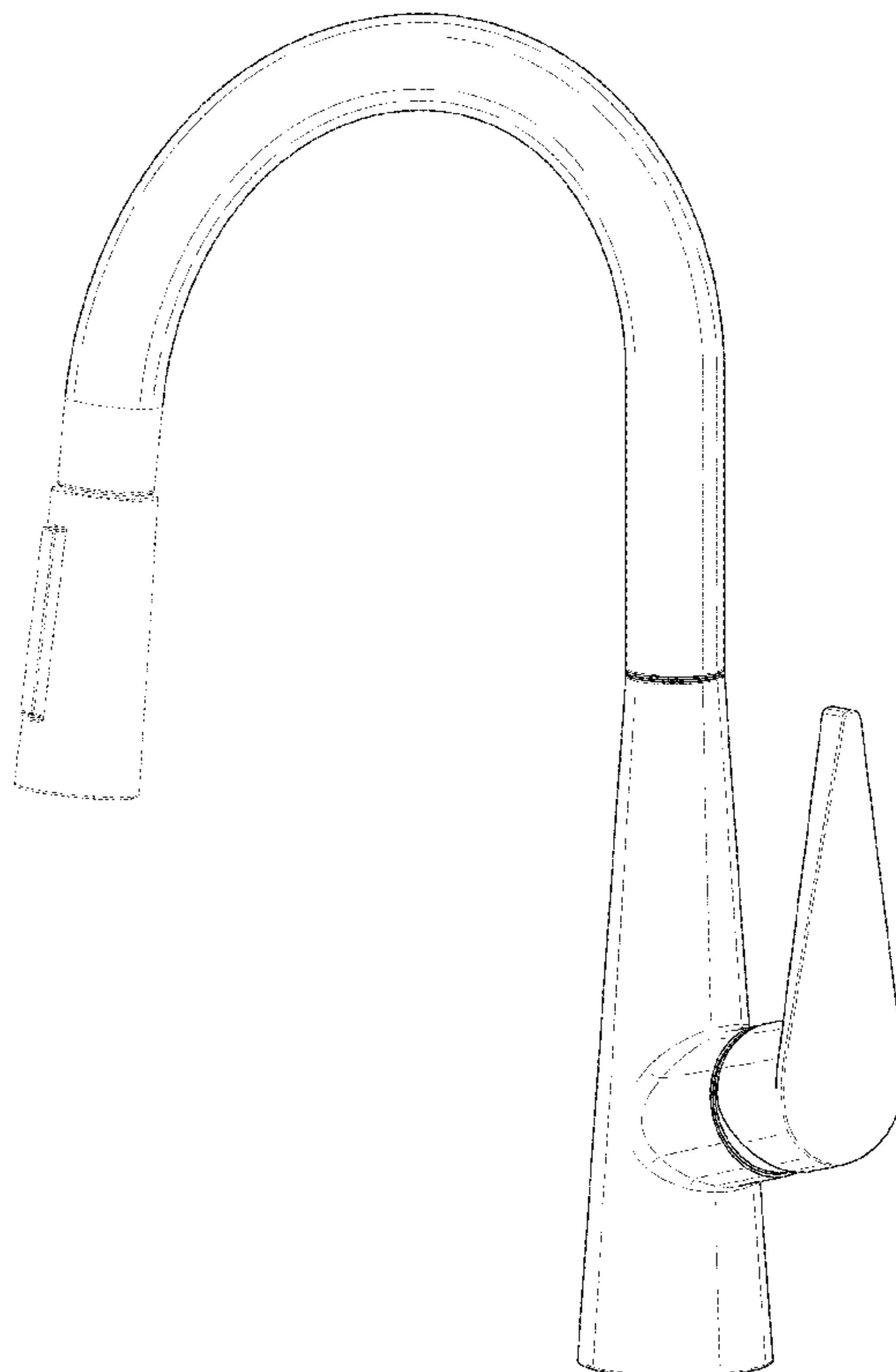

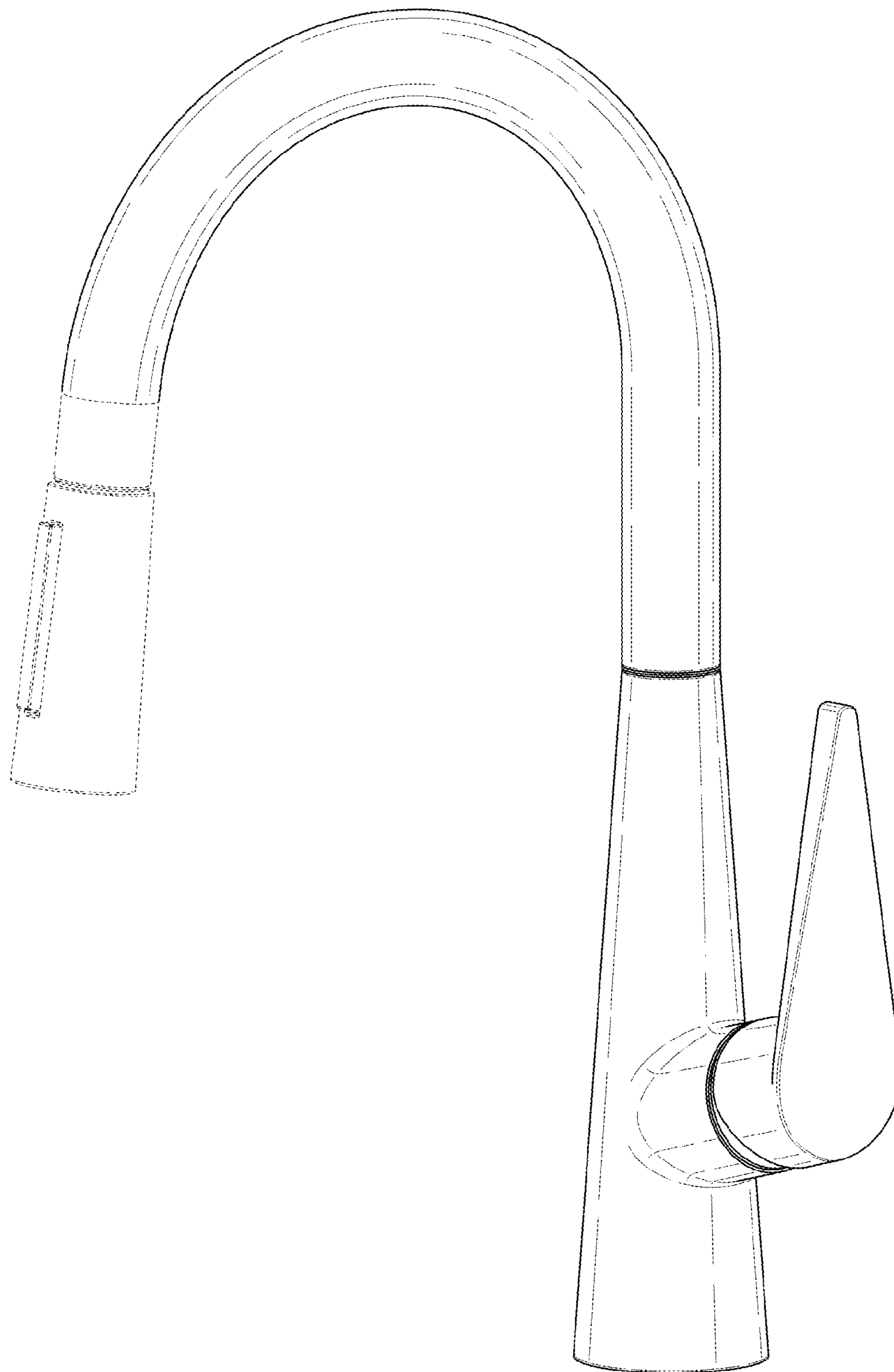

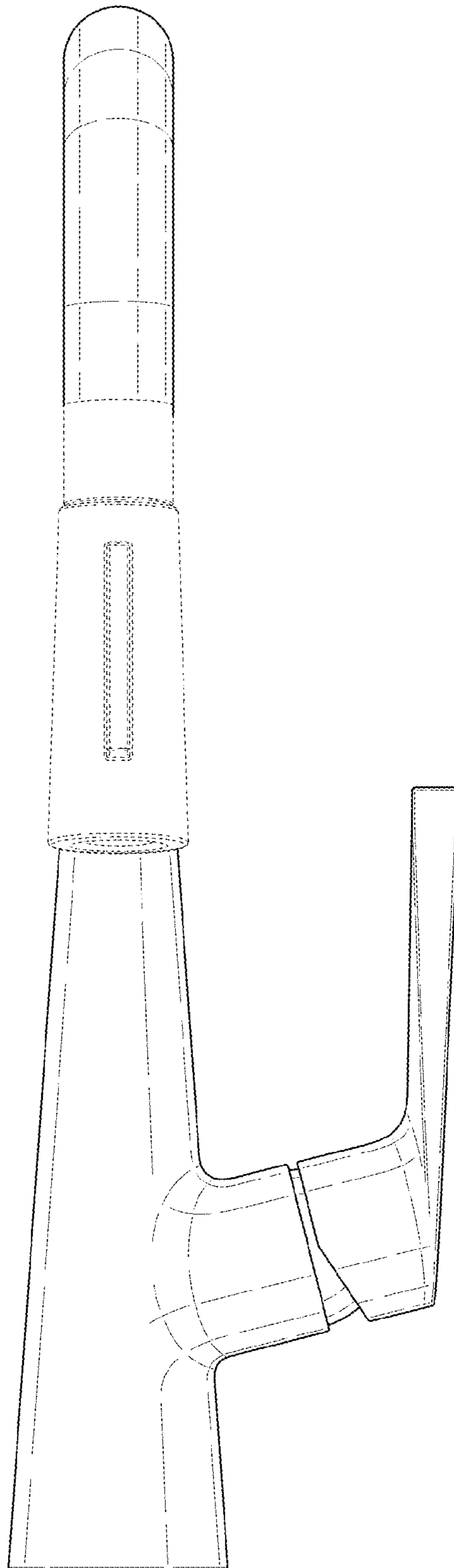

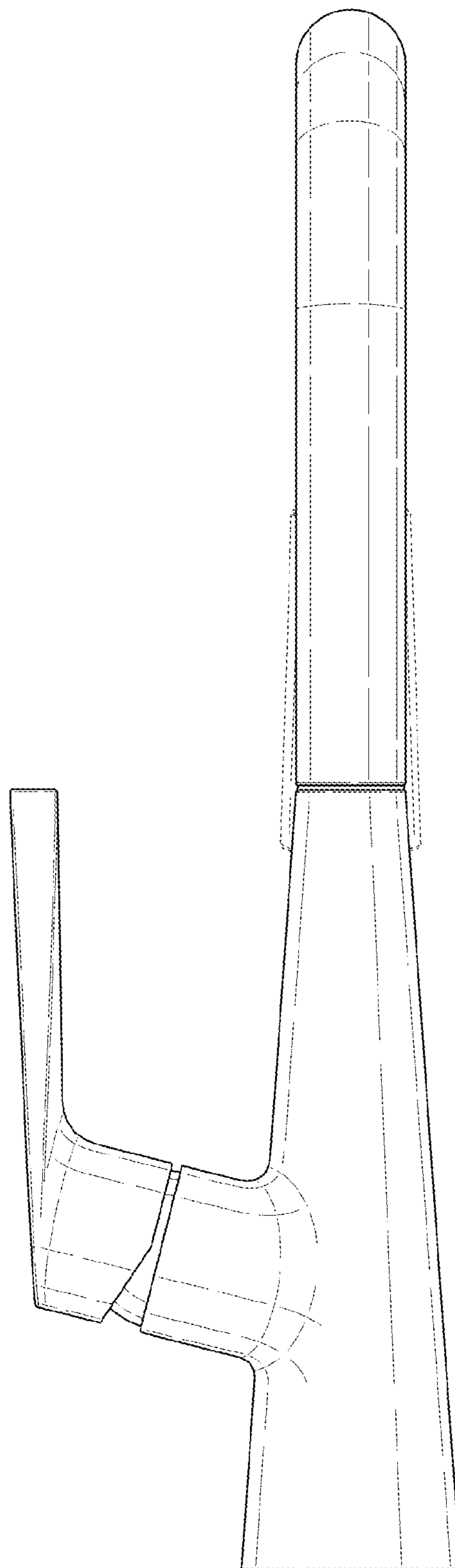

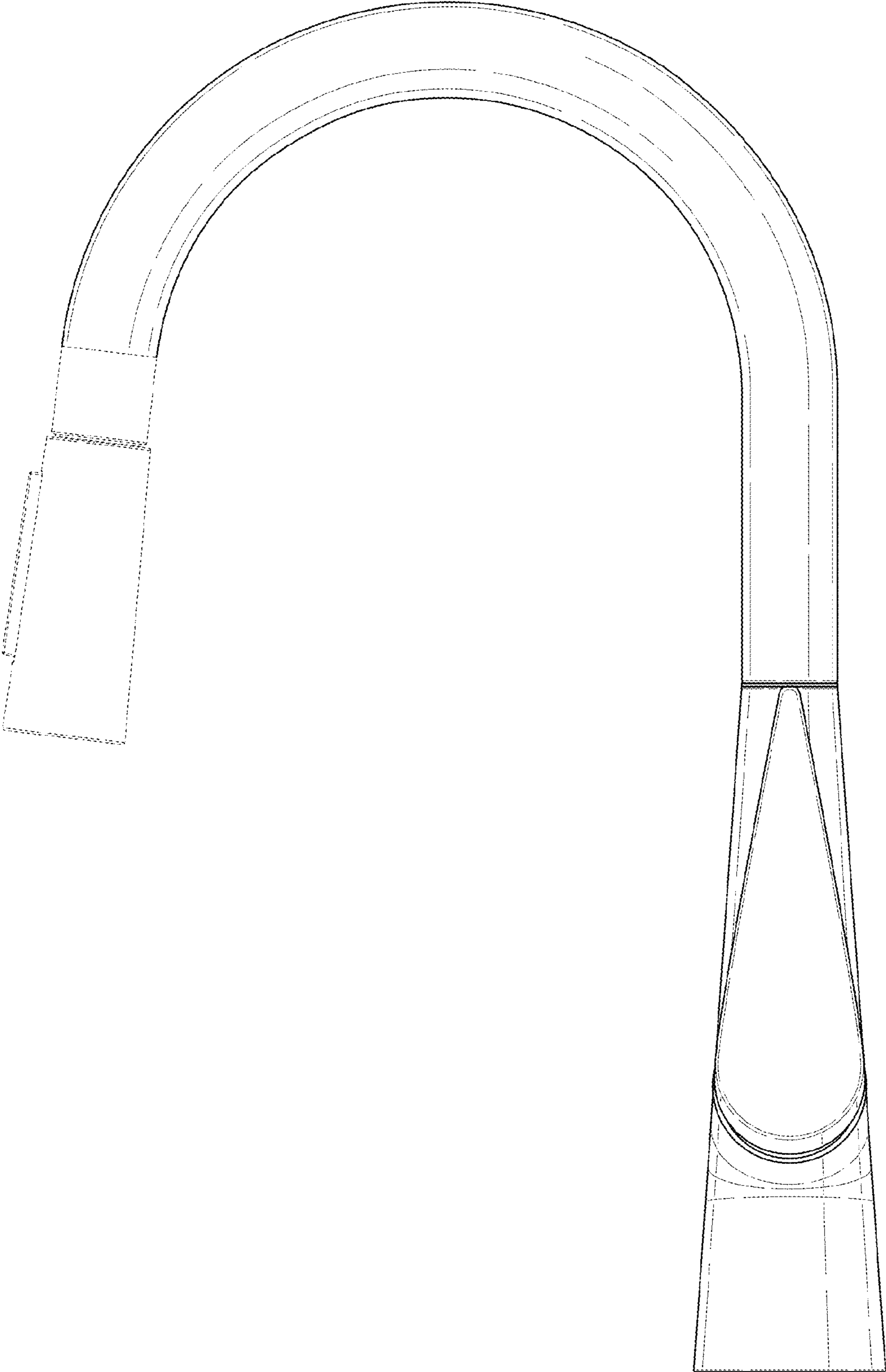

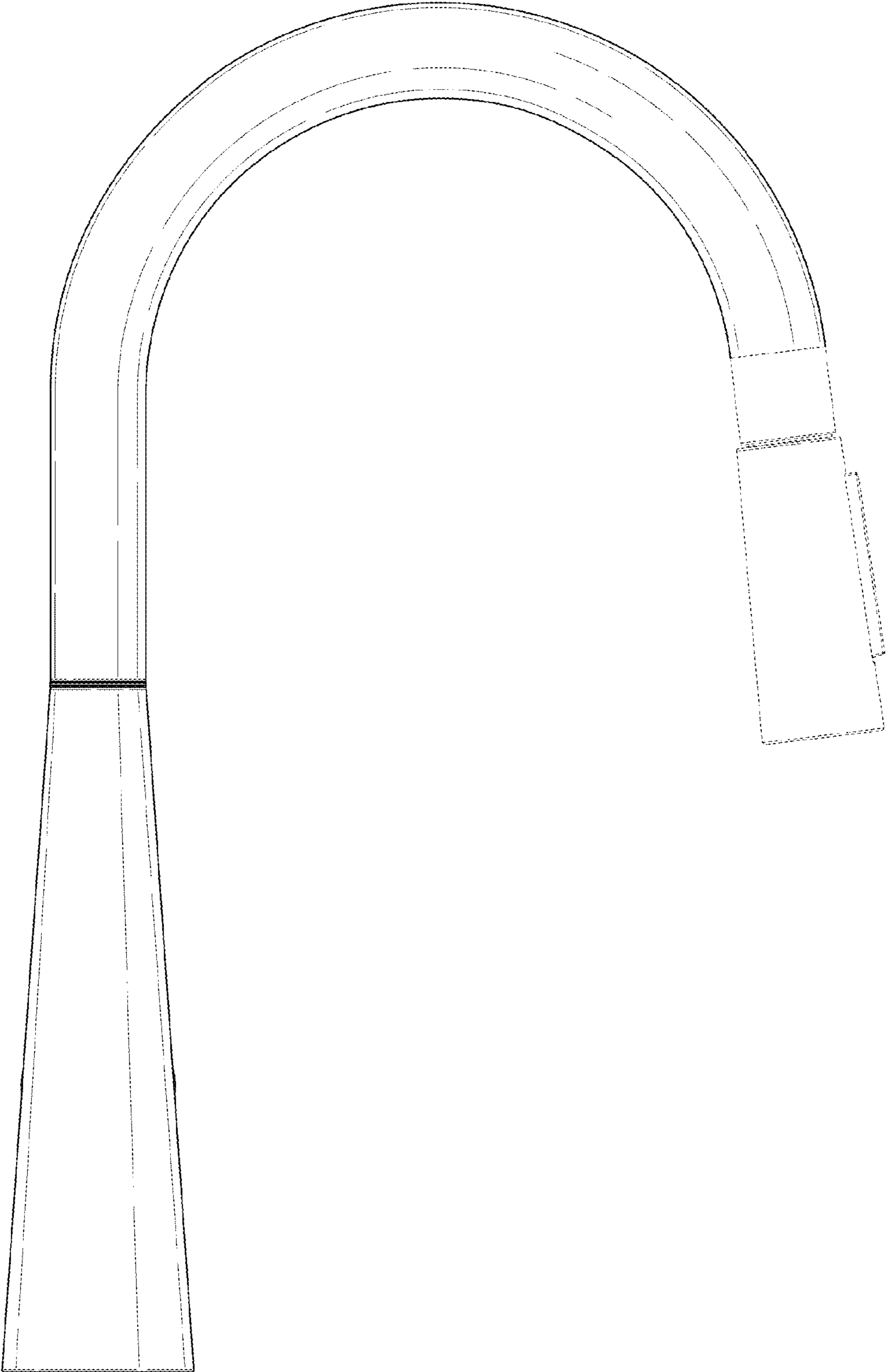

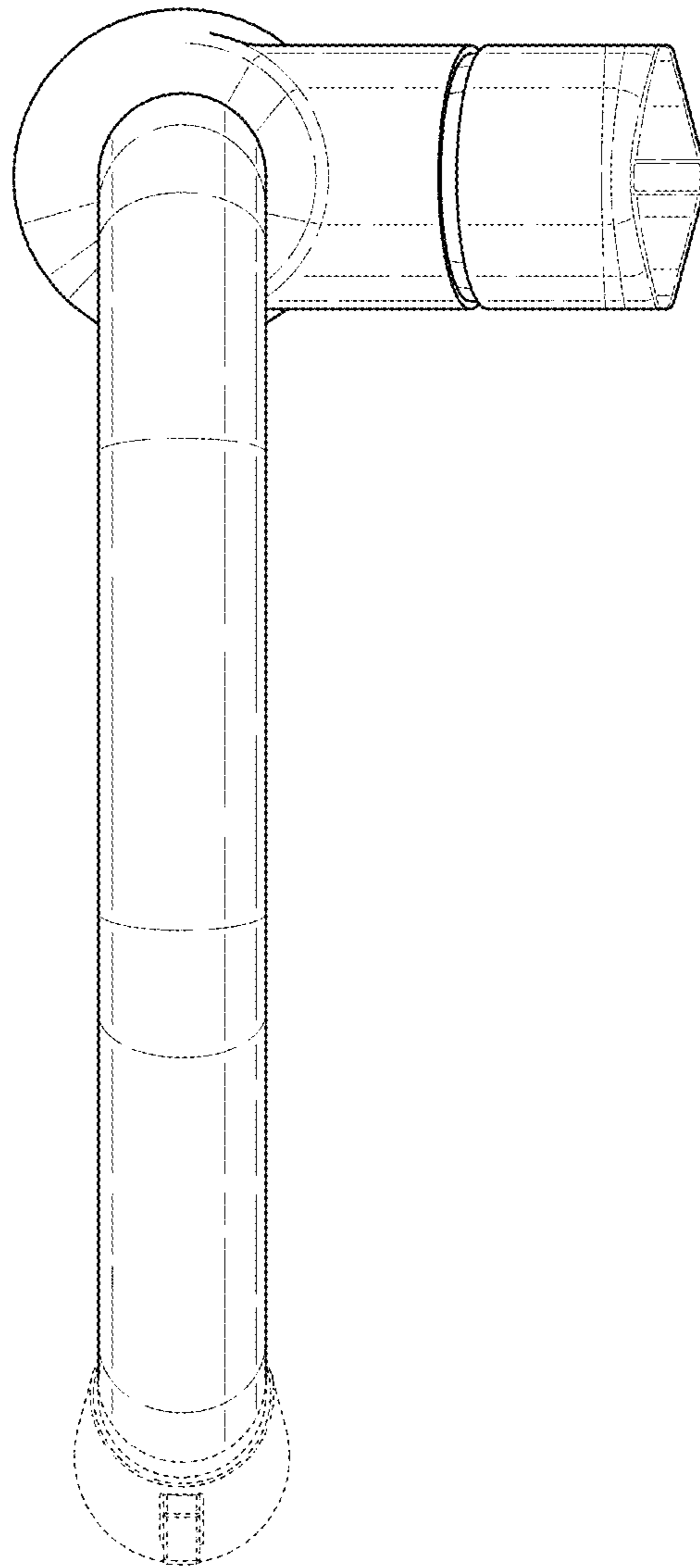
