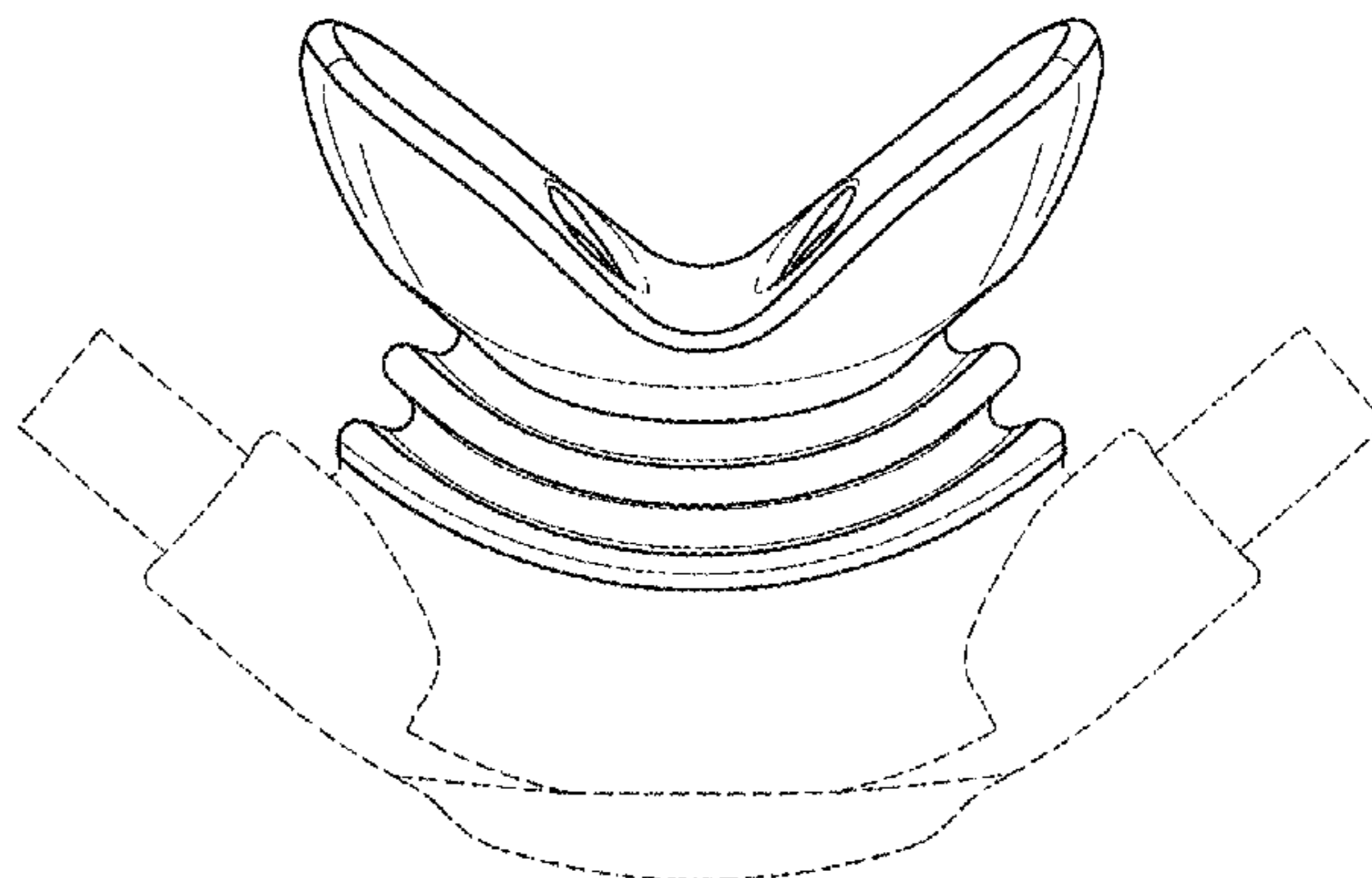
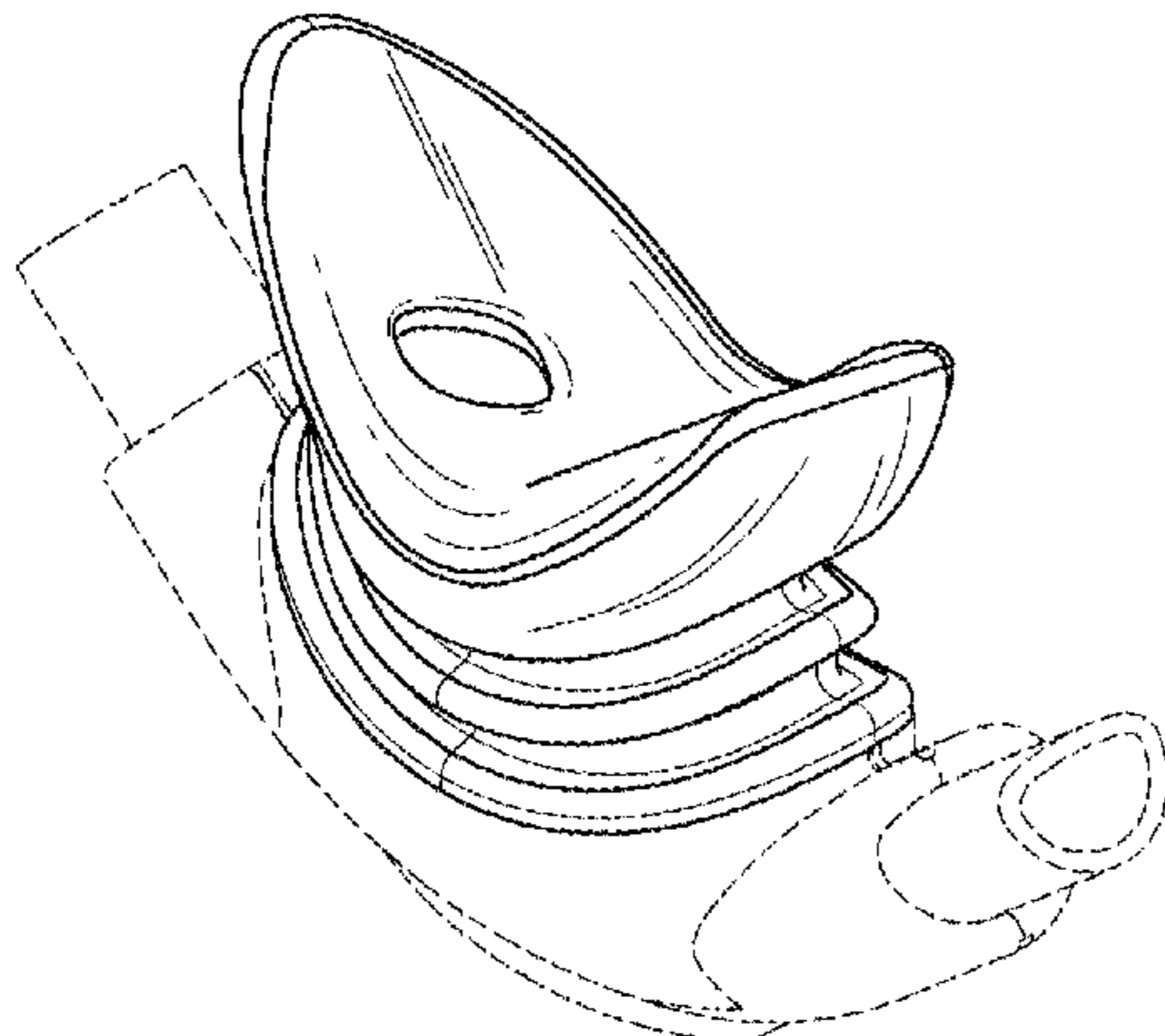
(57) **CLAIM**

The ornamental design for a nasal pillow, as shown and described.

**DESCRIPTION**

FIG. 1 is a top rear left side perspective view of the nasal pillow showing our design in a position of use. FIG. 2 is a front elevational view thereof. FIG. 3 is a rear elevational view thereof. FIG. 4 is a right side elevational view thereof. FIG. 5 is a left side elevational view thereof. FIG. 6 is top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines in the drawings illustrate the environment of the nasal pillow and form no part of the claimed design.

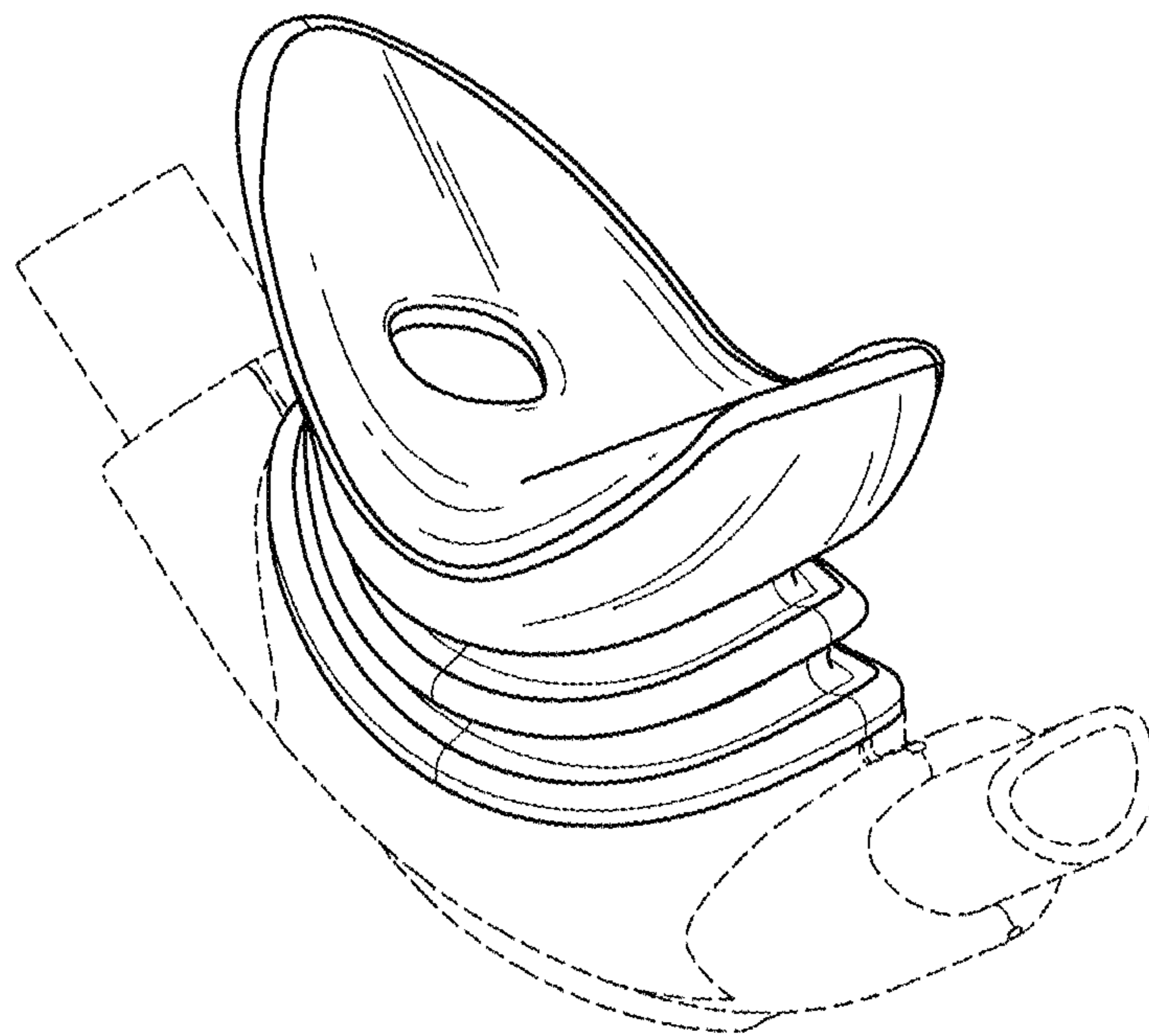

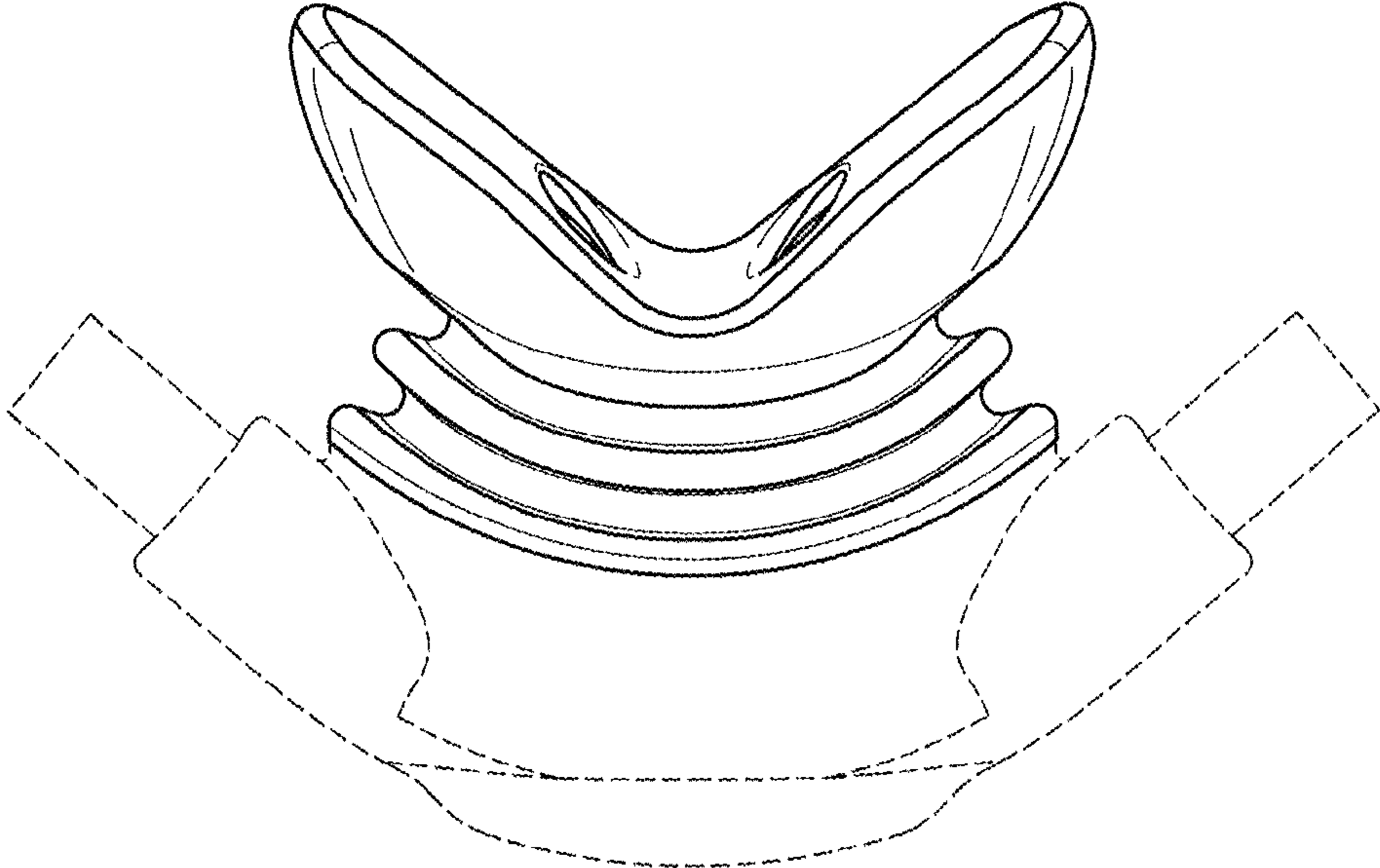

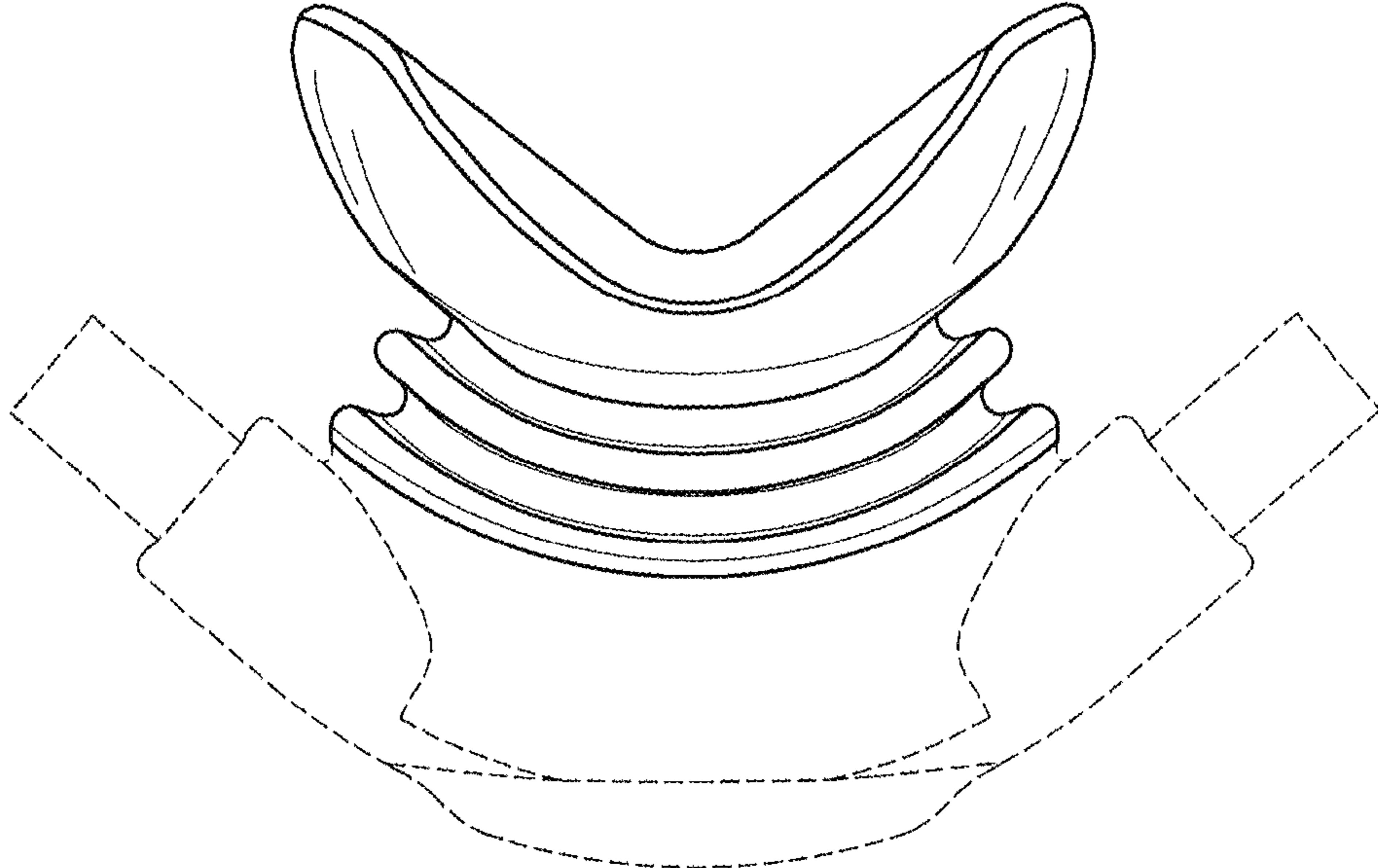

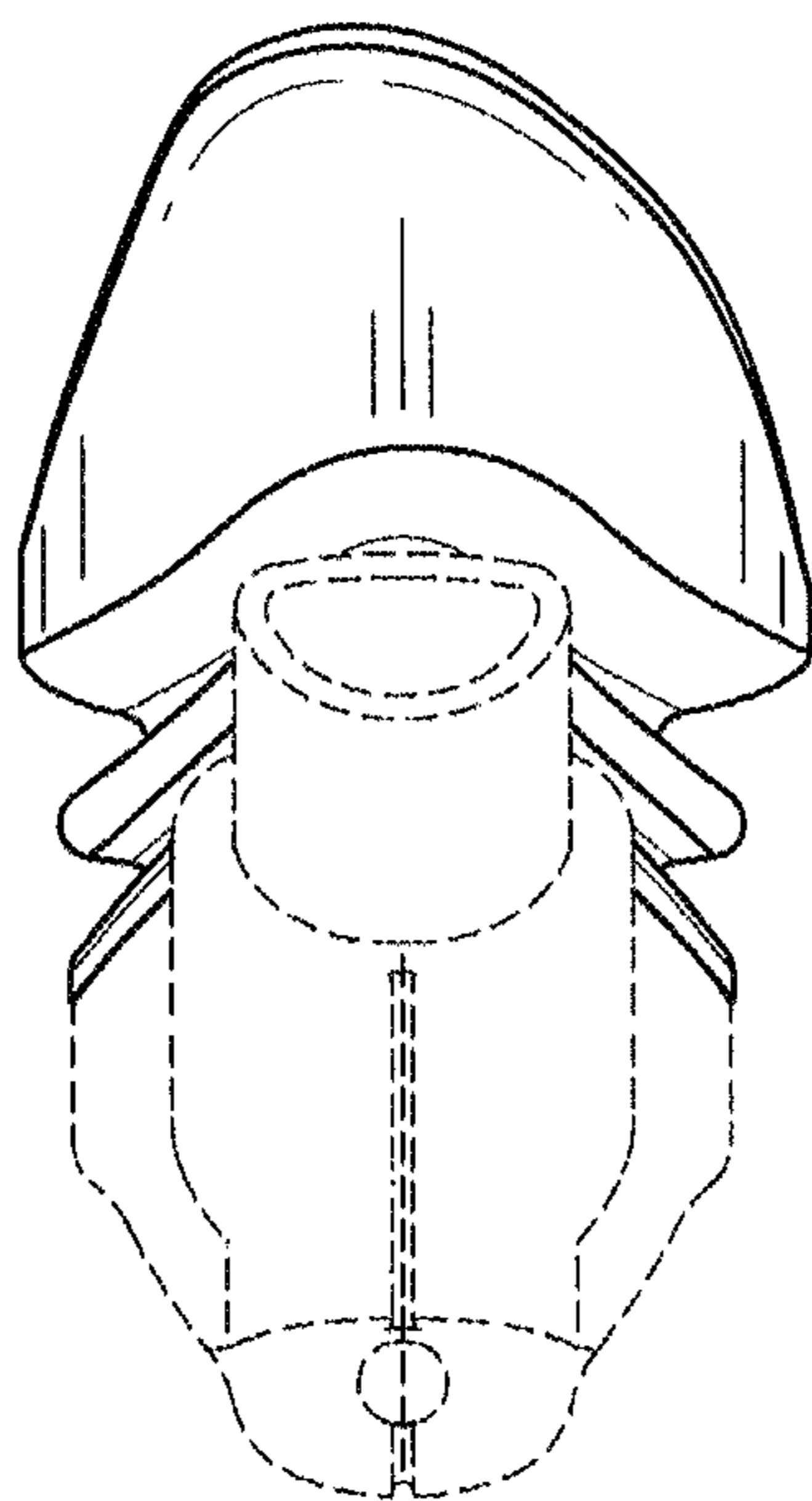

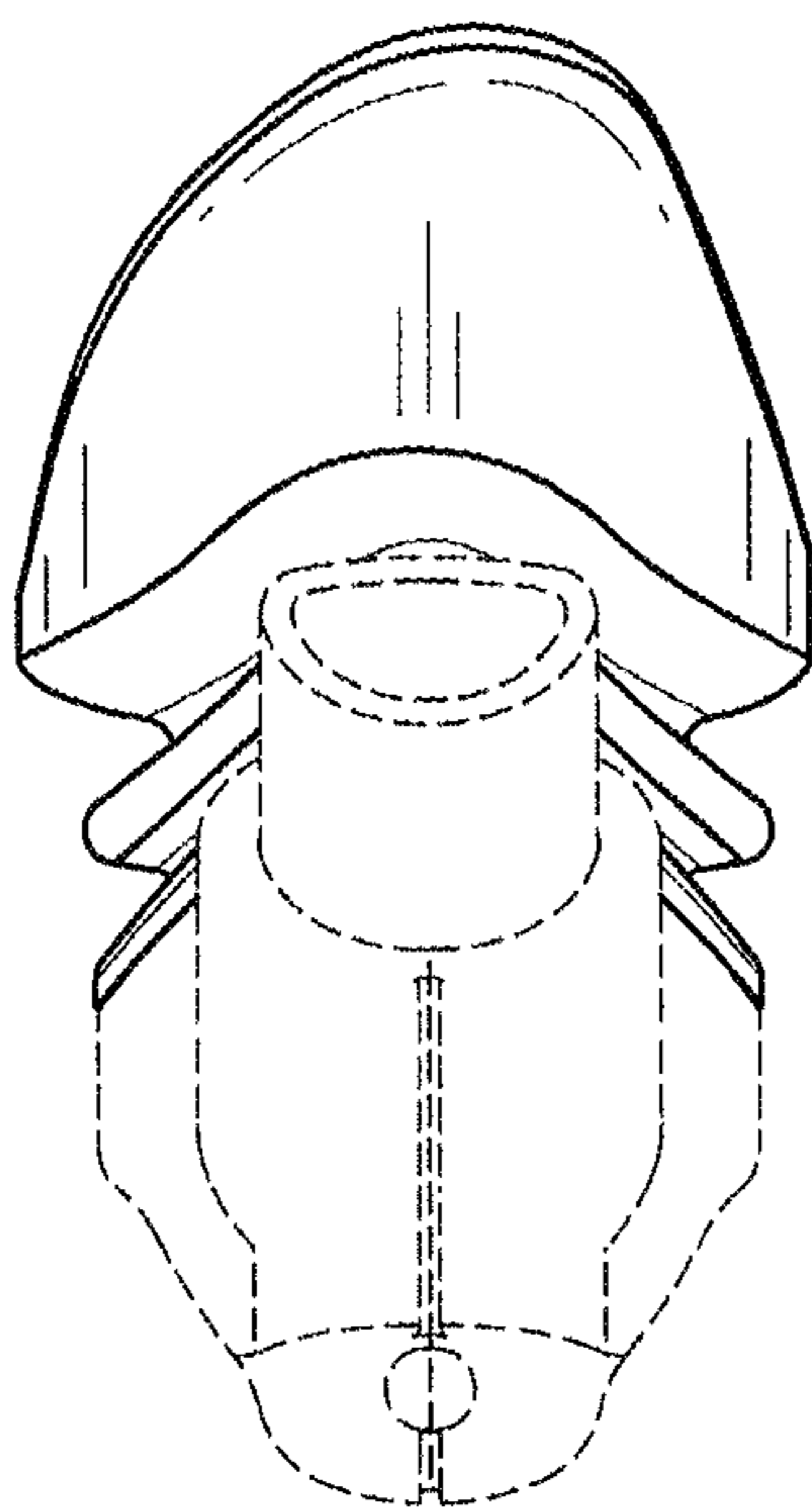

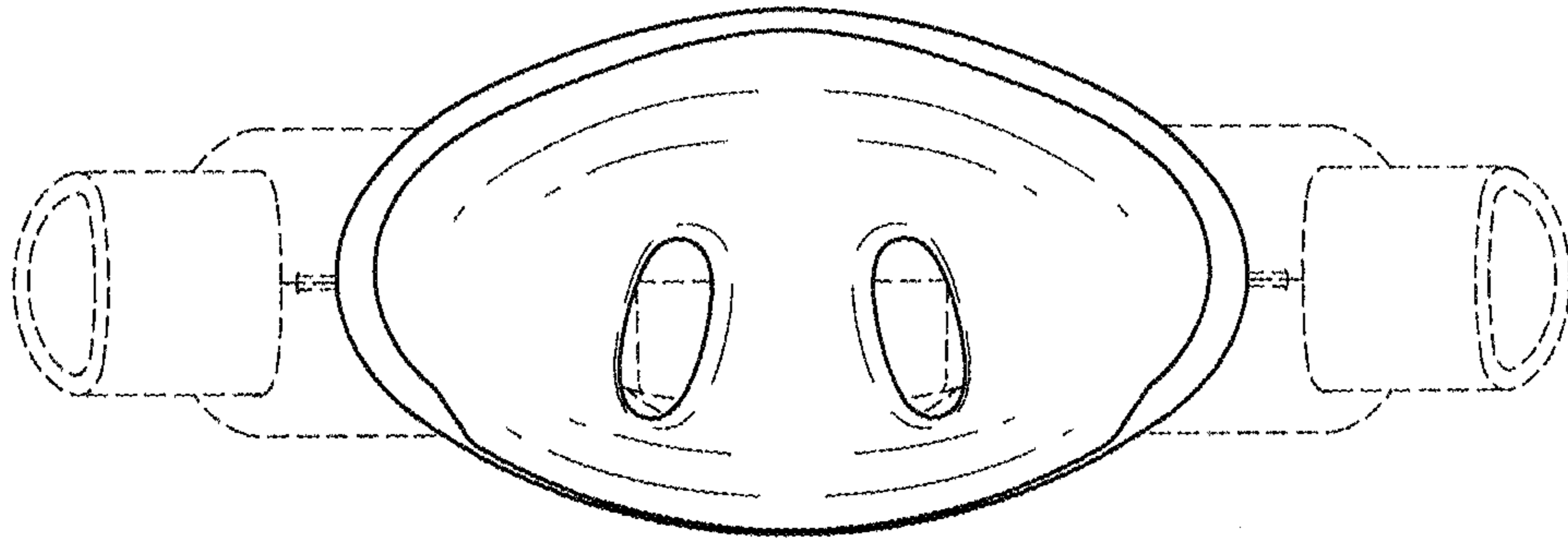

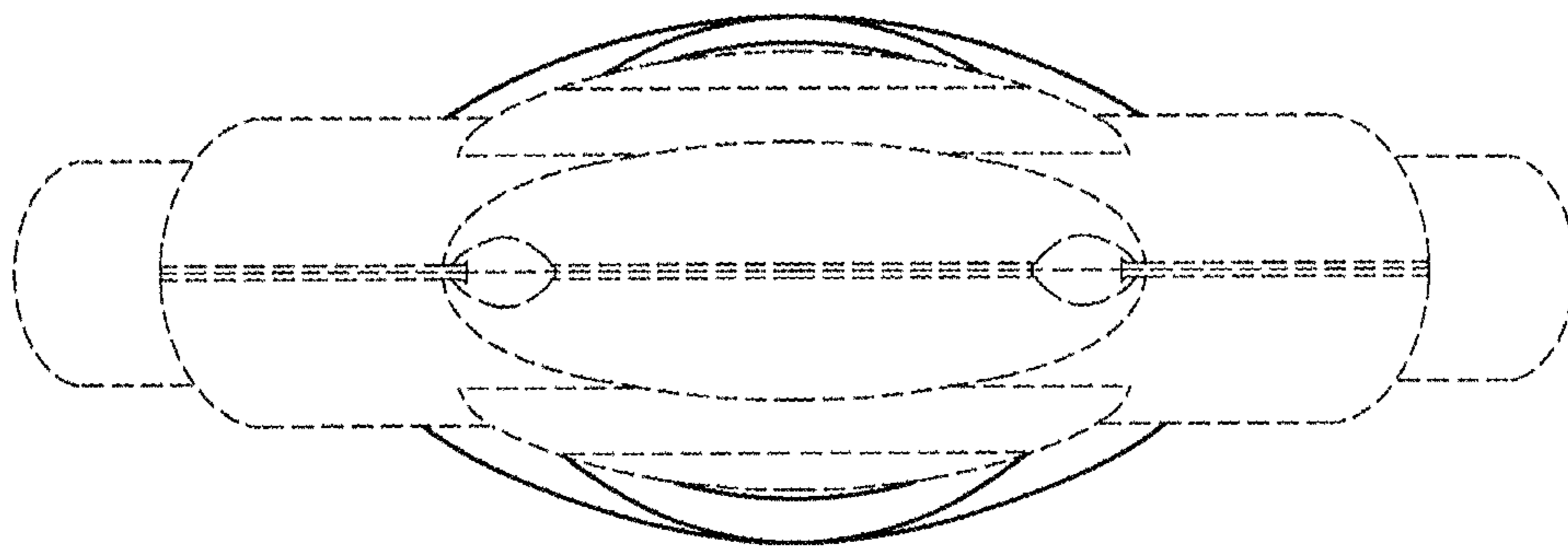
