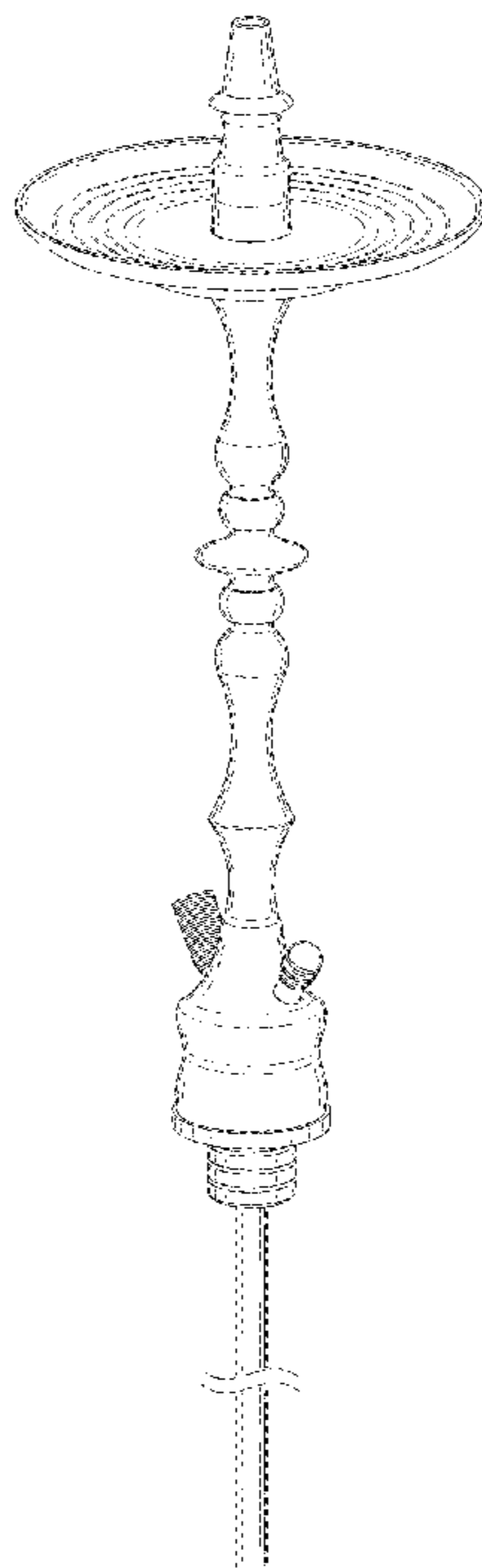
(57) **CLAIM**

and described.

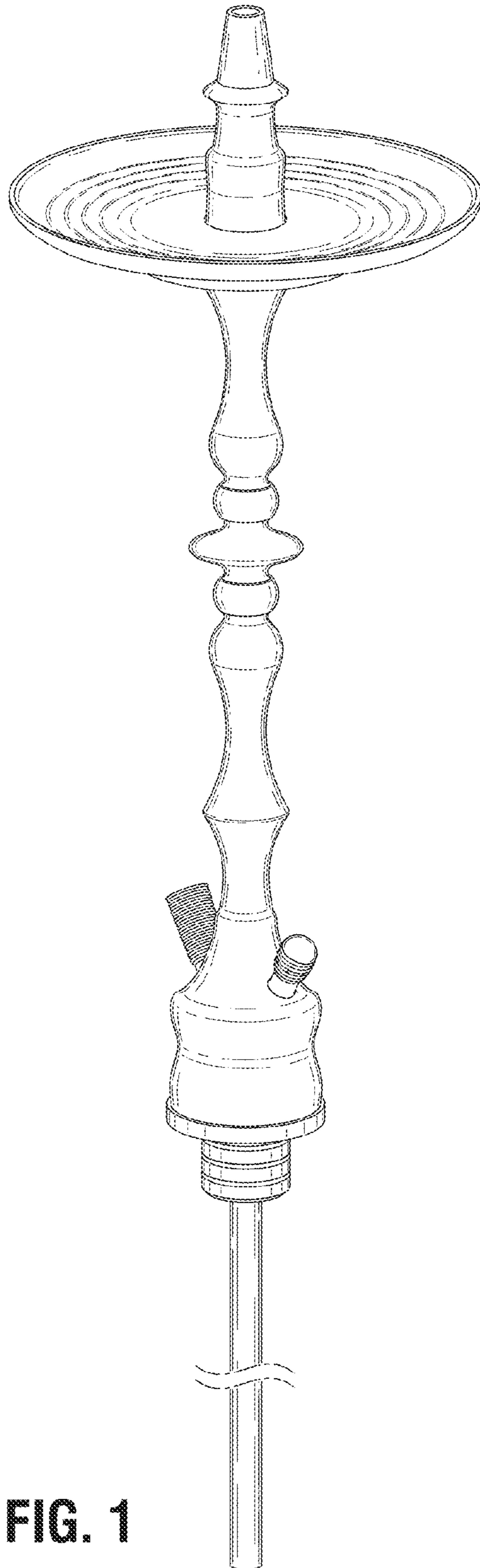
**DESCRIPTION**

FIG. 1 is a top perspective view of a hookah component  
according to the present design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a right elevation view thereof;  
FIG. 4 is a left elevation view thereof;  
FIG. 5 is a rear elevation view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The hookah component is shown with a symbolic break in its  
length. The appearance of any portion of the article between  
the break lines forms no part of the claimed design.

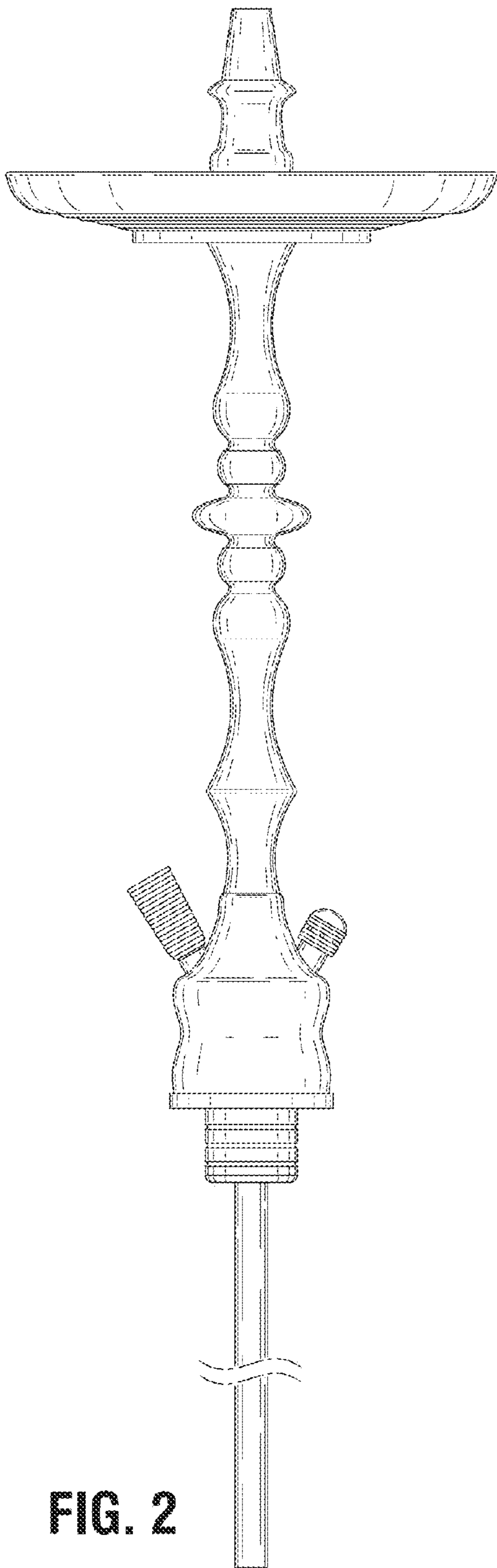

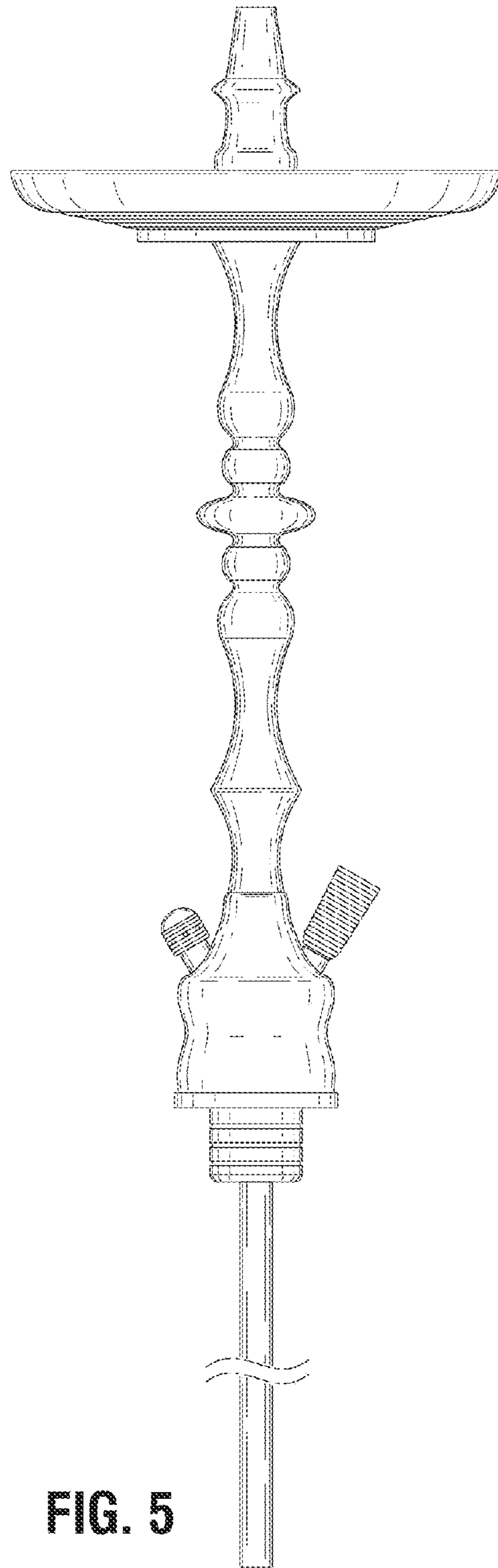
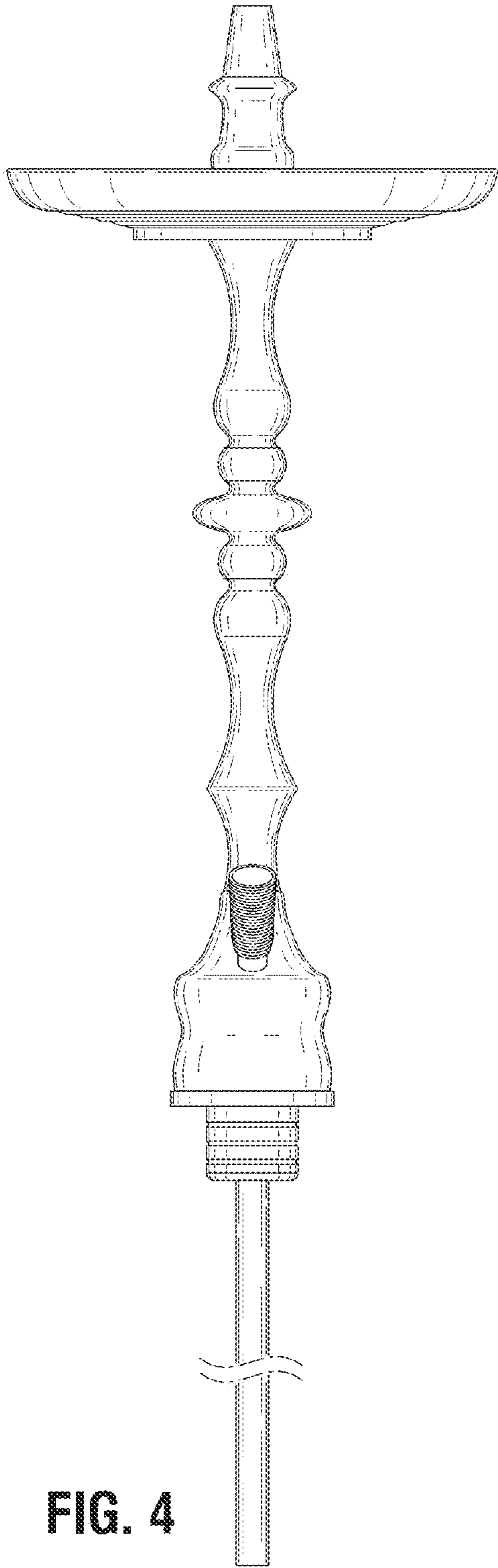

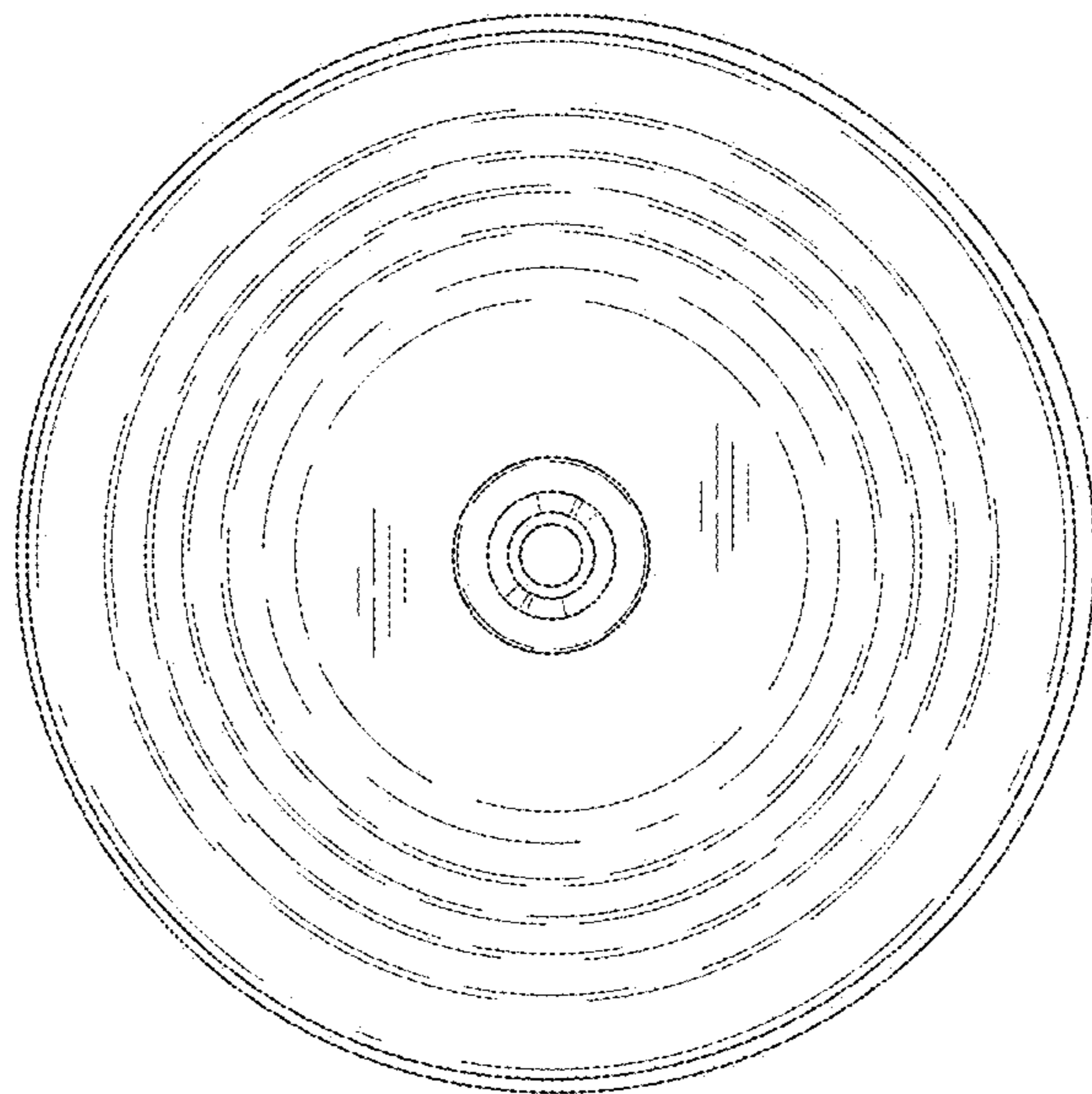




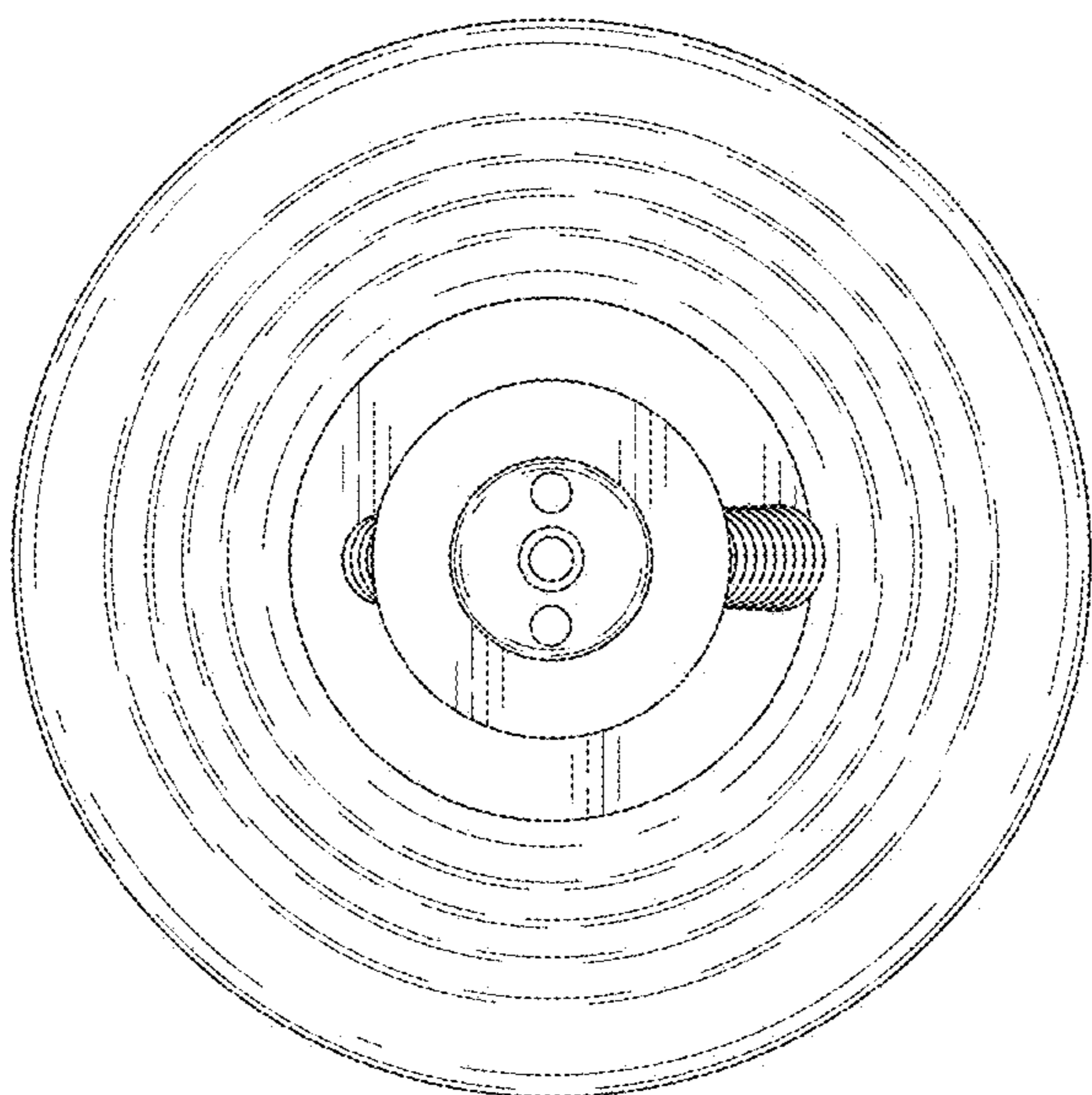
