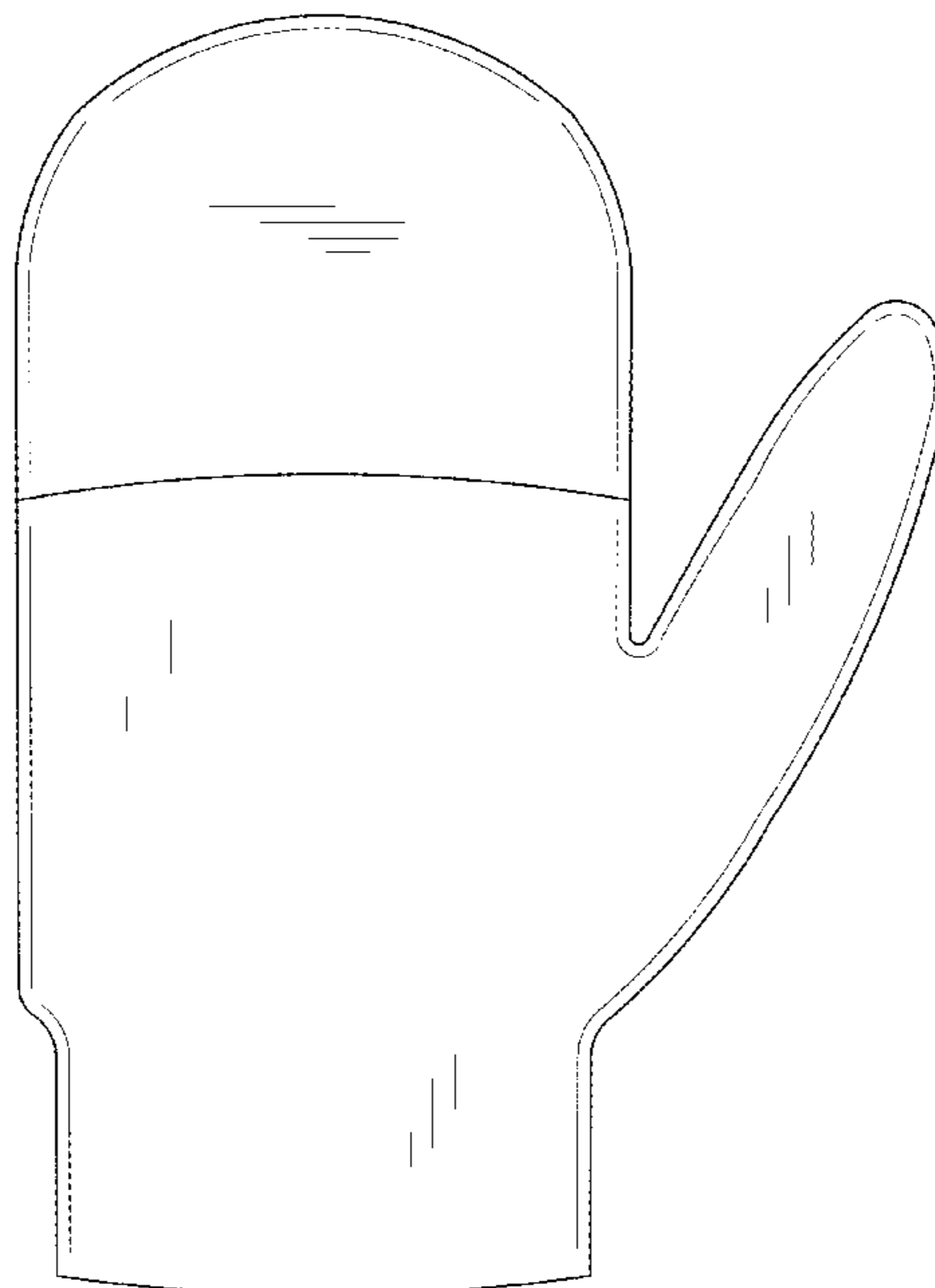
(57) **CLAIM**

The ornamental design for a children's personal sanitary wiping mitt, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a children's personal sanitary wiping mitt showing my new design;
FIG. 2 is a left side view of the children's personal sanitary wiping mitt;
FIG. 3 is a right side view of the children's personal sanitary wiping mitt;

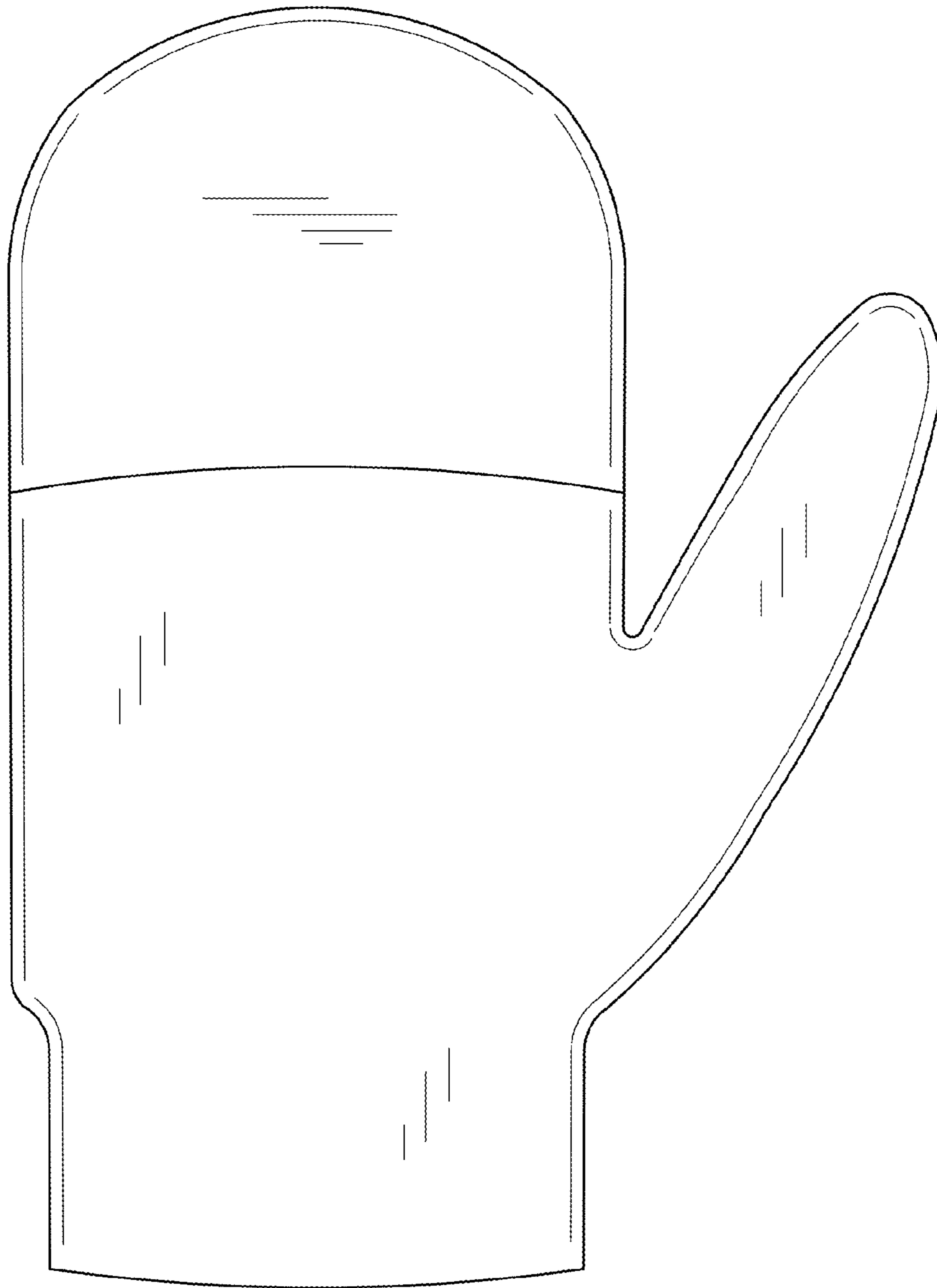

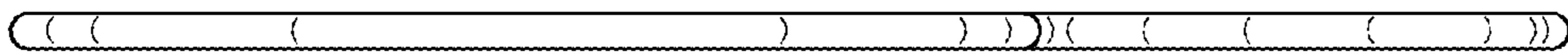

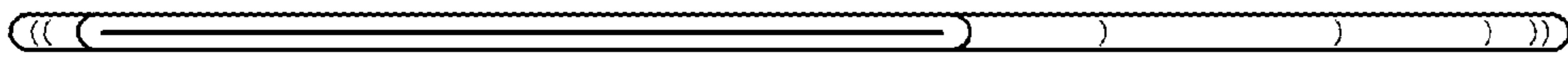
