(57) **CLAIM**

I claim the ornamental design for a garment, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a garment in a flat position; and, FIG. 2 is a rear view of the garment of FIG. 1. The broken lines show boundaries of the claimed design and elements of the garment that form no part of the claimed design. The contrast in shading represents a contrast in appearance only and does not represent any particular color, material, texture, or finish.

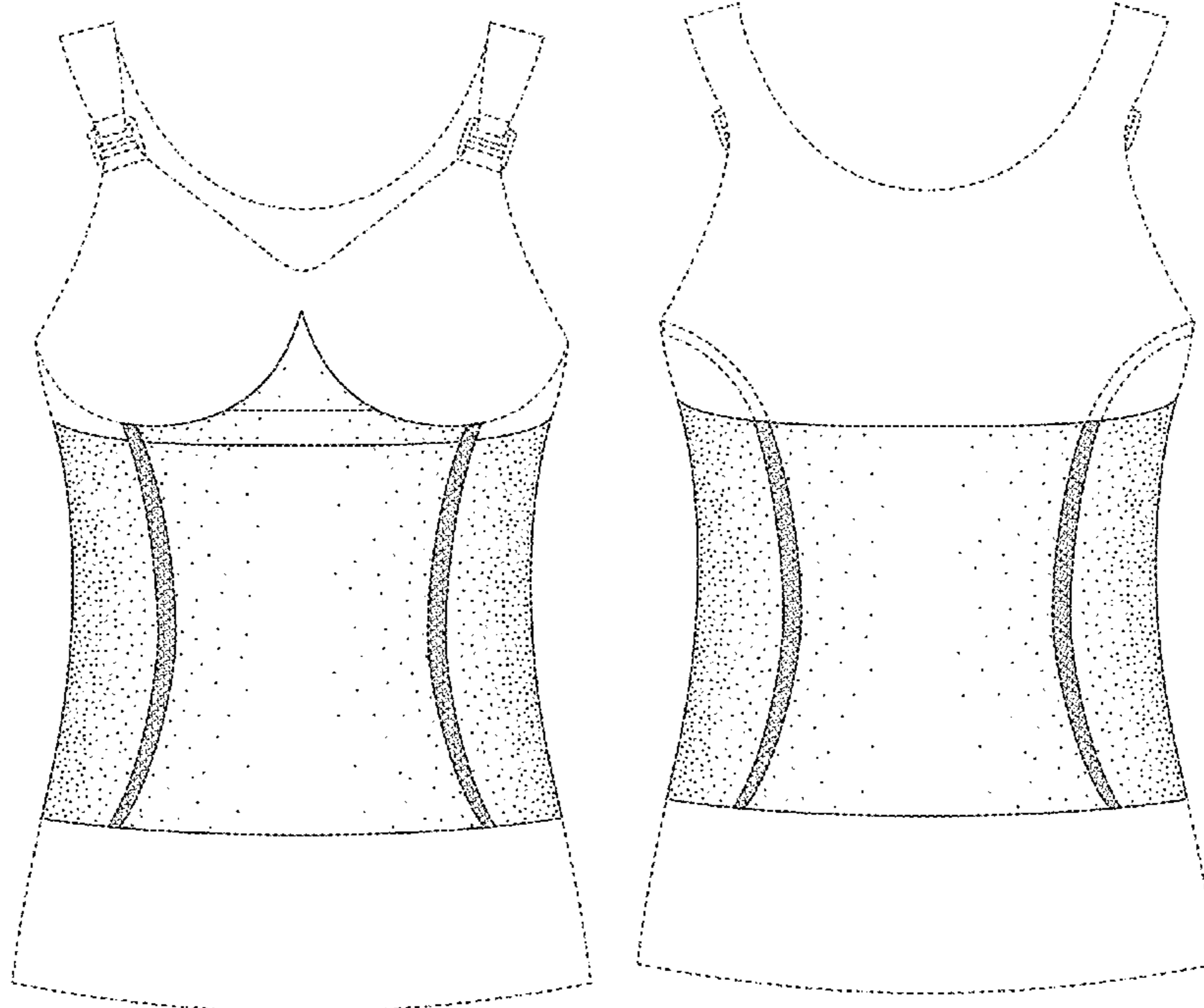

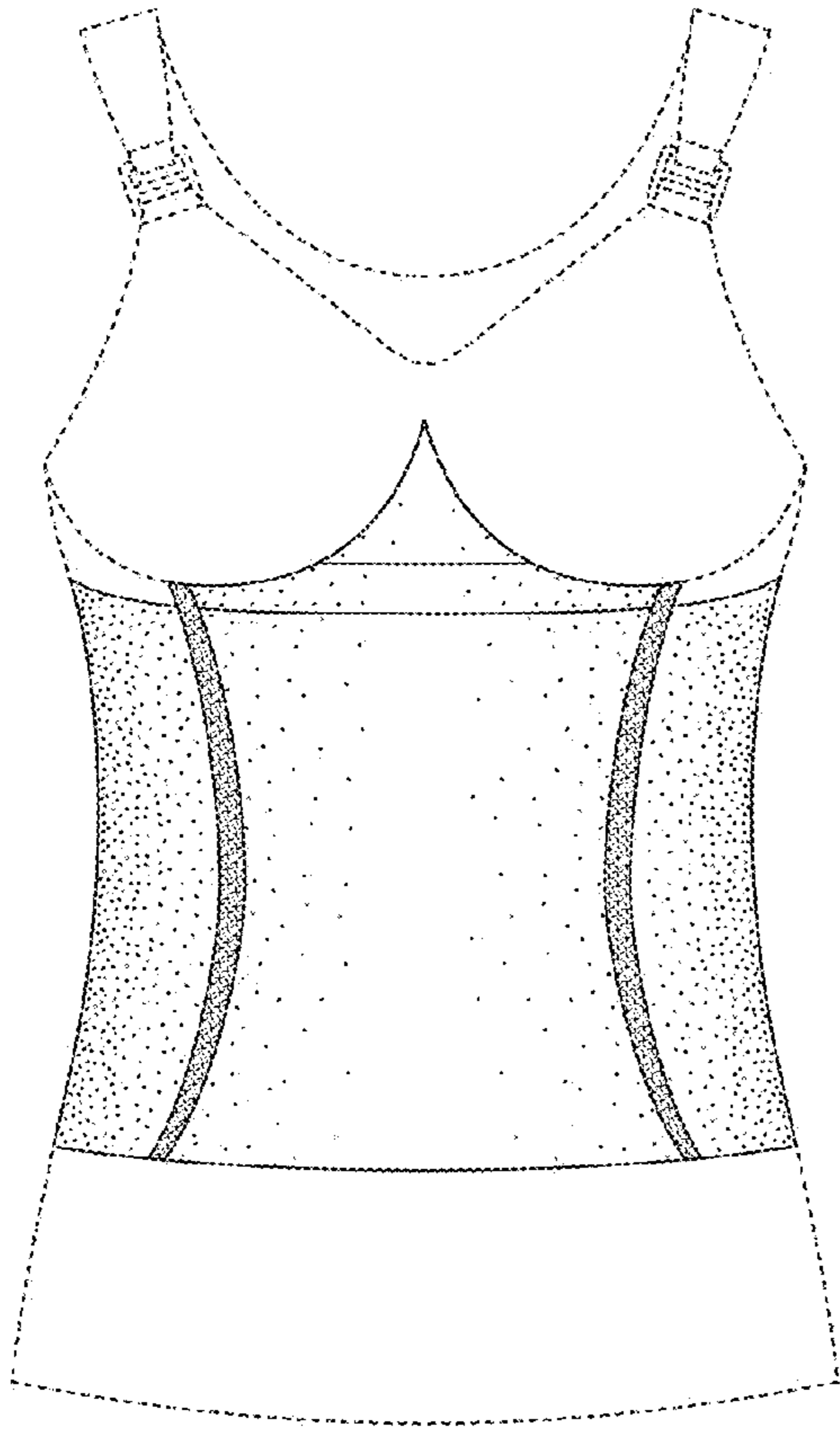
