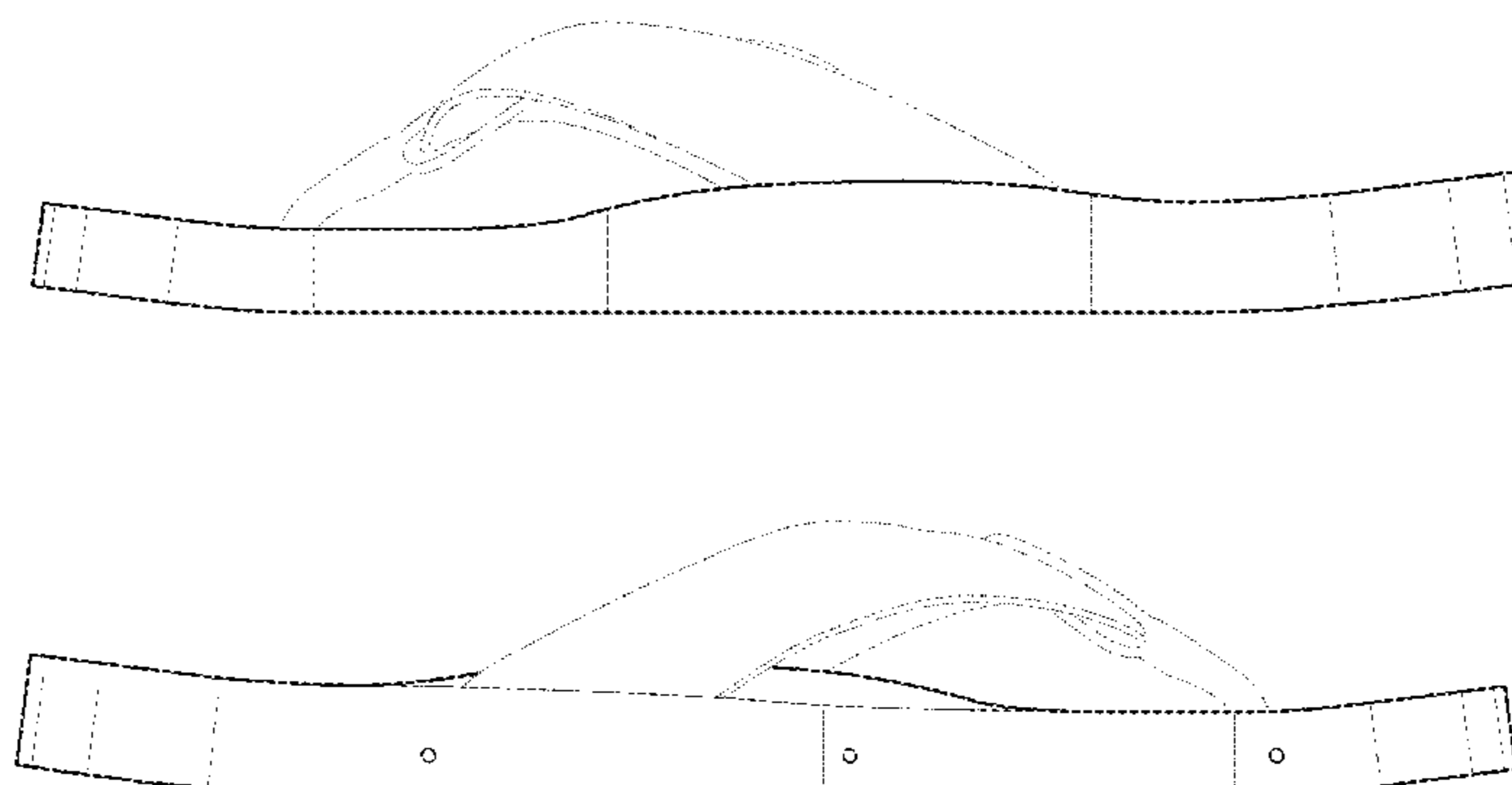
(57) **CLAIM**
The ornamental design for a midsole with illumination locations, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the midsole with illumination locations;
 FIG. 2 is an inner side view of the midsole with illumination locations of FIG. 1;
 FIG. 3 is an outer side view of the midsole with illumination locations of FIG. 1;
 FIG. 4 is a top view of the midsole with illumination locations of FIG. 1;
 FIG. 5 is a bottom view of the midsole with illumination locations of FIG. 1;
 FIG. 6 is a front view of the midsole with illumination locations of FIG. 1; and,
 FIG. 7 is a rear view of the midsole with illumination locations of FIG. 1.
 Surface markings are provided for clarity of the shape of the design but do not indicate the use of any specific type of surface material and form no part of the claimed design. The broken lines depicting an upper portion of the midsole are for environmental purposes only and form no part of the claimed design.

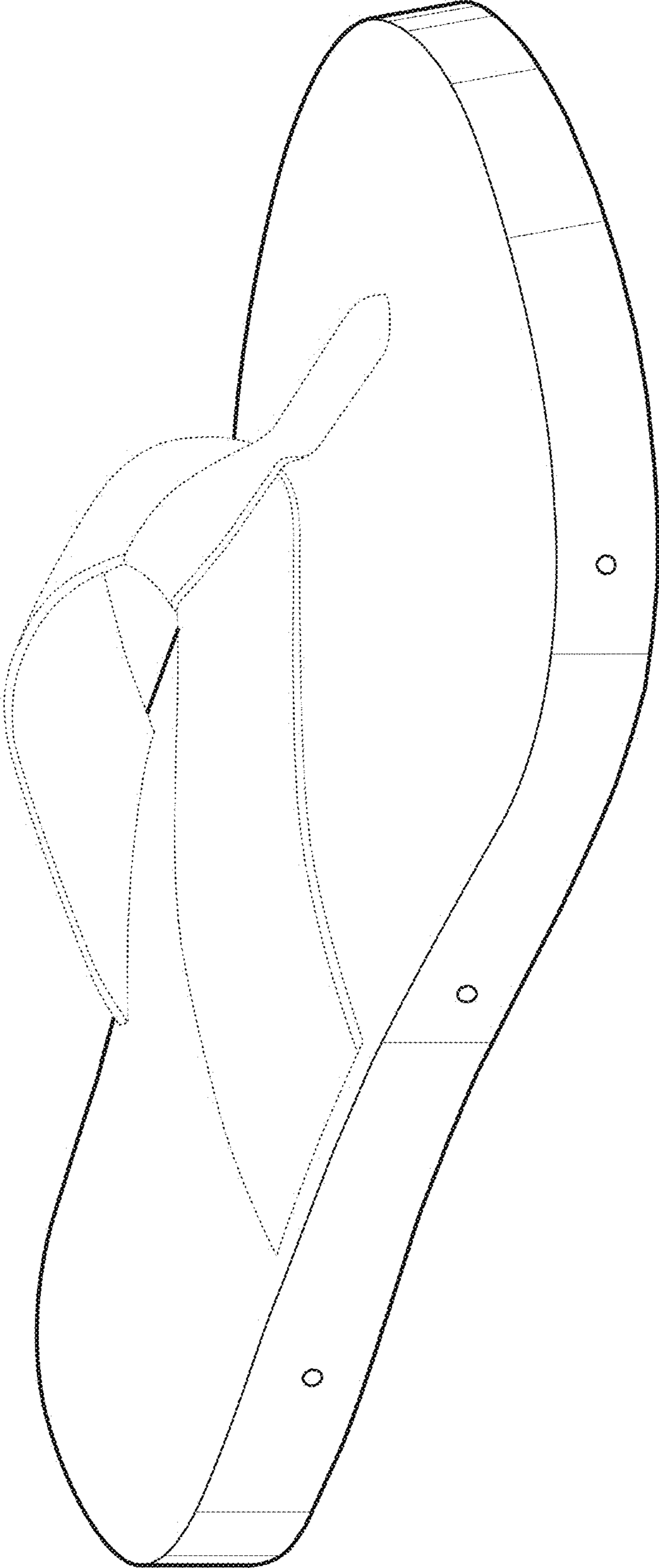

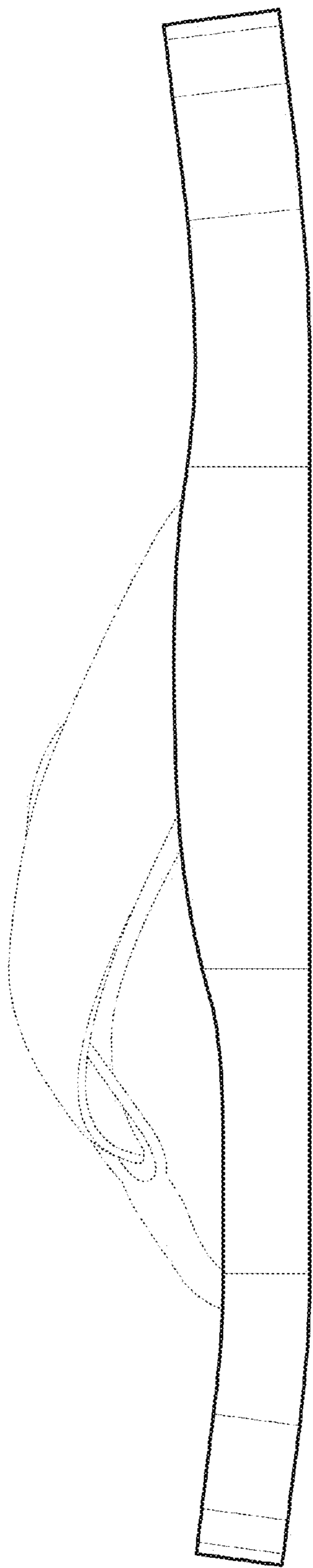

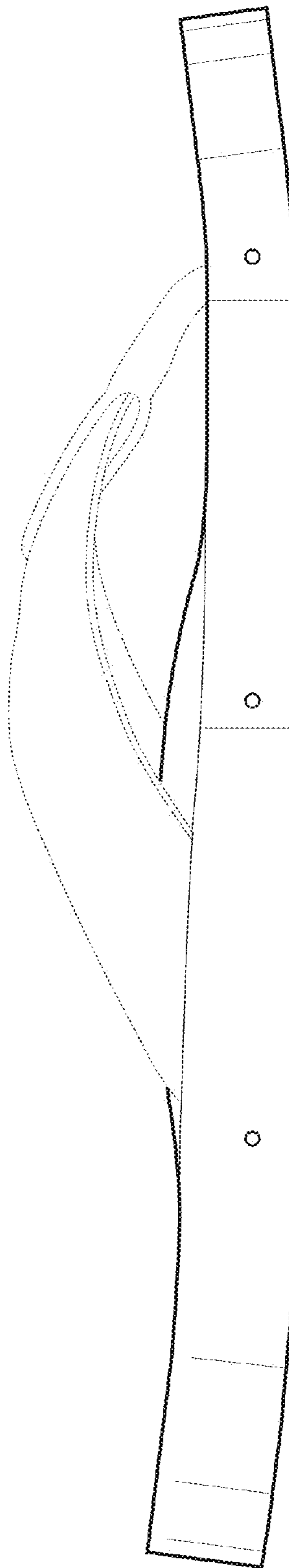

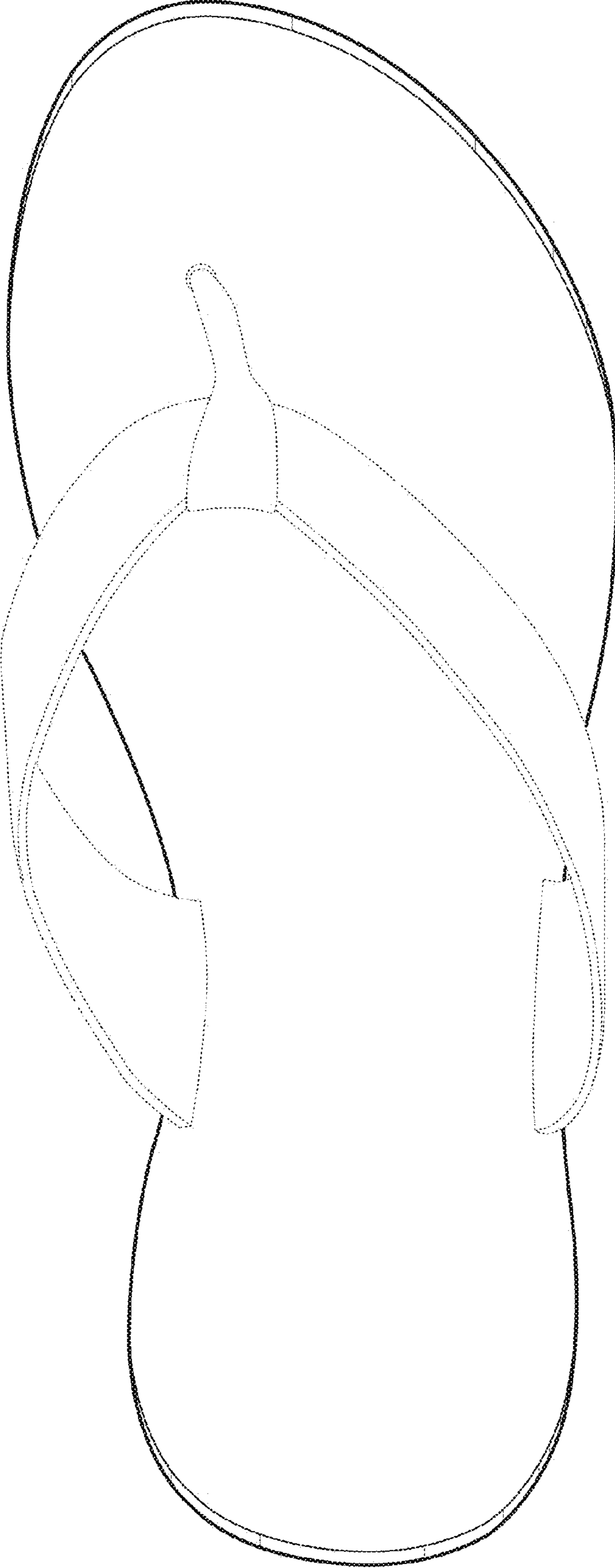

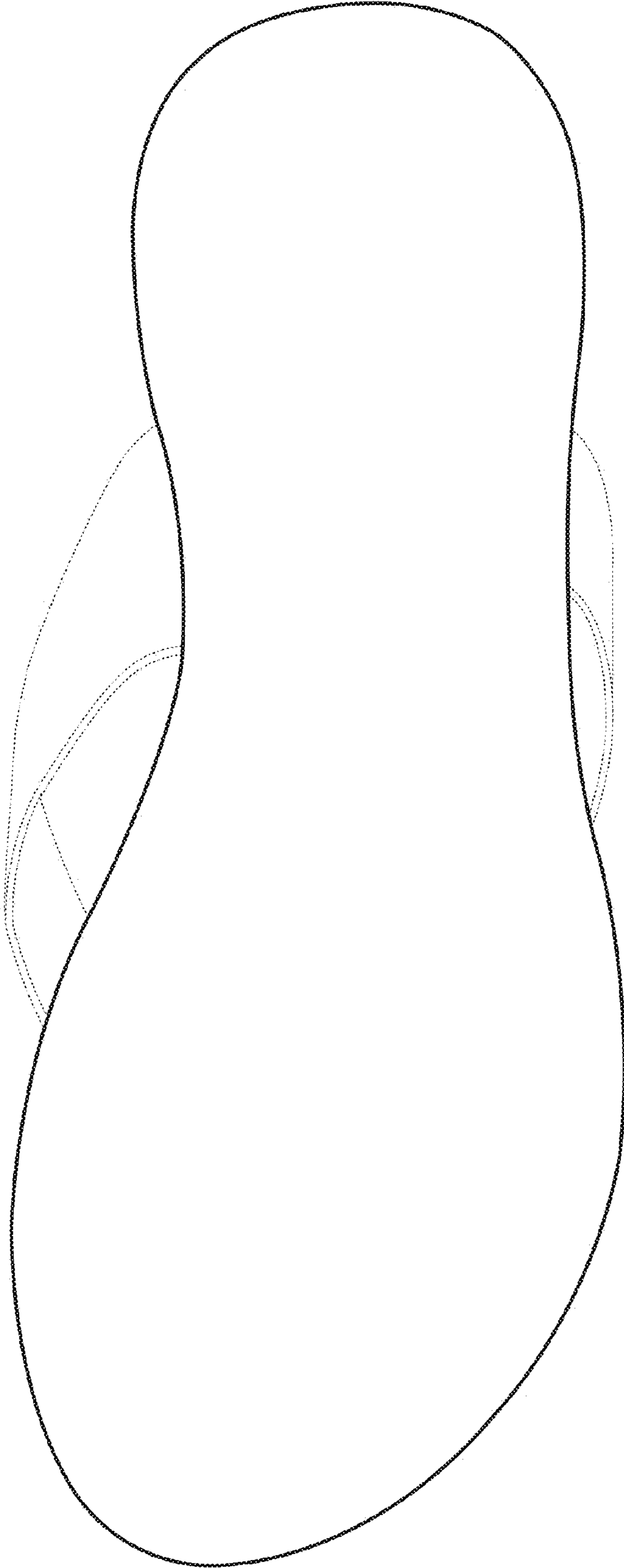

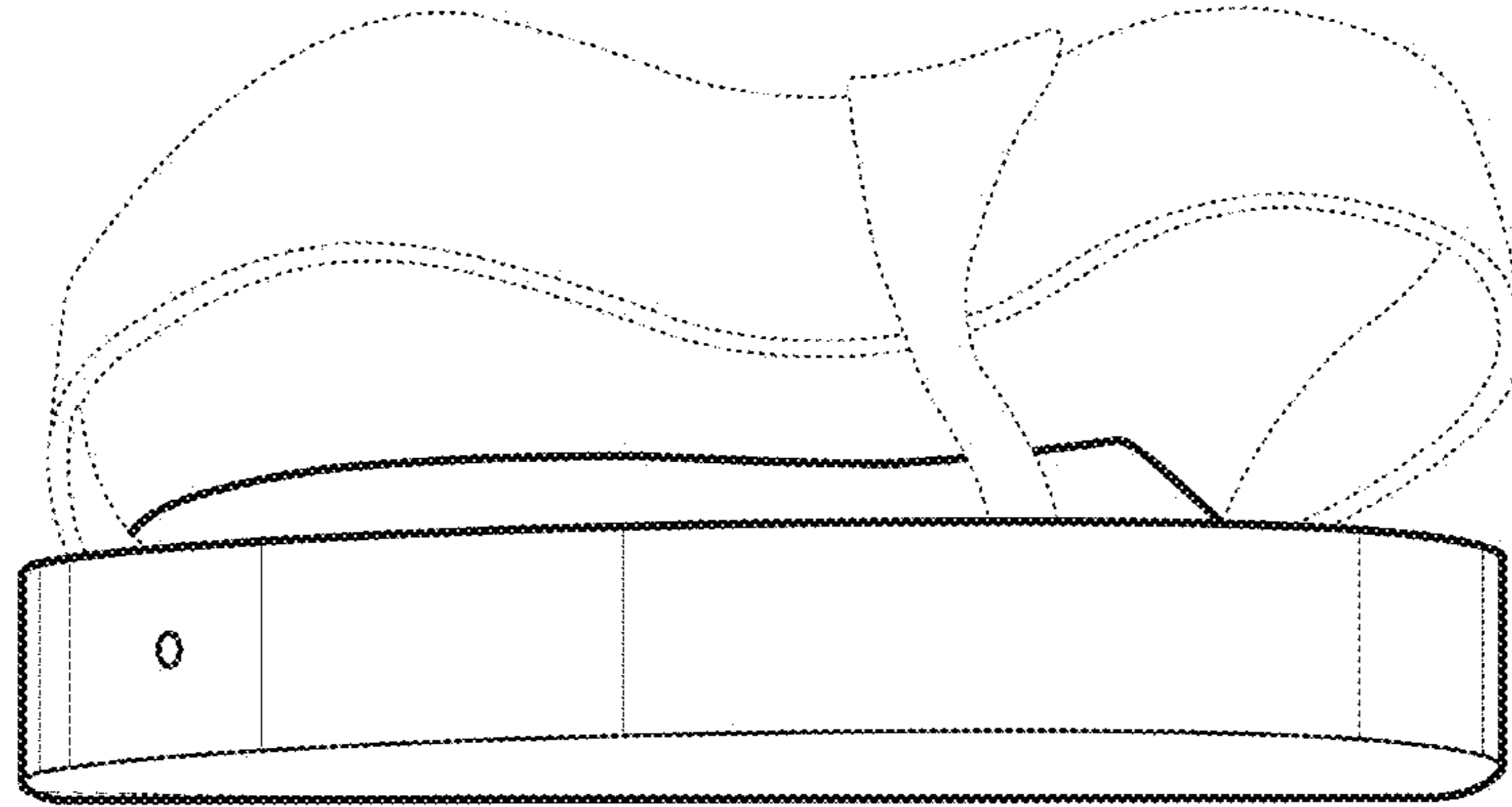

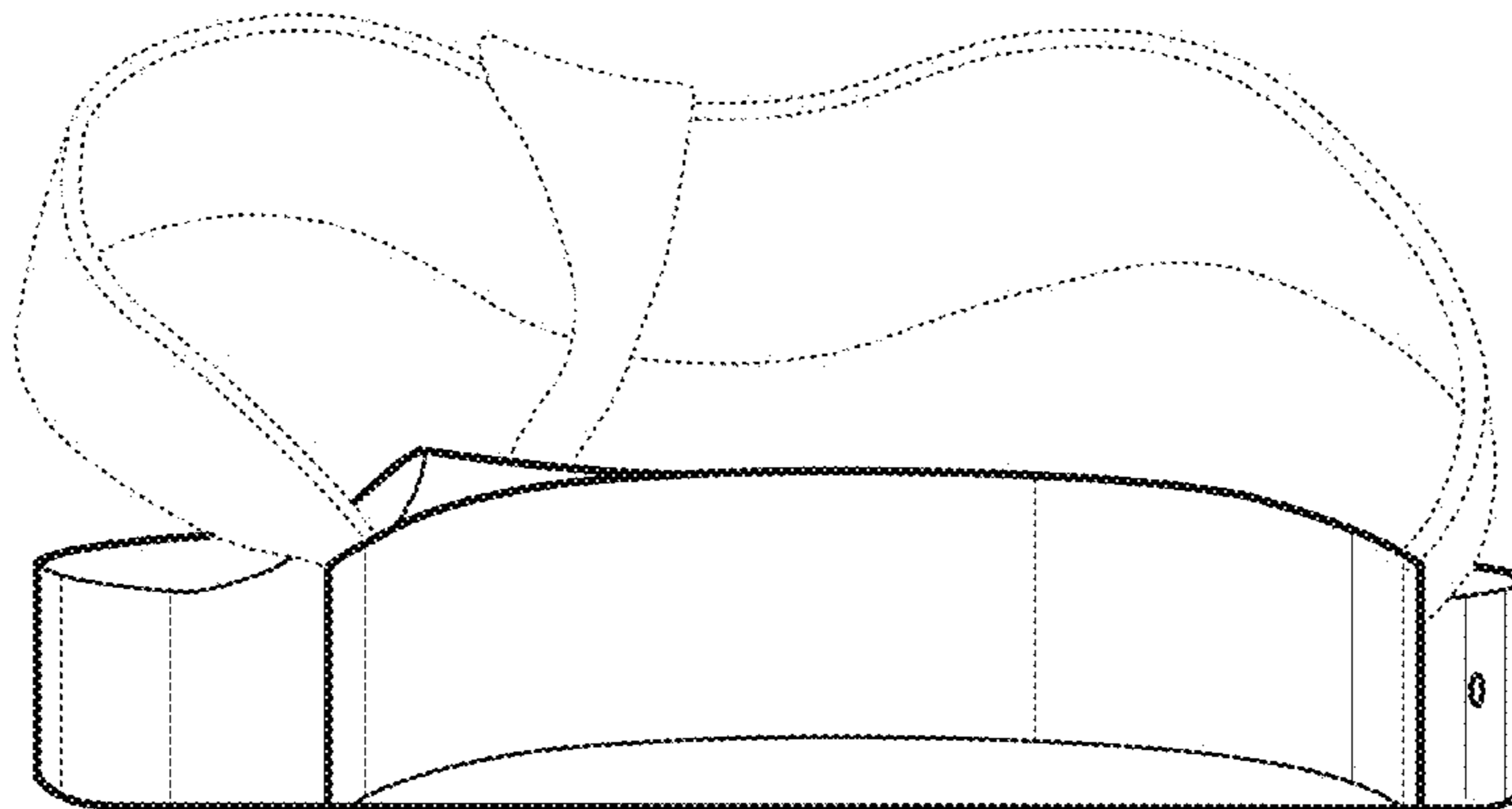
