FIG. 6 is a right side view of the present invention in an open position.

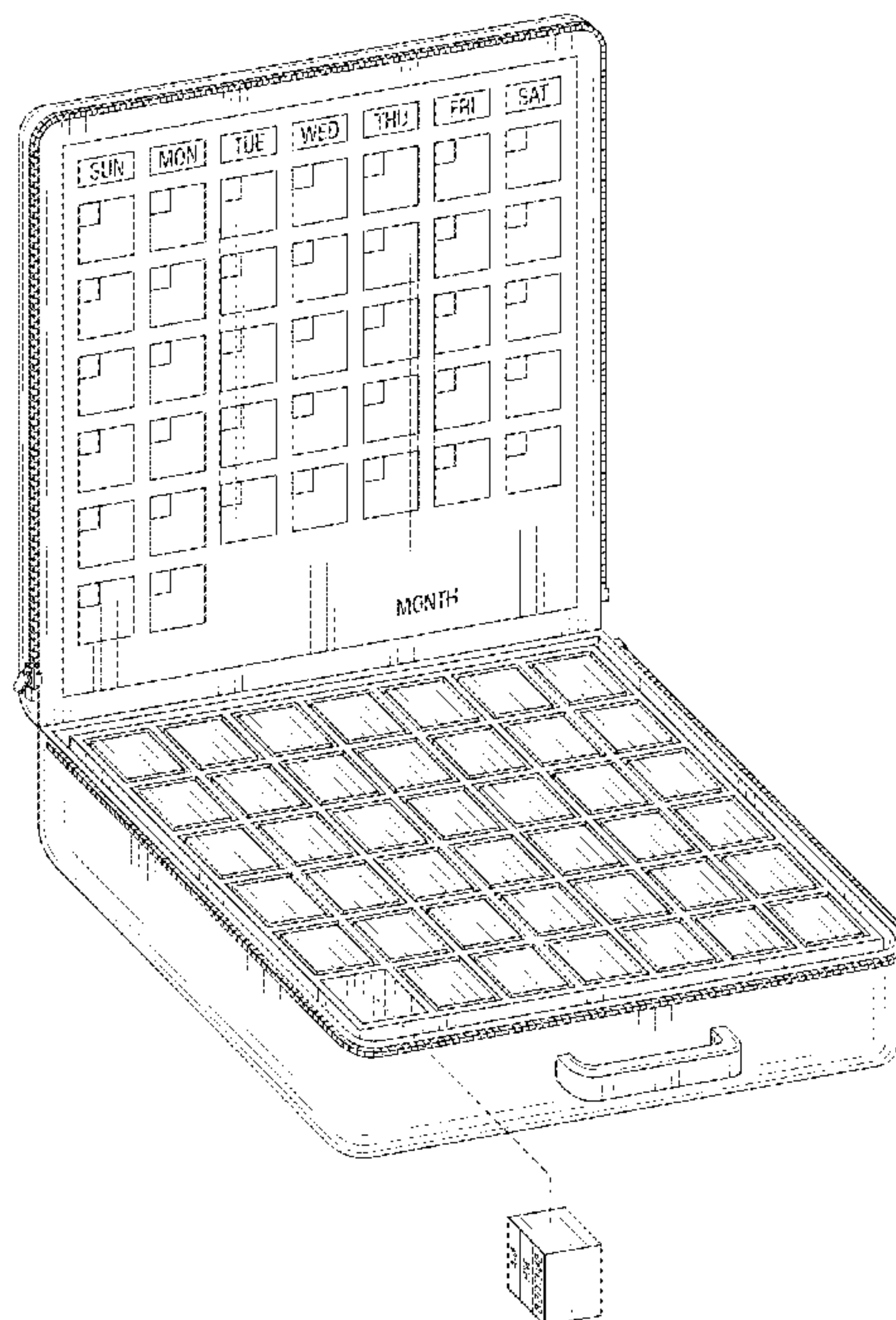

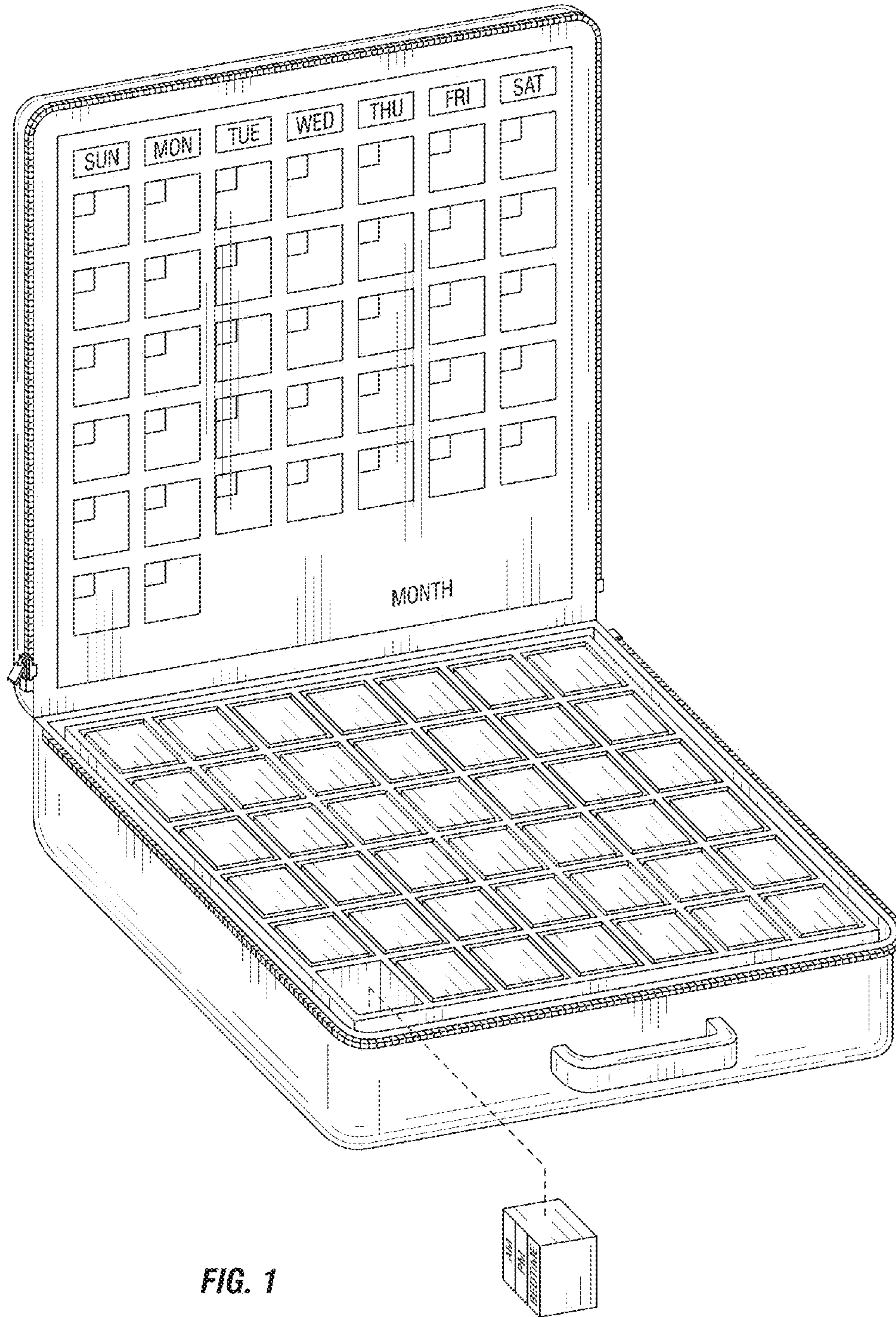

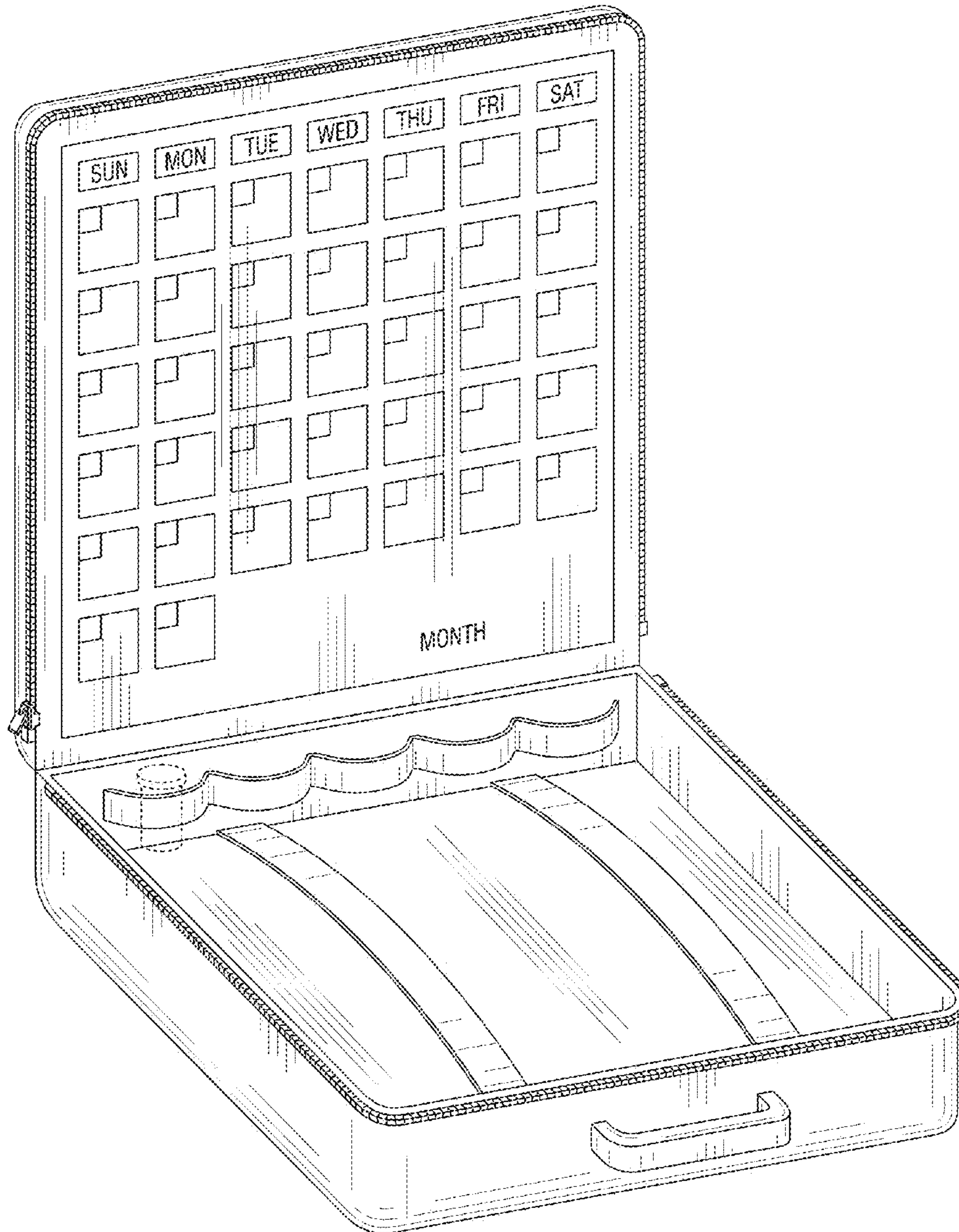

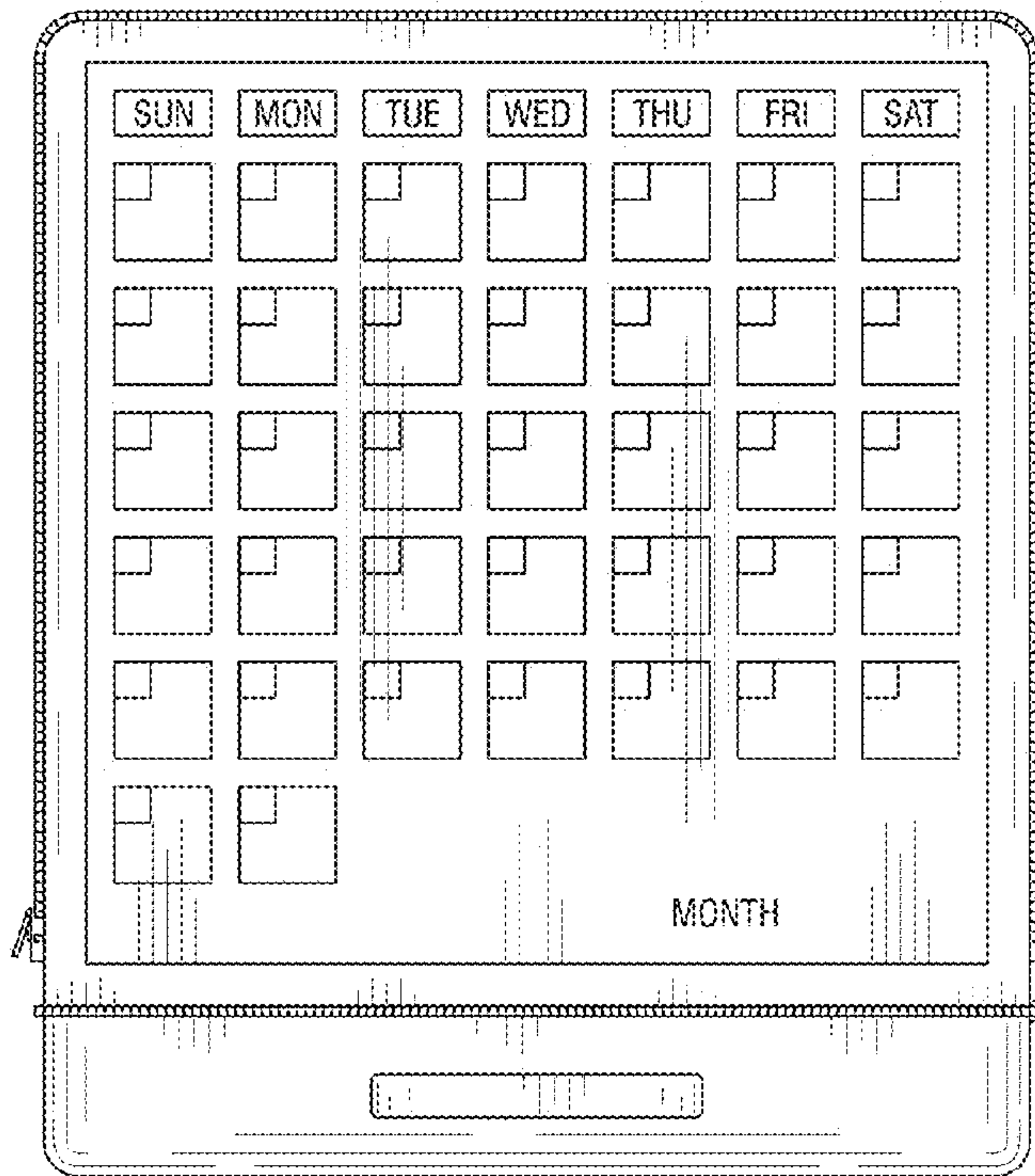

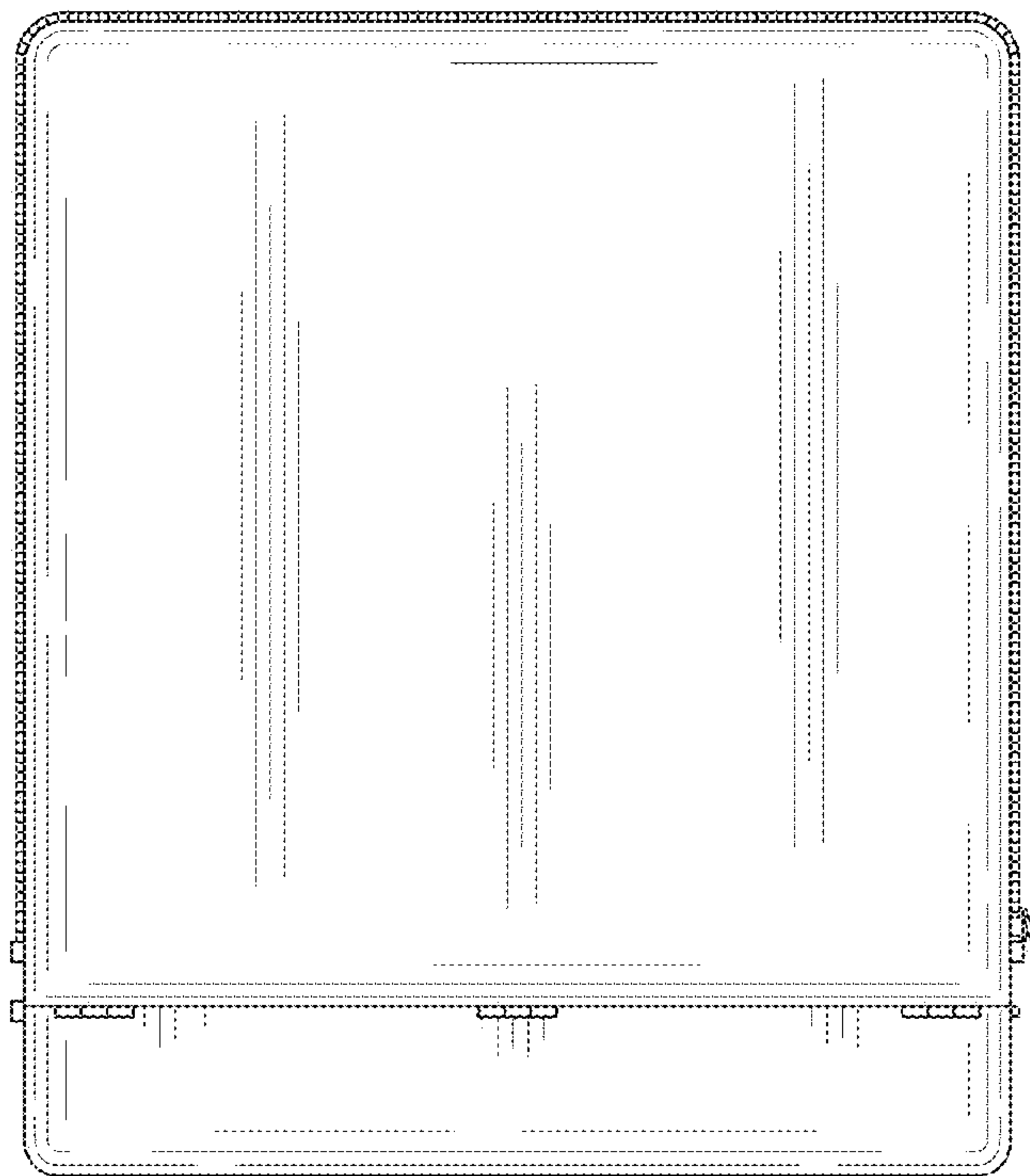

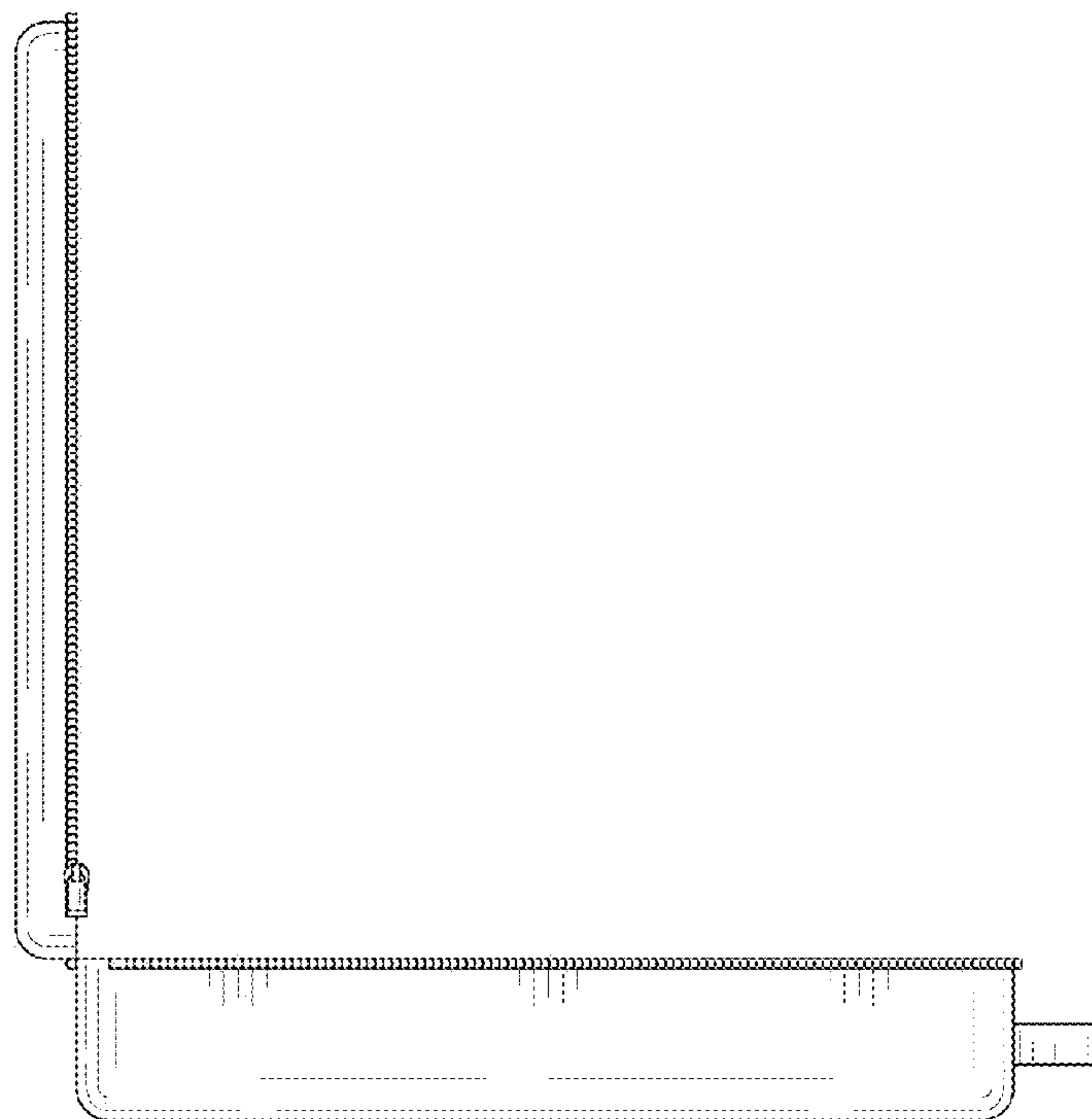

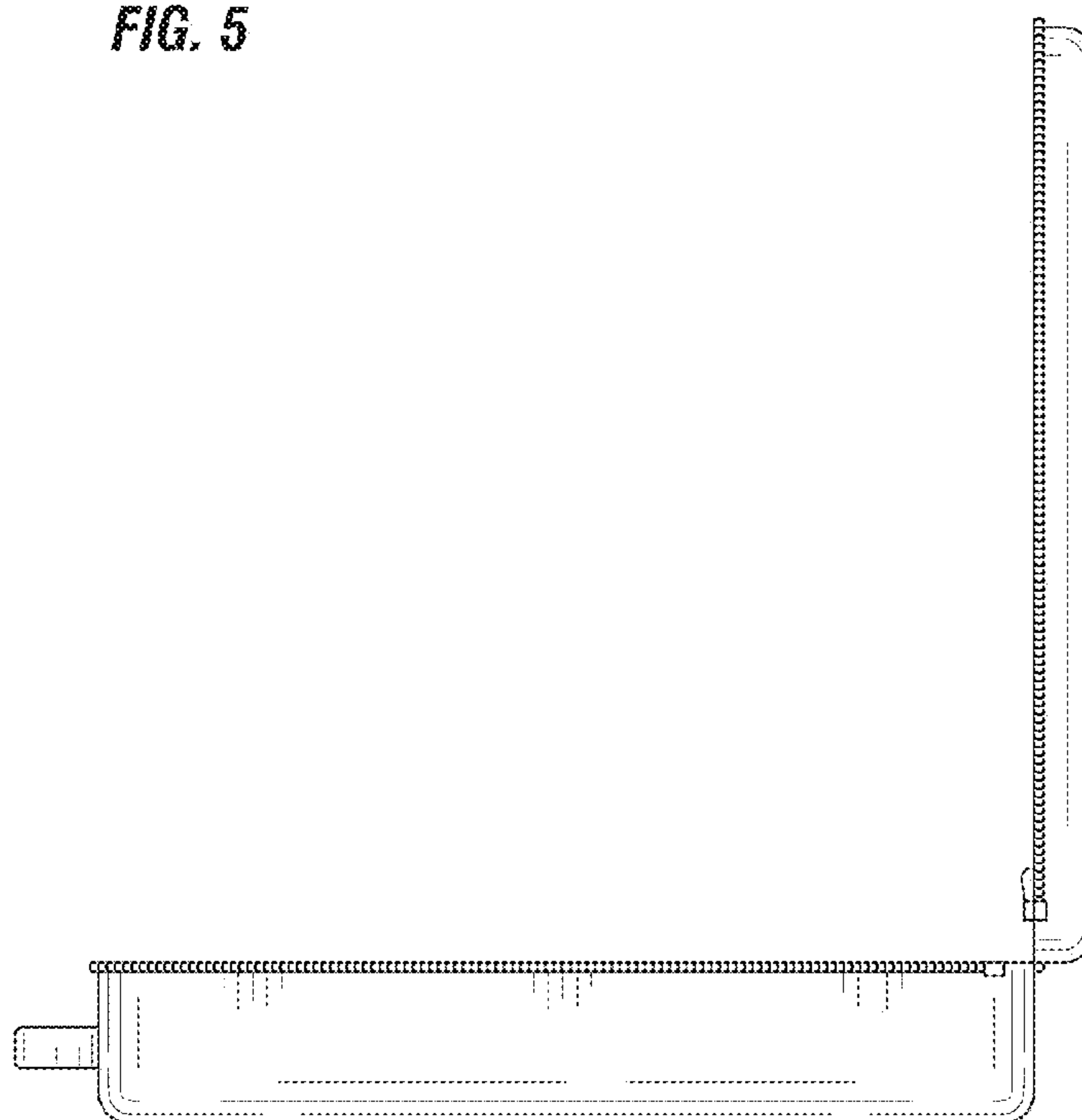
