FIG. 3 is a front view of the design of the eyeglass holder shown in FIG. 1;

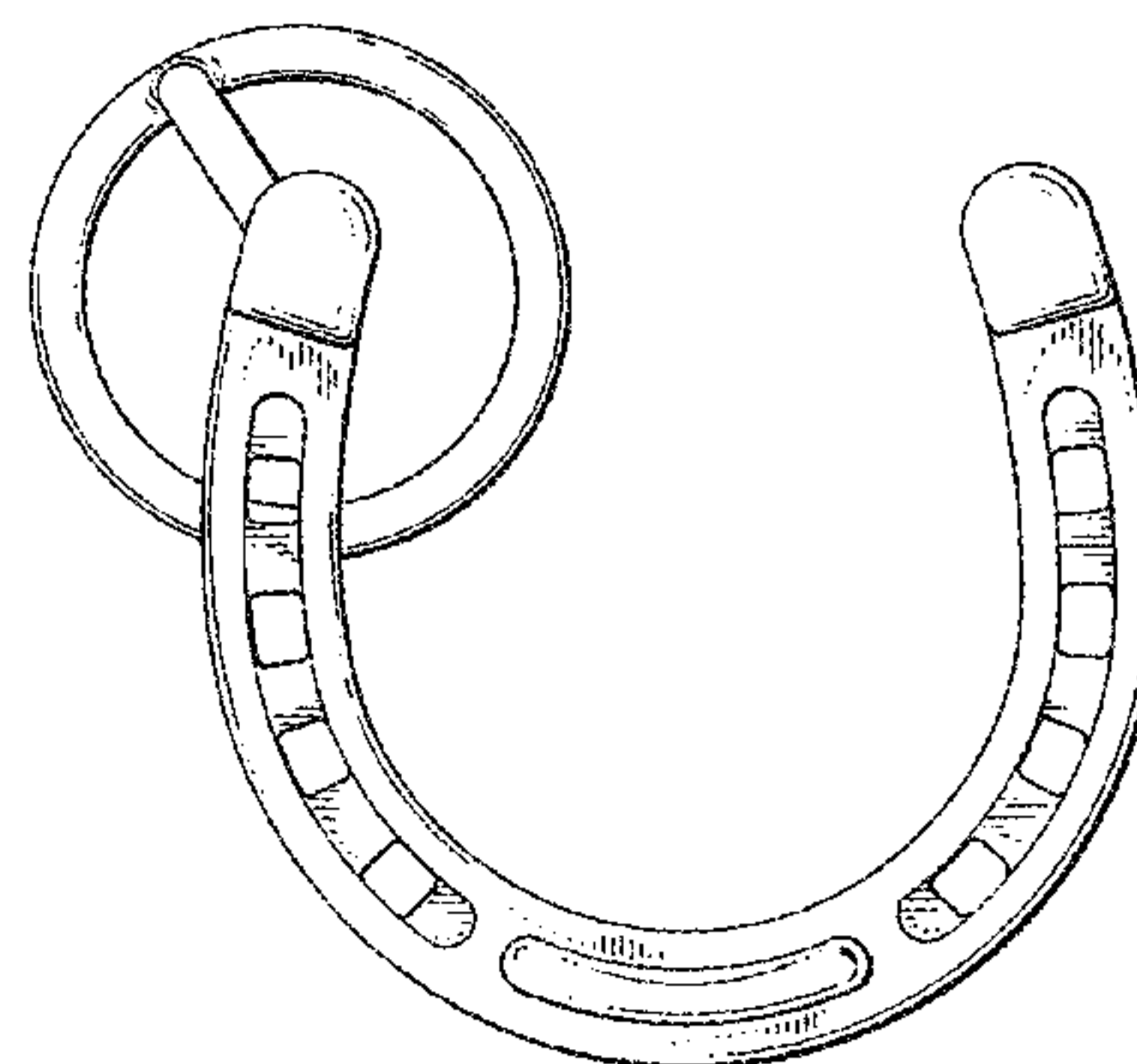
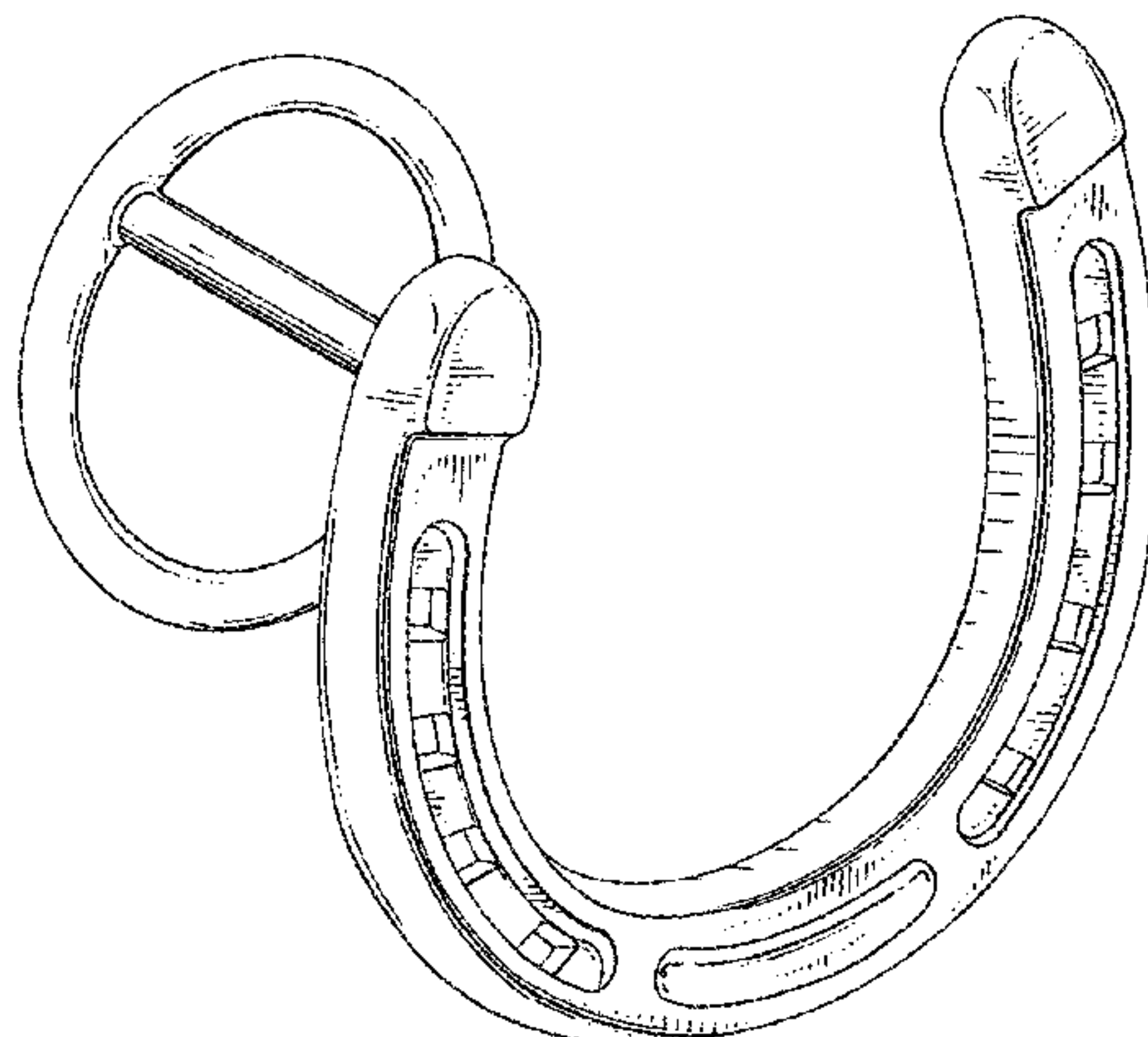
FIG. 4 is a bottom view of the design of the eyeglass holder shown in FIG. 1;

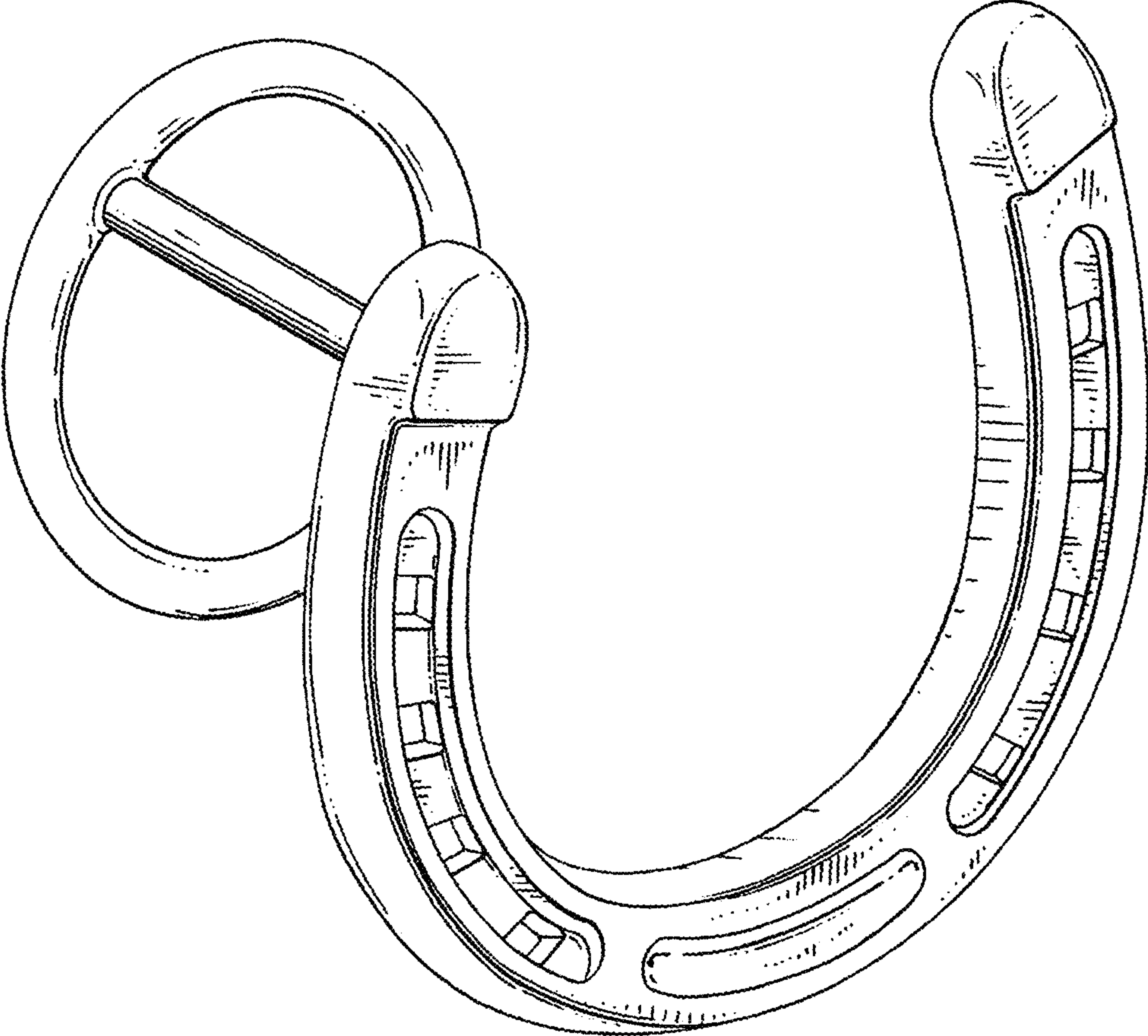

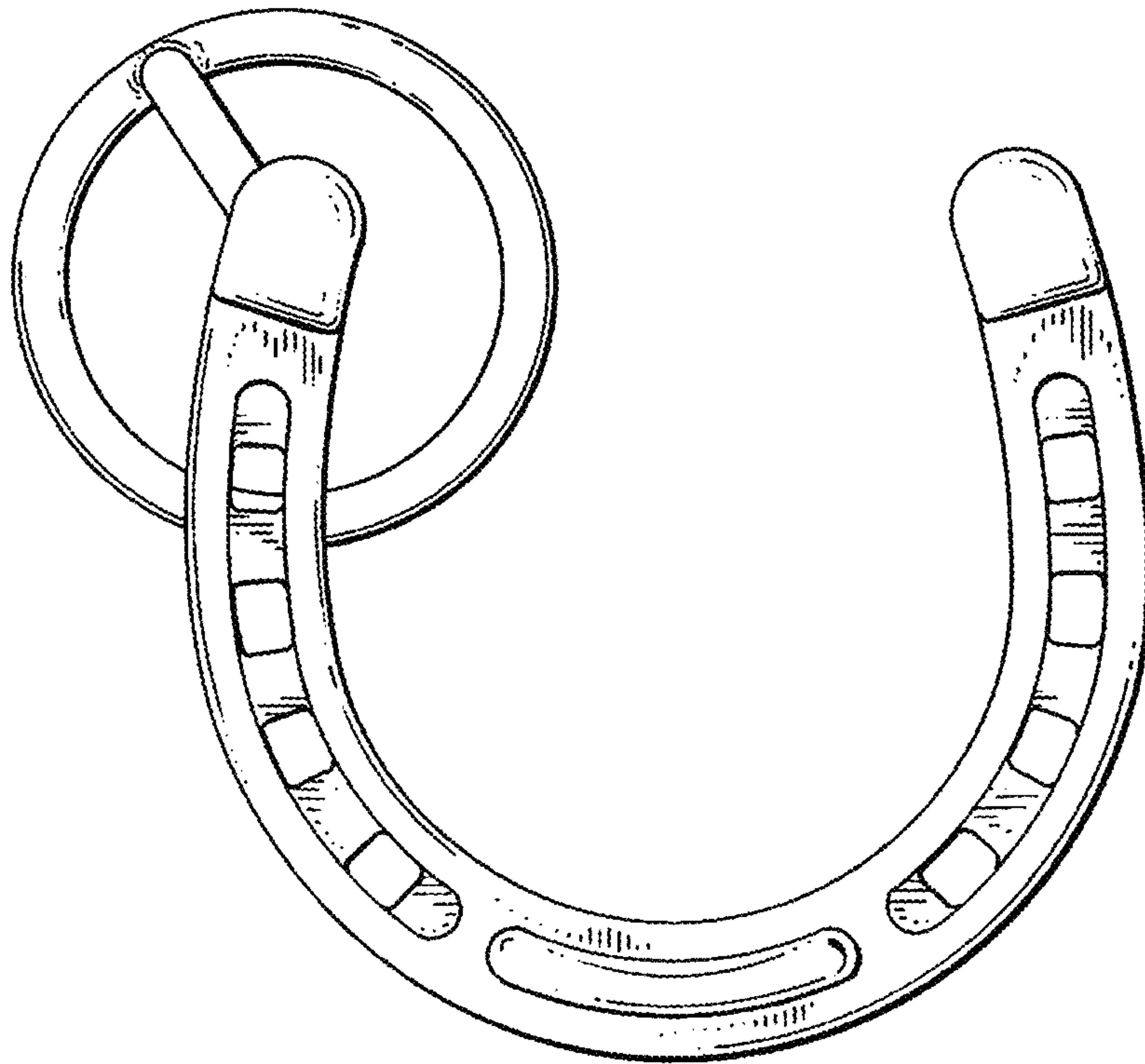
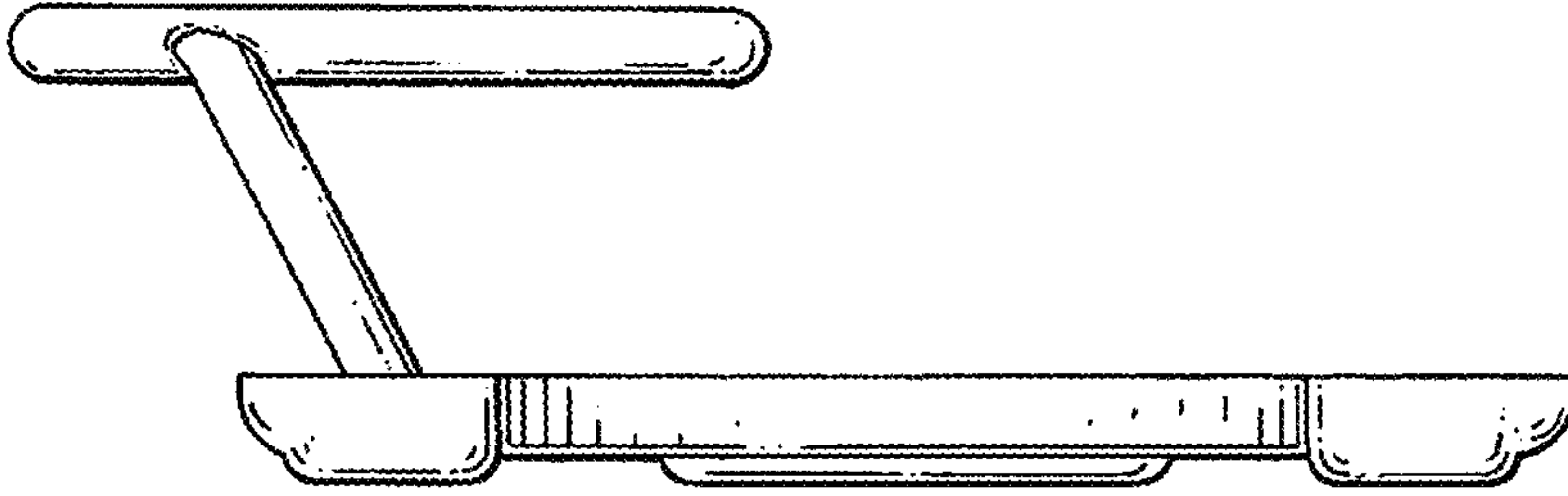

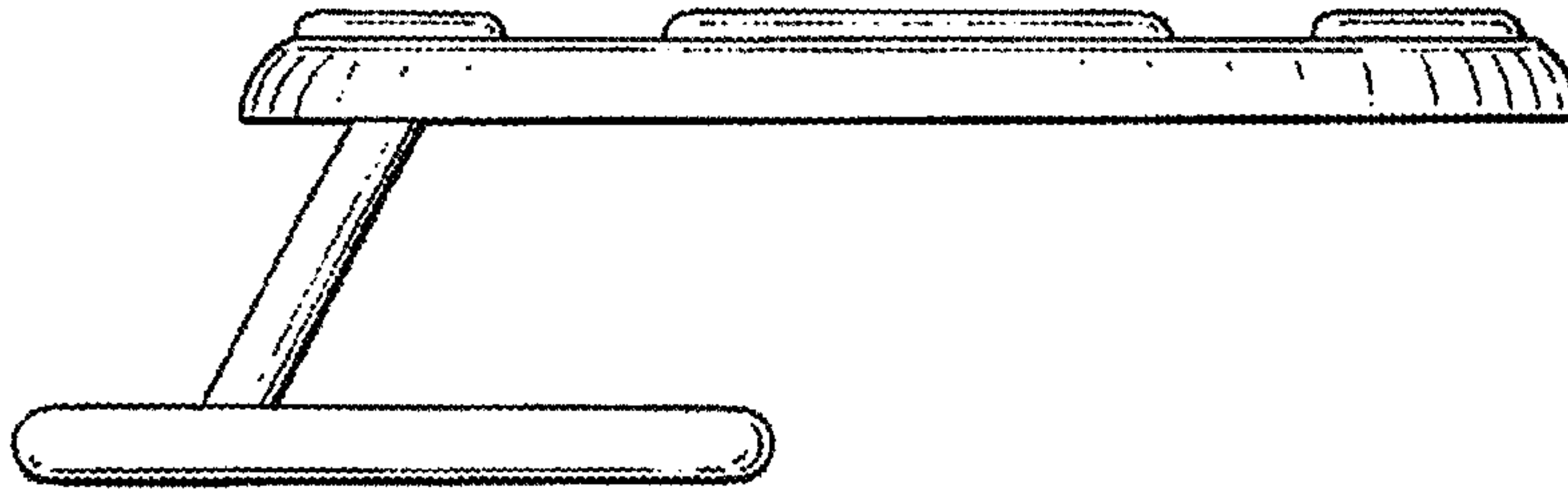

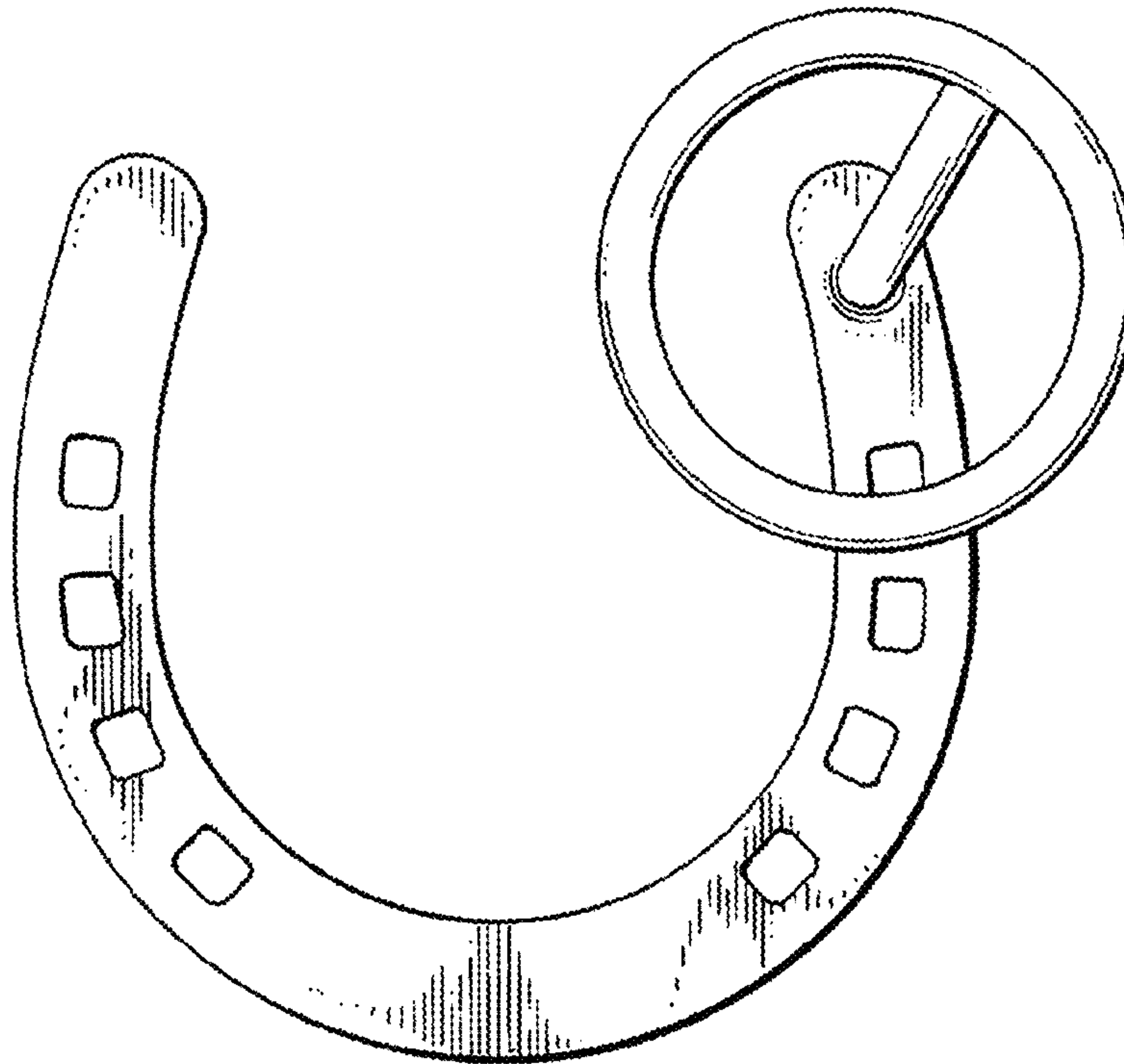
