DESCRIPTION

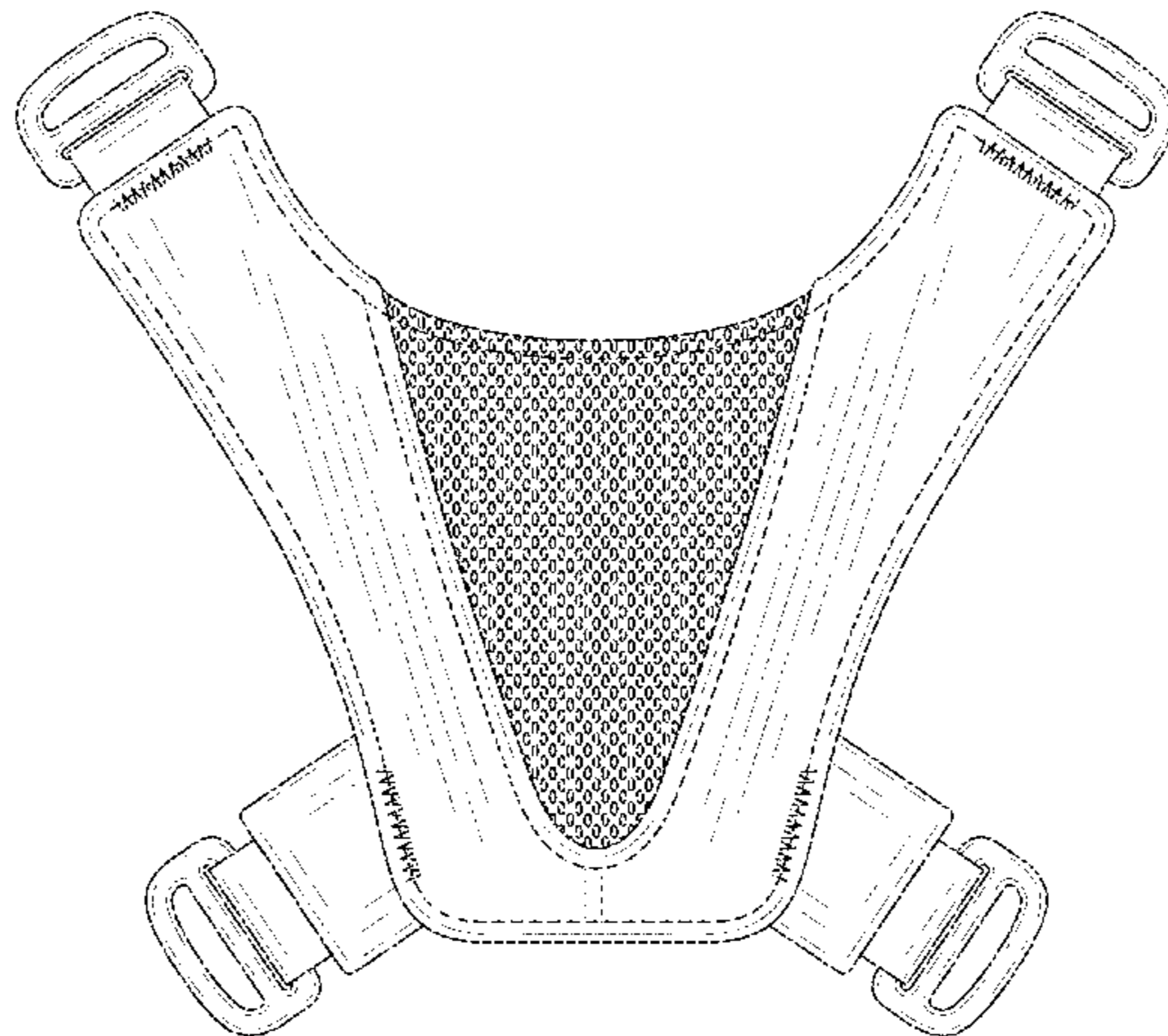
FIG. 1 is a front view of a hub for balanced strap system showing my new design;

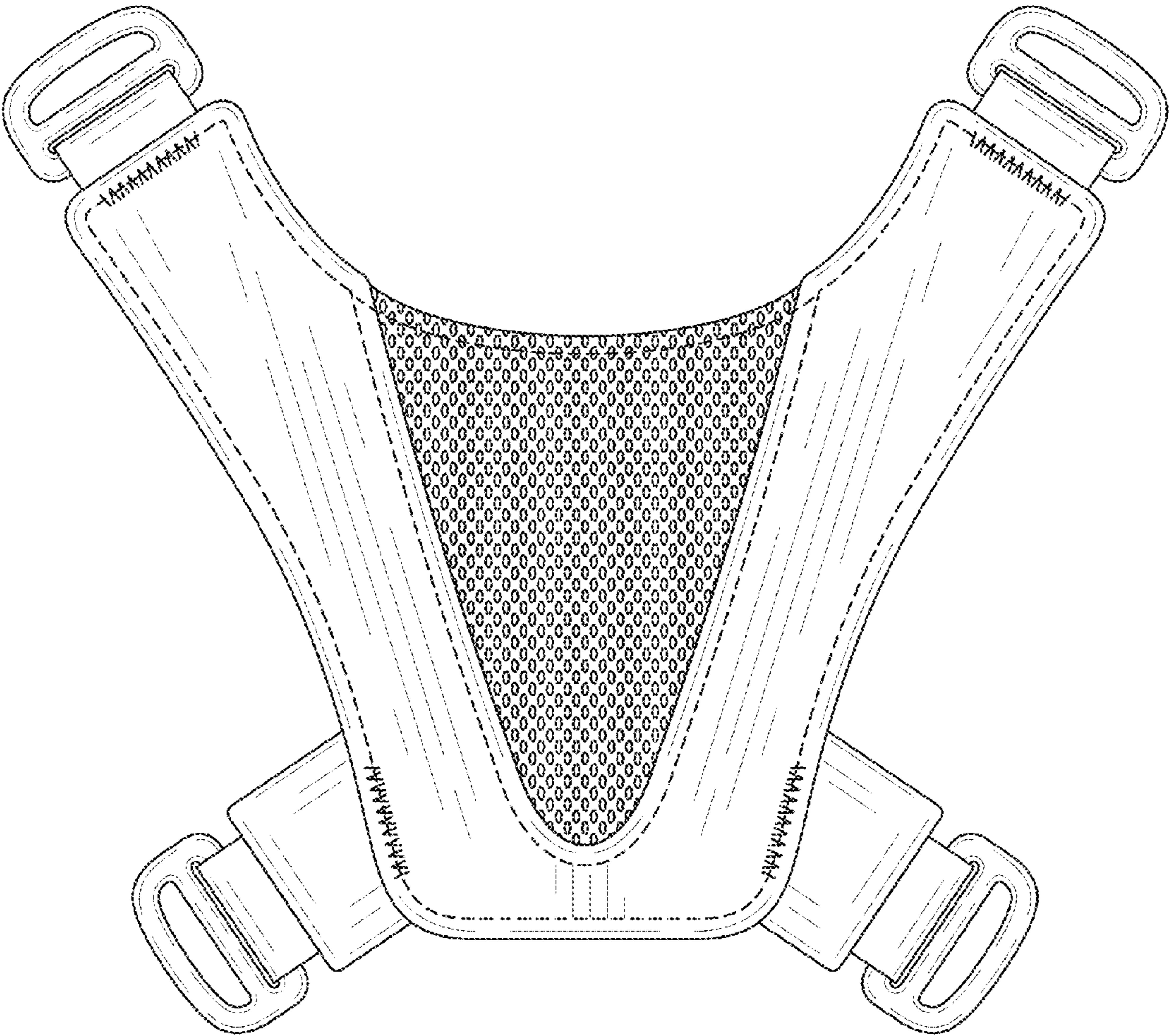

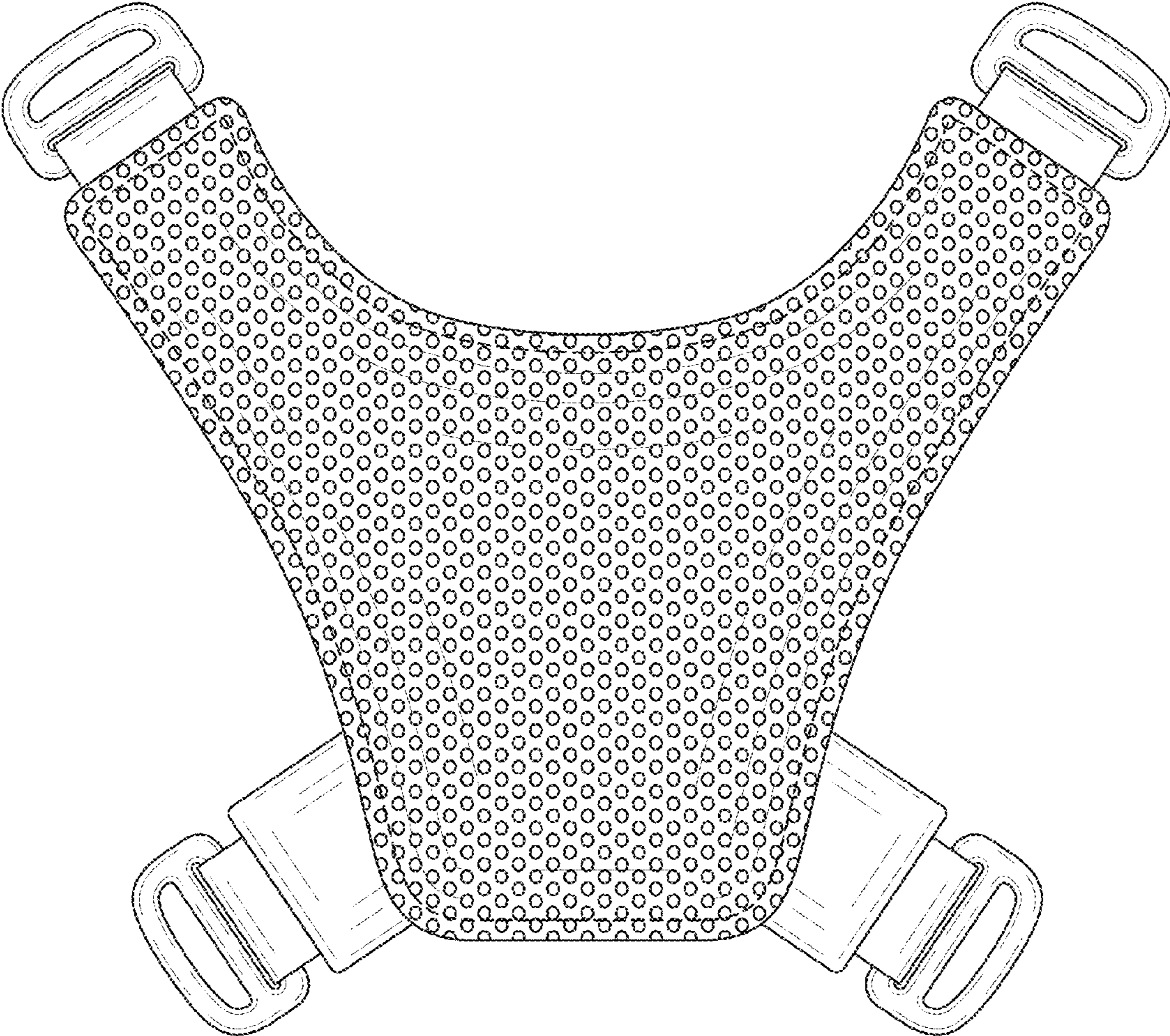

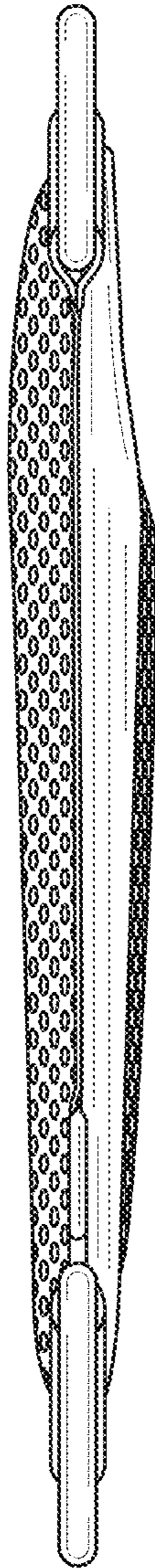
