The ornamental design for a coffeemaker, as shown and described.

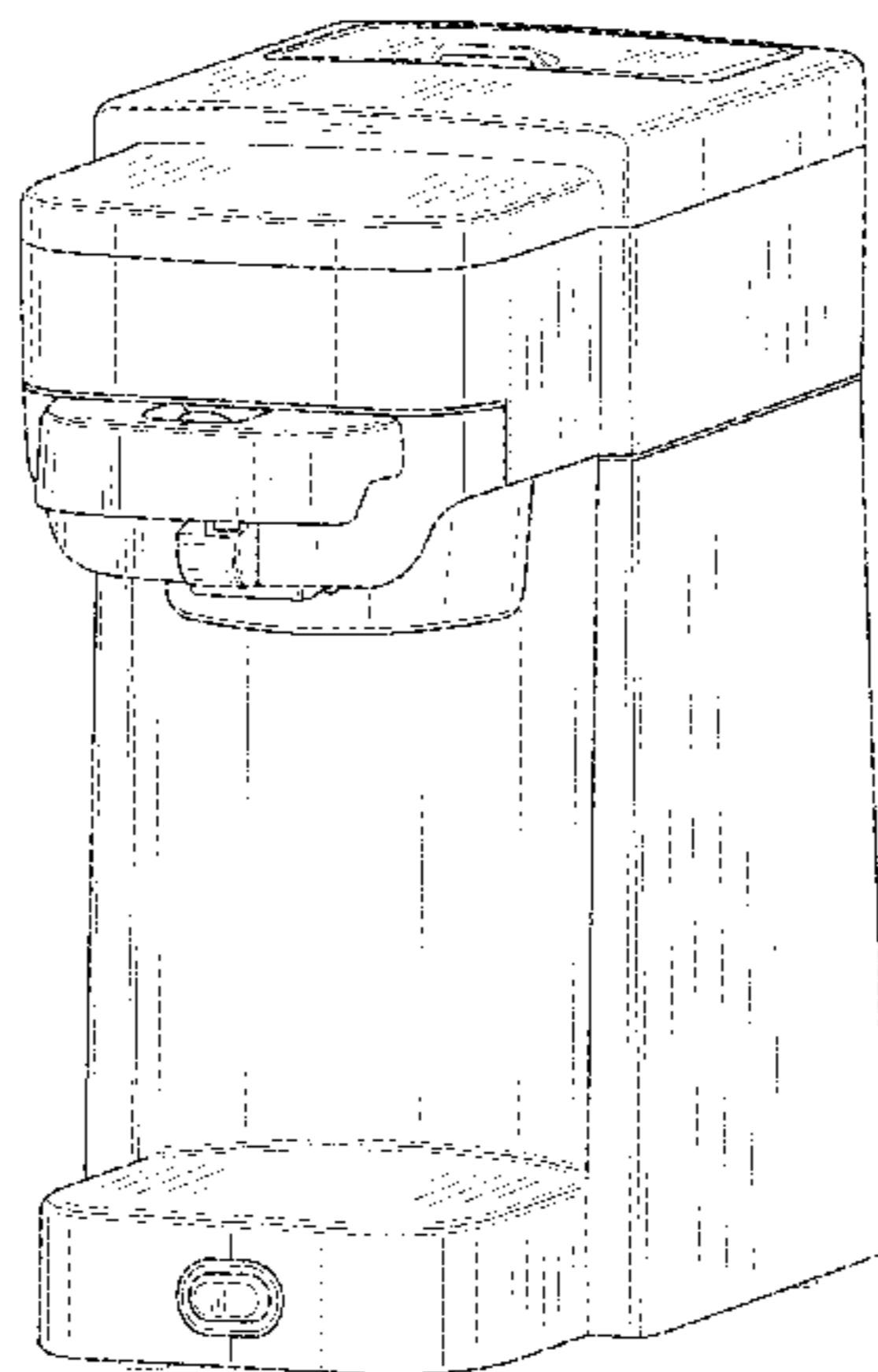
**DESCRIPTION**

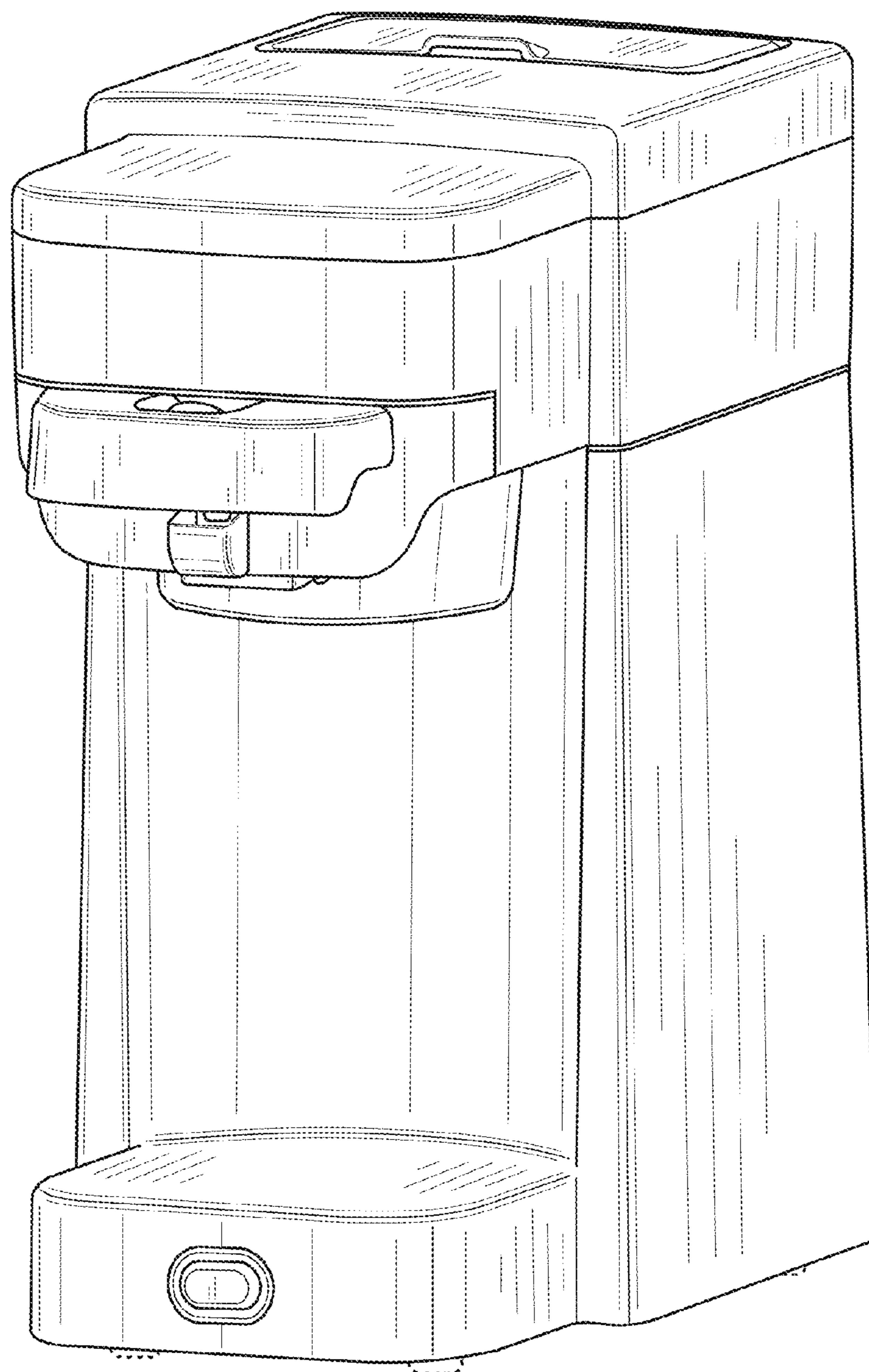
FIG. 1 is a top front right perspective view of a coffeemaker showing our new design;

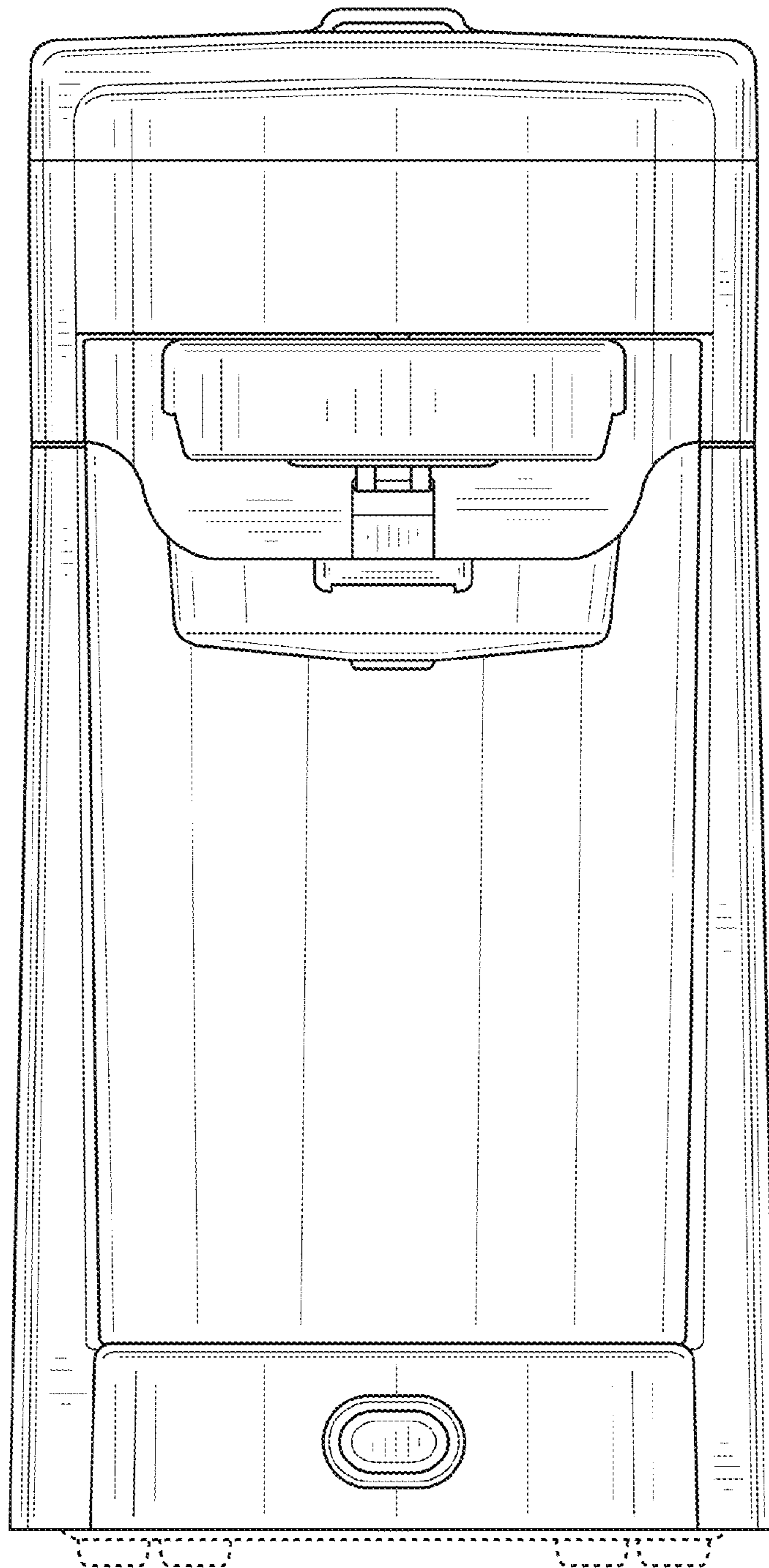

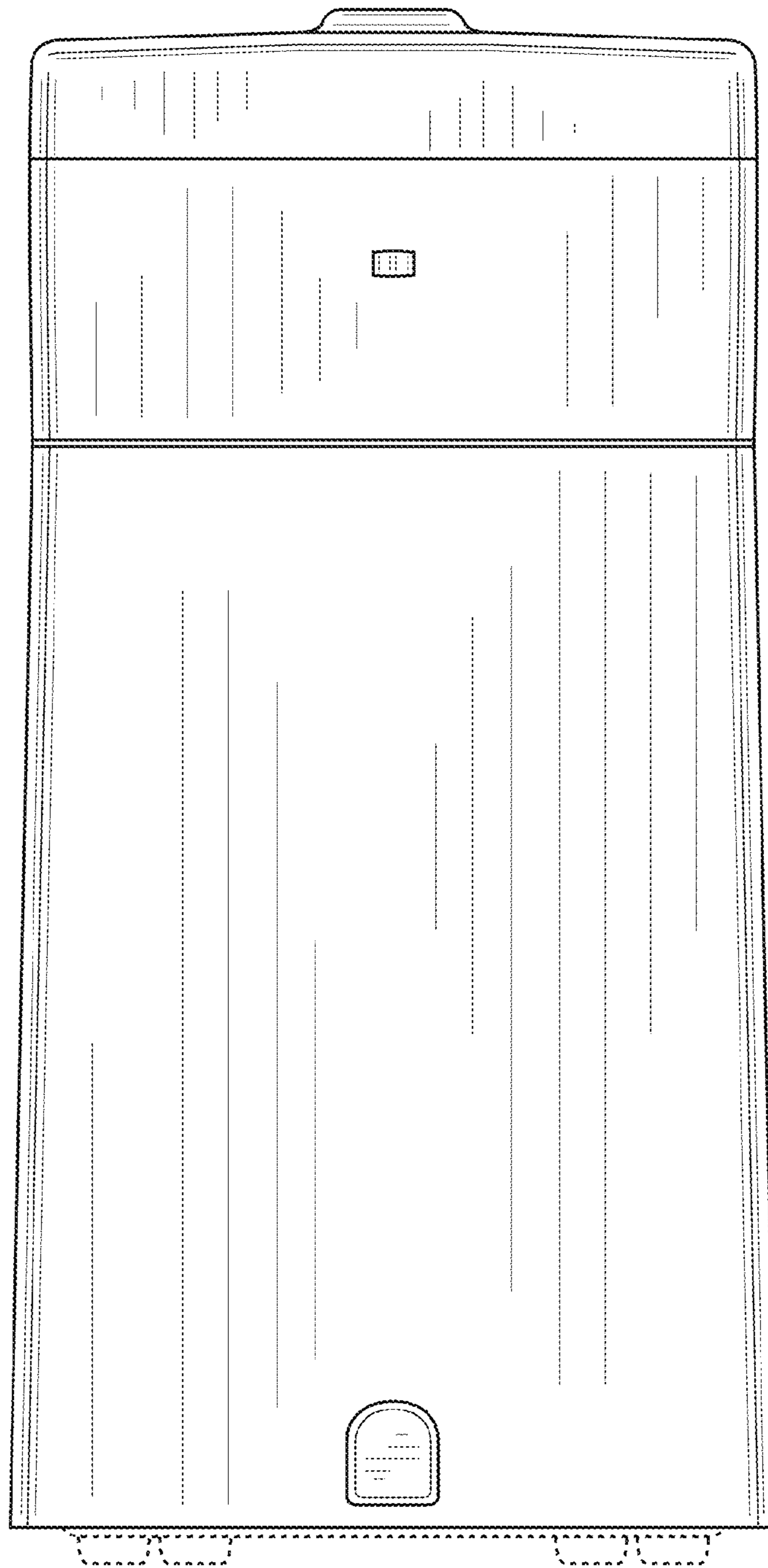




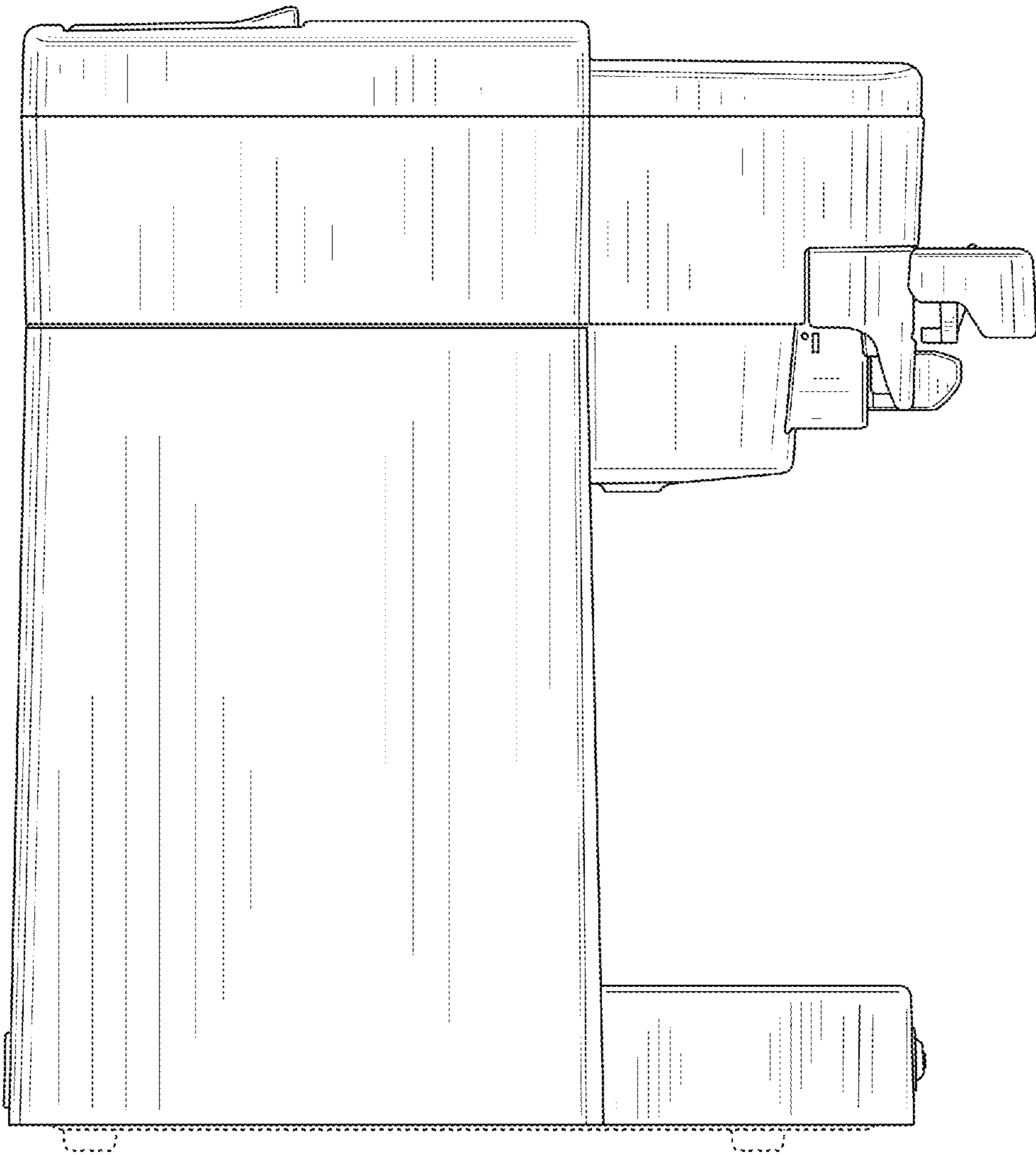

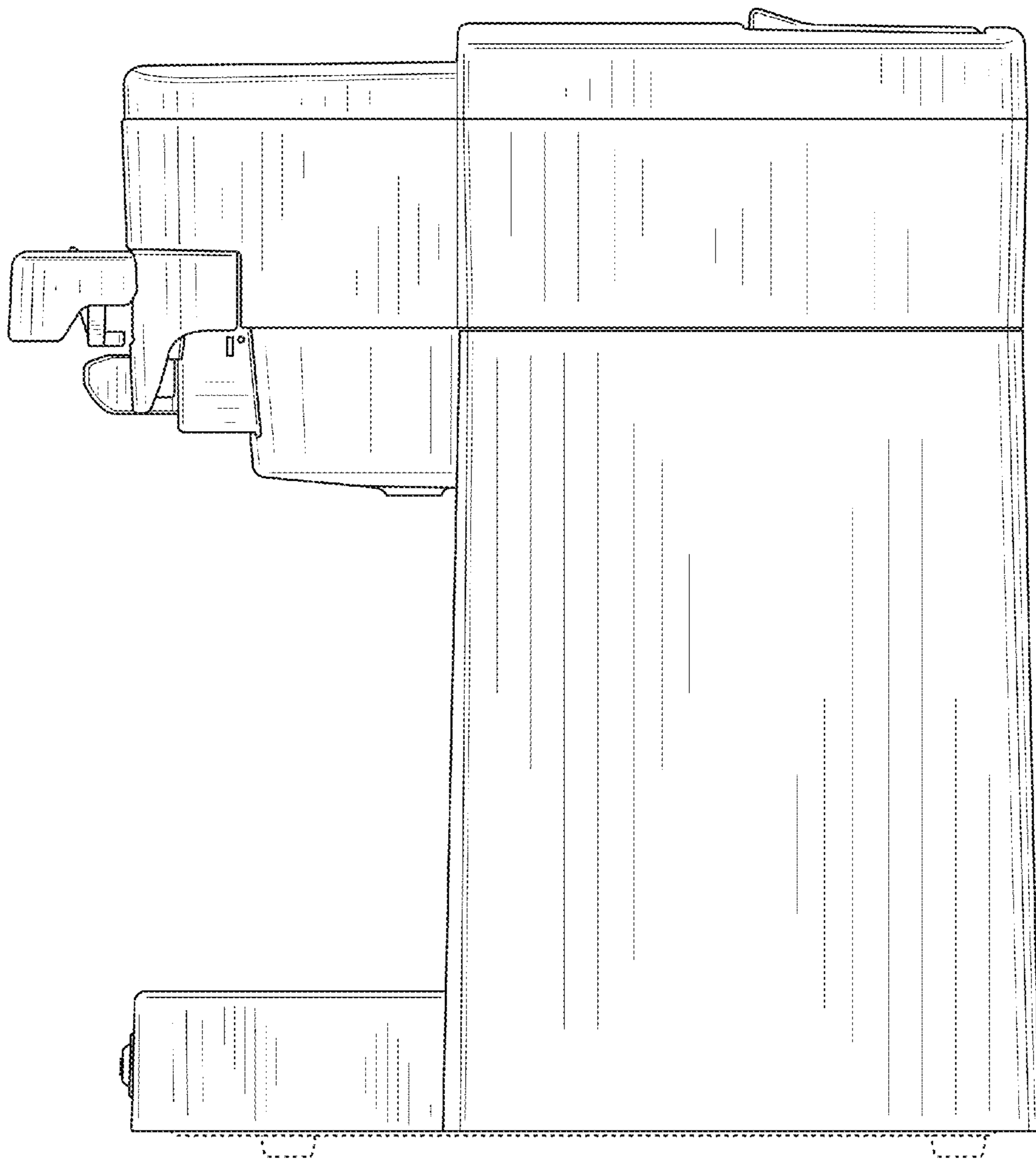

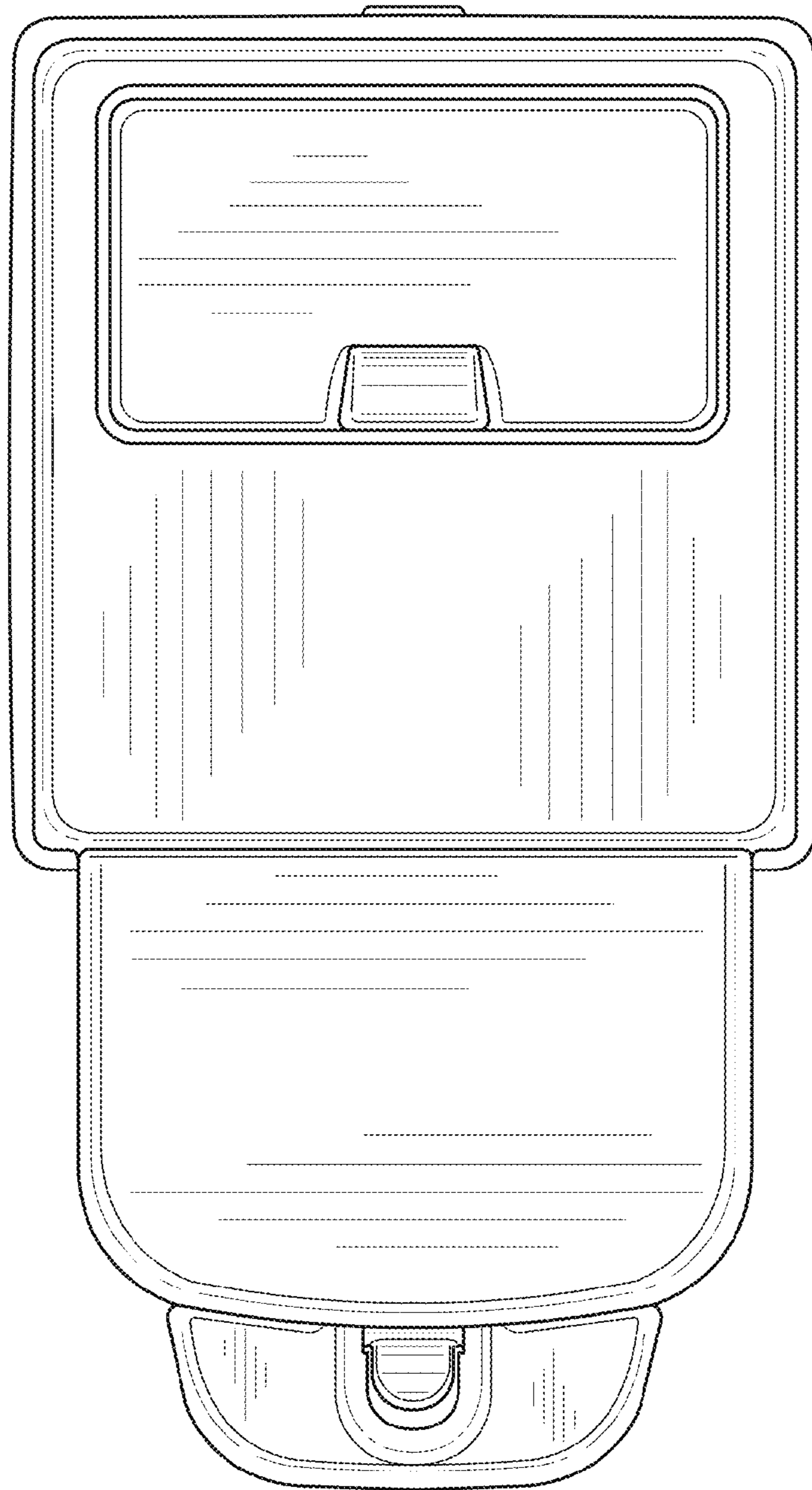

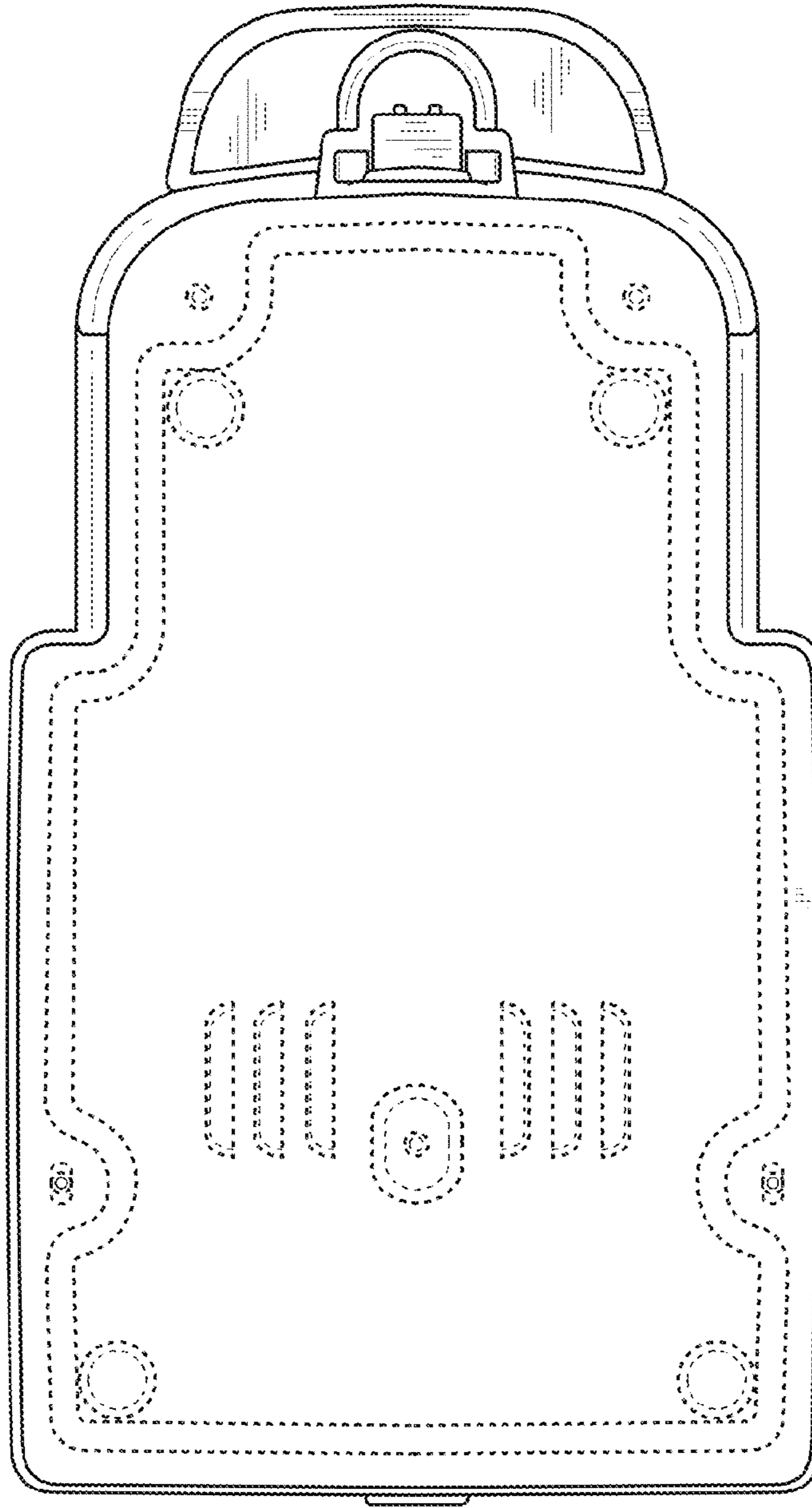
