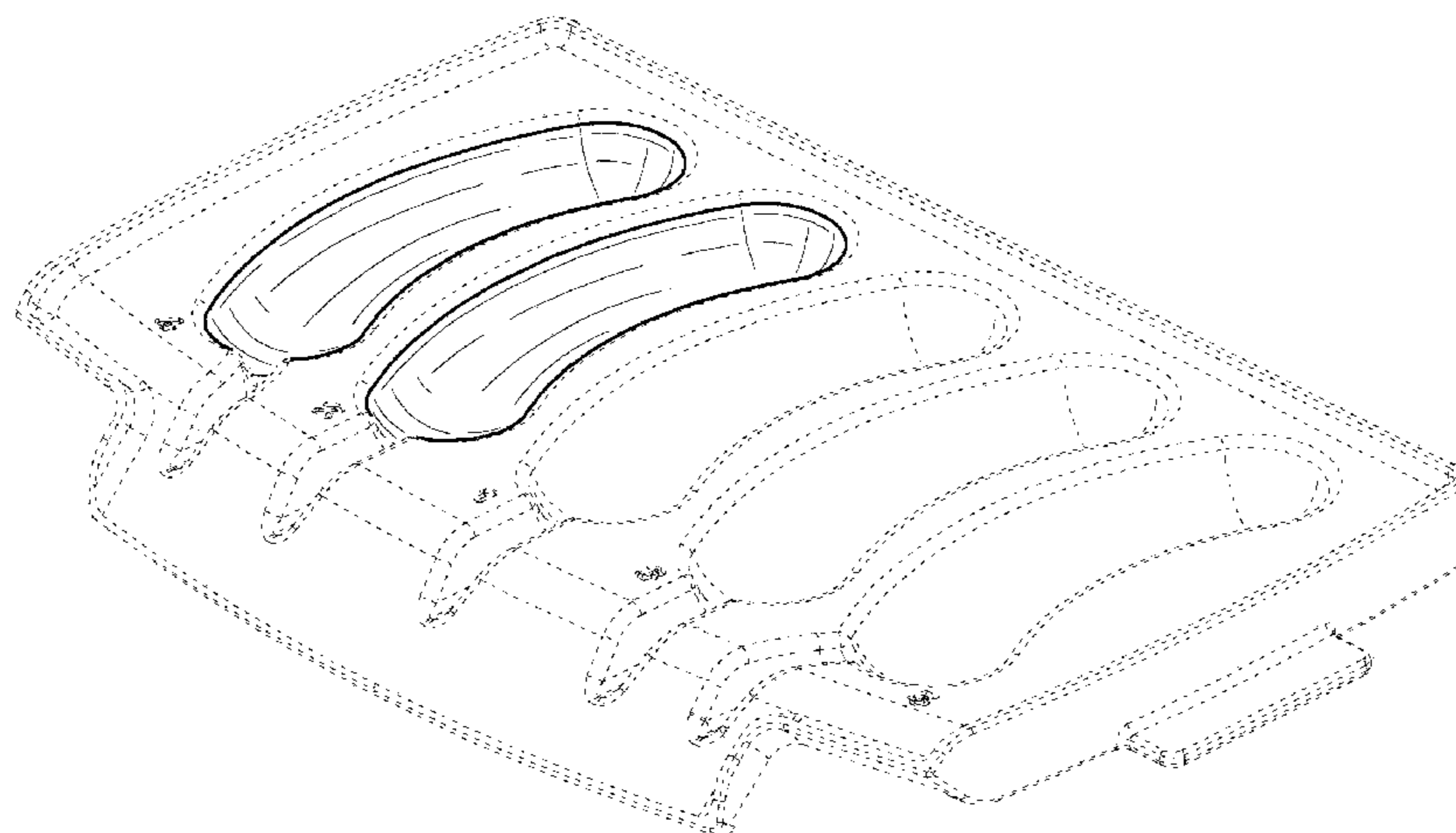
(57) **CLAIM**
The ornamental design for a grill plate, as shown and described.

DESCRIPTION

FIG. 1 is a top, left side perspective view of a grill plate embodying our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof.
FIG. 4 is a front elevational view thereof.
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right elevational view thereof; and,
FIG. 7 is a rear elevational view thereof.
The broken line representations of items in FIGS. 1-7 are for purposes of illustration only, and form no part of the claimed design.
In a preferred embodiment, the nature of this product is a grill plate for use in a grill for cooking and/or heating food items.

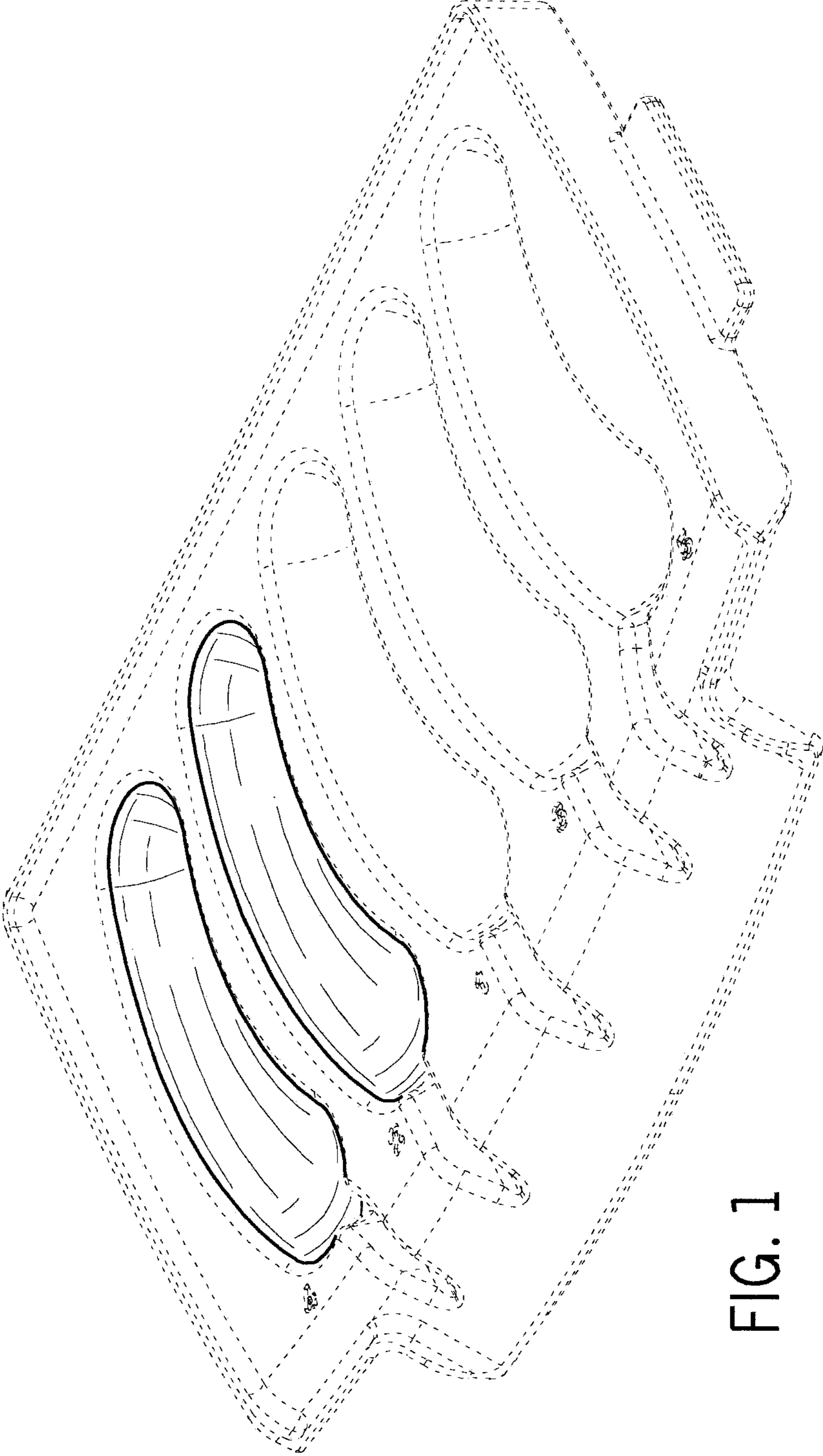

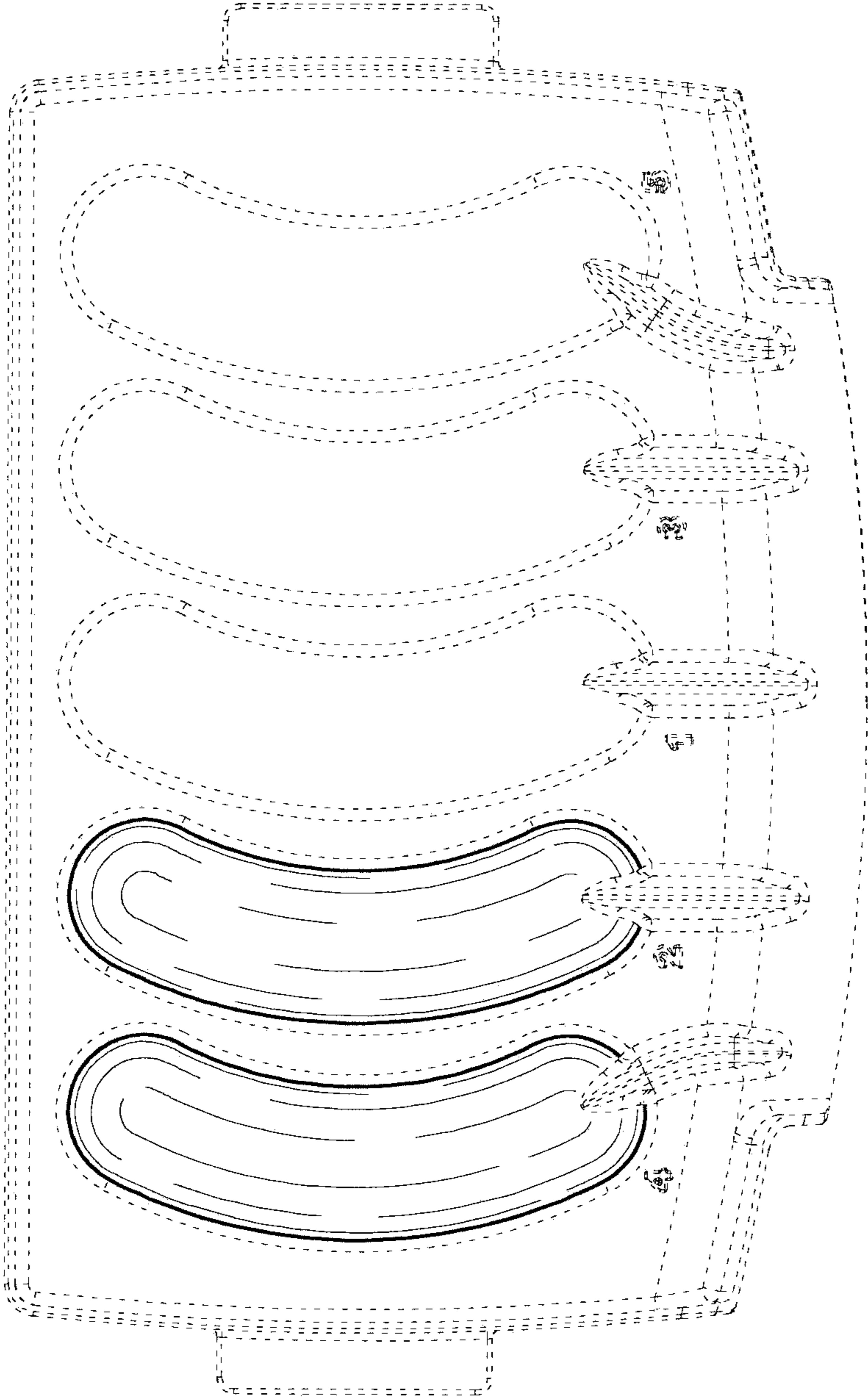

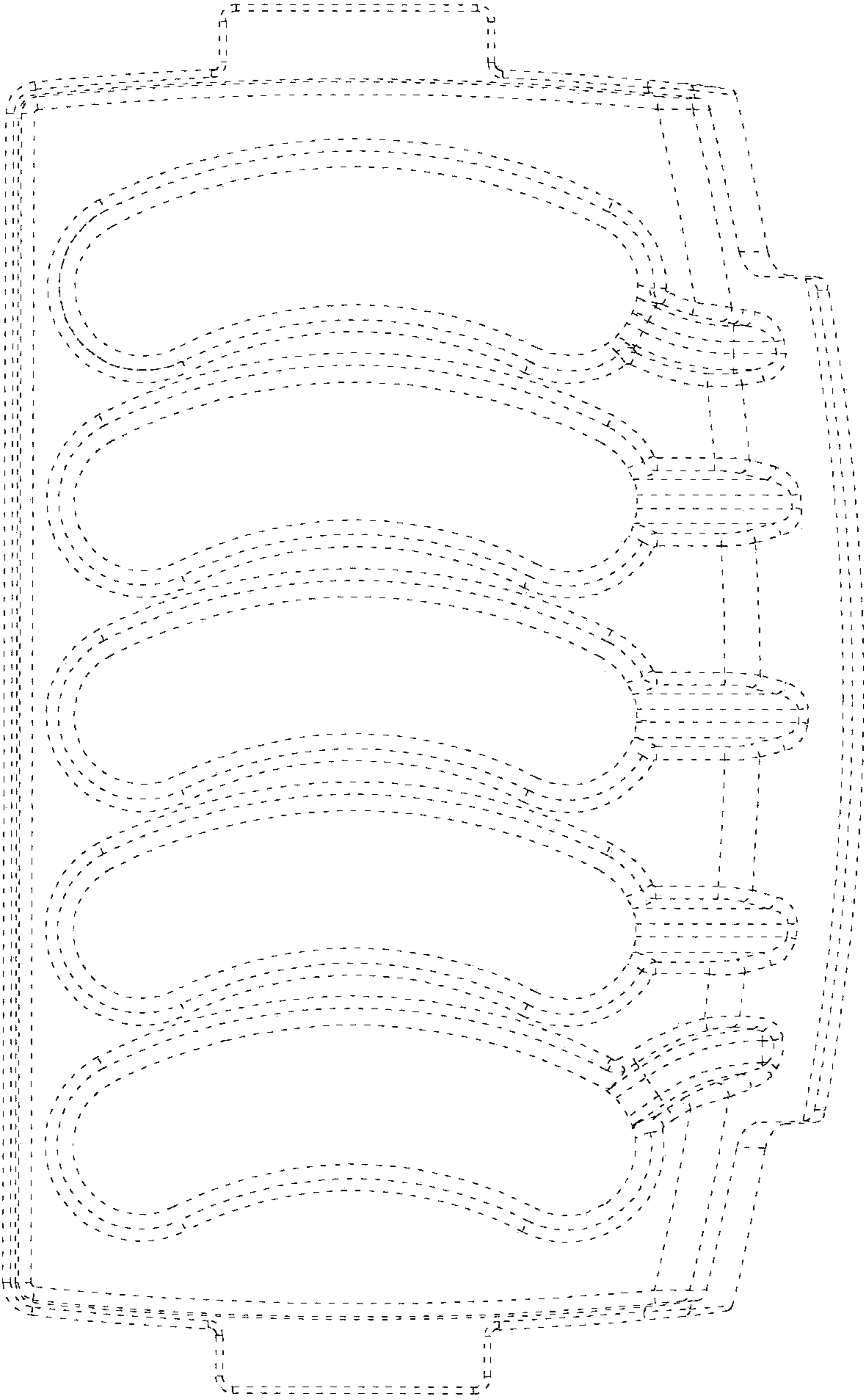

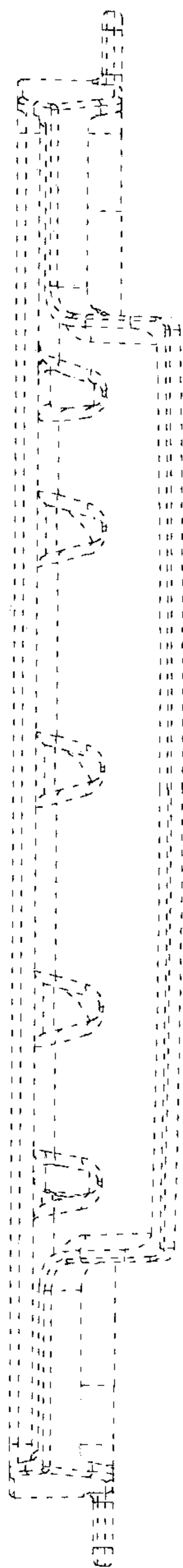

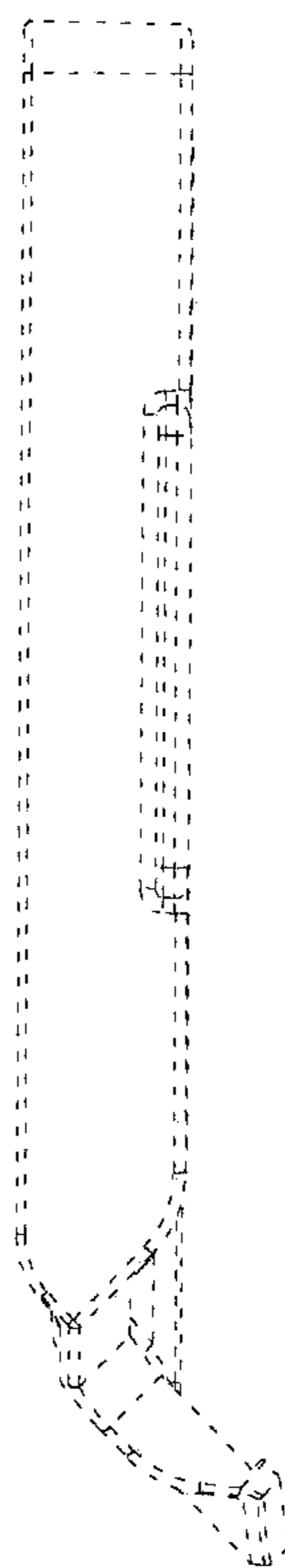

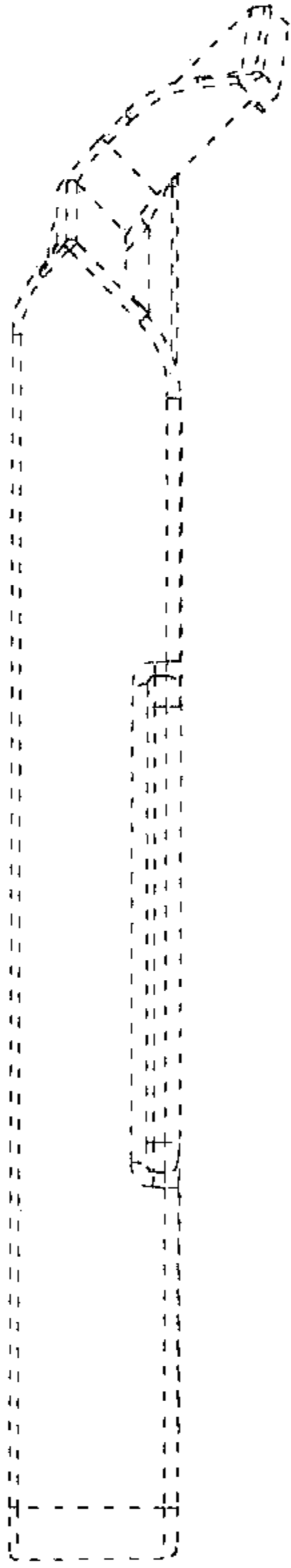
