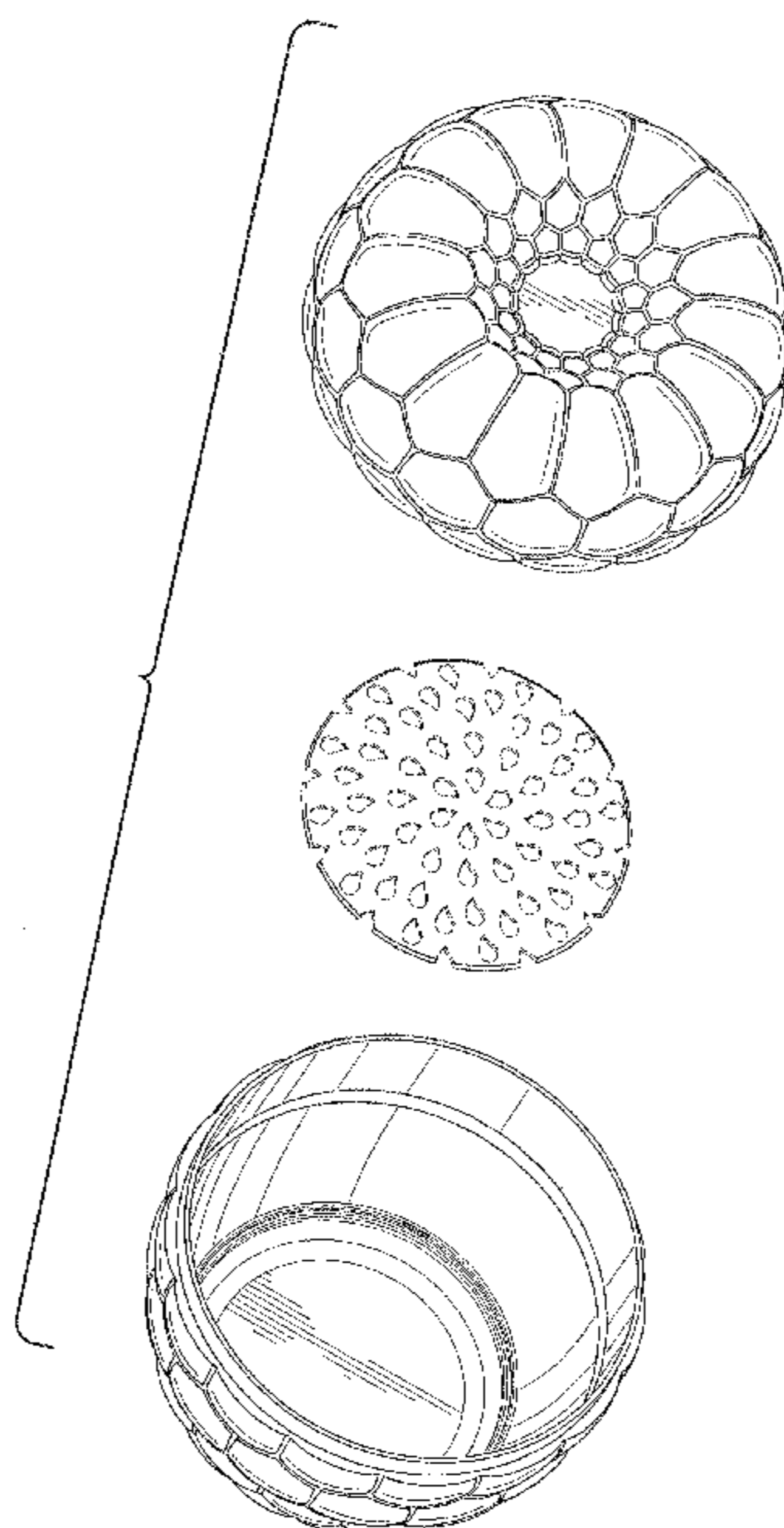
(57) **CLAIM**
The ornamental design for a raspberry container, as shown and described.

DESCRIPTION

FIG. 1 is an exploded top perspective view of a raspberry container showing my new design;
FIG. 2 is an exploded bottom perspective view thereof;
FIG. 3 is an exploded front elevation view thereof;
FIG. 4 is an exploded rear elevation view thereof;
FIG. 5 is an exploded left side elevation view thereof;
FIG. 6 is an exploded right side elevation view thereof;
FIG. 7 is an exploded top plan view thereof;
FIG. 8 is an exploded bottom plan view thereof;
FIG. 9 is a closed perspective view thereof; and,
FIG. 10 is a closed front elevation view thereof.
The broken lines shown illustrate portions of the raspberry container and forms no part of the claimed design.

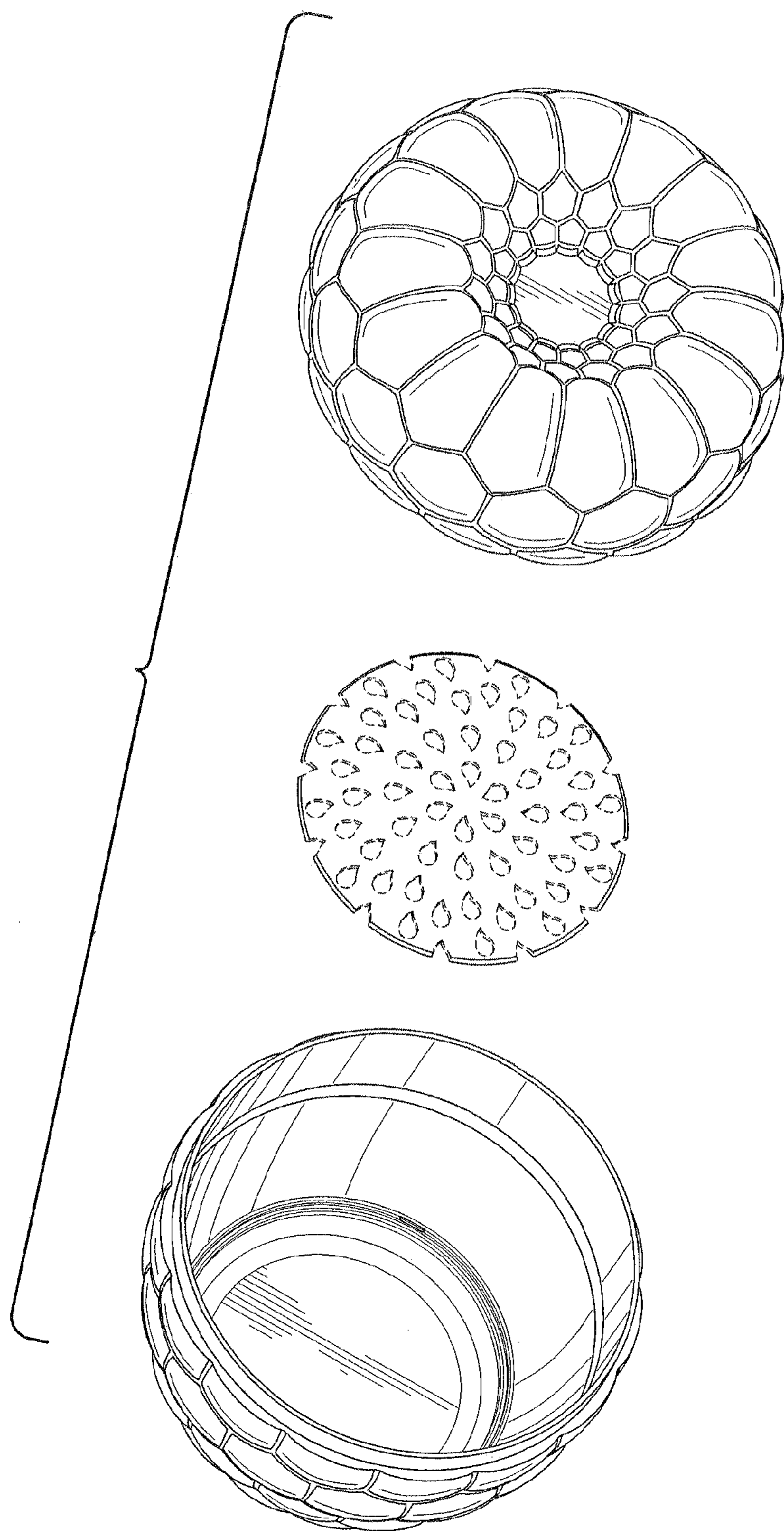

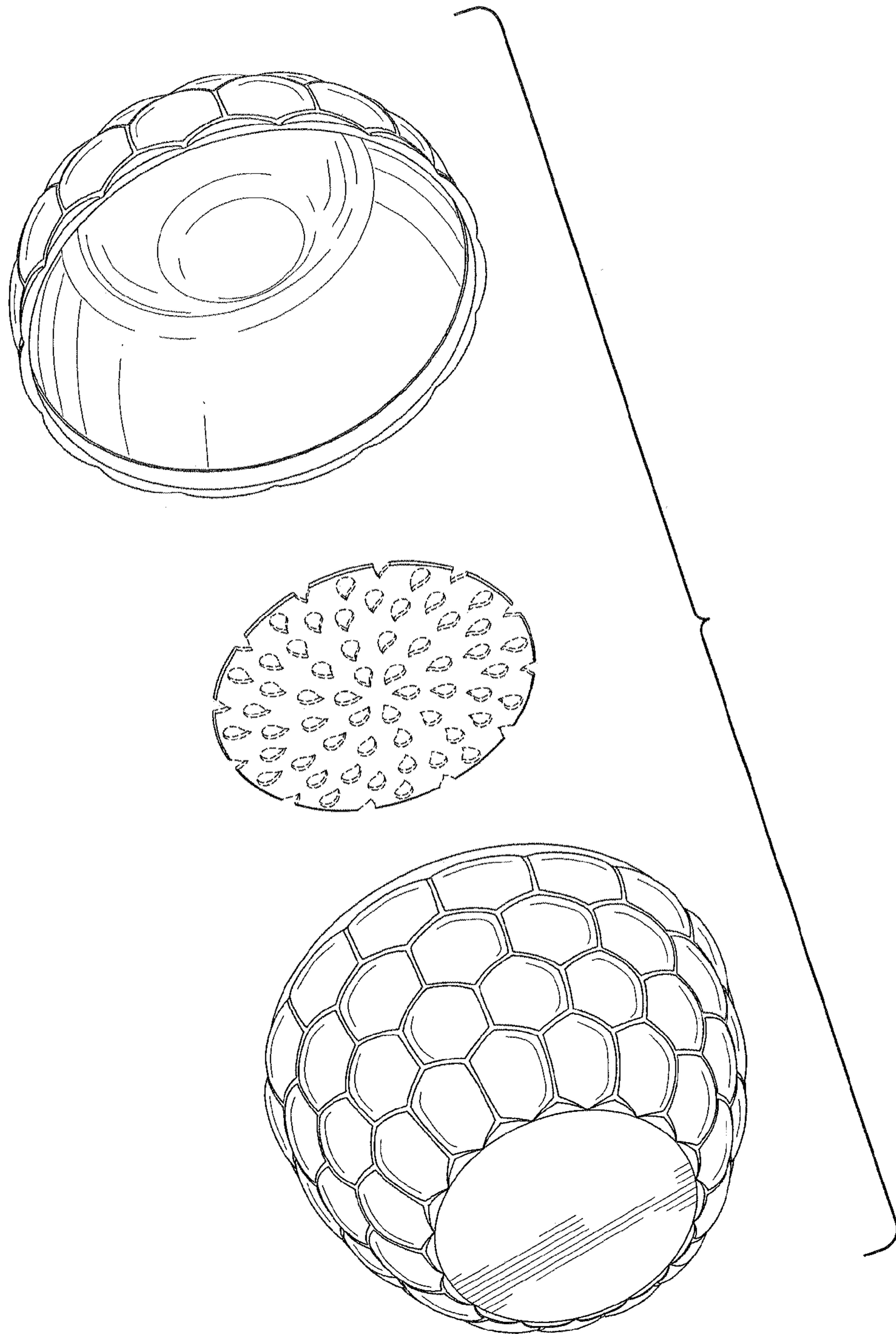

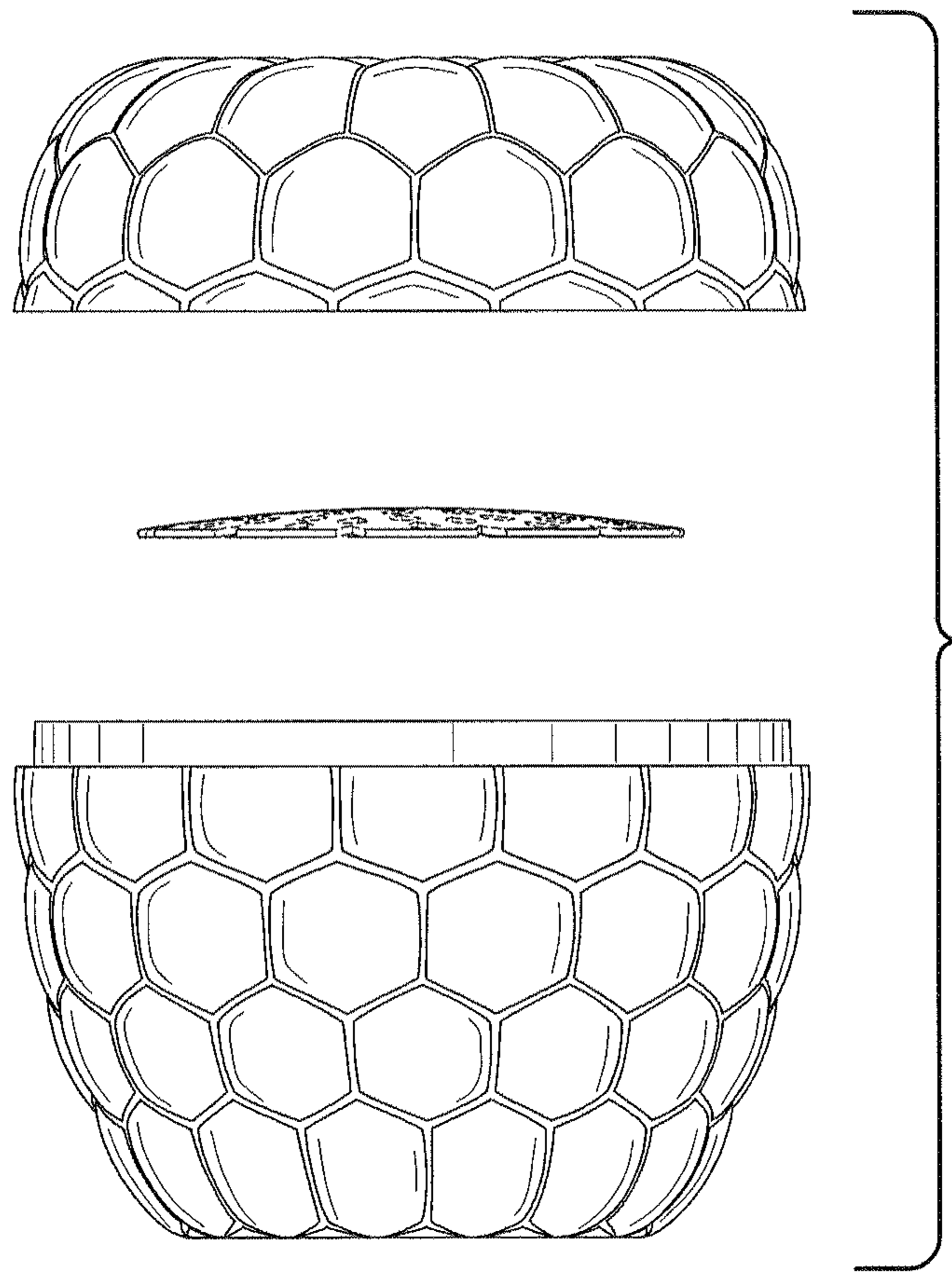

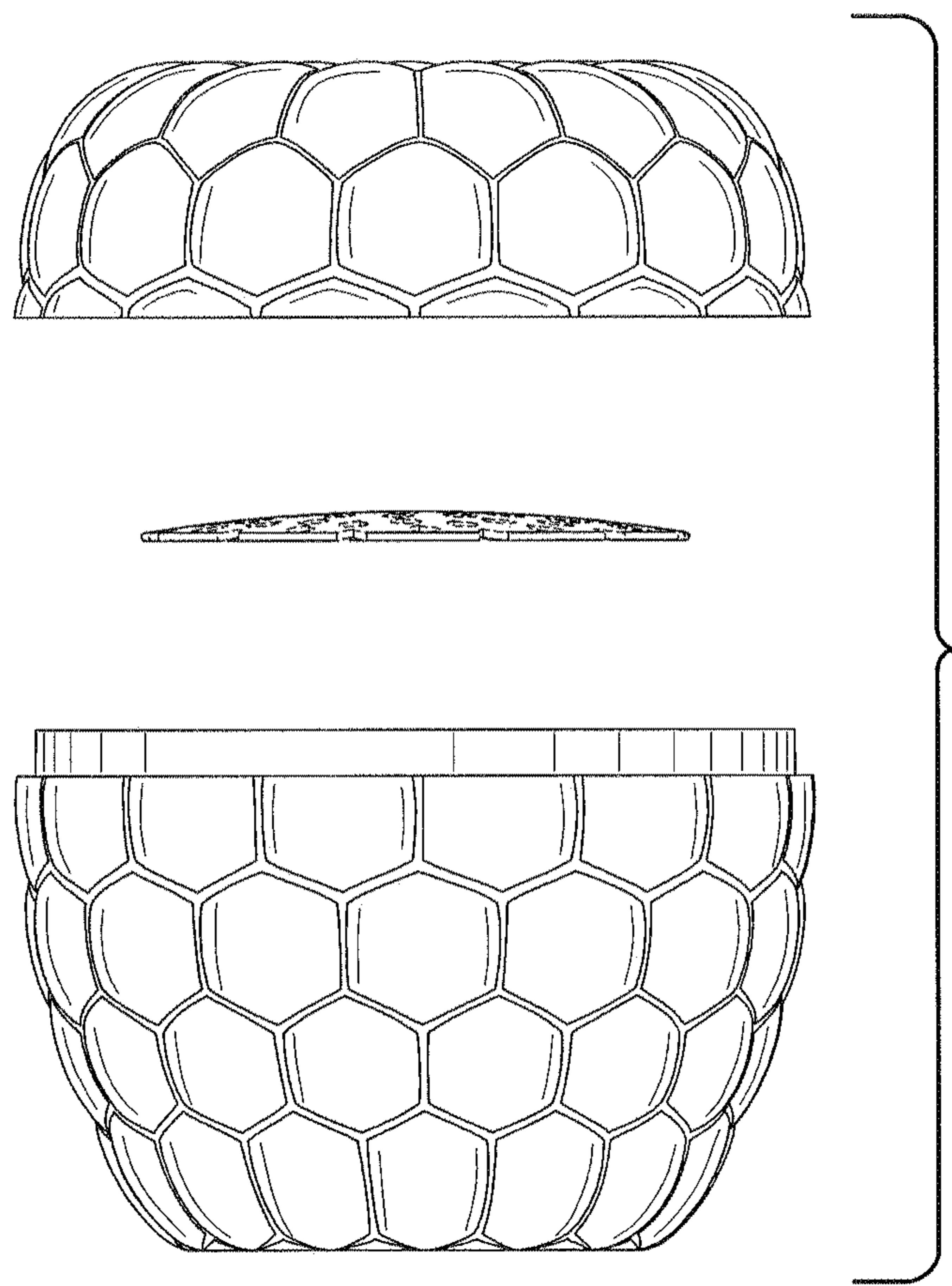

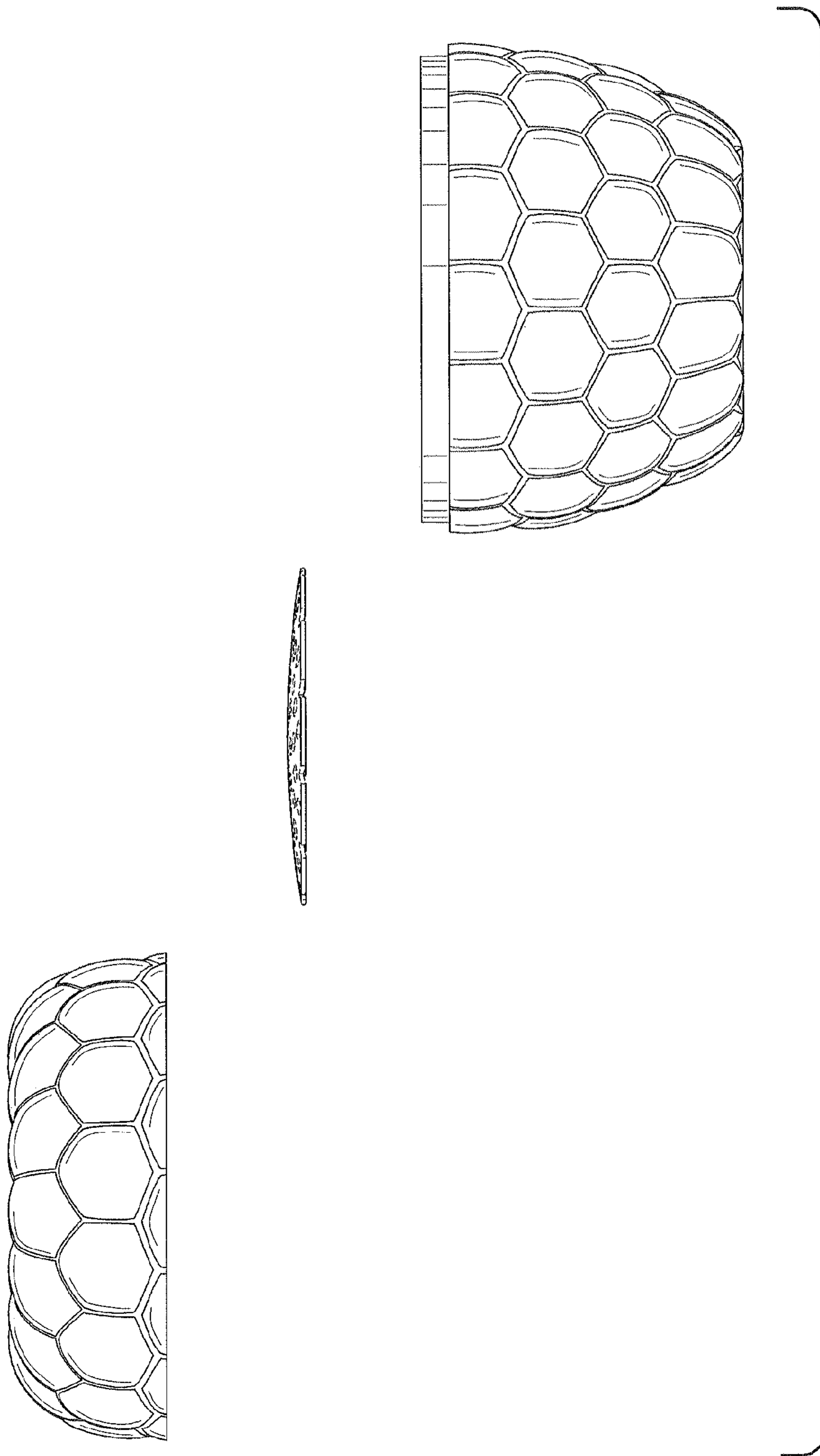

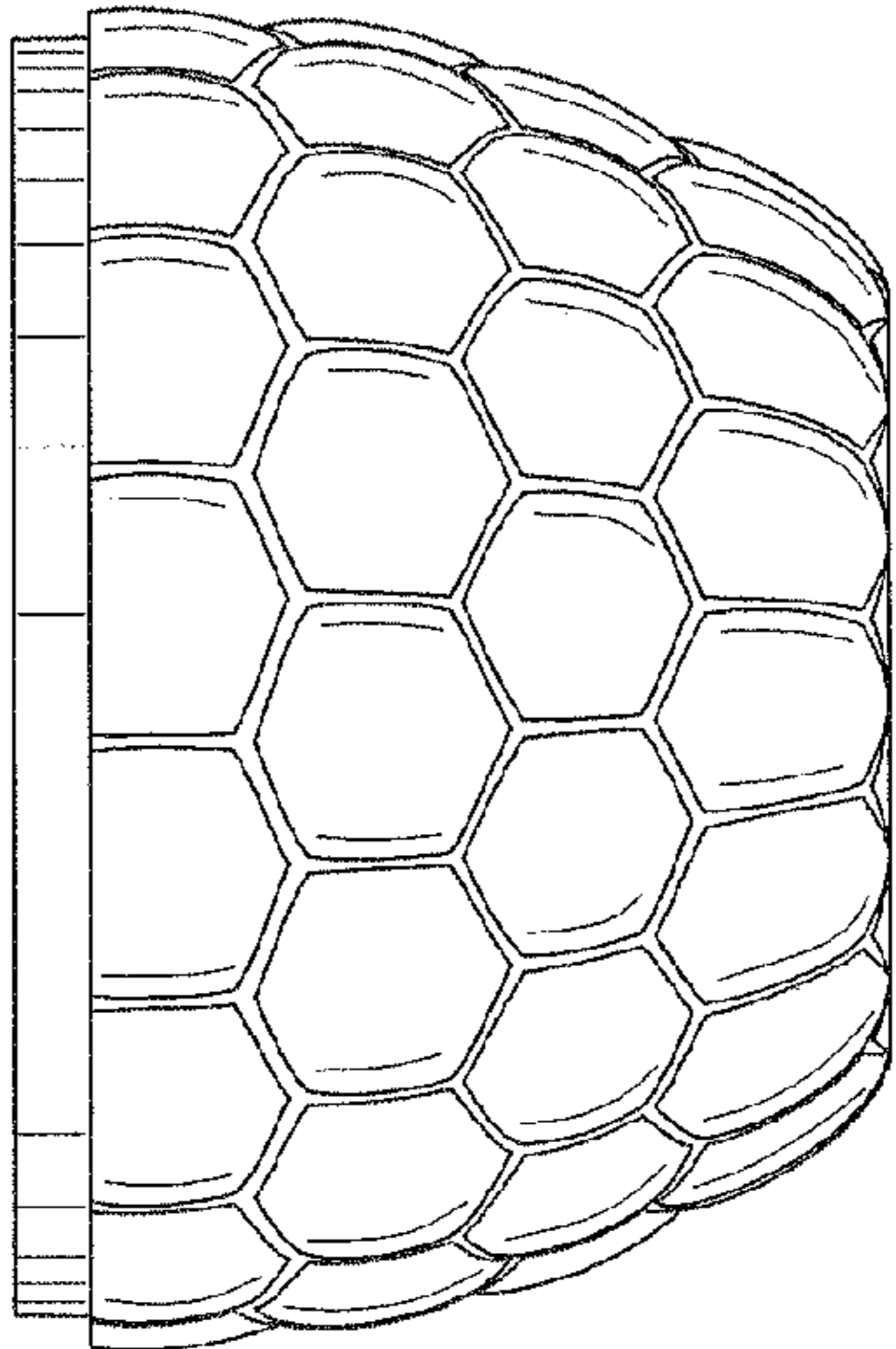
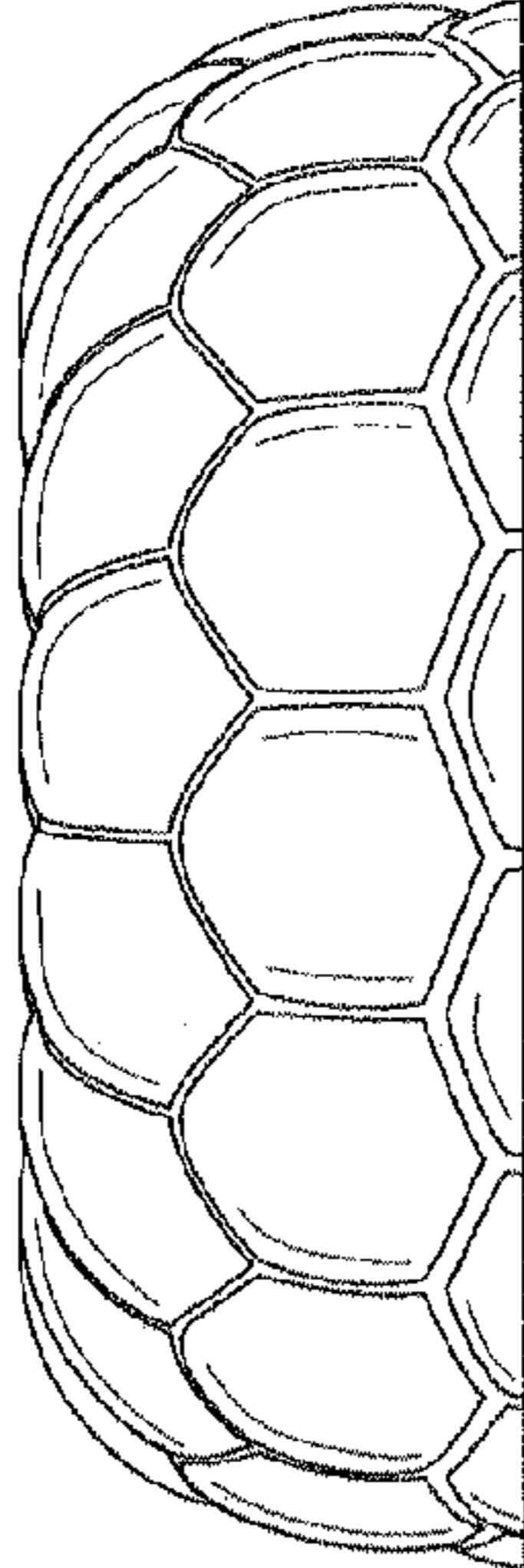

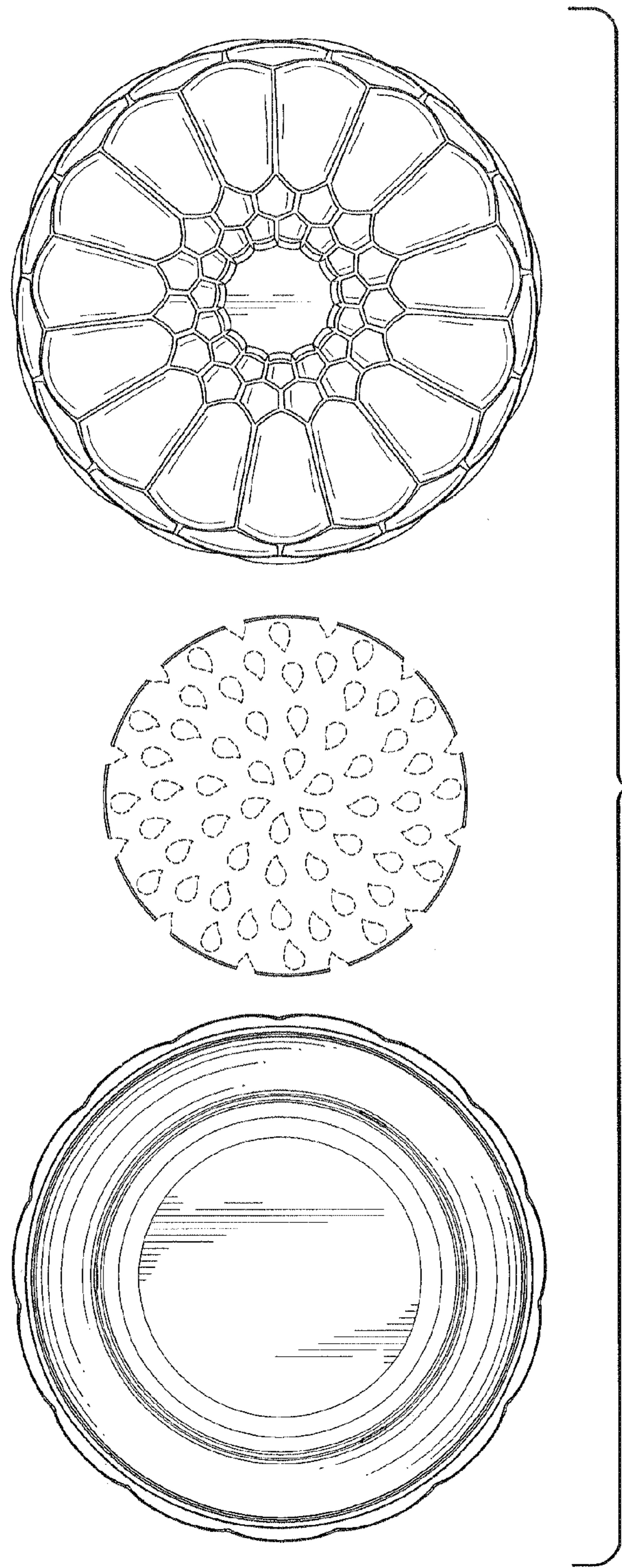

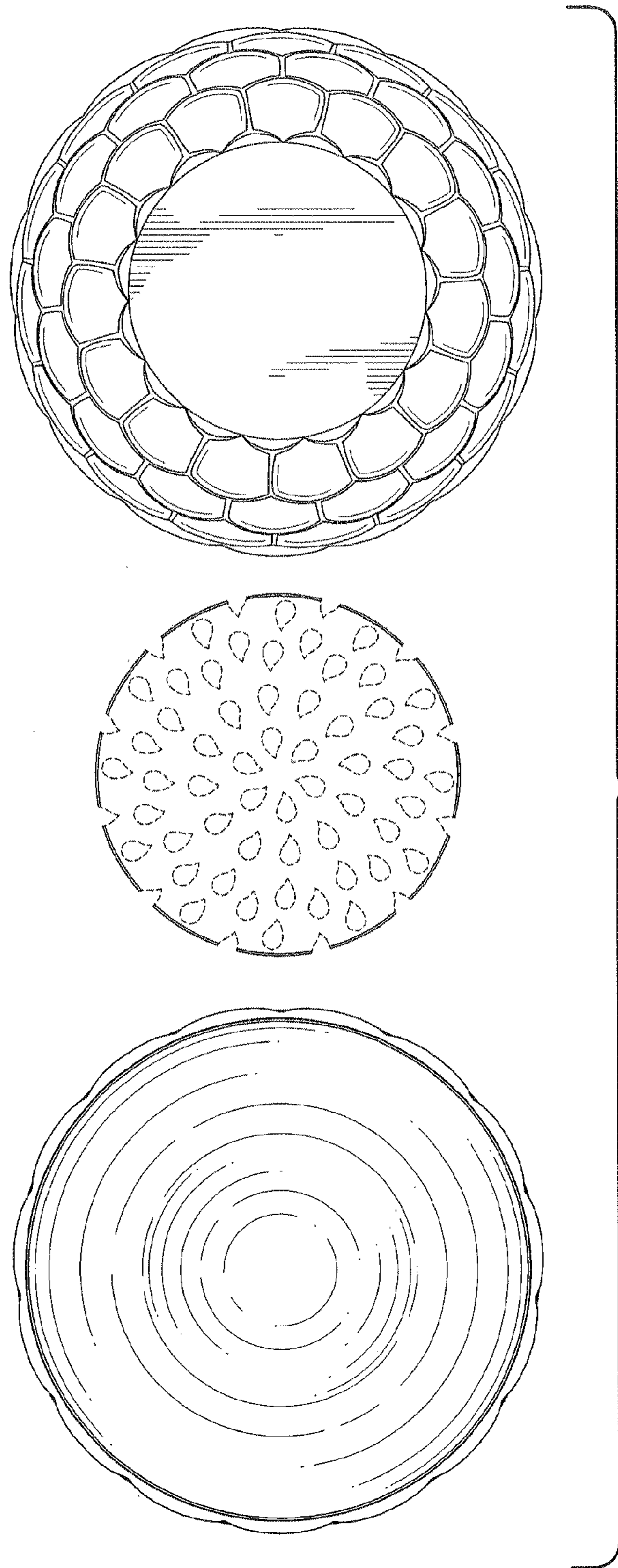

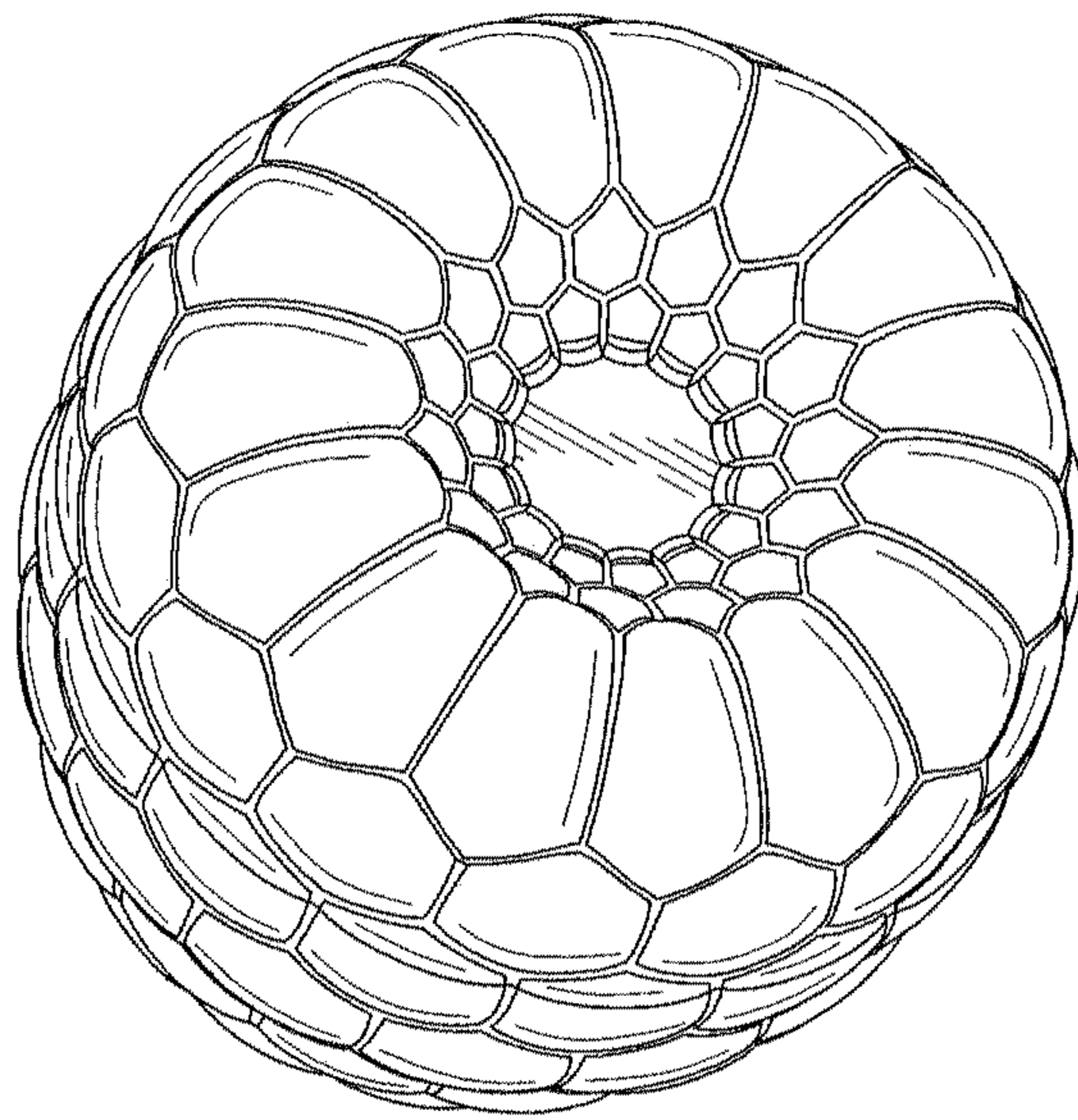

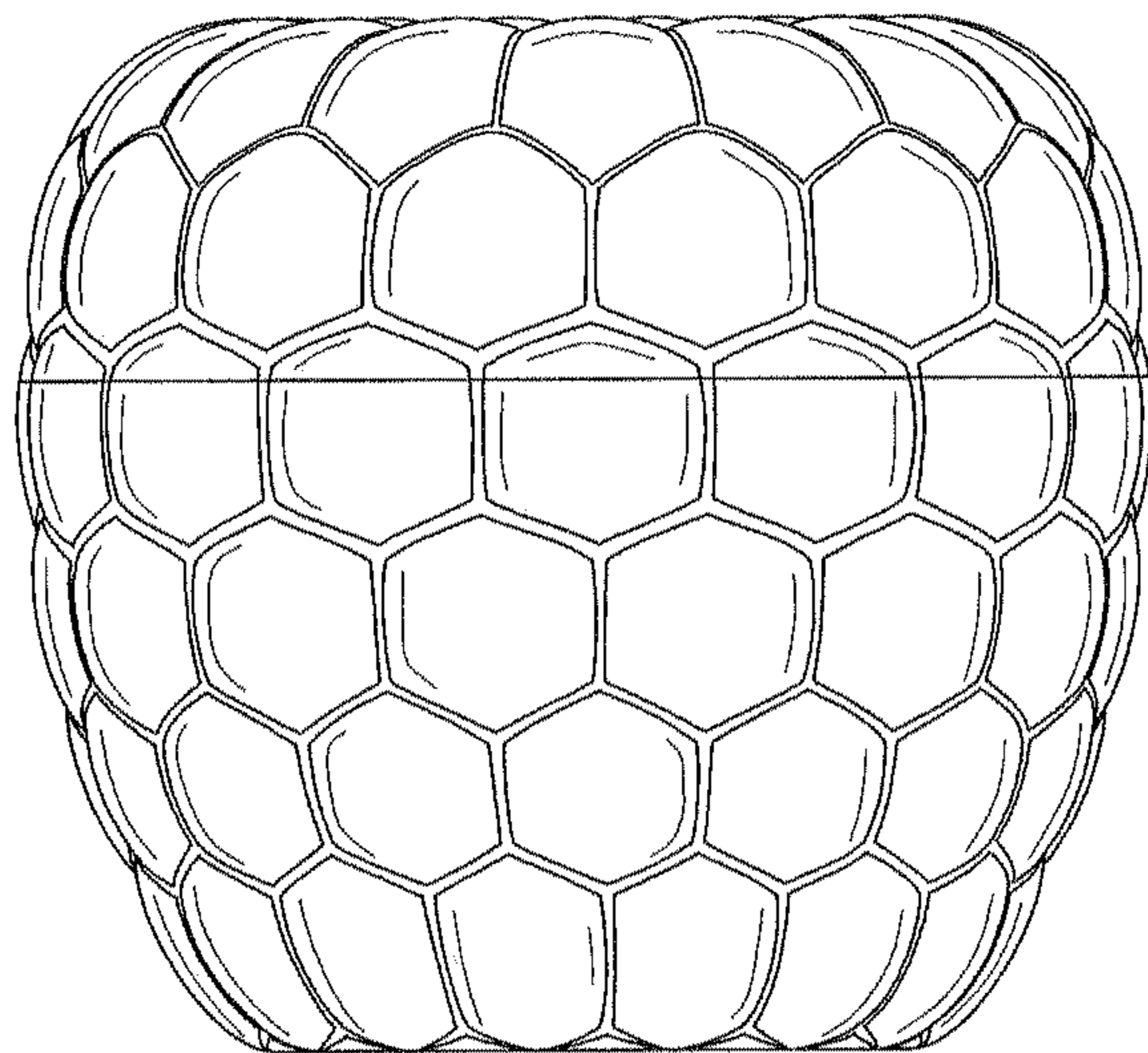
