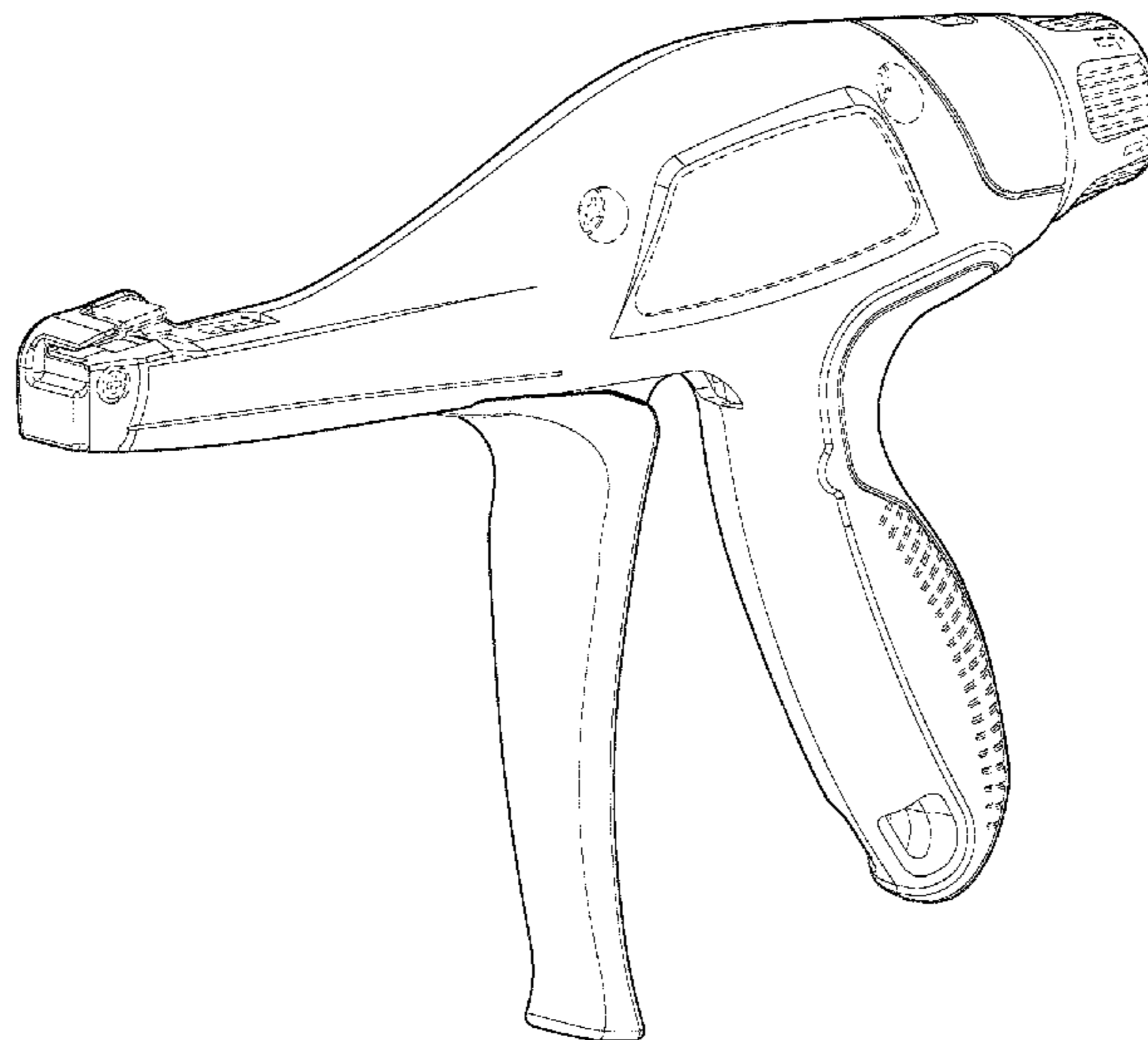

**DESCRIPTION**

FIG. 1 is a front left side perspective view of a cable tie tool; FIG. 2 is a rear left side perspective view thereof; FIG. 3 is a left side elevation view thereof; FIG. 4 is a front right side perspective view thereof; FIG. 5 is a rear right side perspective view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is a front elevation view thereof; and, FIG. 10 is a rear elevation view thereof. The broken lines illustrate portions of the cable tie tool that form no part of the claimed design.

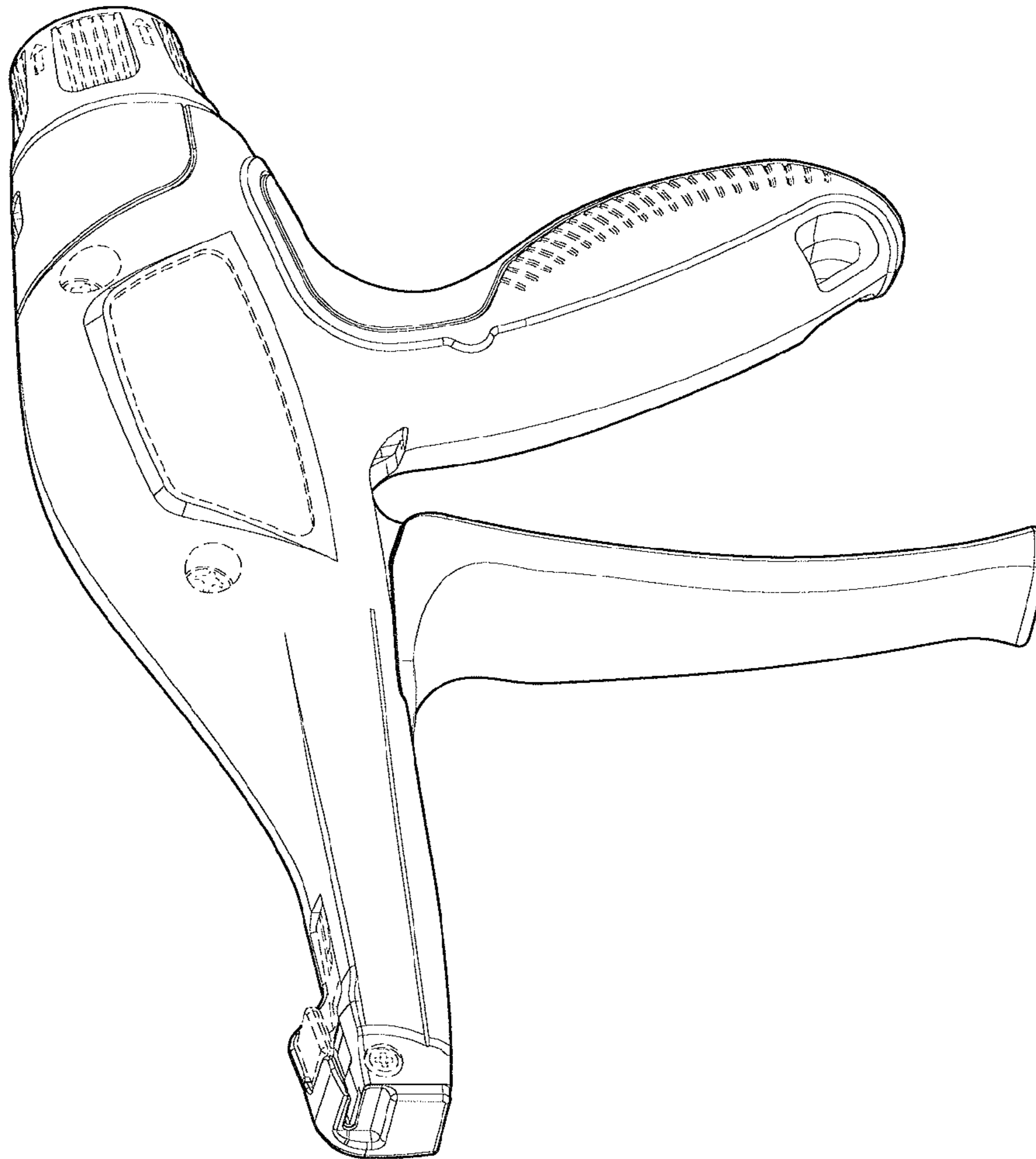

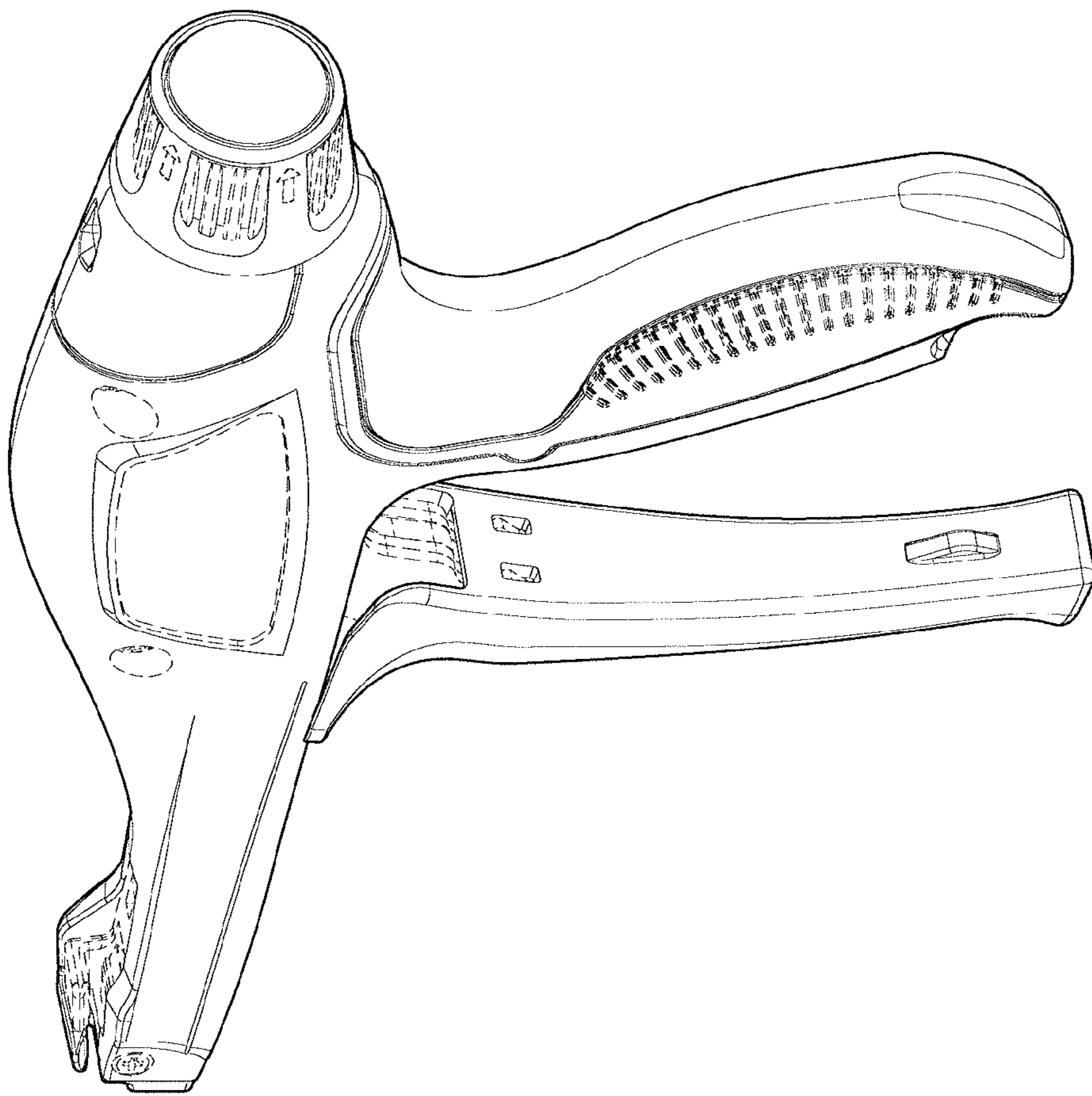

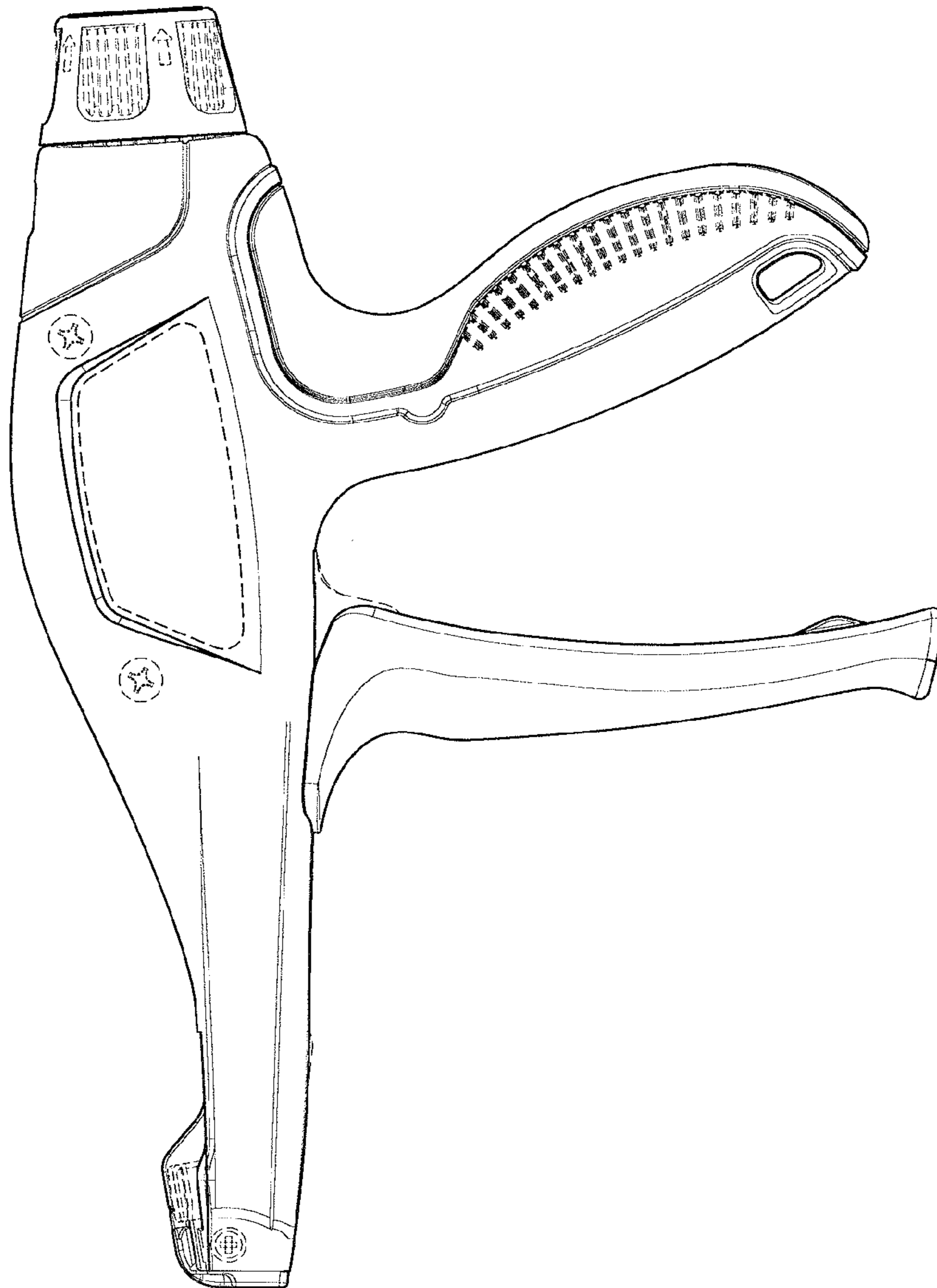

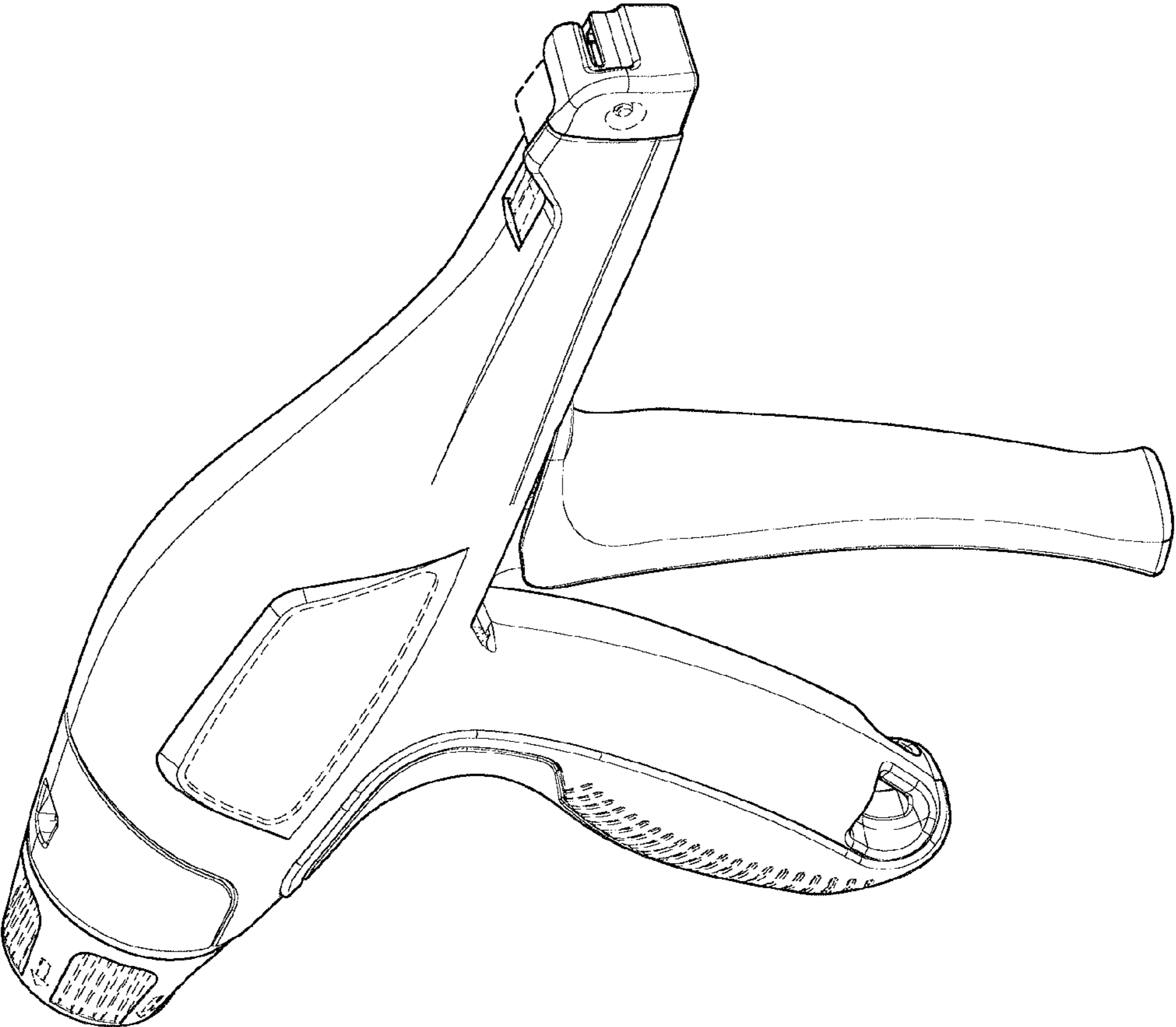

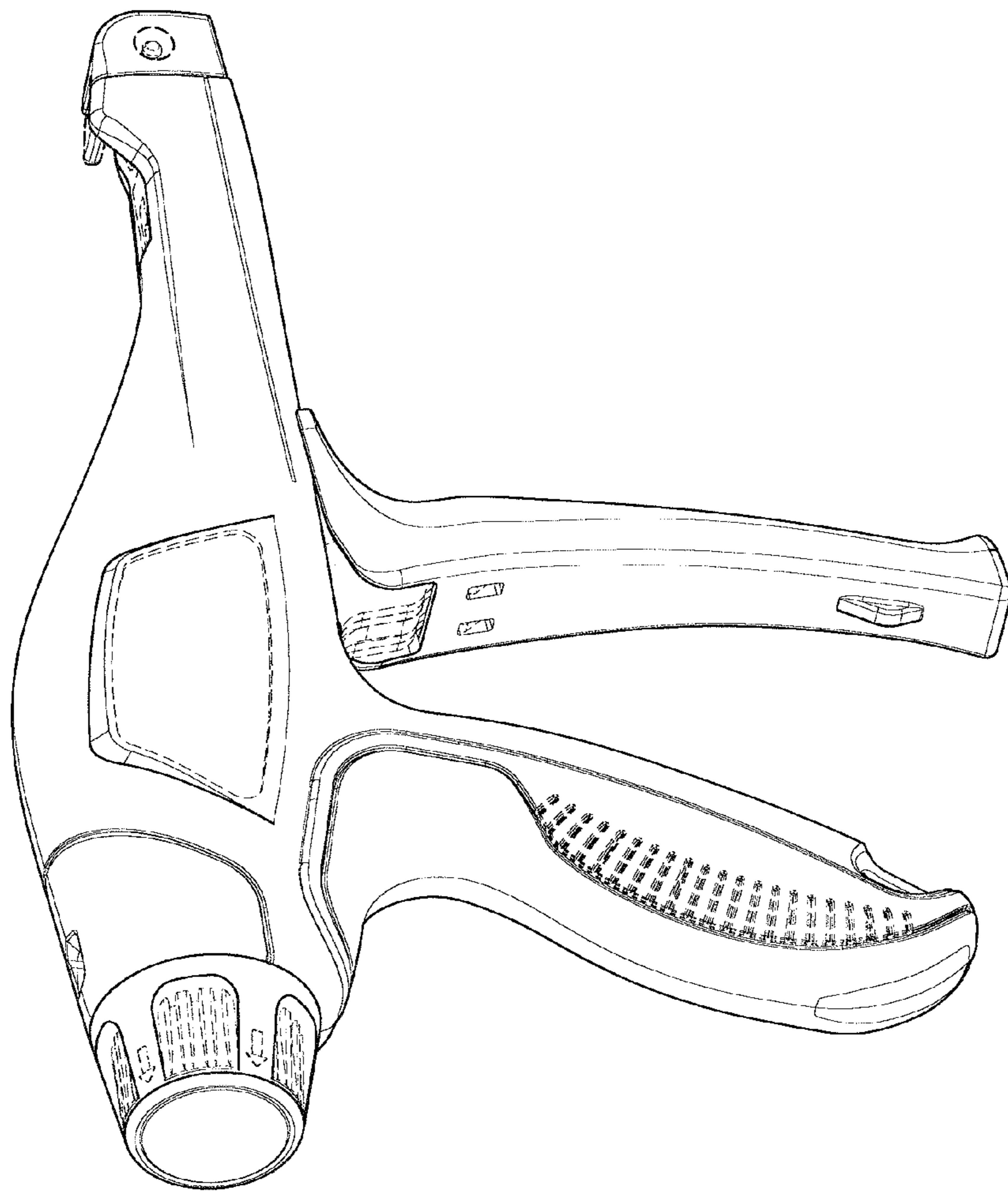

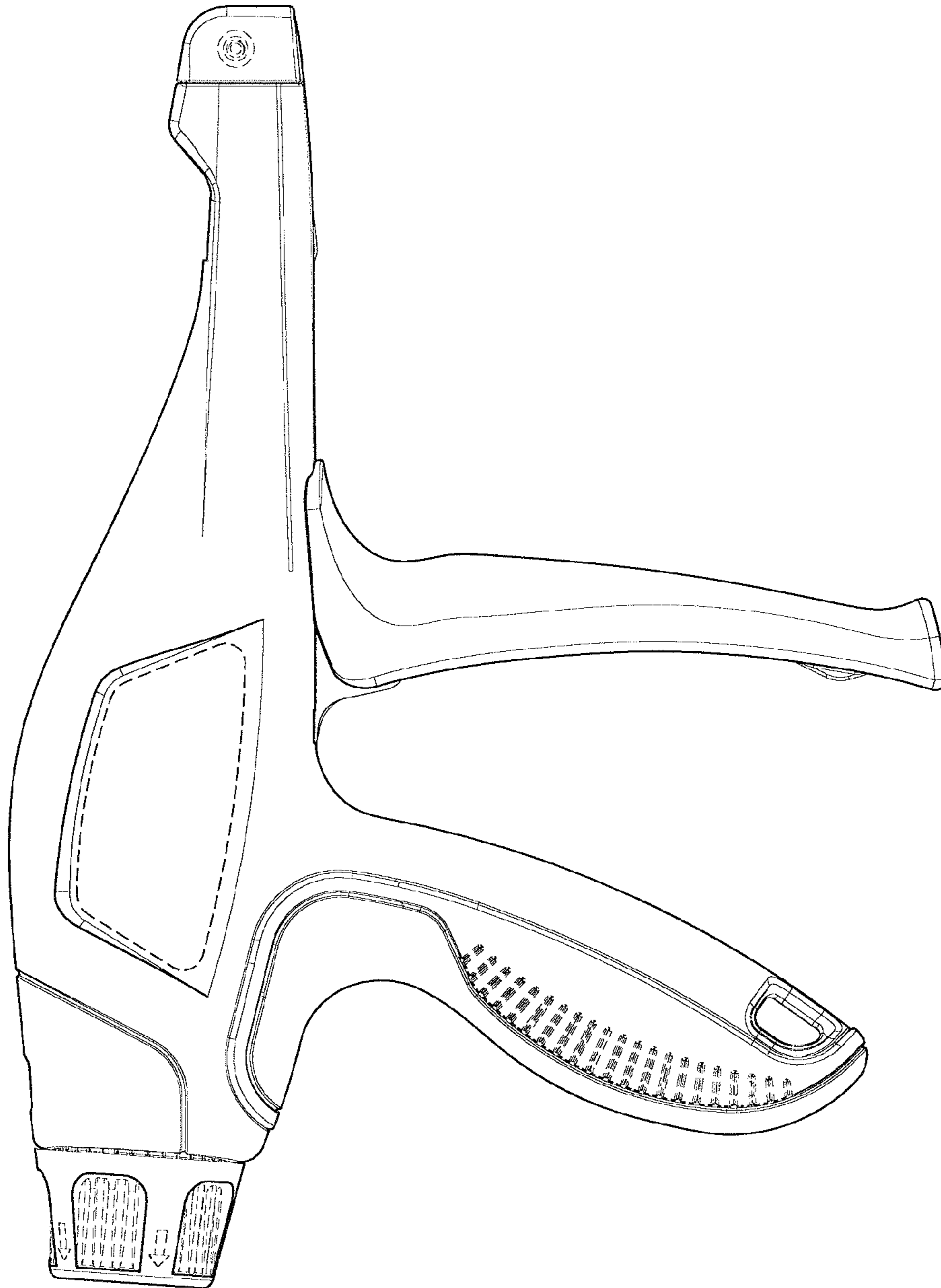

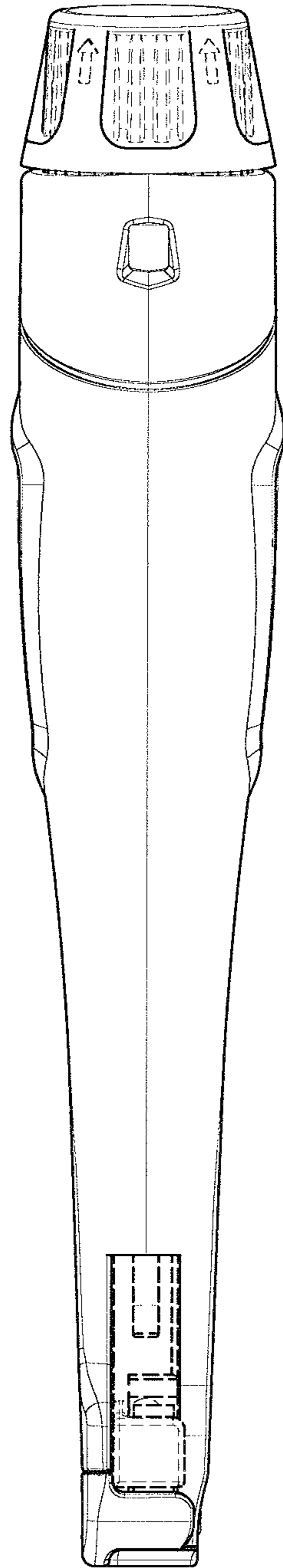

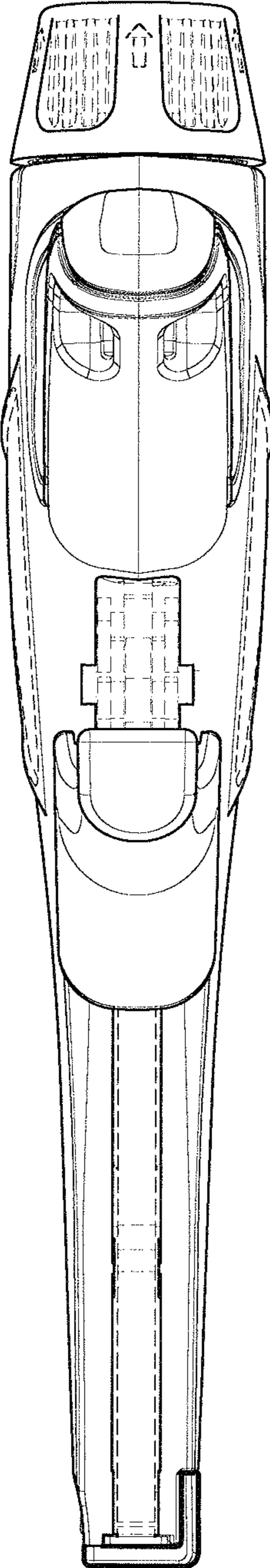

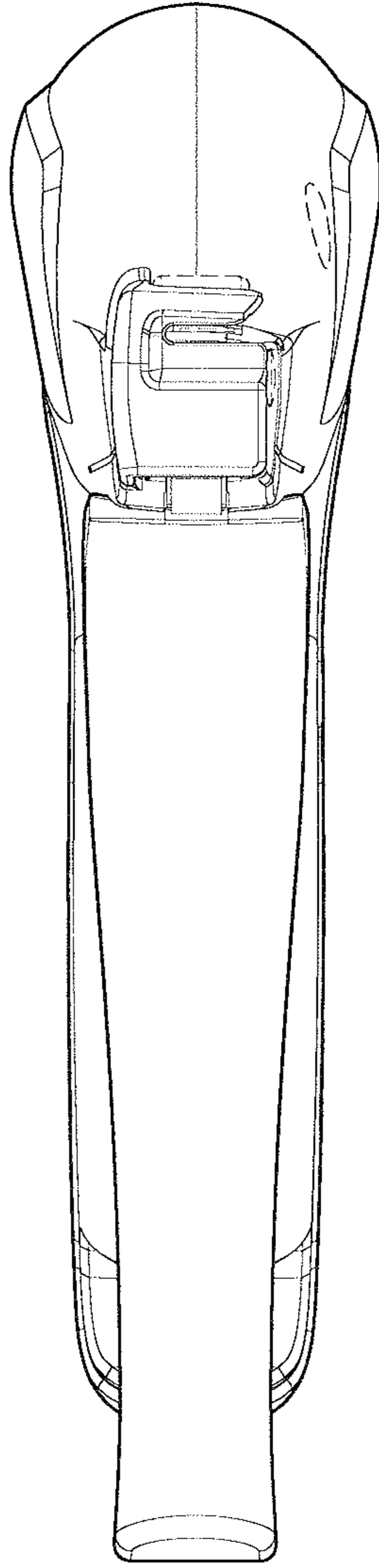

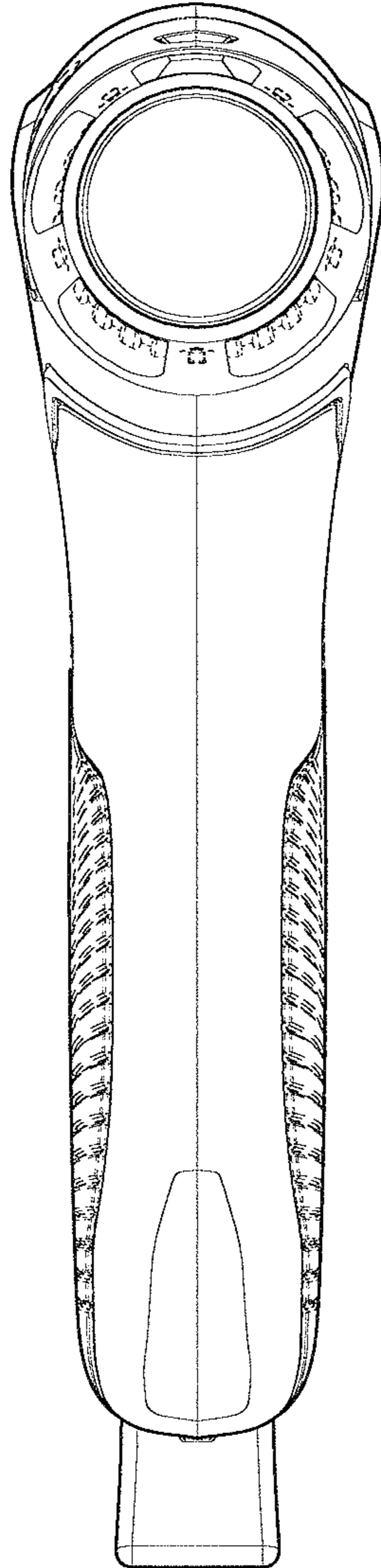
