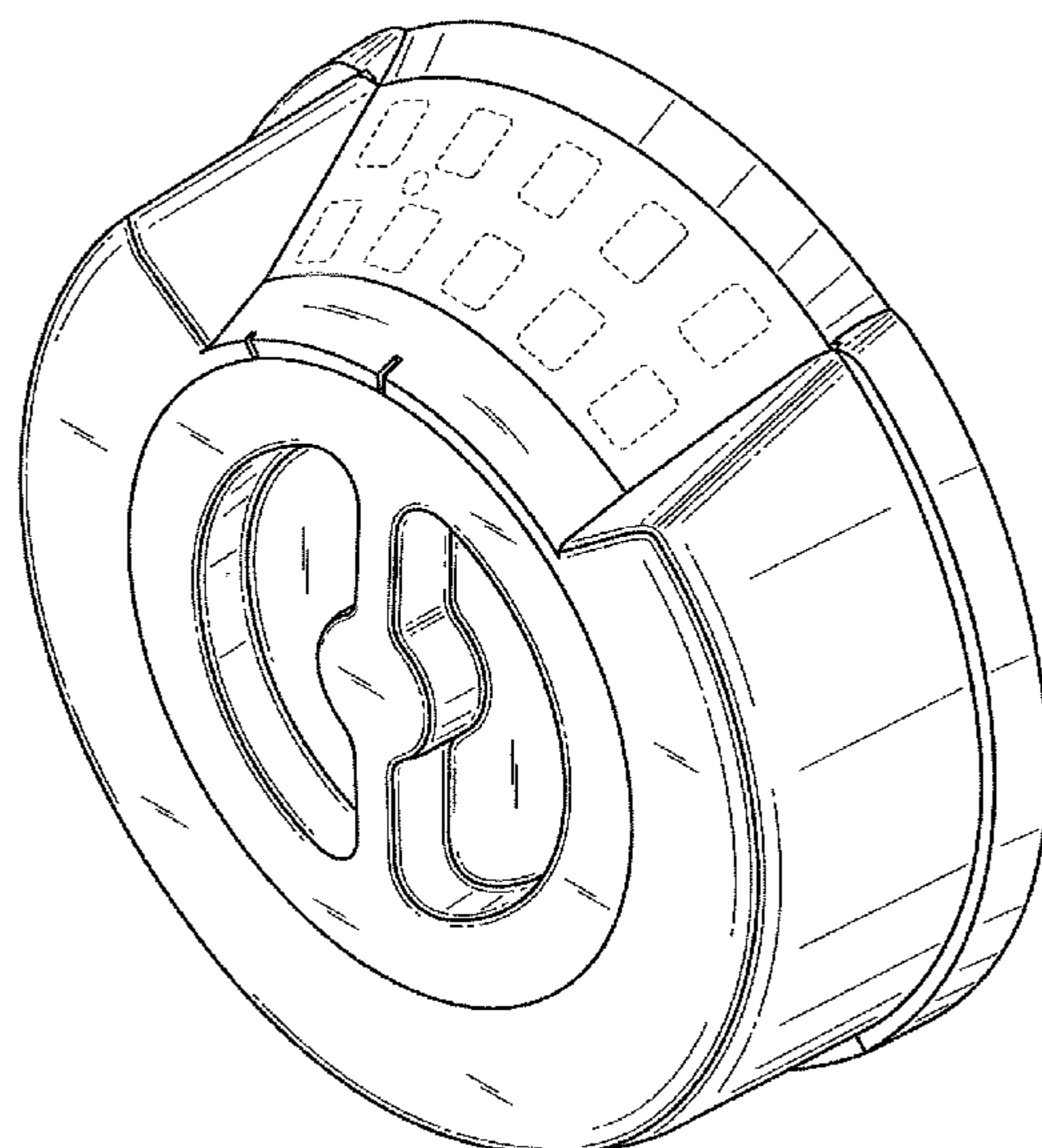

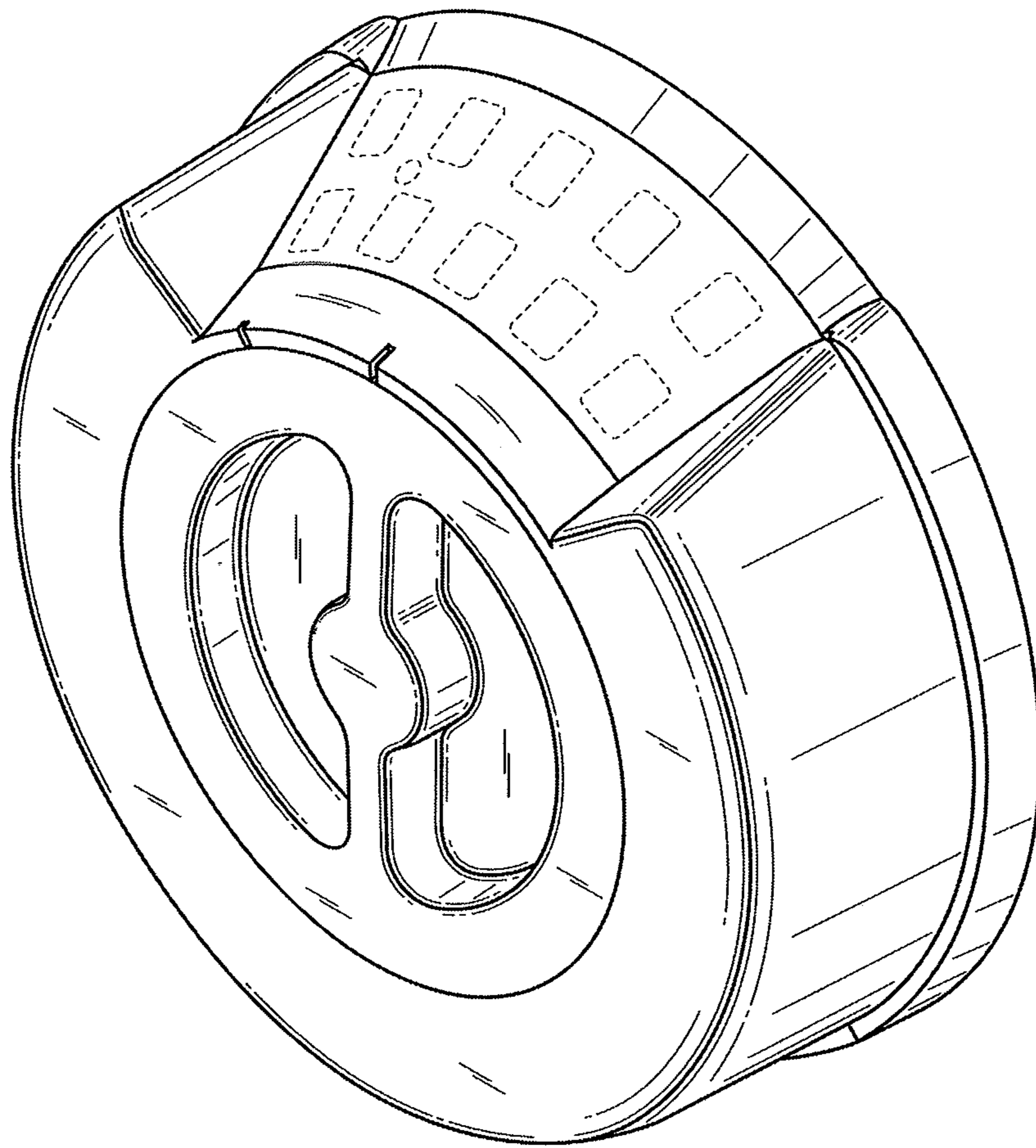
The ornamental design for a dual input dial for electronic and mechanical combination lock, as shown and described.

**DESCRIPTION**

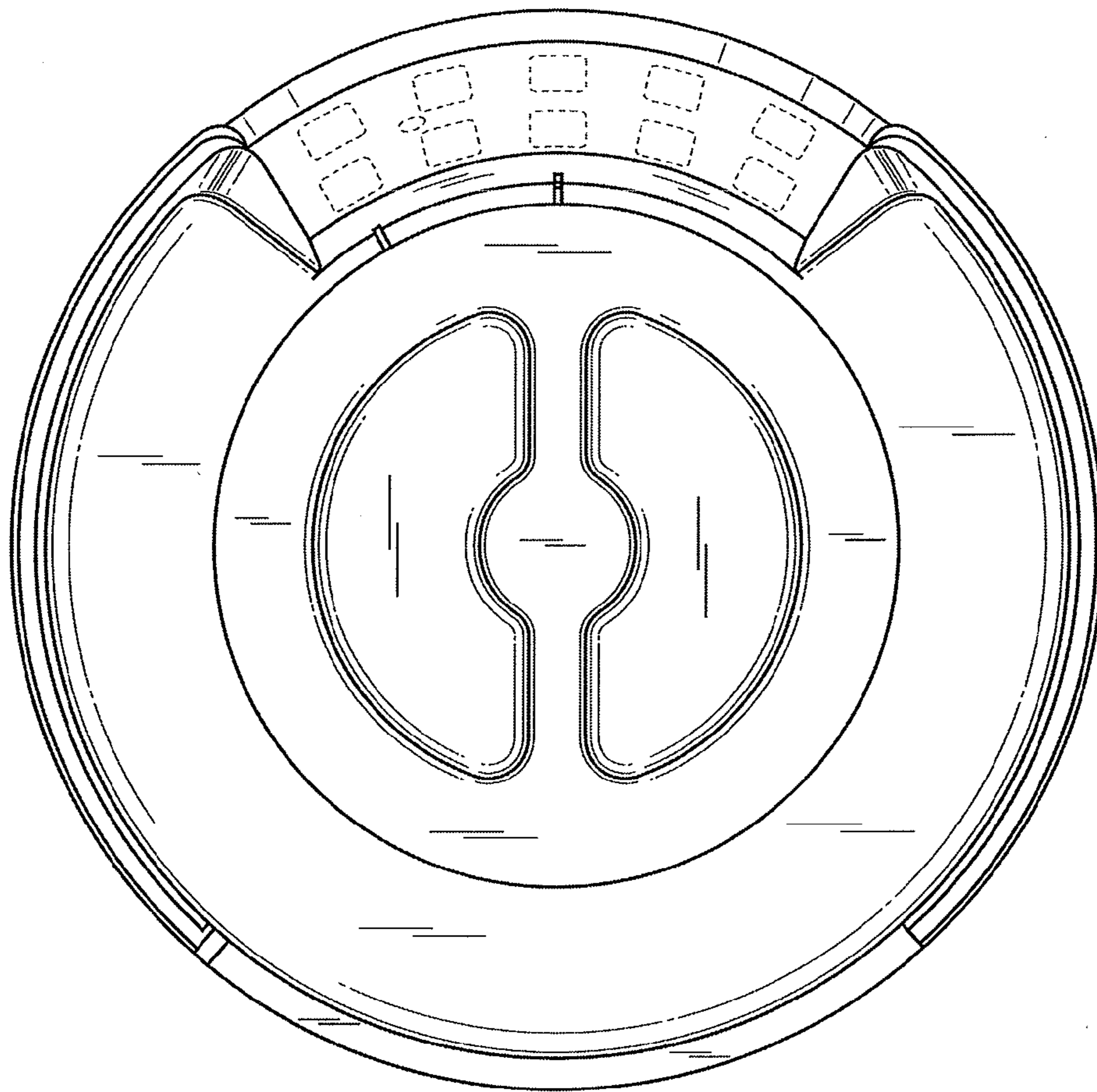

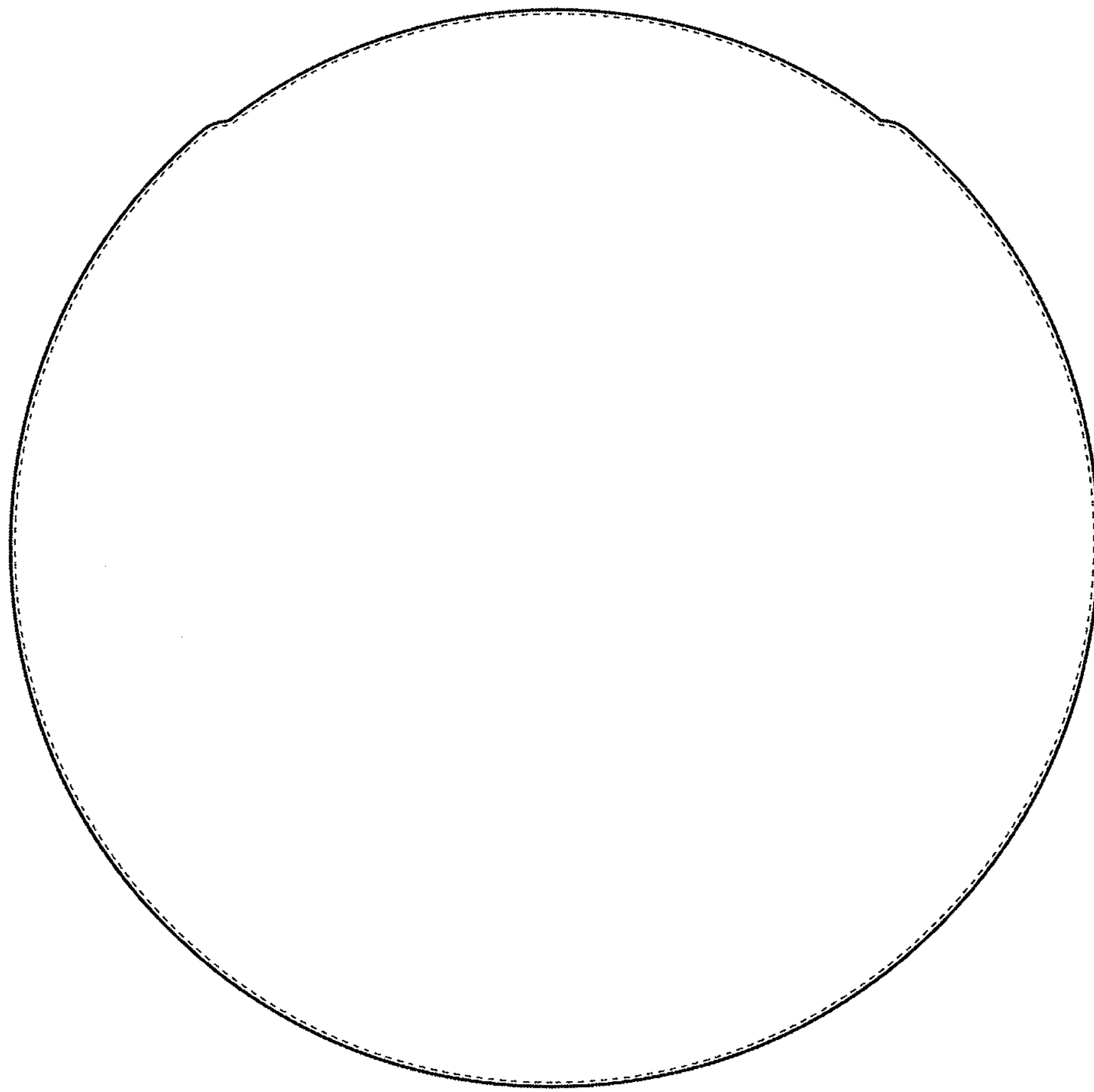




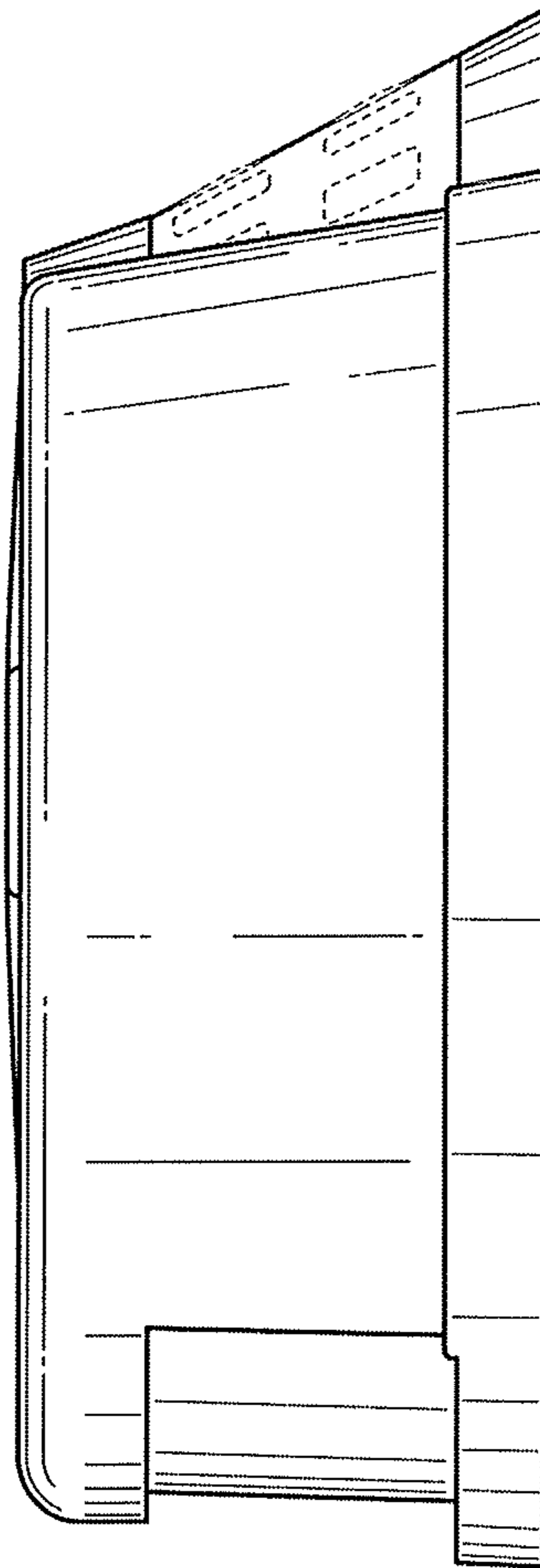

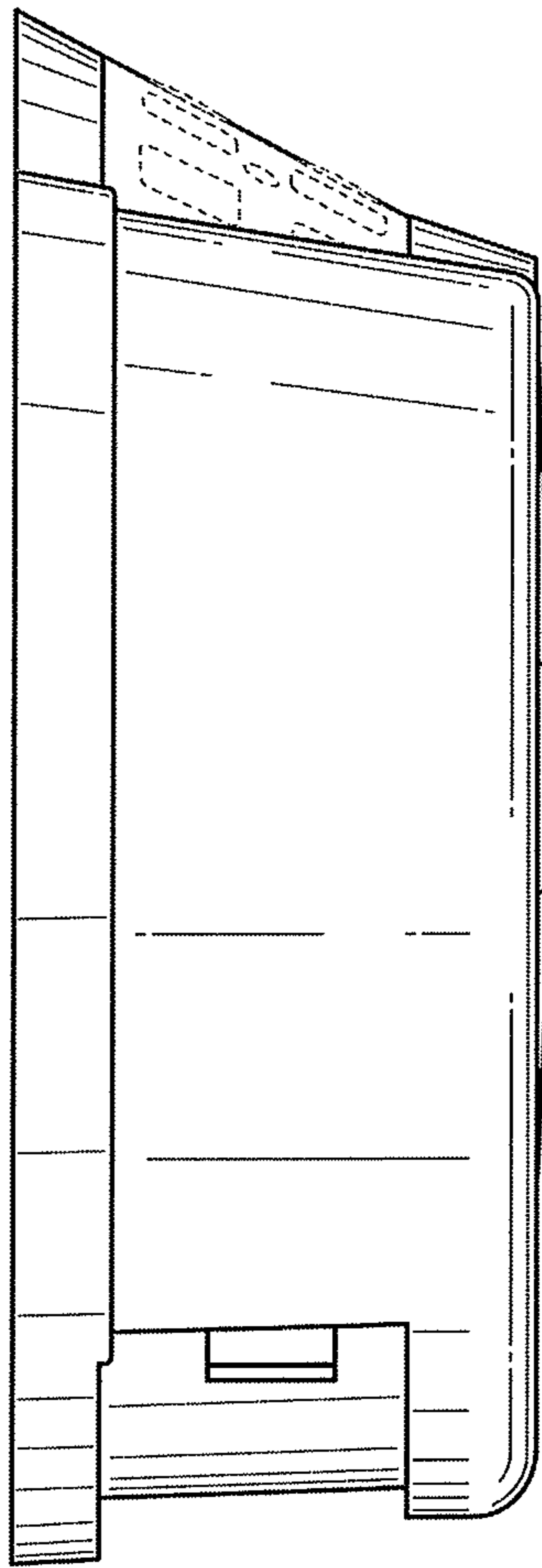
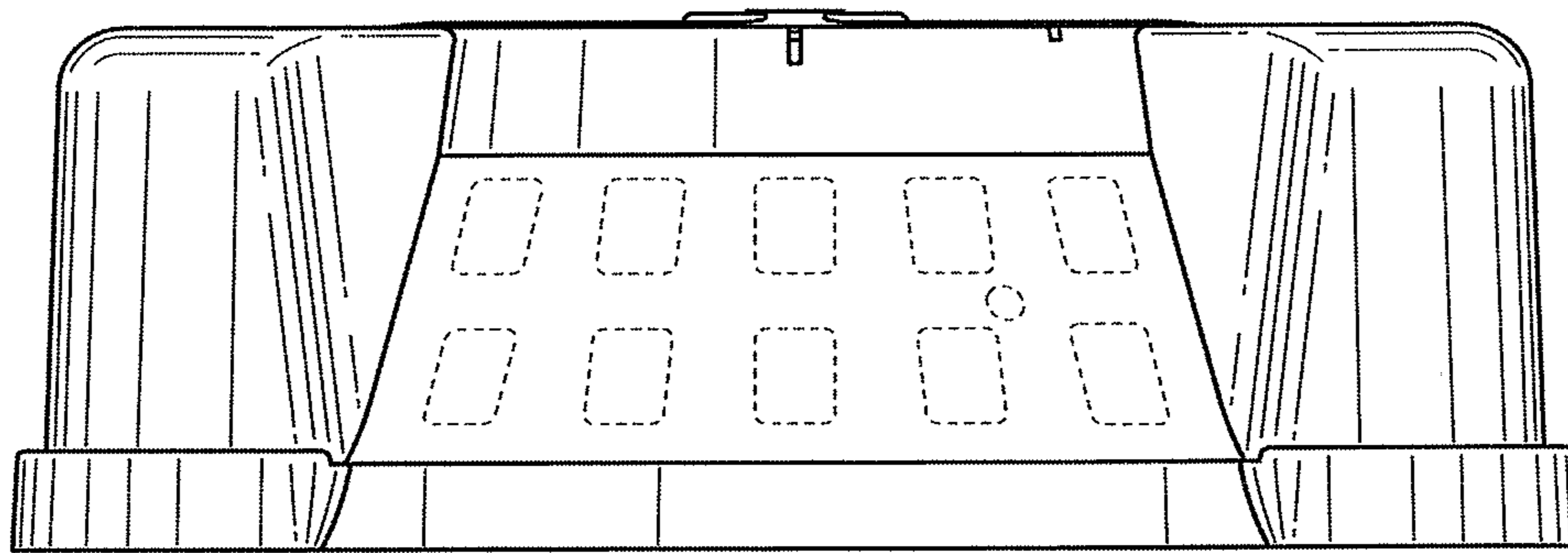
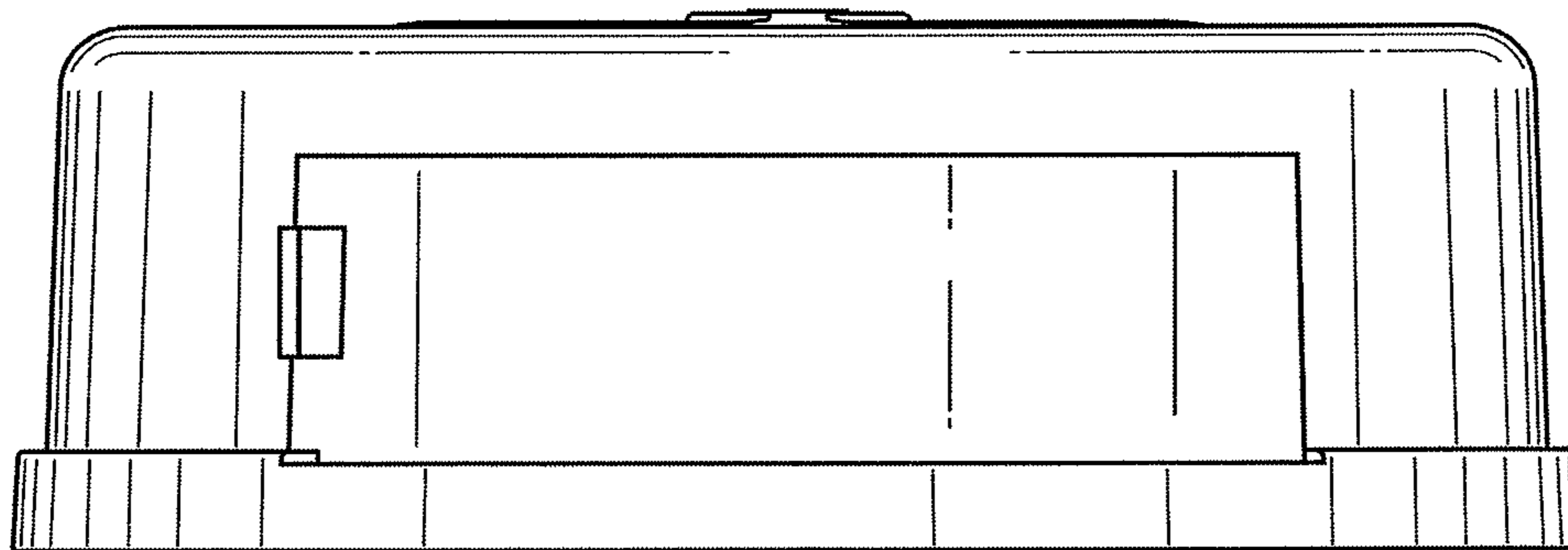
