FIG. 2 is a plan view of a second embodiment of a container; and,

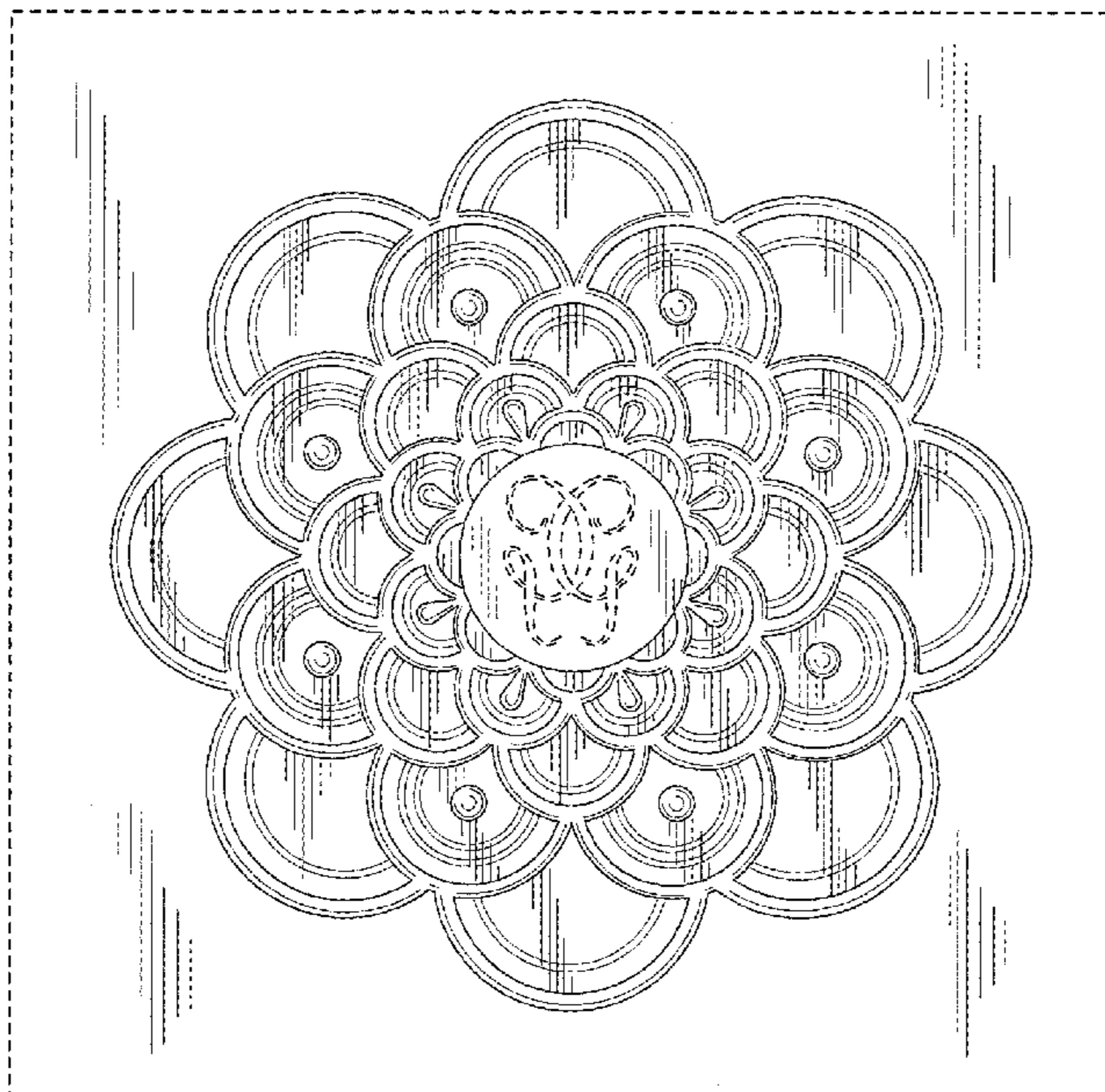

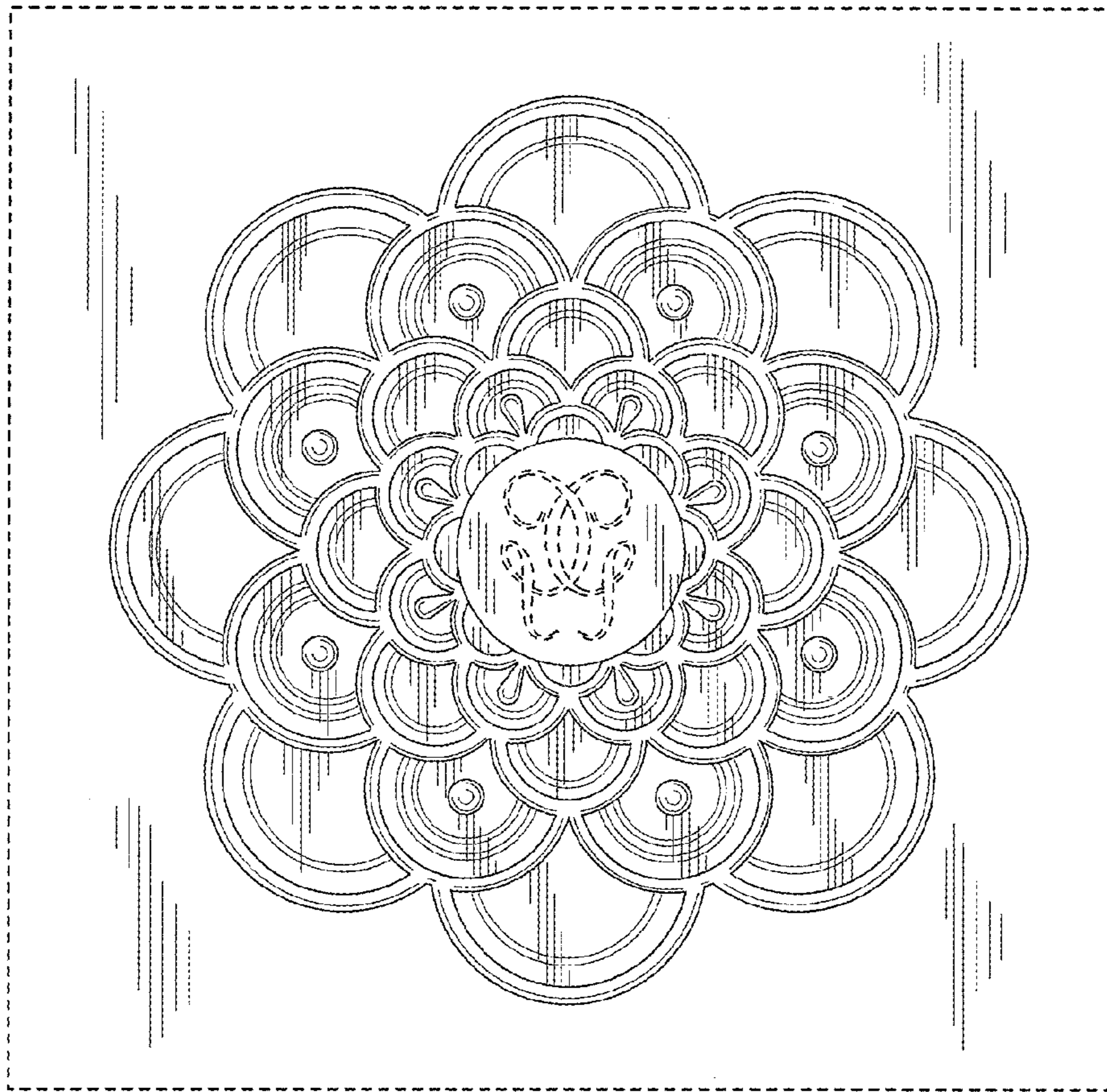

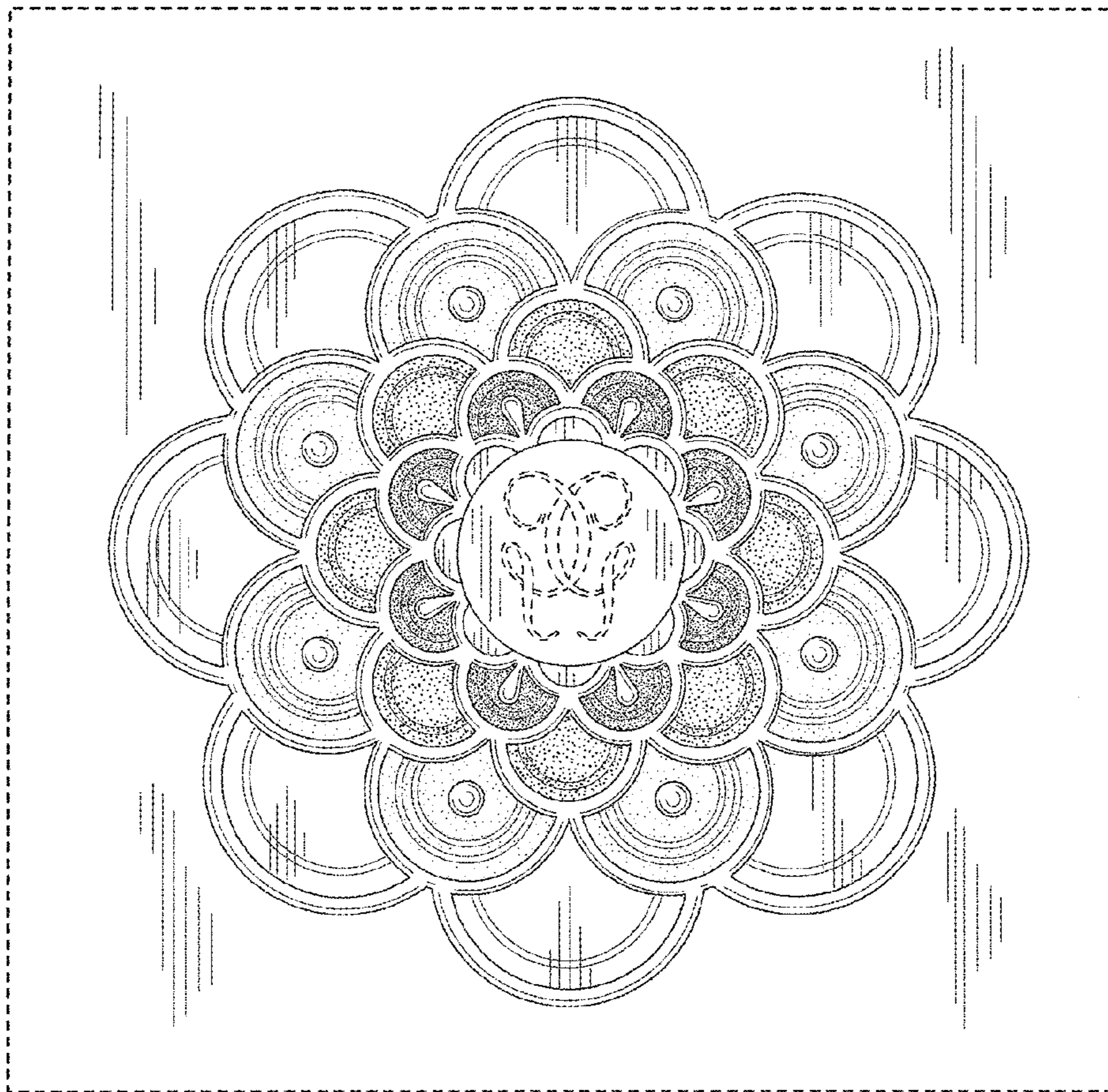

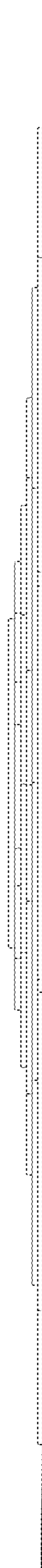
