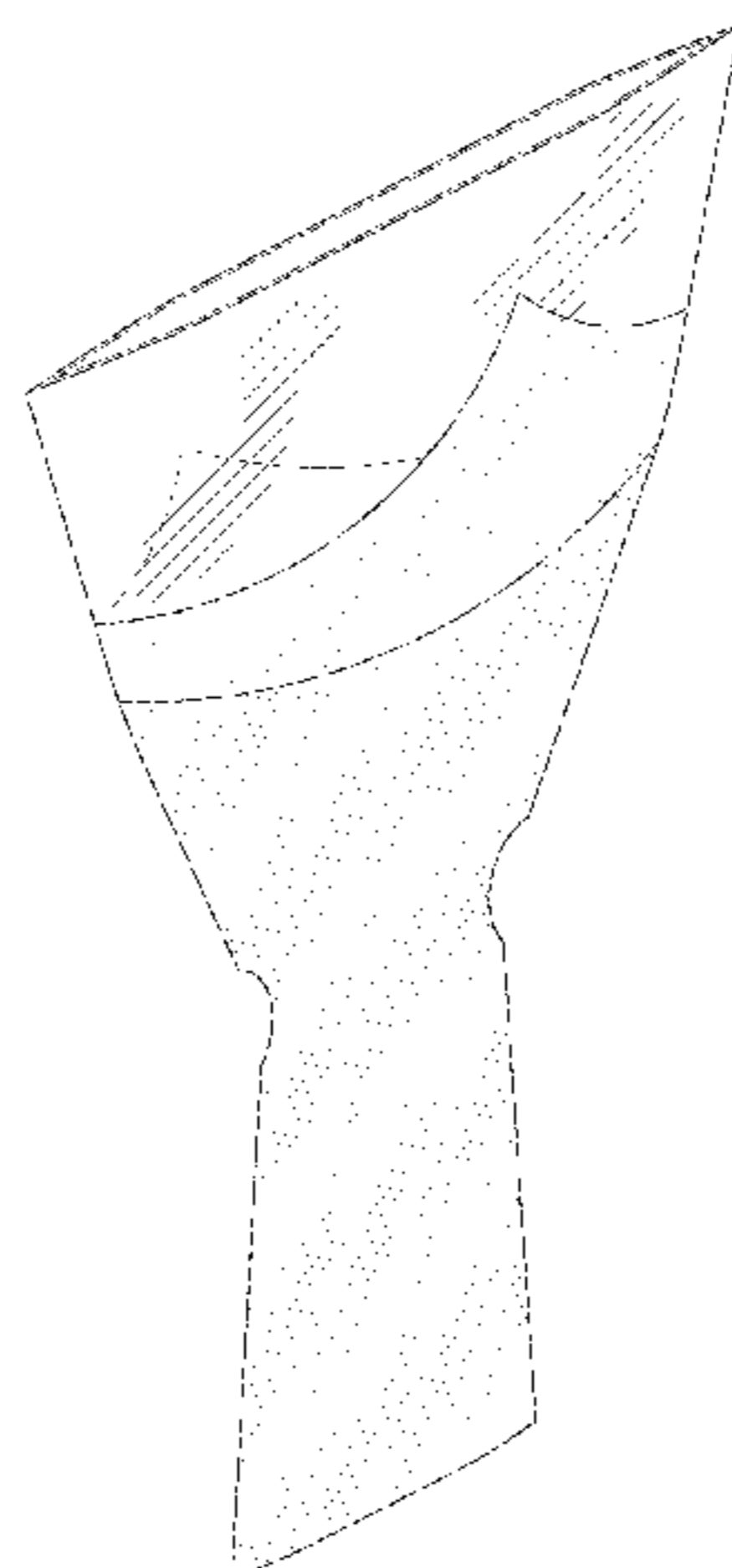
(57) **CLAIM**  
The ornamental design of a package sleeve, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the package sleeve, showing my new design;  
FIG. 2 is a front view, the rear view being a mirror image thereof;  
FIG. 3 is a left side view, the right side view being a mirror image thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a bottom view thereof; and,  
FIG. 6 is another perspective view thereof.  
In the drawings, the two types of stippling indicate a contrast in appearances. In FIG. 6 the broken lines are for the purpose of illustrating environment only and form no part of the claimed design.

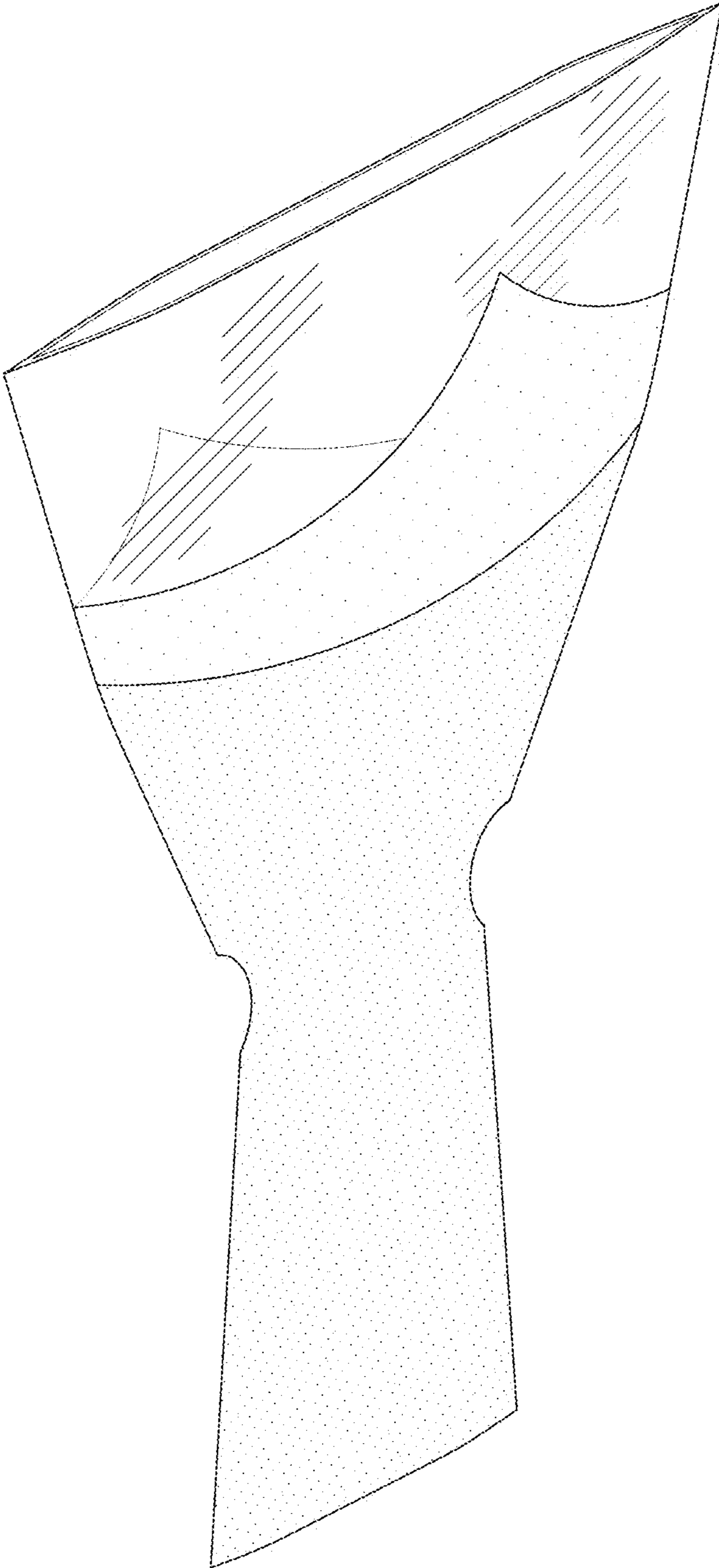

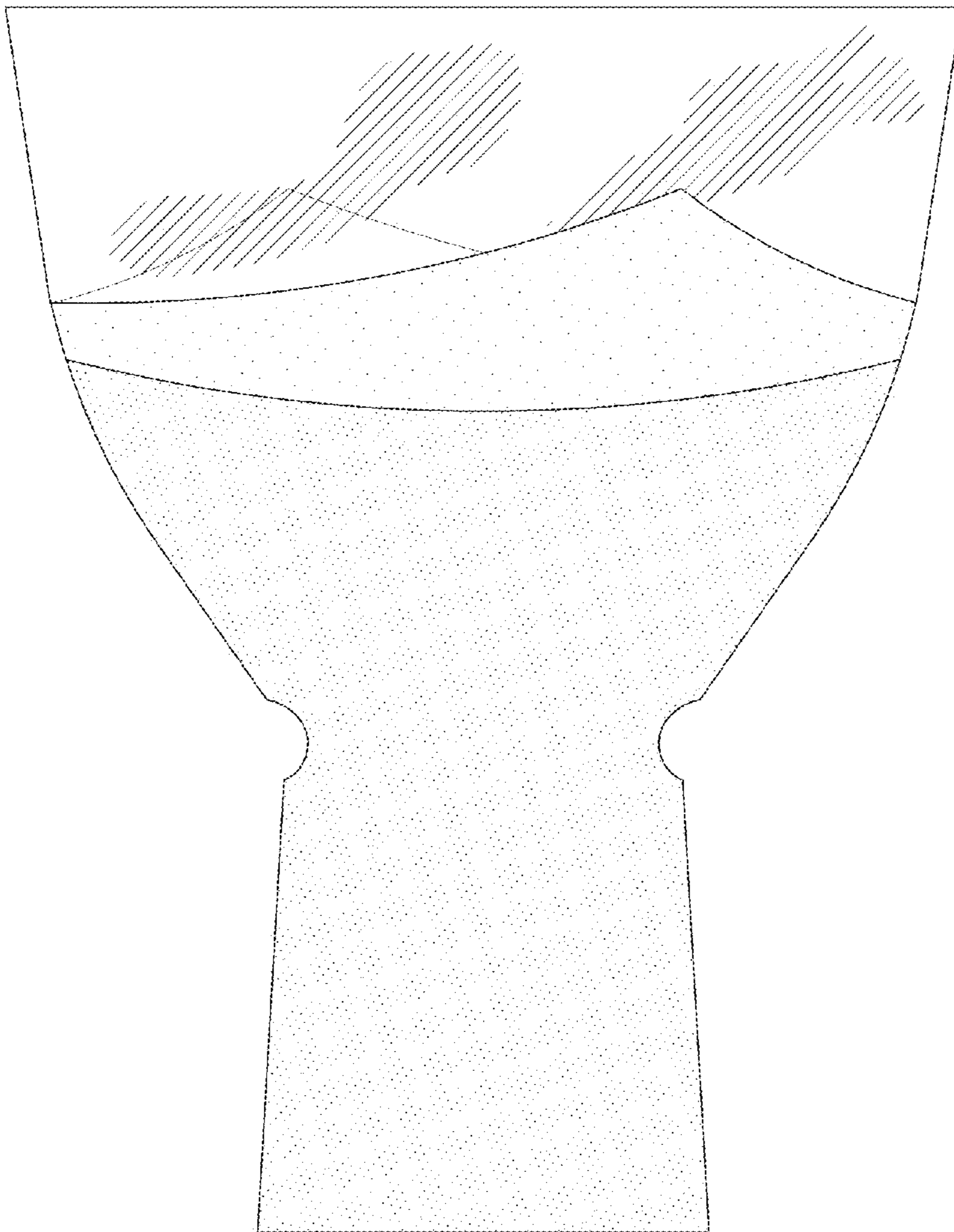
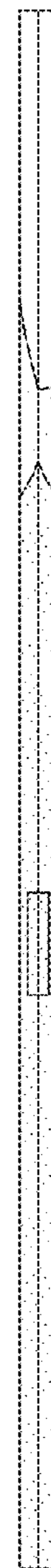
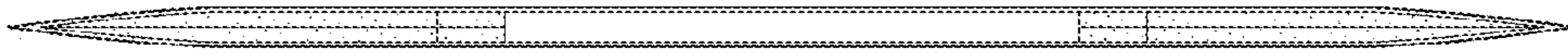
