**DESCRIPTION**

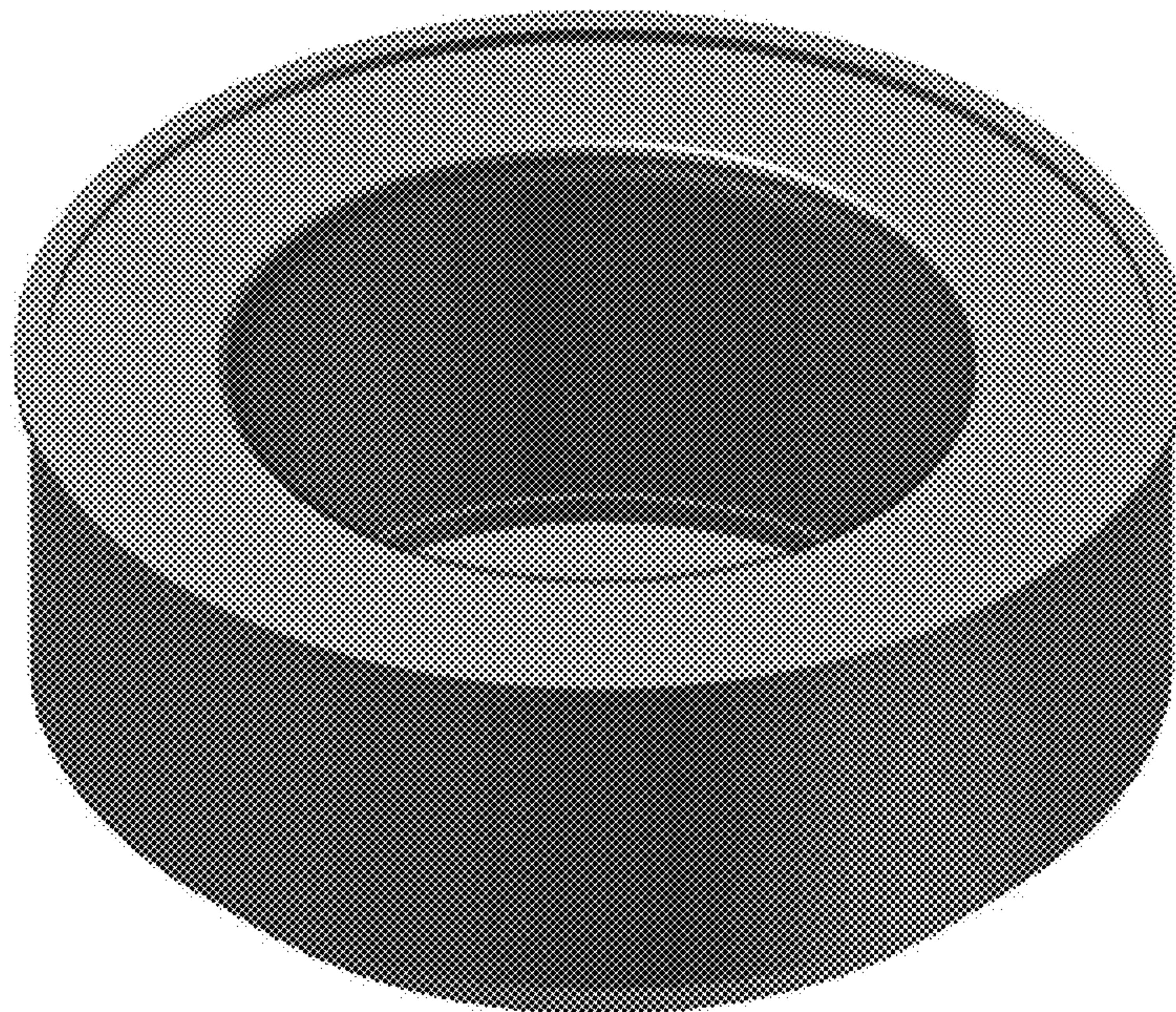
FIG. 1 is a front, top perspective view of a sight glass for refrigeration valve comprising a new, original and ornamental design;

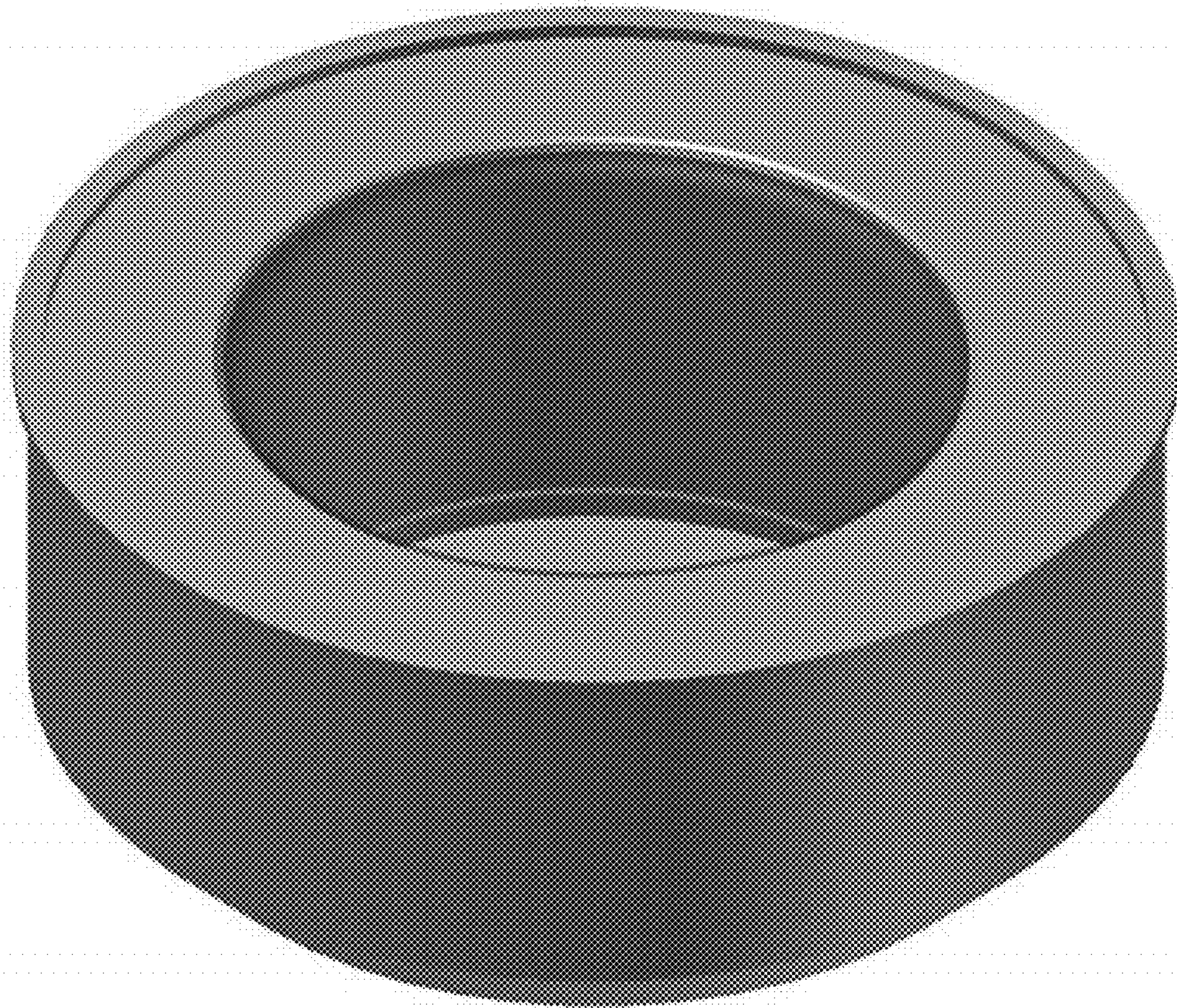

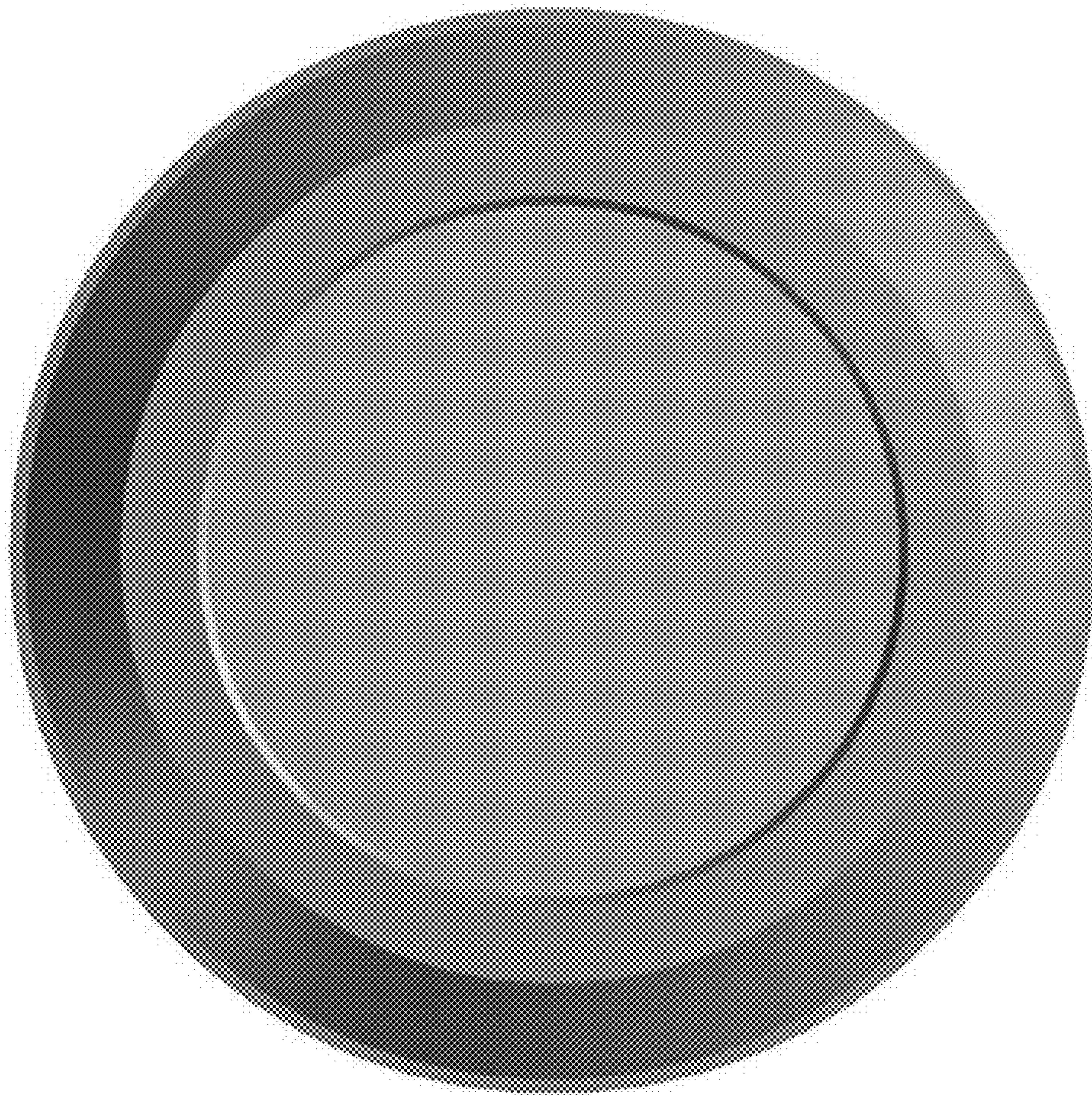

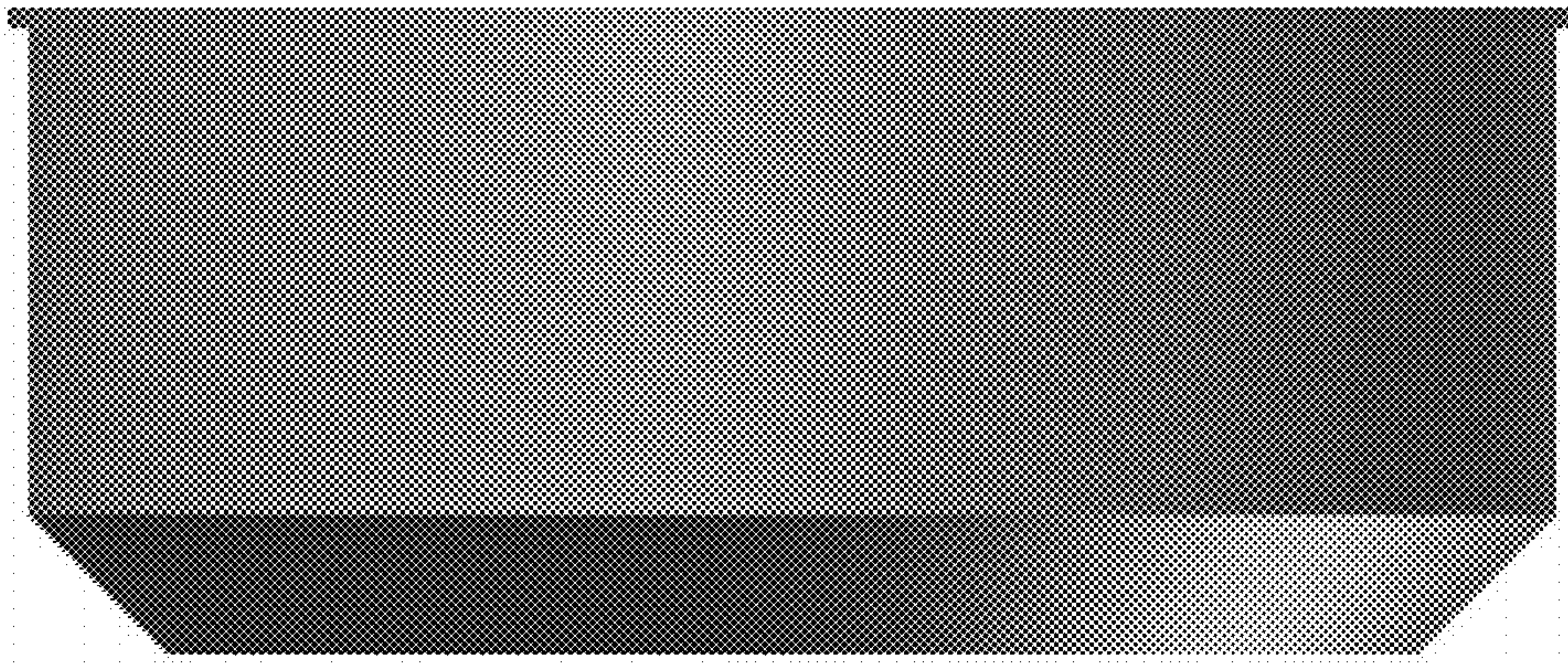

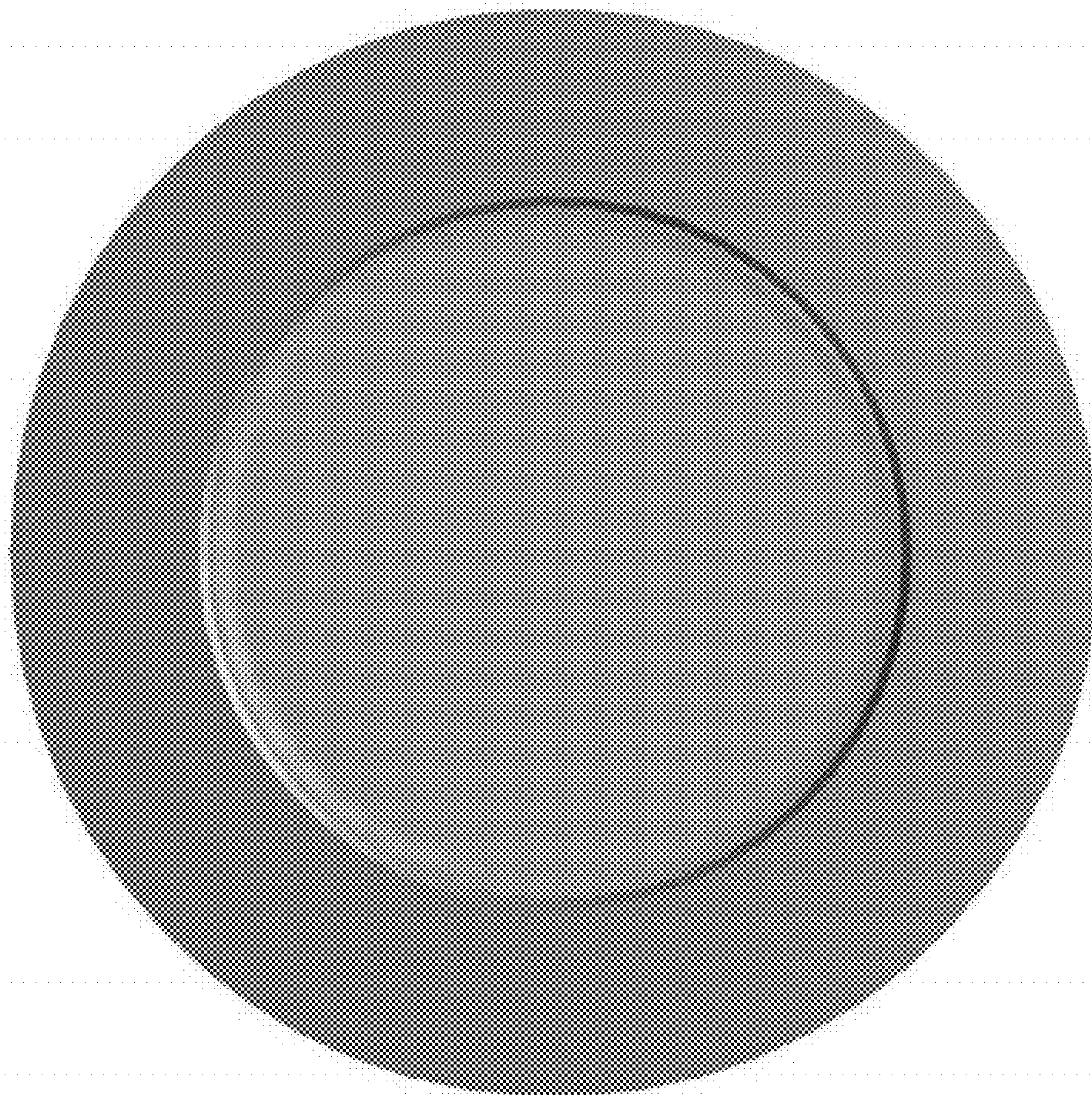
