The ornamental design for a rail vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the rail vehicle showing my new invention;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a top plan view thereof, at a reduced scale relative to FIGS. 1 and 2;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a right side elevation view thereof; and,
FIG. 7 is a front perspective view thereof, at a slightly enlarged scale.

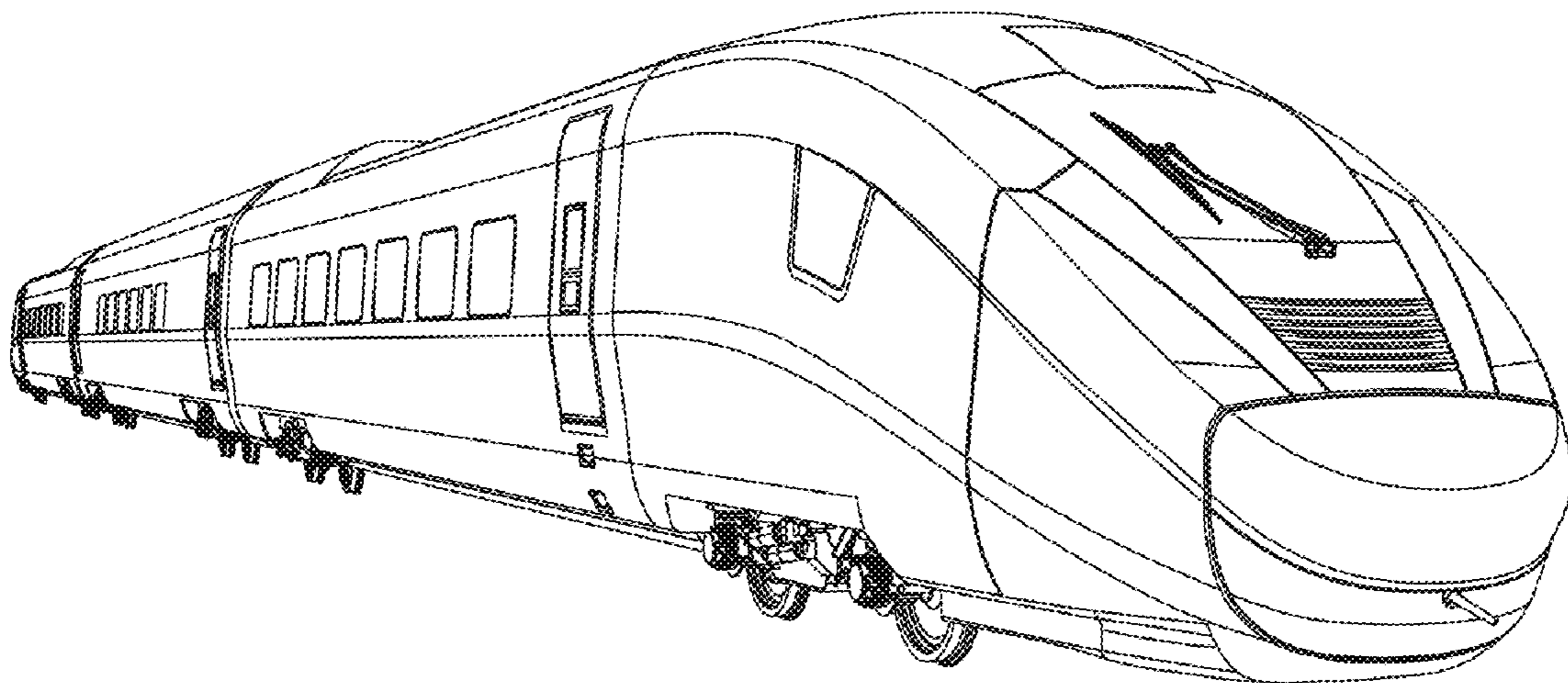

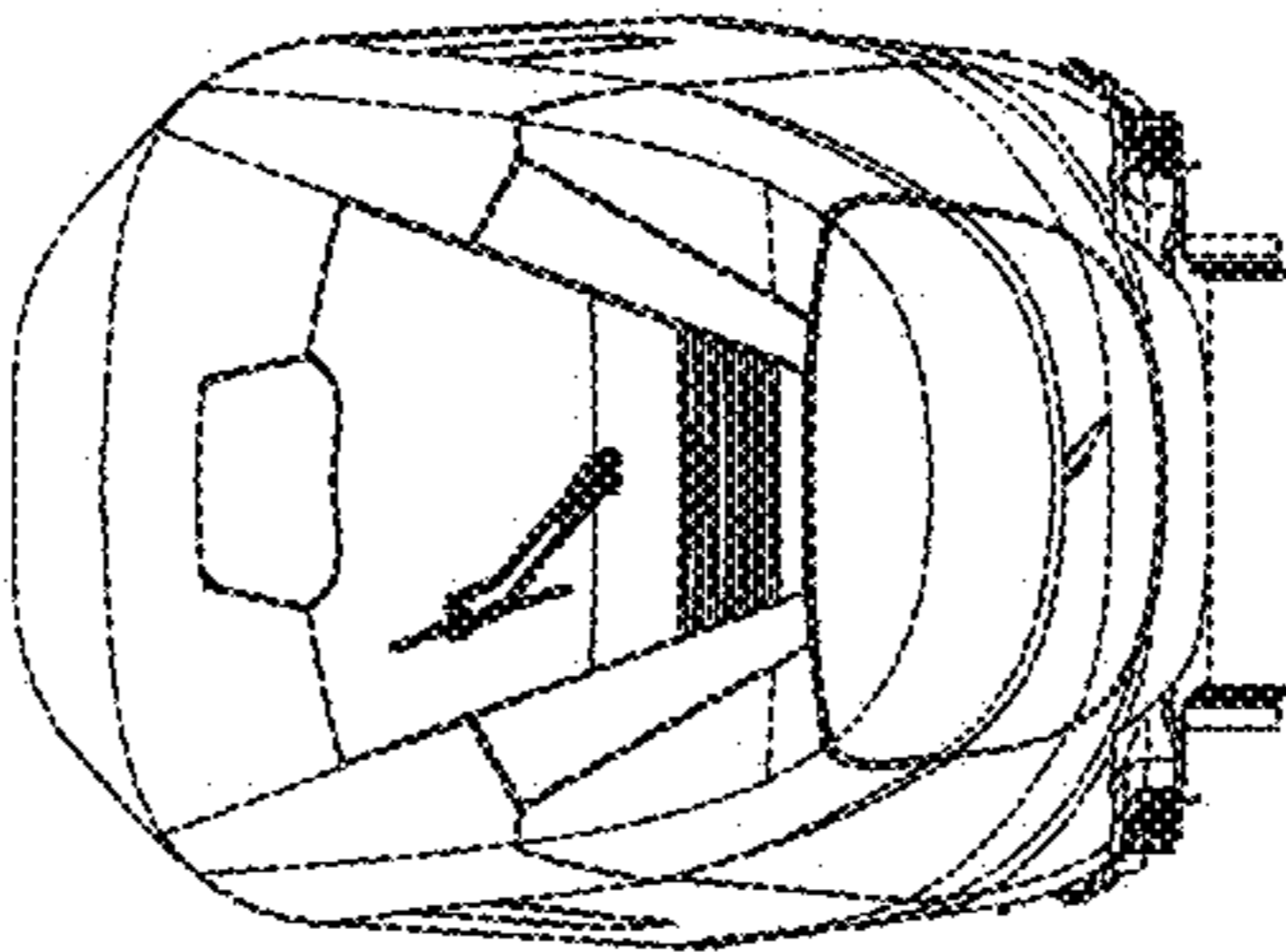

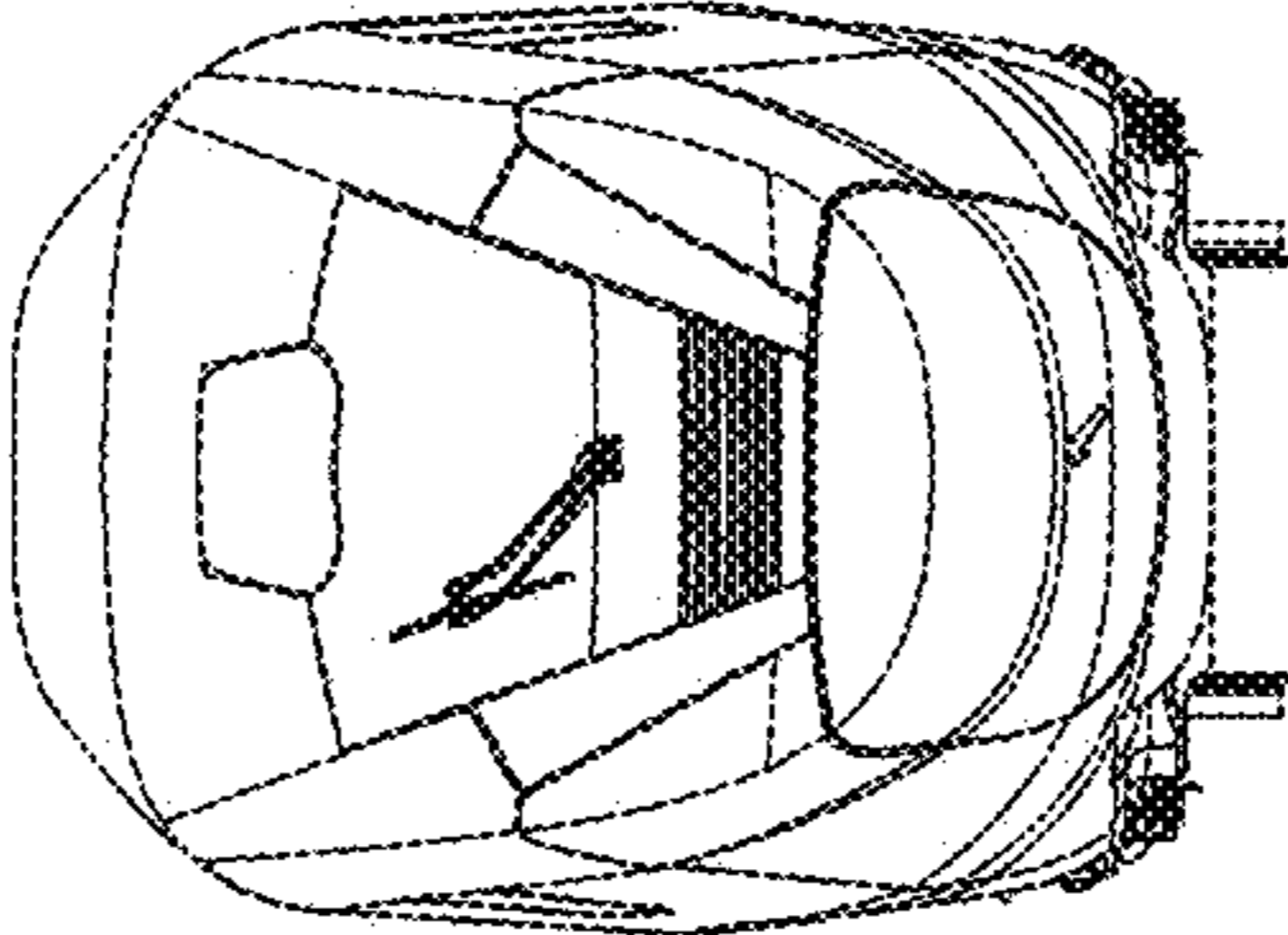

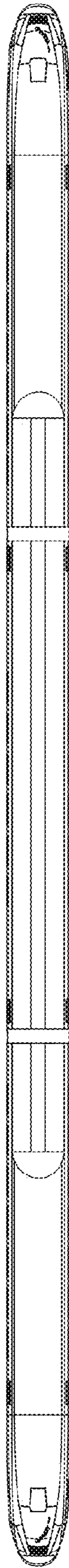

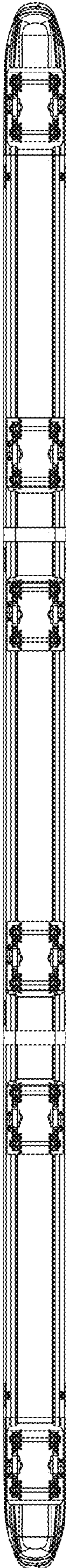

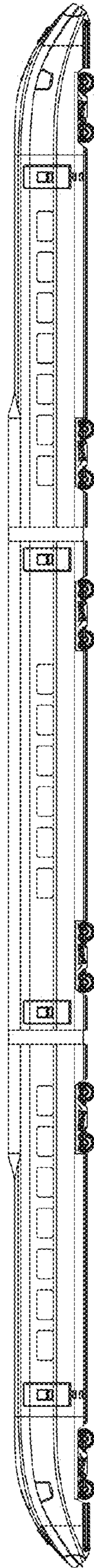

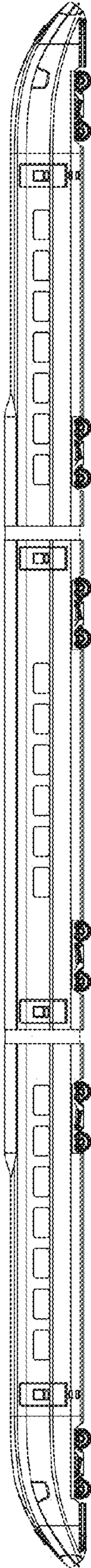
