DESCRIPTION

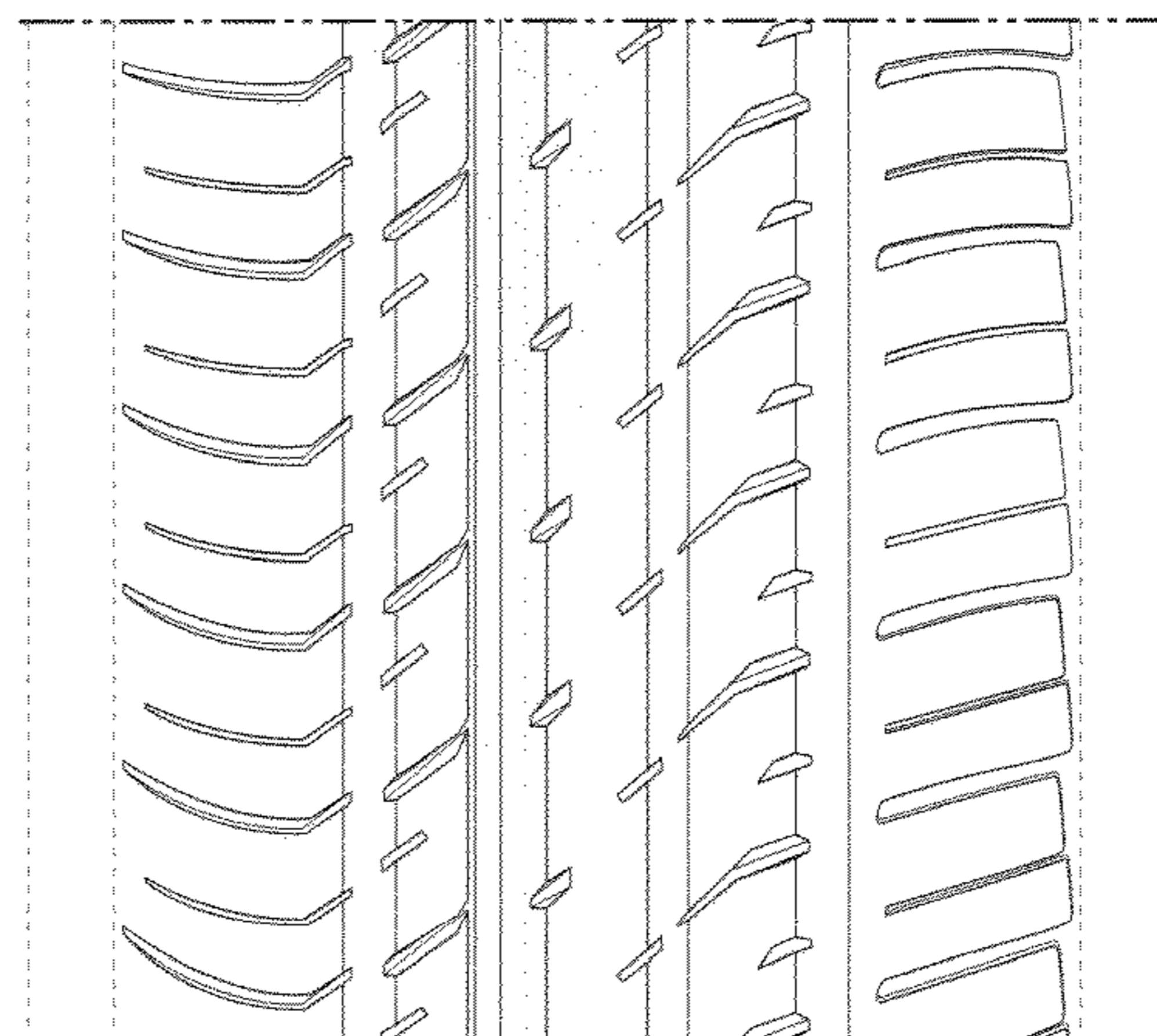
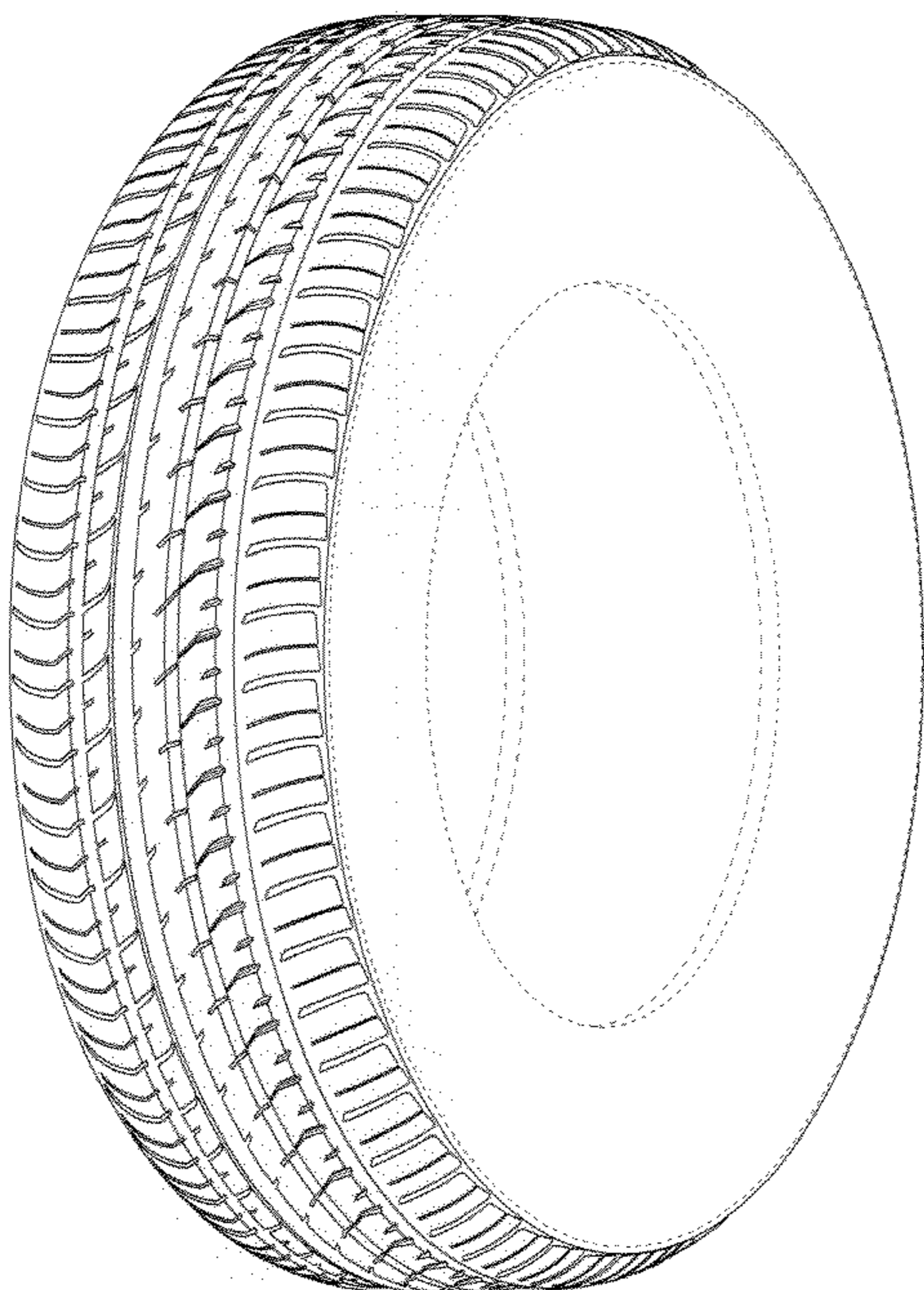

FIG. 7 is a bottom view of a tire showing our new design; and, FIG. 8 is an enlarged fragmentary front view of a tire showing our new design. The broken line showing of the sidewall, inner bead and the peripheral boundary between the tire tread and the sidewall is included for the purpose of illustrating environment and forms no part of the claimed design. The dot-dot-dash lines in FIG. 8 define the bounds of the fragmentary view and form no part thereof.

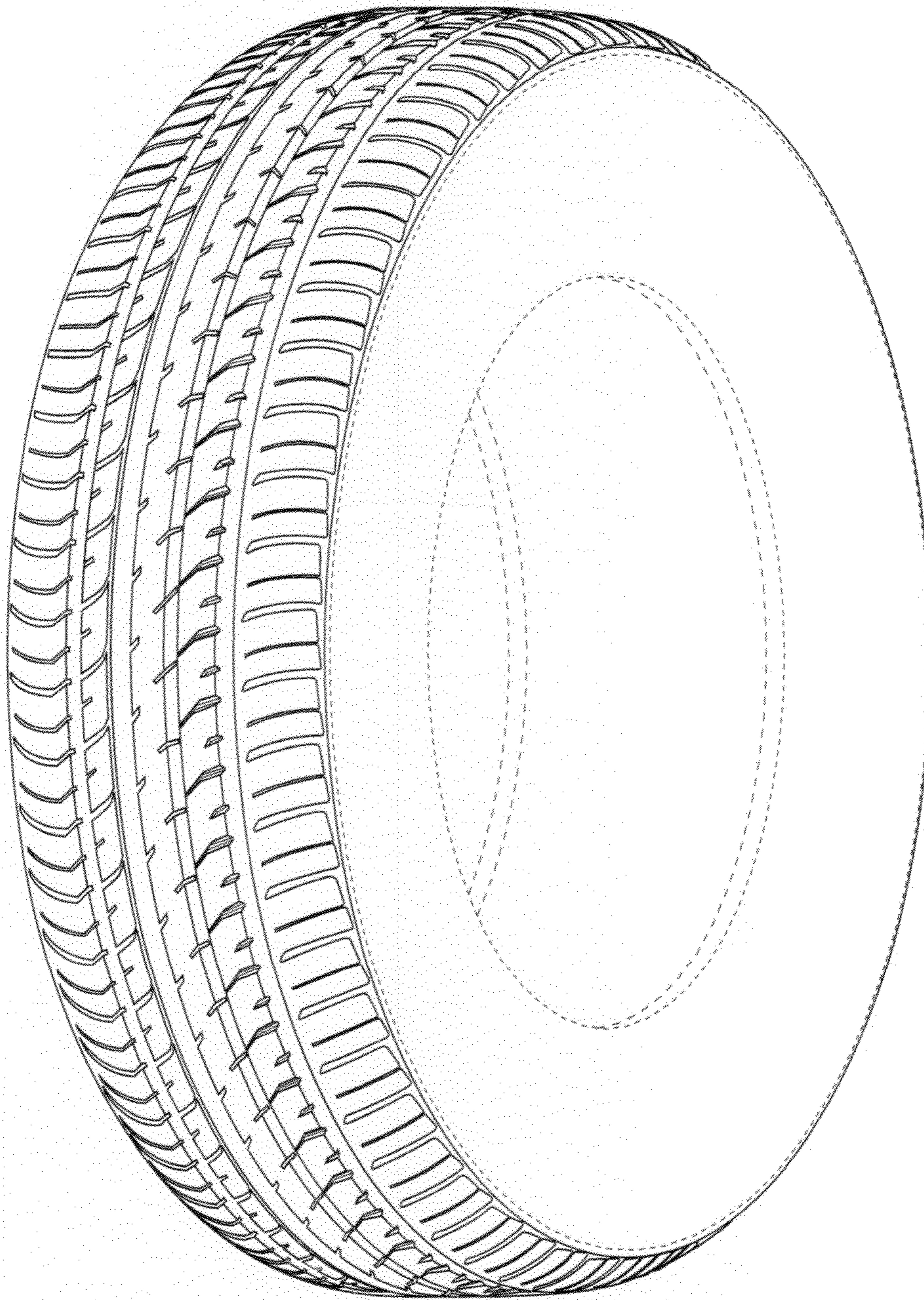

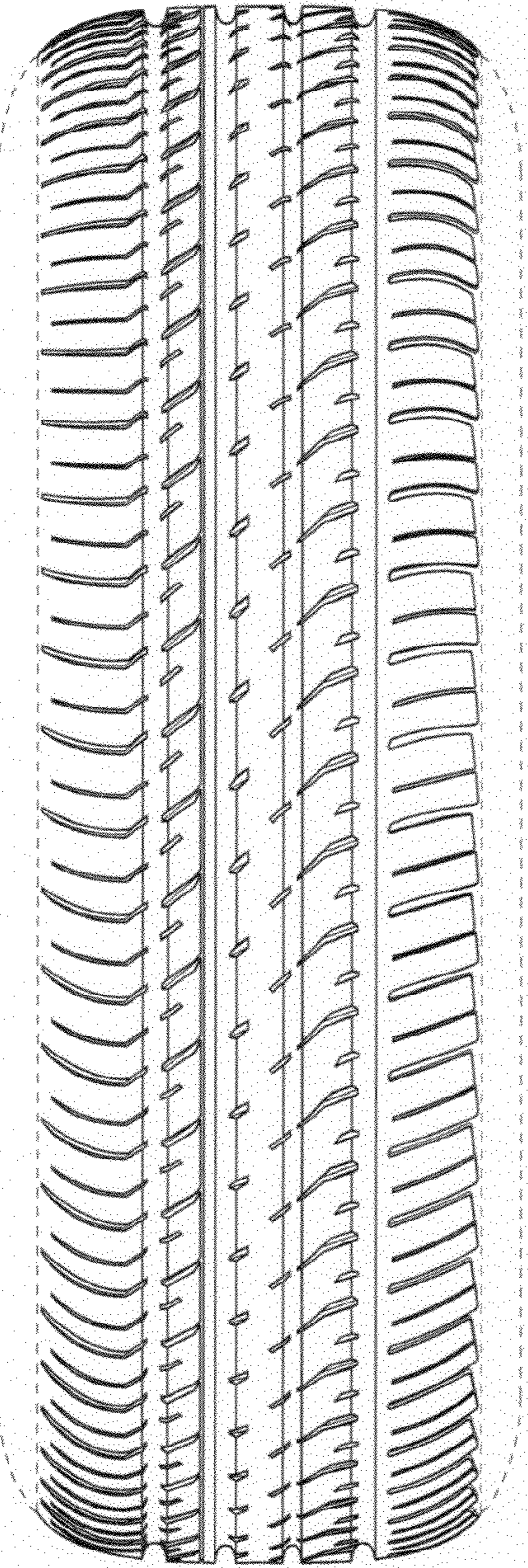

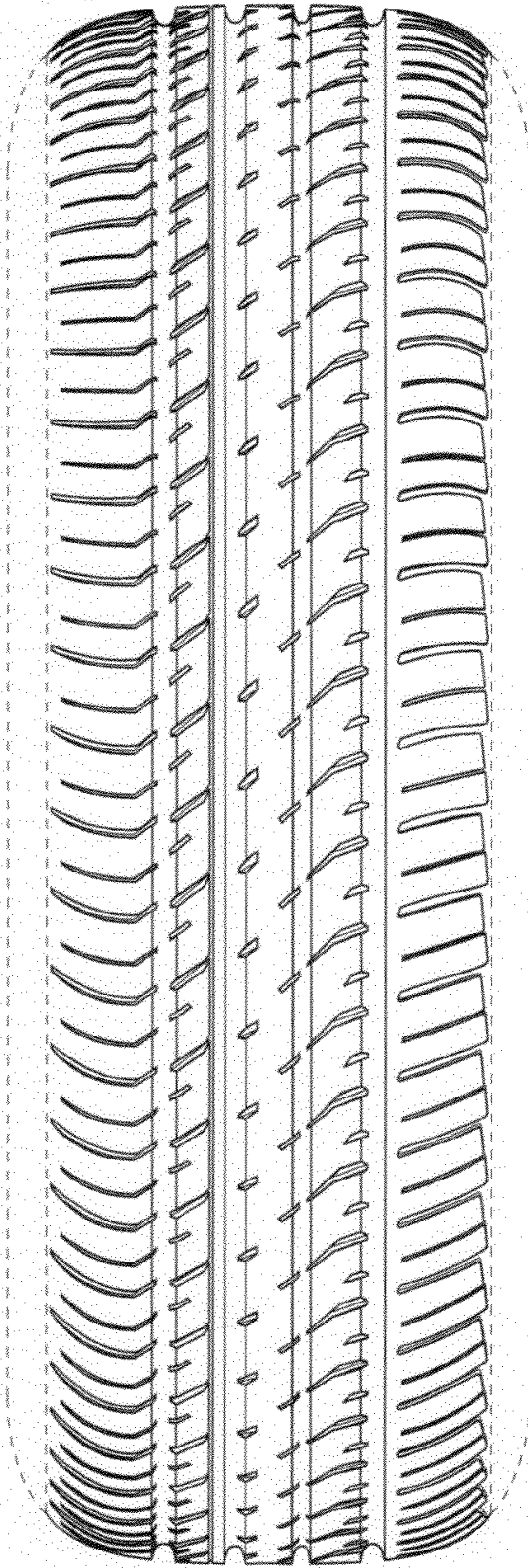

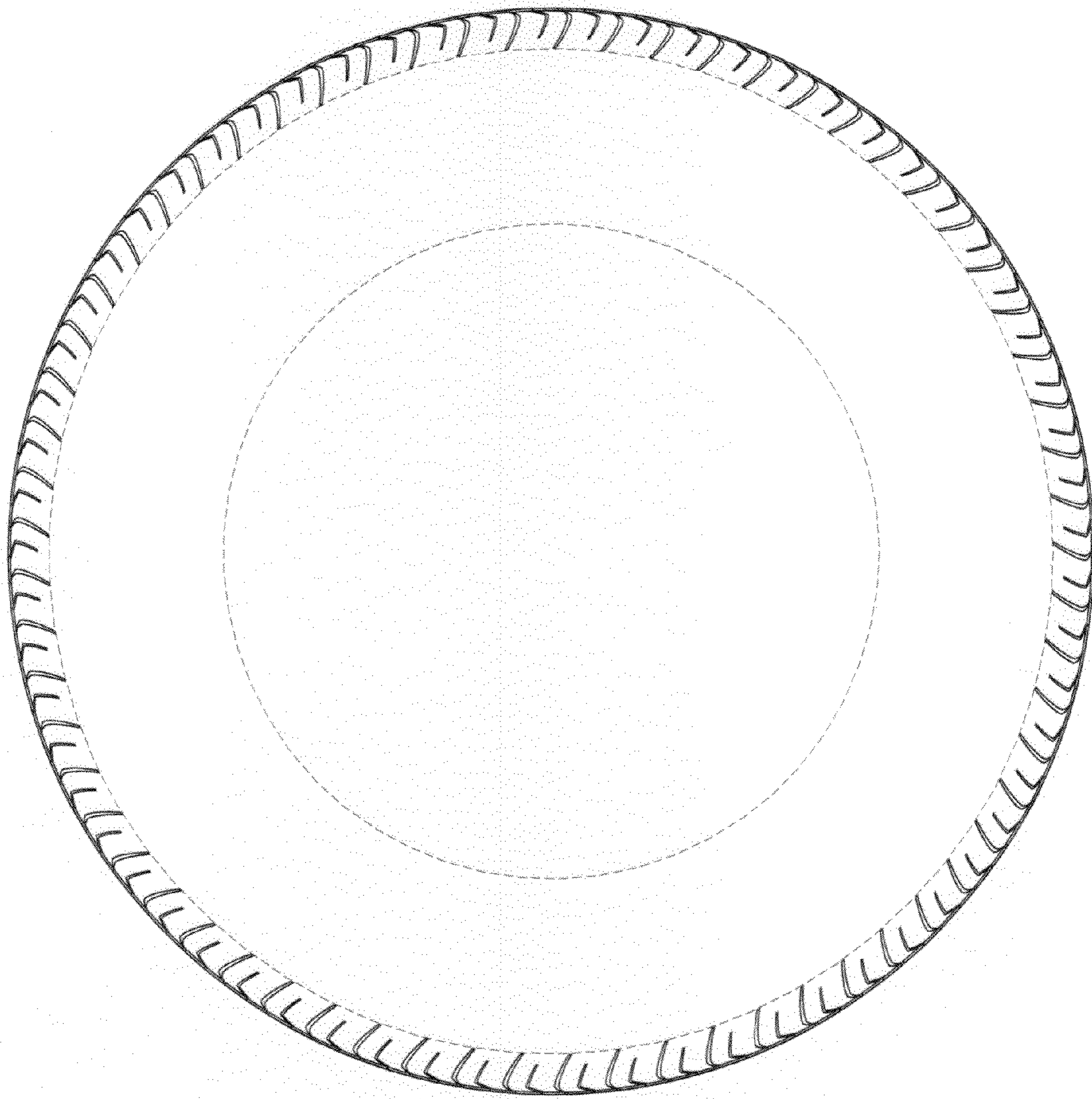

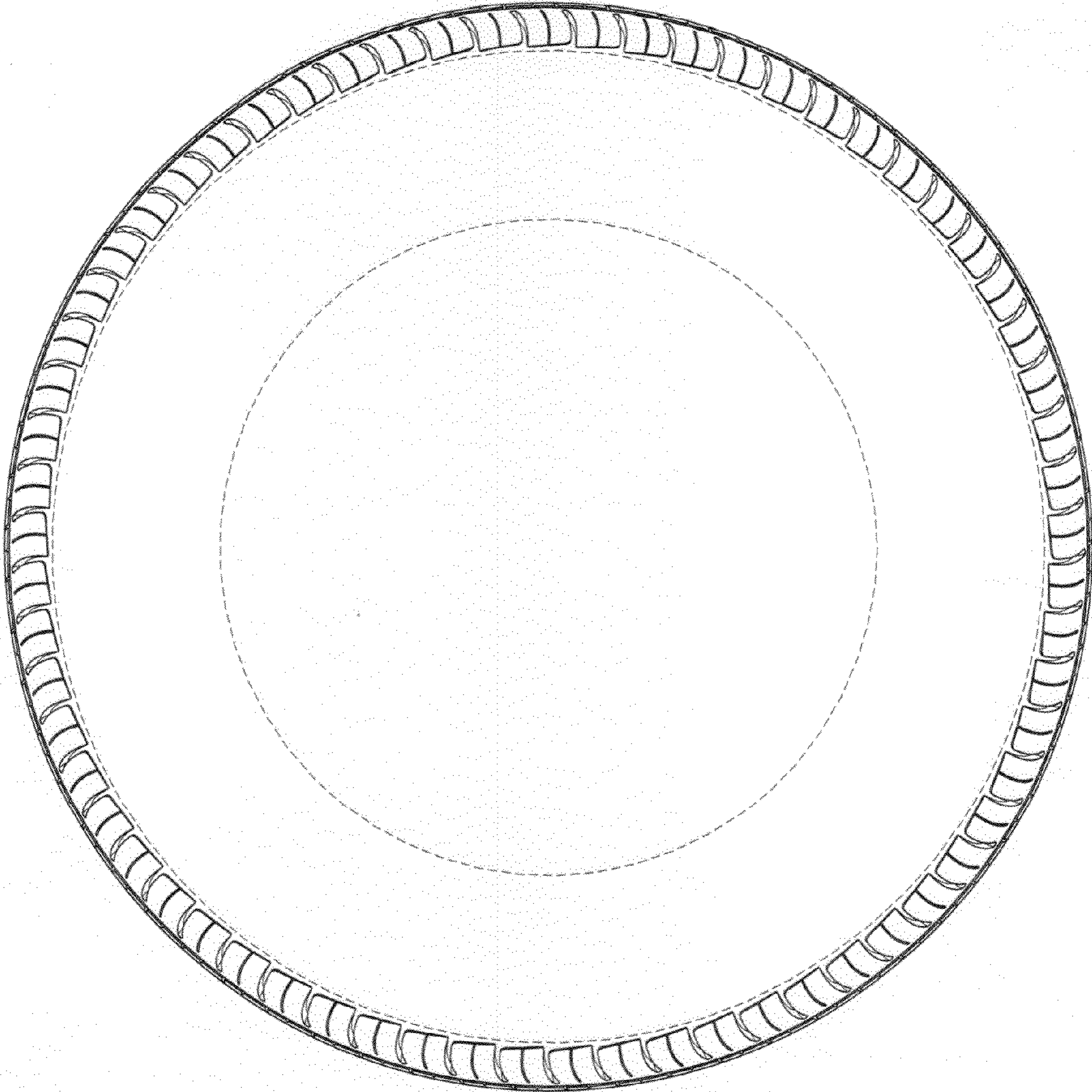

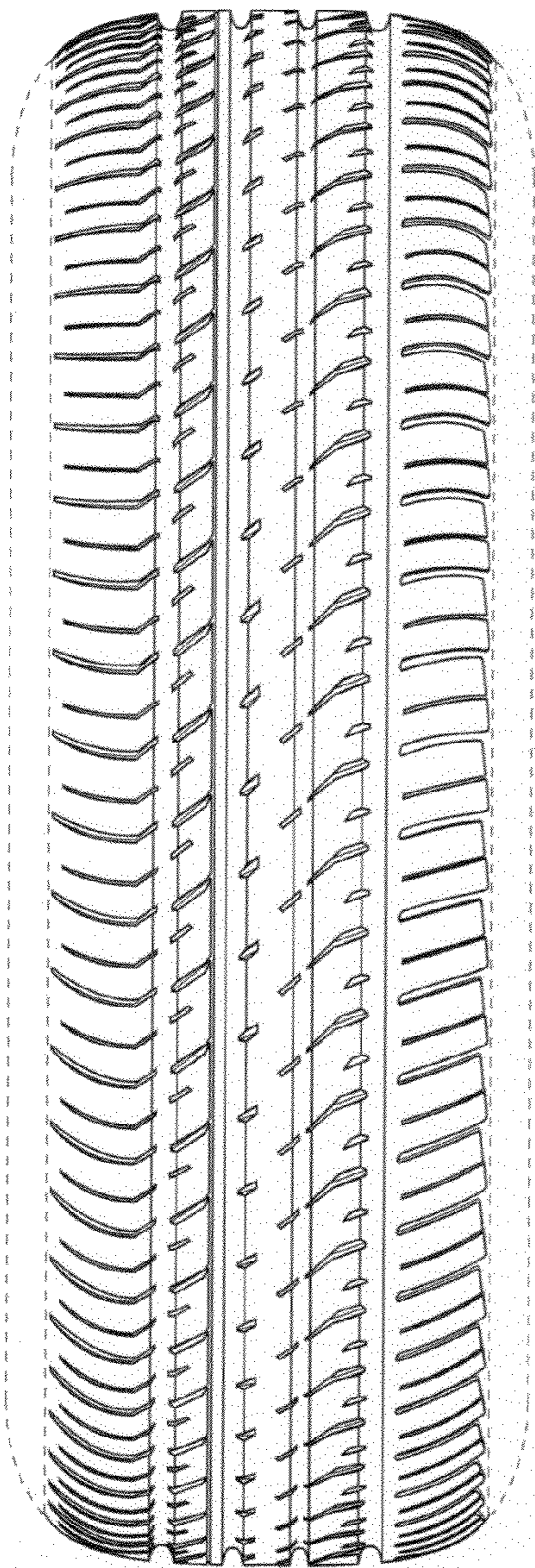

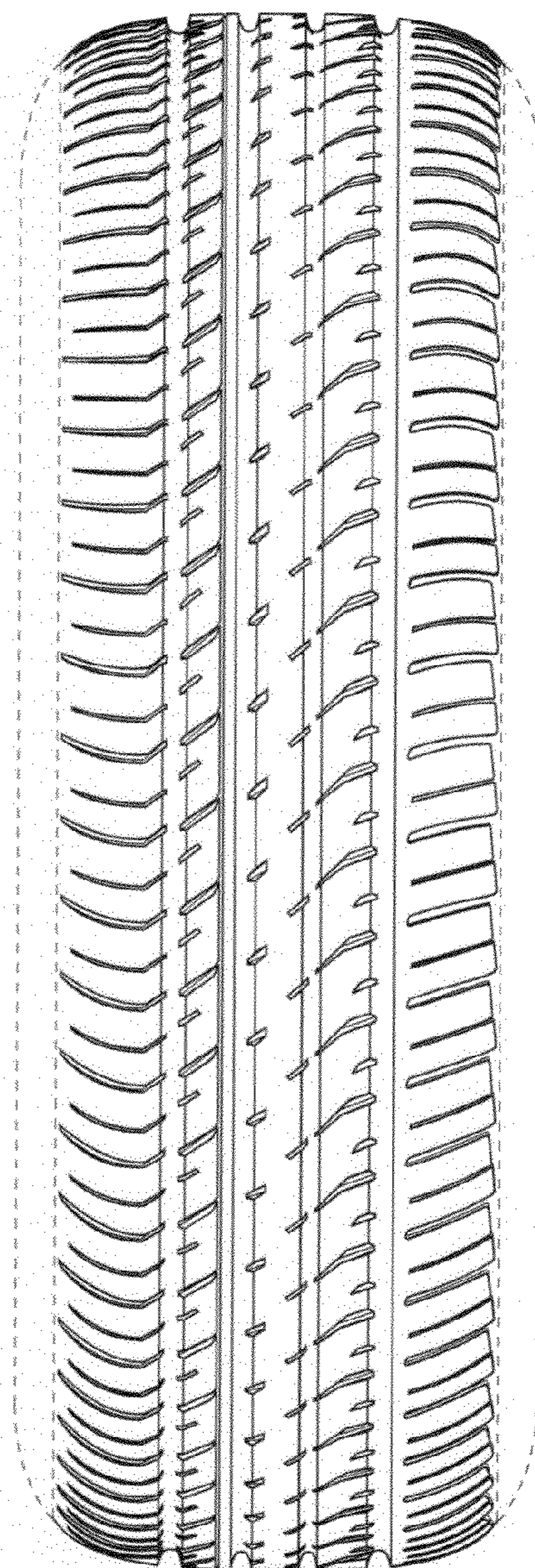

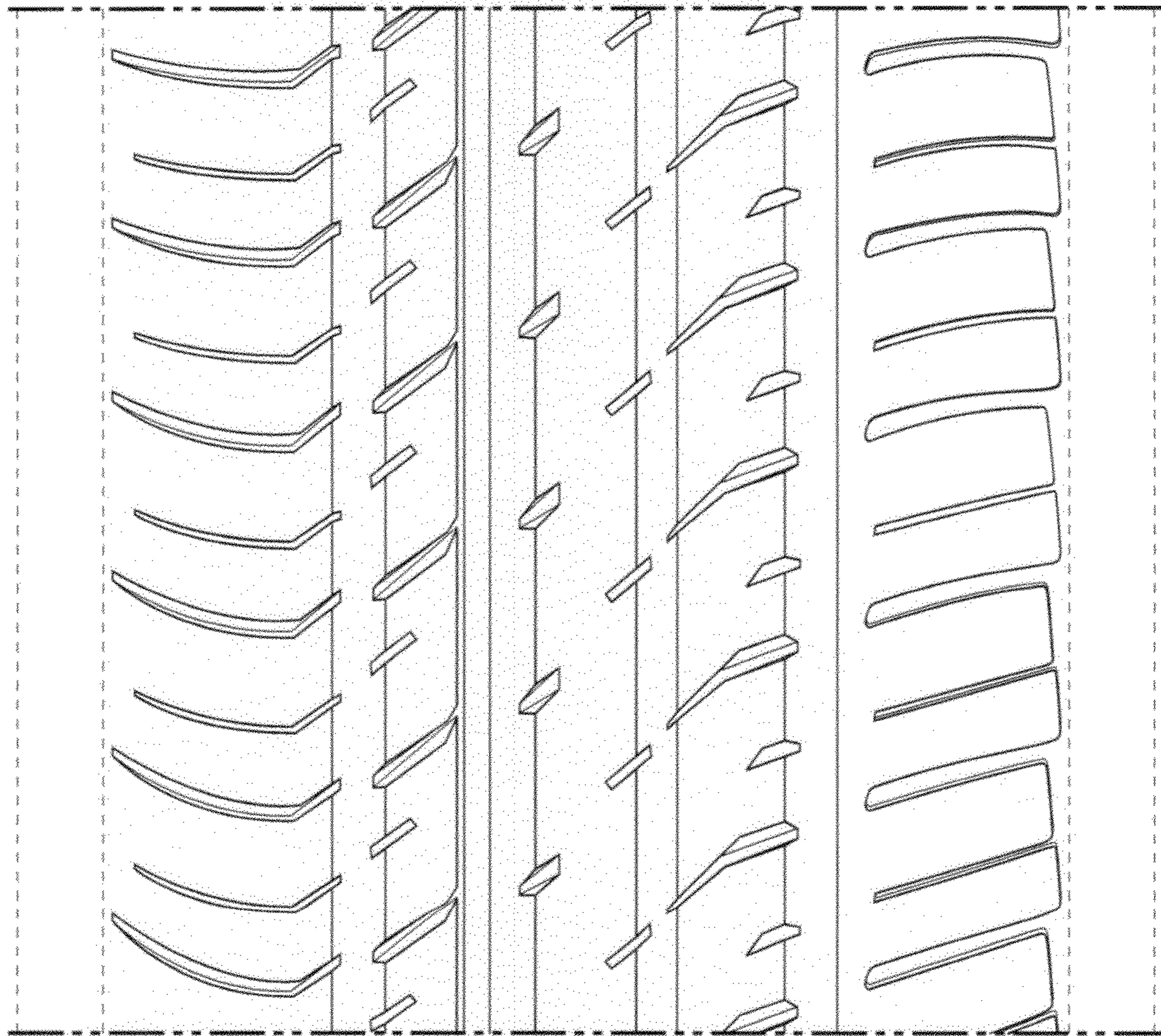
