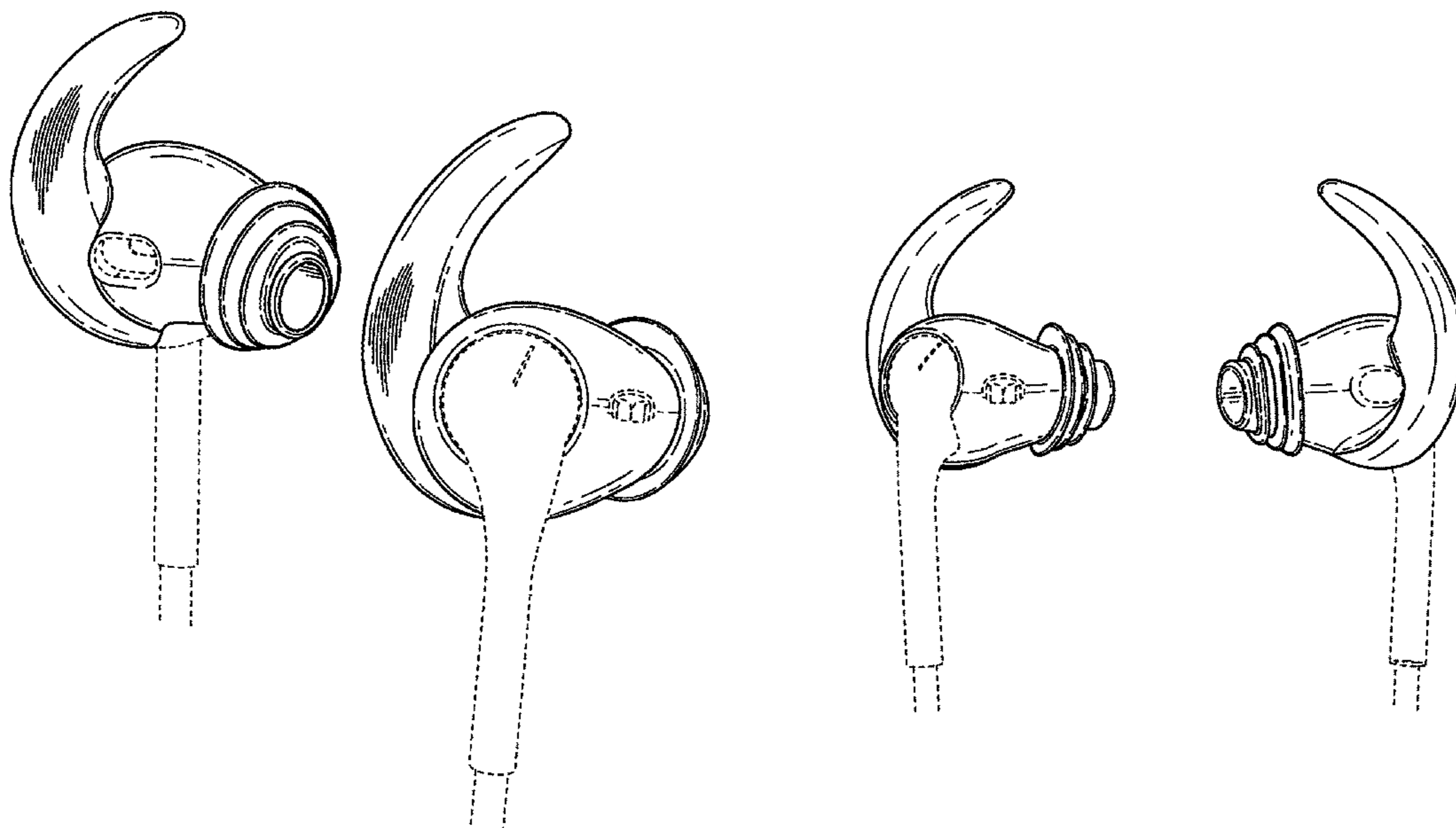
(57) **CLAIM**

The ornamental design for headphones, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the headphones, showing the new design;  
FIG. 2 is a front view of the left headphone, and a rear view of the right headphone;  
FIG. 3 is a rear view of the left headphone, and a front view of the right headphone;  
FIG. 4 is a side view of the headphones;  
FIG. 5 is an opposing side view of the headphones;  
FIG. 6 is a top view of the headphones; and,  
FIG. 7 is a bottom view of the headphones.

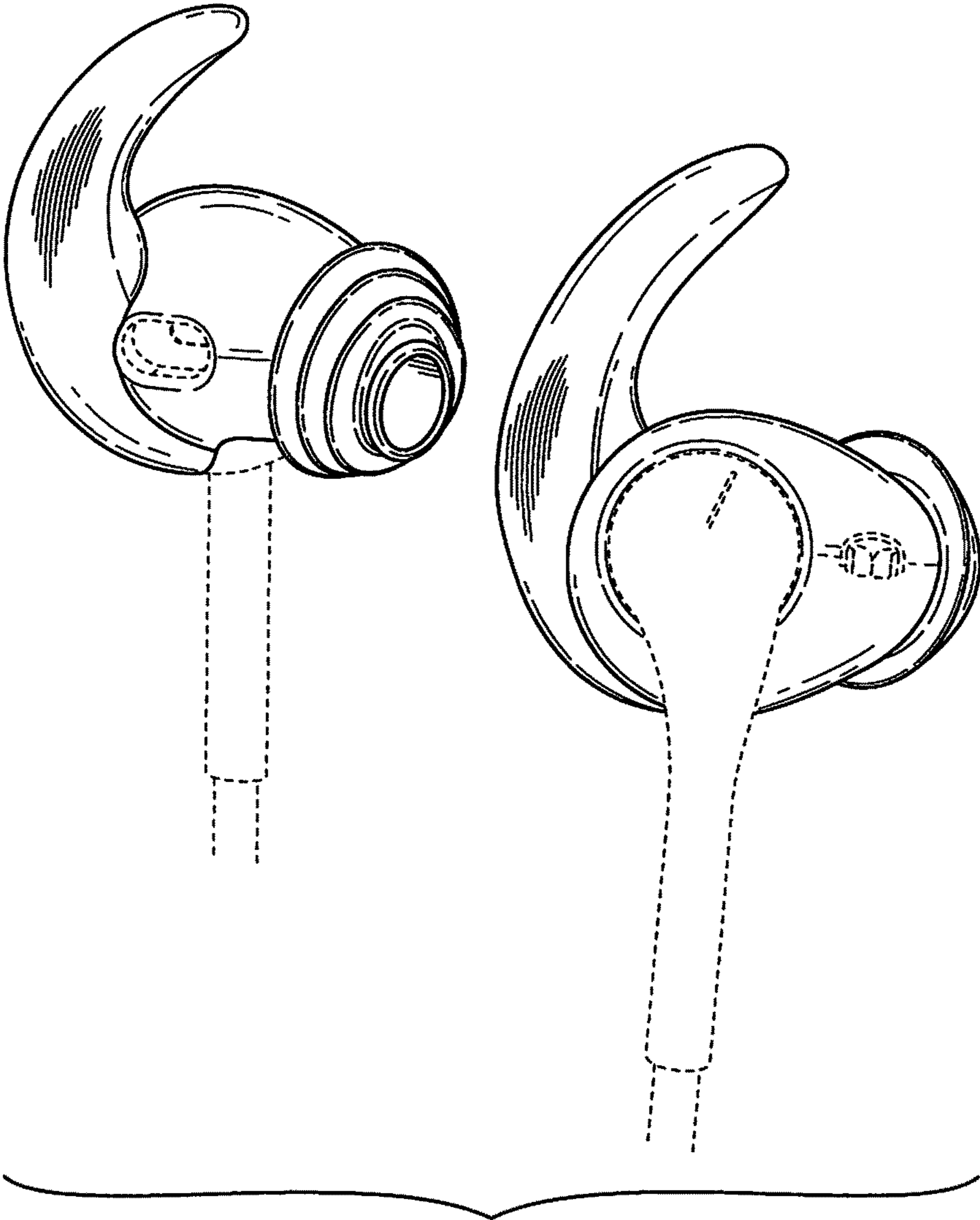

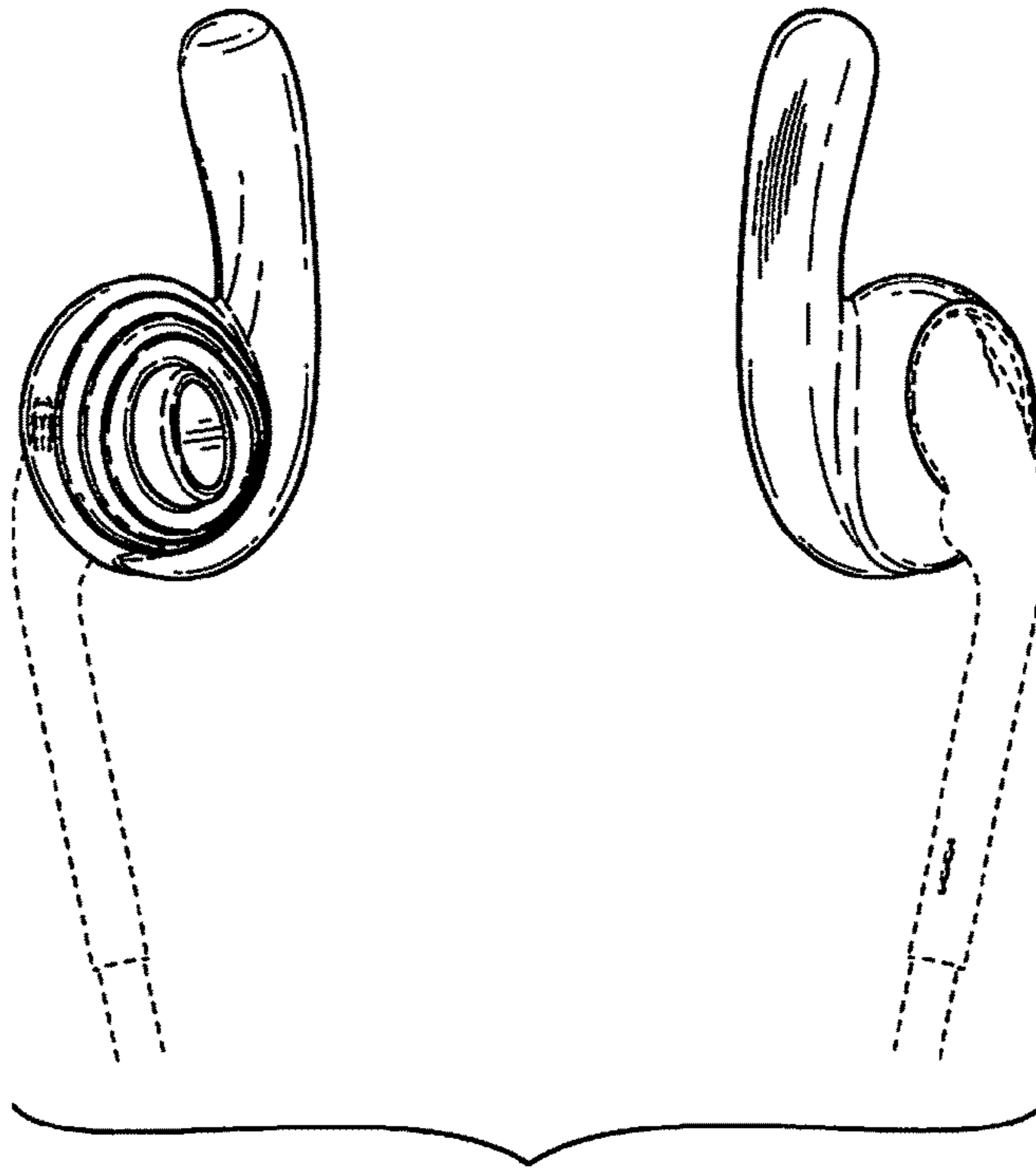

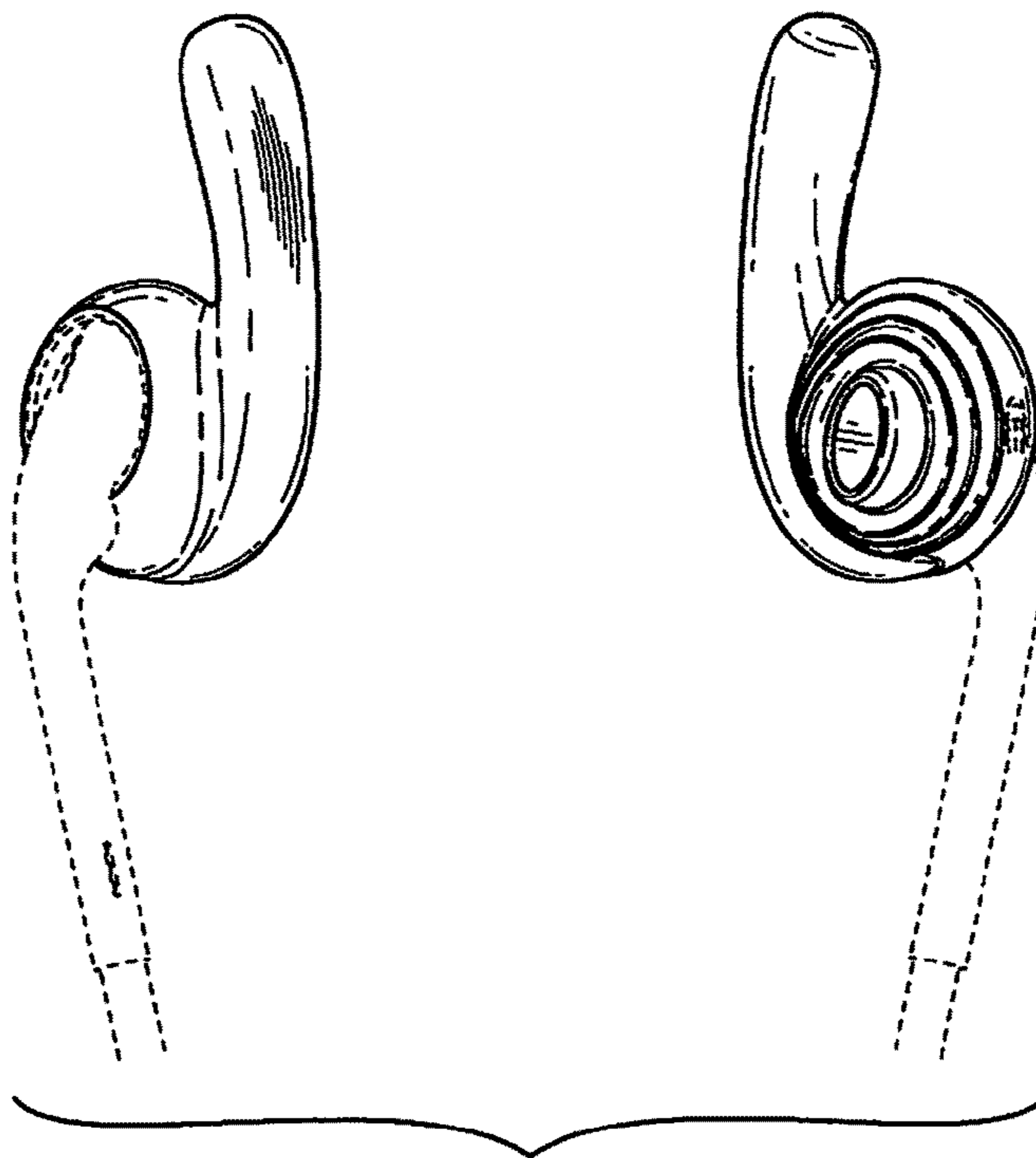

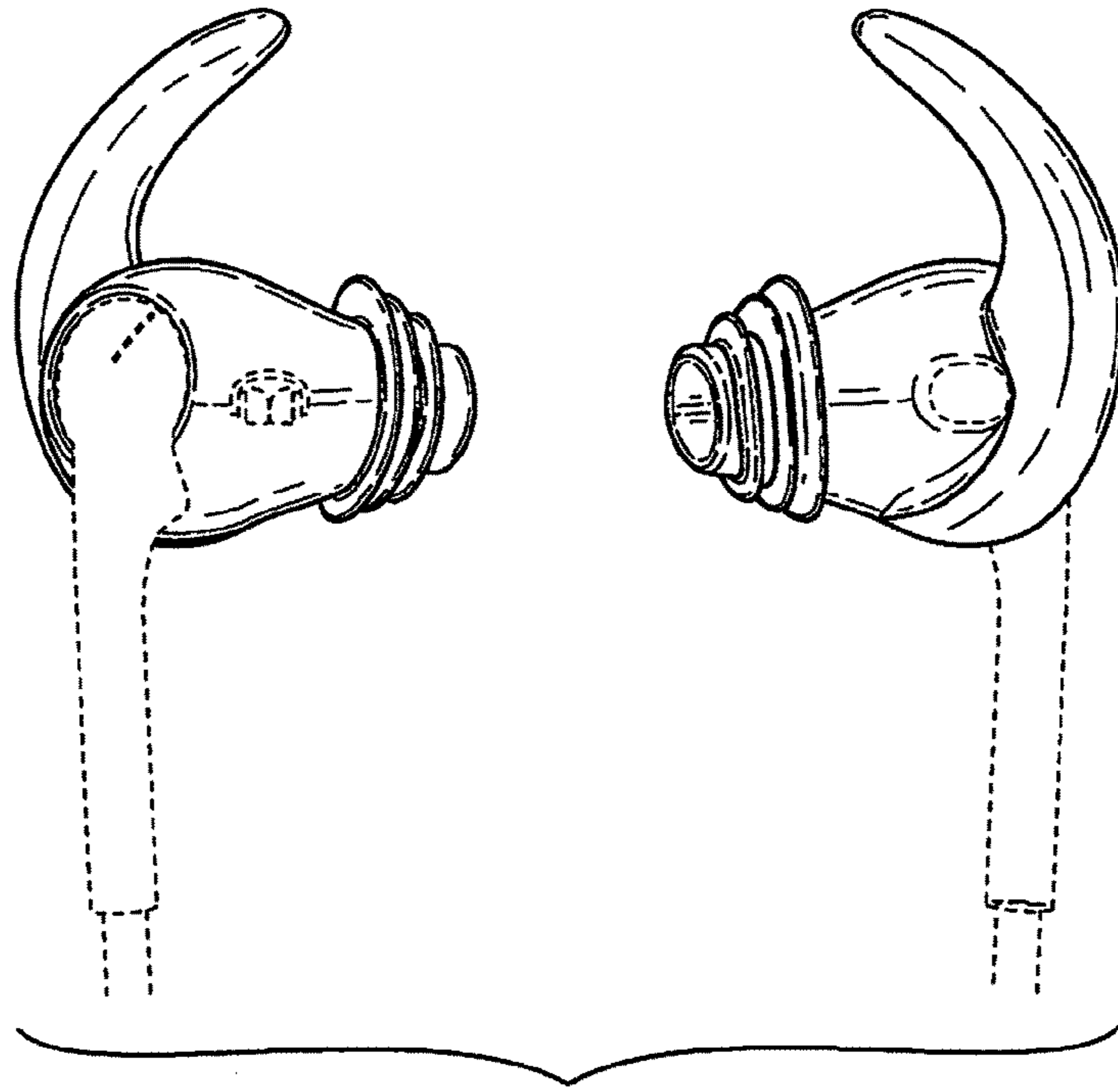

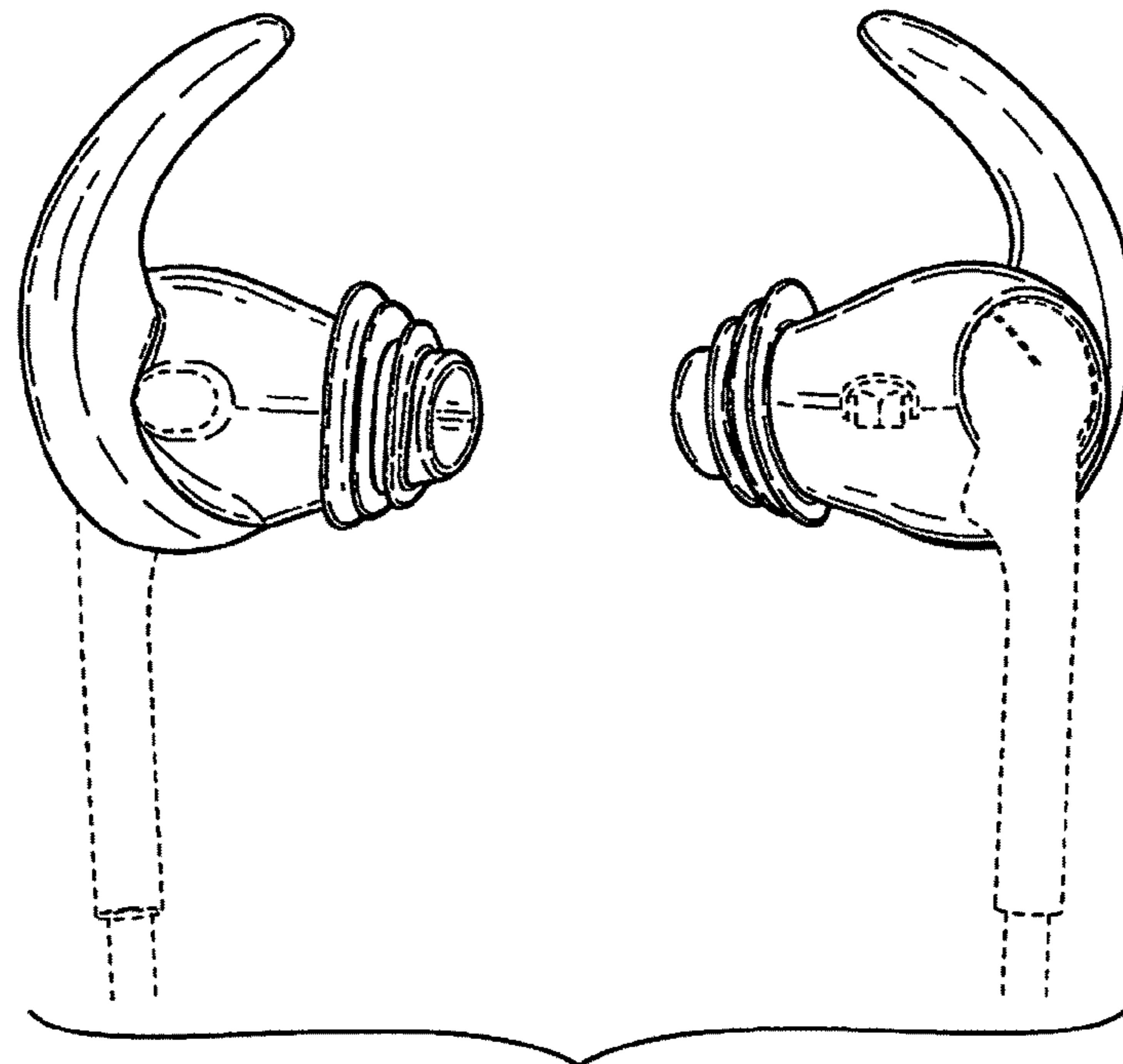

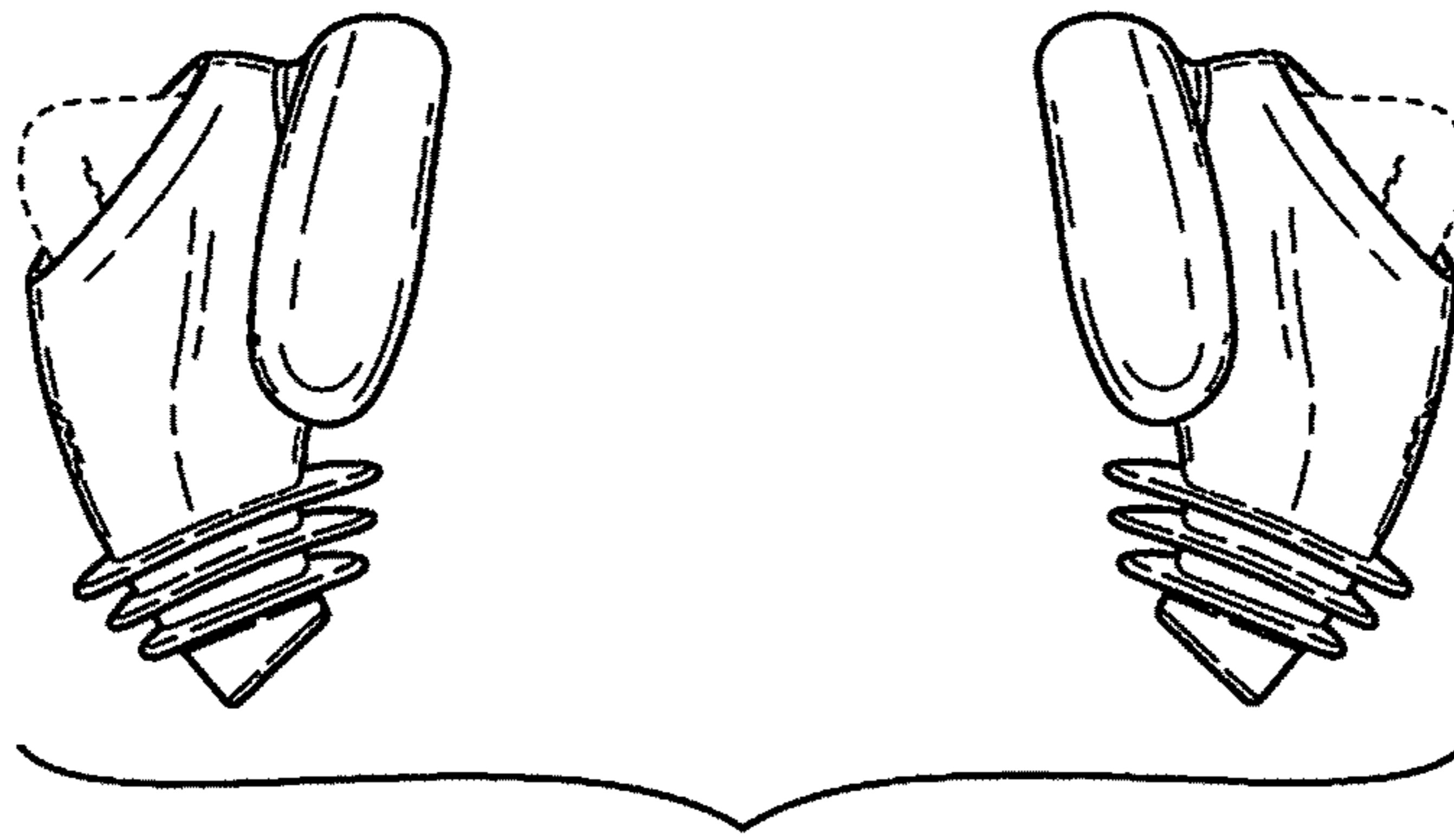

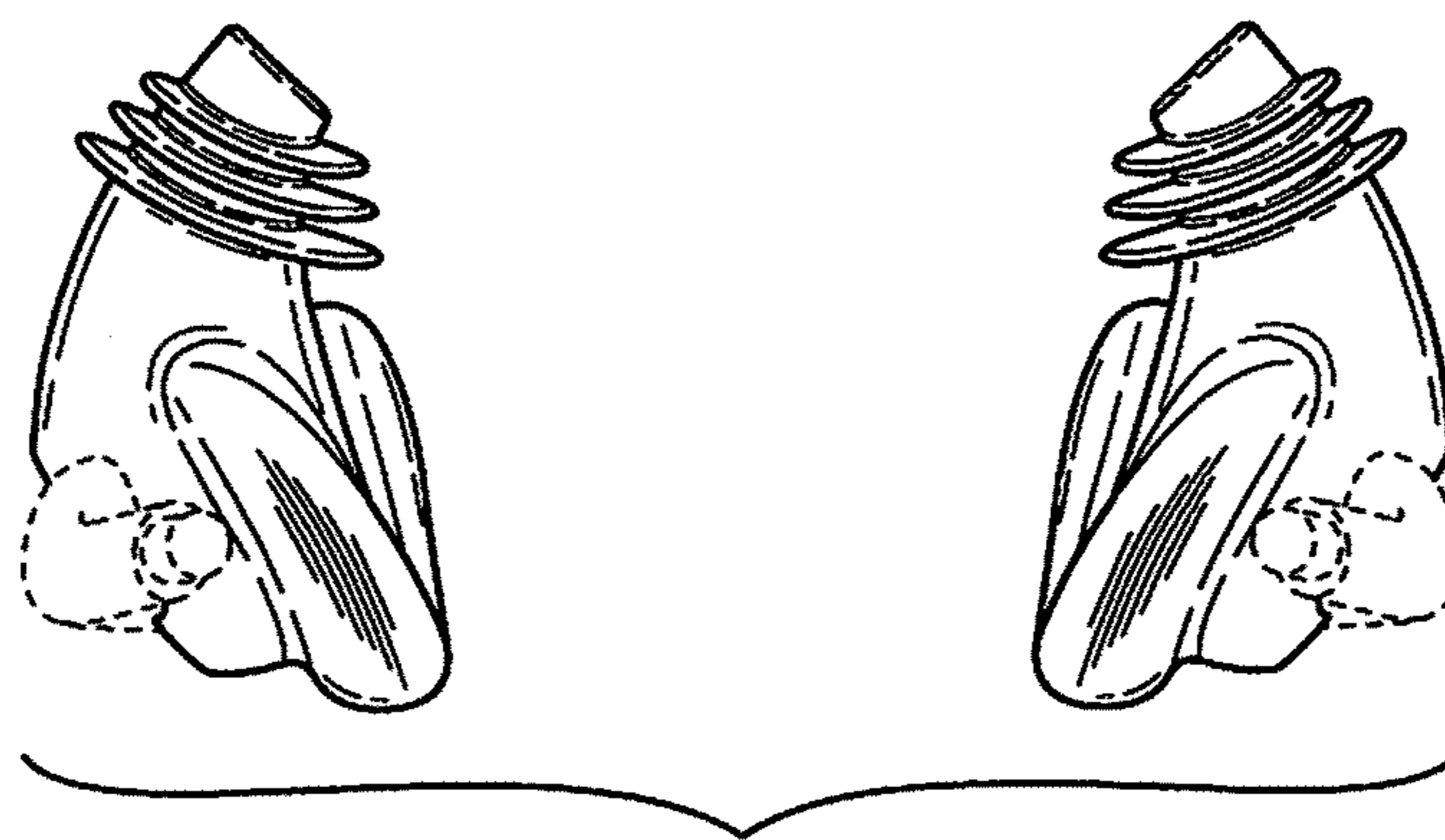
