FIG. 8 is a rear view thereof.

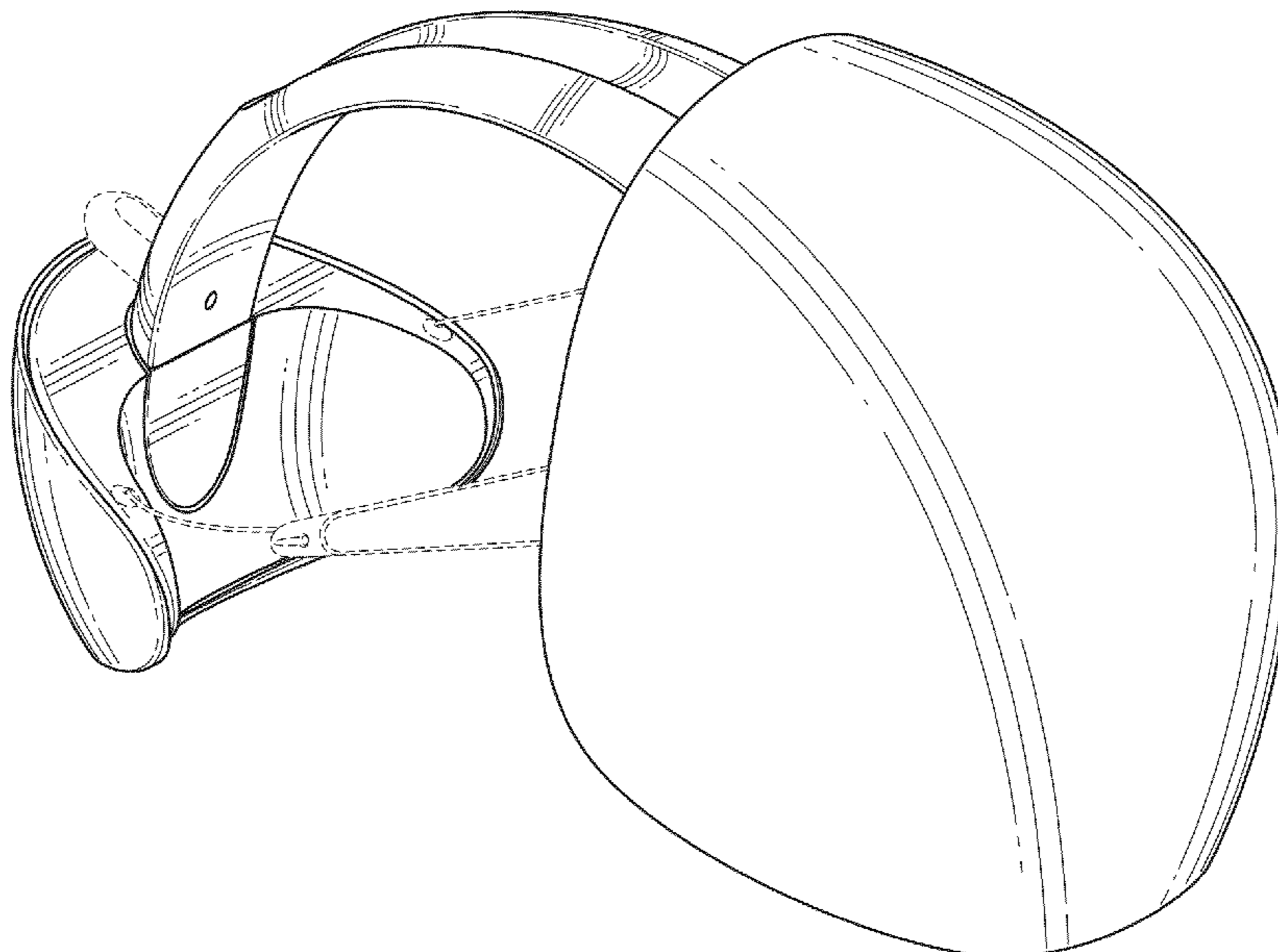
The broken lines shown in the Figures show portions of the virtual reality headset that form no part of the claimed design.

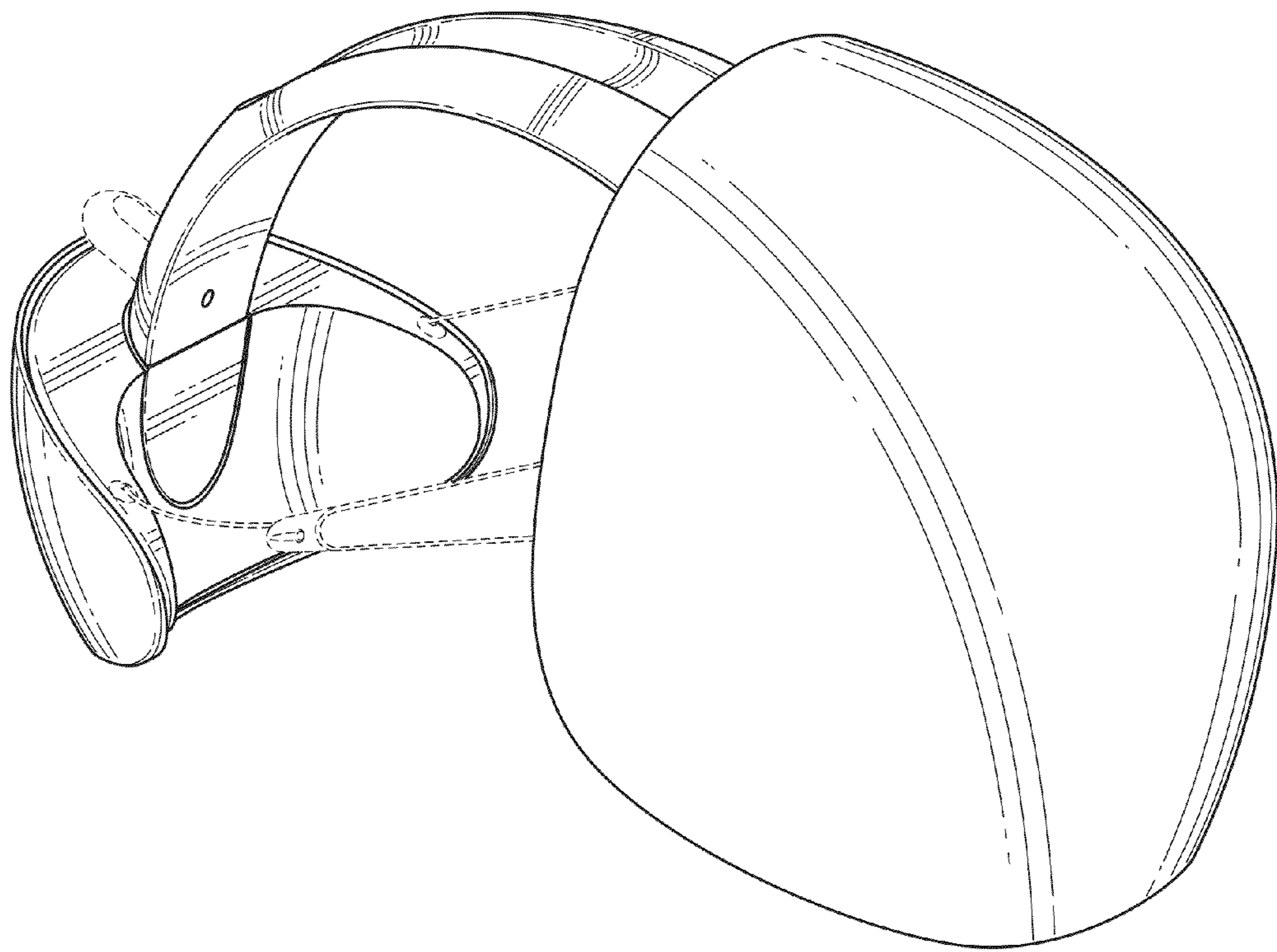

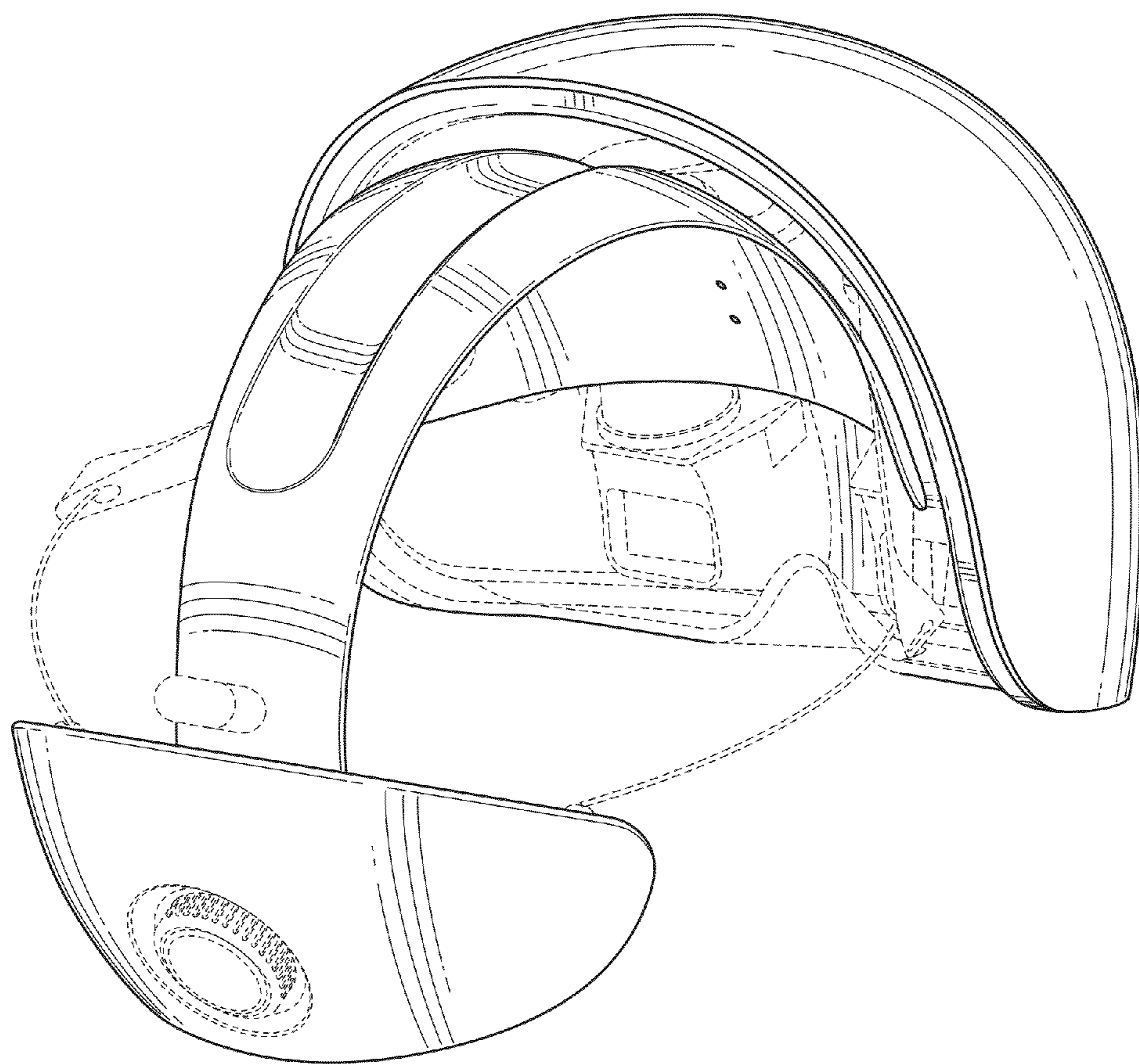

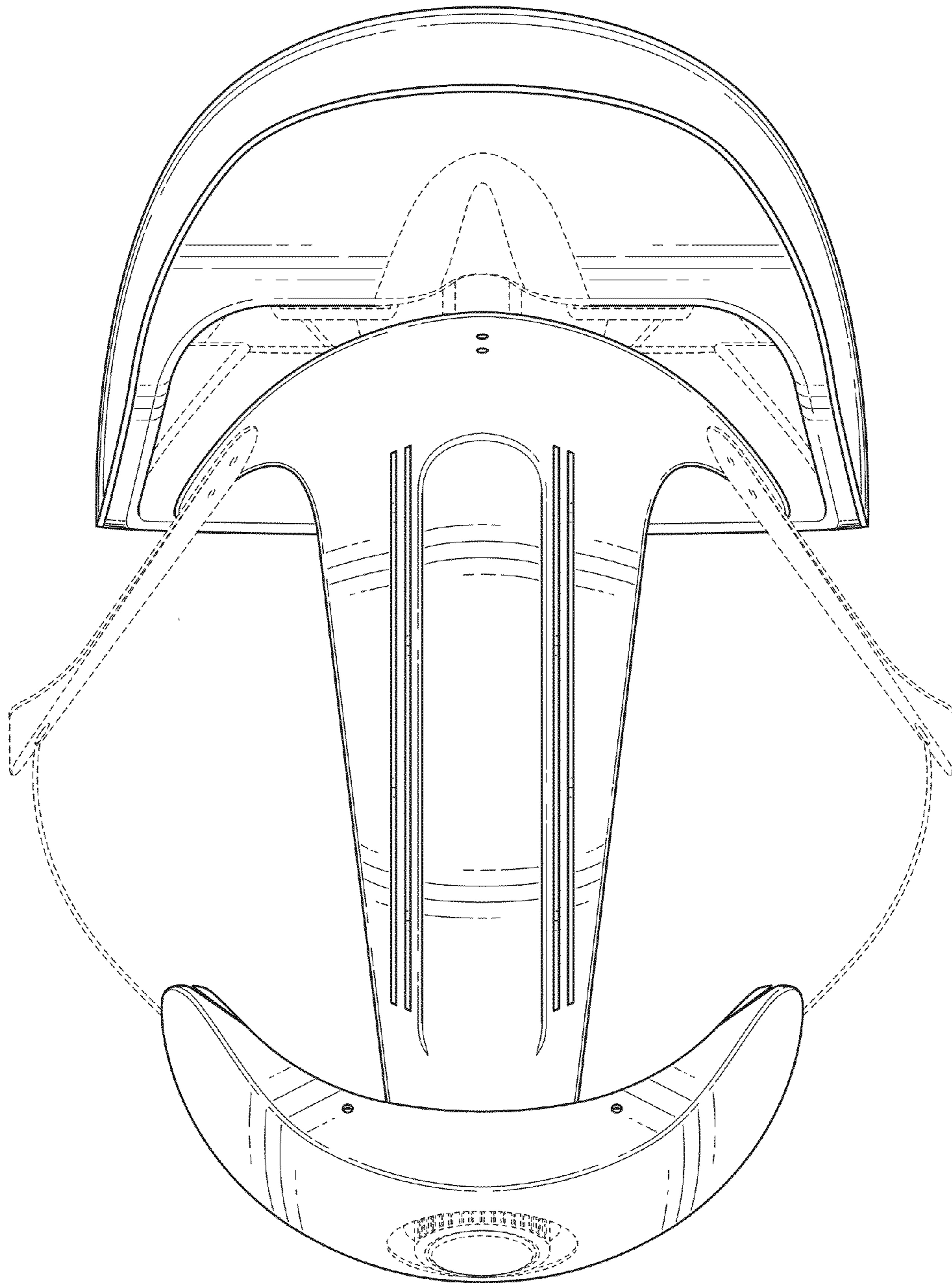

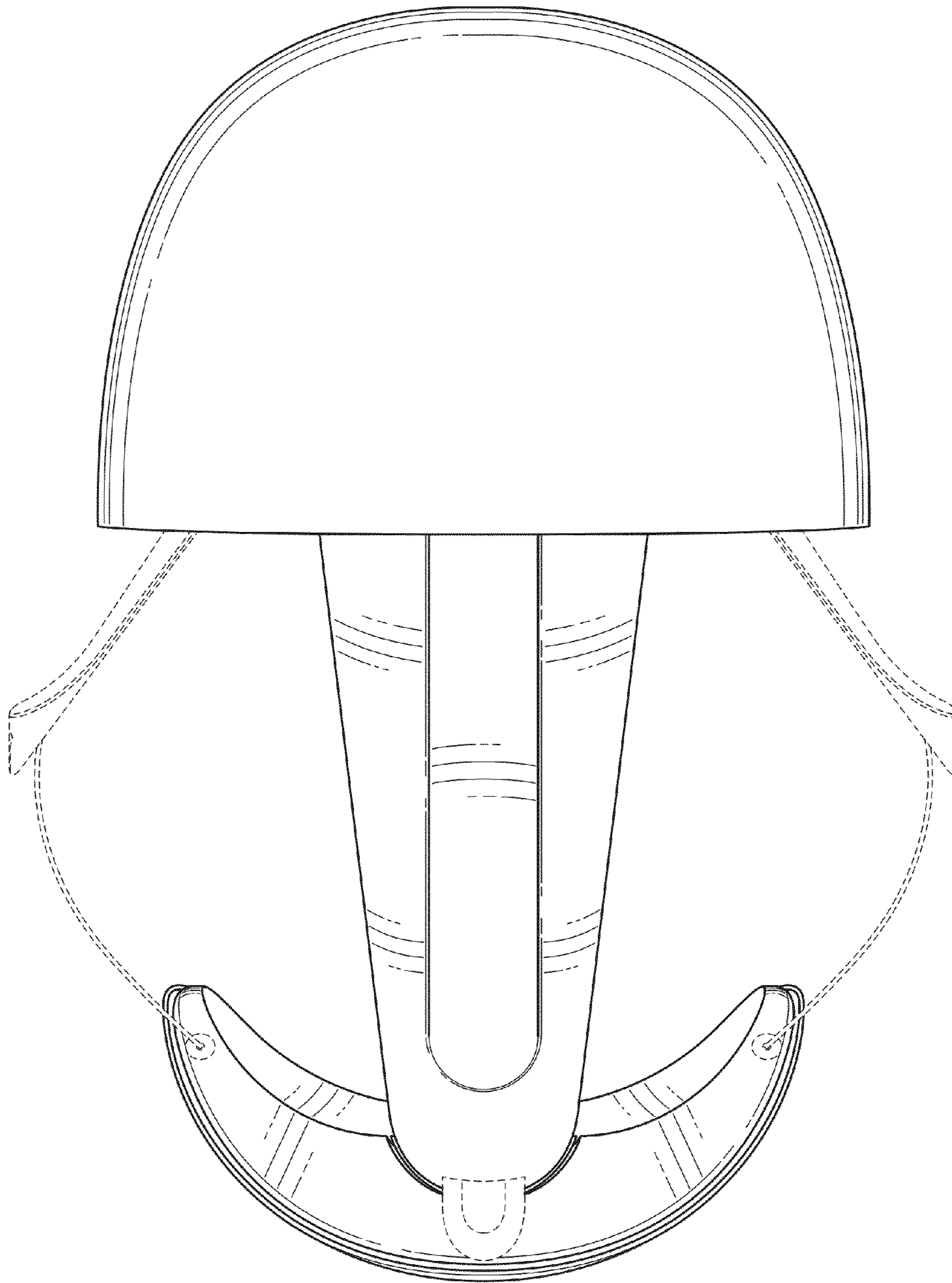

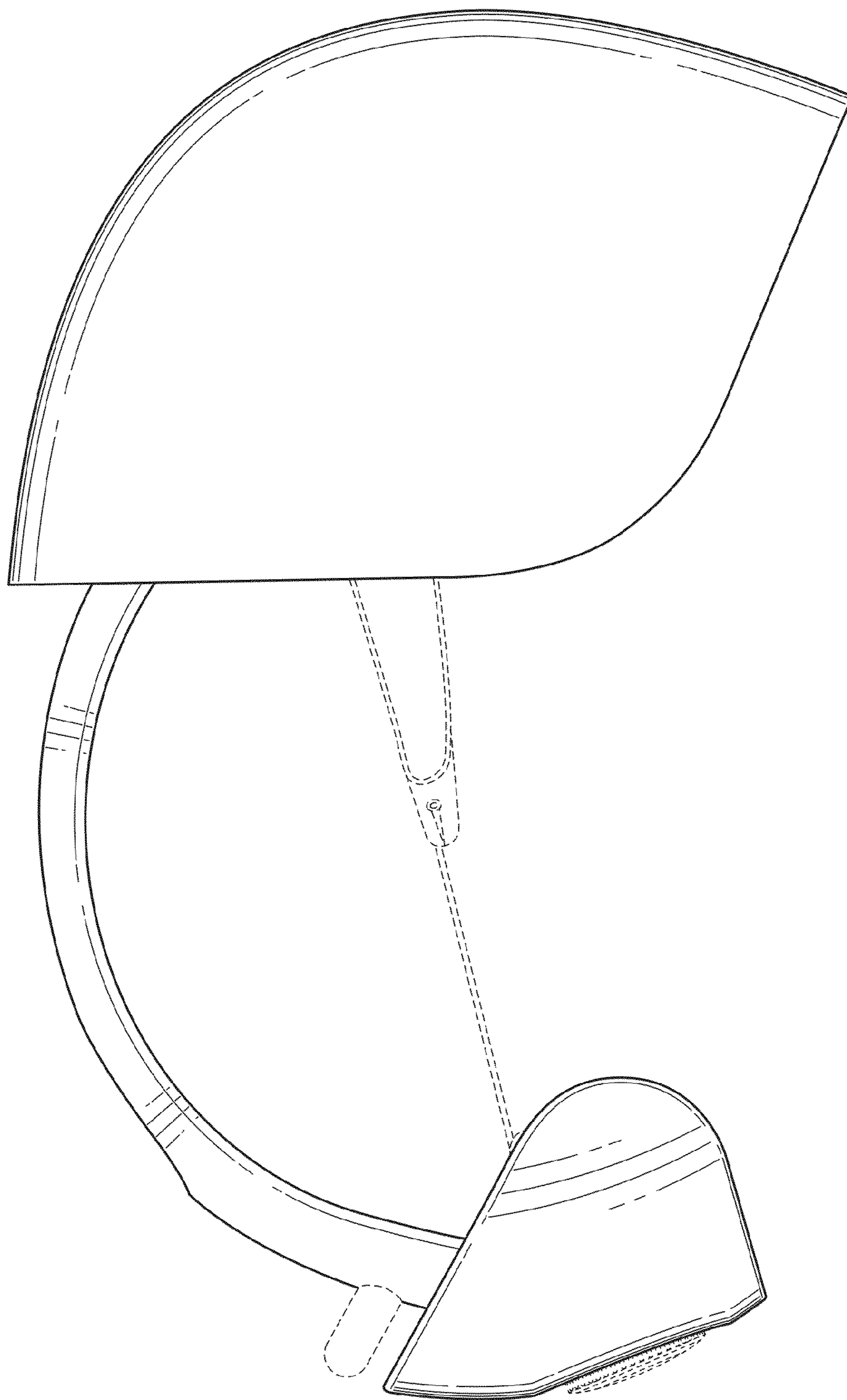

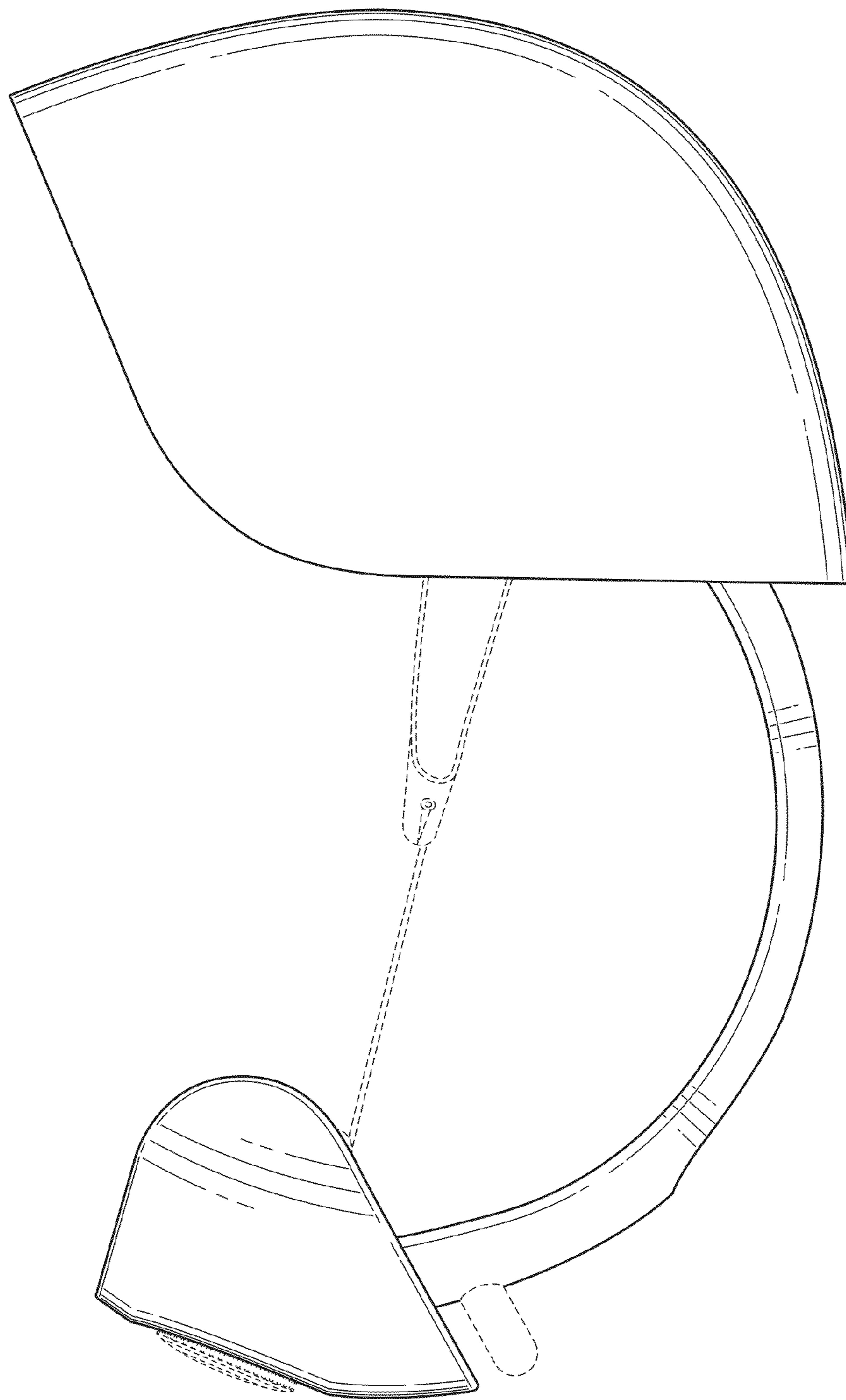

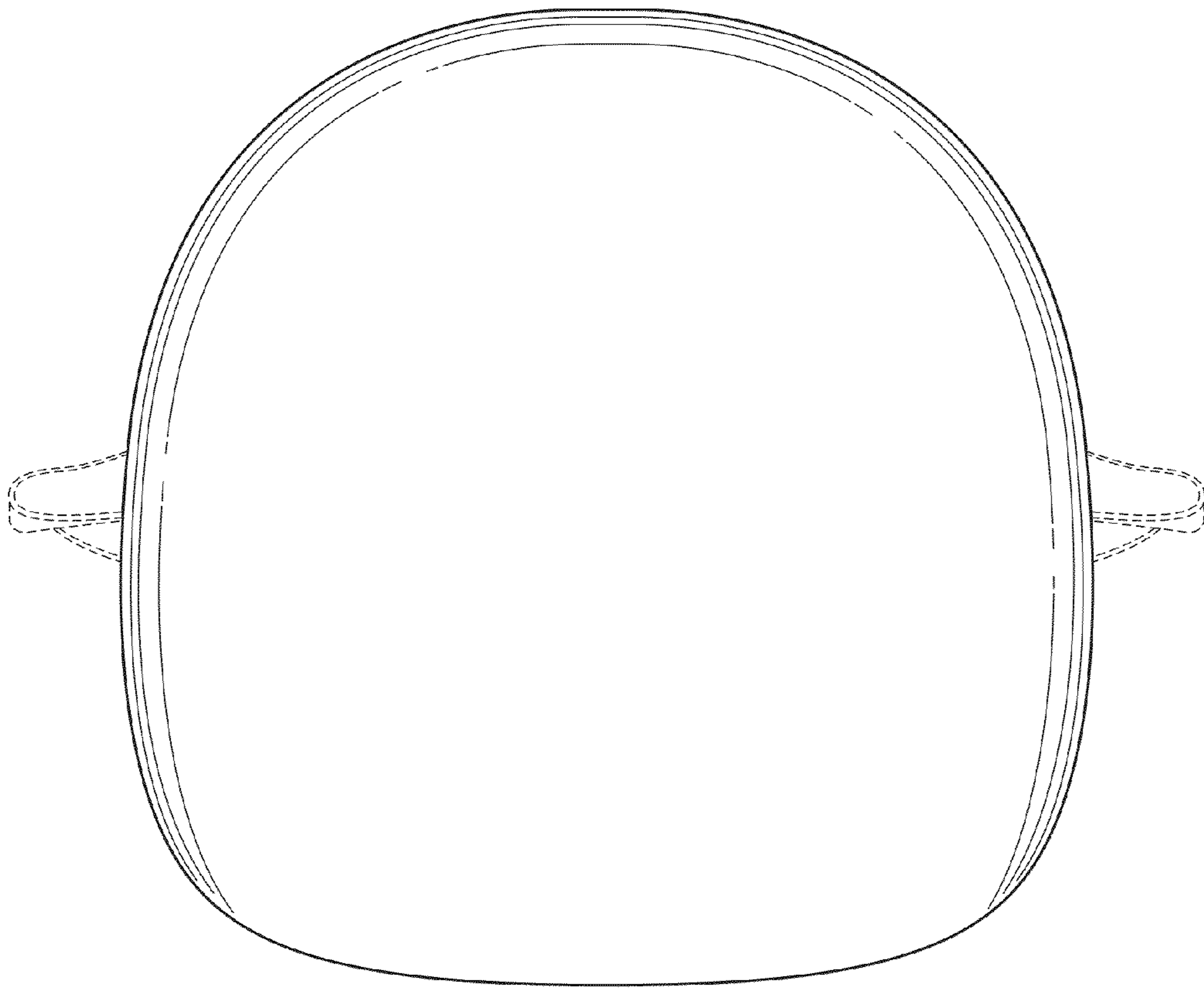

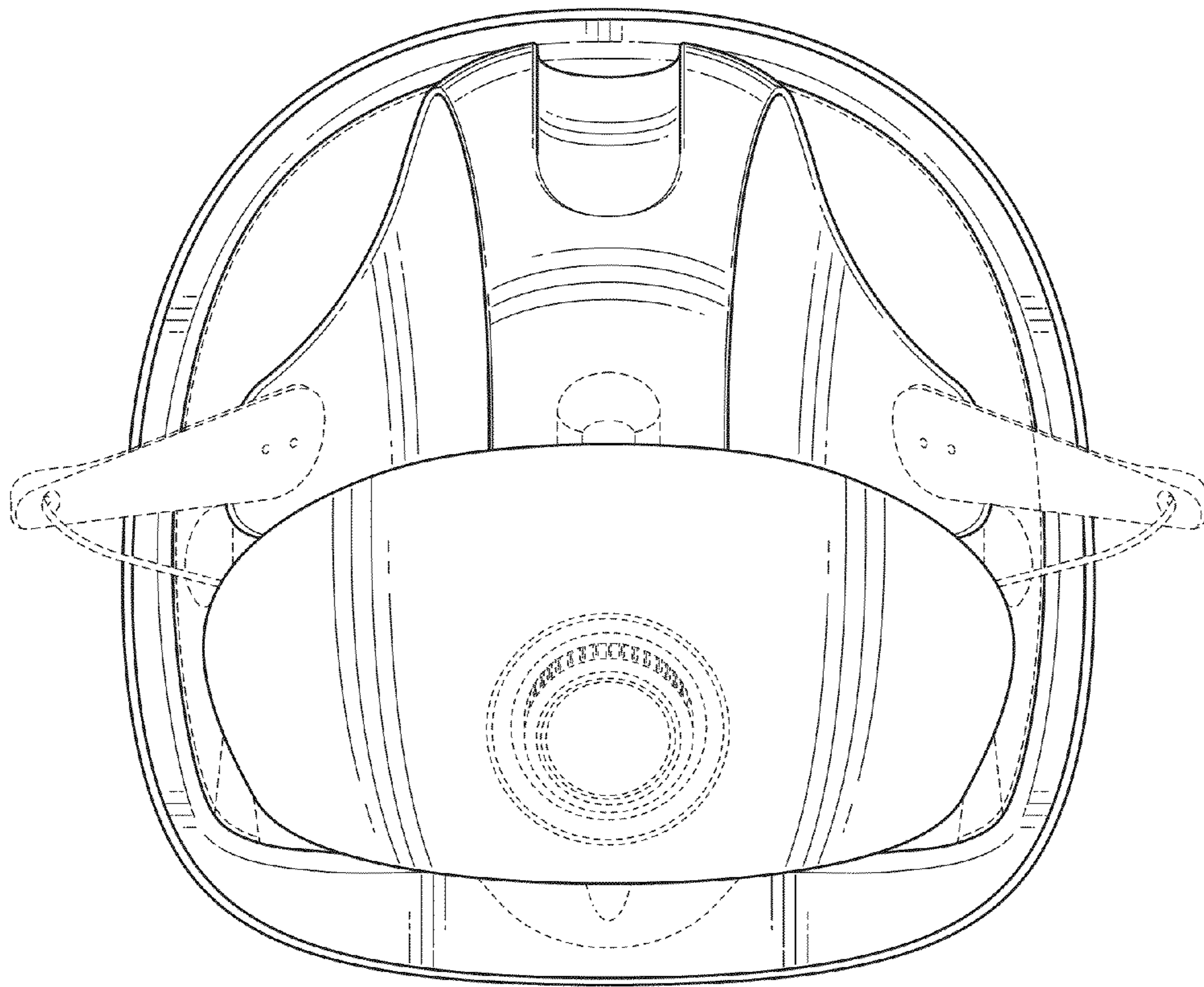
