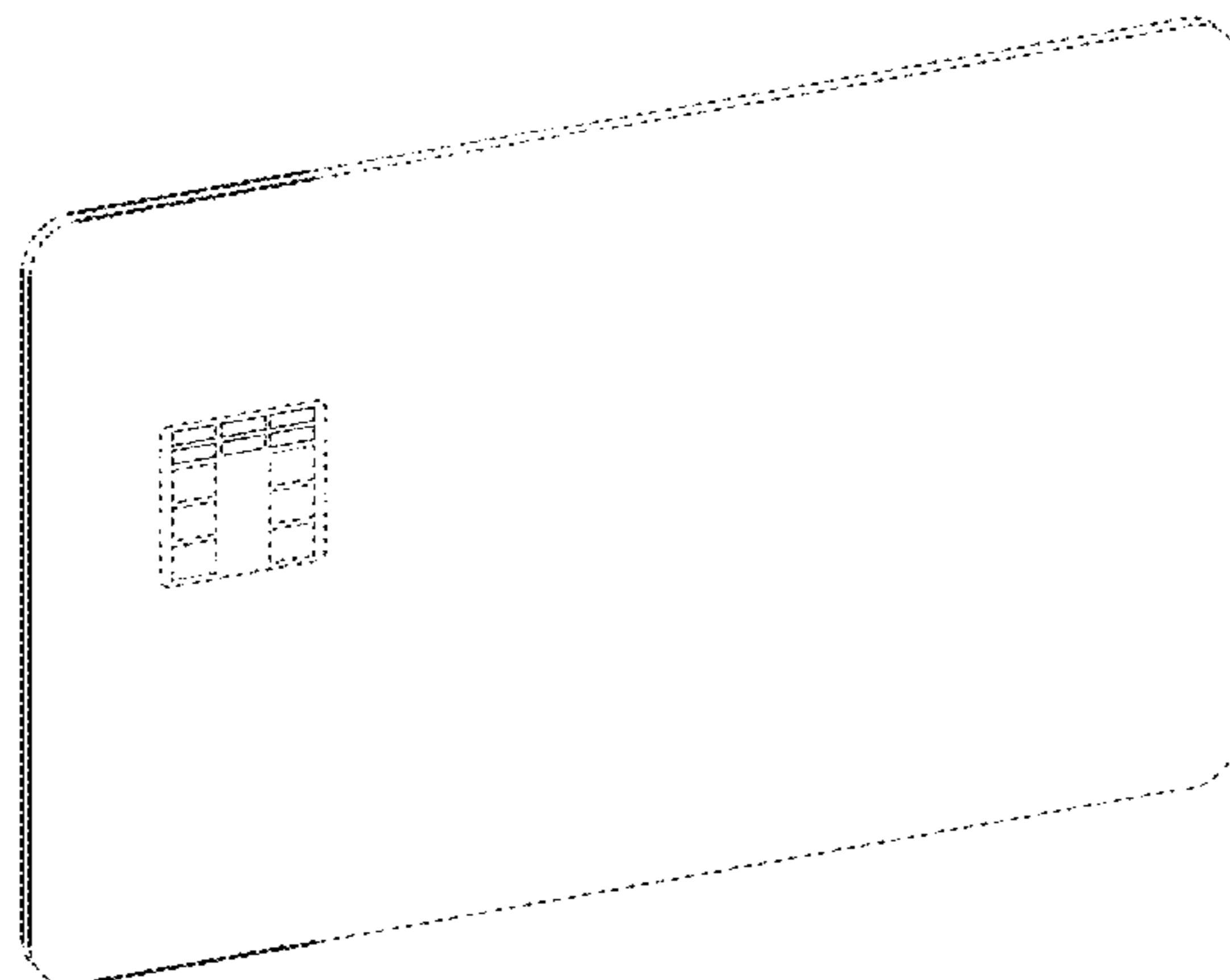
The ornamental design for a smart card interface, as shown and described.

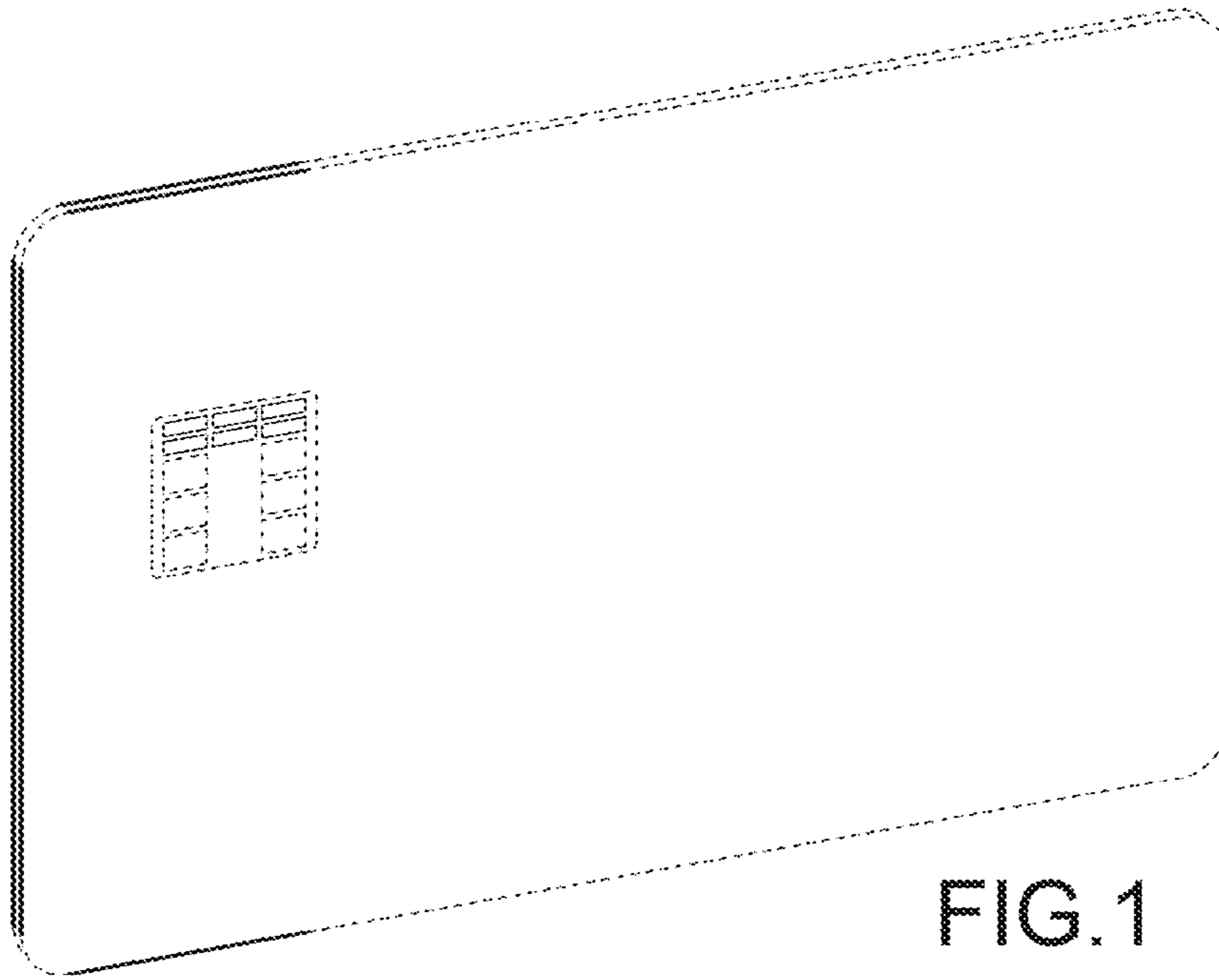

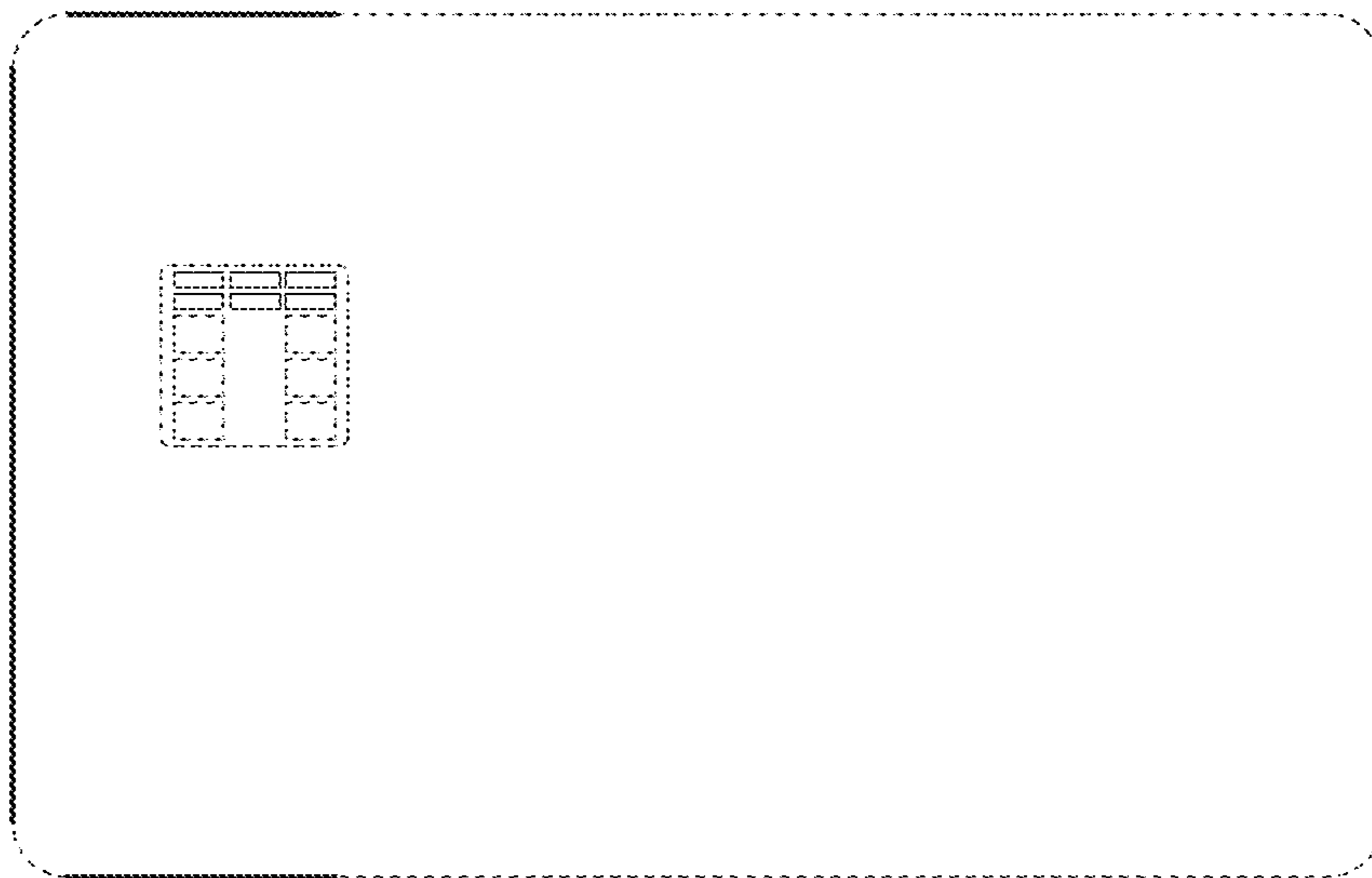

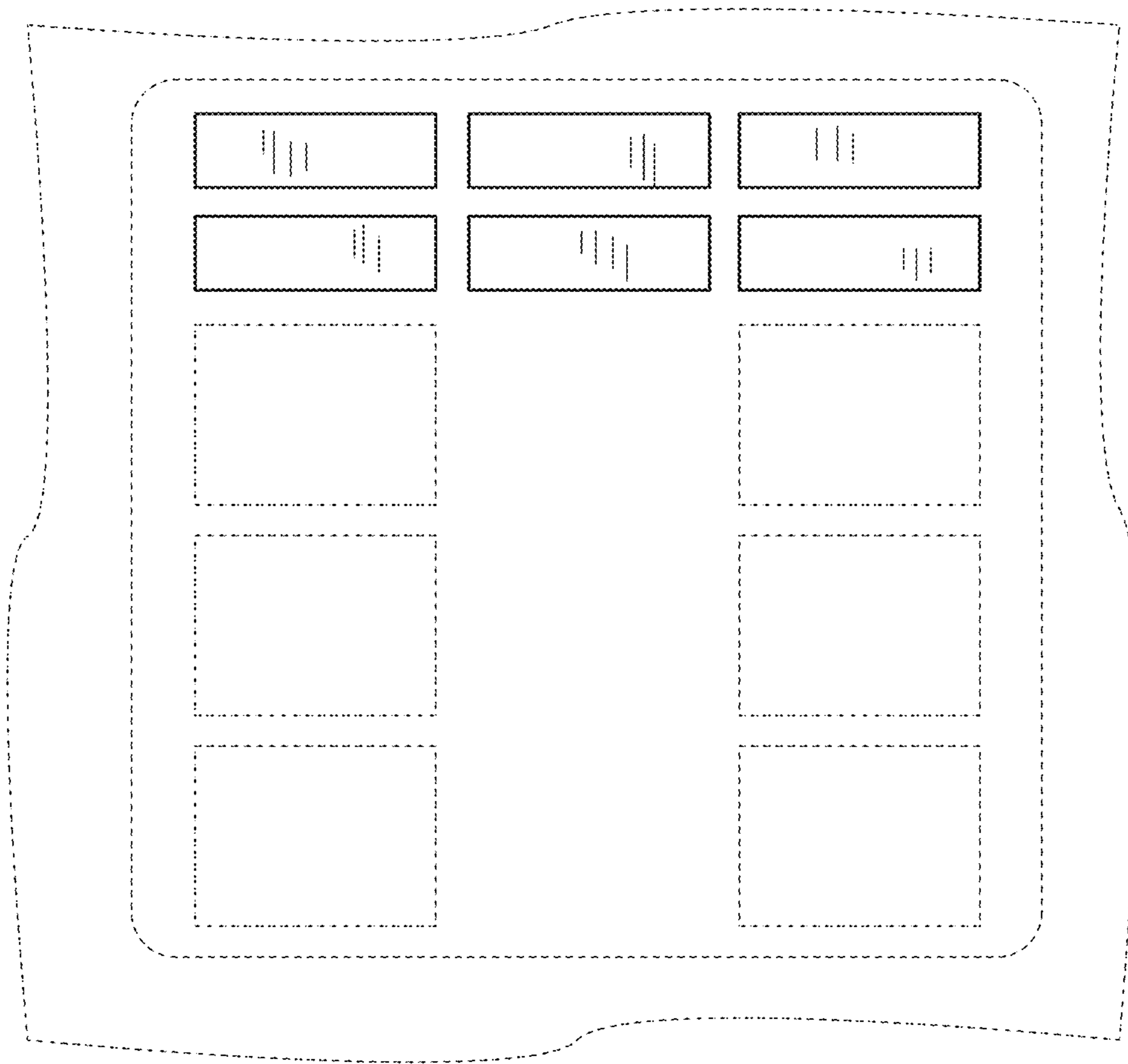
