(57) **CLAIM**

The ornamental design for an portion of a display screen with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first image of a first embodiment of an portion of a display screen with animated graphical user interface showing my new design;

FIG. 2 is a front view of a second image thereof;

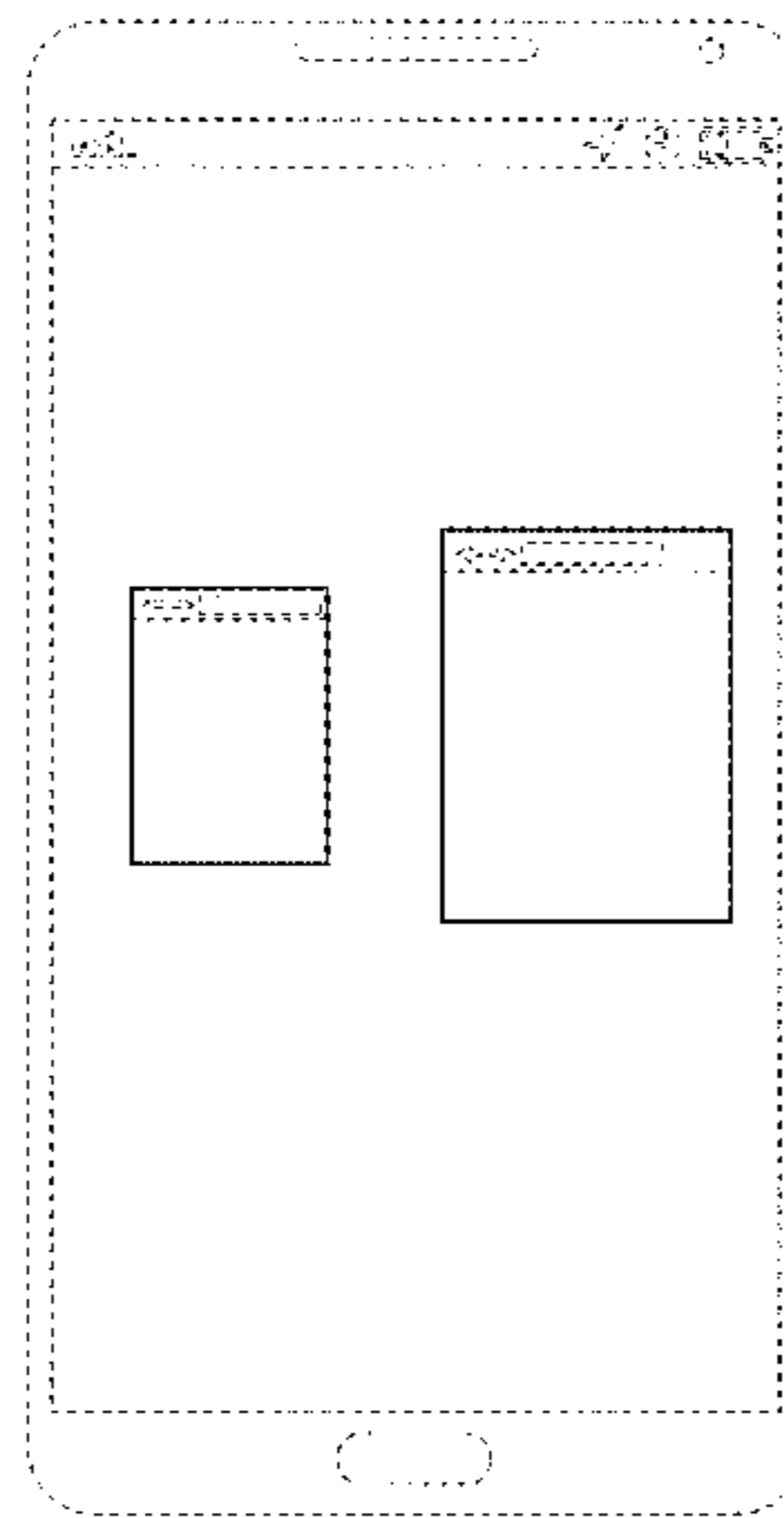
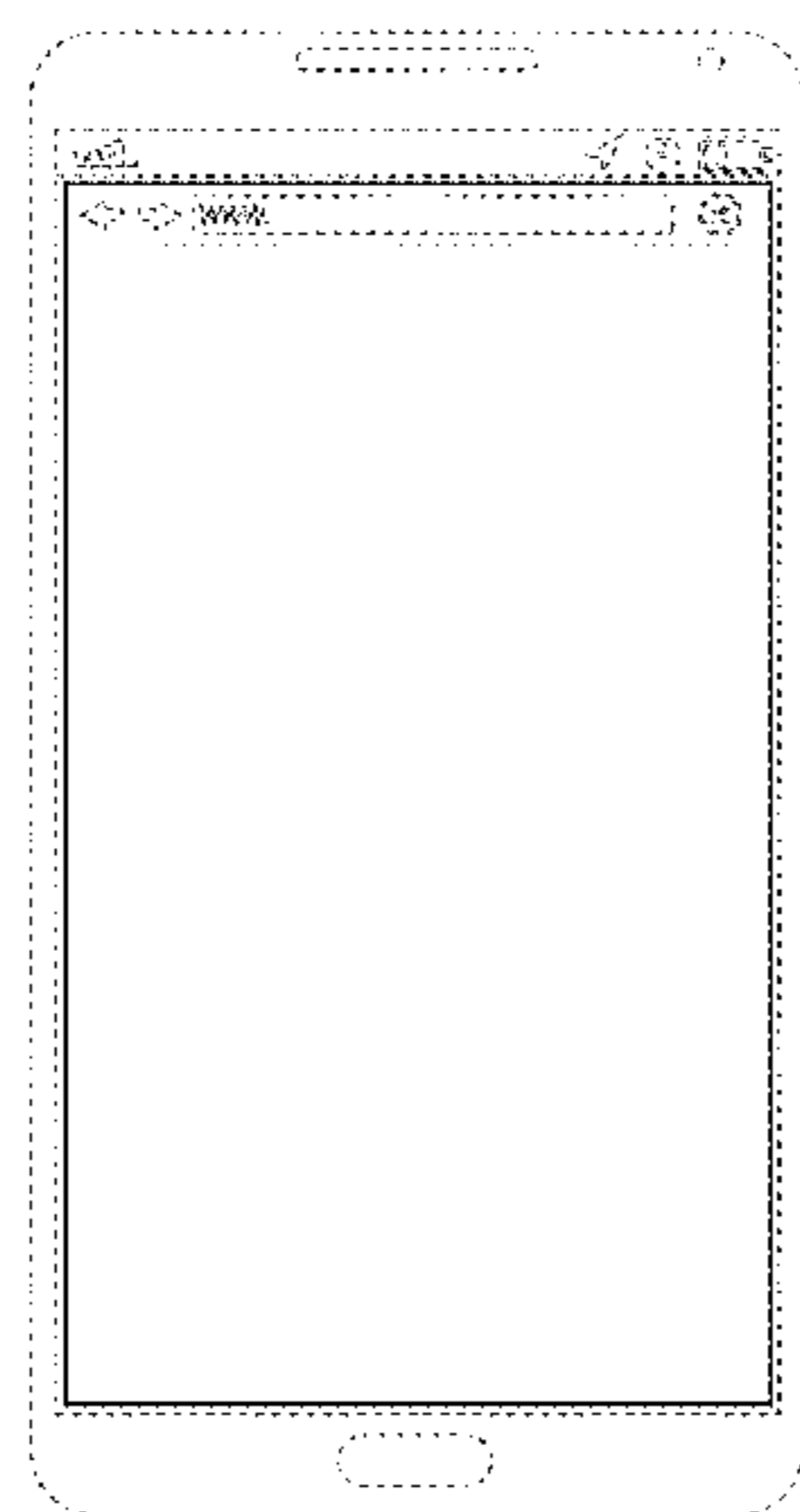
FIG. 3 is a front view of a first image of a second embodiment of an portion of a display screen with animated graphical user interface showing my new design; and,

FIG. 4 is a front view of a second image thereof.

In the second embodiment, the appearance of the transitional image sequentially transitions between the images shown in FIGS. 3 through 4. The process or period in which one image transitions to another image forms no part of the claimed design.

The broken line showing of text and portions of the graphical user interface in FIGS. 1 through 4 represents environmental subject matter and forms no part of the claimed design.

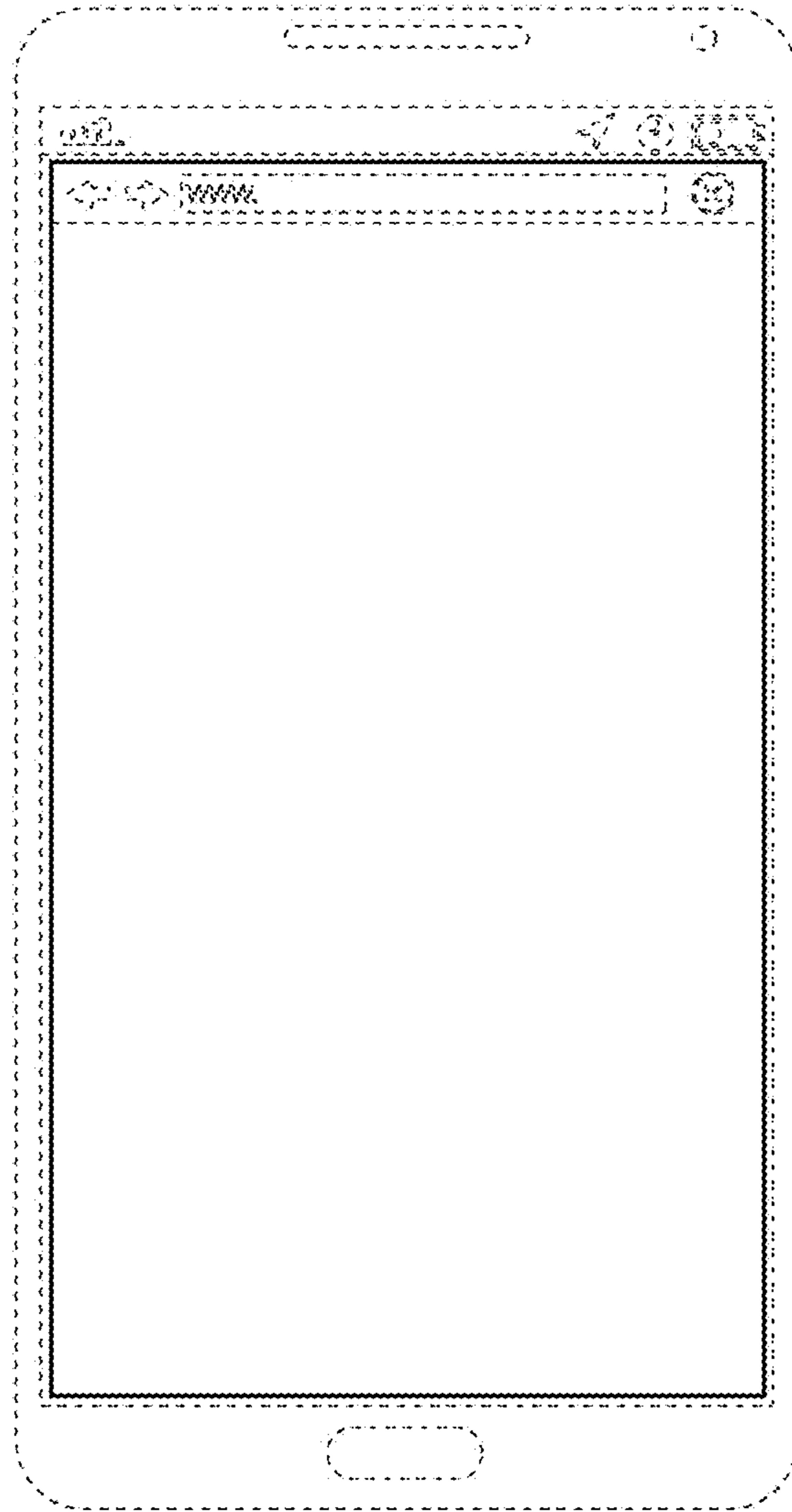

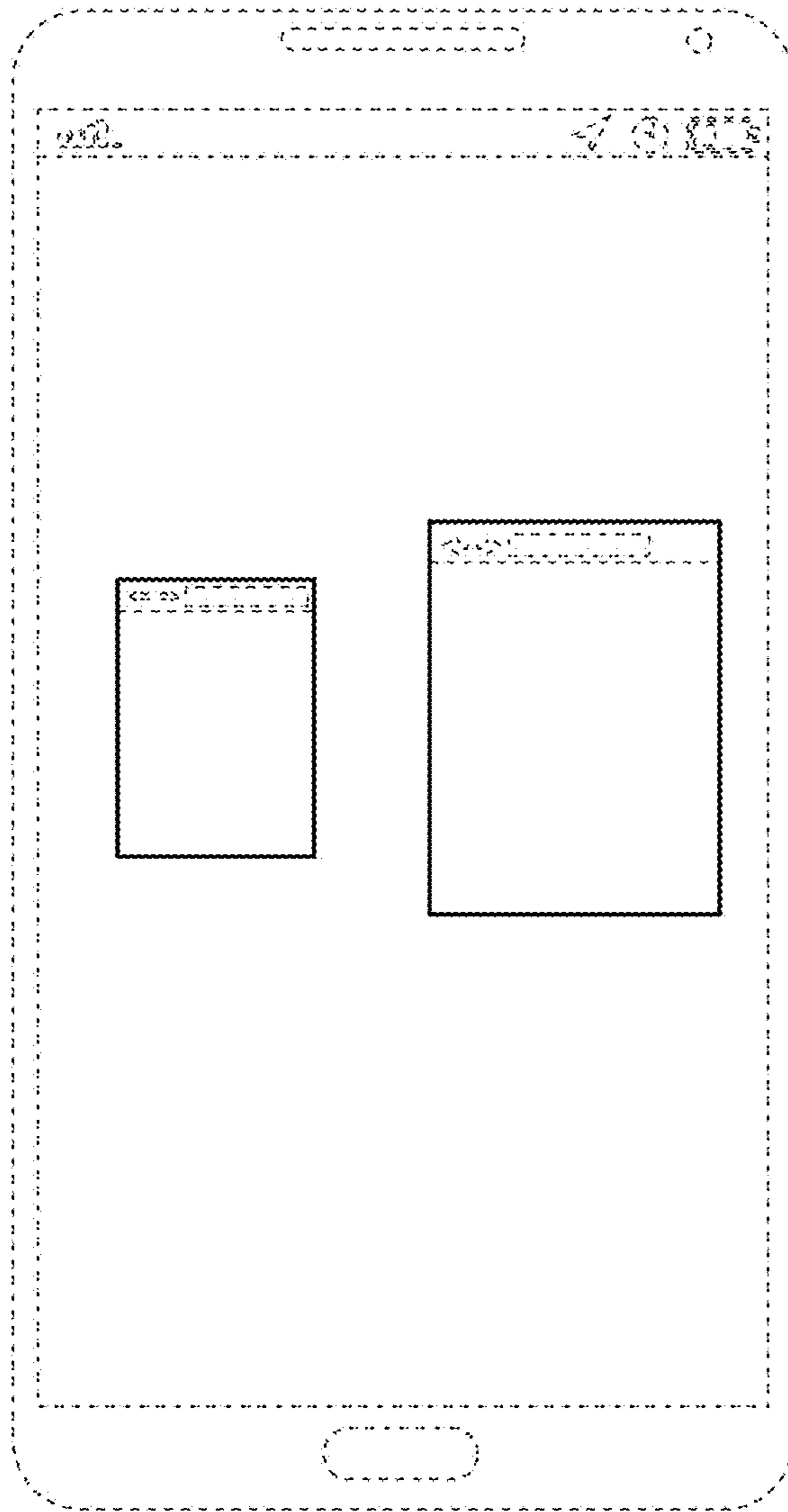

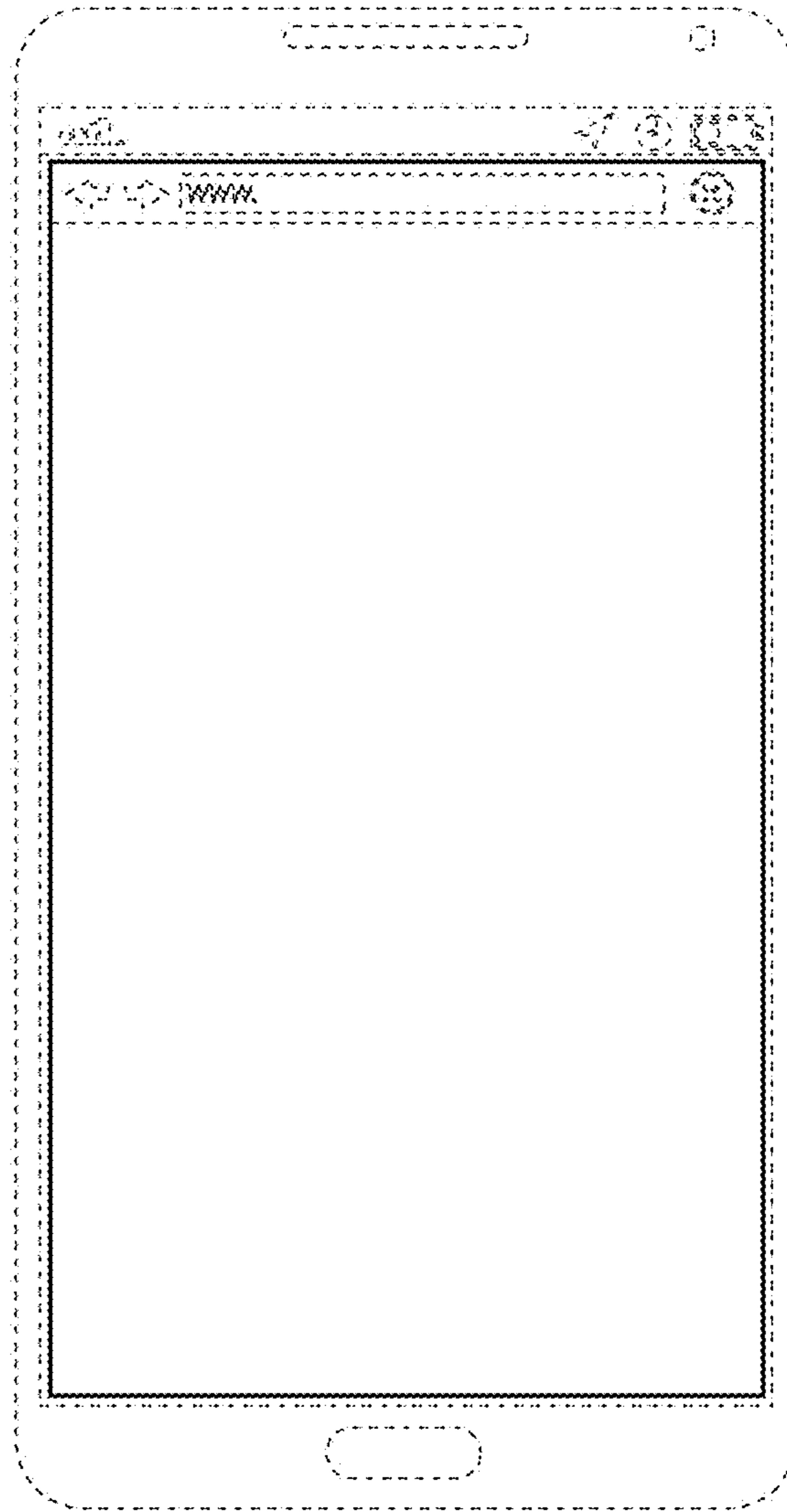

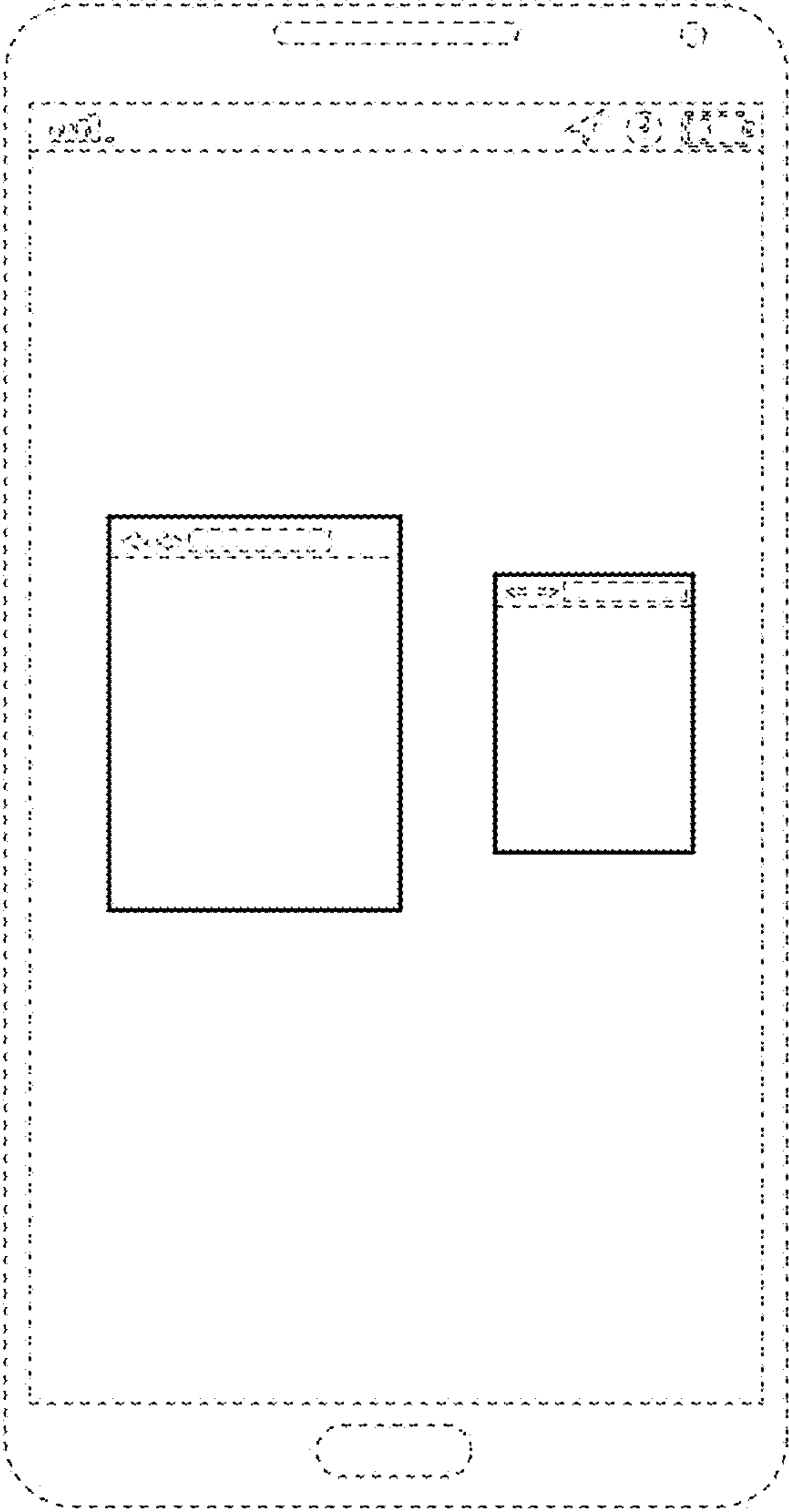
