The ornamental design for a display screen or a portion thereof with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 9 is a ninth image thereof;

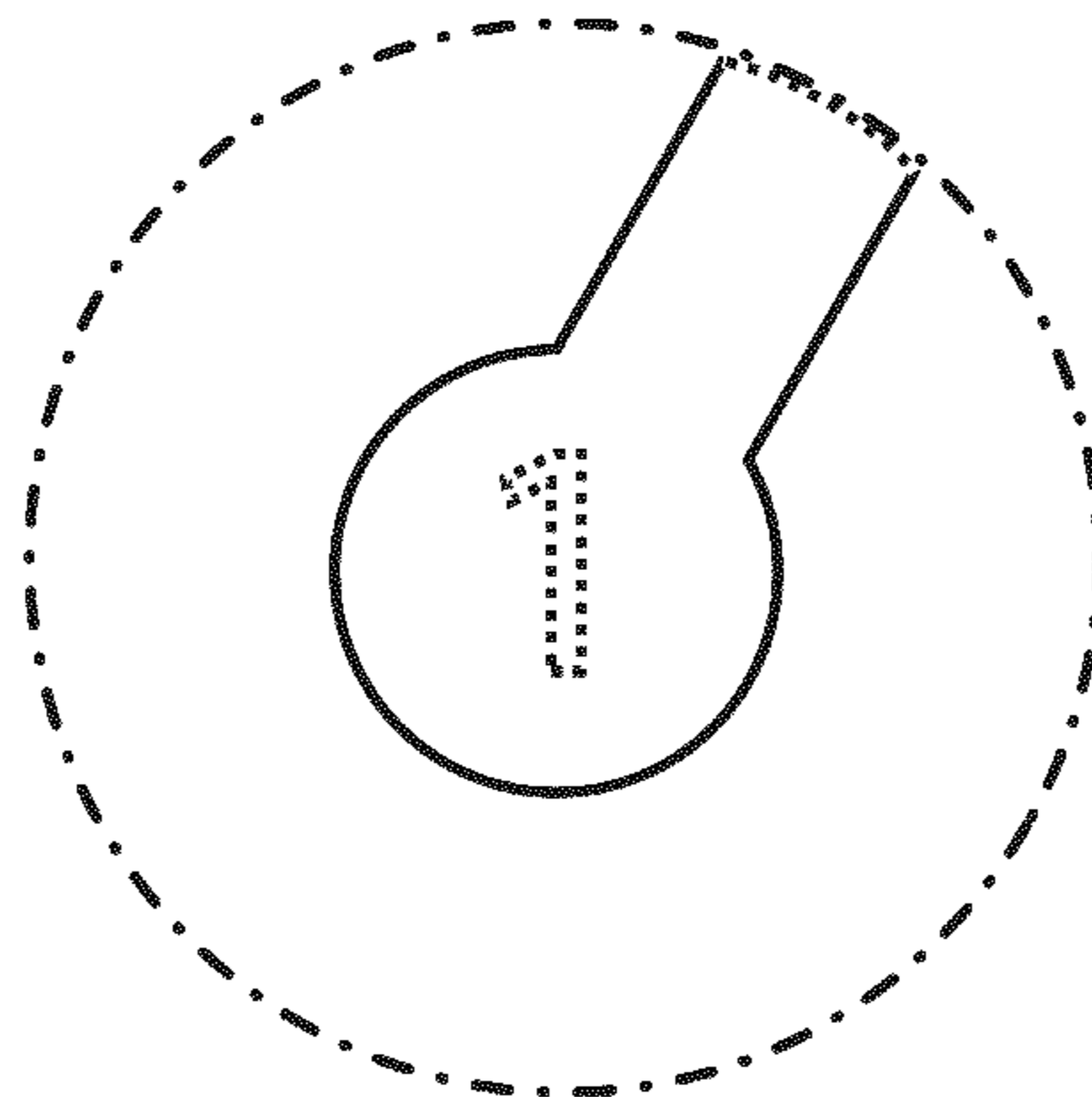
FIG. 10 is a tenth image thereof;

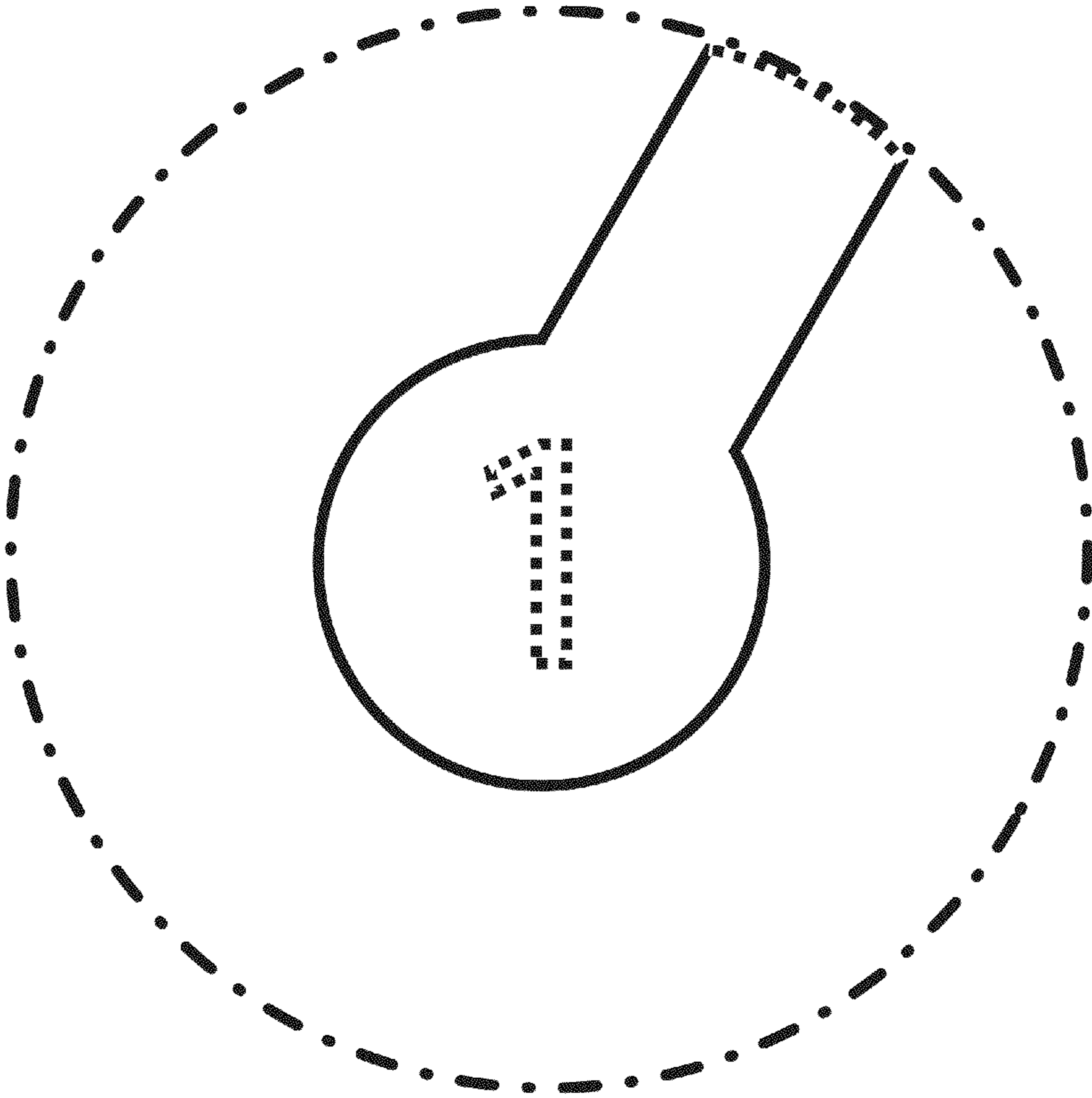

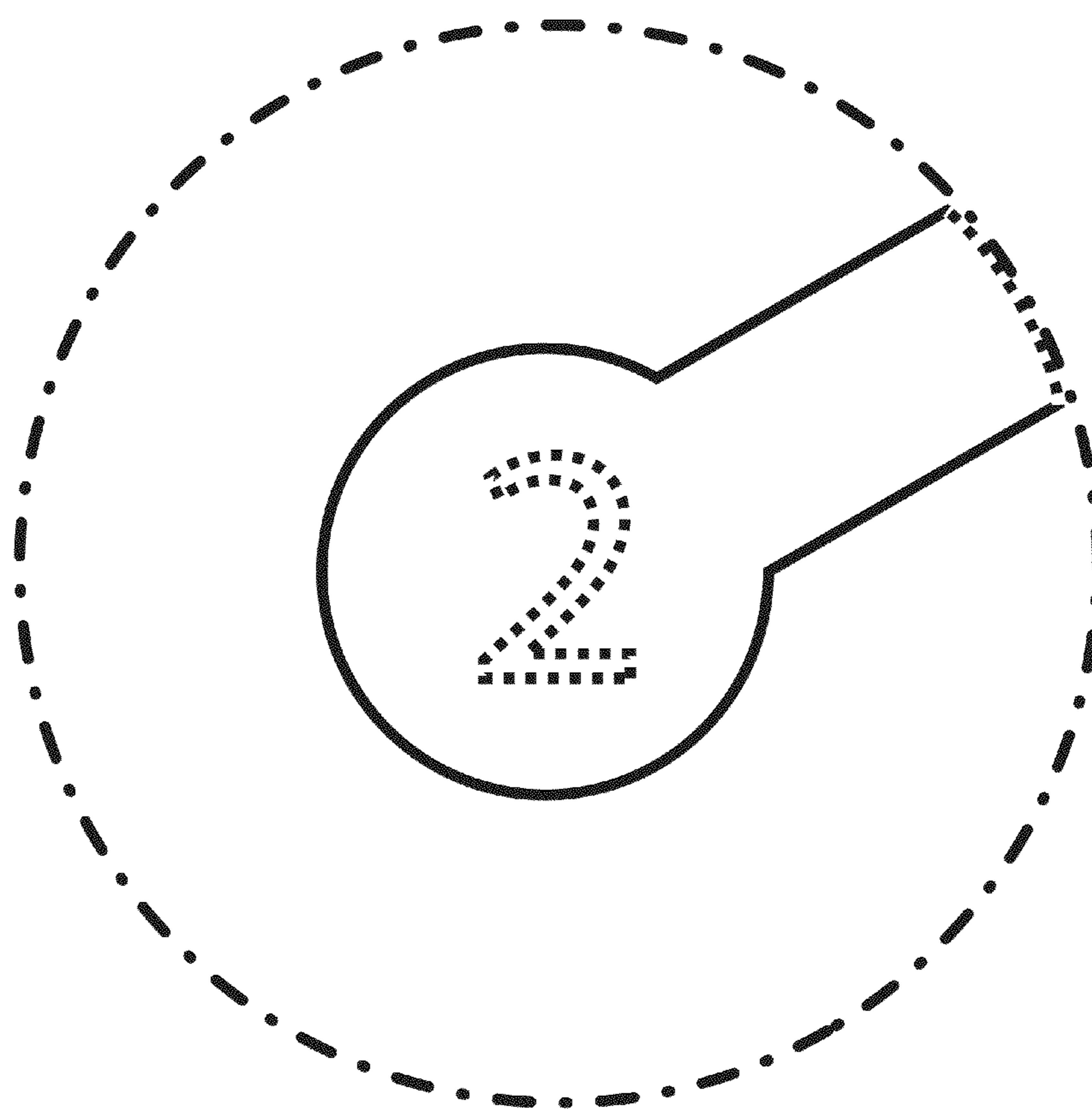

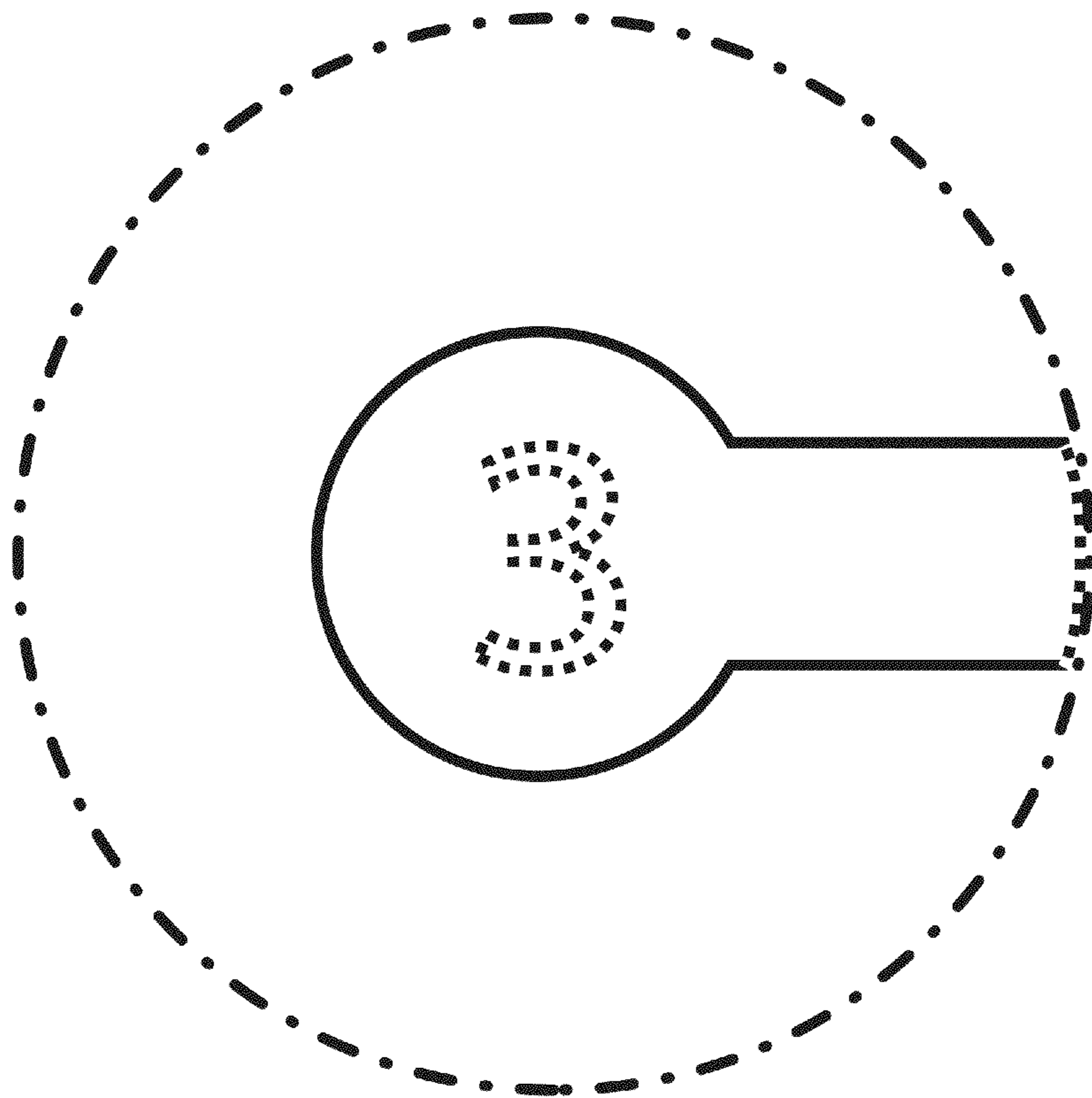

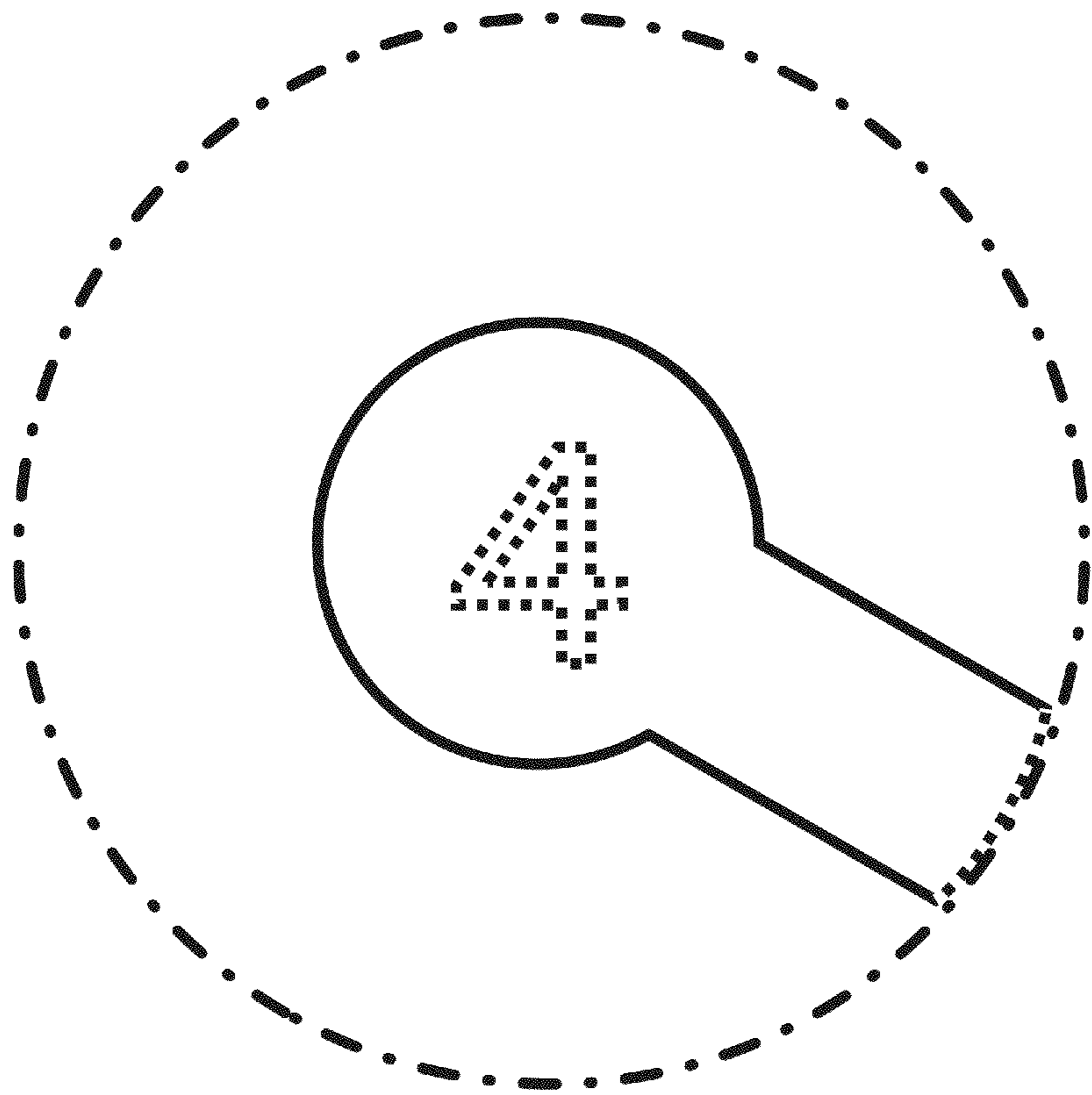

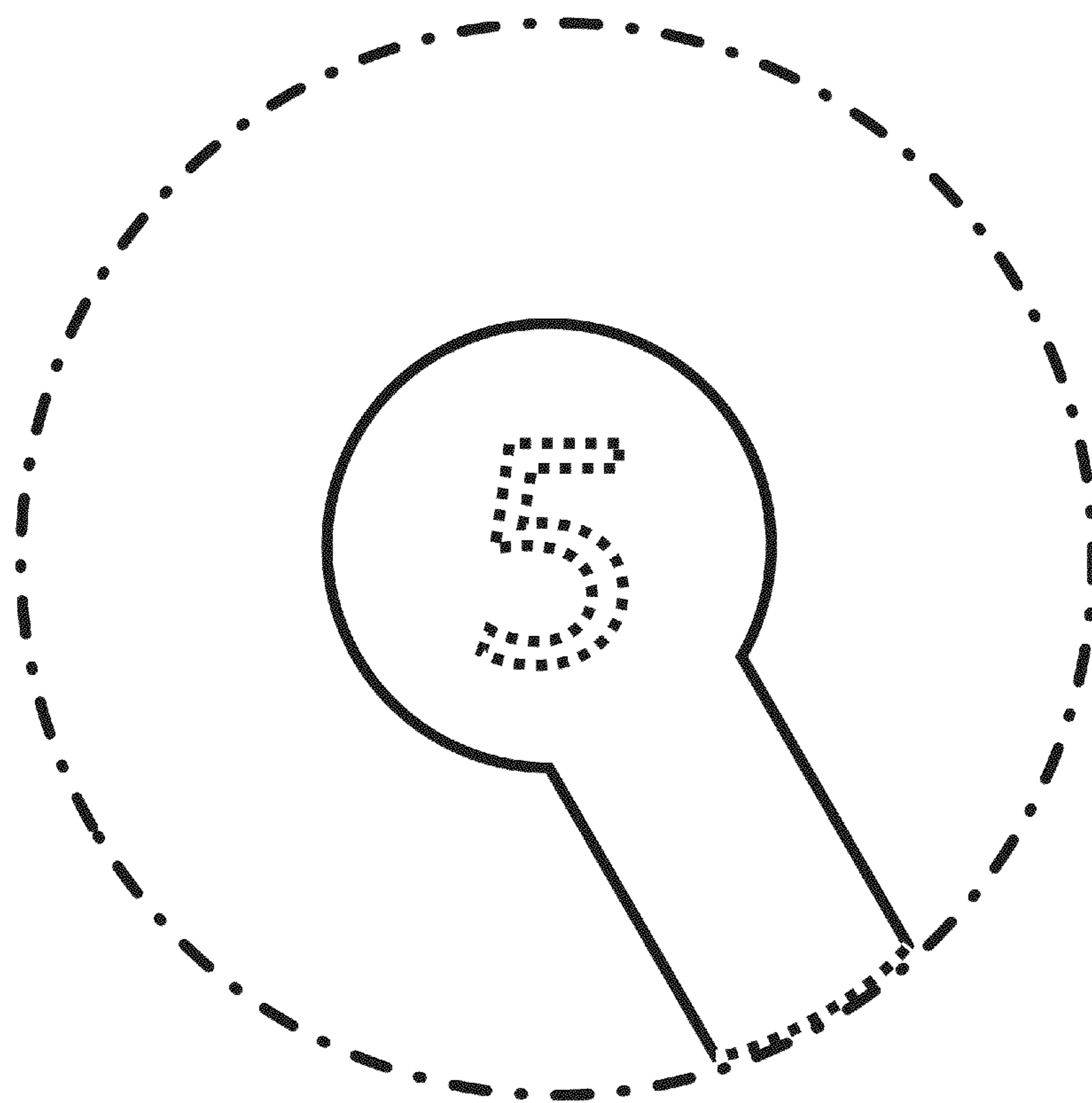

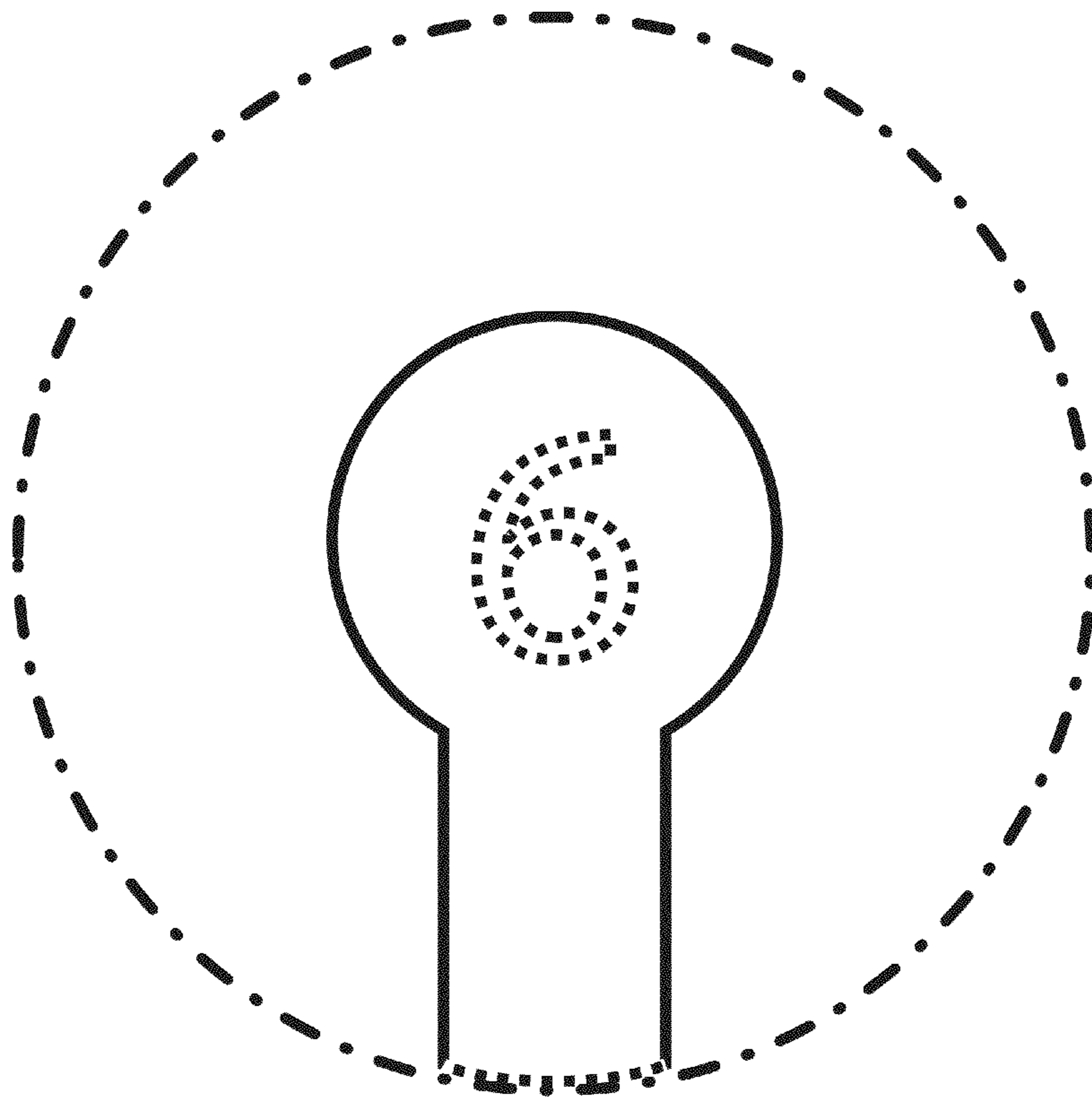

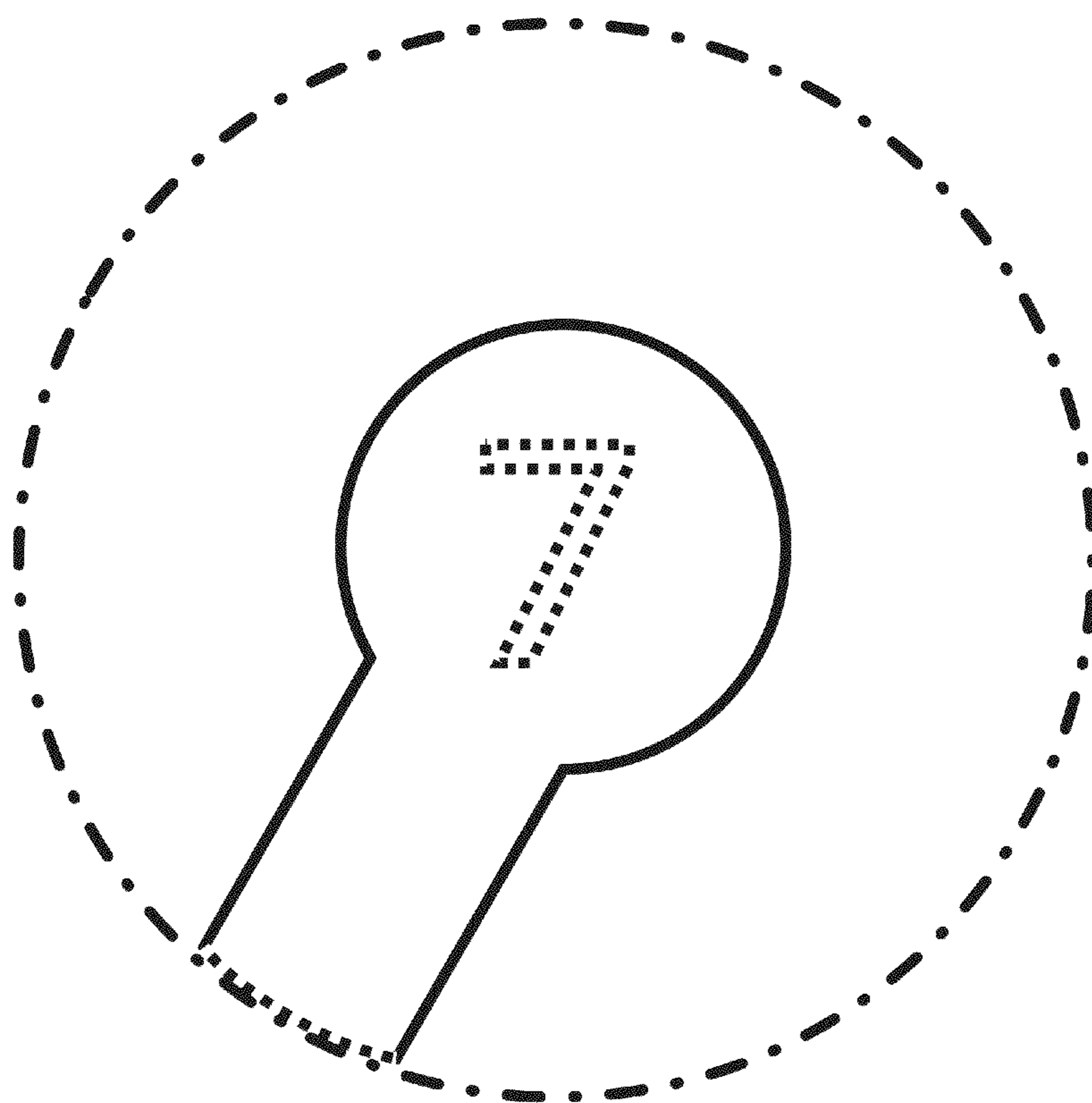

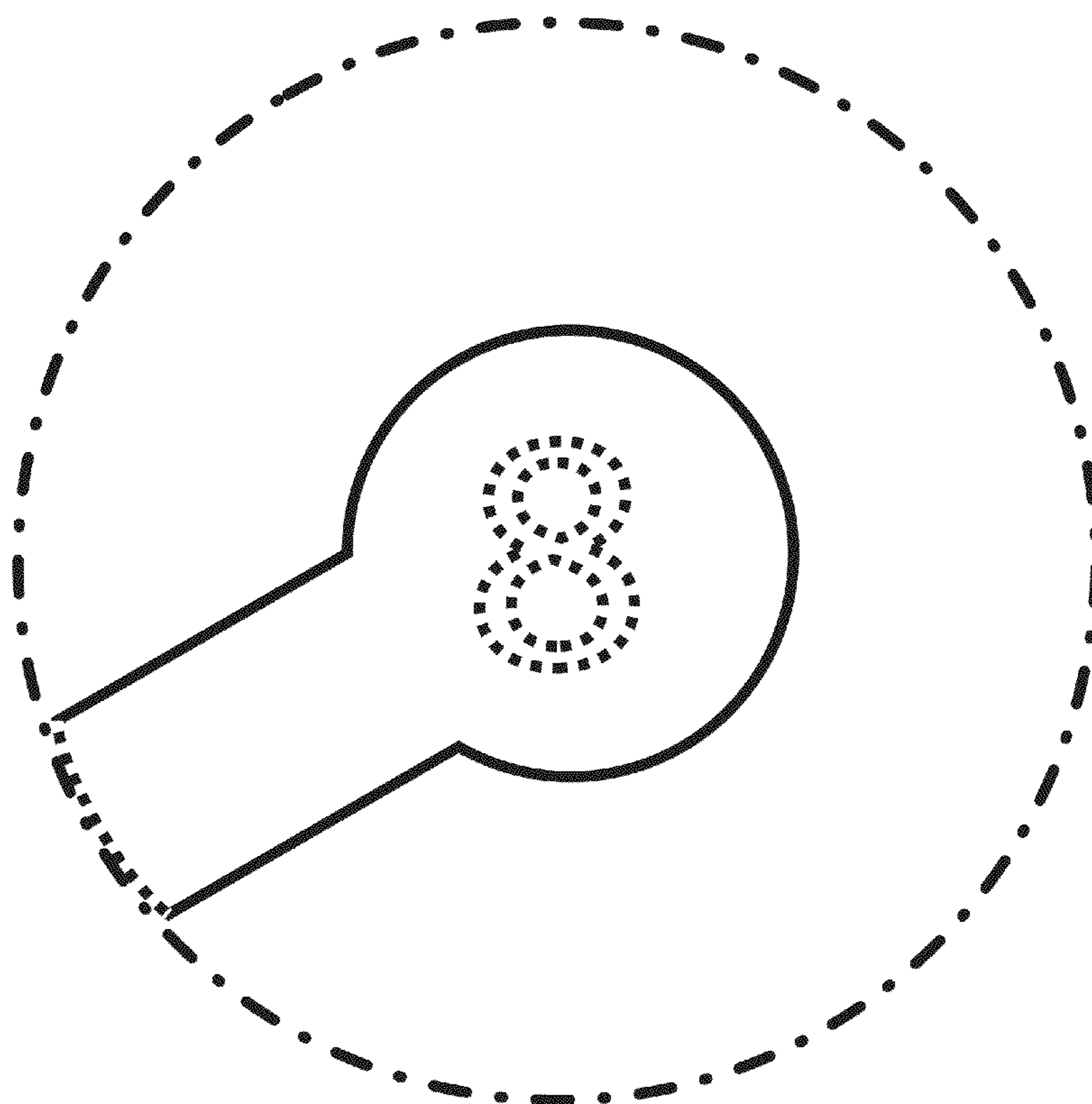

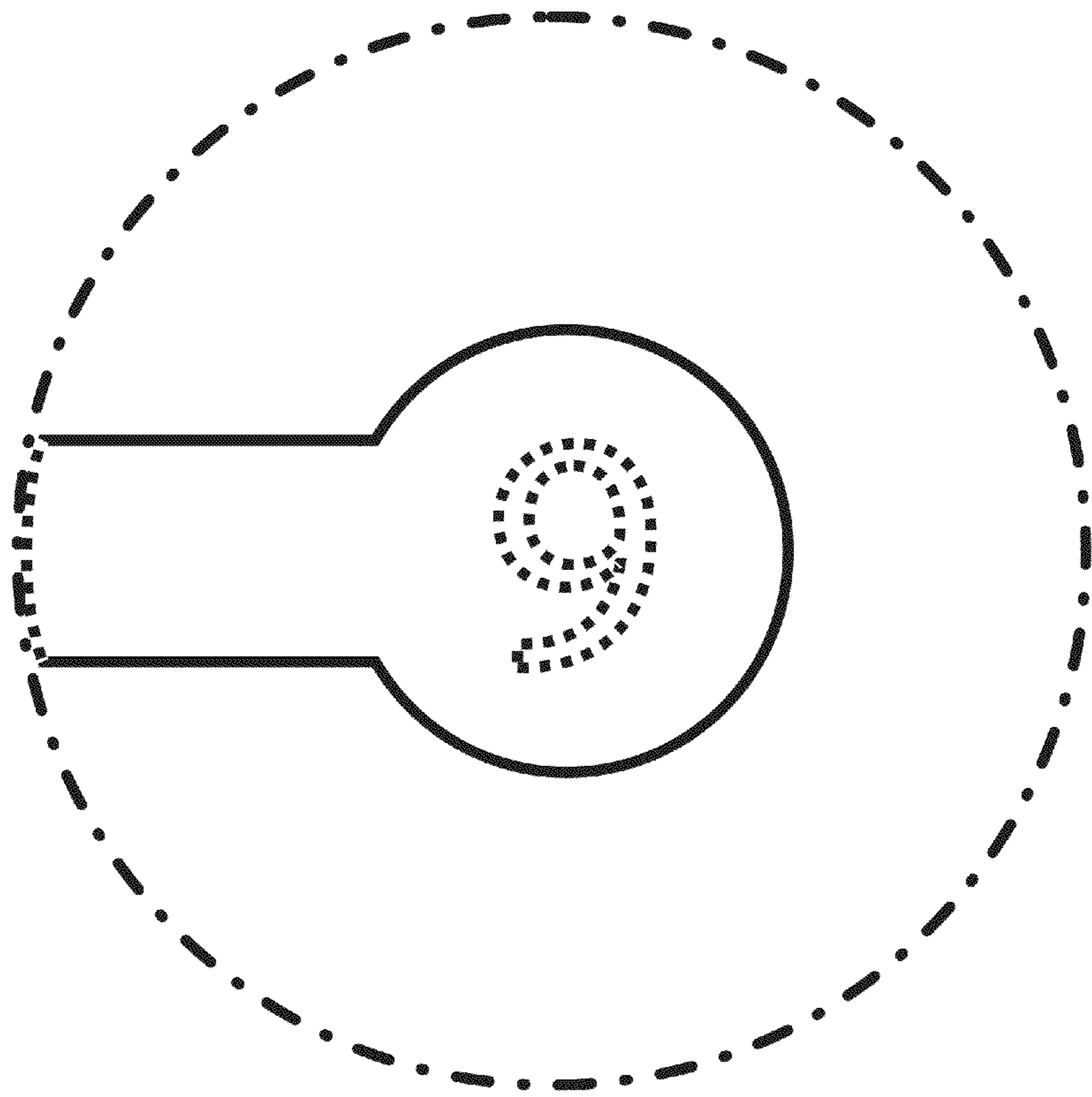

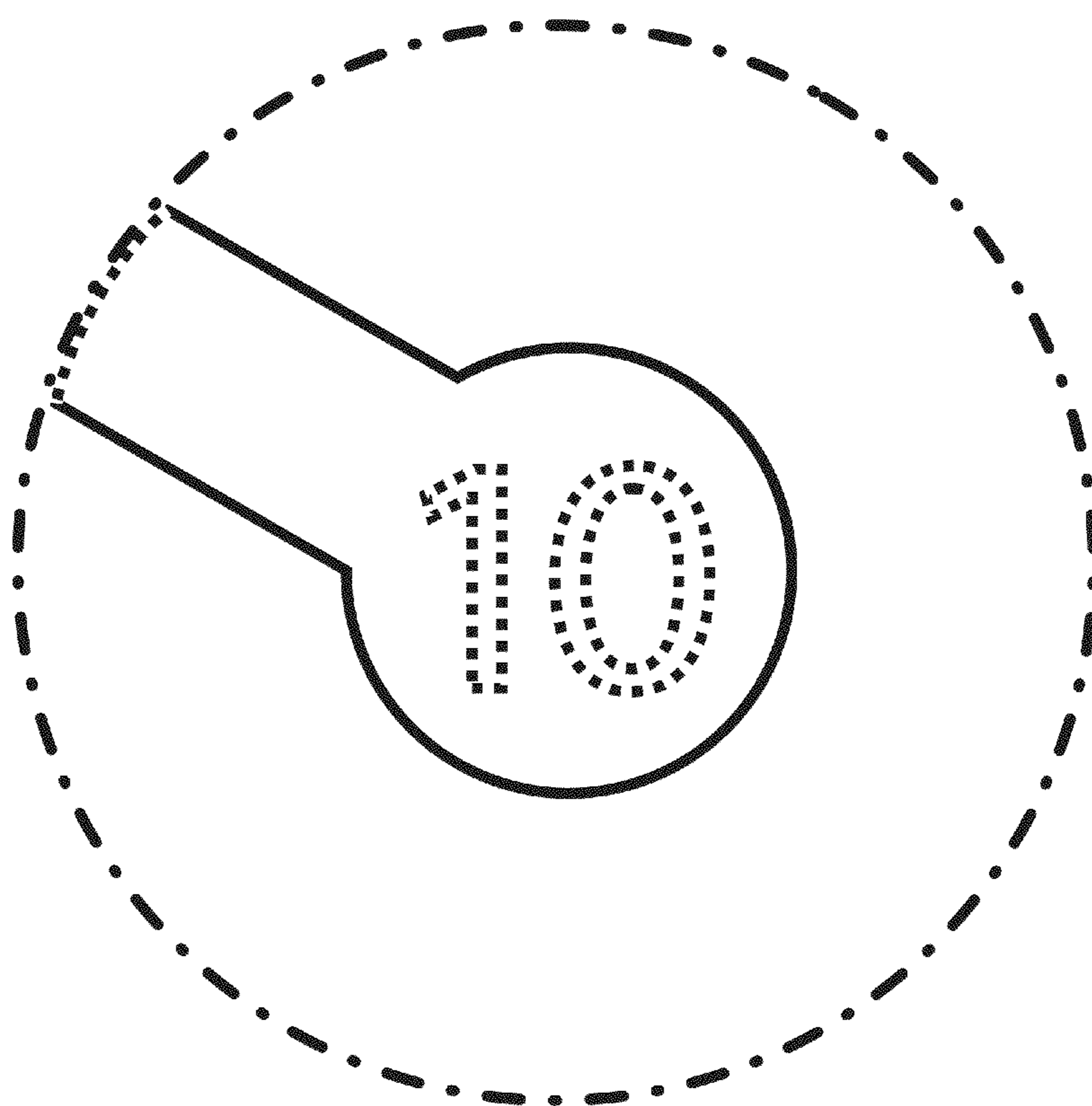

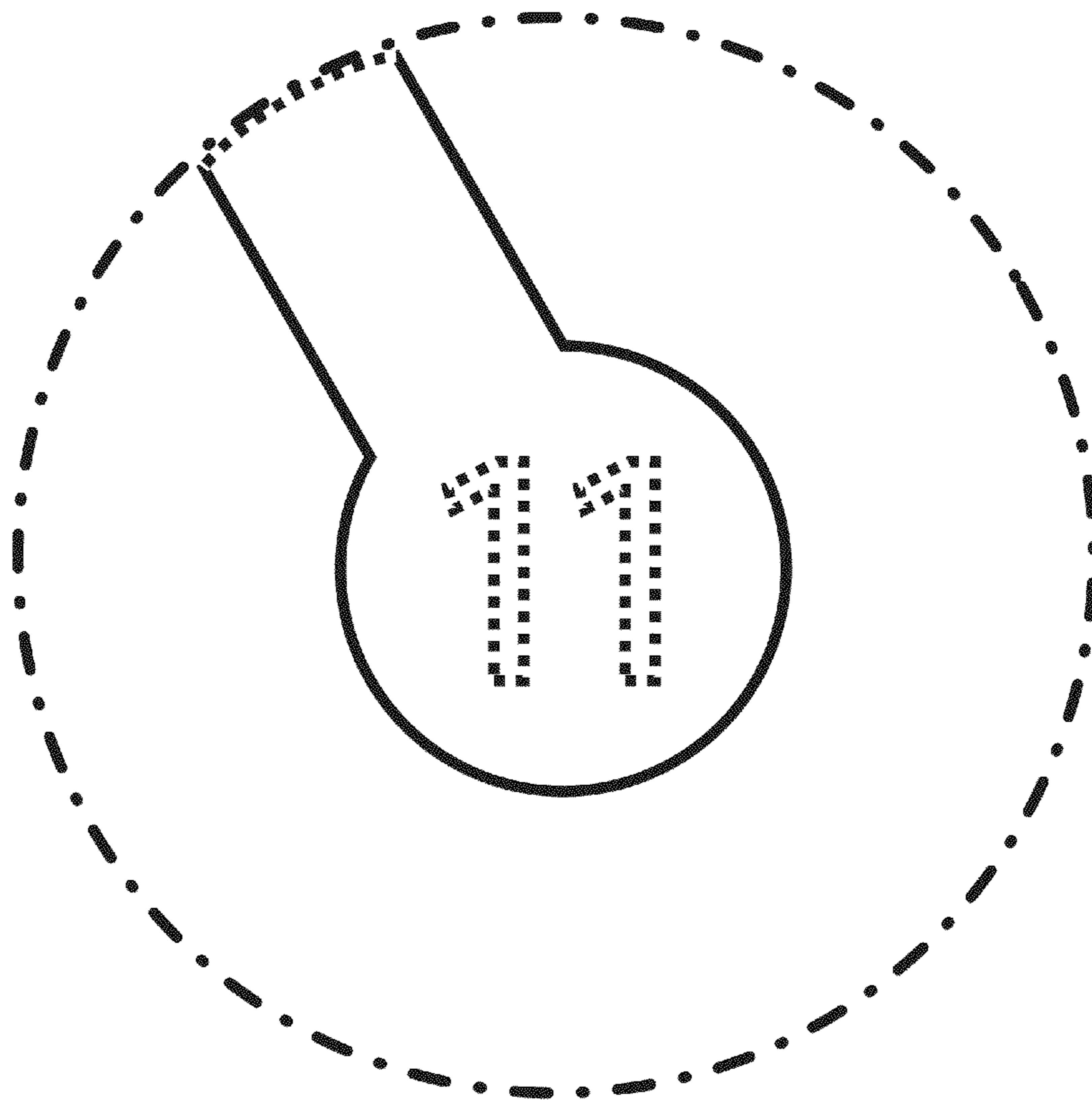

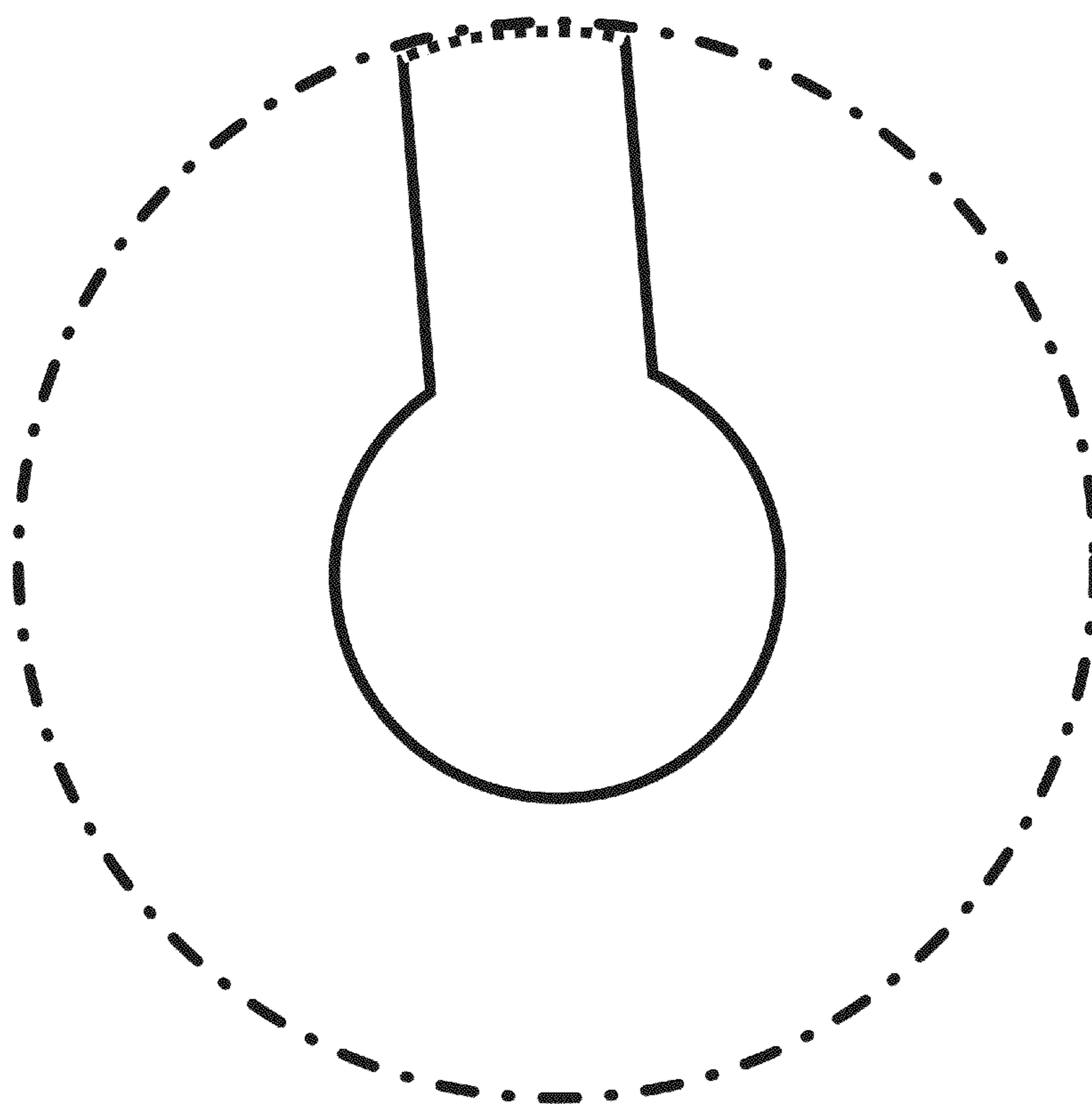
