The ornamental design for a display screen with a graphical user interface, as shown and described.

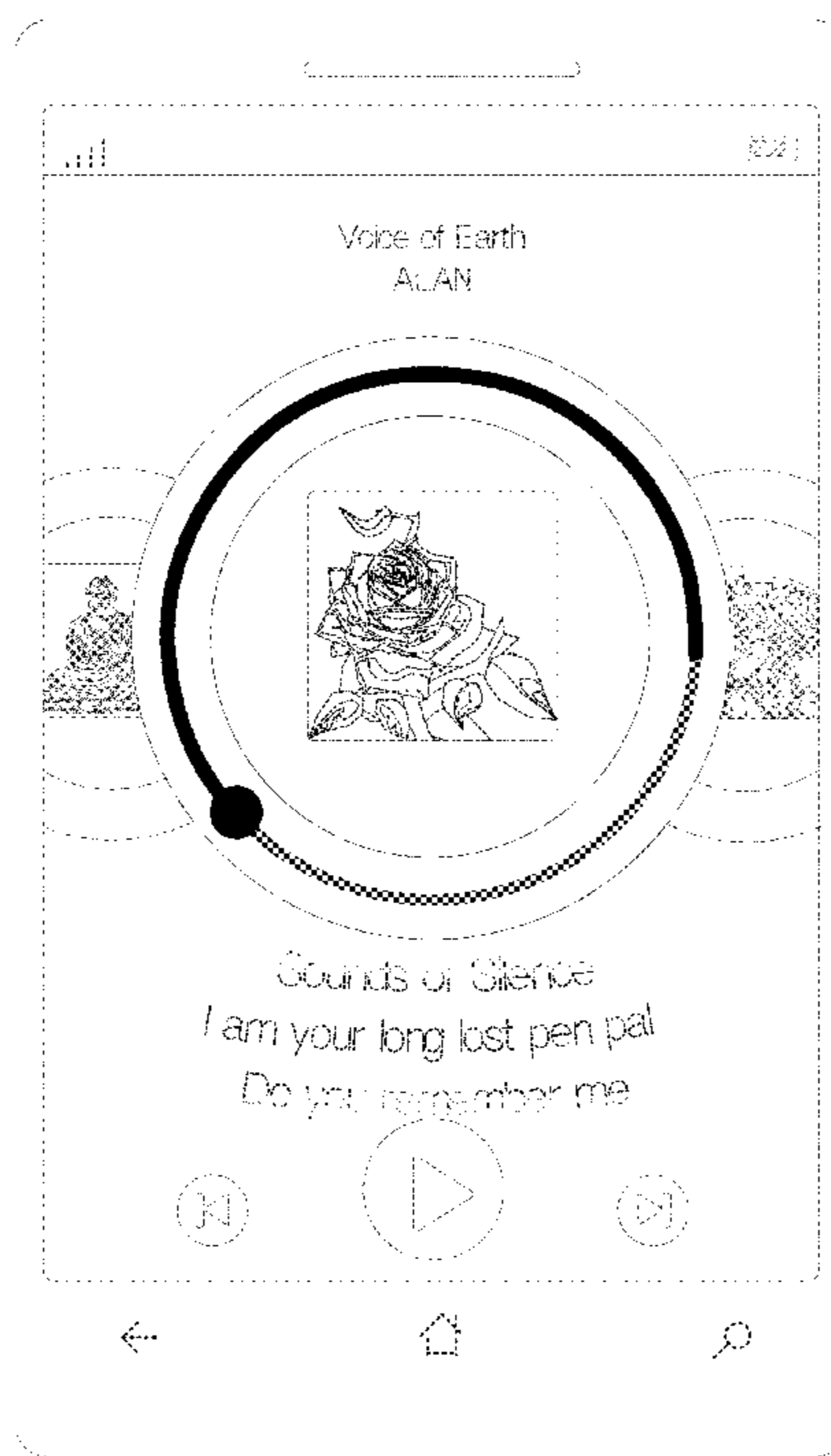
**DESCRIPTION**

FIG. 1 is a first image in a sequence for a display screen with graphical user interface of music player;  
FIG. 2 is a second image thereof;  
FIG. 3 is a third image thereof;  
FIG. 4 is a fourth image thereof; and,  
FIG. 5 is a fifth image thereof.

The ornamental design which is claimed is shown in solid lines in the drawings. 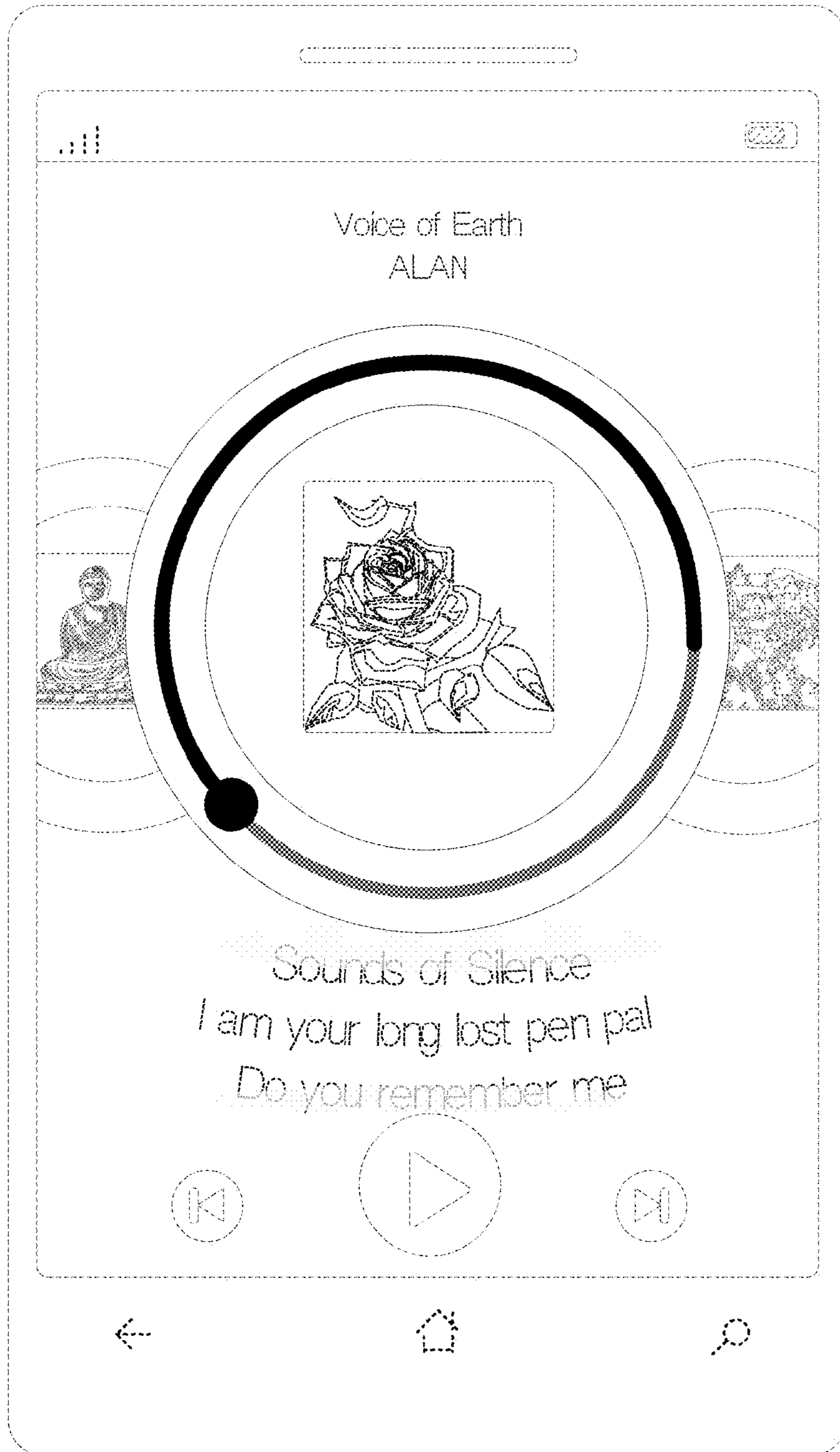

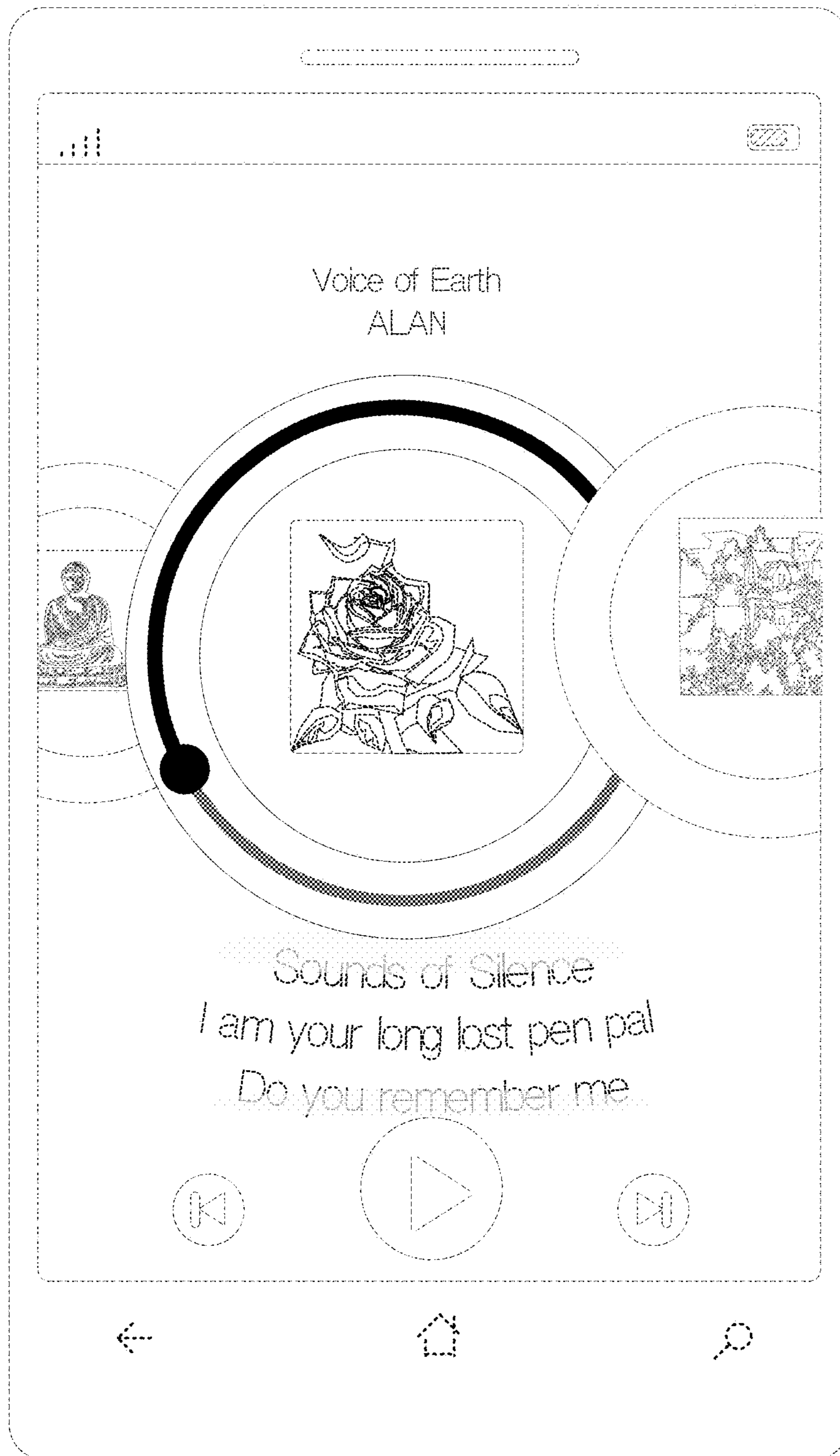

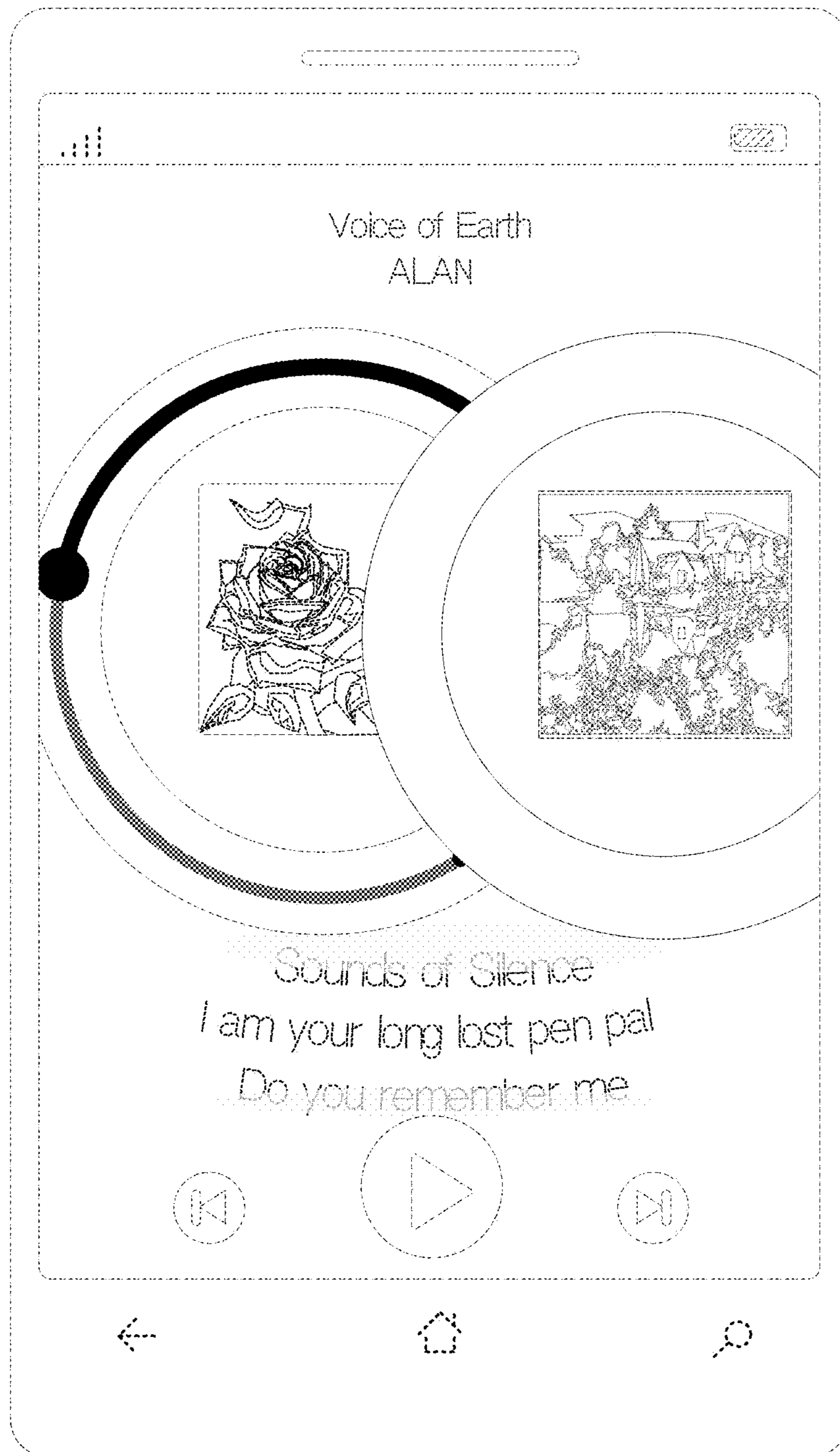

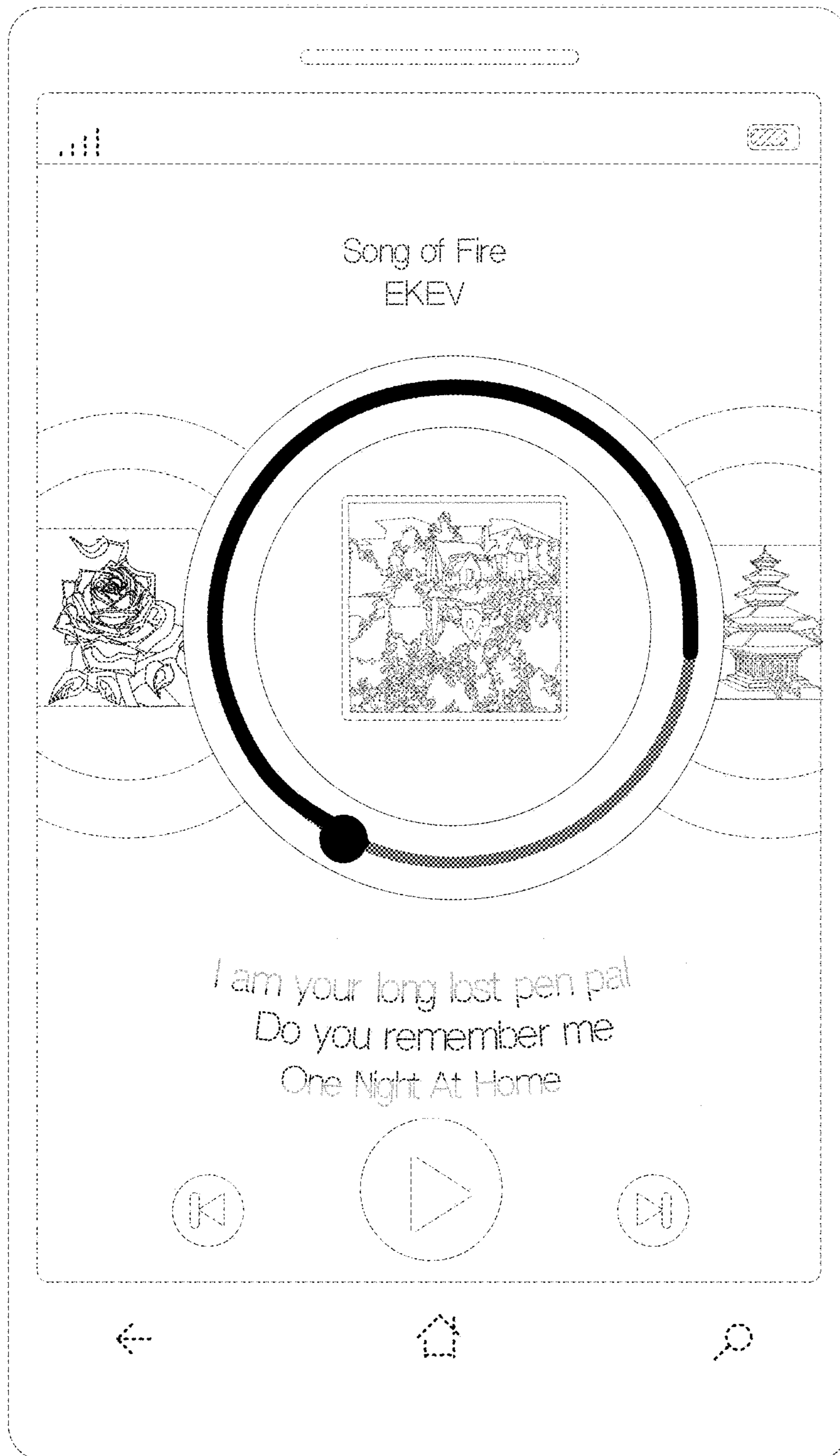

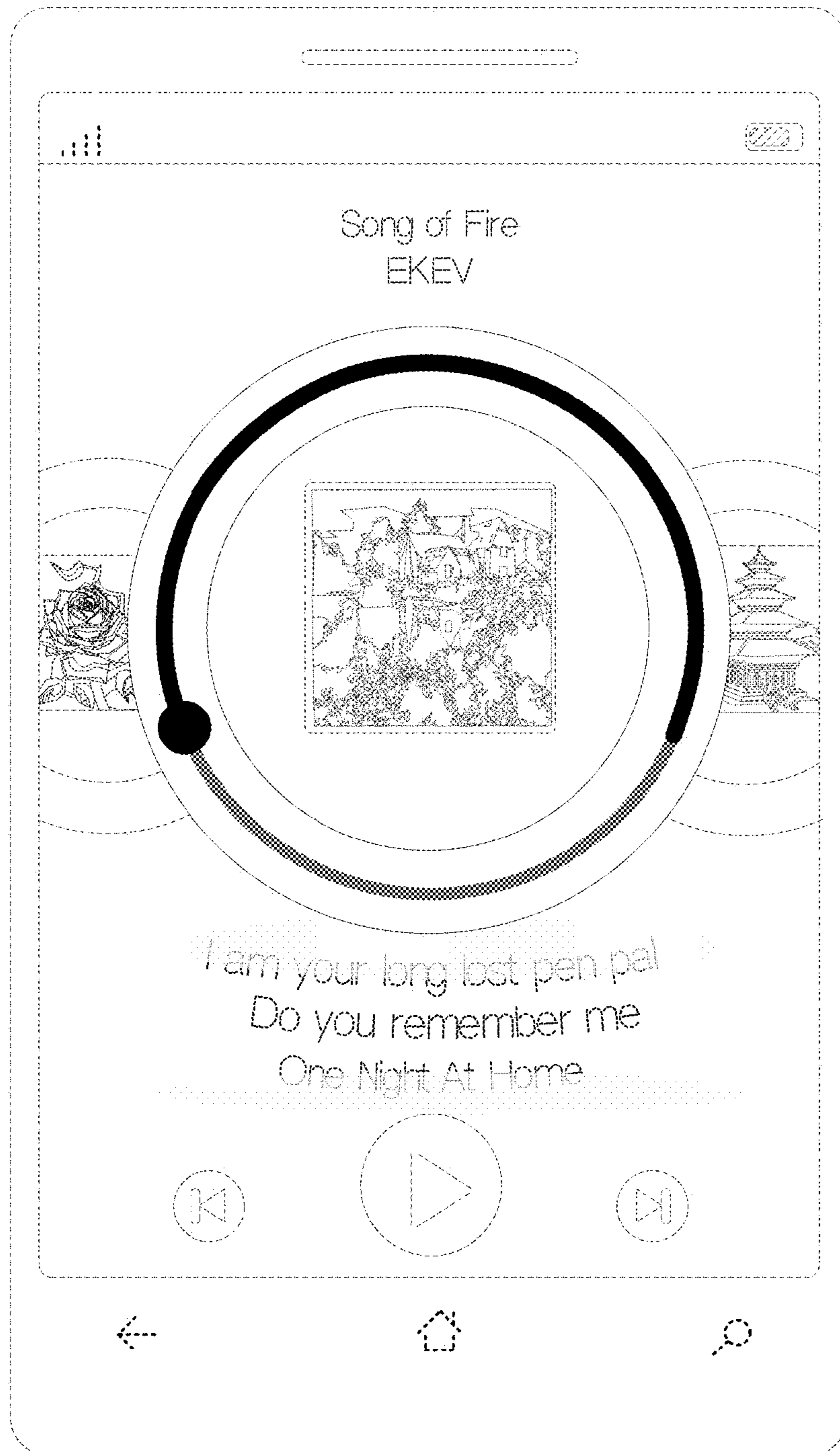
