CLAIM

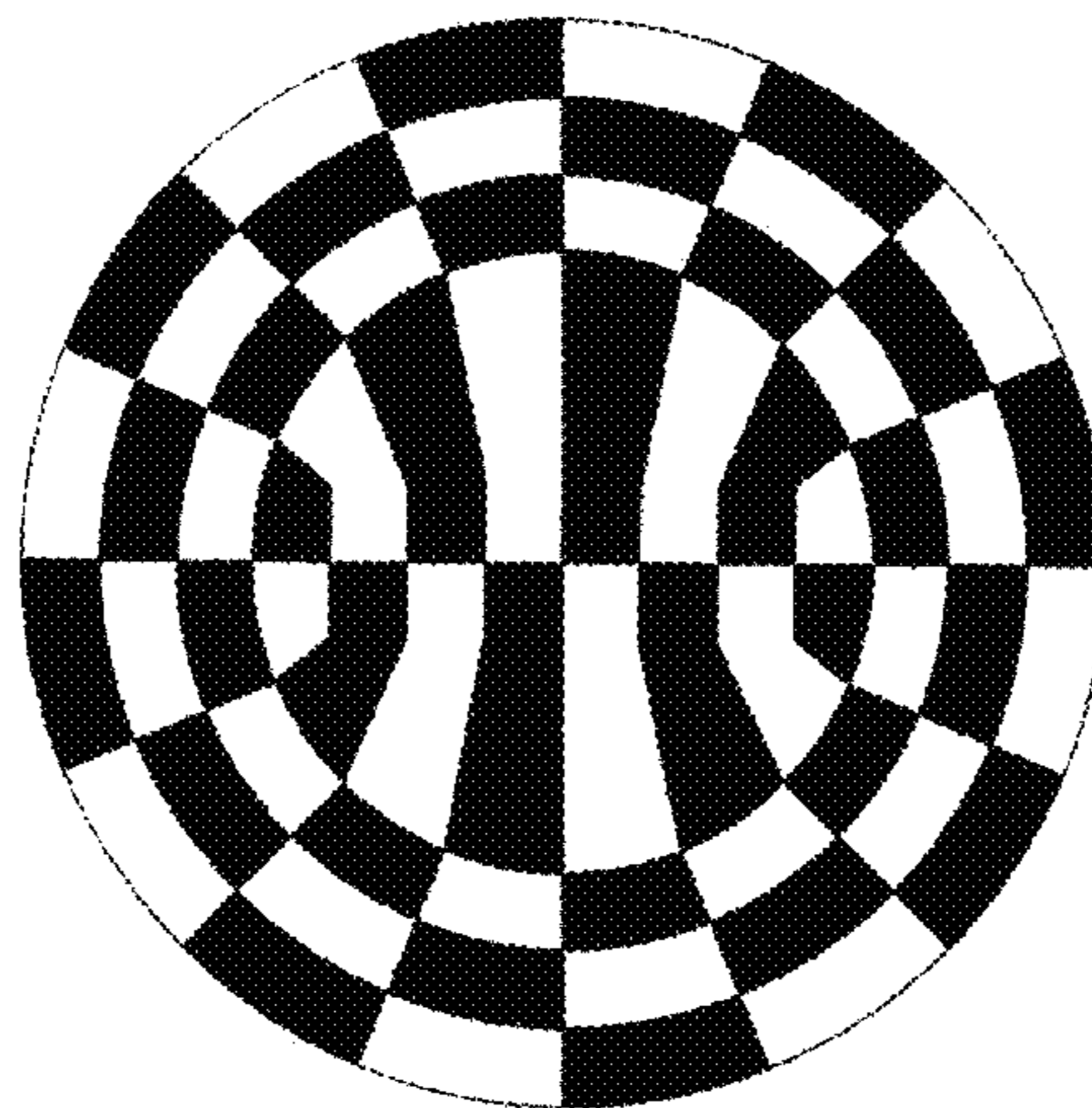
I claim the ornamental design for a game board, as shown and described.
