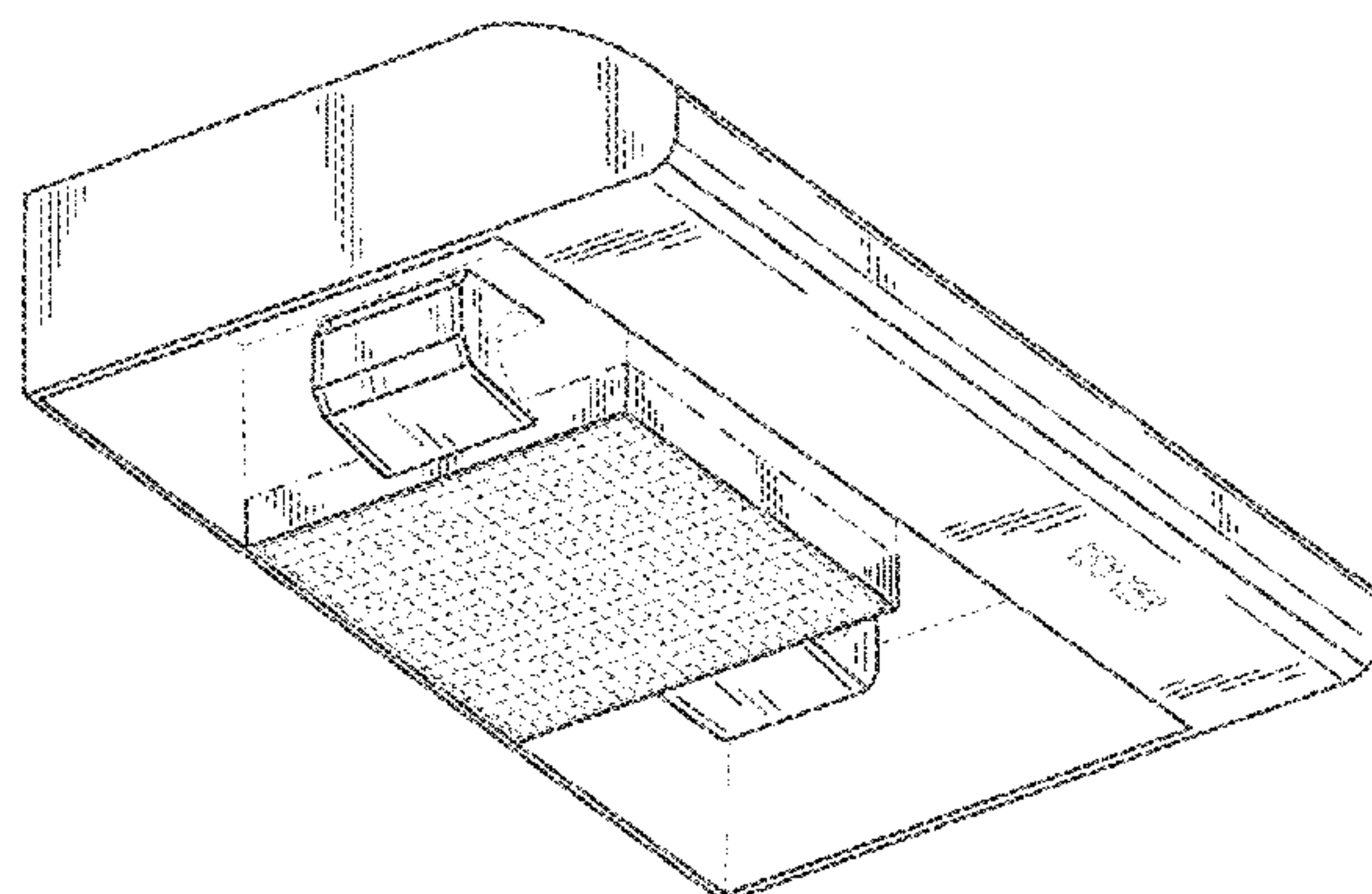
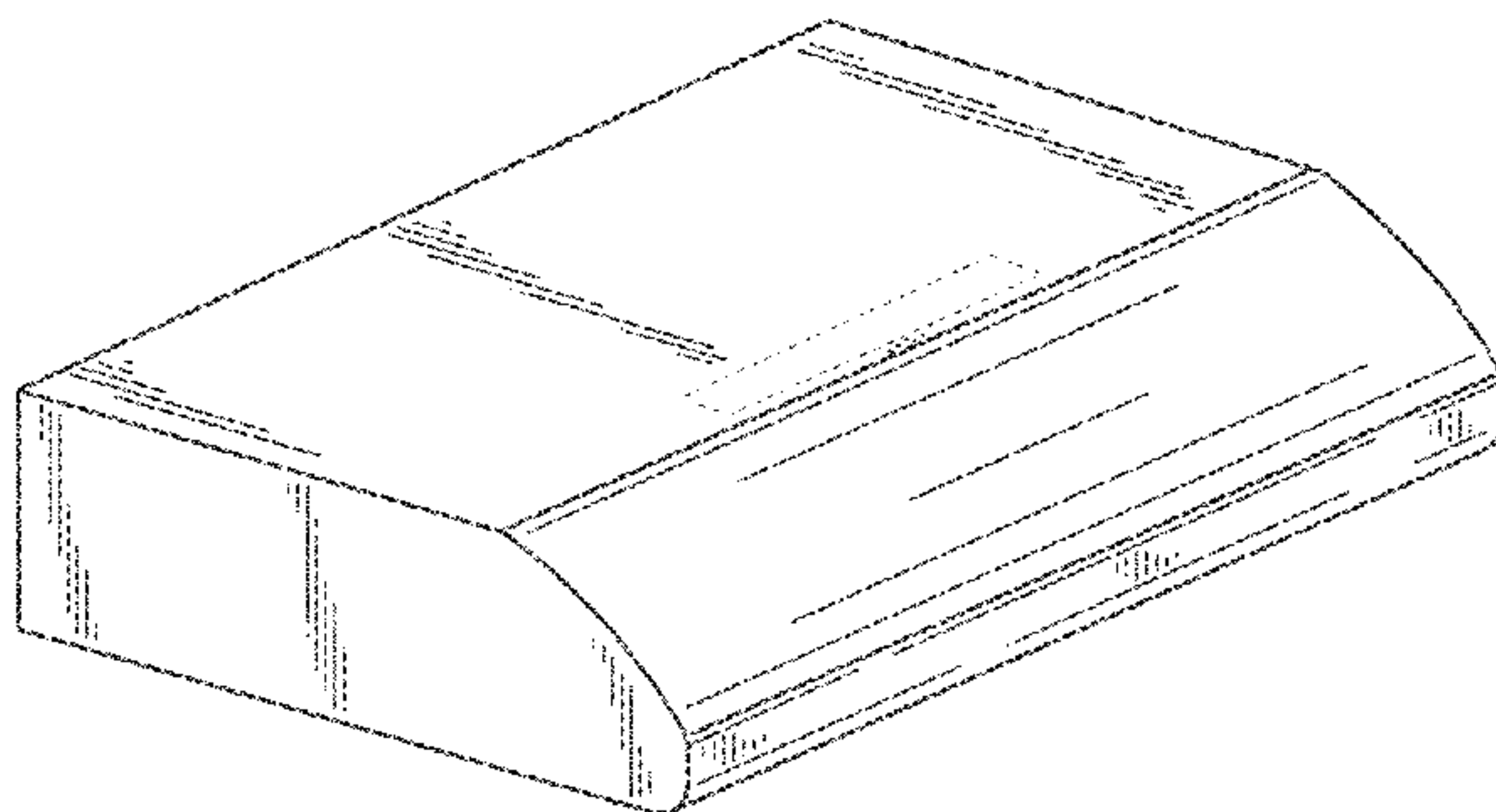
CLAIM

DESCRIPTION

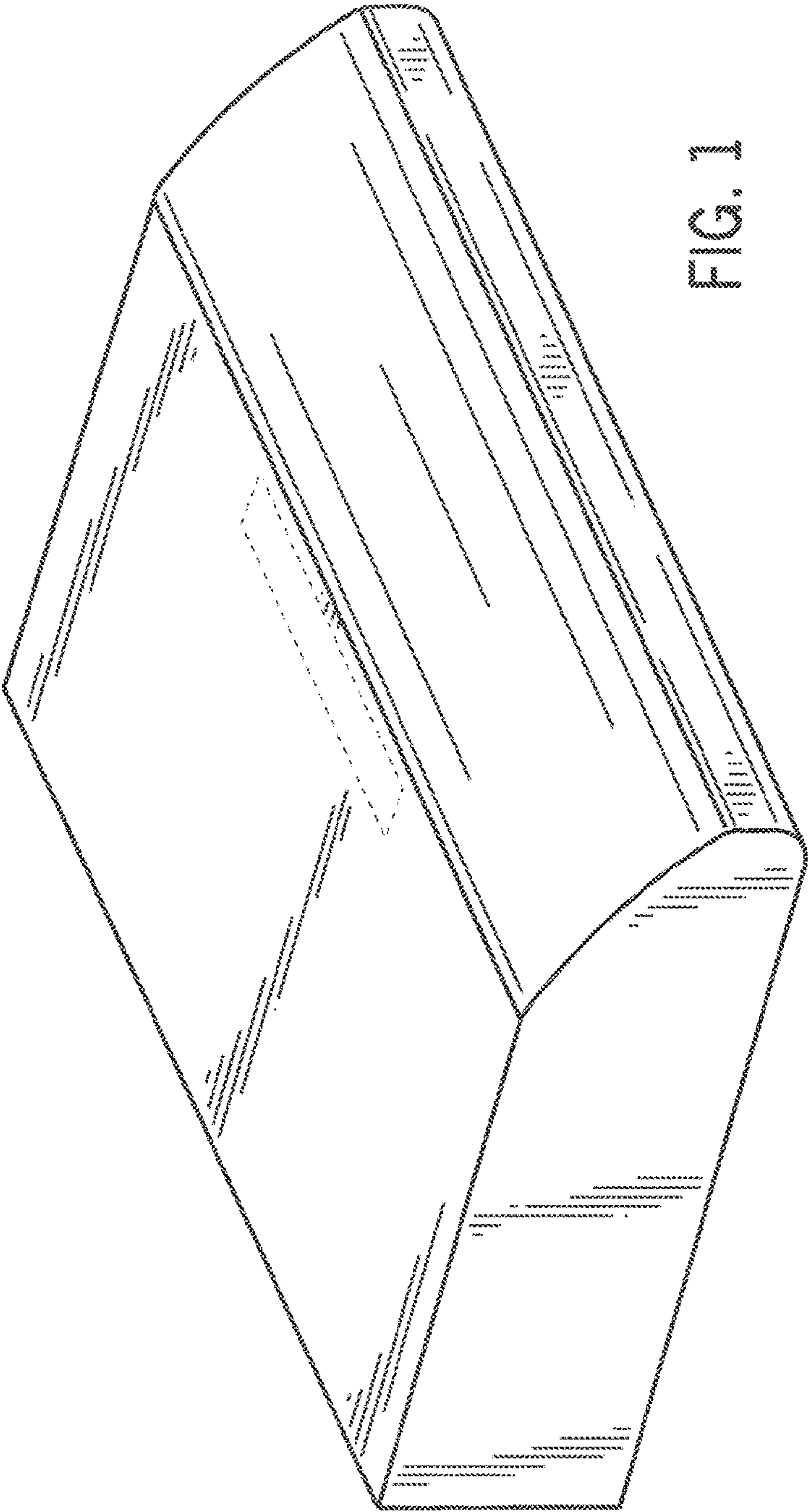

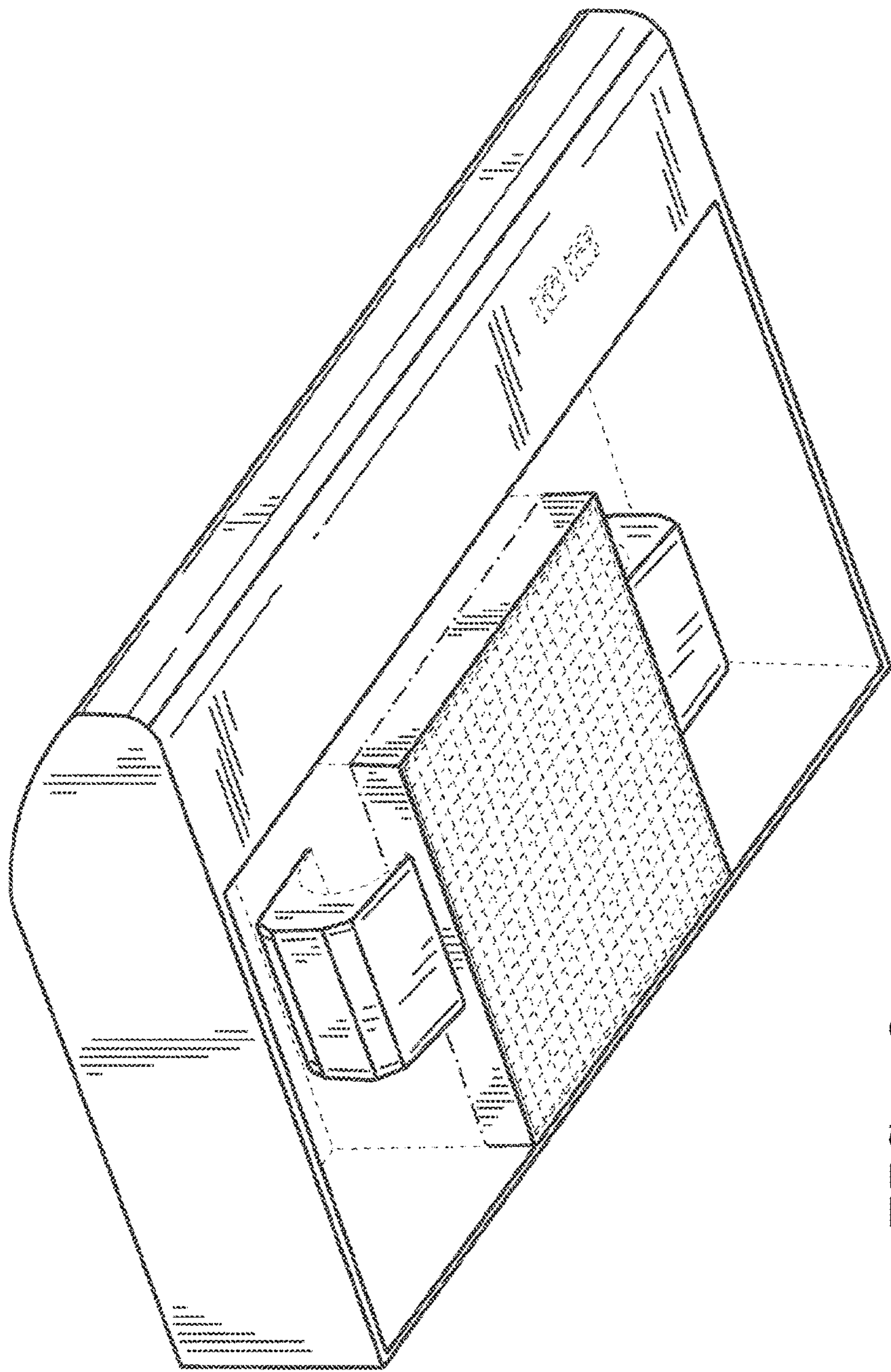

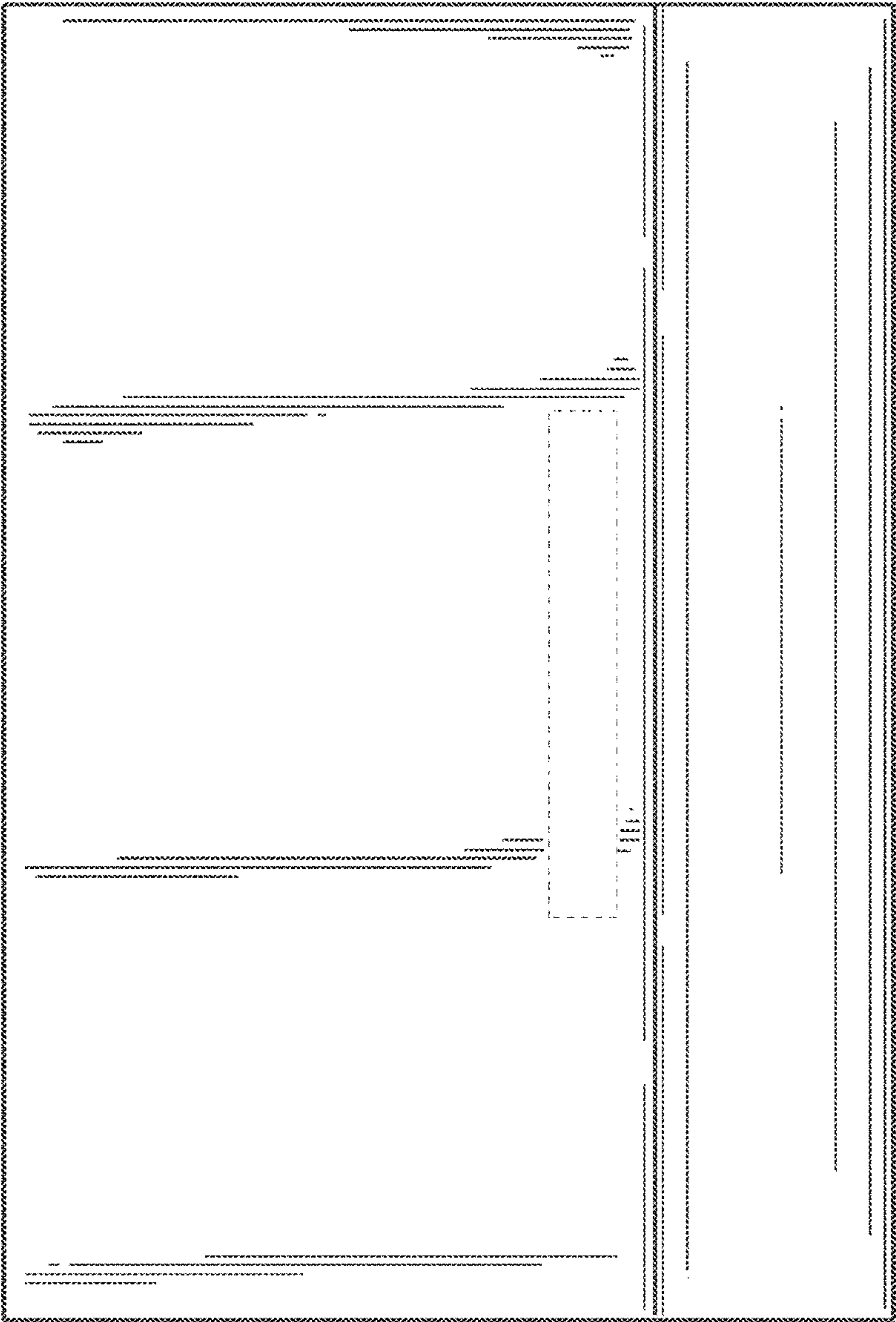

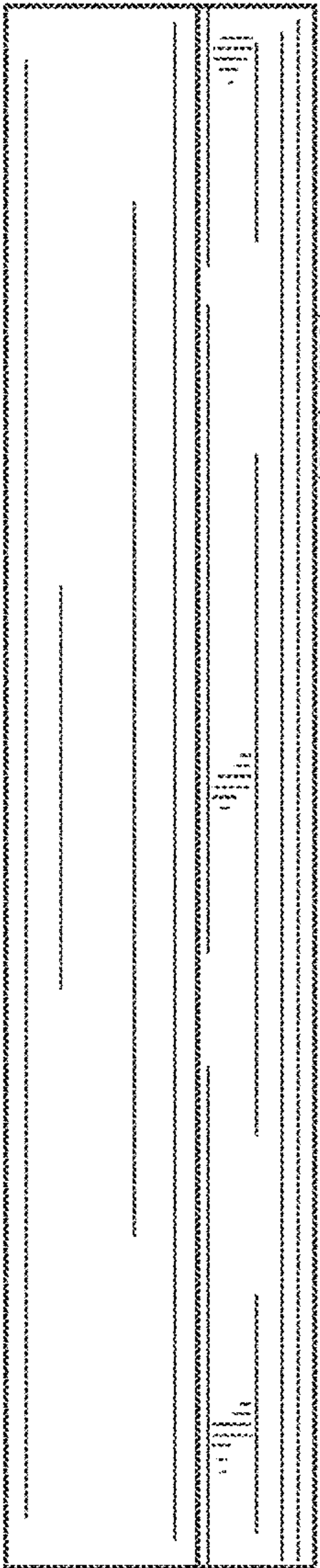

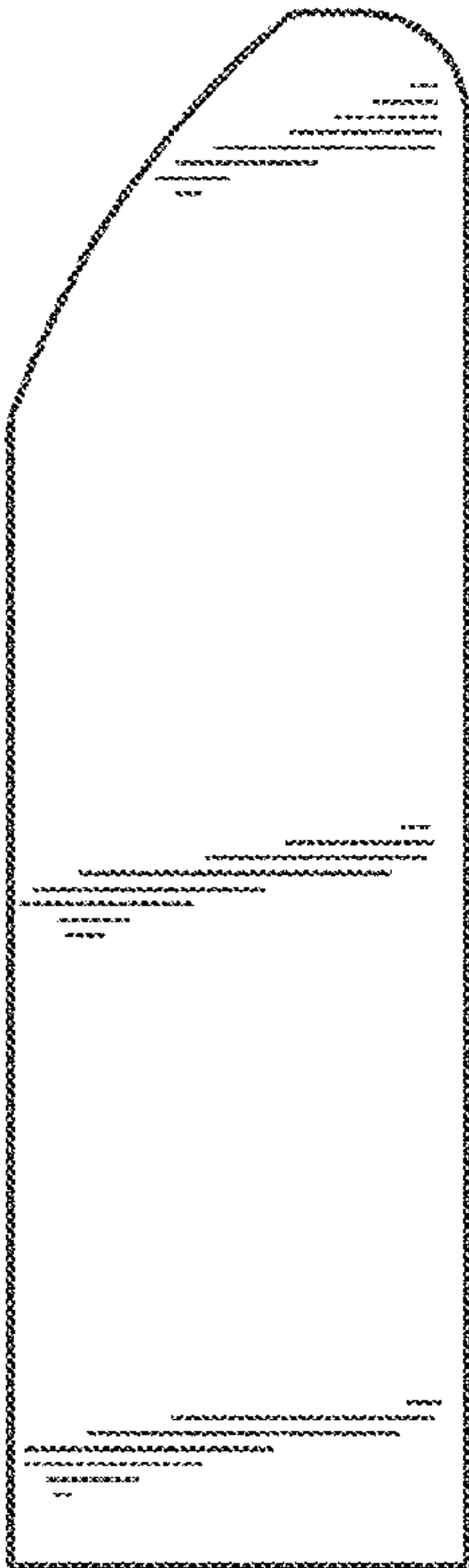

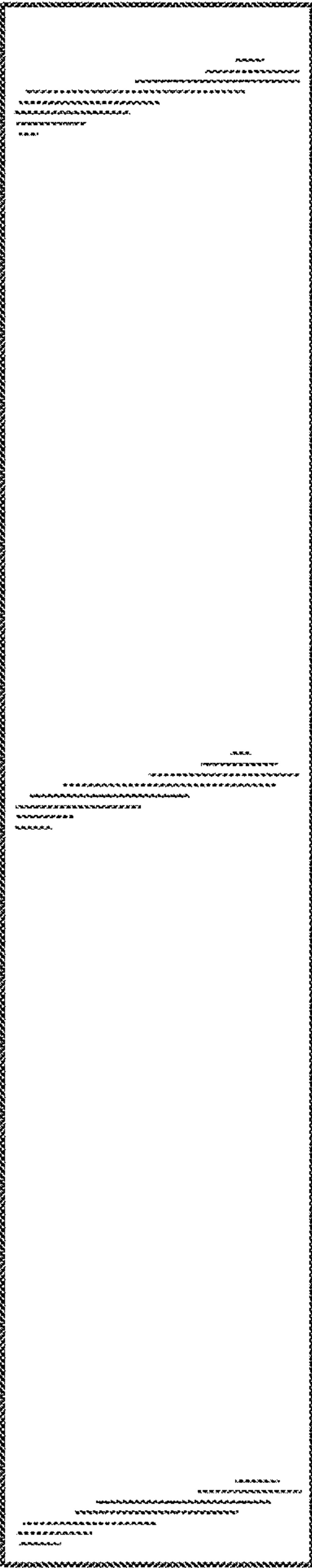

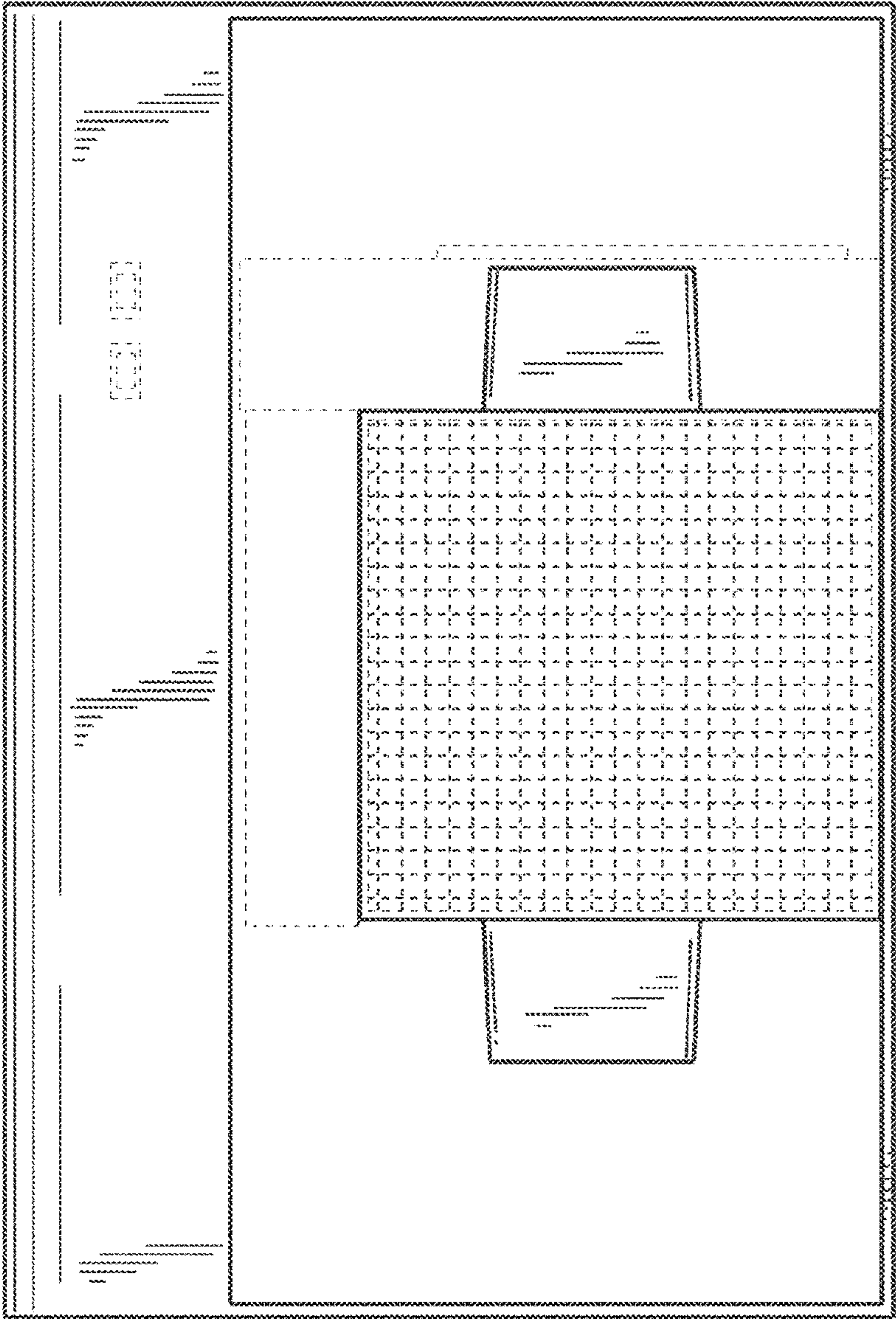
