FIG. 3 is a rear, bottom, left side perspective view of the medical instrument of FIG. 1;

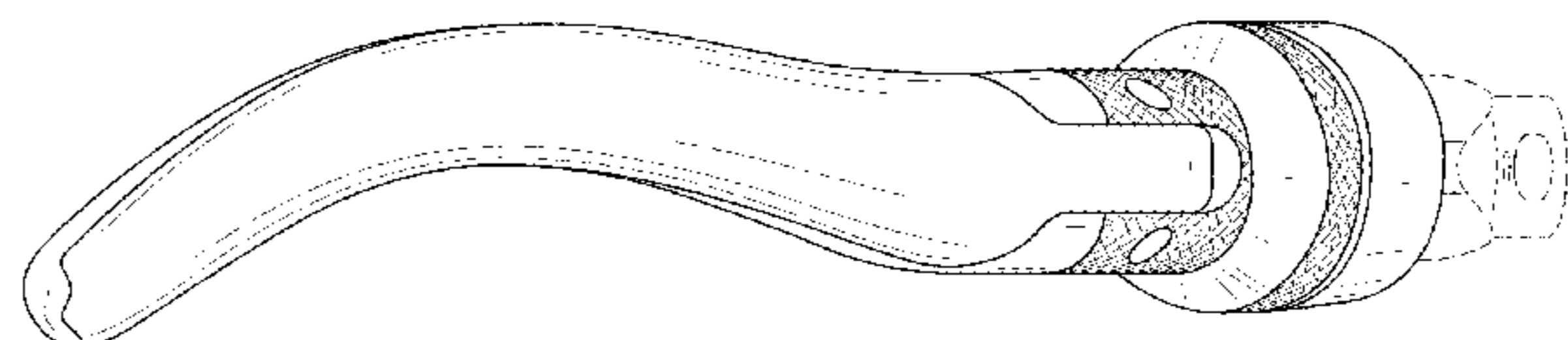
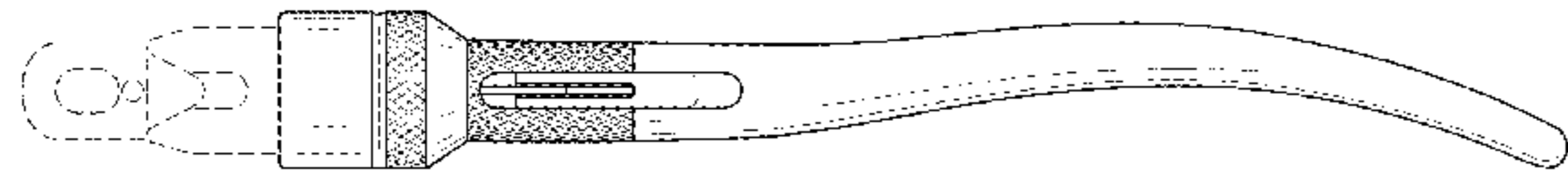
FIG. 4 is a bottom, right side view of the medical instrument of FIG. 1;

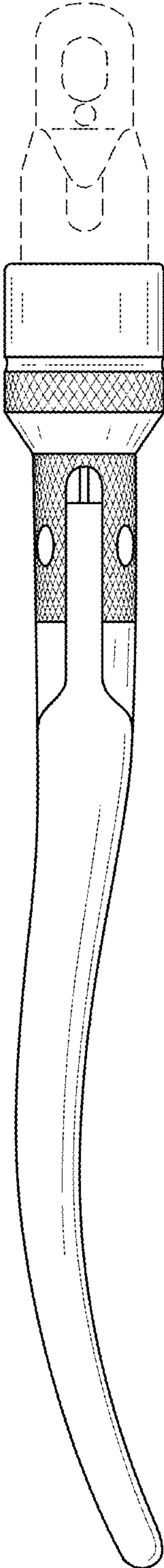

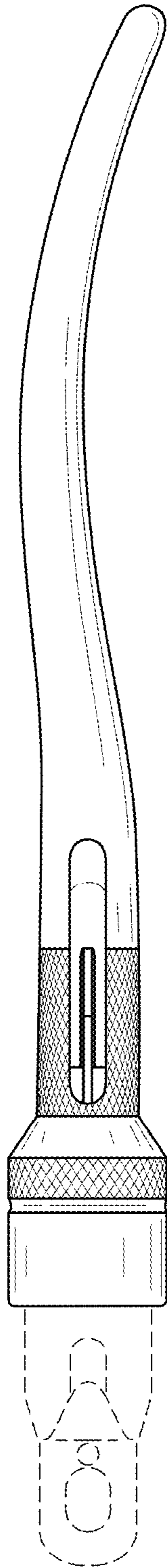

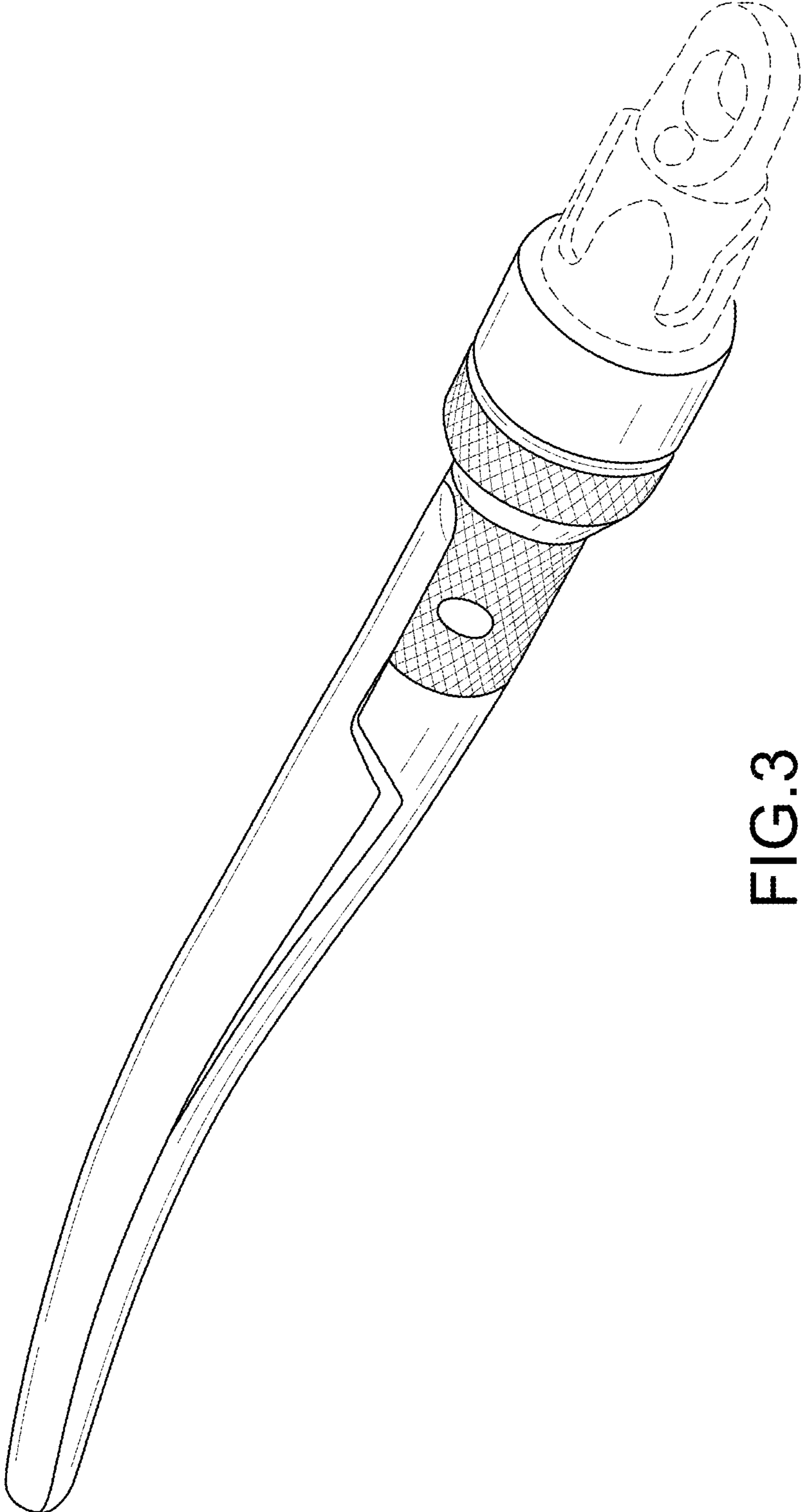

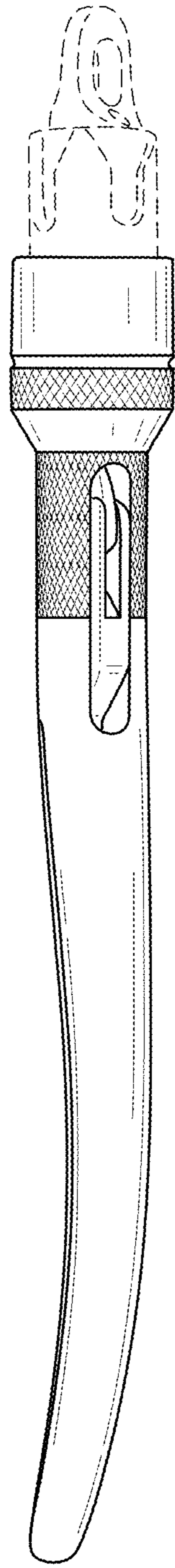

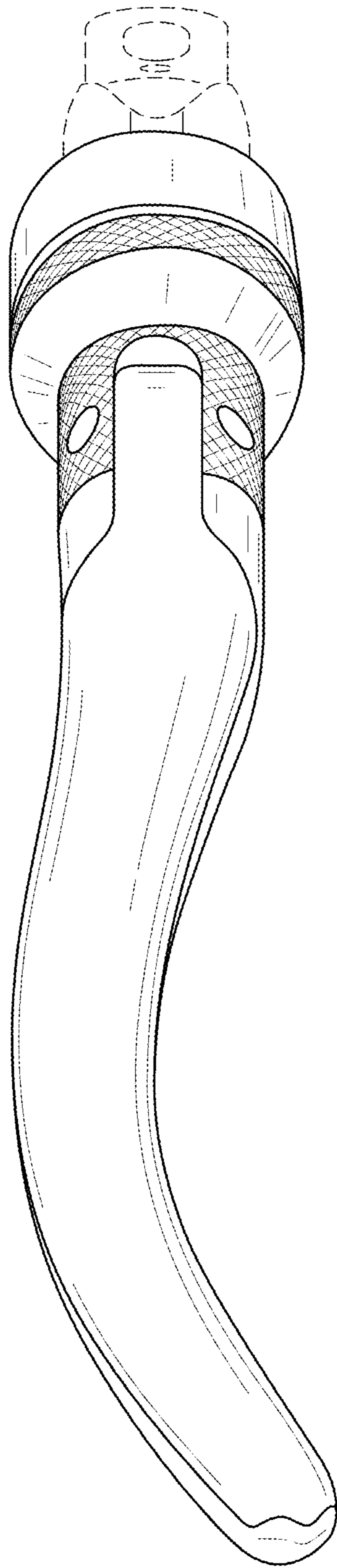

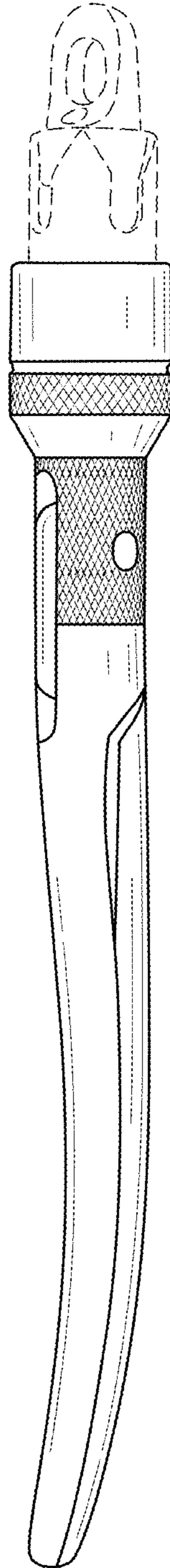
