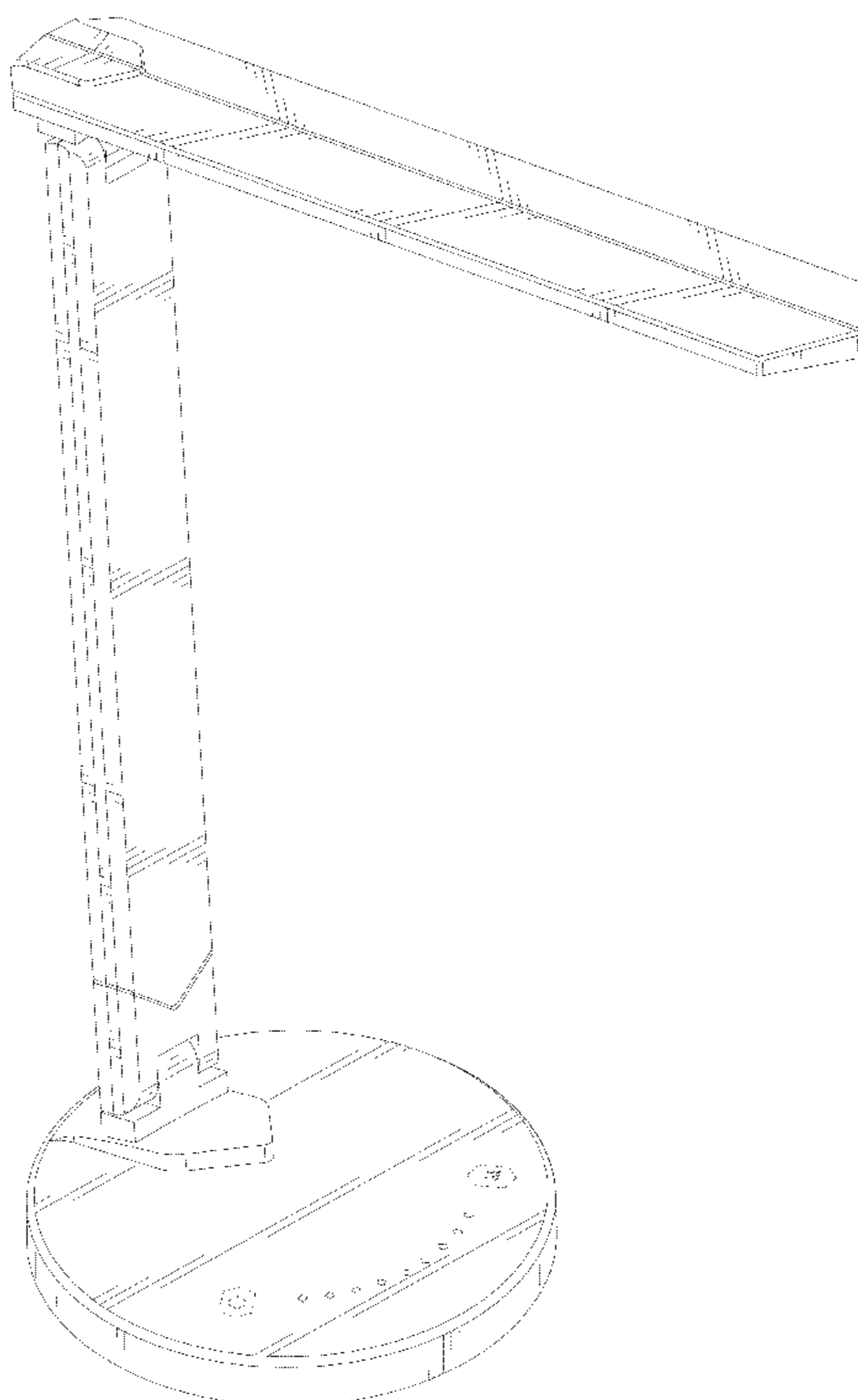
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a light showing our new design;
FIG. 2 is a rear elevational view thereof;

FIG. 6 is a bottom plan view thereof;

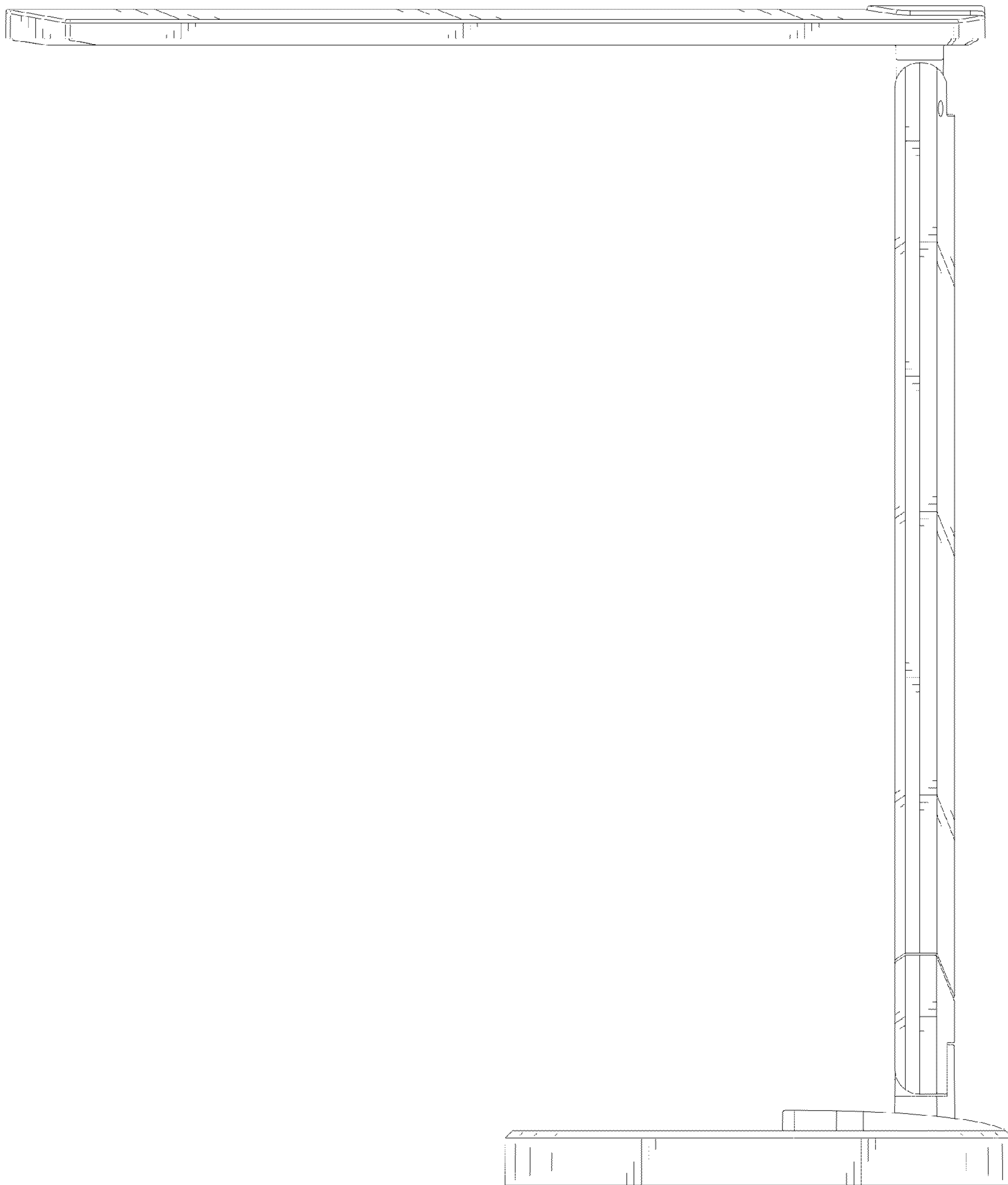

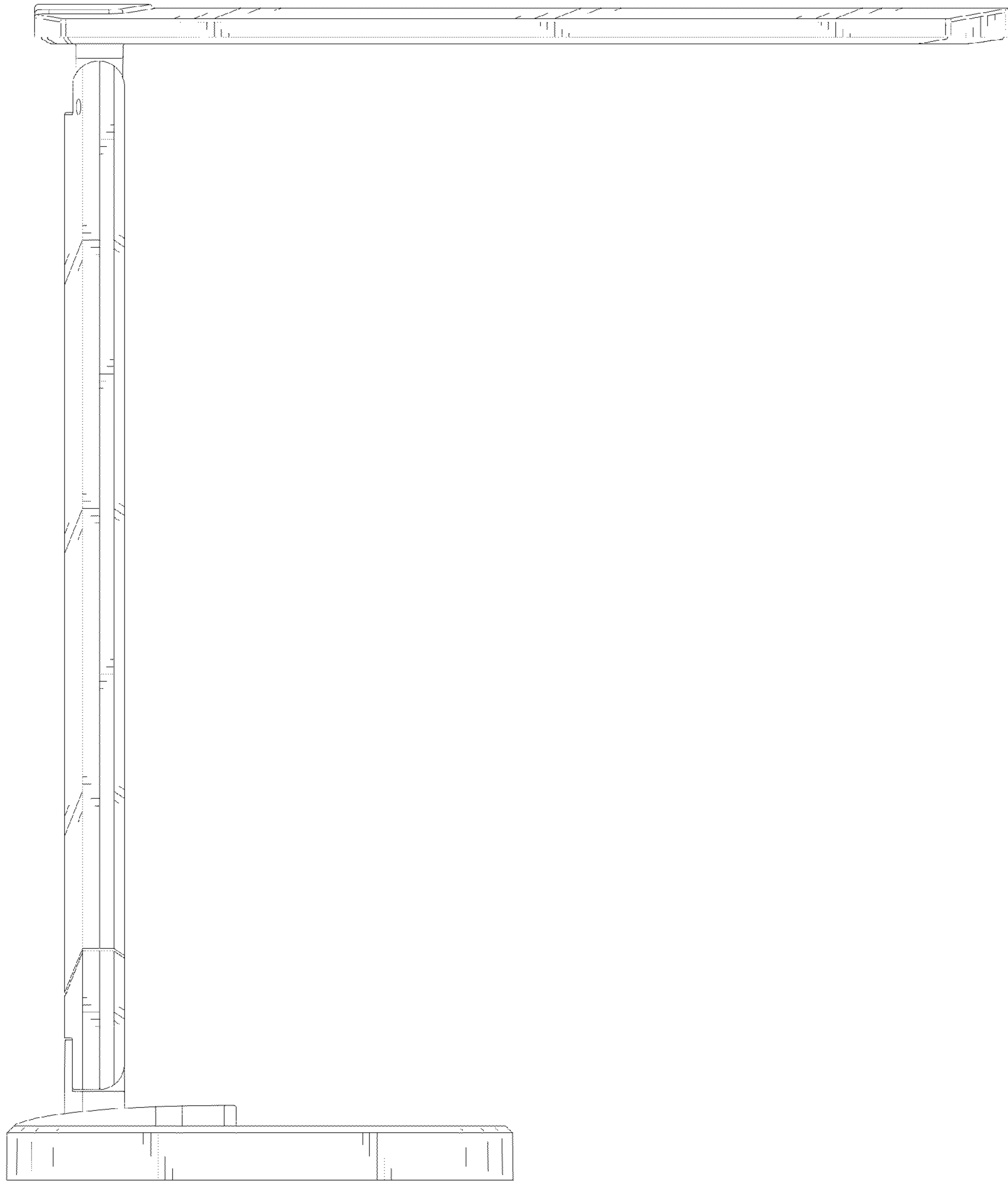

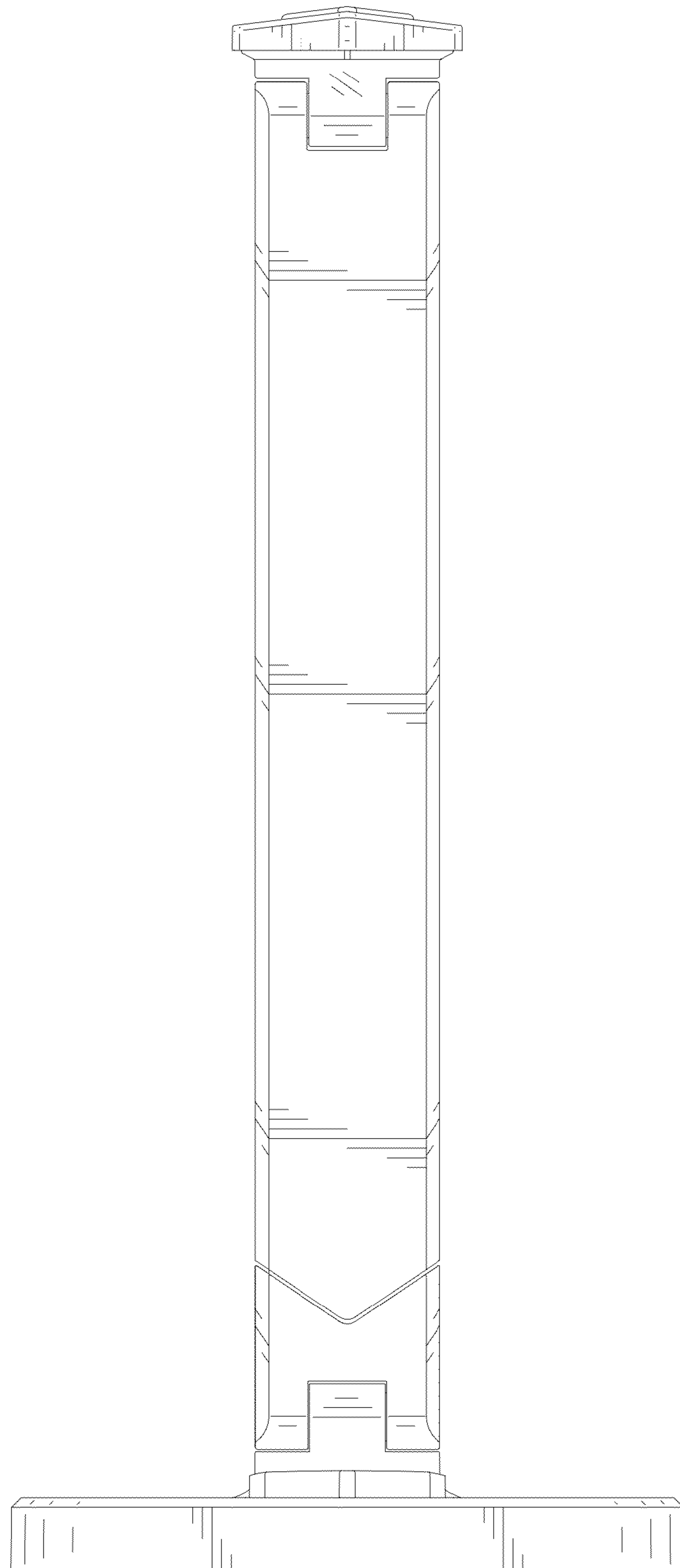

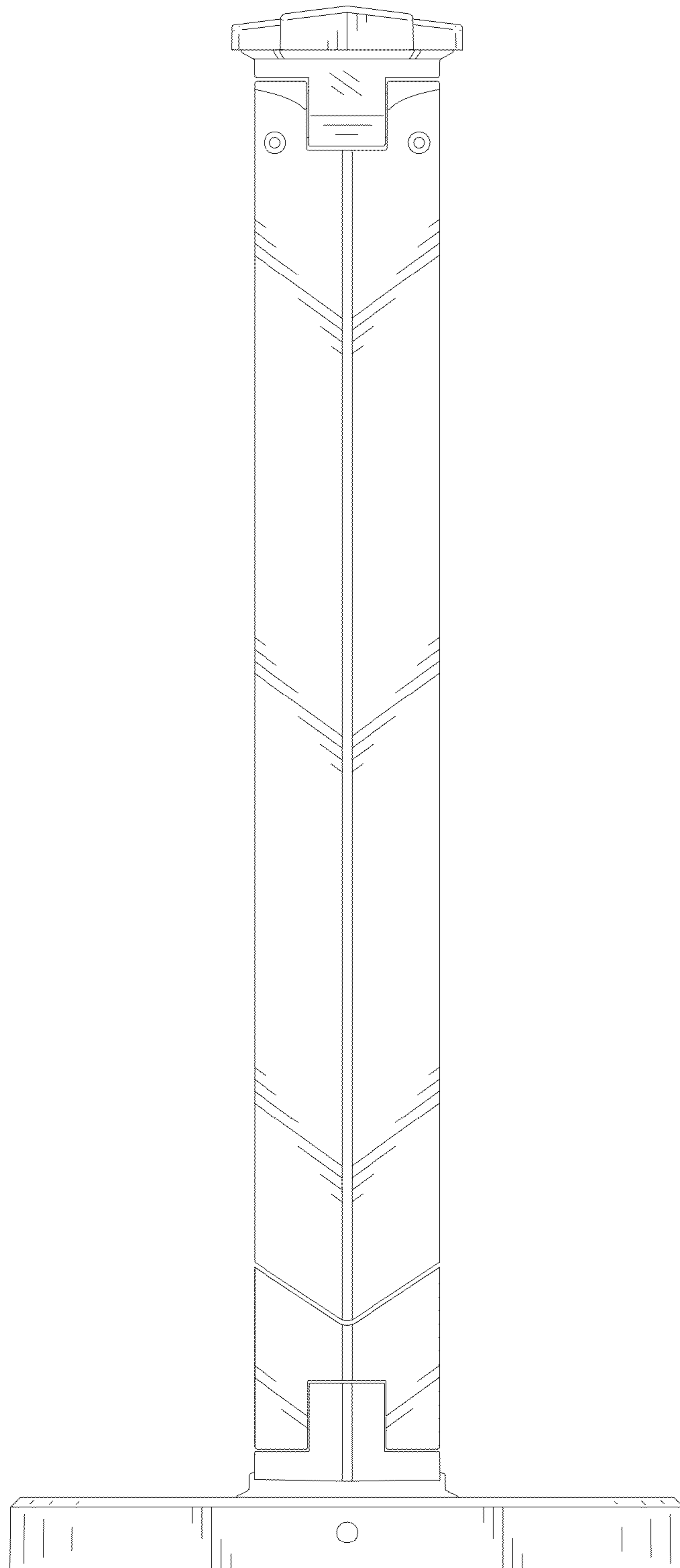

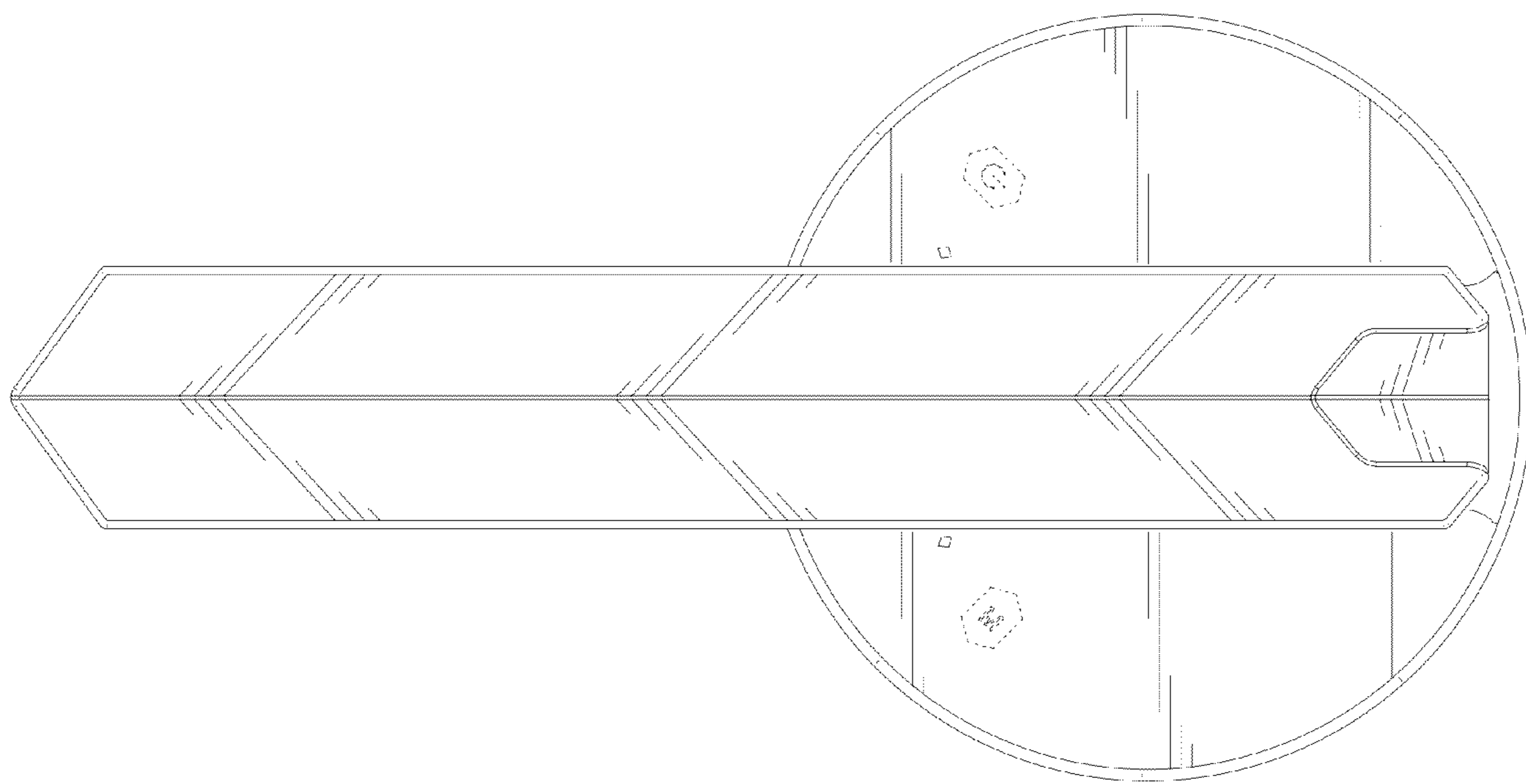

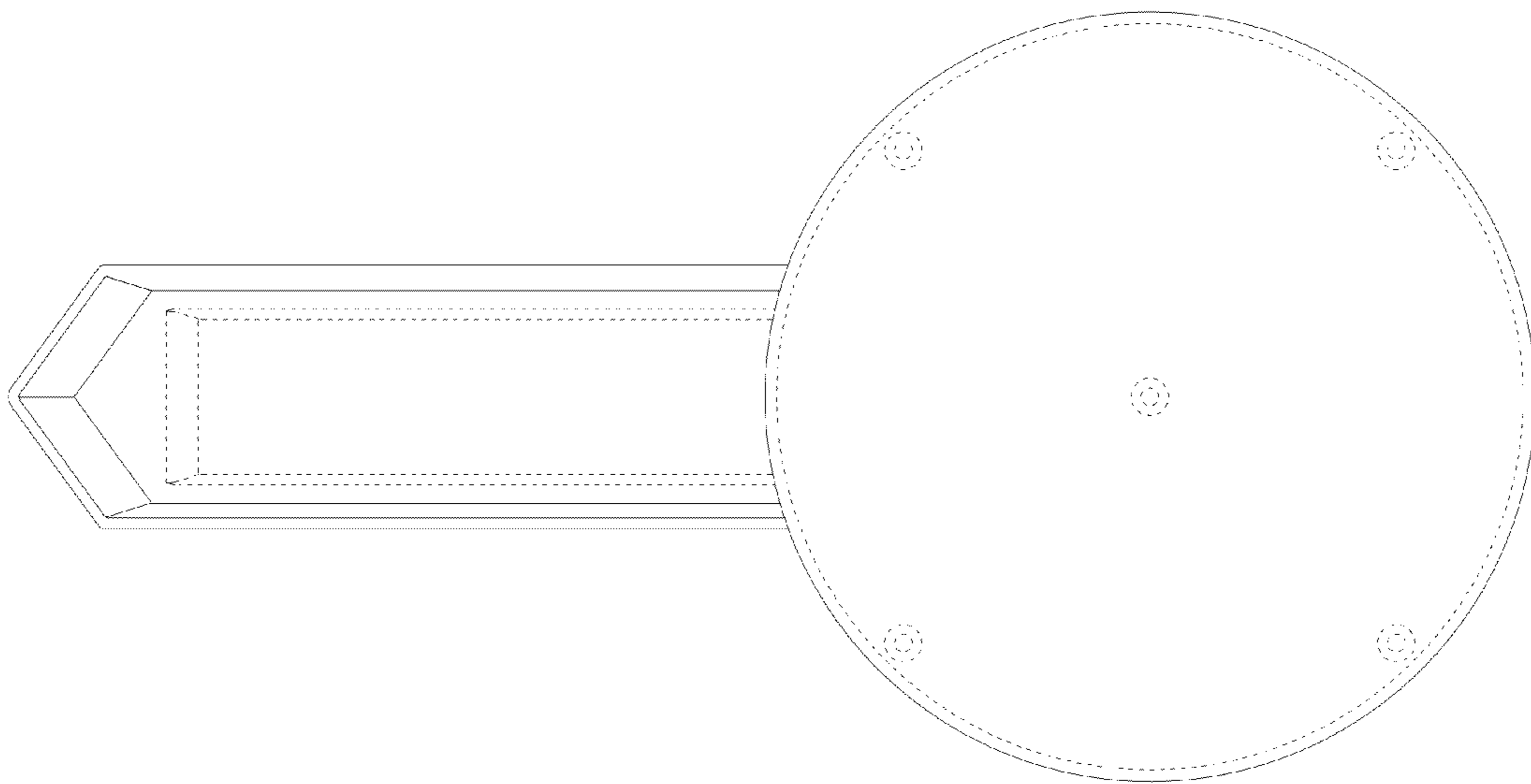

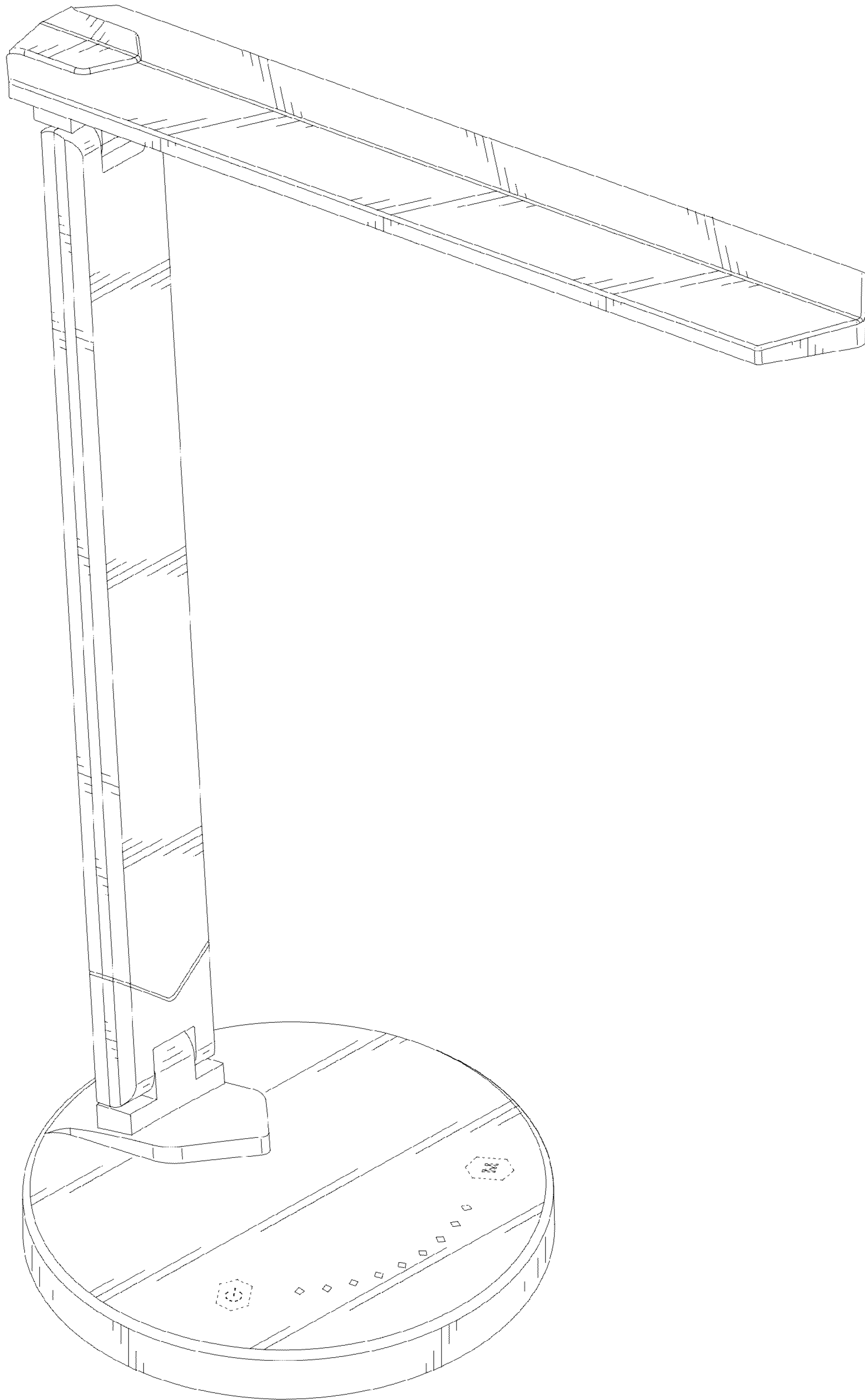

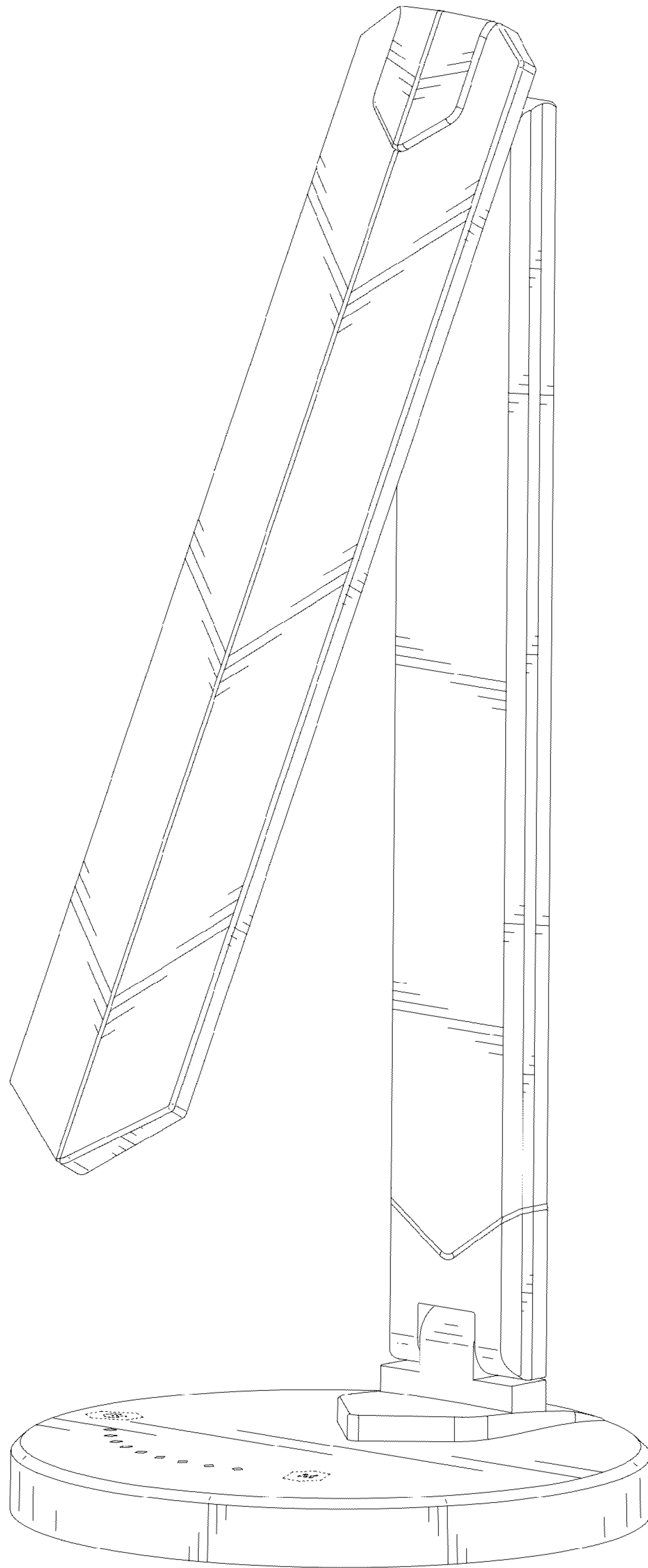

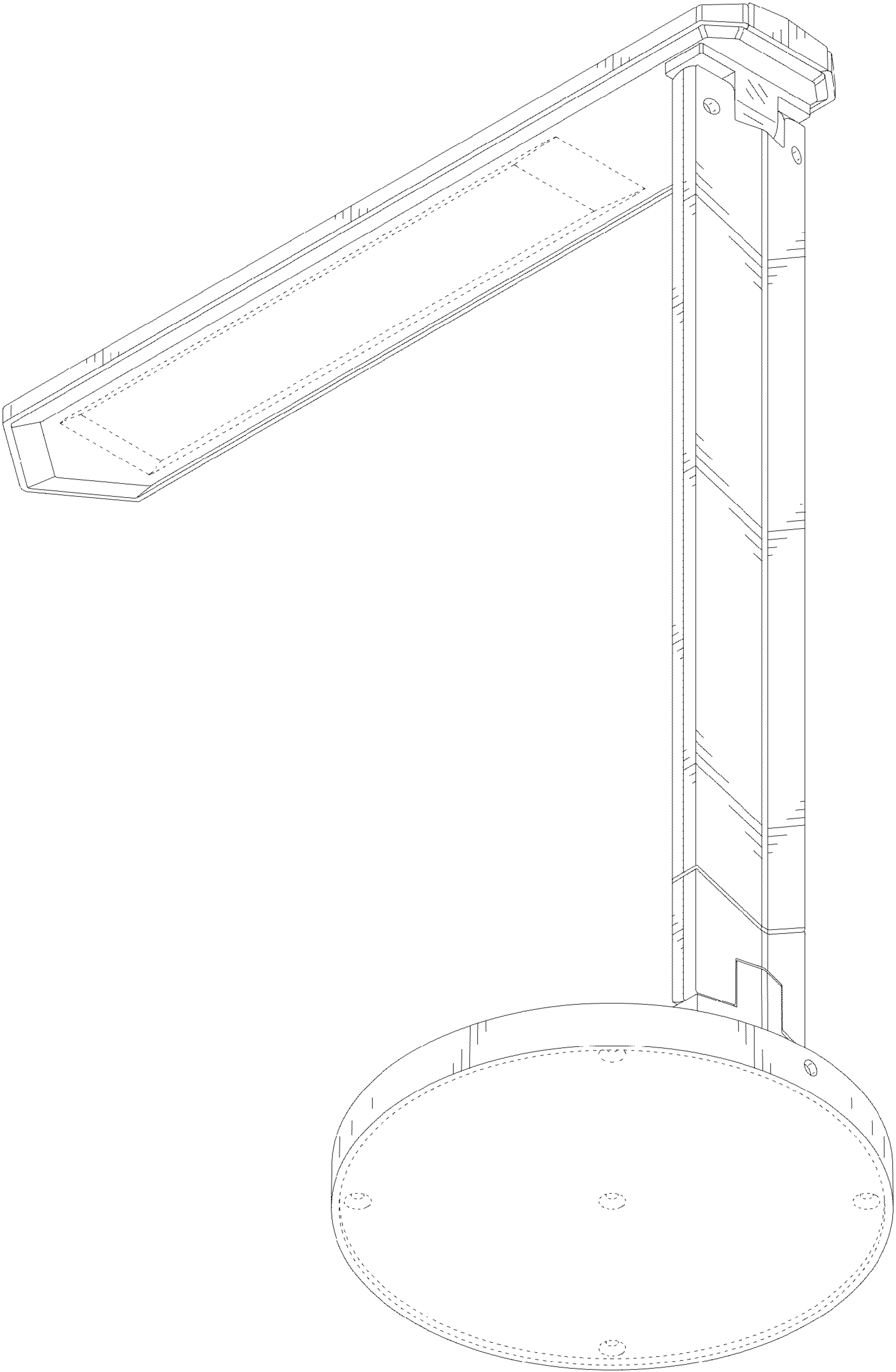
