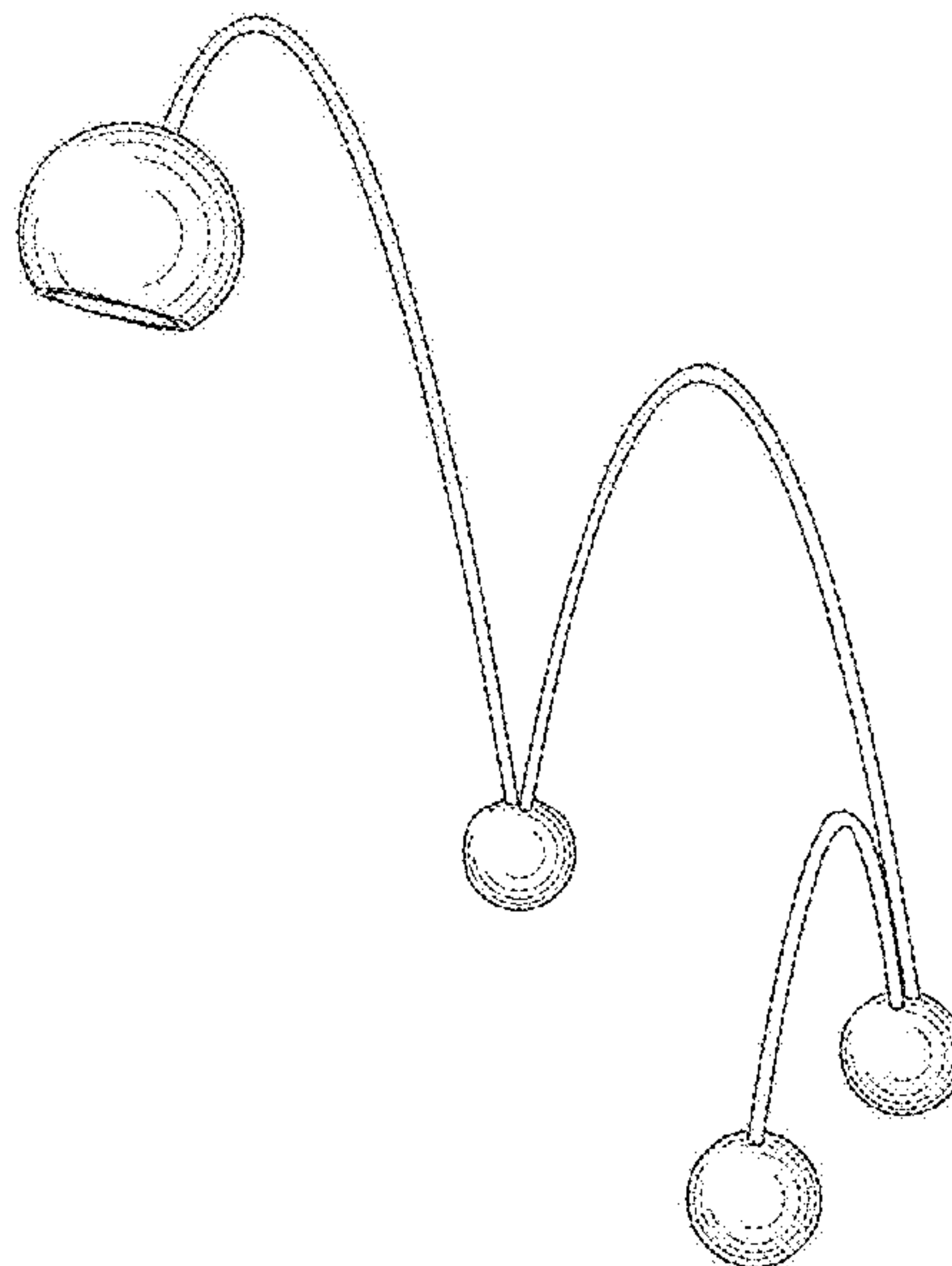
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a right front perspective view of a task light according to the present invention;

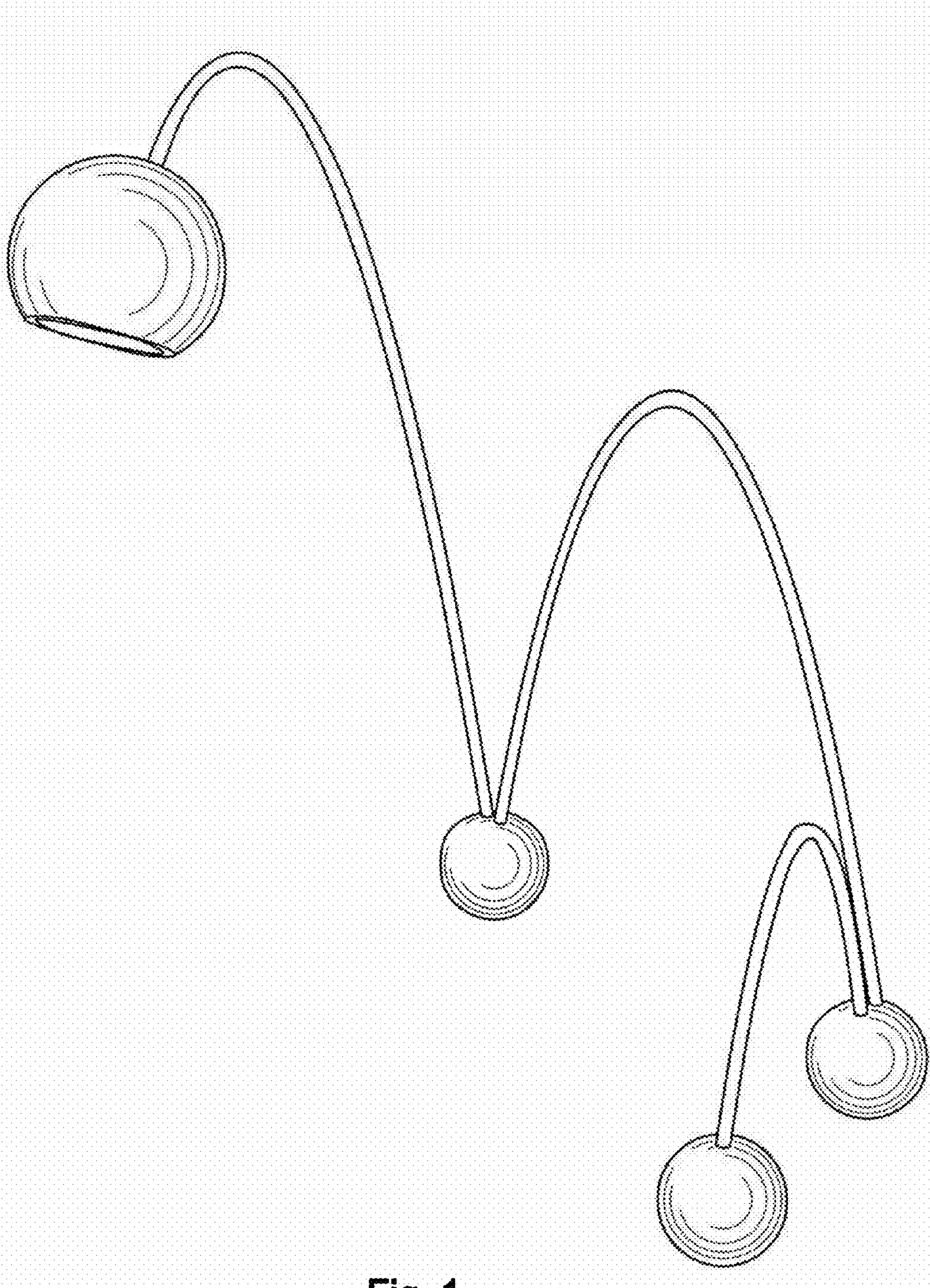

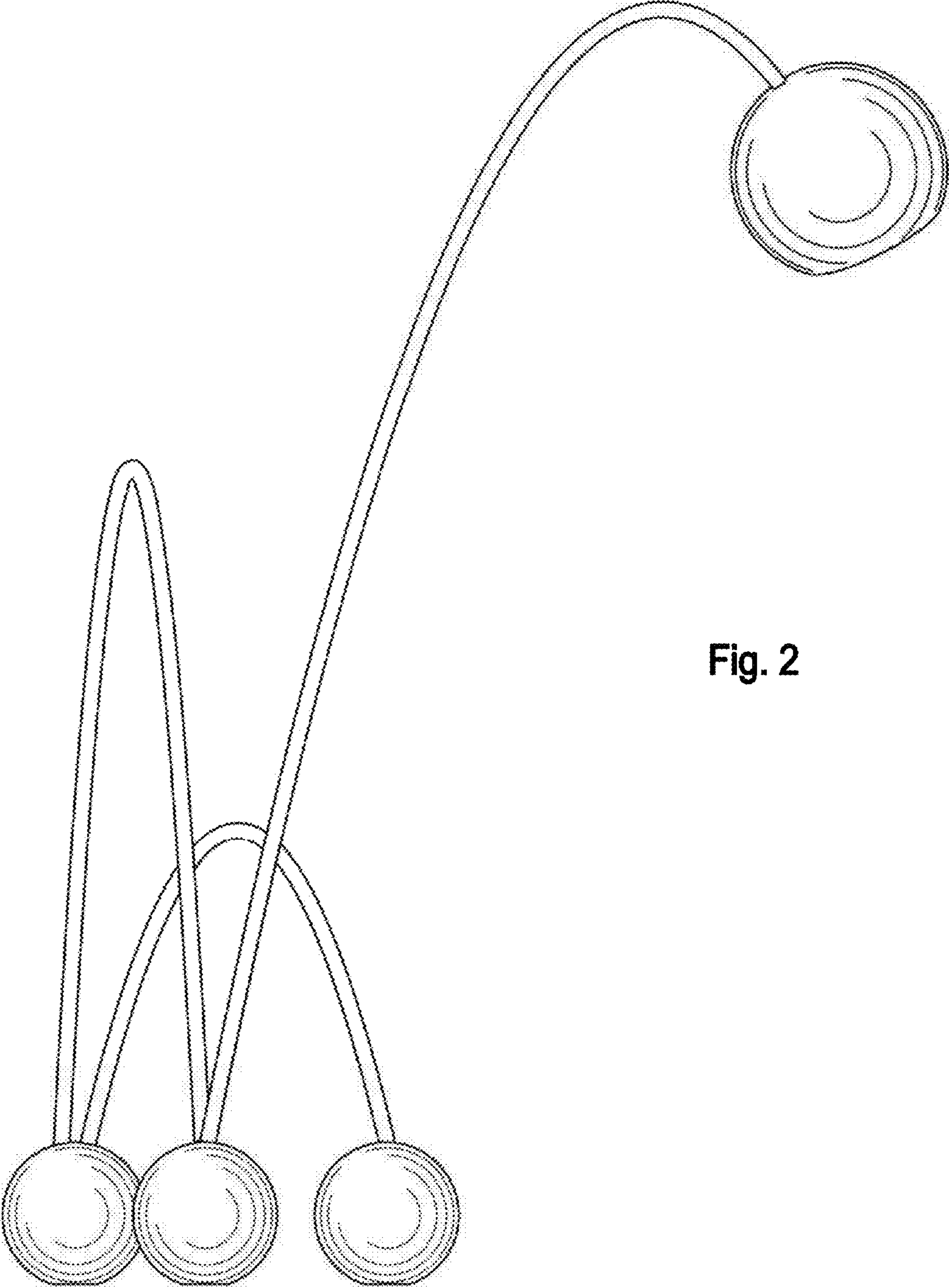

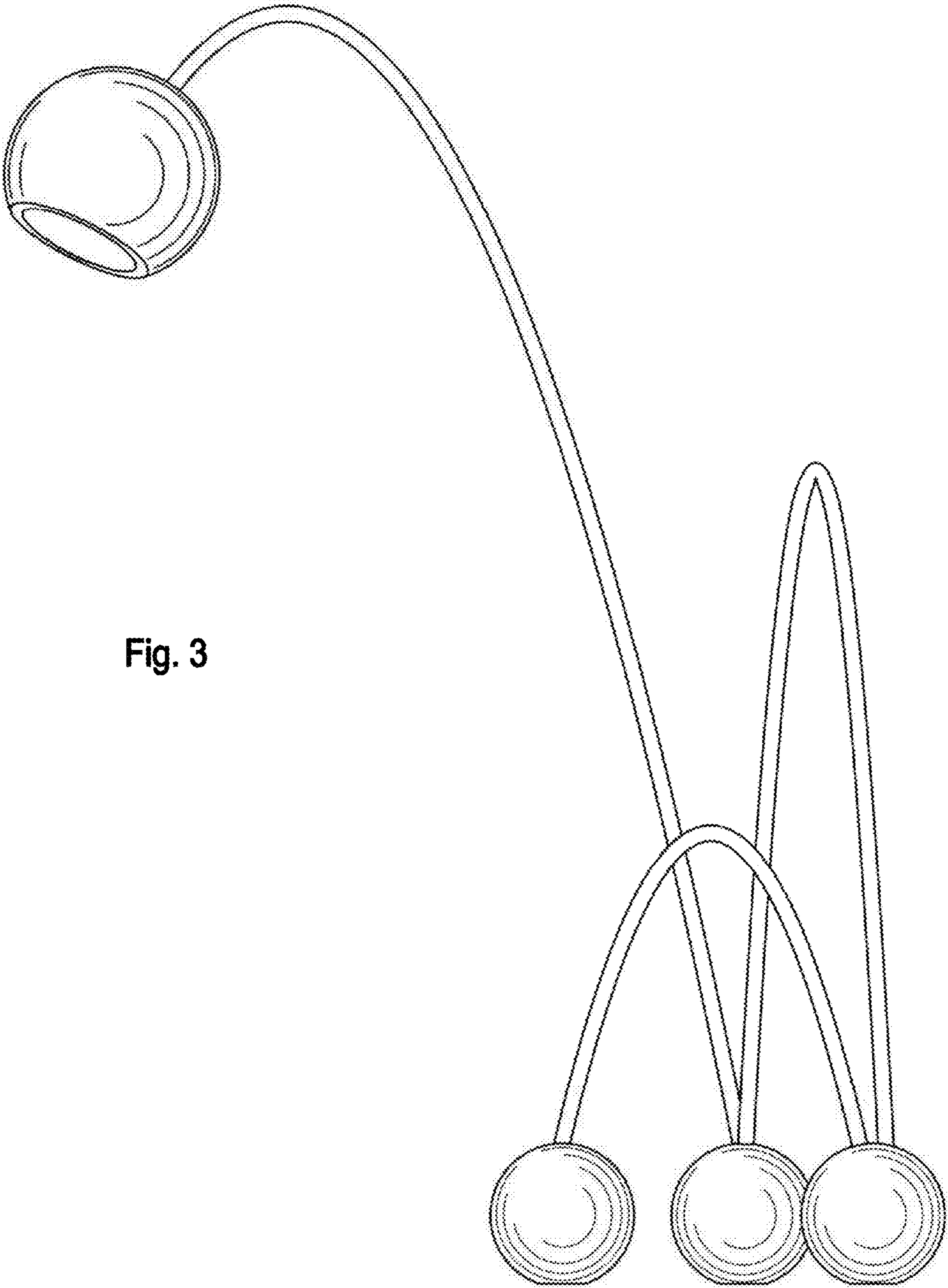
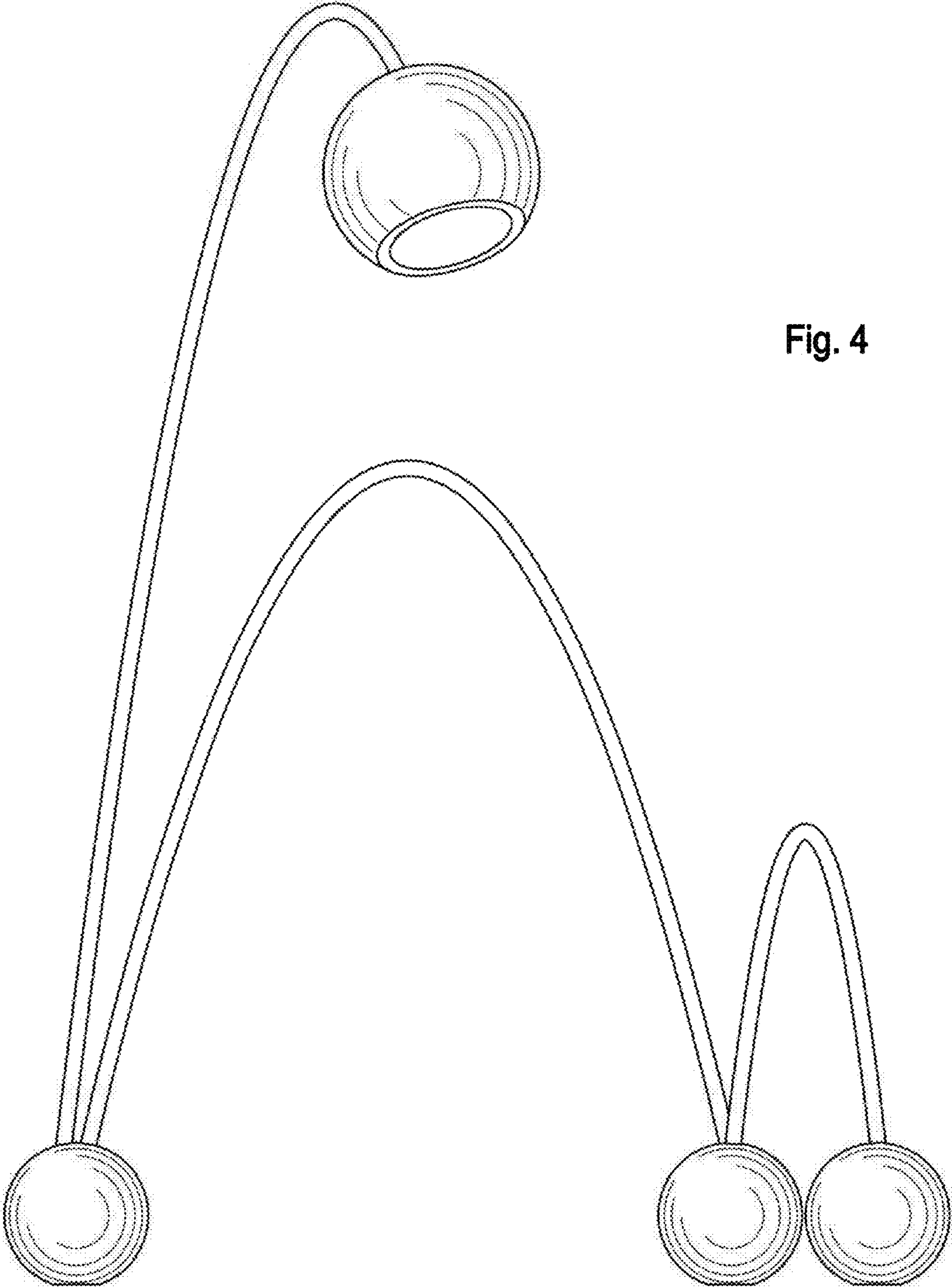

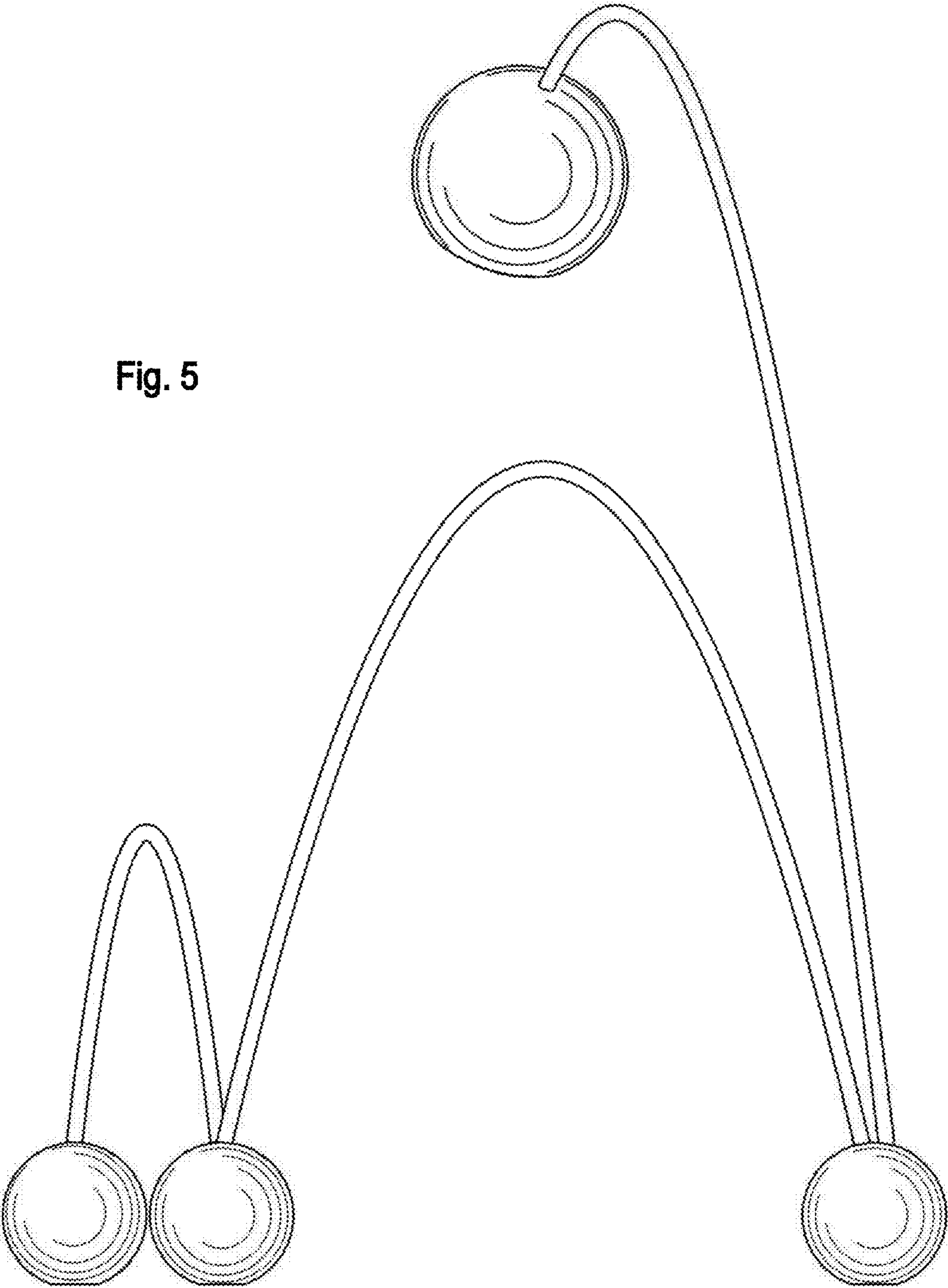

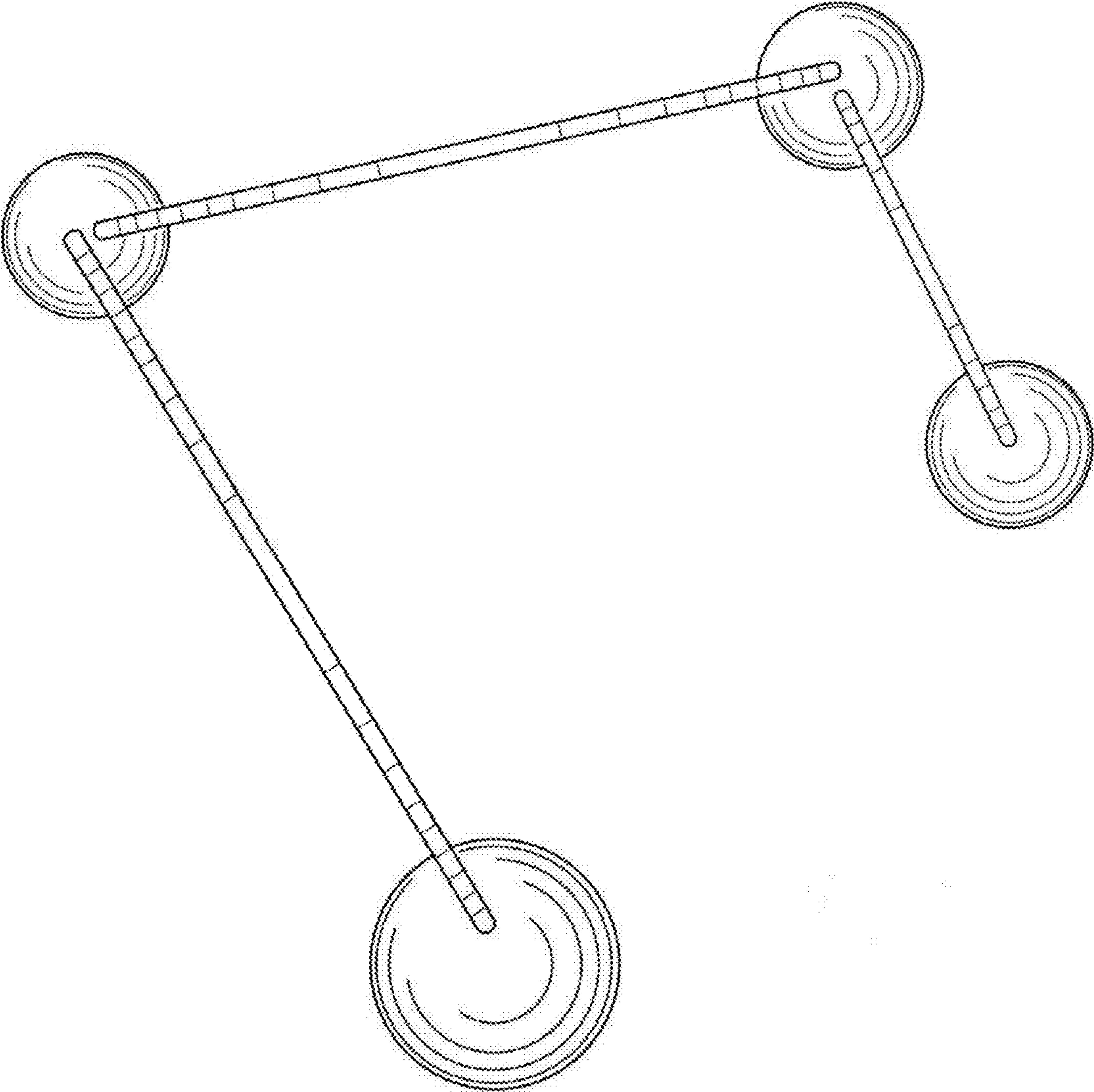

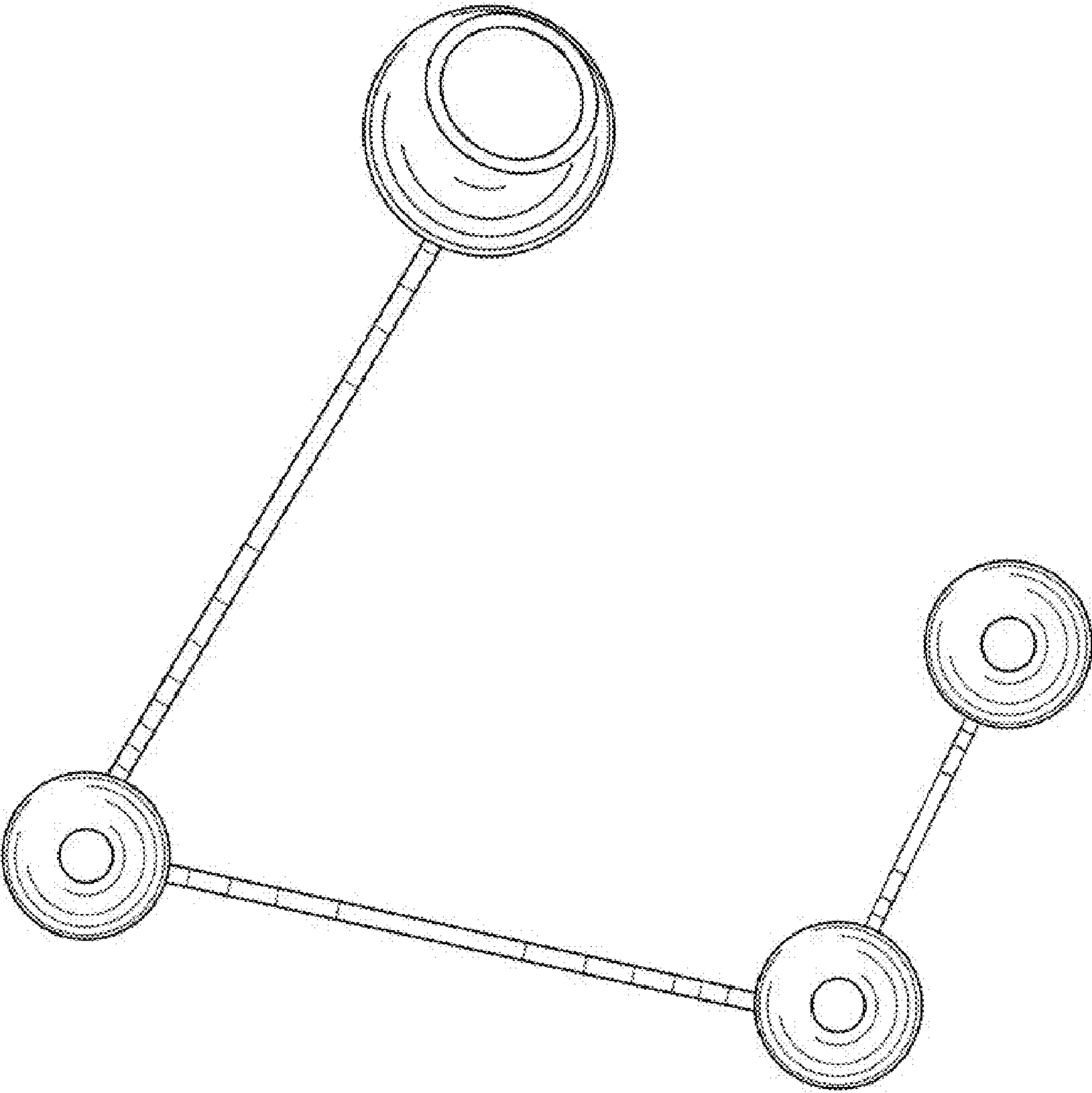
