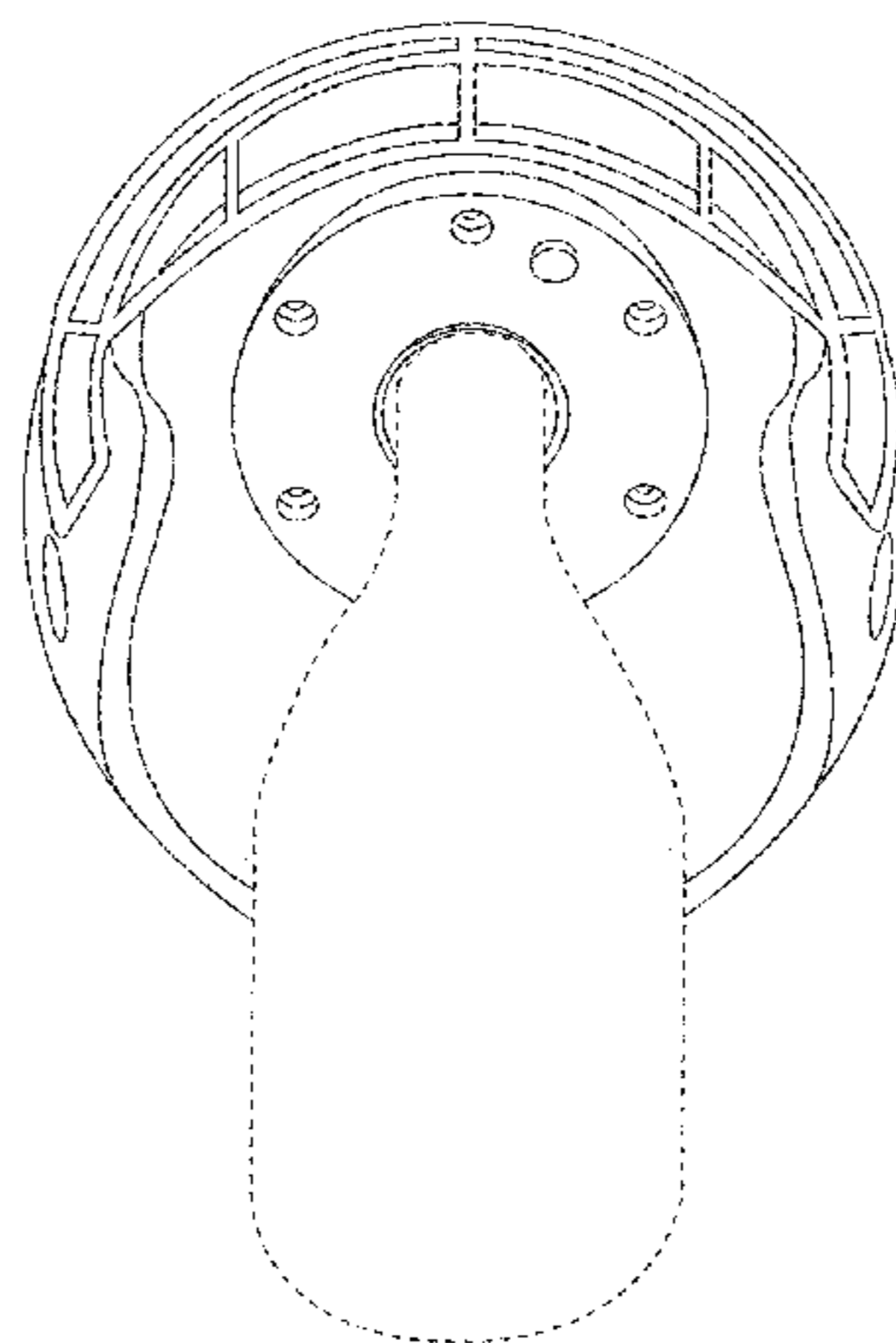
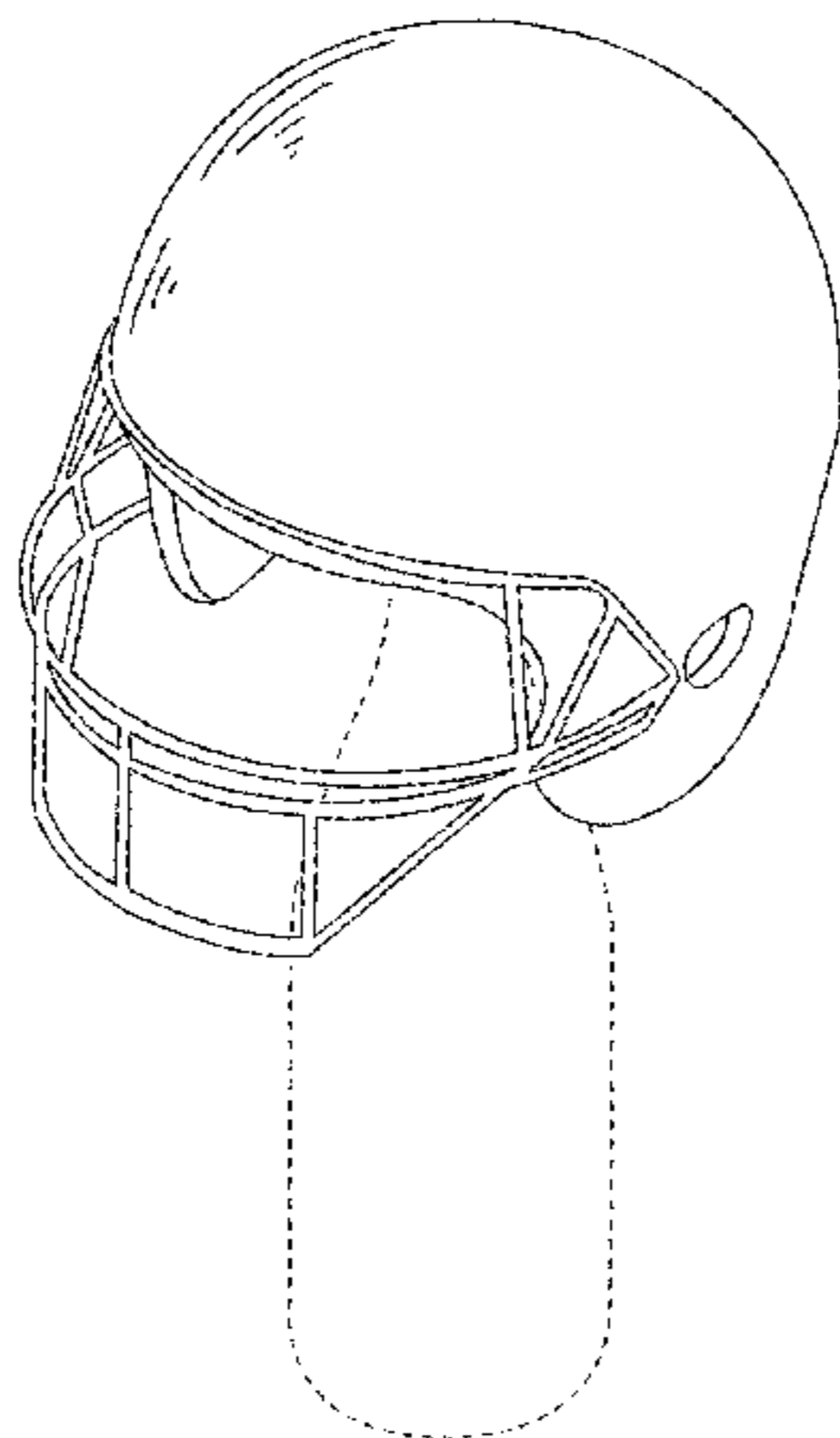
(57) **CLAIM**

The ornamental design for a combined bottle light and helmet shade, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top view of a combined bottle light and helmet shade showing our new design; FIG. 2 is a perspective bottom view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a front elevation view thereof; FIG. 6 is a rear elevation view thereof; FIG. 7 is a right side elevation view thereof; the left side elevation view is the mirror image of FIG. 7; FIG. 8 is a first perspective top view of the combined bottle light and helmet shade shown in an environment of use; FIG. 9 is a second perspective top view of the combined bottle light and helmet shade shown in an environment of use; FIG. 10 is a third perspective top view of the combined bottle light and helmet shade shown in an environment of use; and, FIG. 11 is a perspective bottom view of the combined bottle light and helmet shade shown in an environment of use. The broken line portions shown in FIGS. 8-11 illustrate environmental subject matter only and form no part of the claimed design.

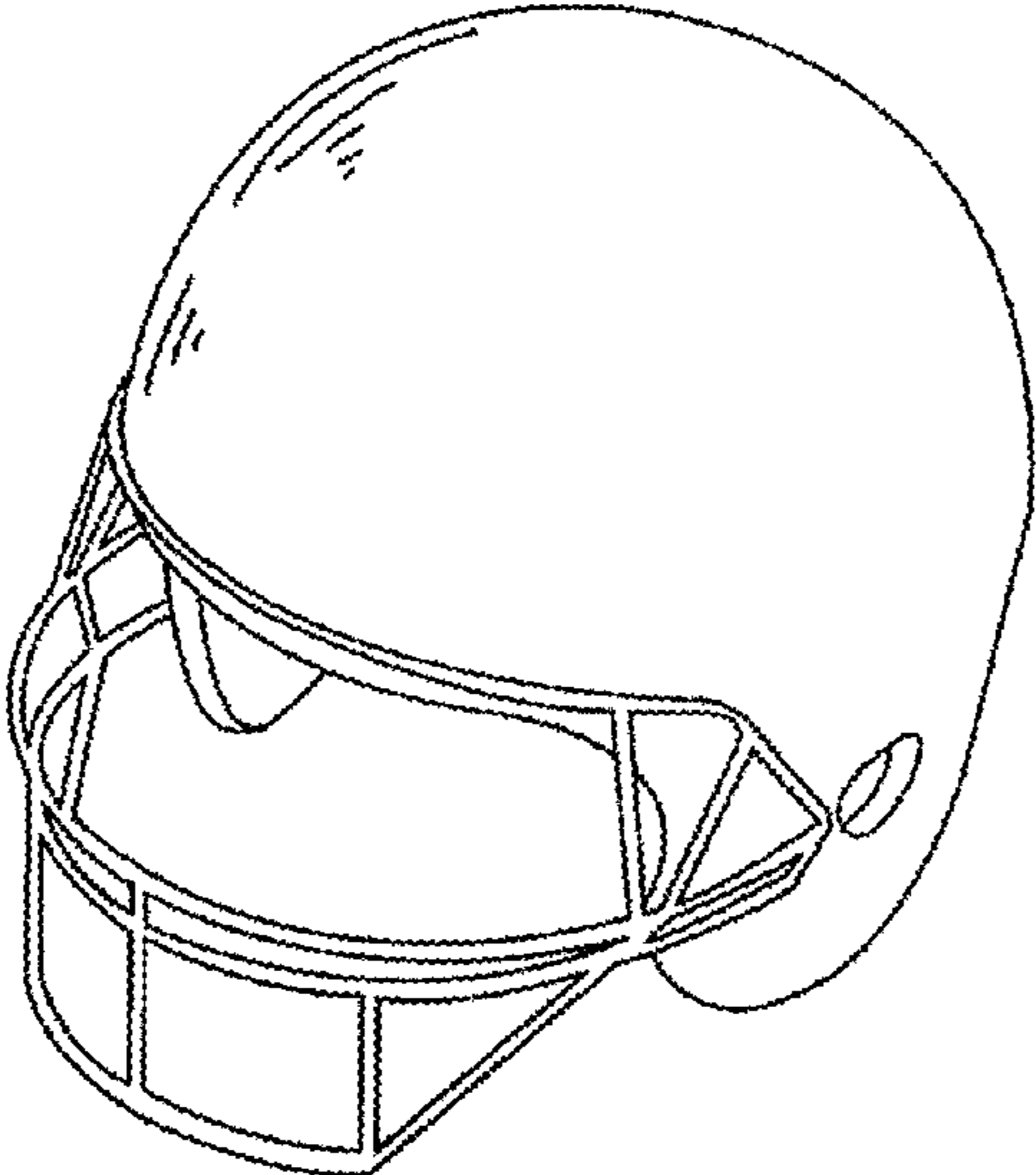

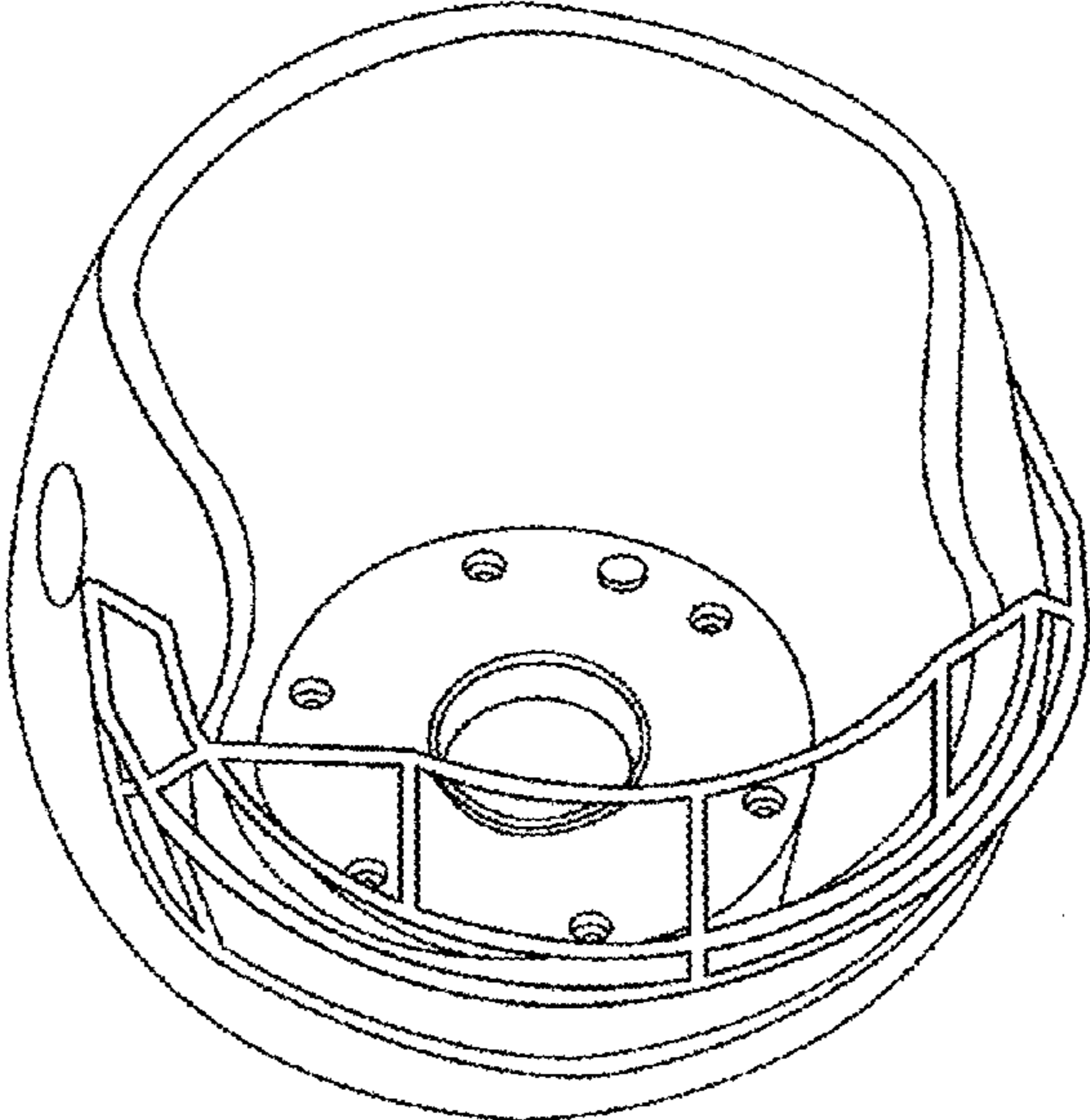

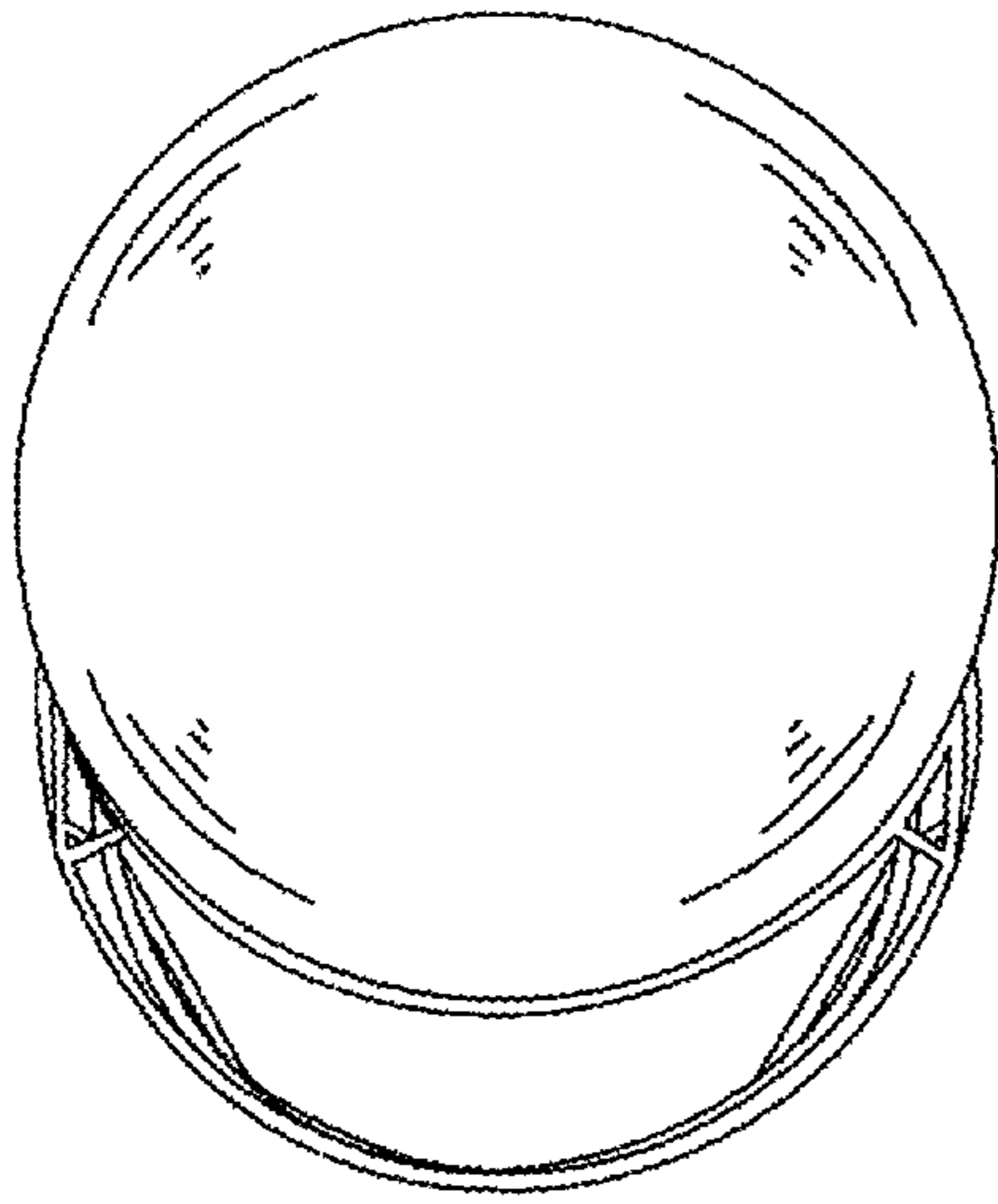

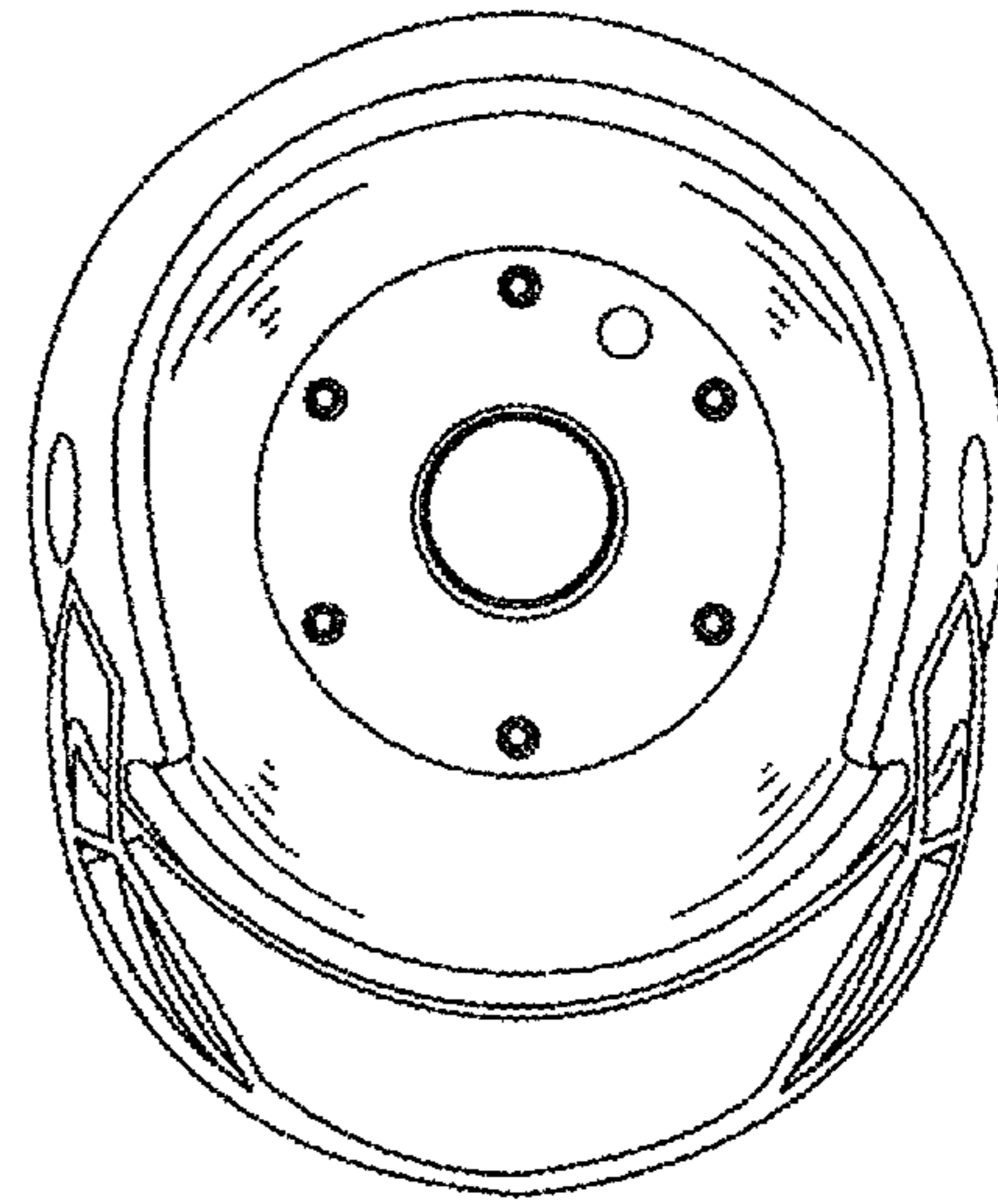

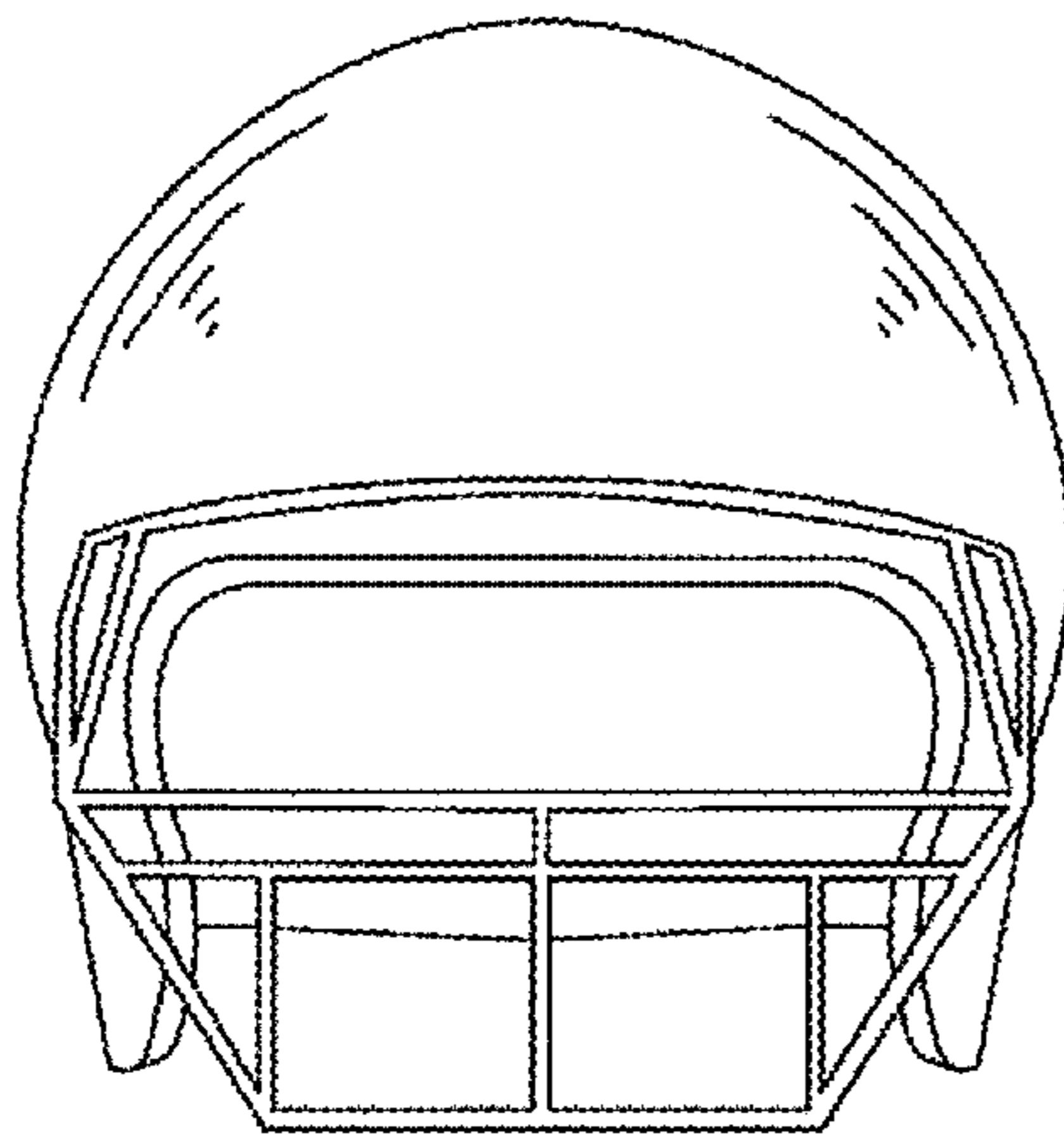

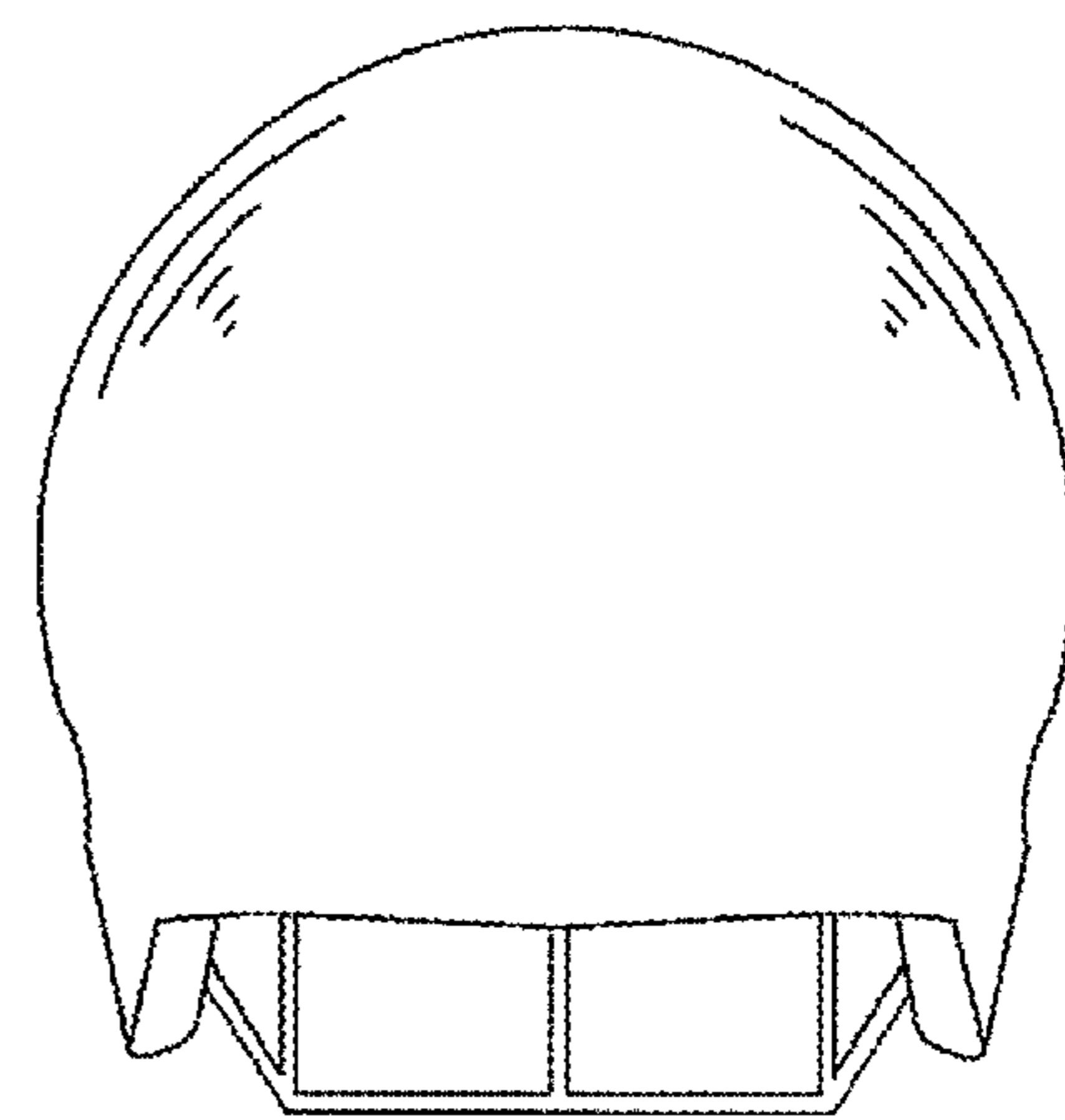

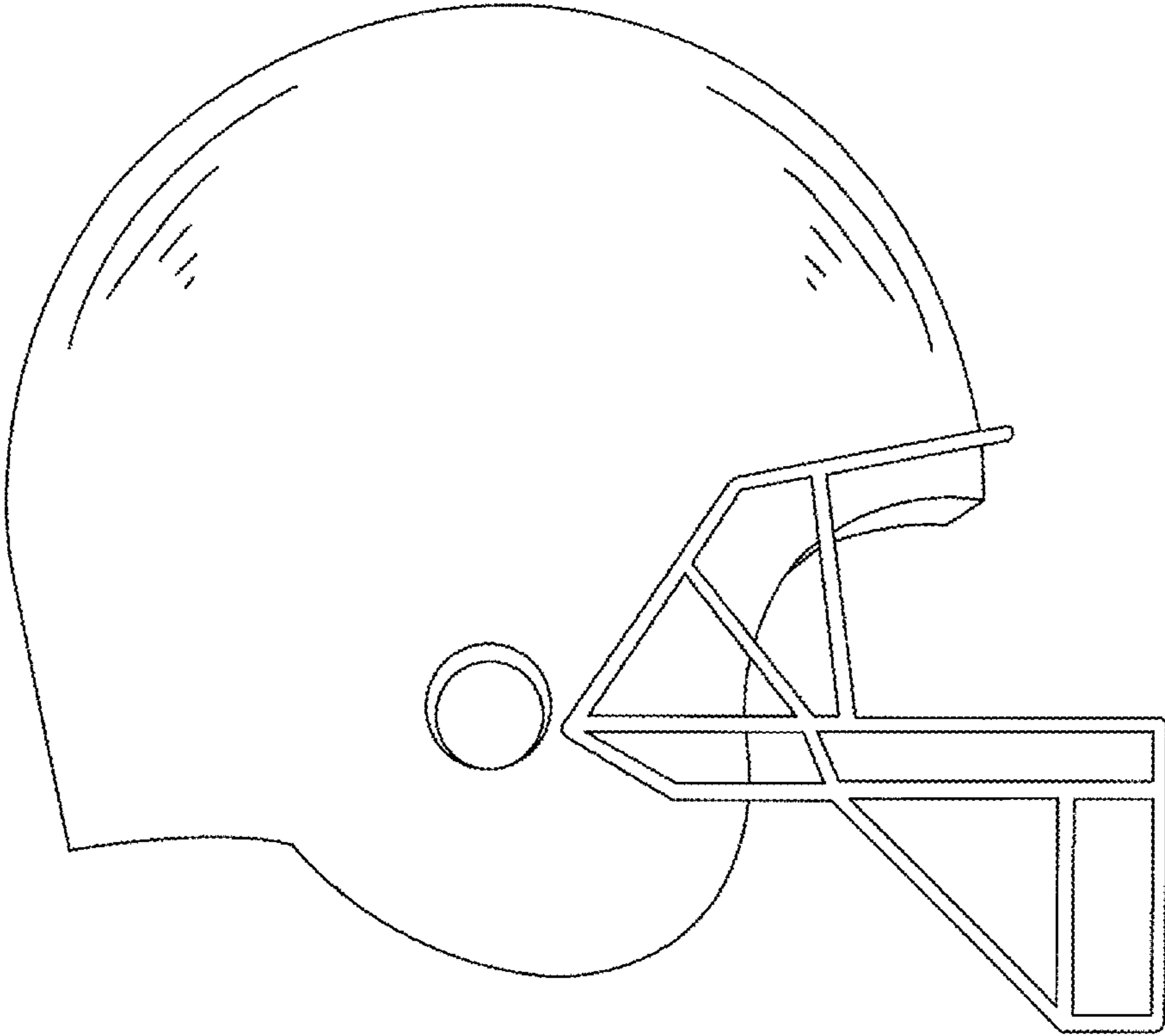

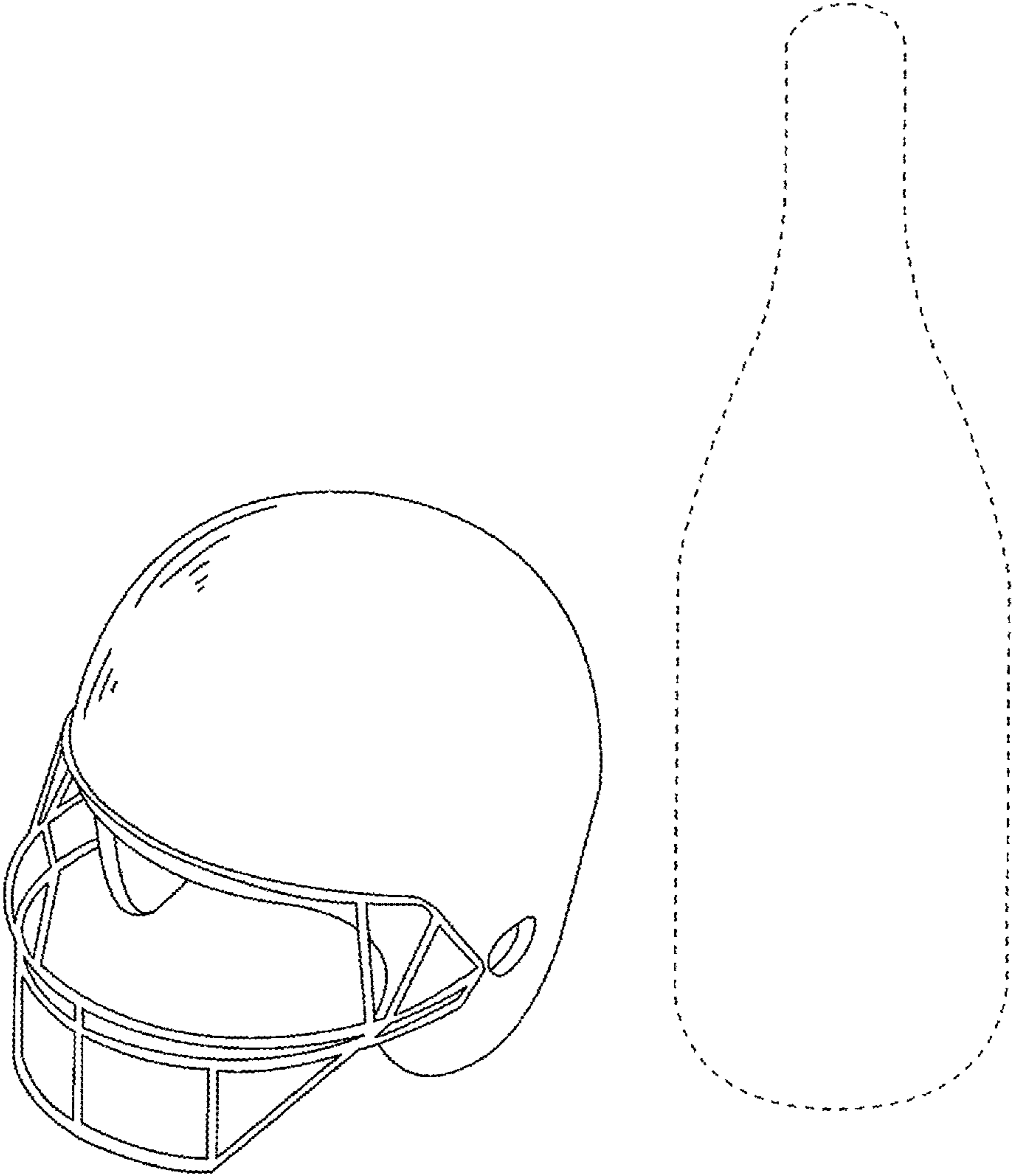

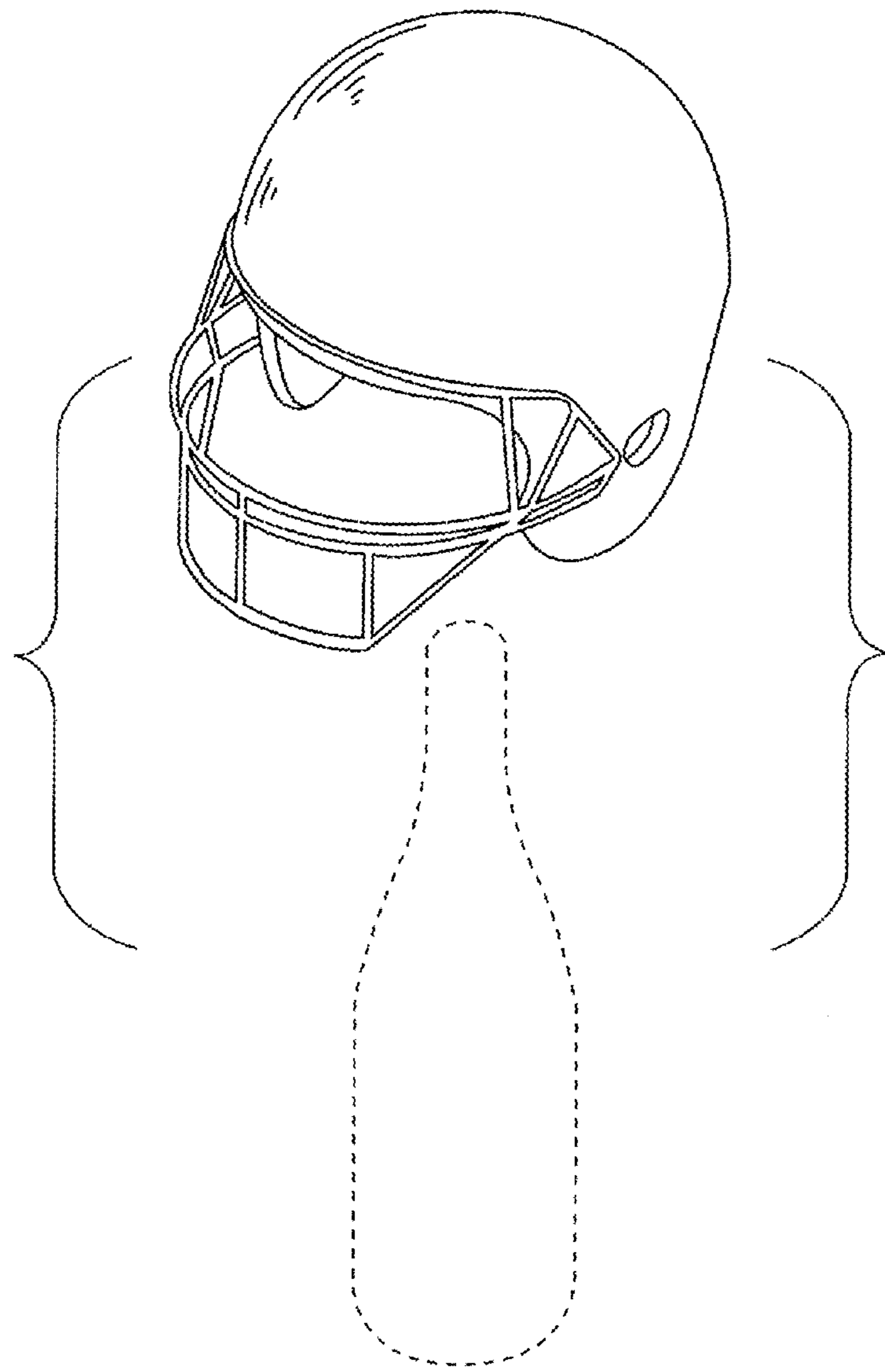

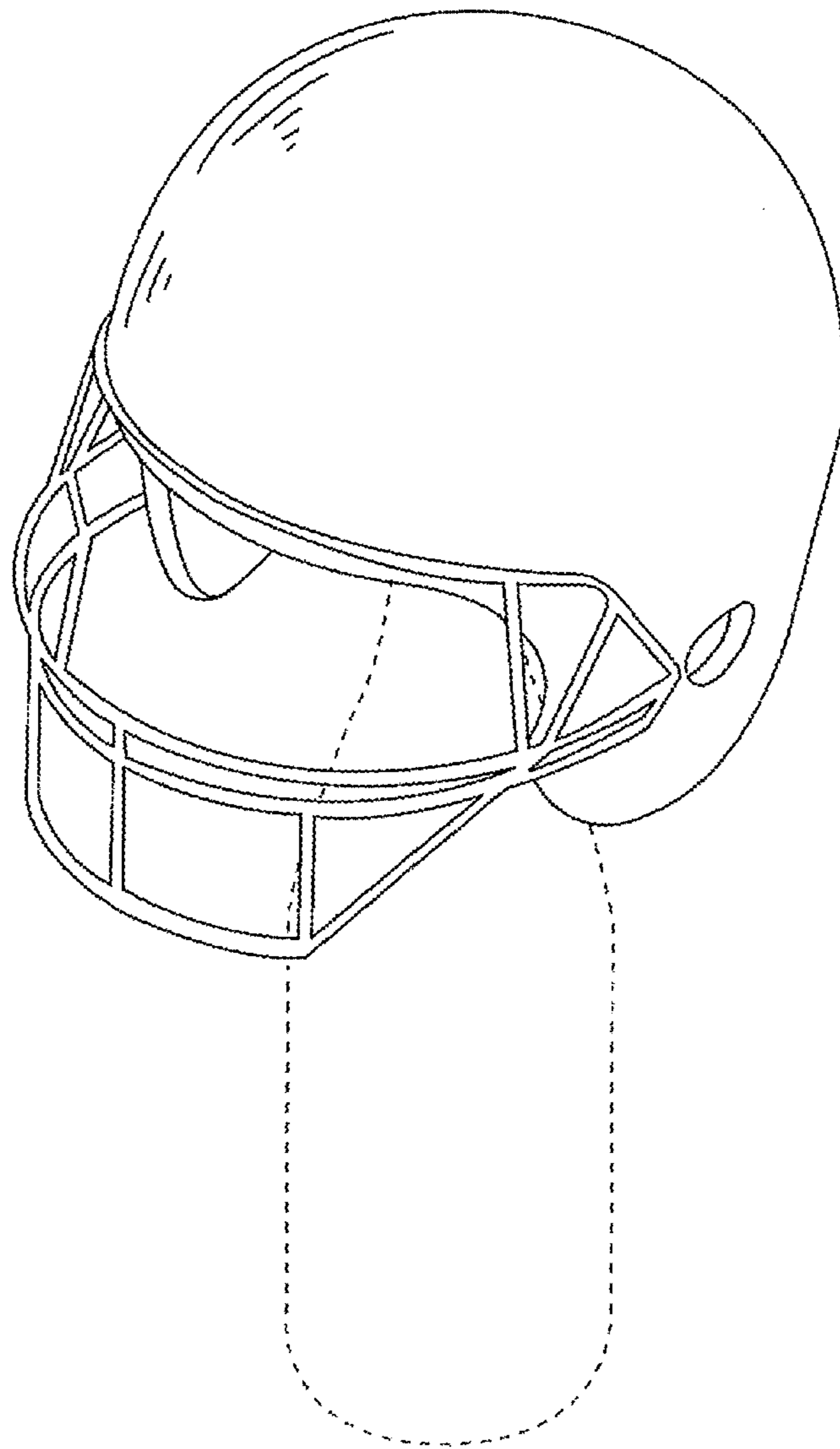

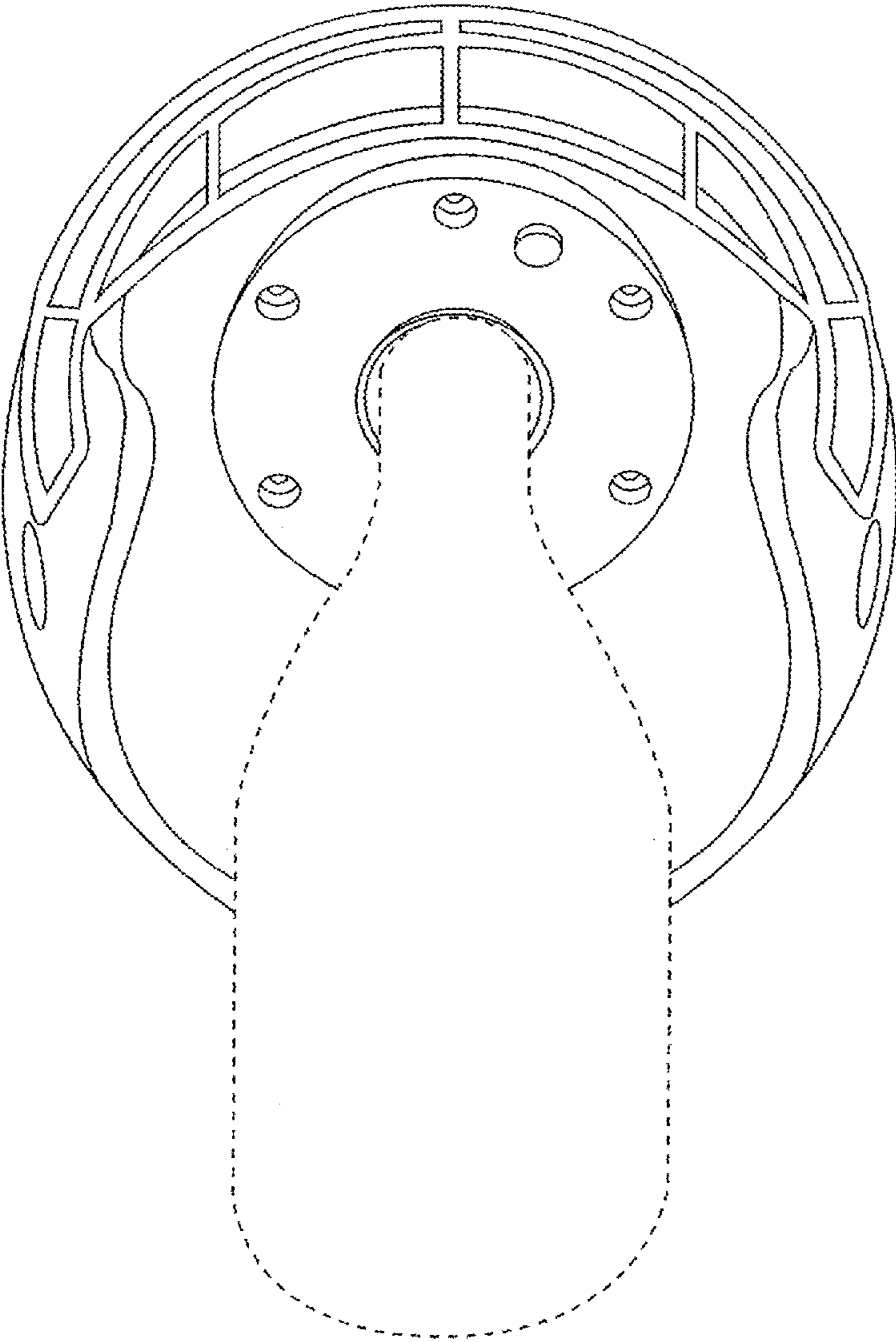
